The ornamental design for a neck and shoulder massager, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a neck and shoulder massager with the neck massager shown in phantom;

FIG. 11 is a left view of the neck and shoulder massager shown in FIG. 8;

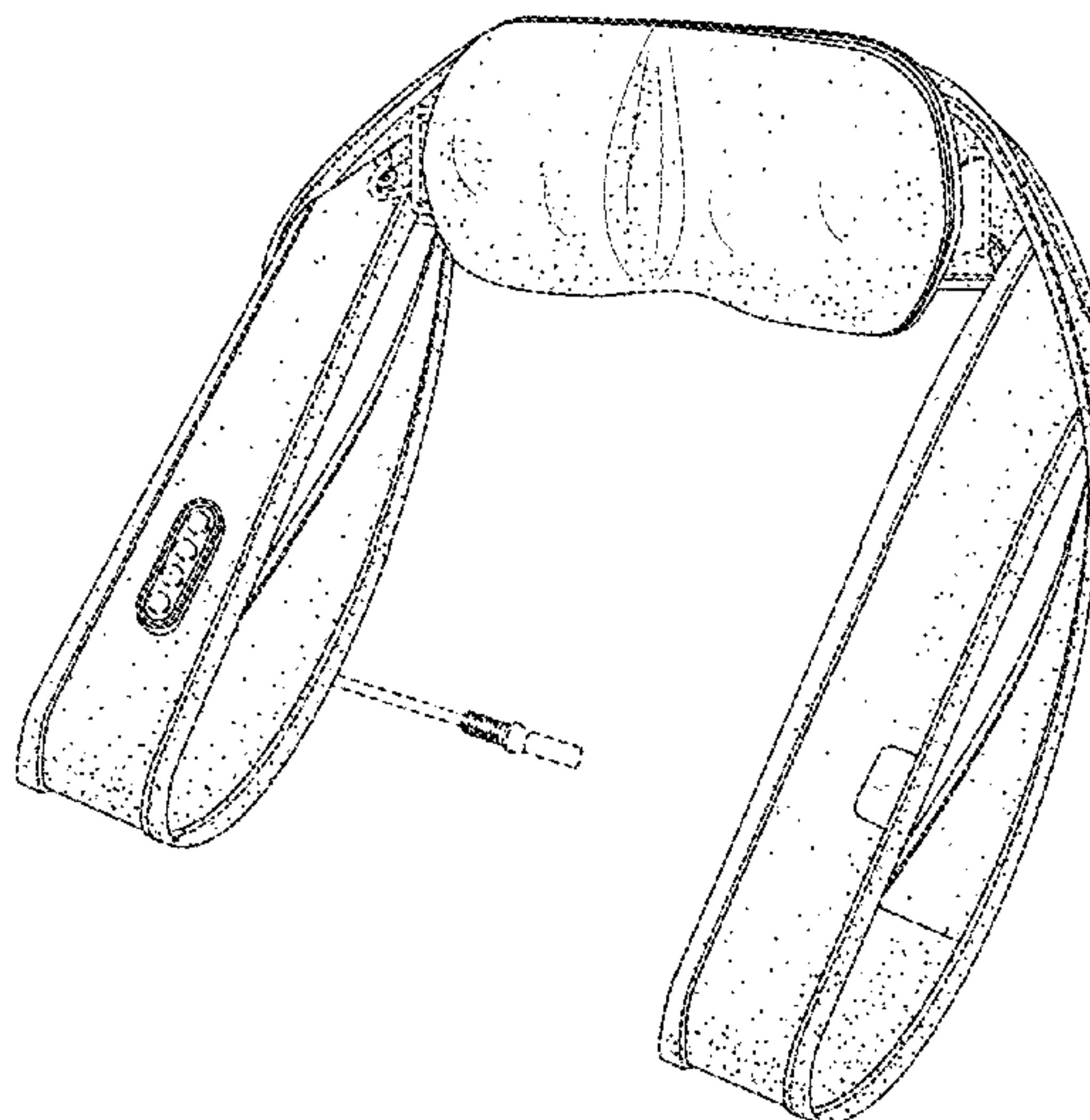
FIG. 12 is a right view of the neck and shoulder massager shown in FIG. 8;

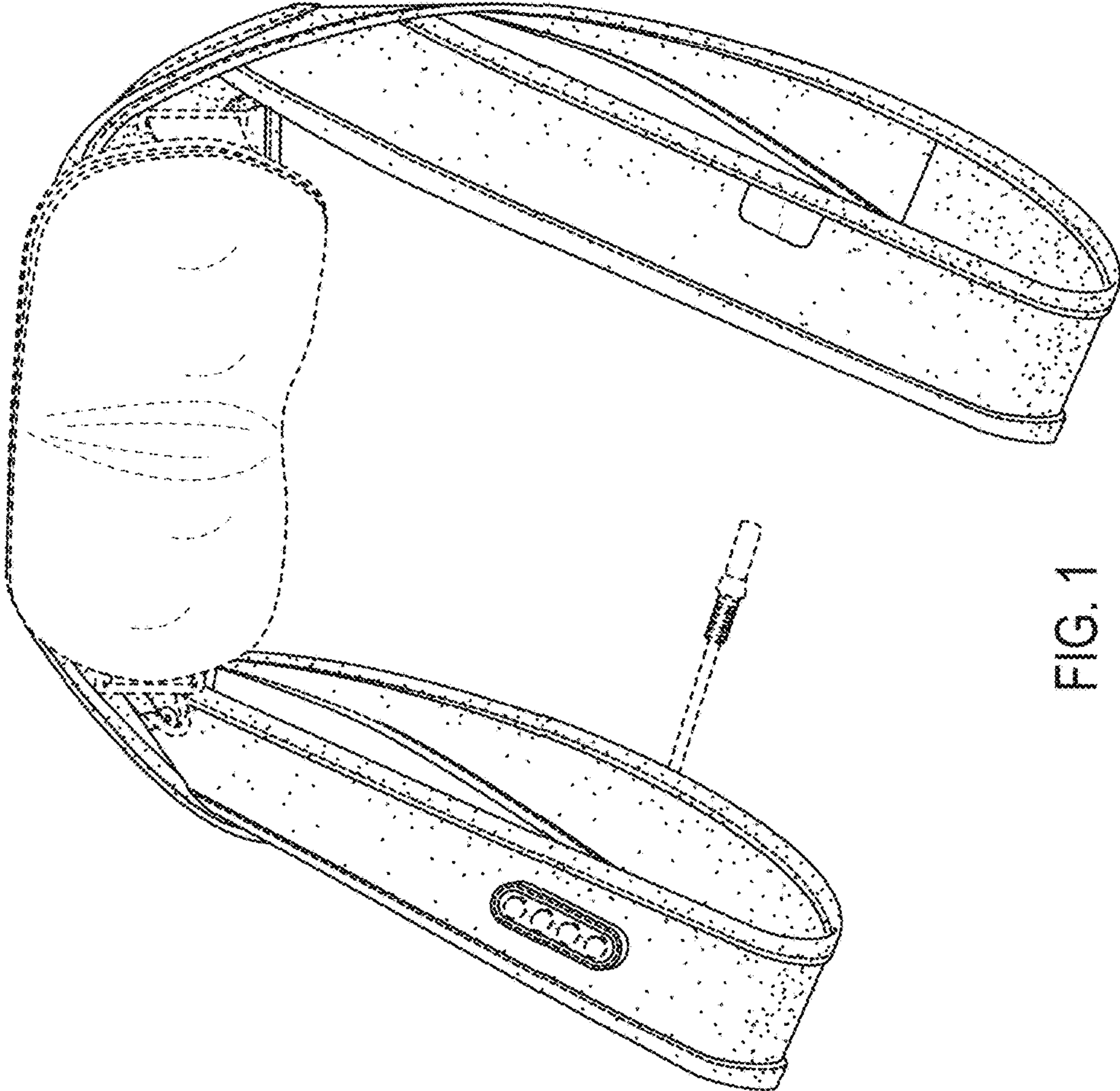

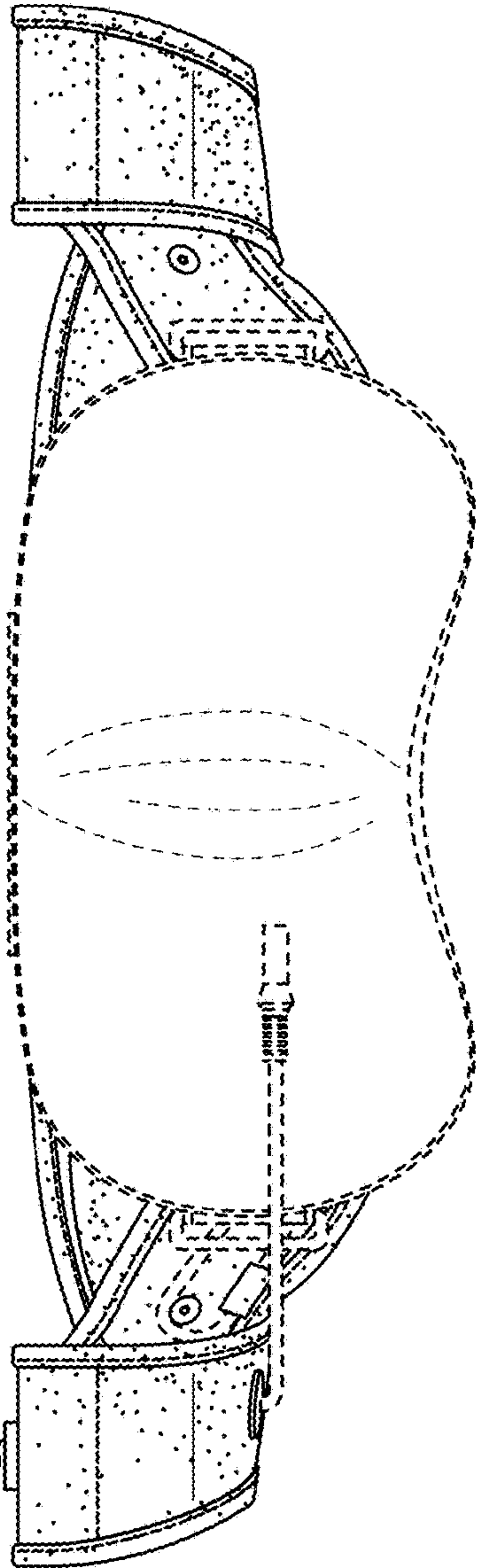

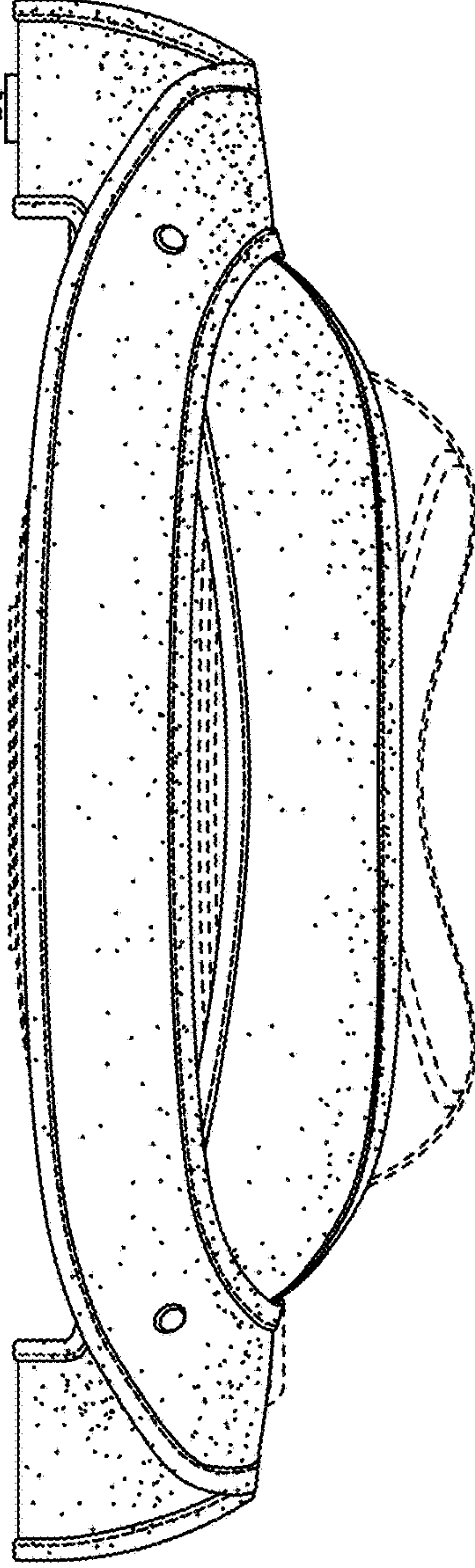

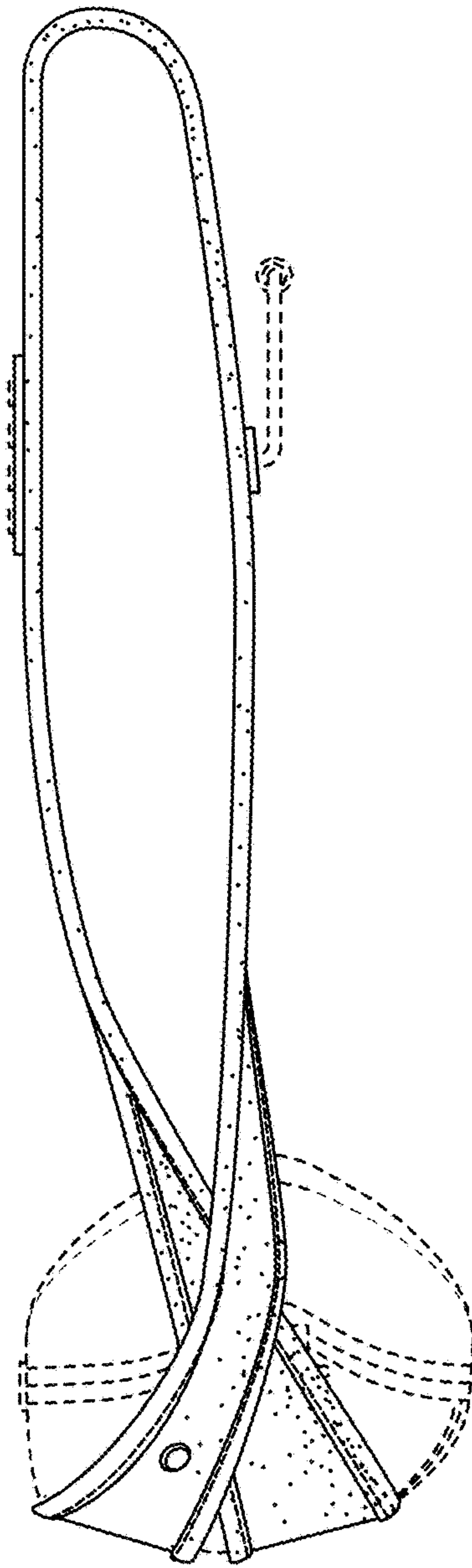

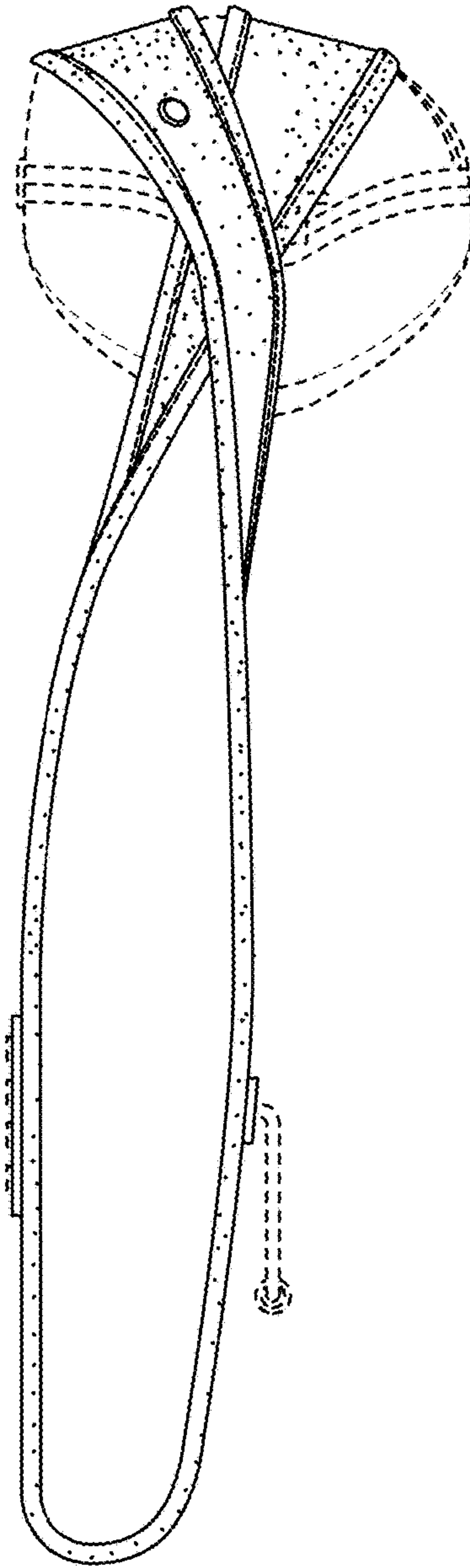

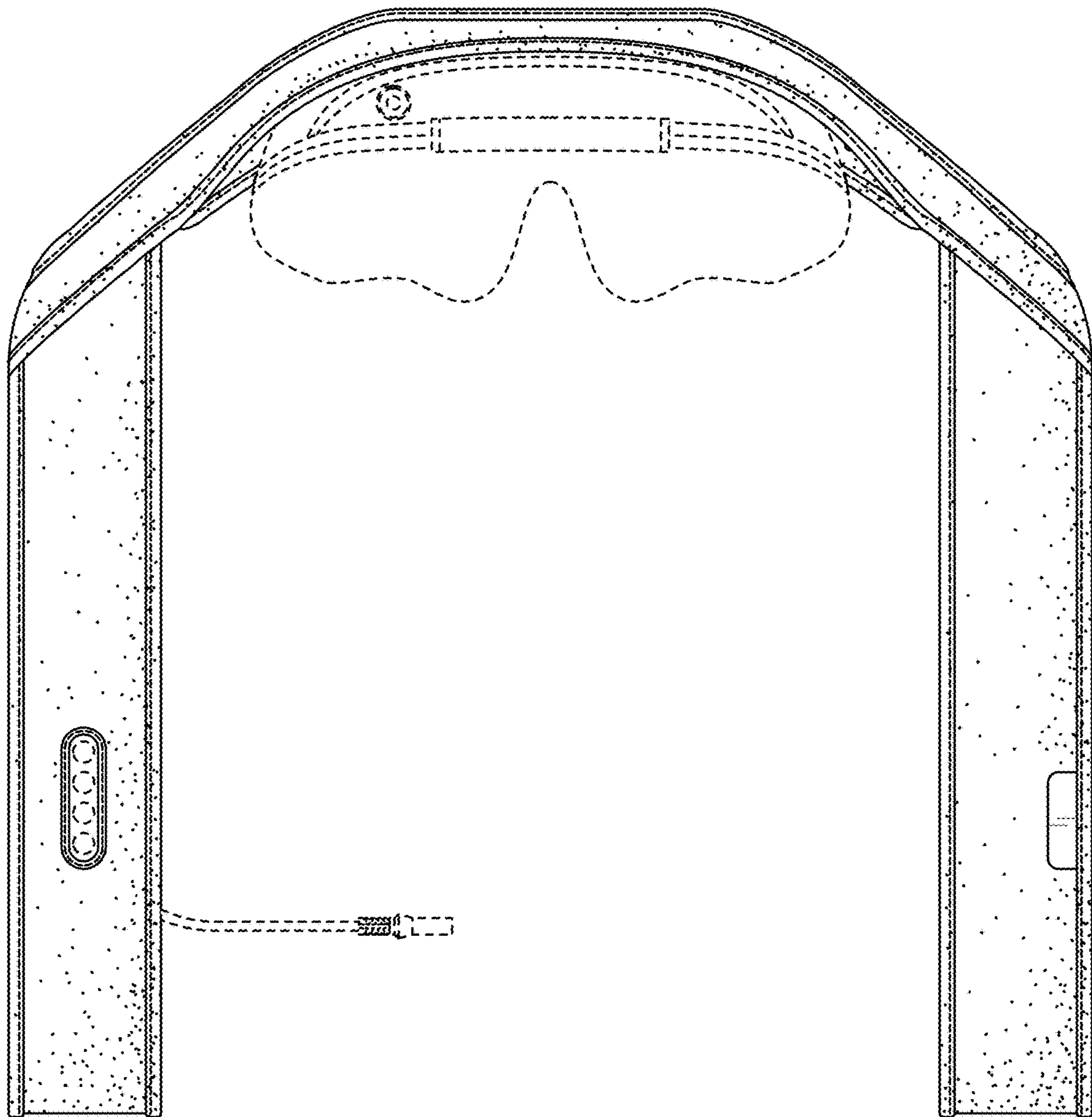

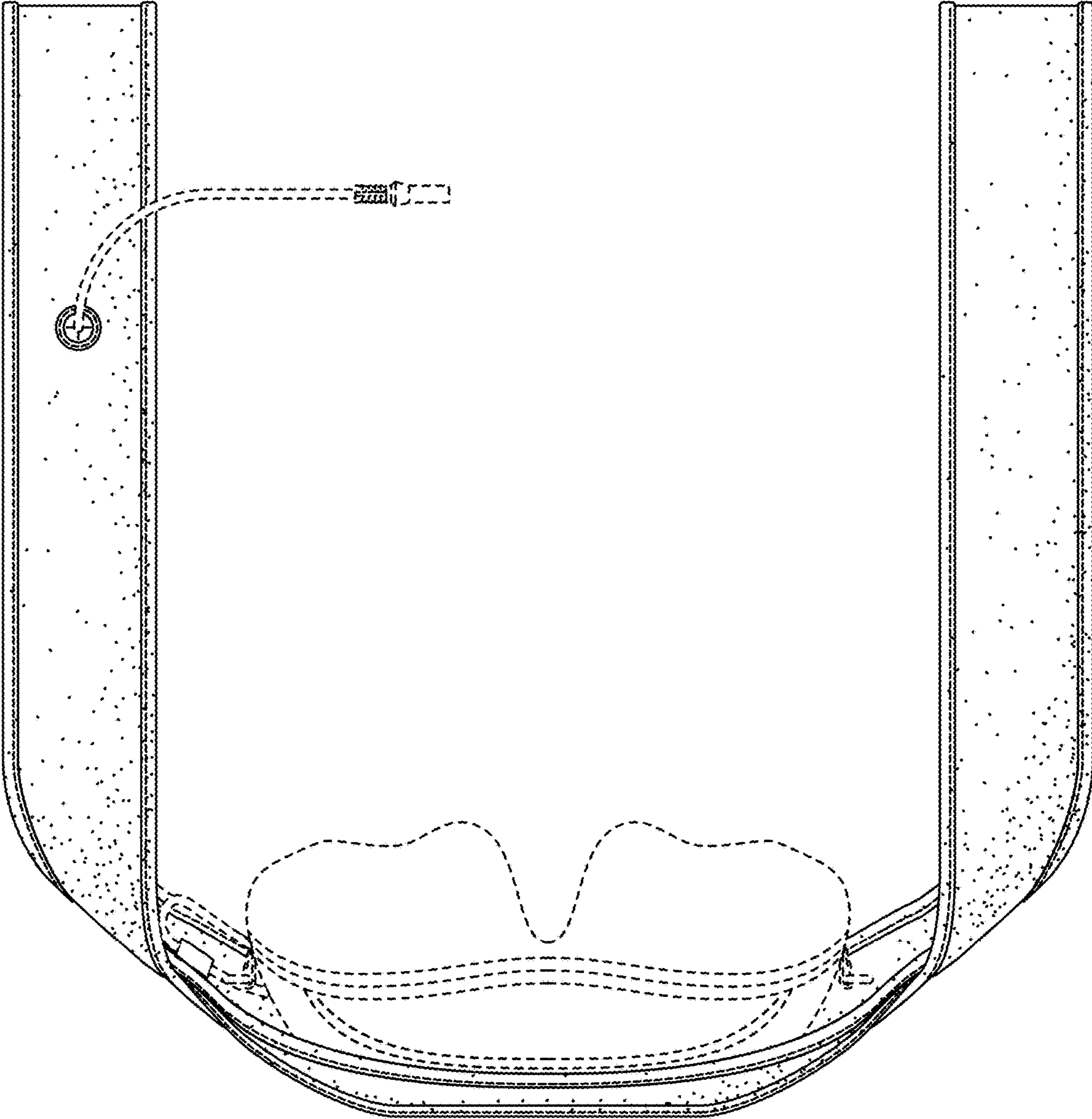

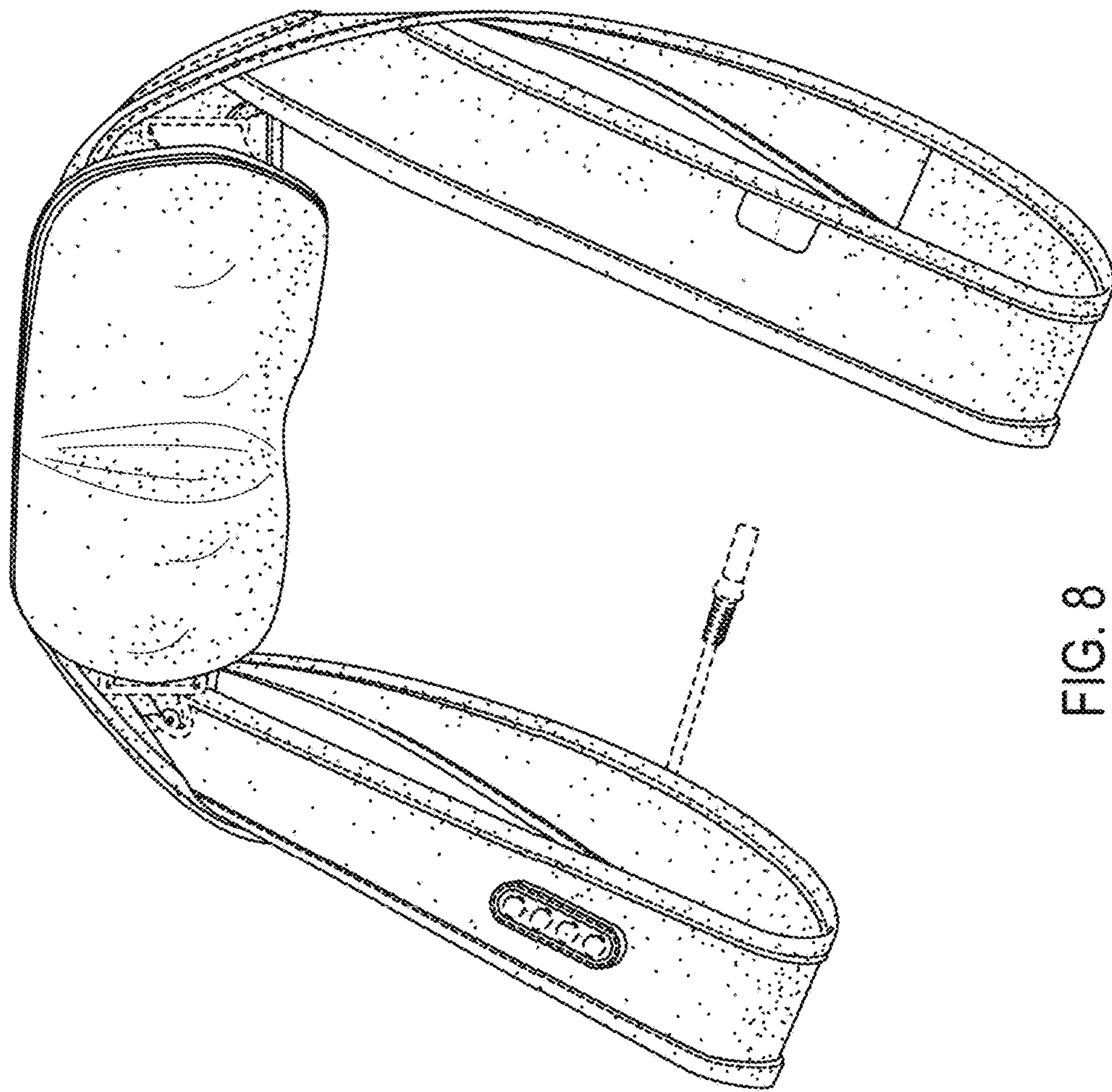

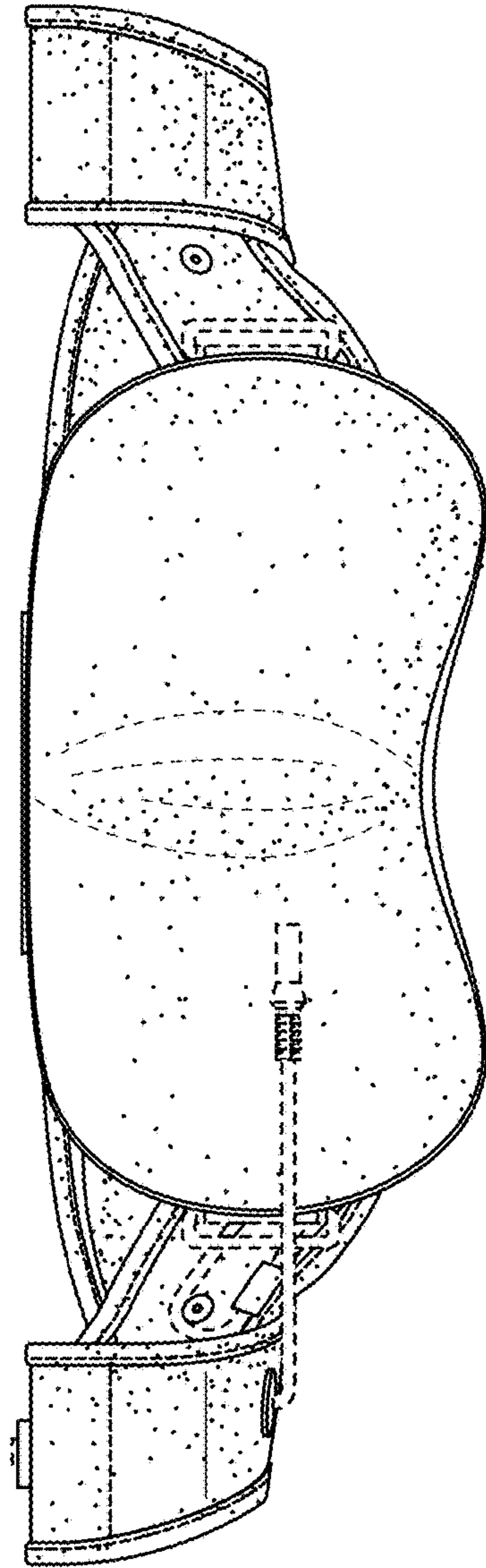

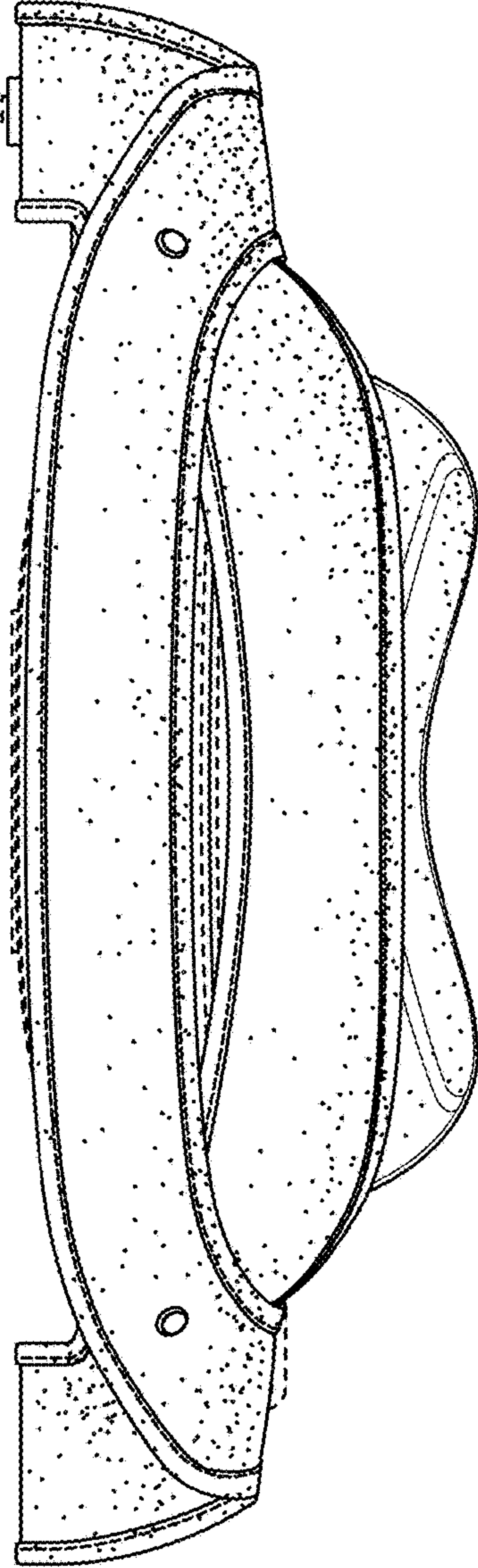

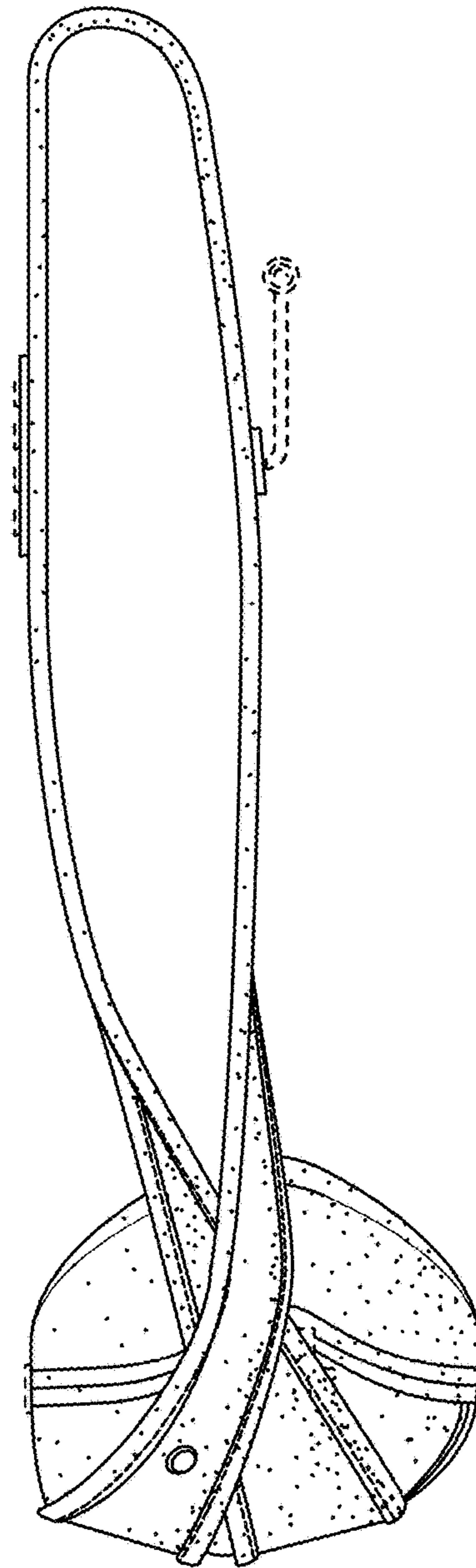

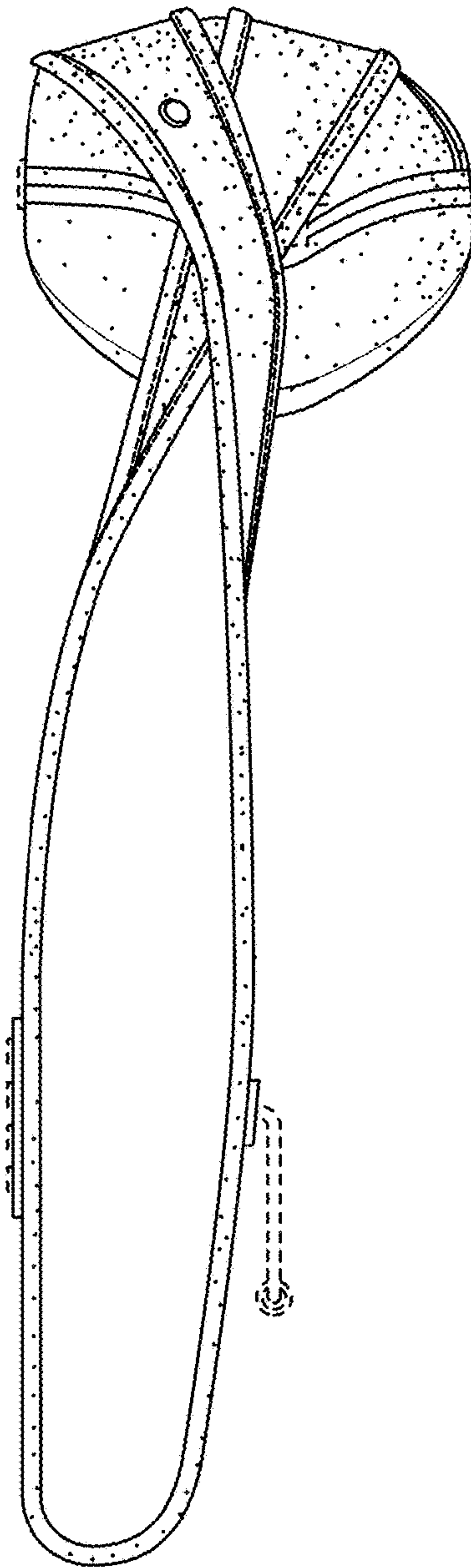

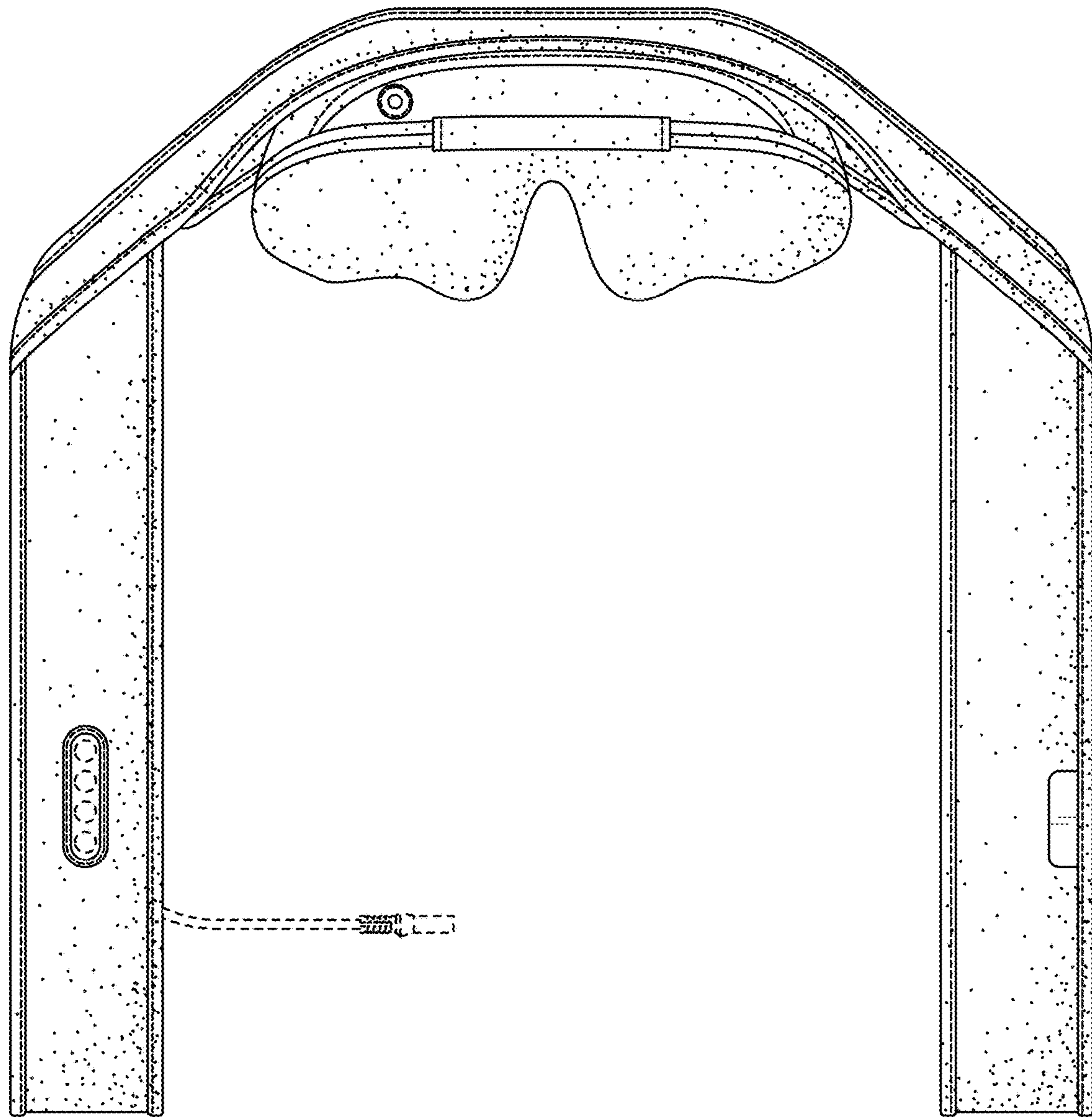

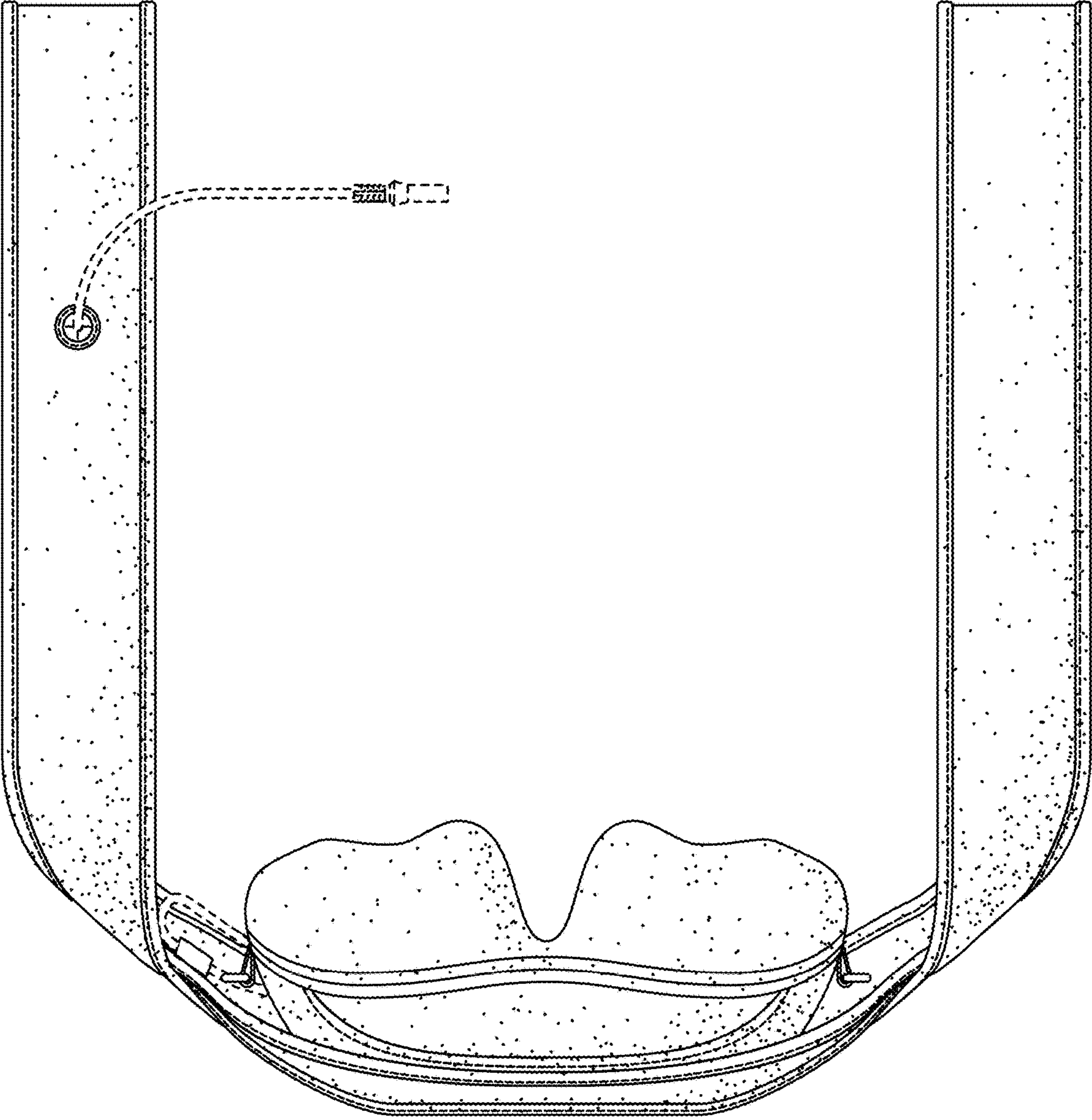
