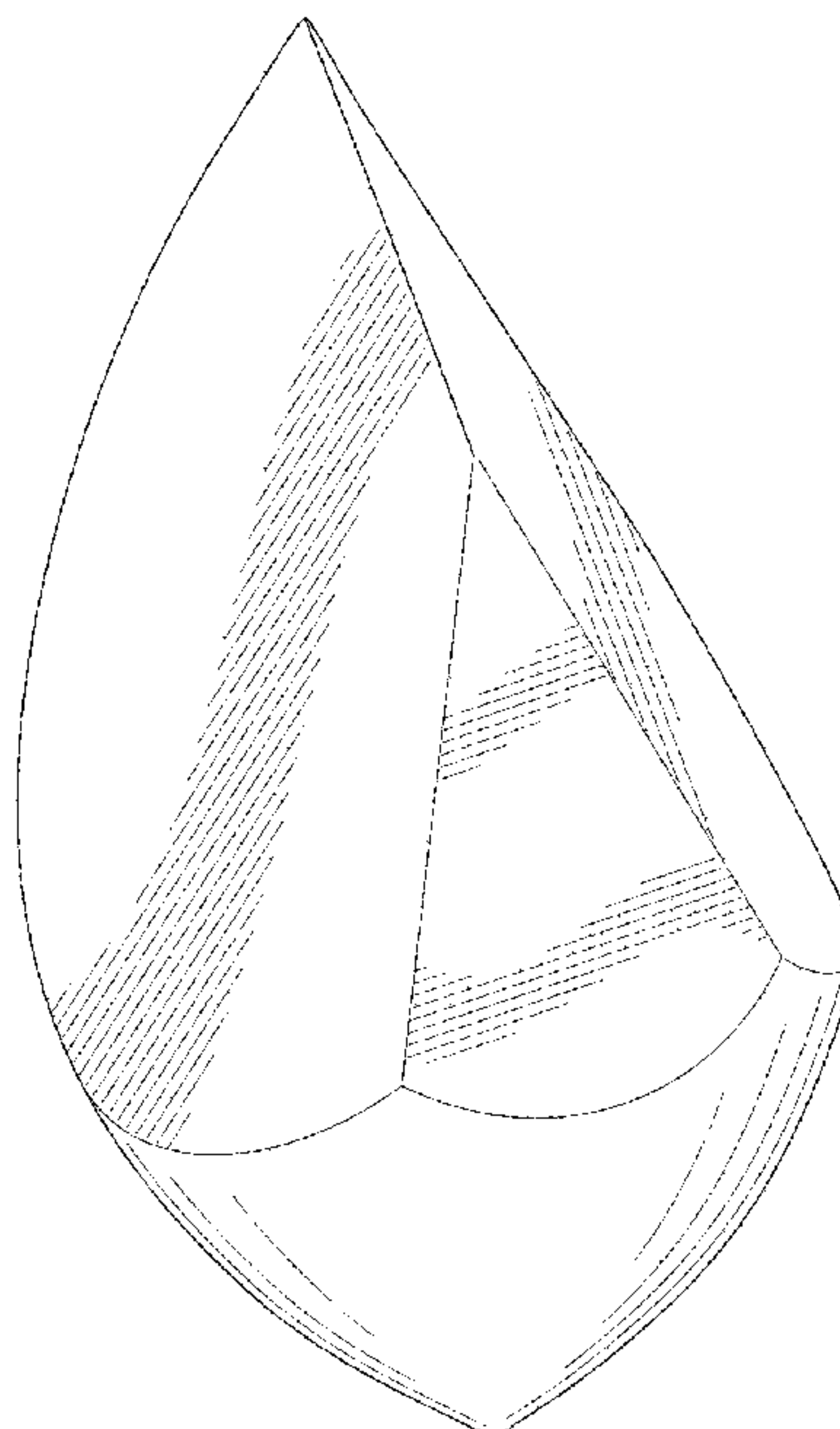
FIG. 1 is a perspective view of a makeup applicator in accordance with my new design;

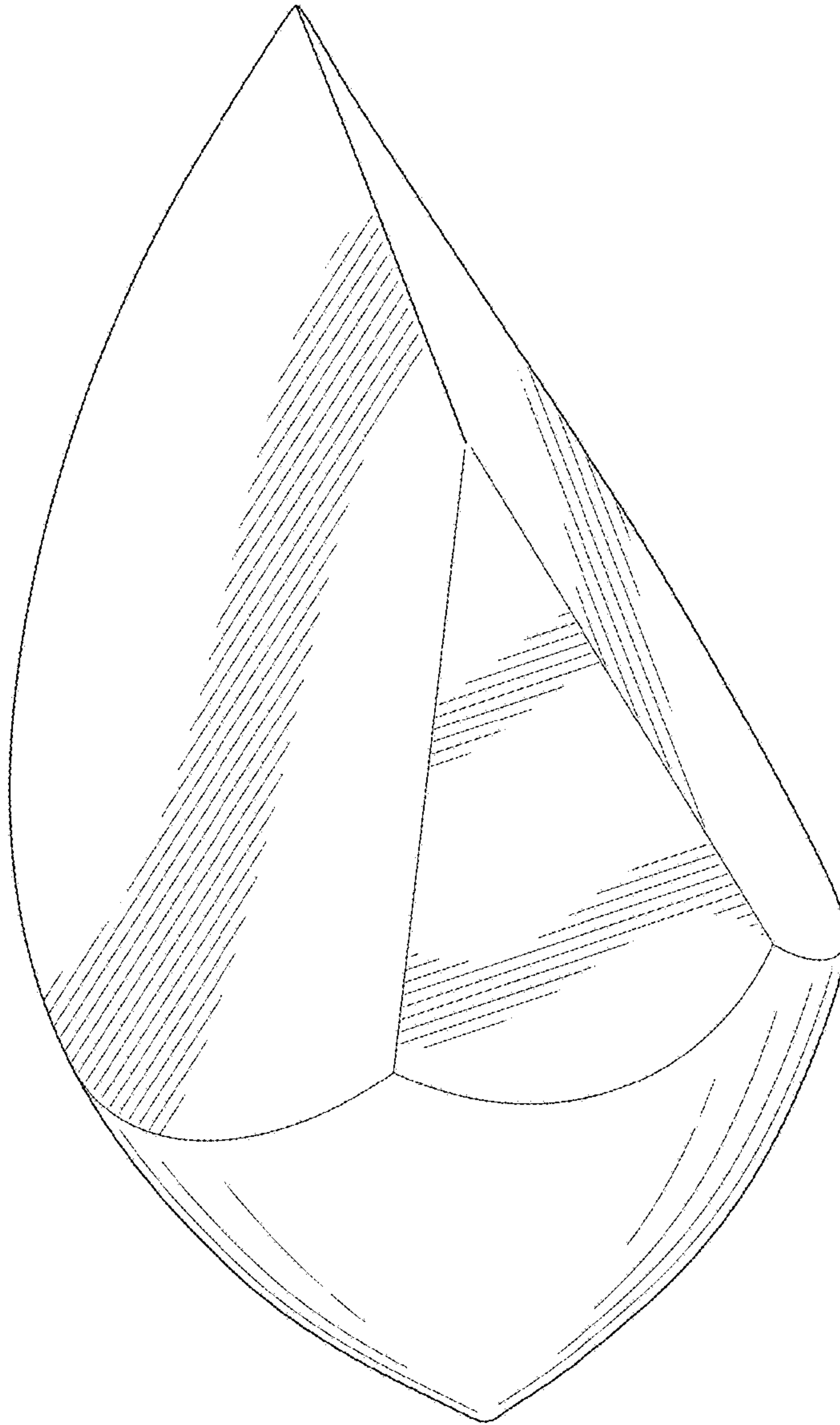

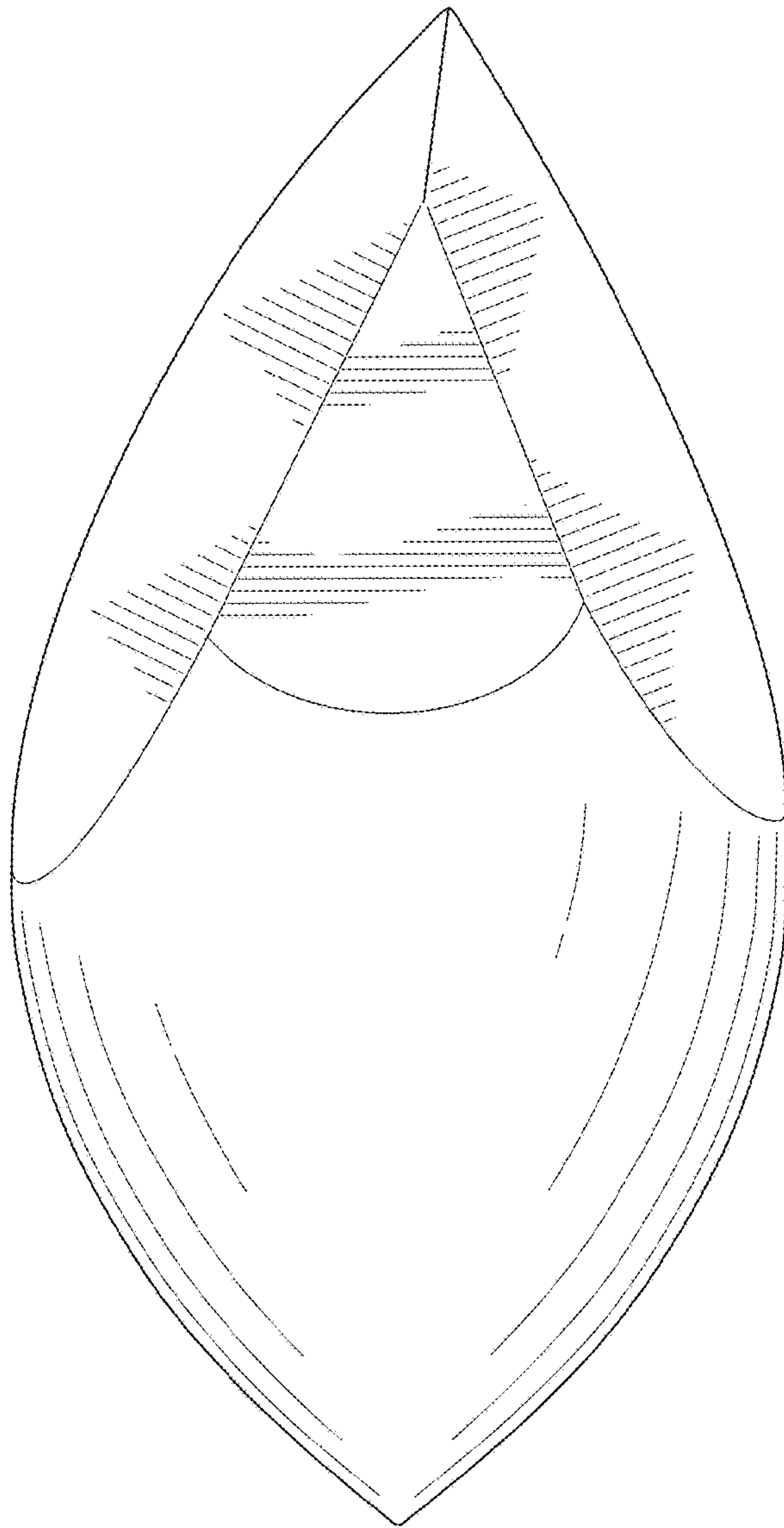

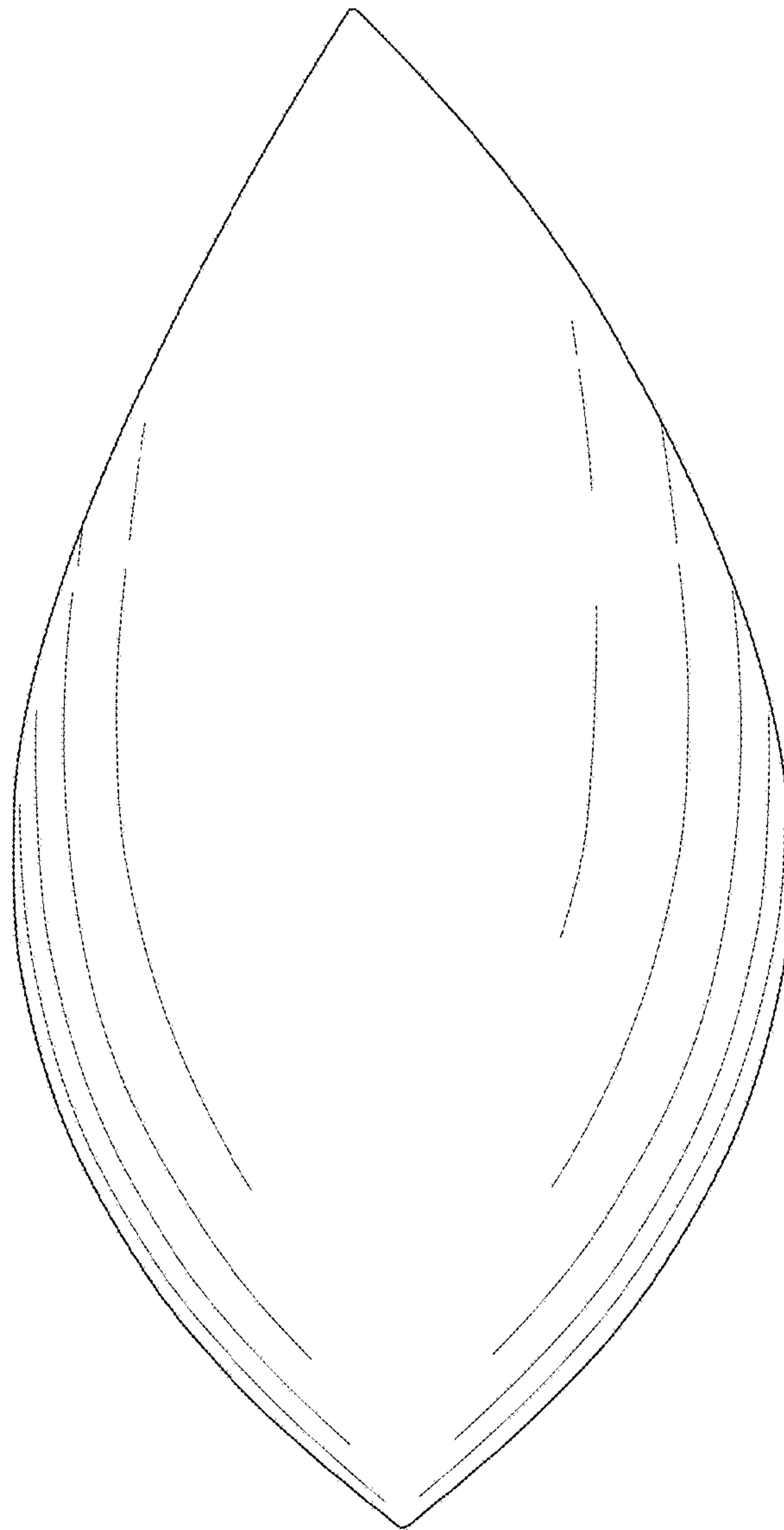

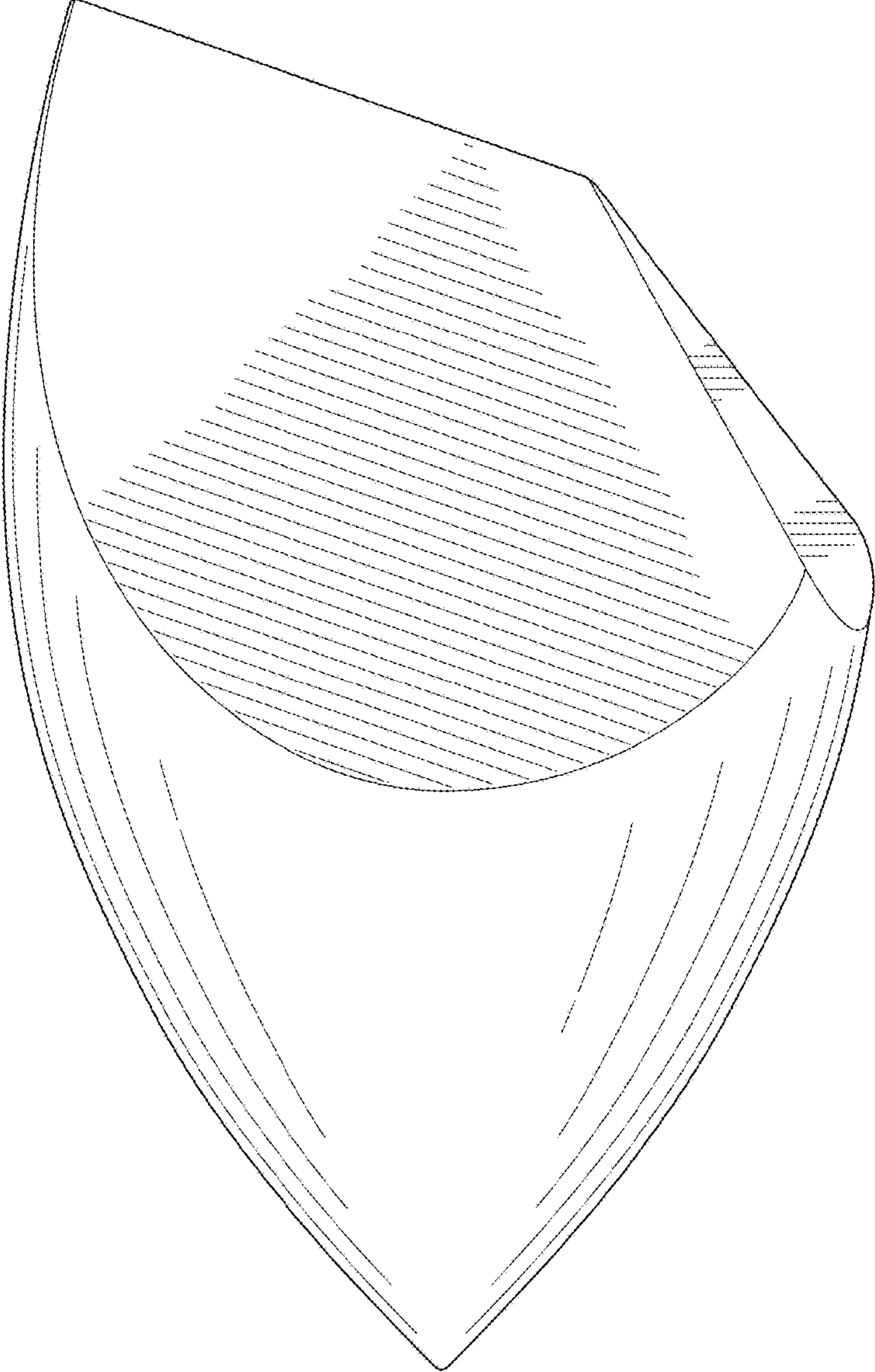

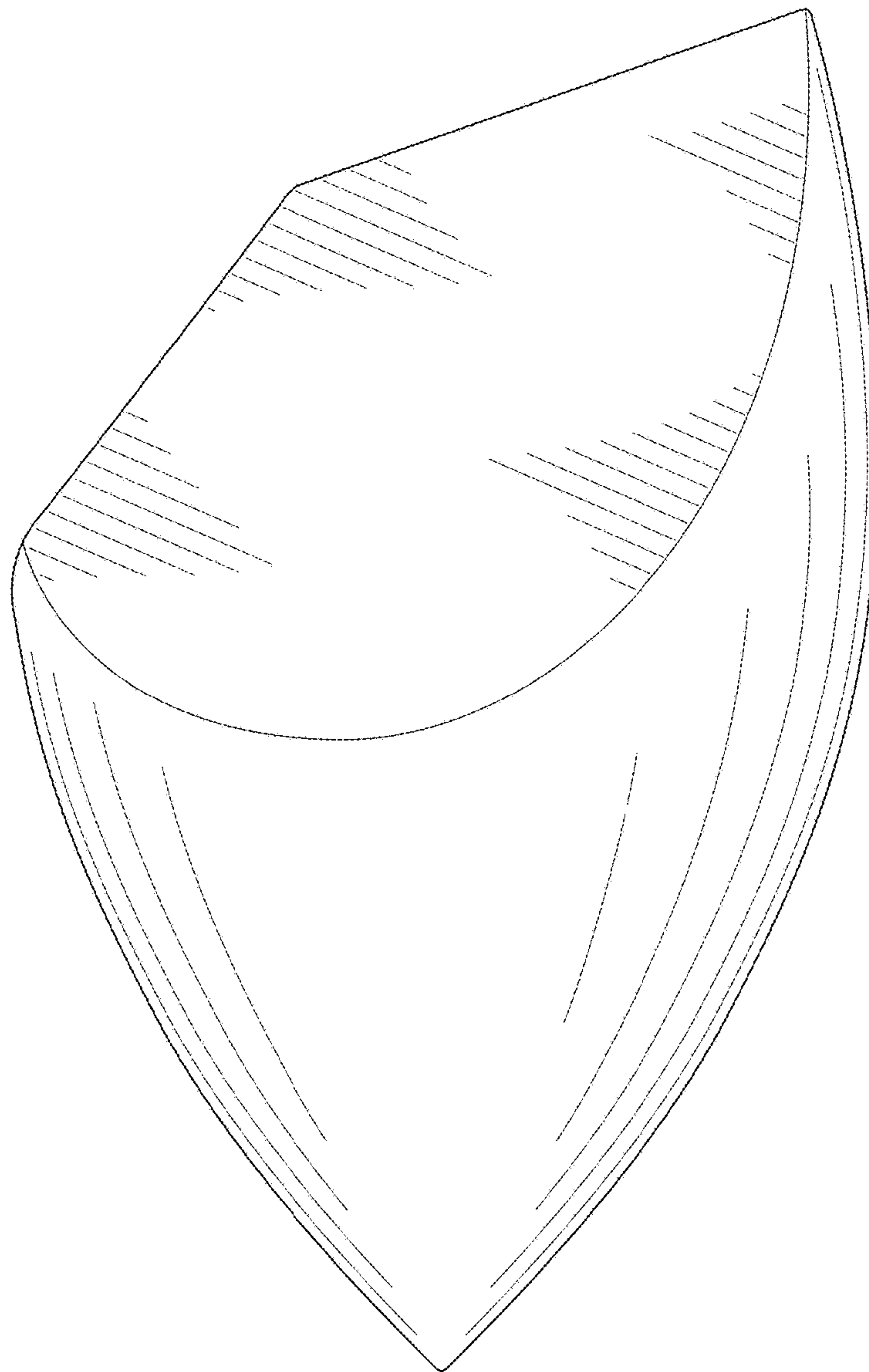

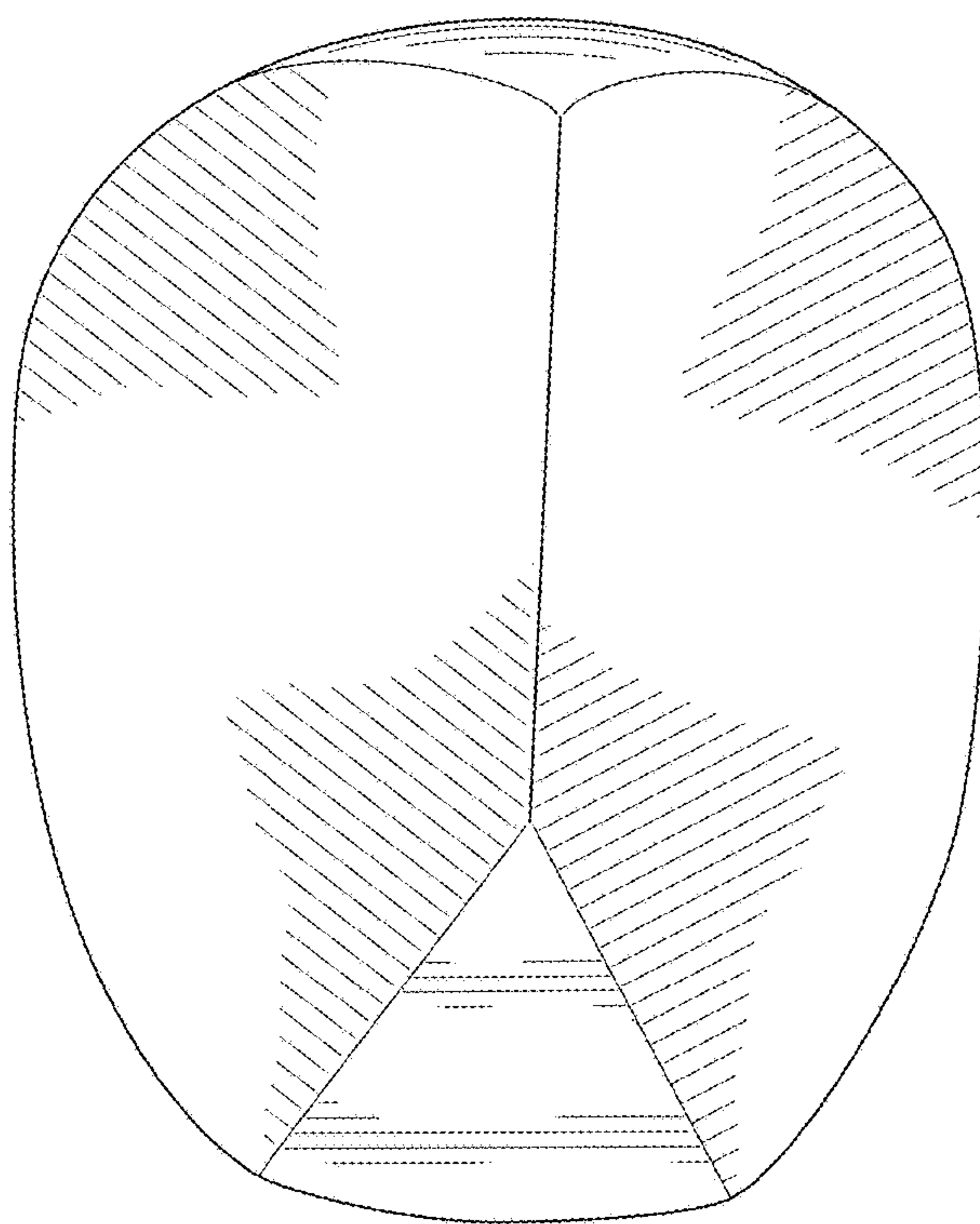

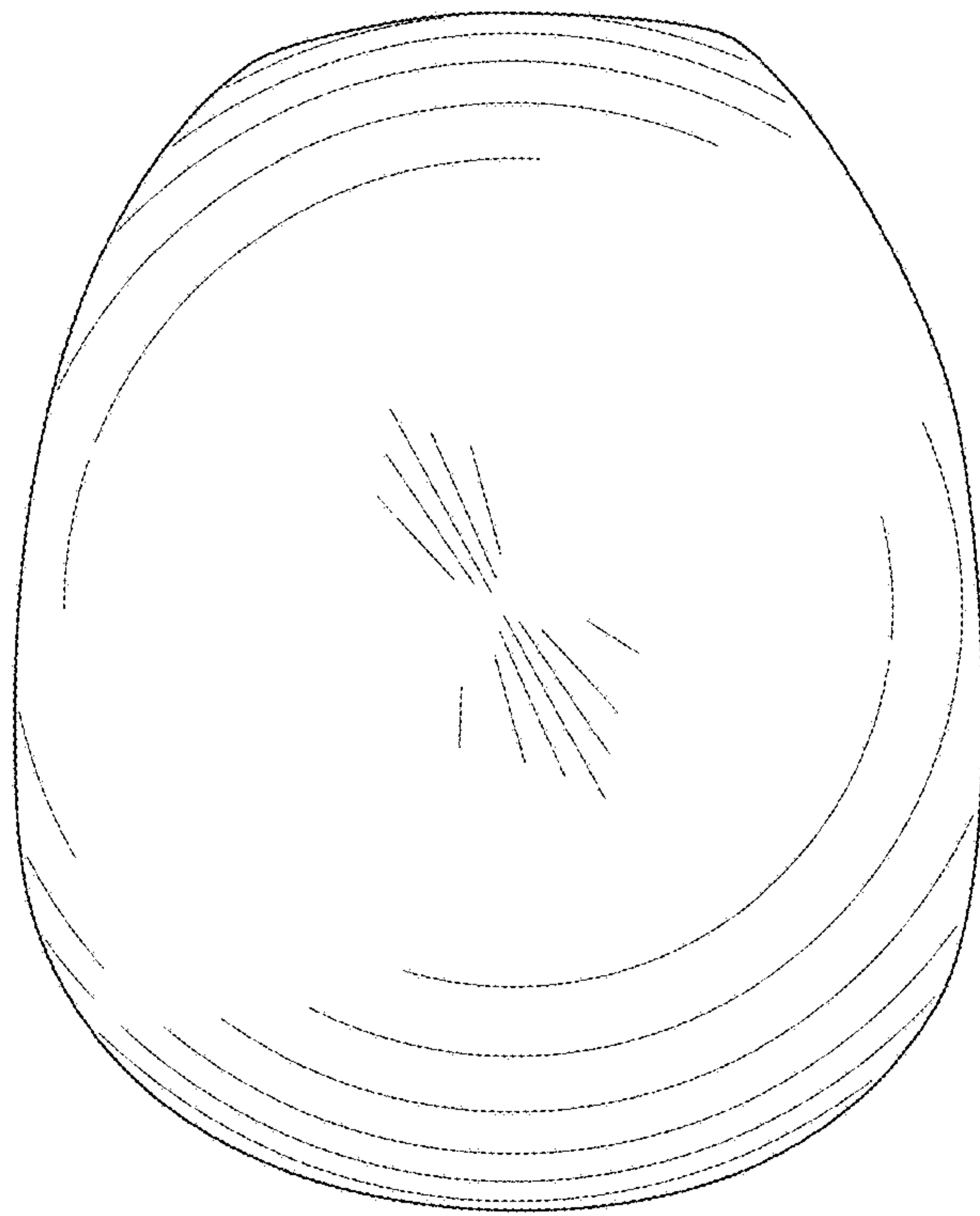
