FIG. 3 is a rear view thereof;


FIG. 4 is a left view thereof;


FIG. 5 is a right view thereof;

FIG. 6 is a top view thereof; and,


FIG. 7 is a bottom view thereof.

The broken lines shown in the figures are included for purpose of illustrating portions of the trash can and form no part of the claimed design.










