The ornamental design for an article of food, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an article of food showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines in FIG. 1 illustrate portions of the article of food that form no part of the claimed design.

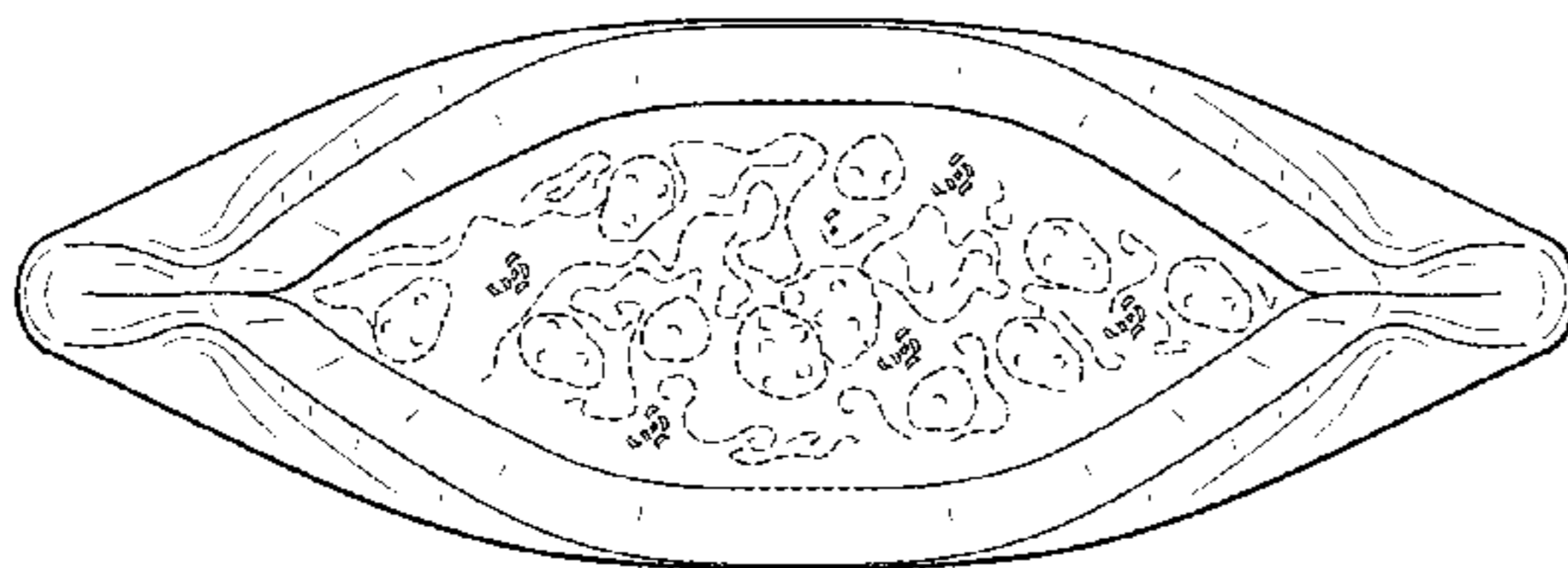

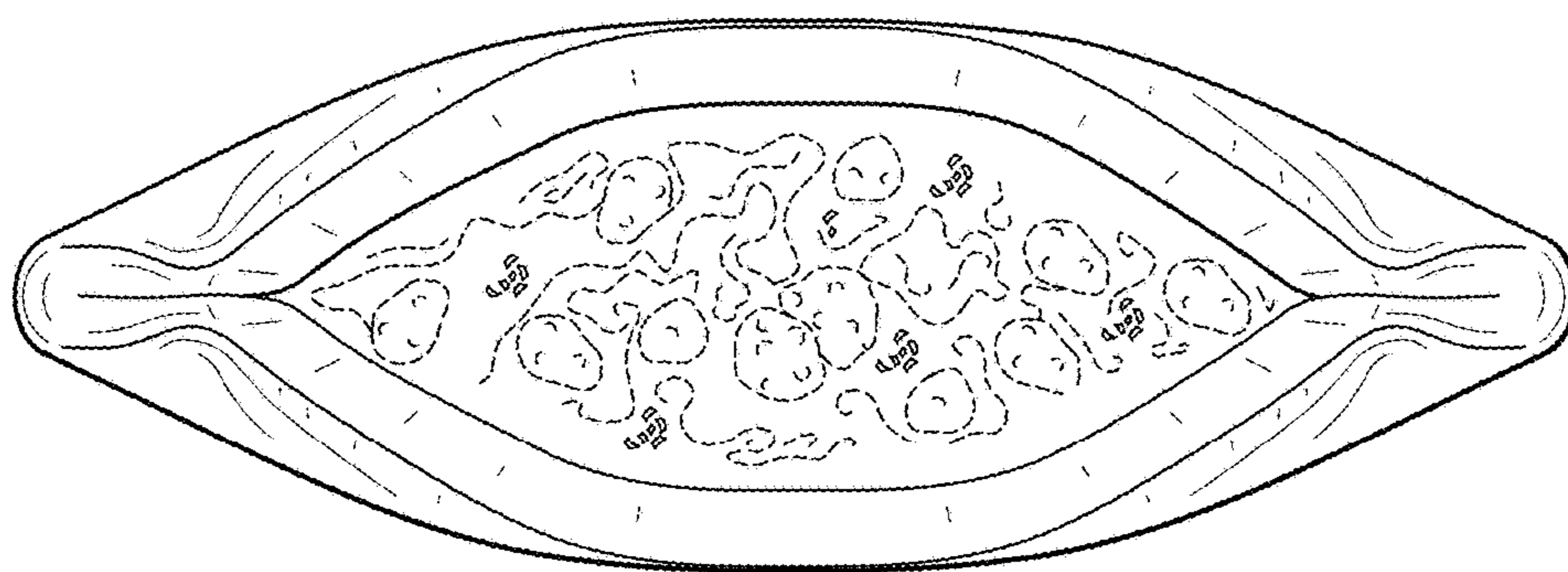

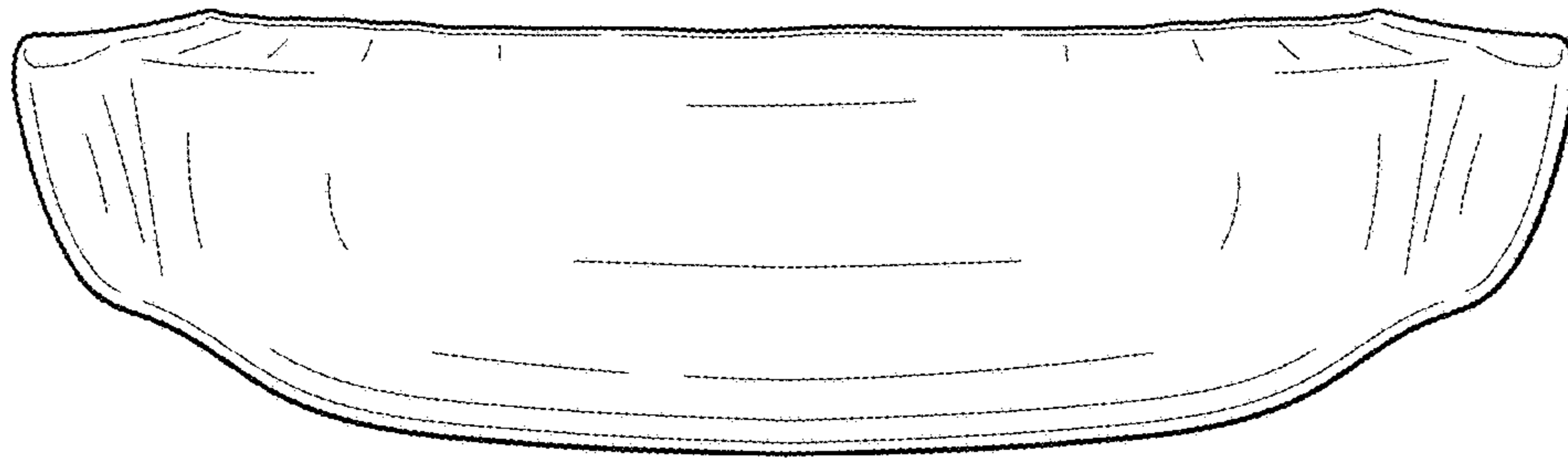

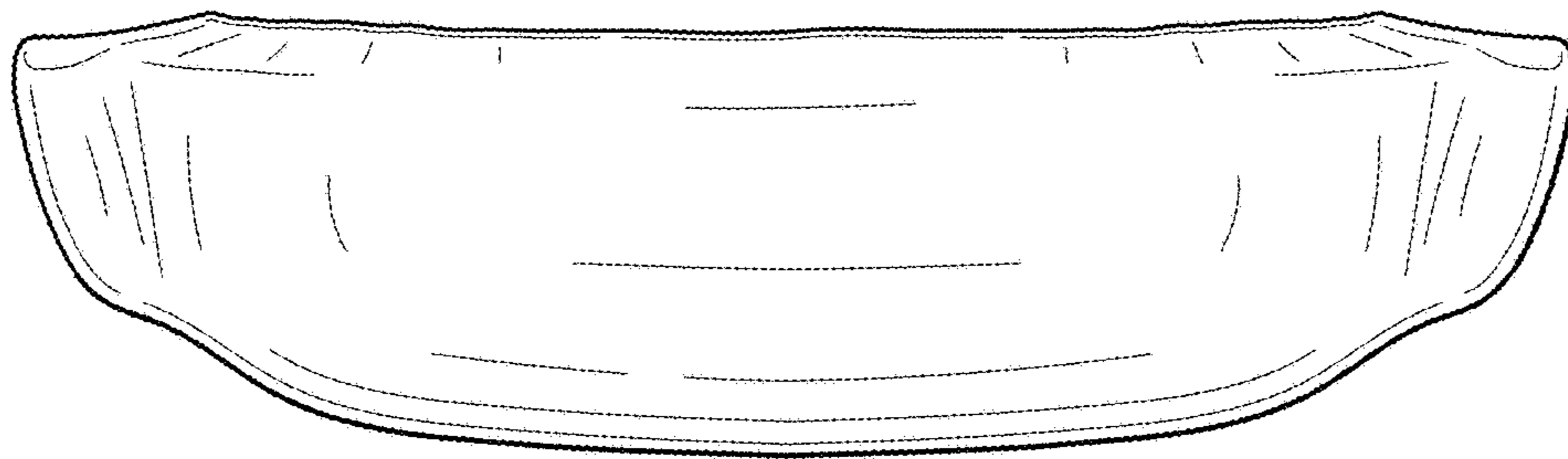

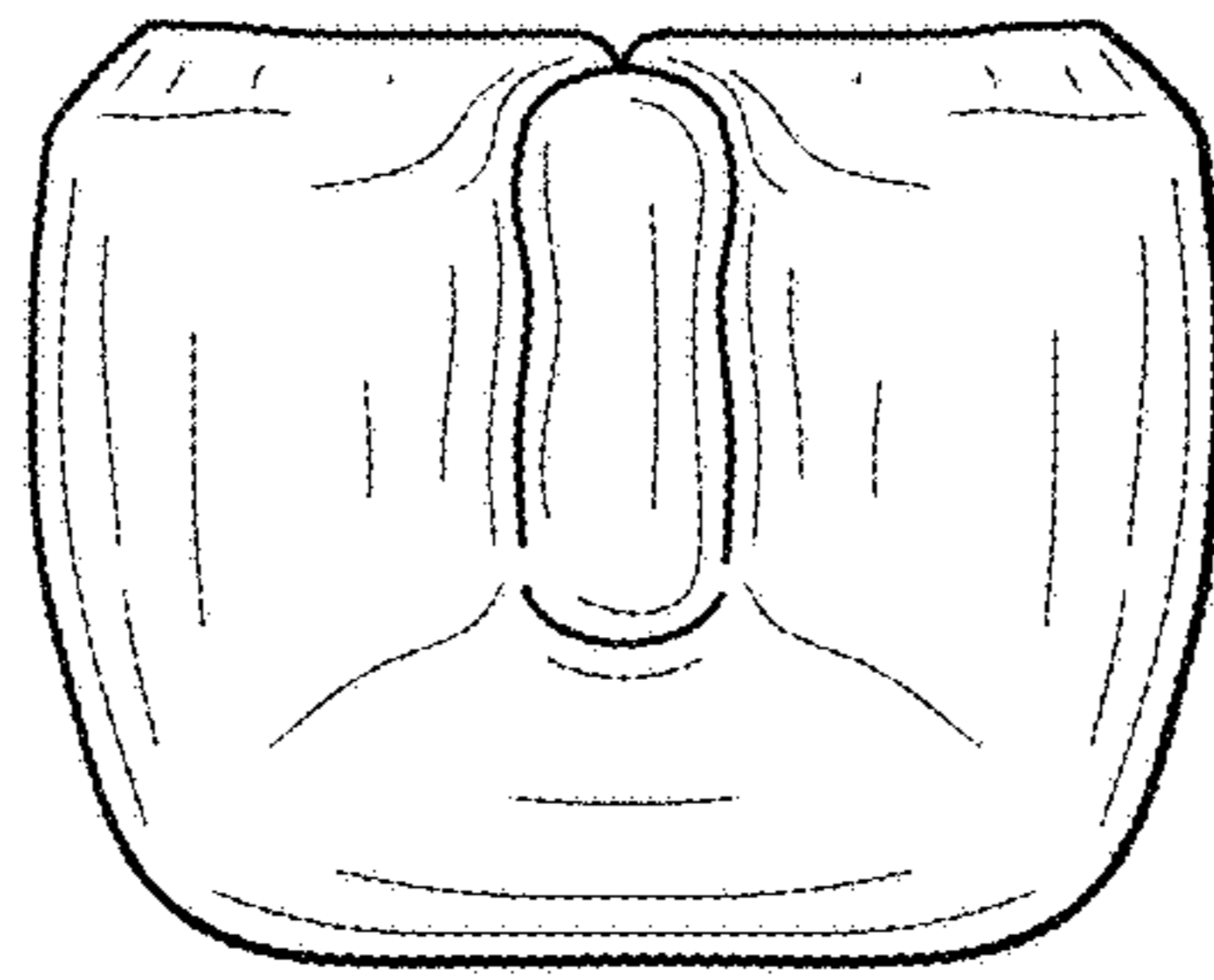

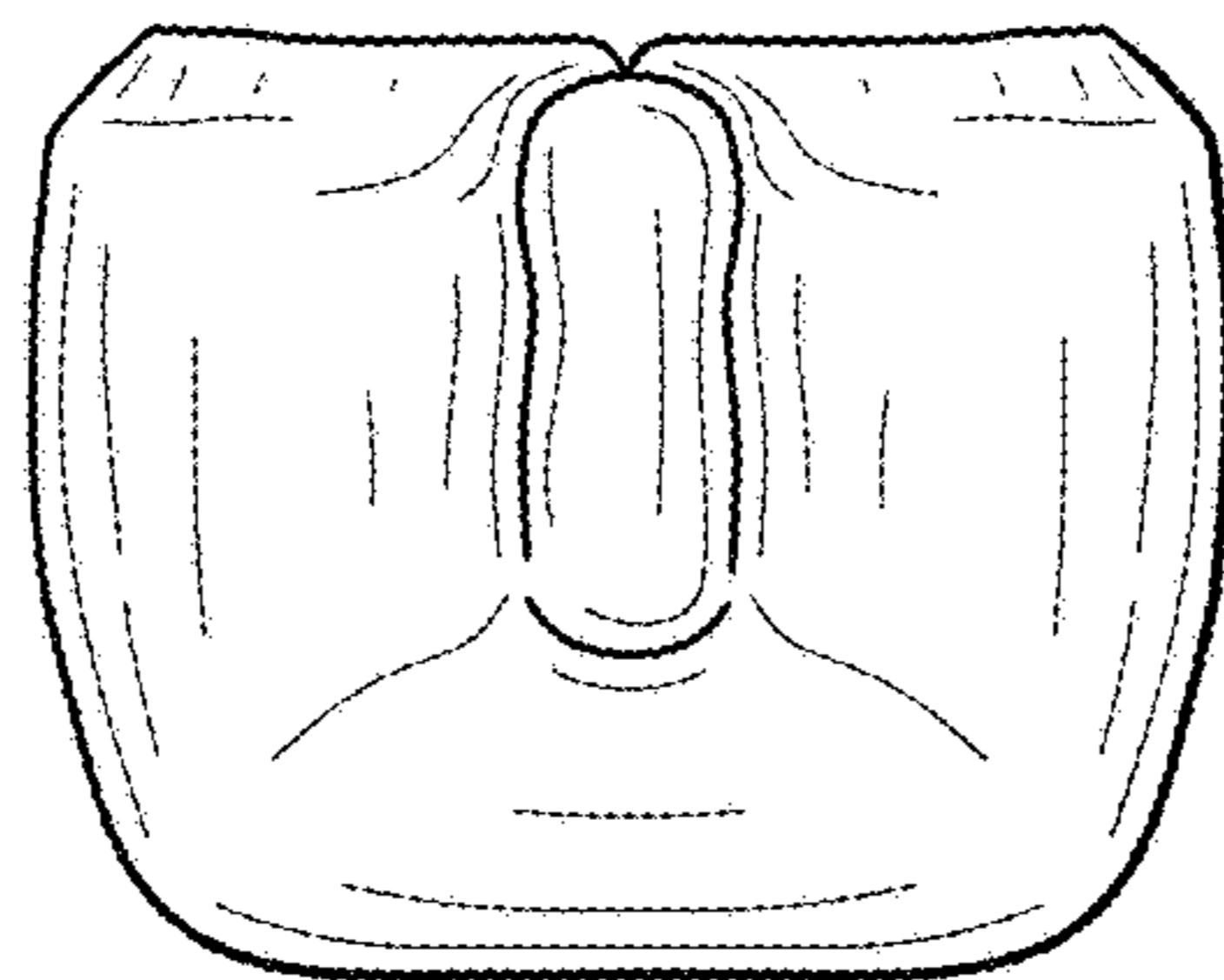
