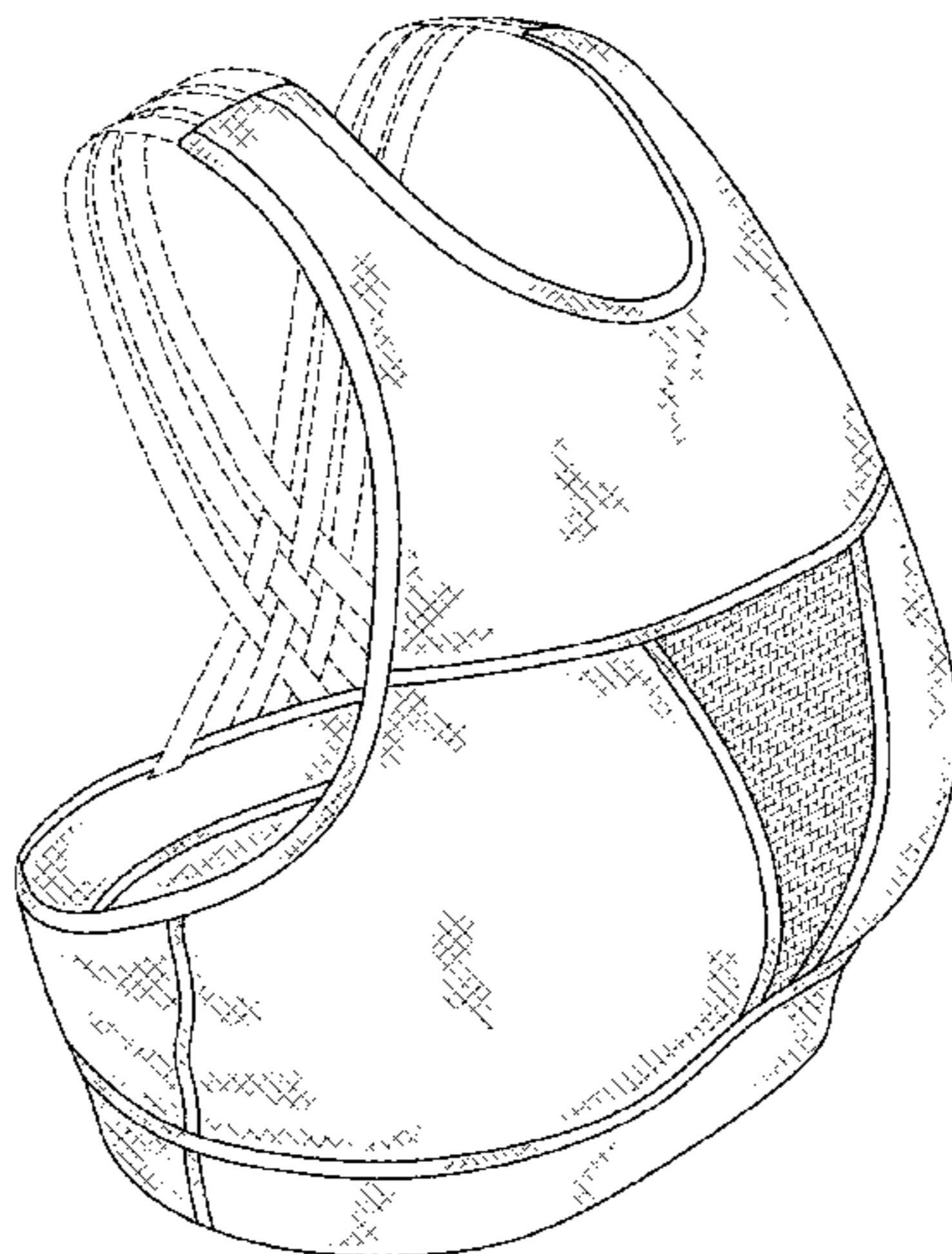
The ornamental design for an athletic shirt, as shown and described.

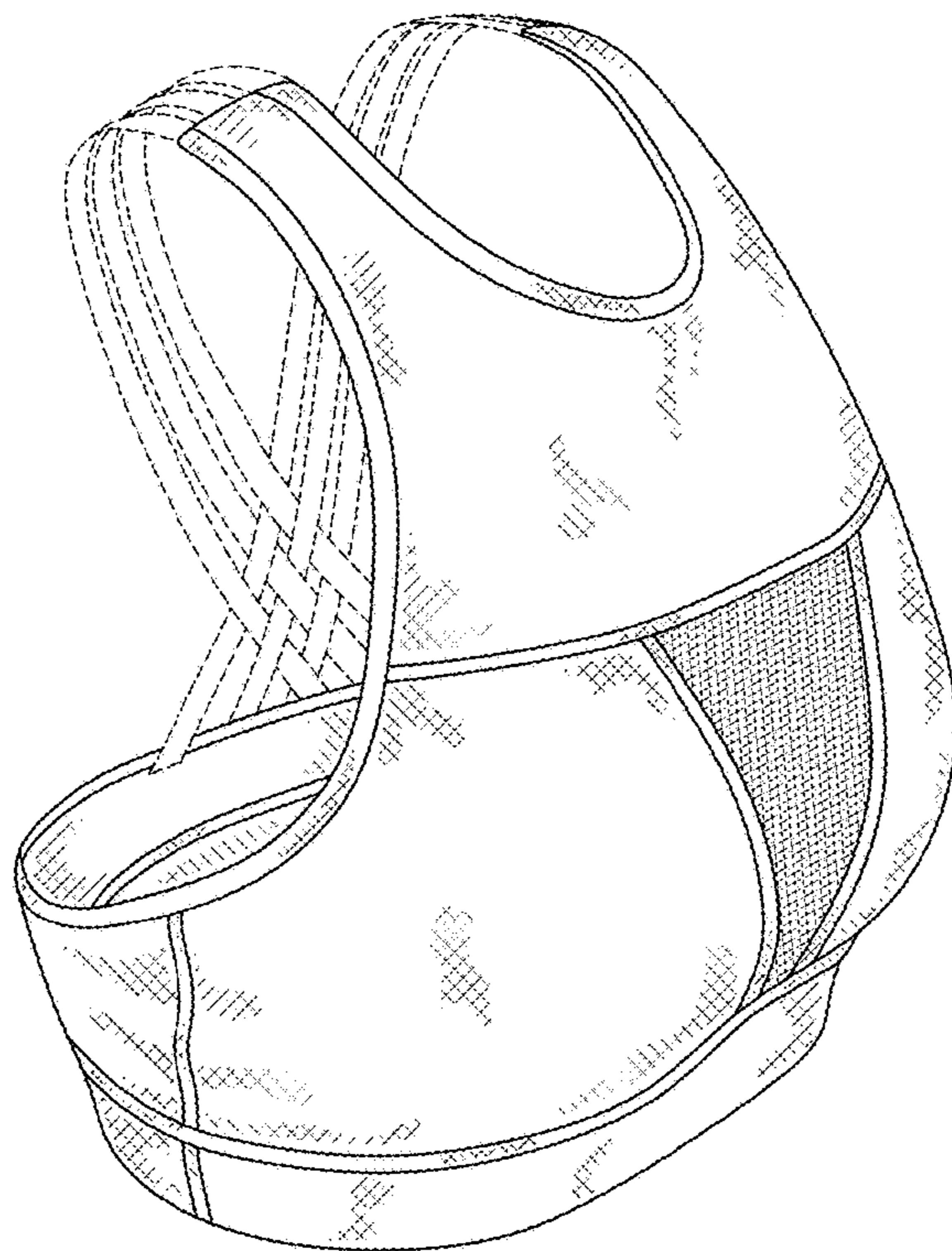

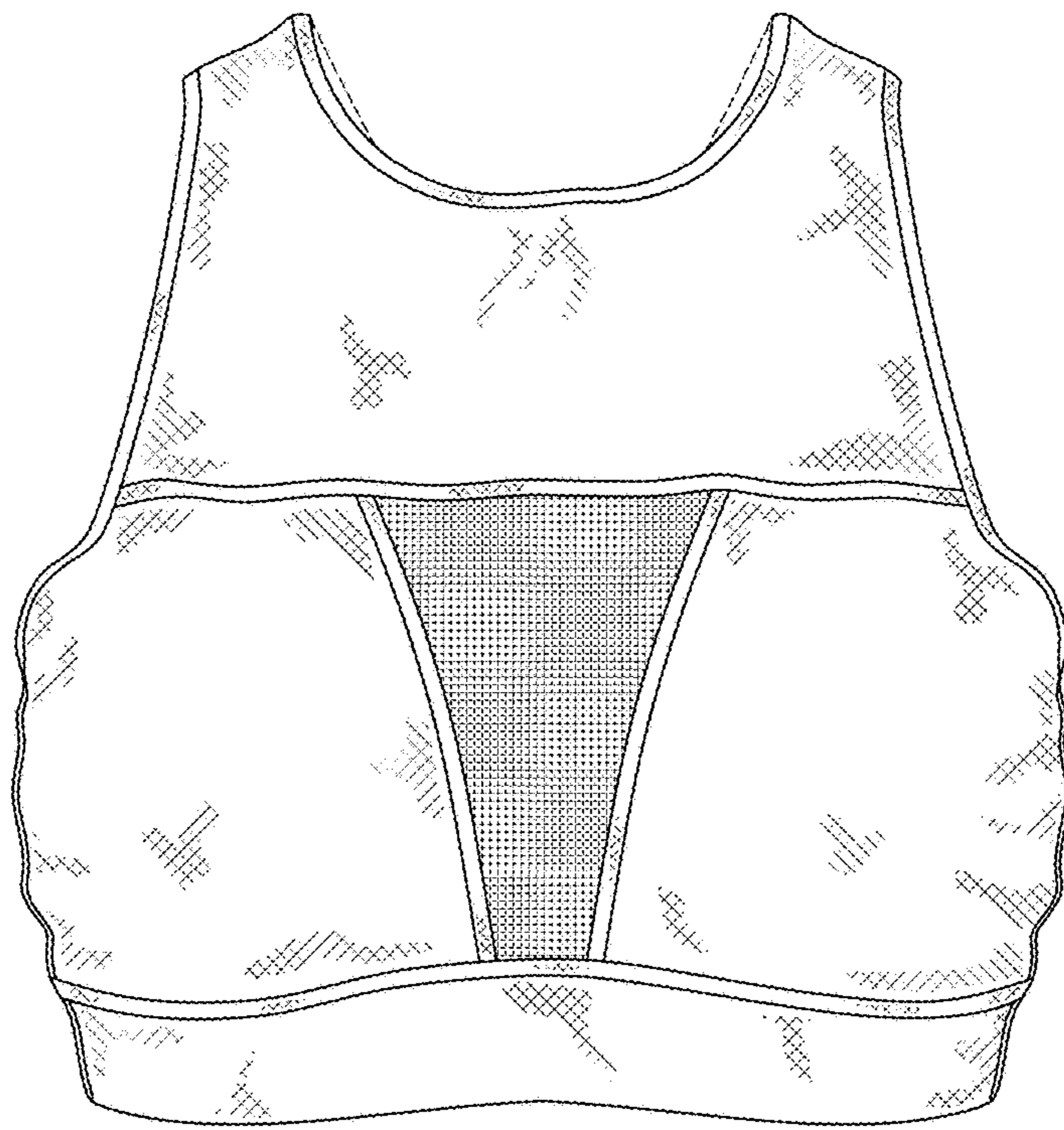

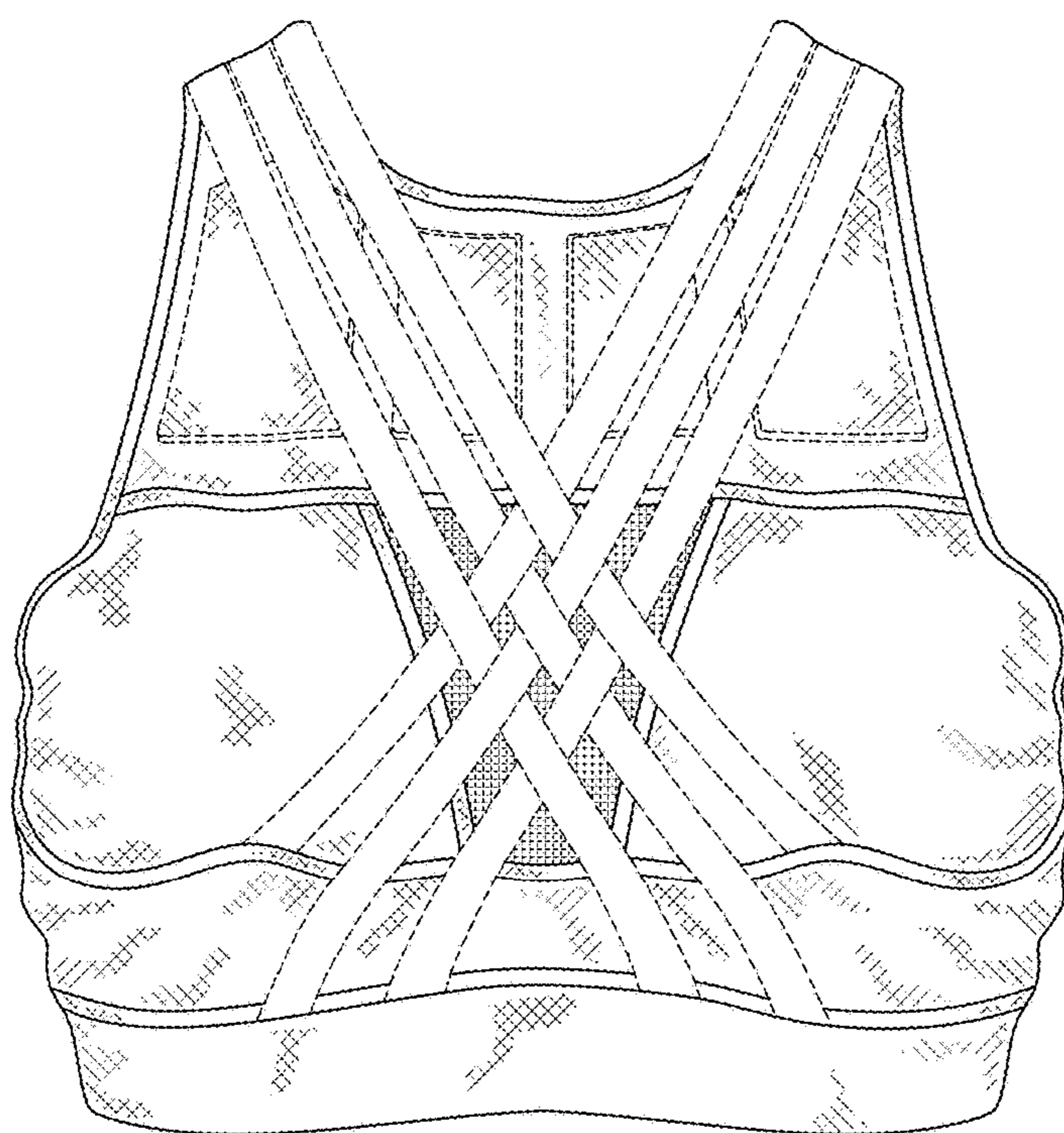

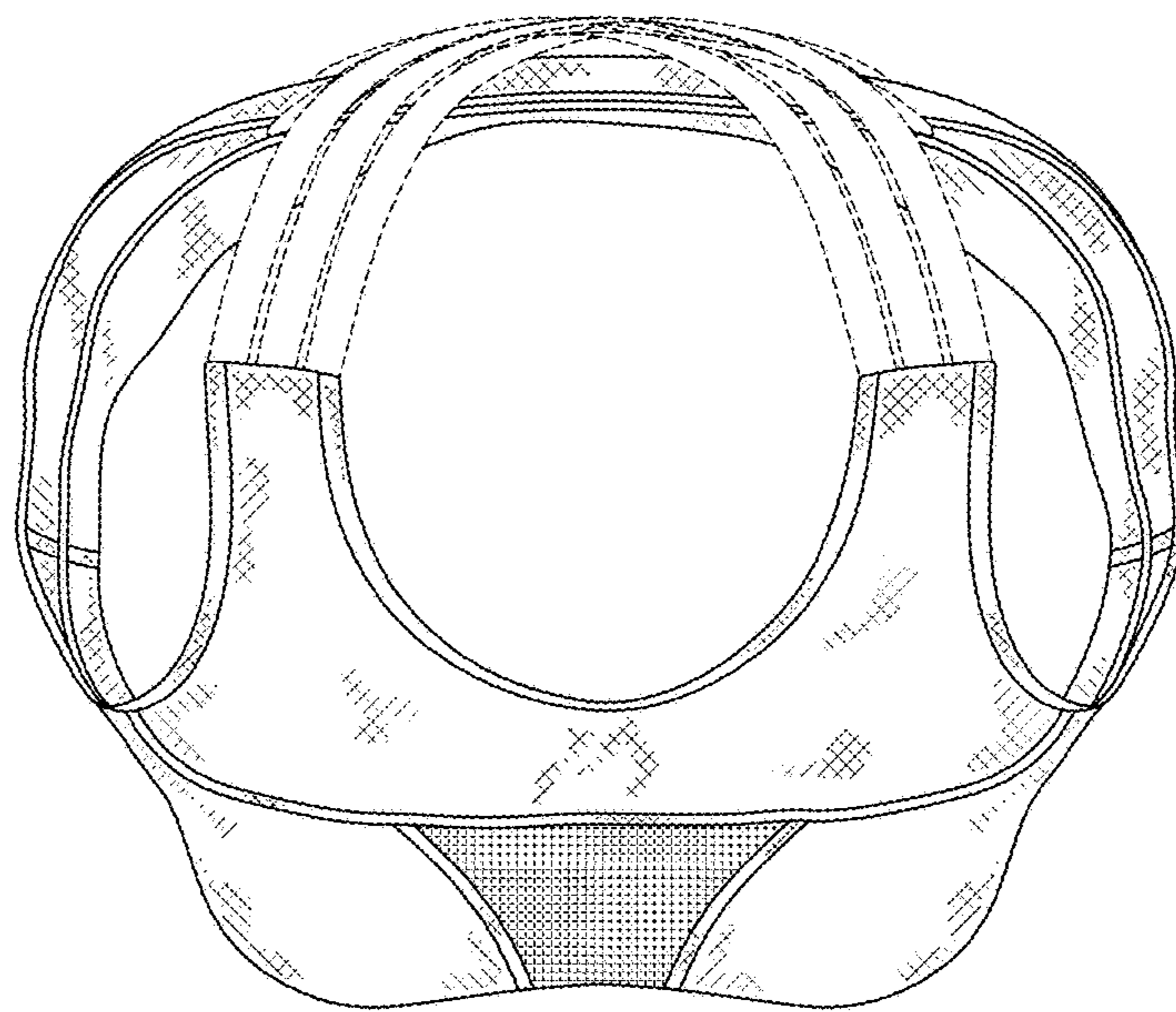

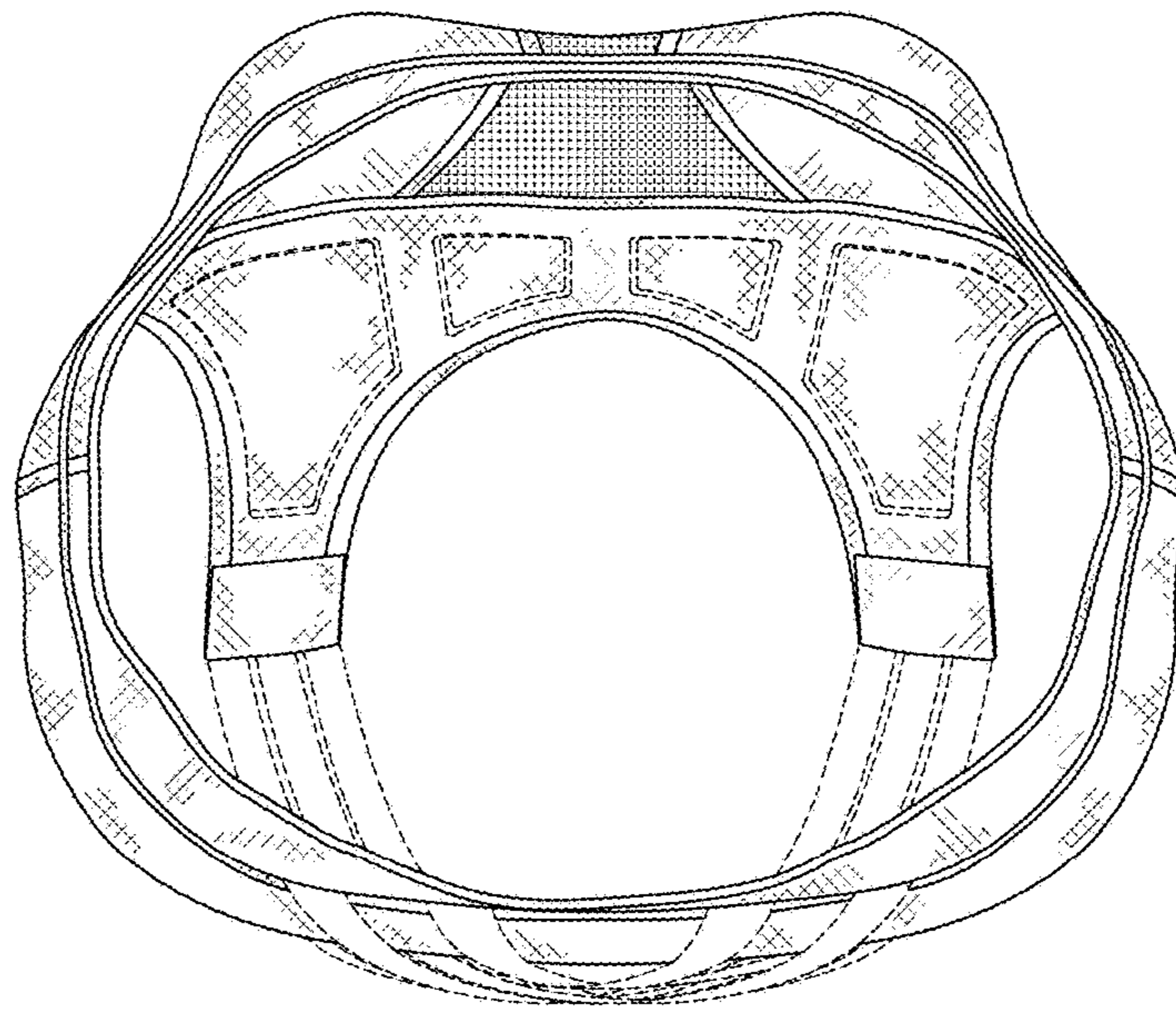

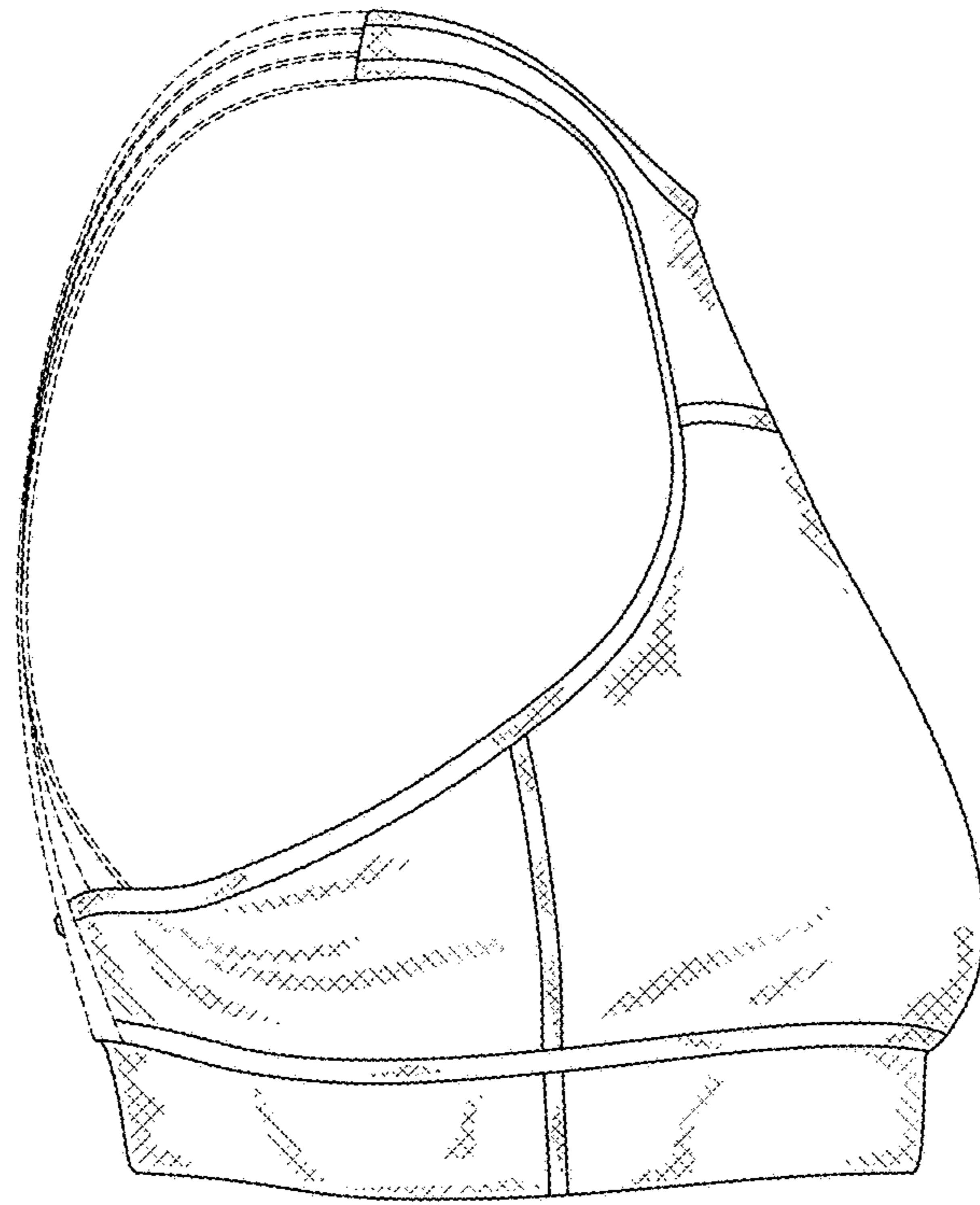

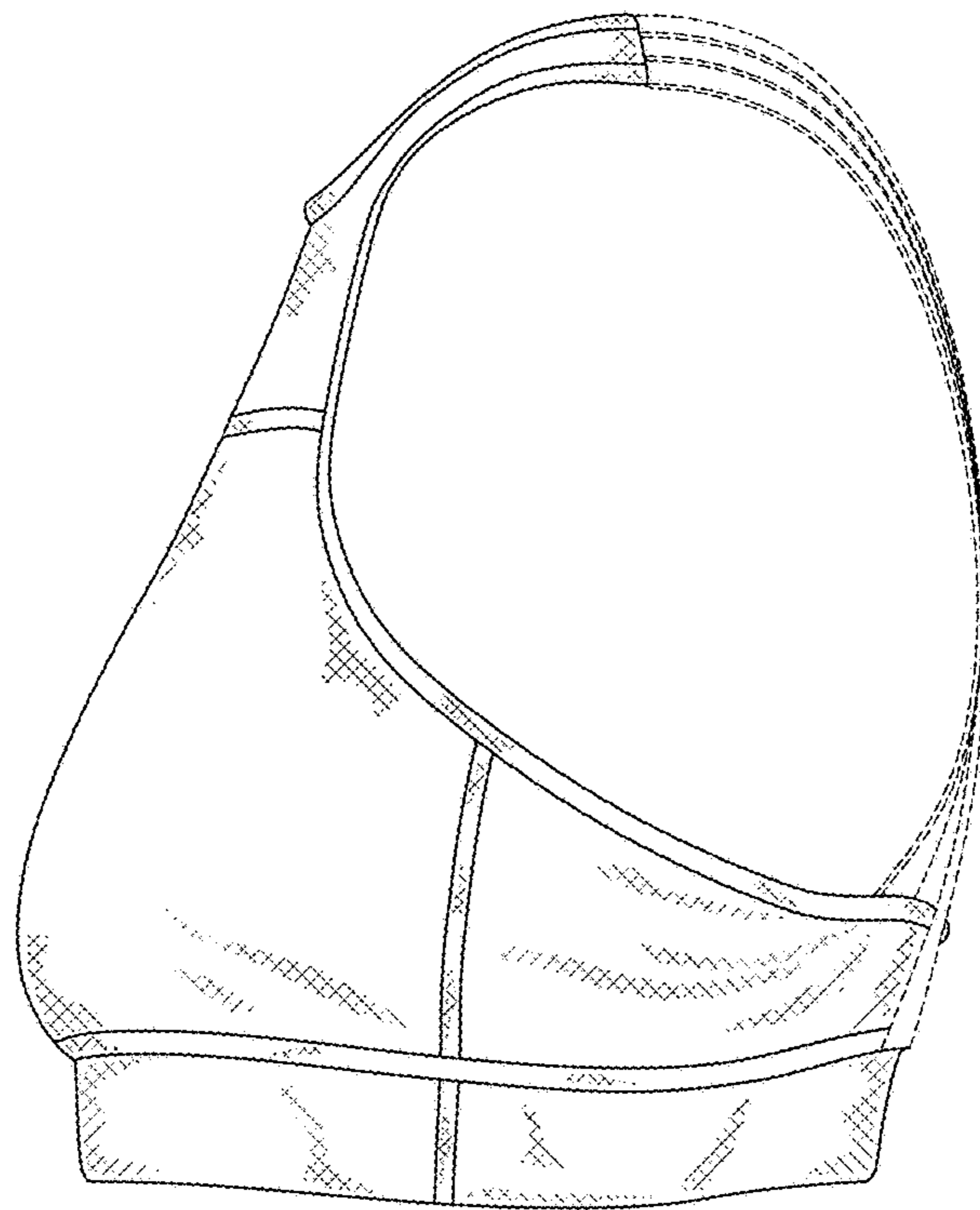
