DESCRIPTION

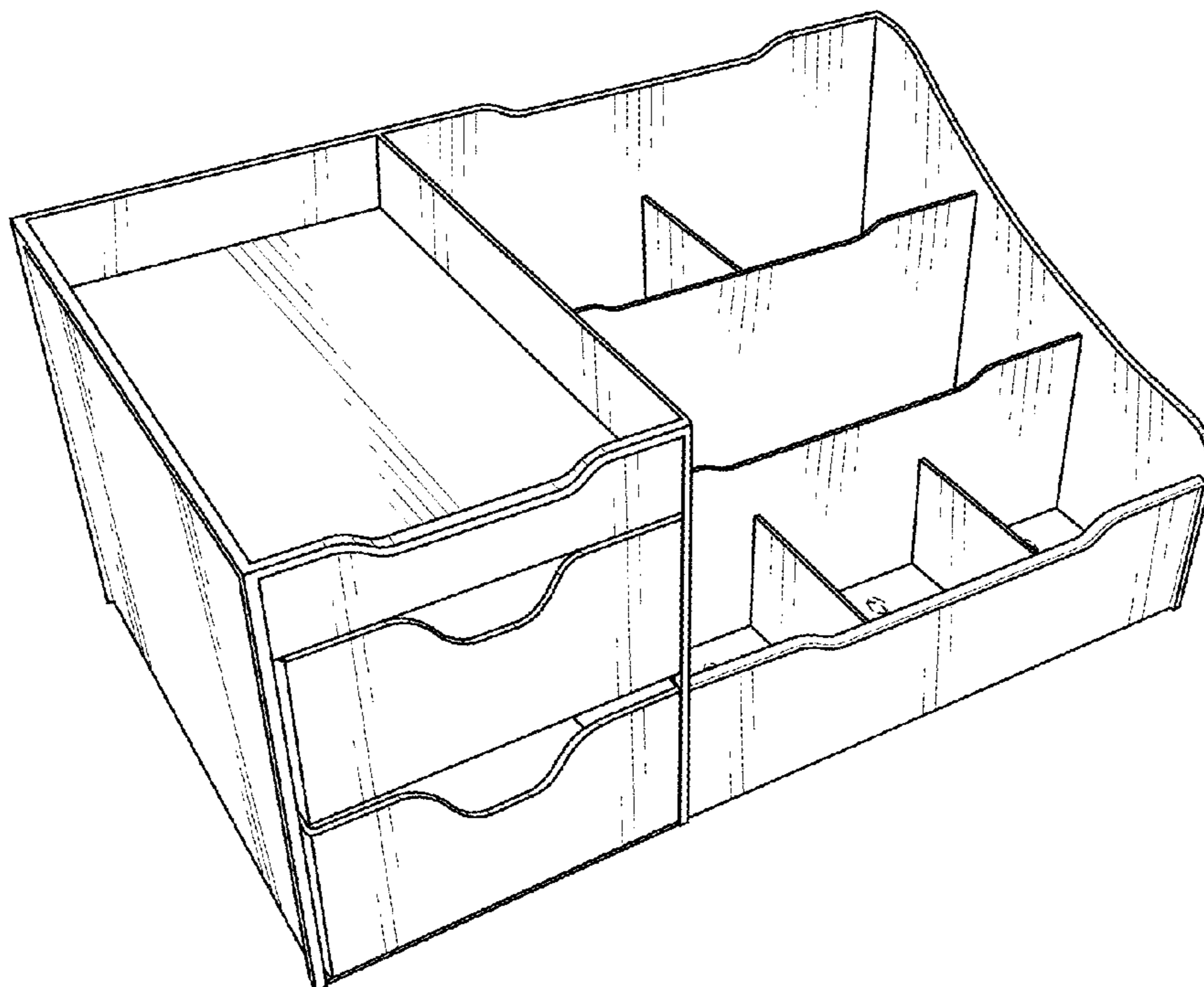
FIG. 1 illustrates a perspective view of the makeup organizer;

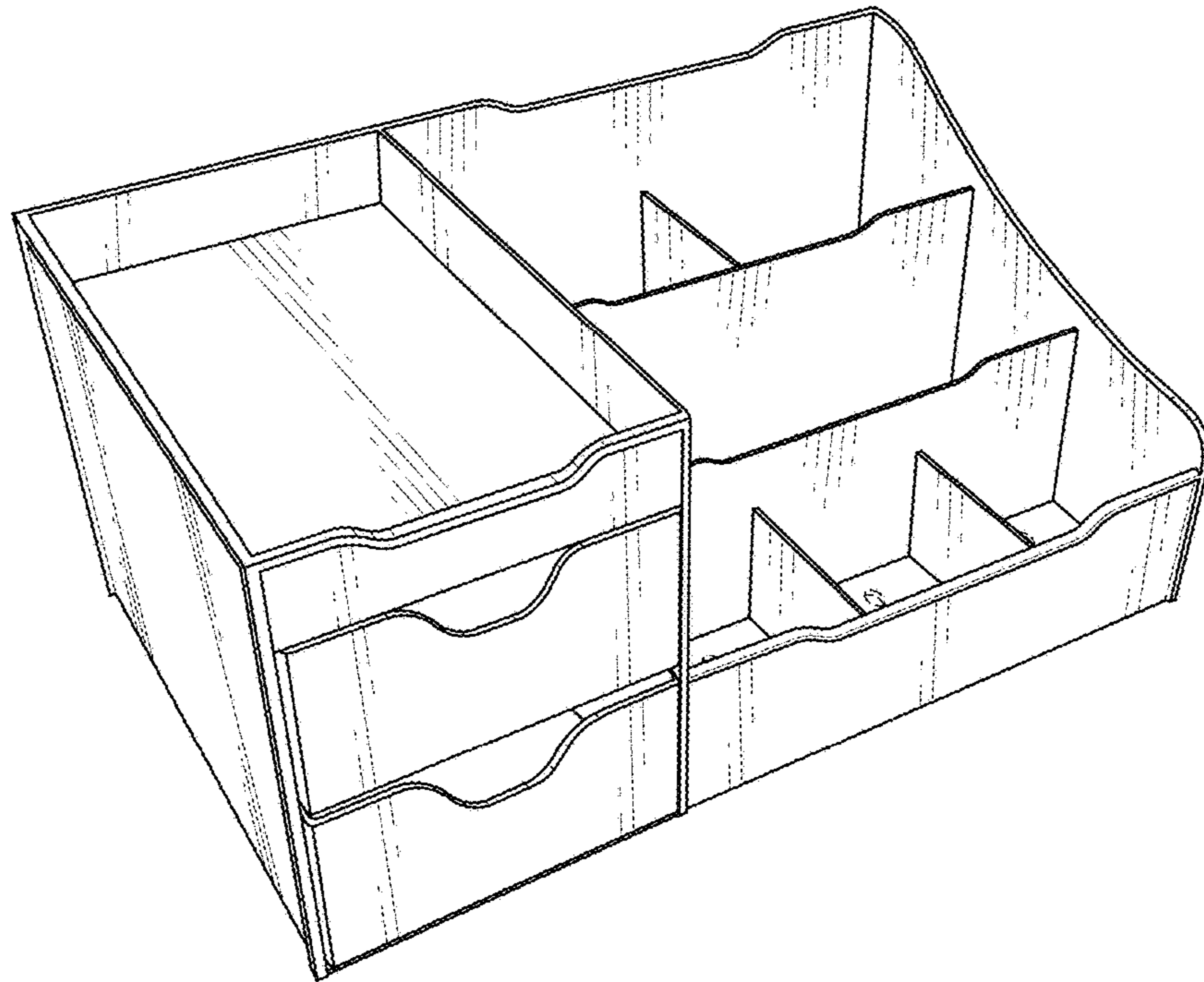

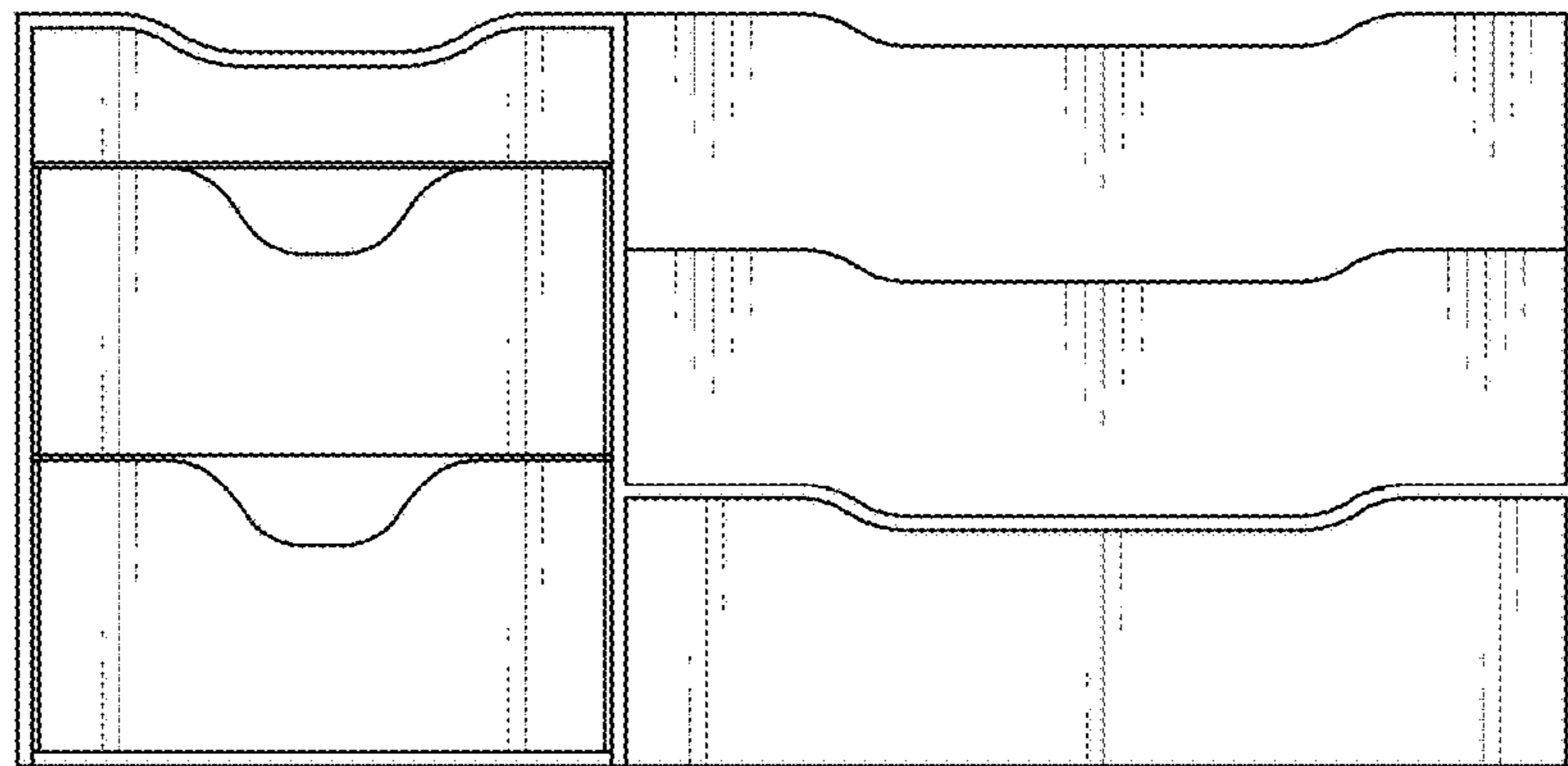

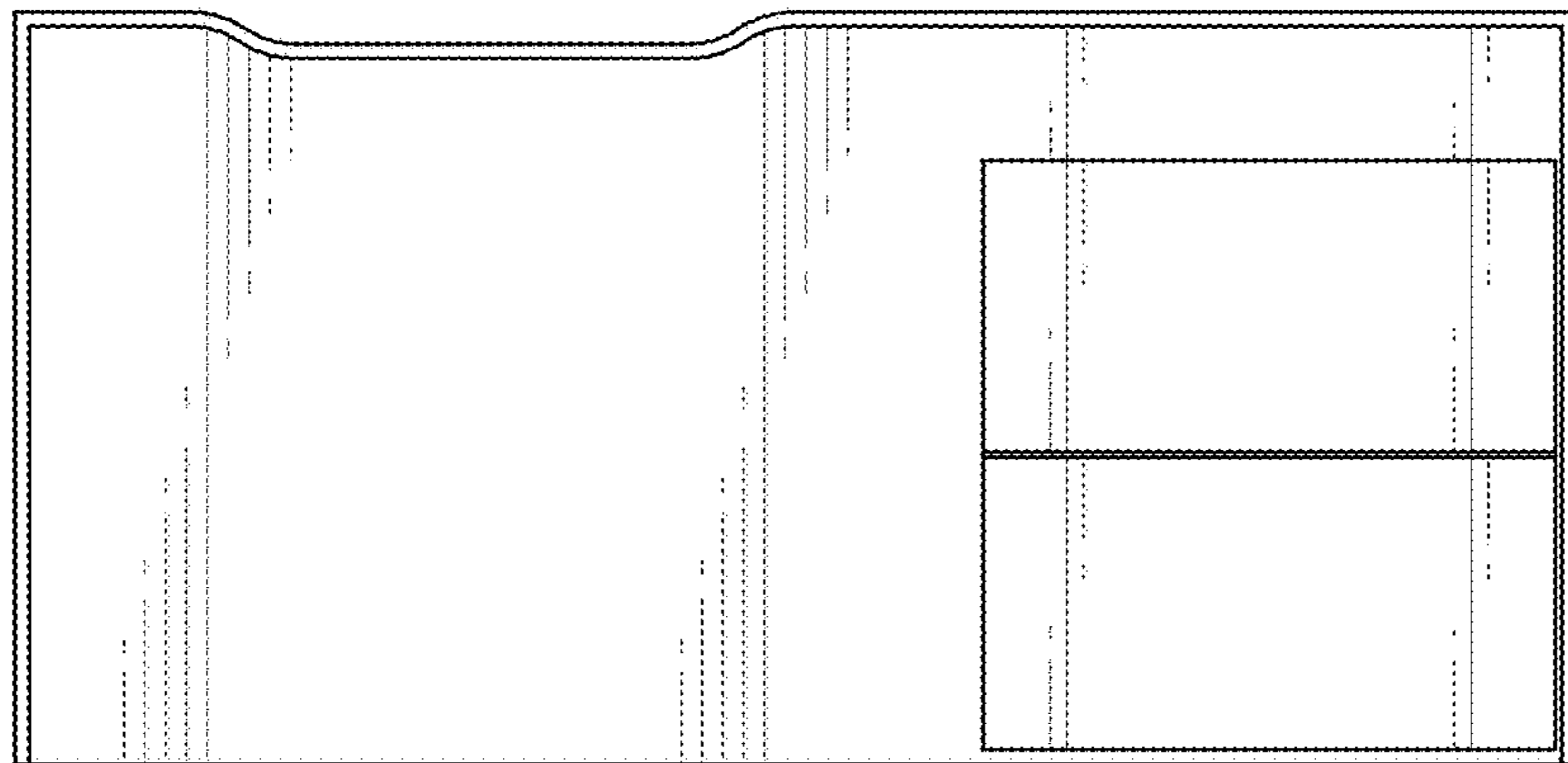

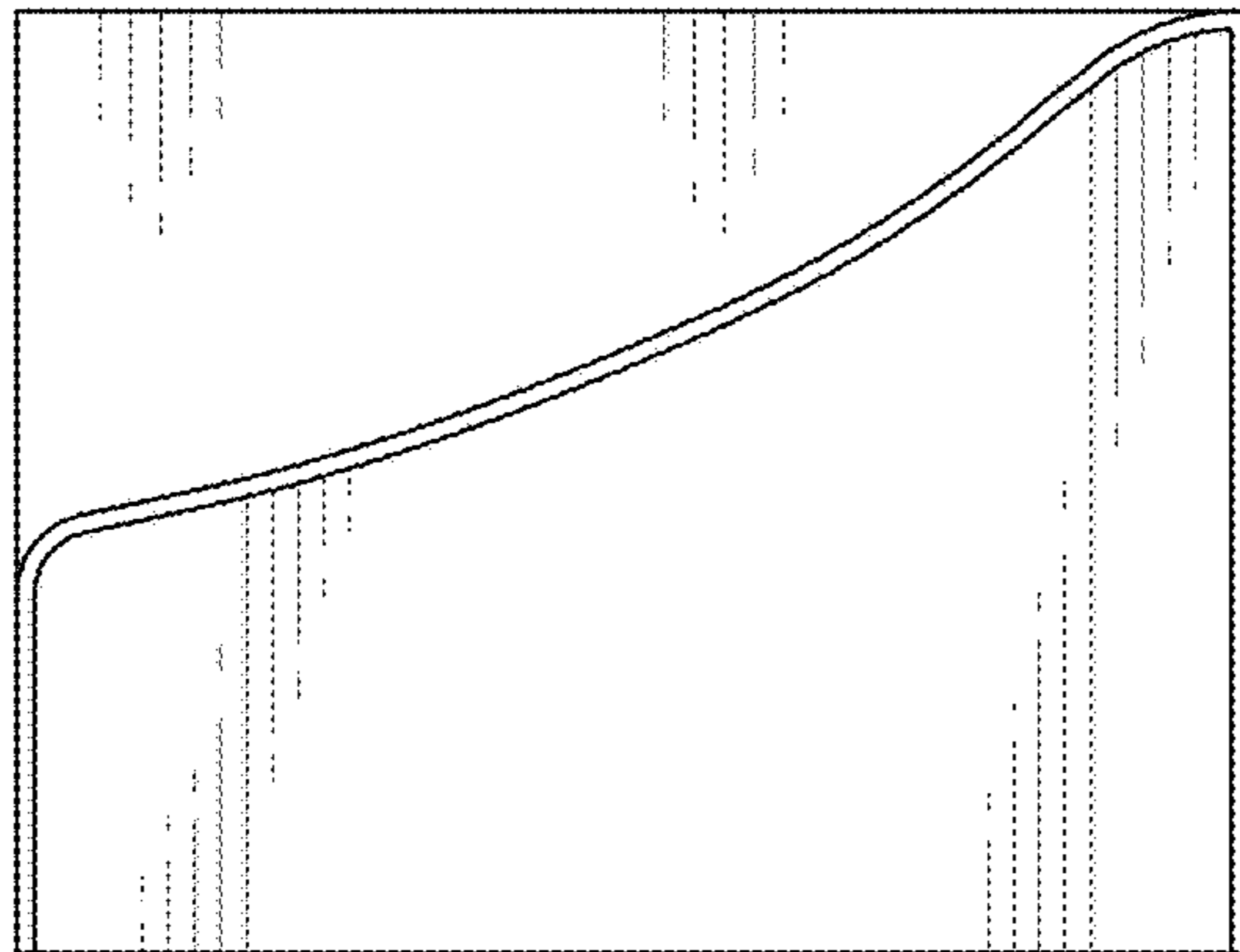

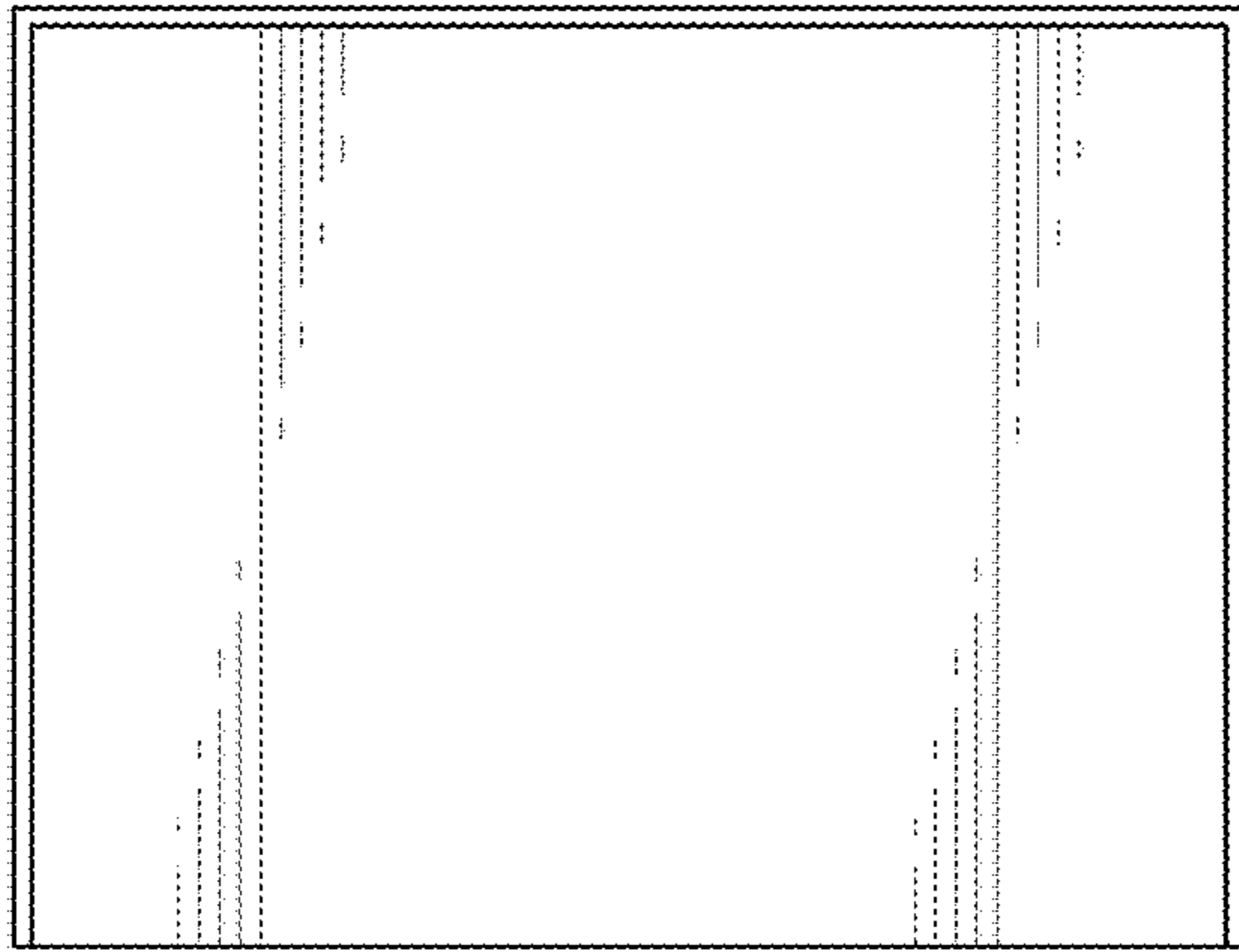

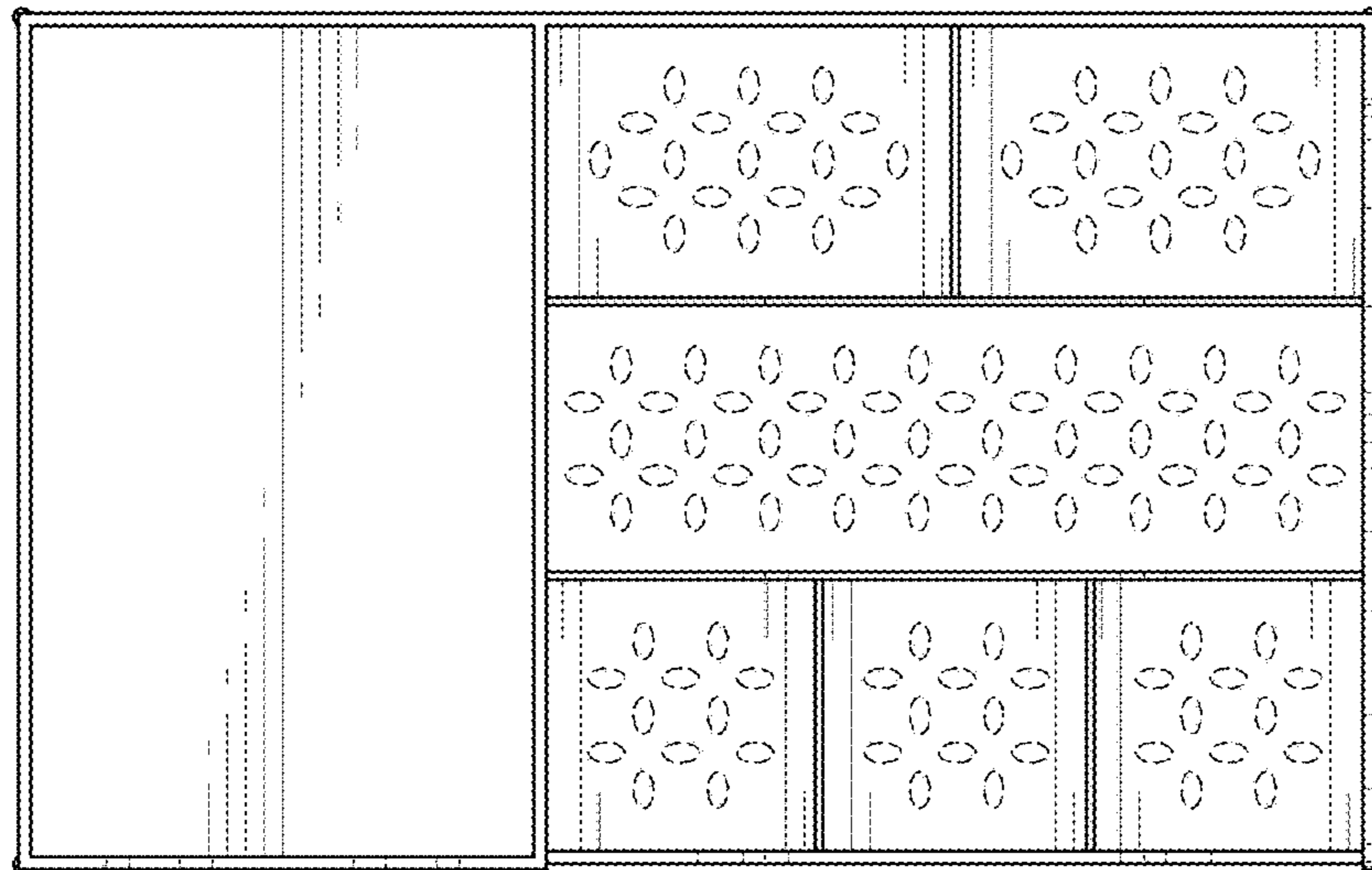

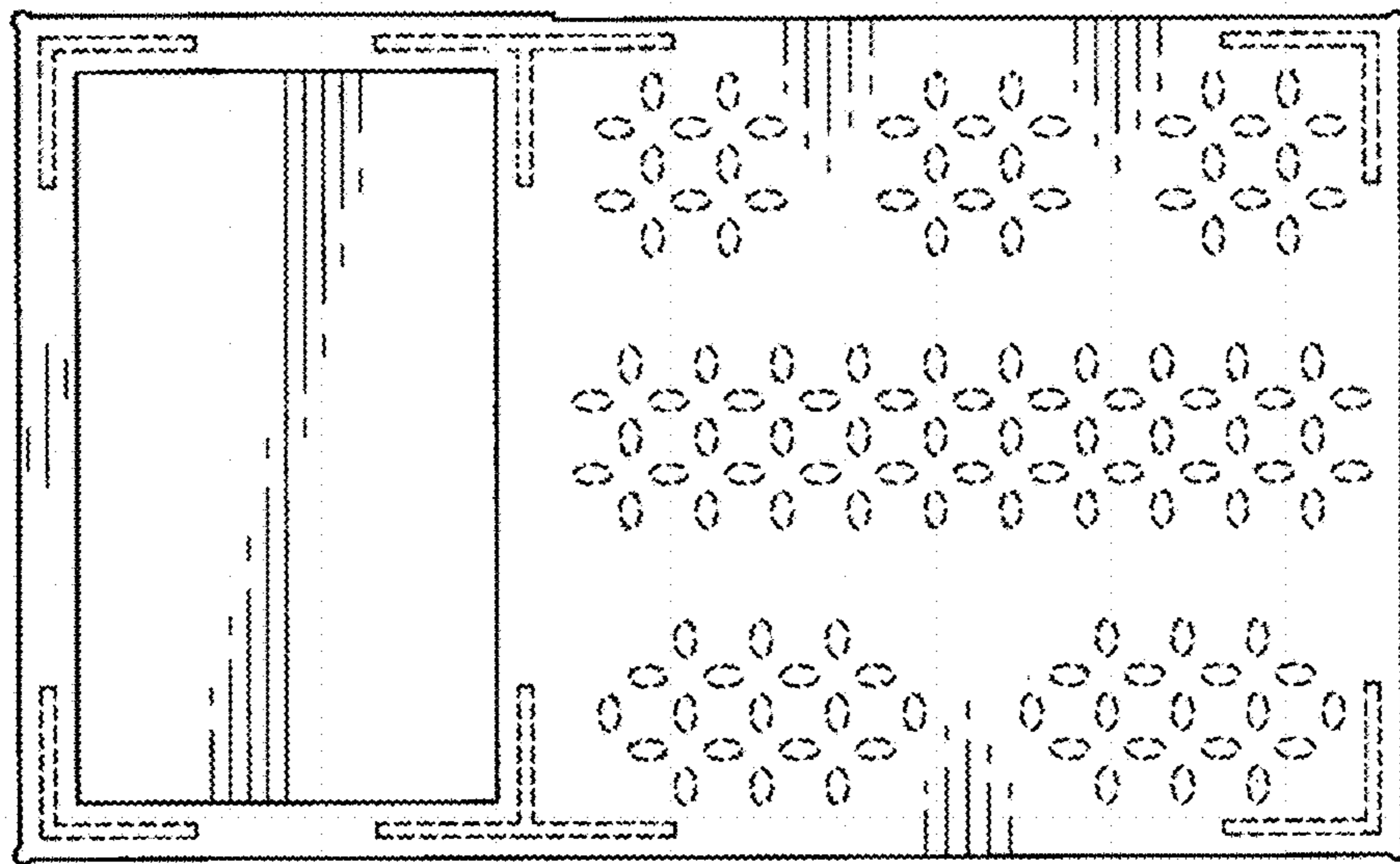
