DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of a panel clamp, showing our new design;

FIG. 2 is a bottom plan view of the invention shown in FIG. 1;

FIG. 3 is a top plan view of the invention shown in FIG. 1;

FIG. 4 is a right-side elevational view of the invention shown in FIG. 1;

FIG. 5 is a left-side elevational view of the invention shown in FIG. 1;

FIG. 6 is a rear elevational view of the invention shown in FIG. 1;

FIG. 7 is a front elevational view of the invention shown in FIG. 1;

FIG. 8 is a perspective view of the second embodiment of a panel clamp, showing our new design;

FIG. 11 is a right-side elevational view of the invention shown in FIG. 8;


FIG. 12 is a left-side elevational view of the invention shown in FIG. 8;




























