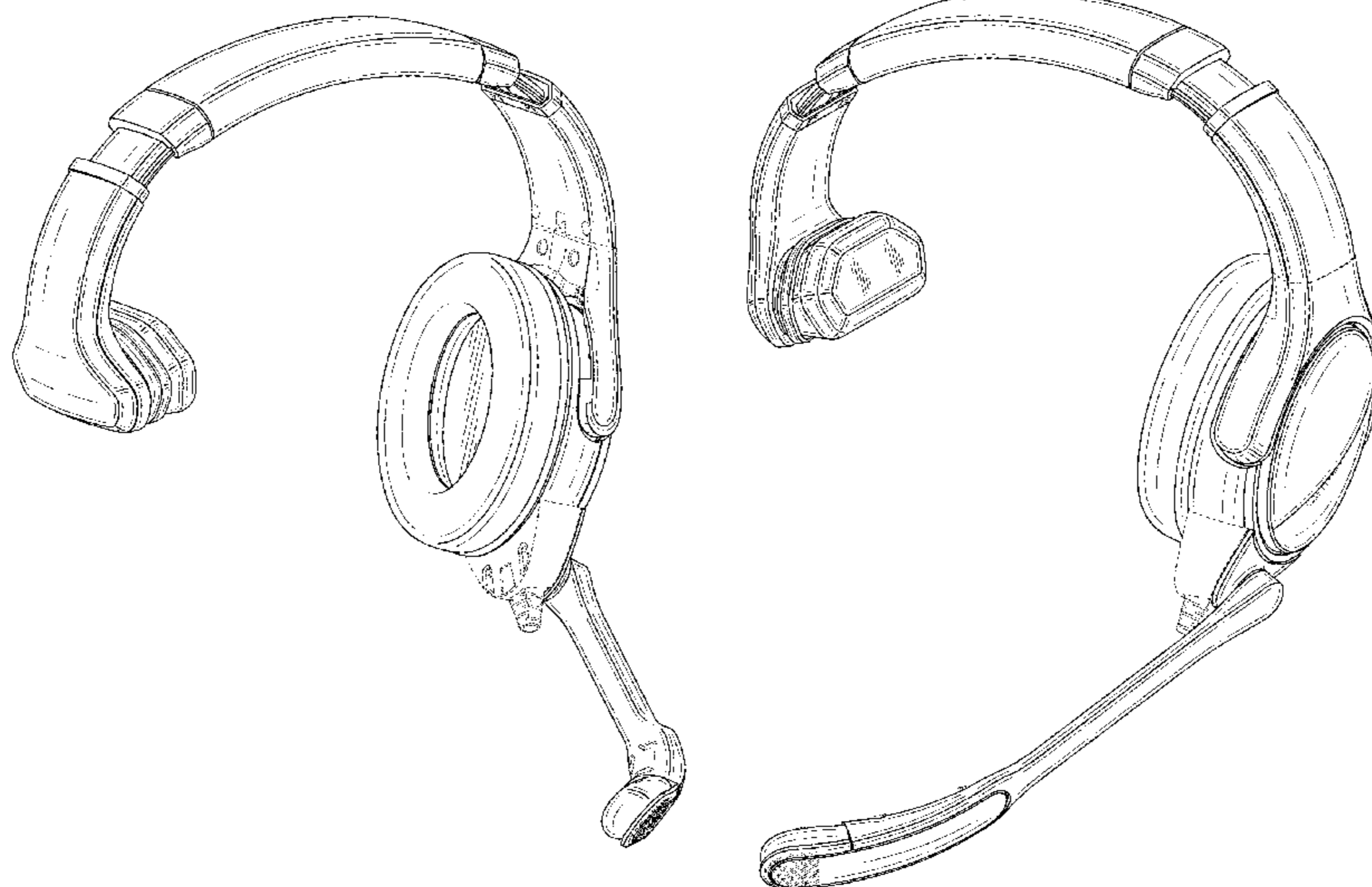
(57) **CLAIM**

The ornamental design for headset, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a headset having one ear cup as seen from the front and right side;  
FIG. 2 is a perspective view thereof as seen from the front and left side;  
FIG. 3 is a front view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a back view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a top view thereof; and,  
FIG. 8 is a bottom view thereof.  
FIGS. 1-8 show a headset with a left-side ear cup and a boom microphone connected to the left-side ear cup. A mirror image design is a headset with a right-side ear cup and a boom microphone connected to the right-side ear cup. The dotted line portions of the drawings represent environmental structure only and do not form part of the claimed design.

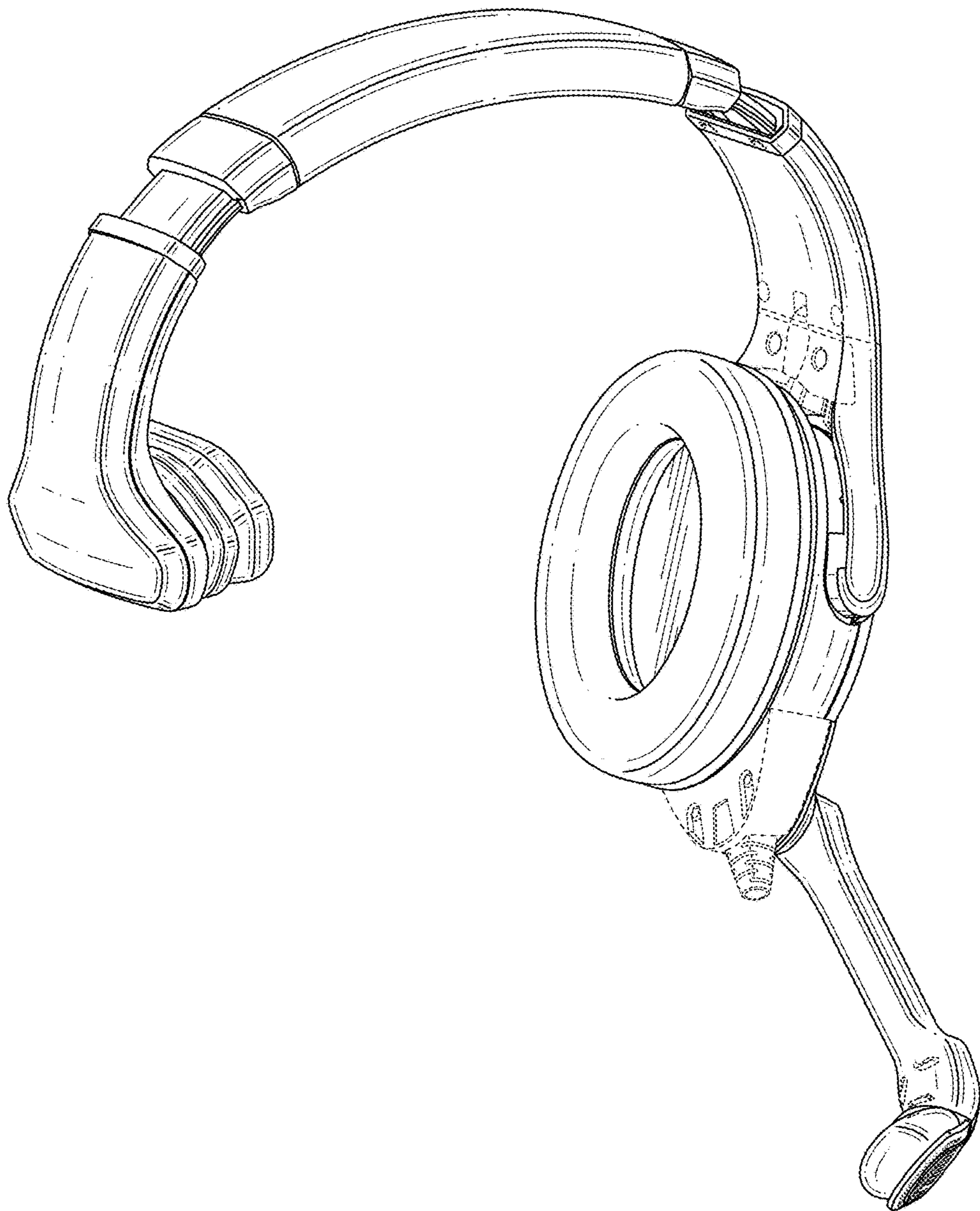

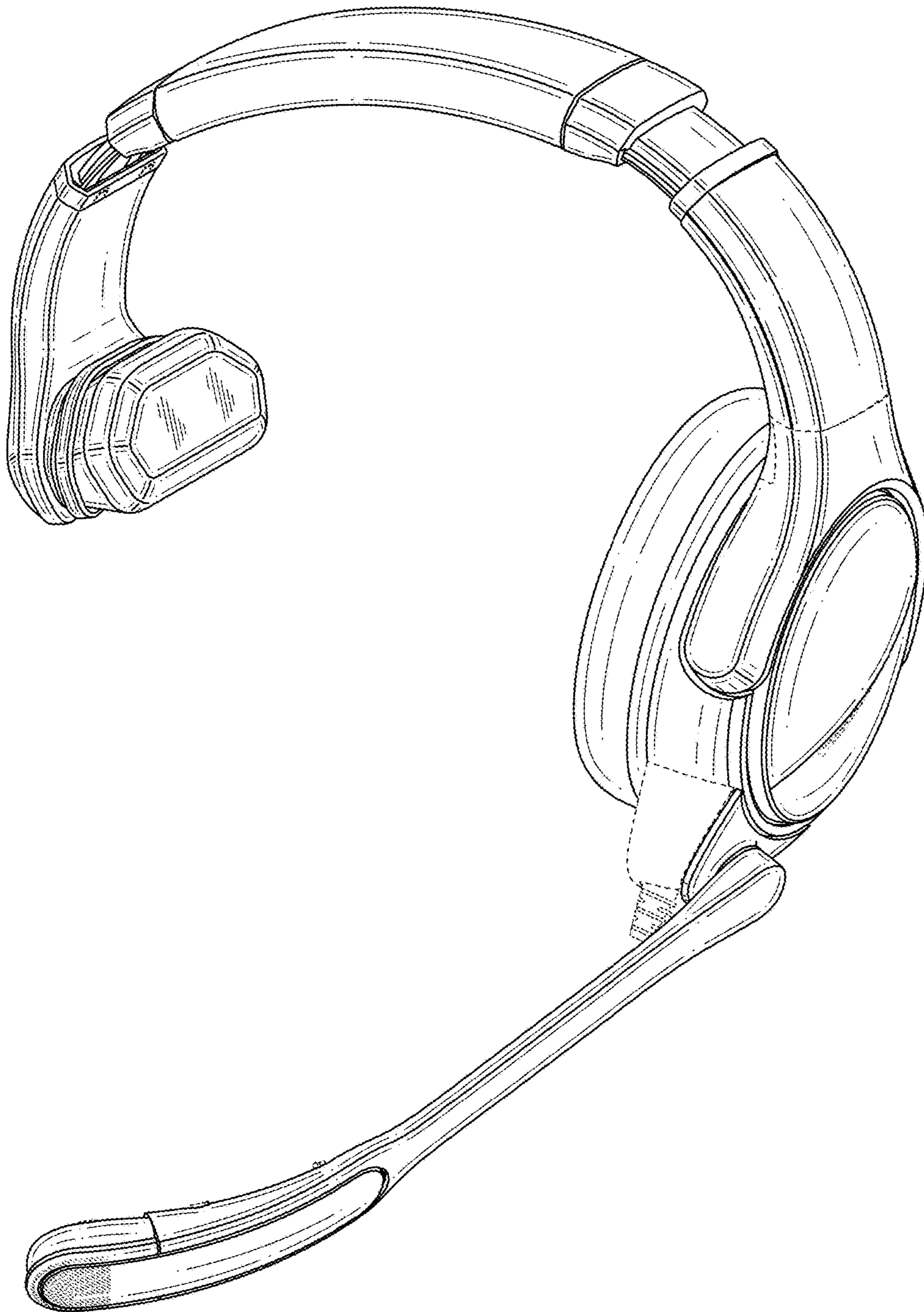
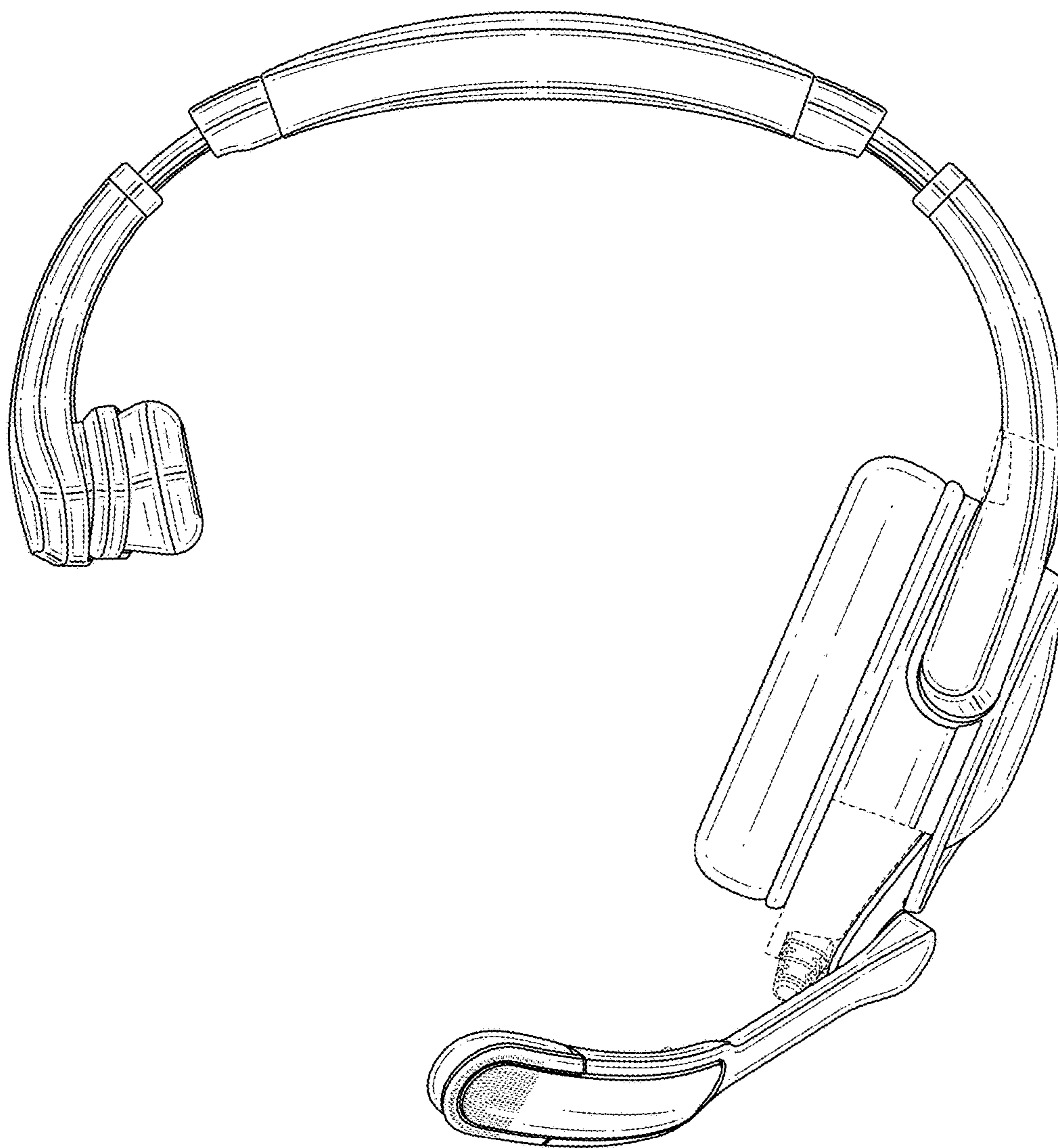

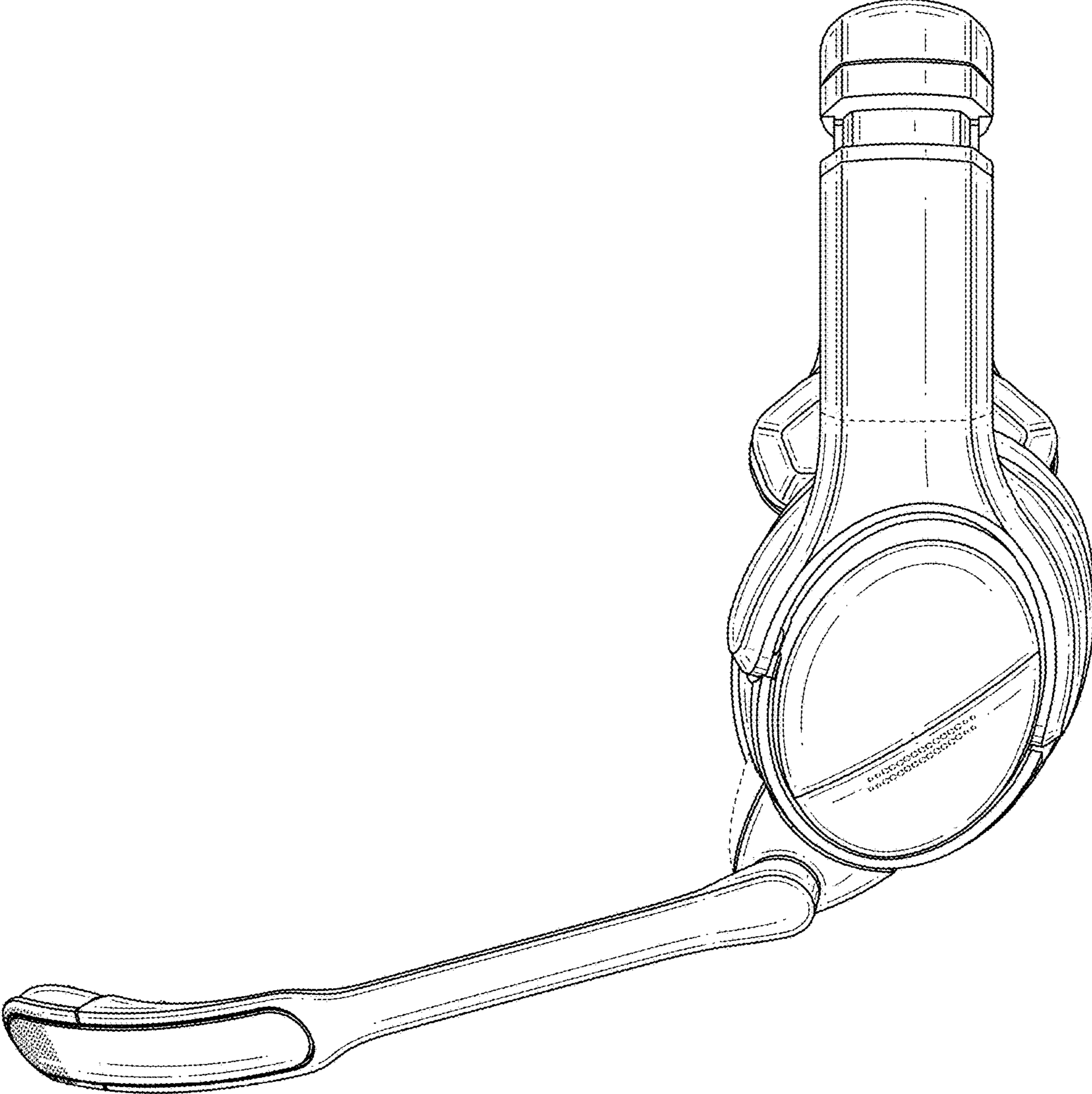

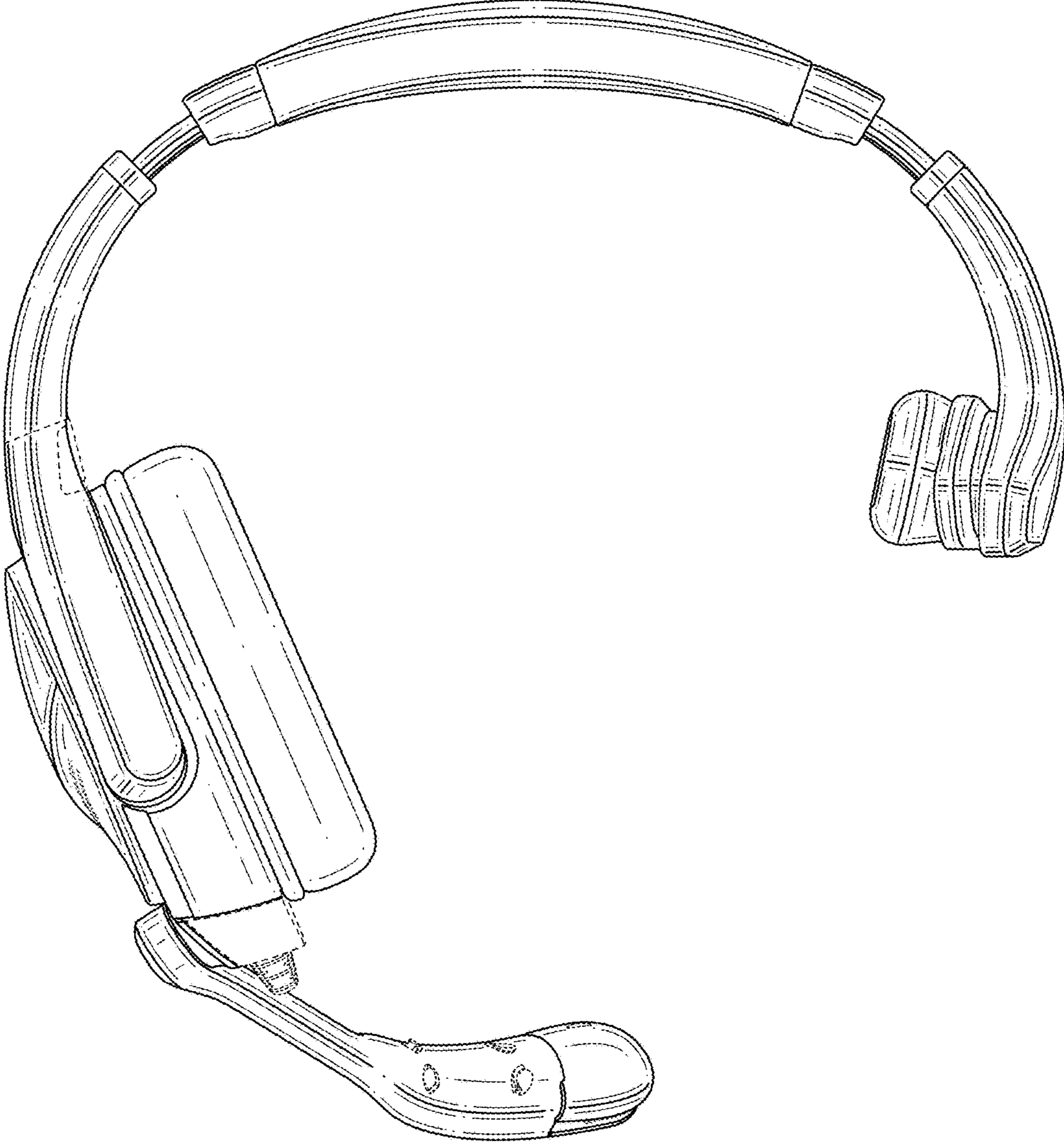

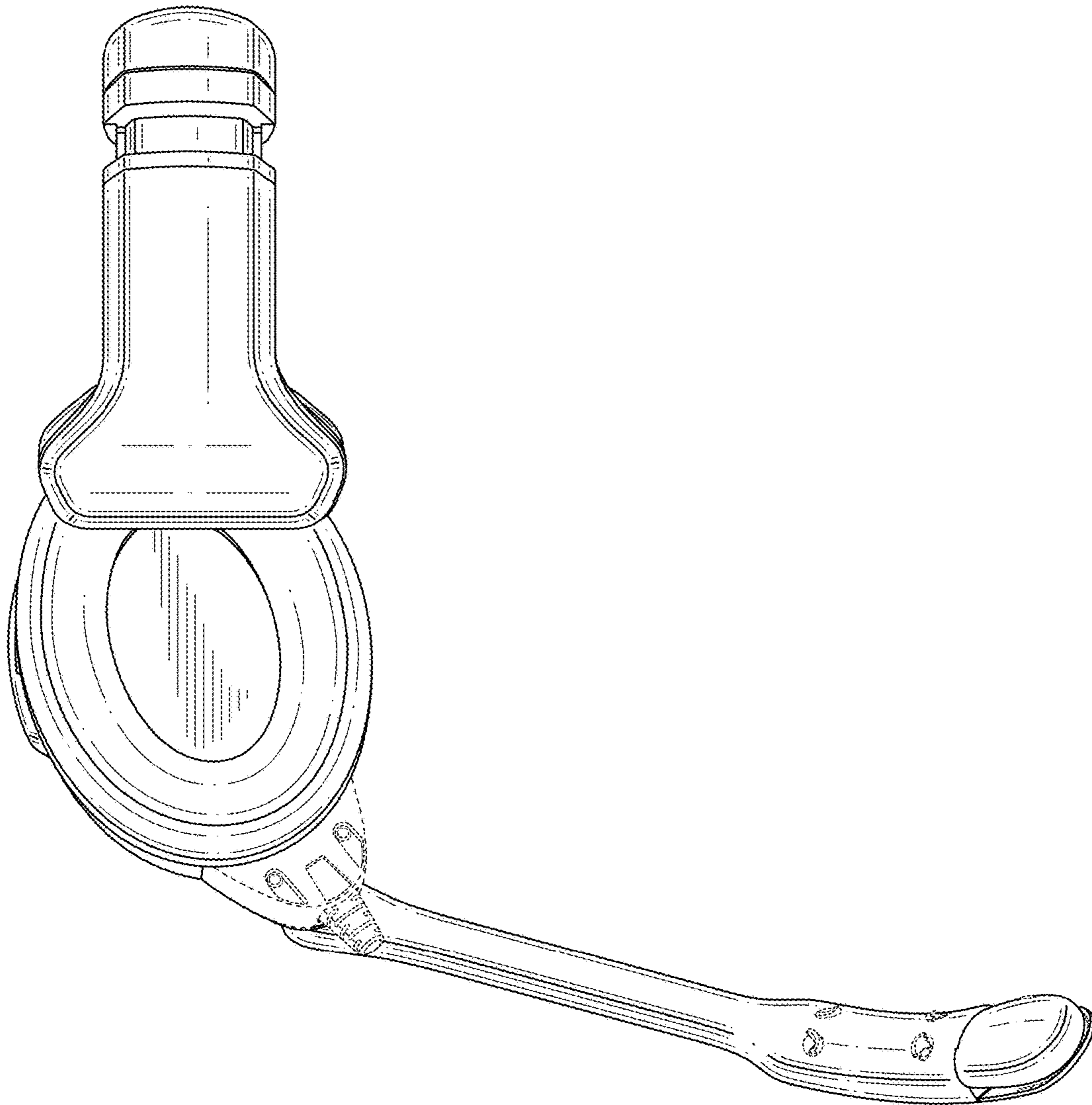

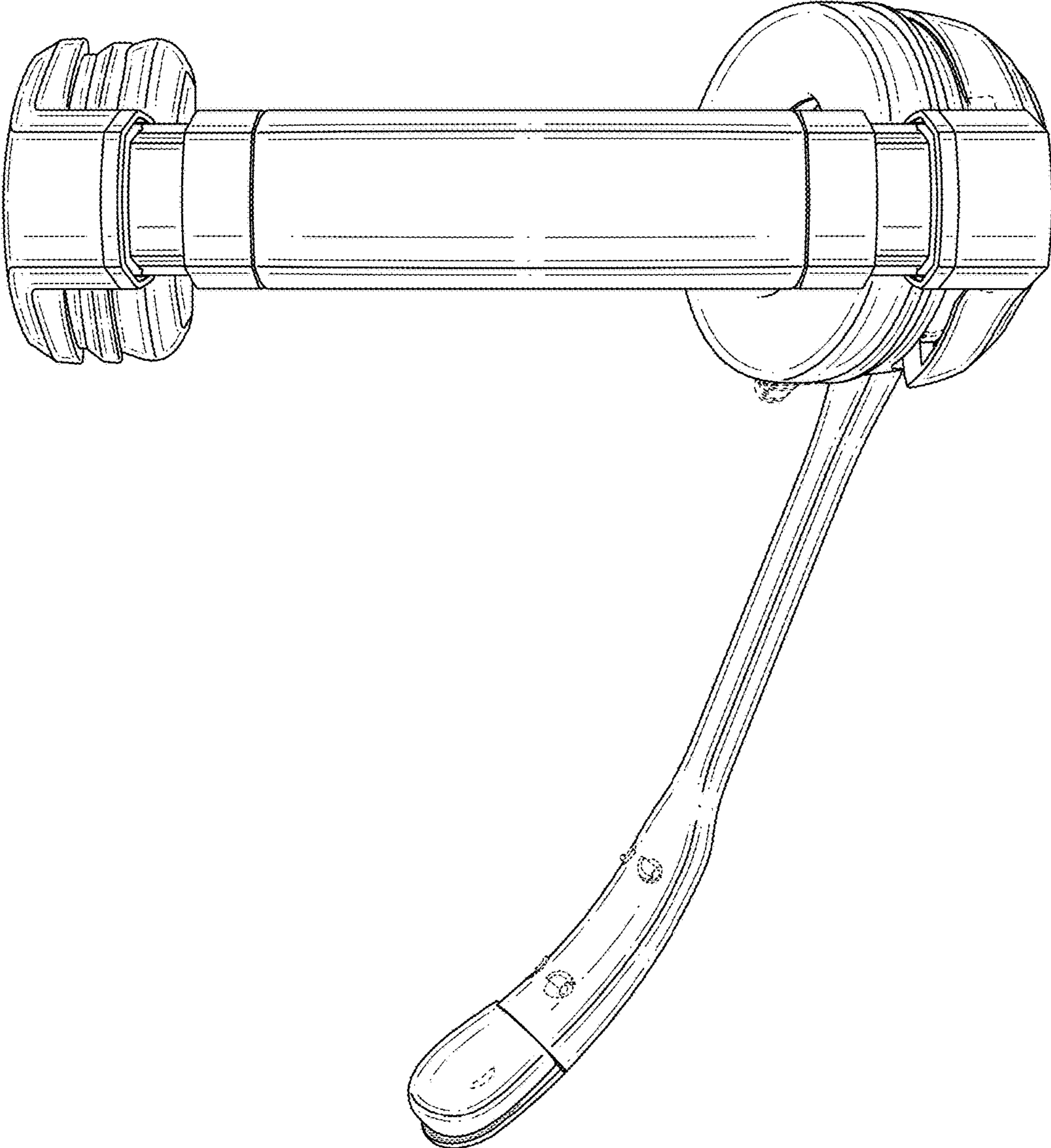
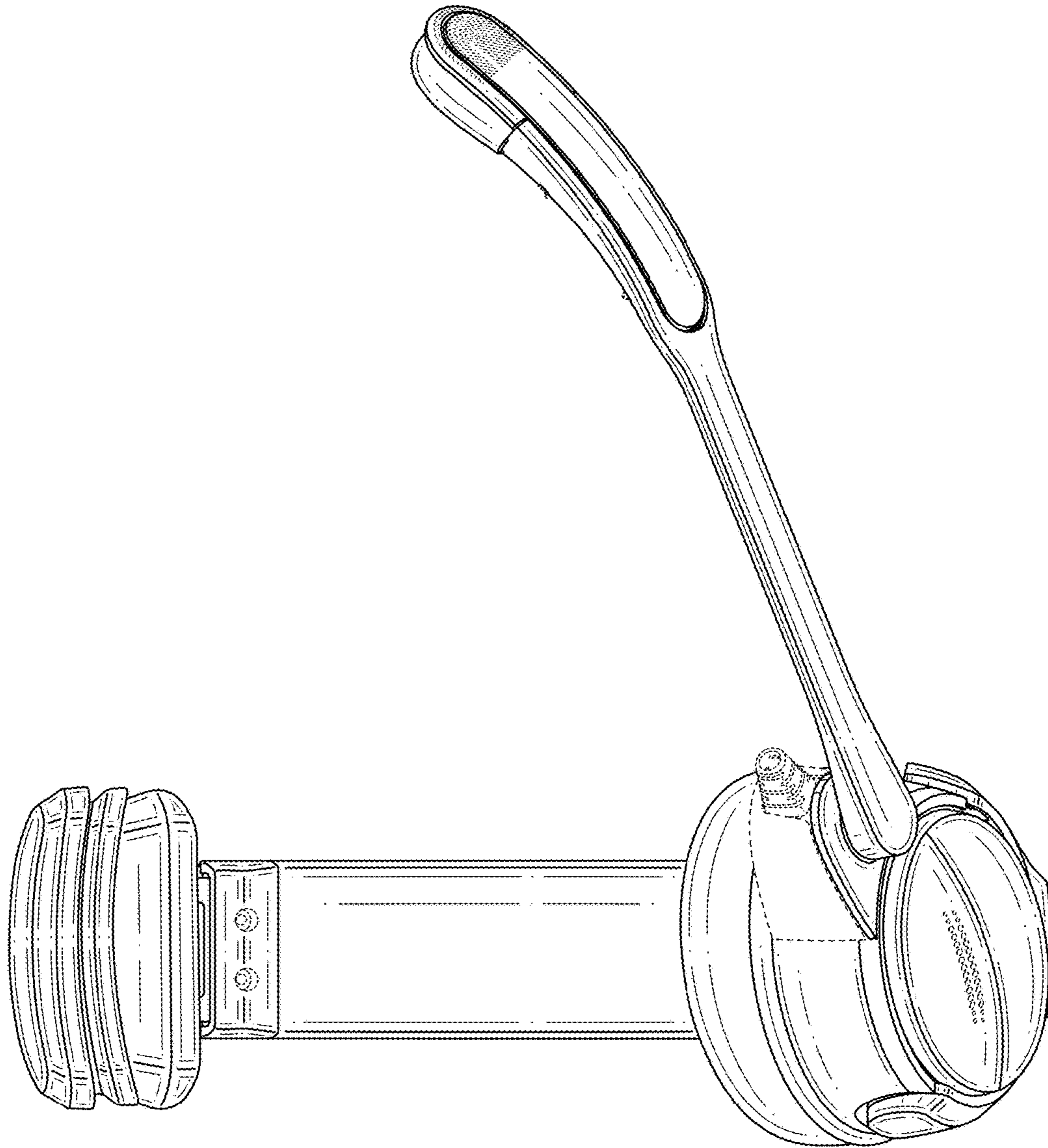
