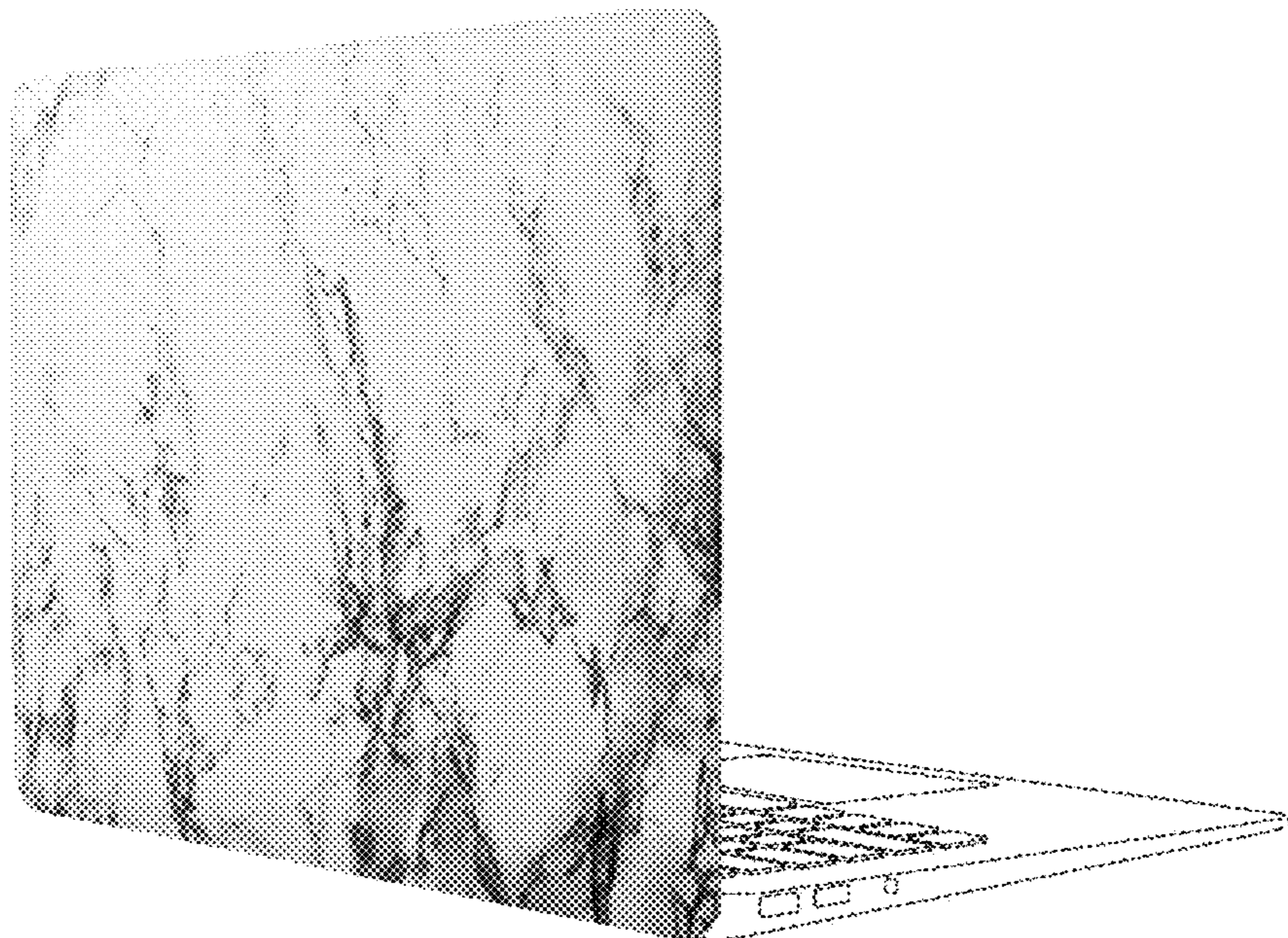
(57) **CLAIM**

The ornamental design for a screen case with surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a screen case with surface pattern showing ray new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is another perspective view thereof with the screen case with surface pattern shown in a condition of being coupled with a laptop; and, FIG. 9 is another rear view thereof with the screen case with surface pattern shown in the condition of being coupled with the laptop. The broken line portion of the screen case with surface pattern in FIG. 3 represents unclaimed portion of the claimed design and form no part thereof. The broken line portions of the laptop in FIGS. 8-9 illustrate unclaimed environment and forms no part of the claimed design.

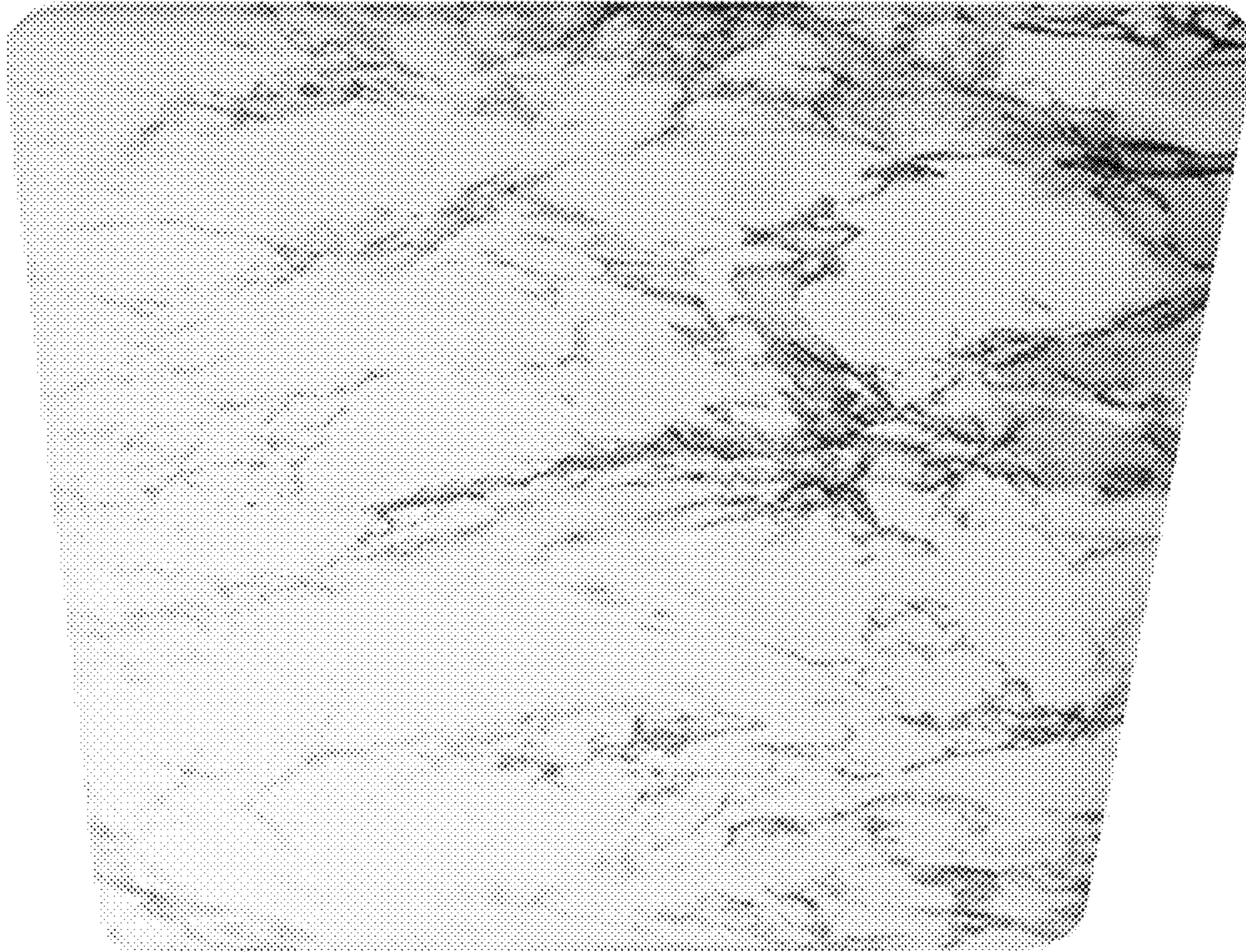

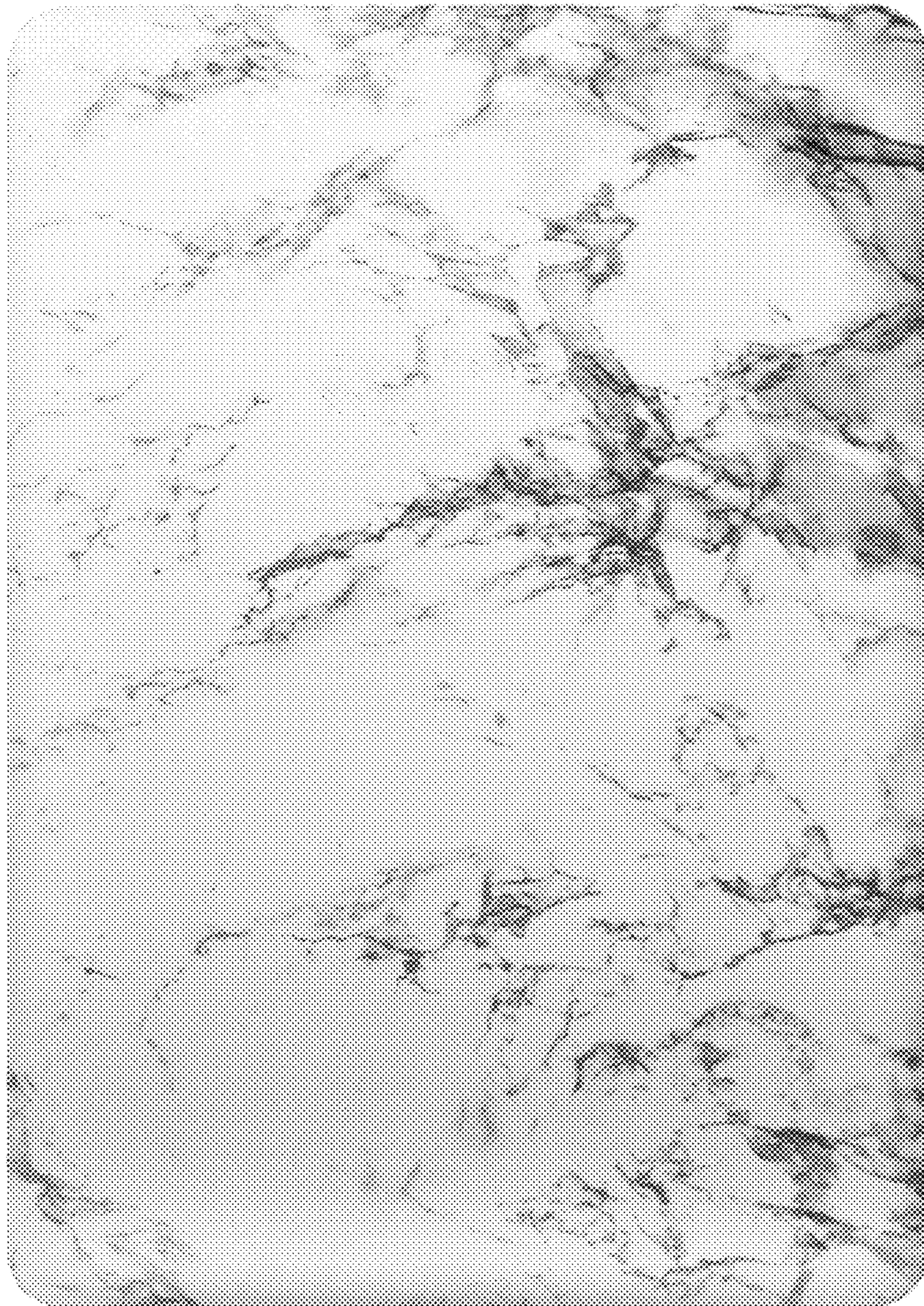

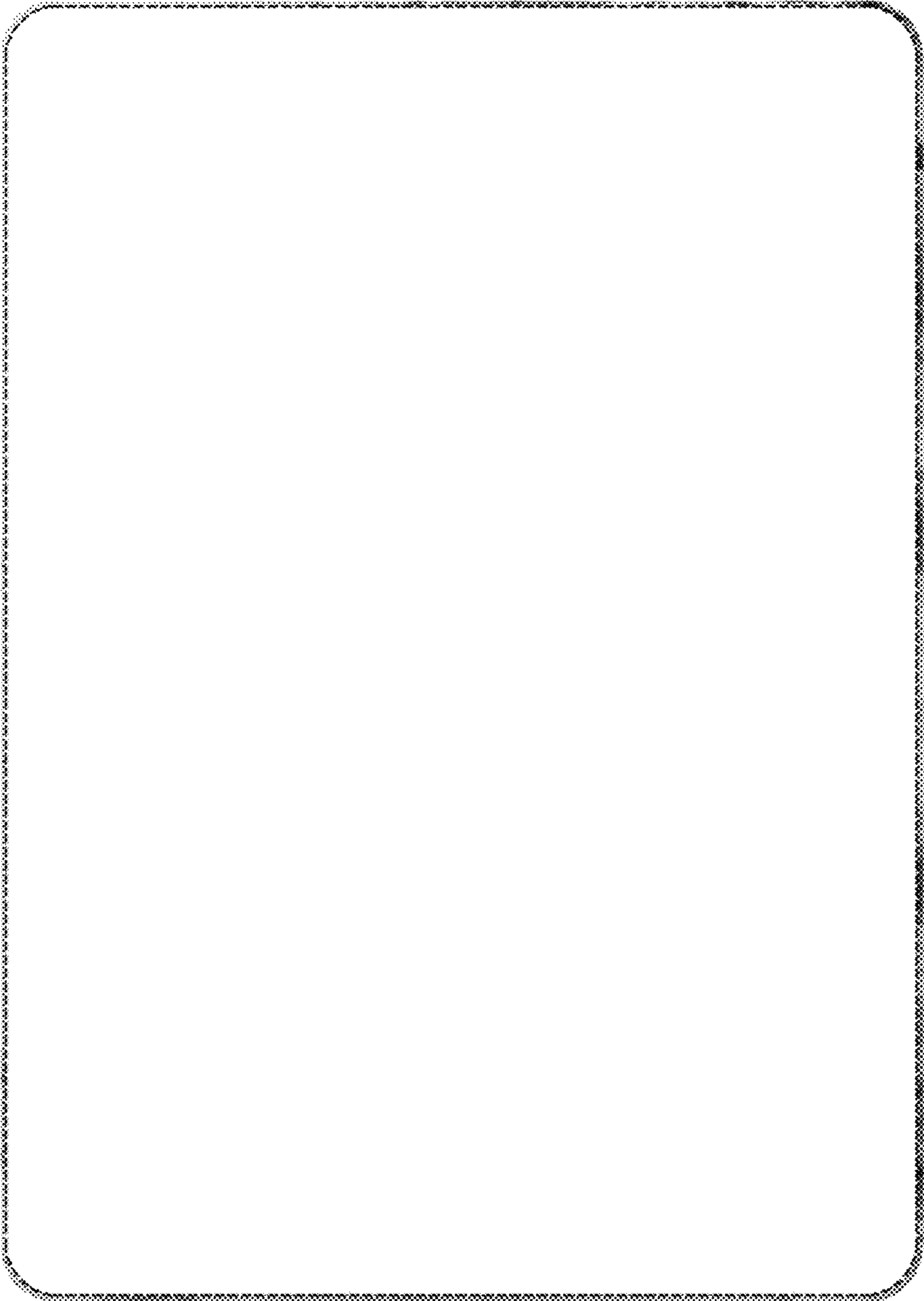

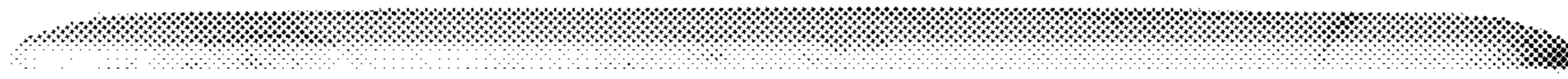

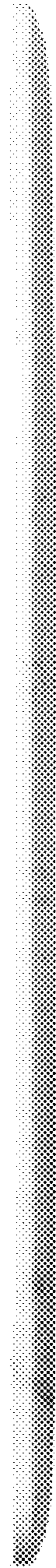

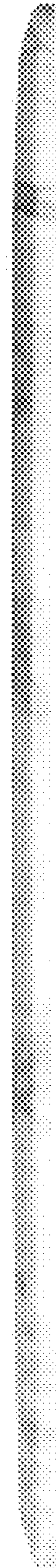

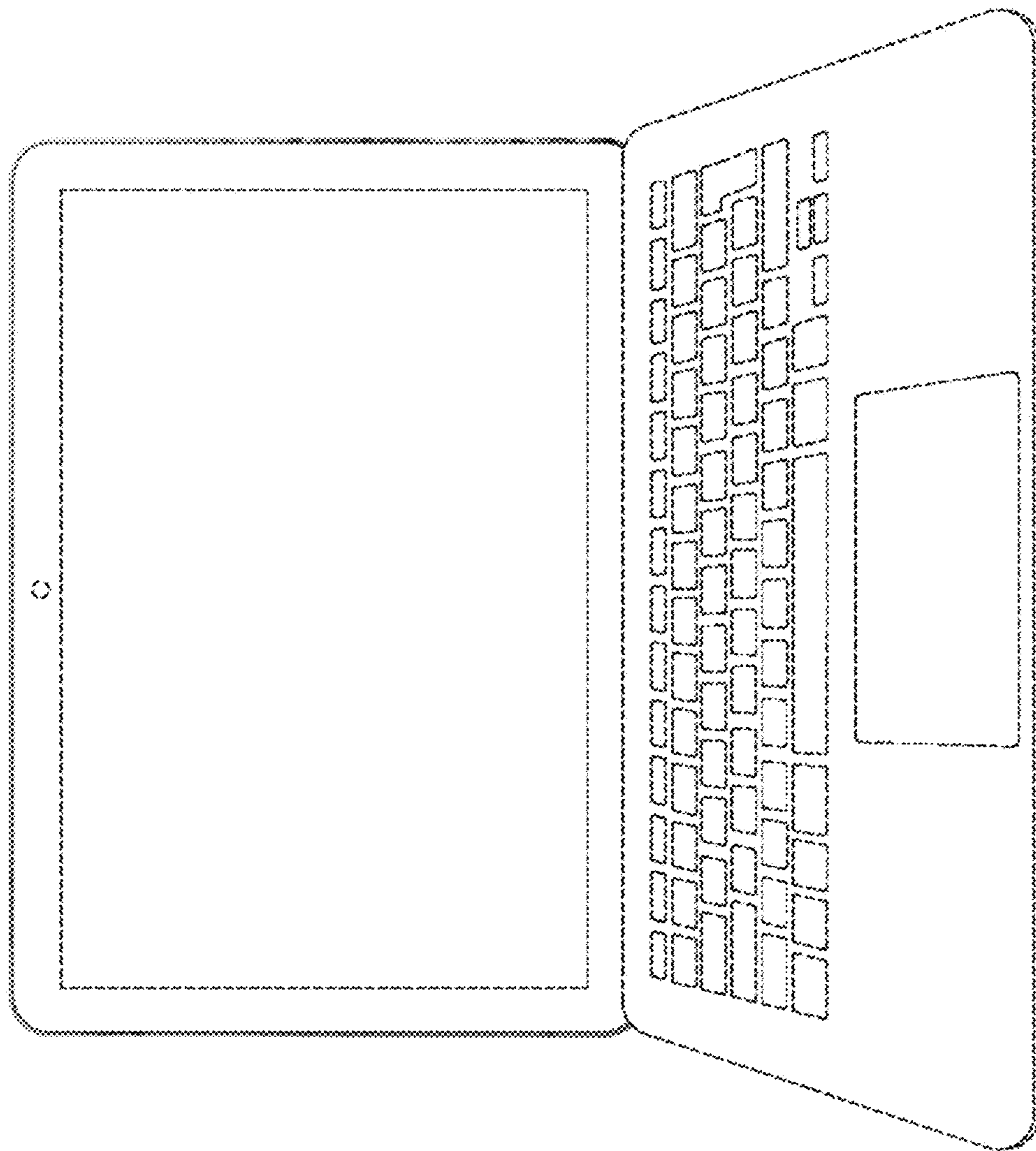
