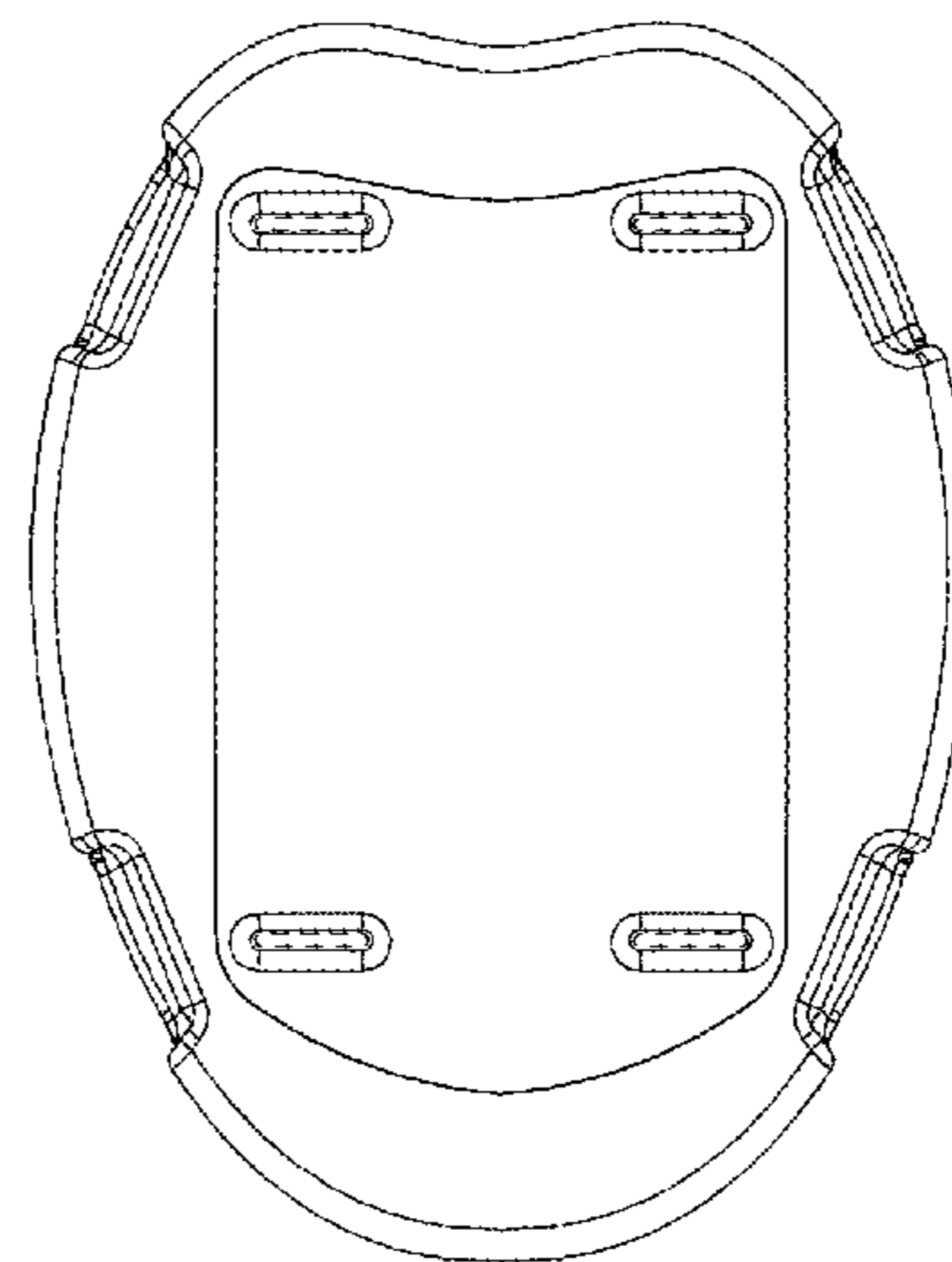
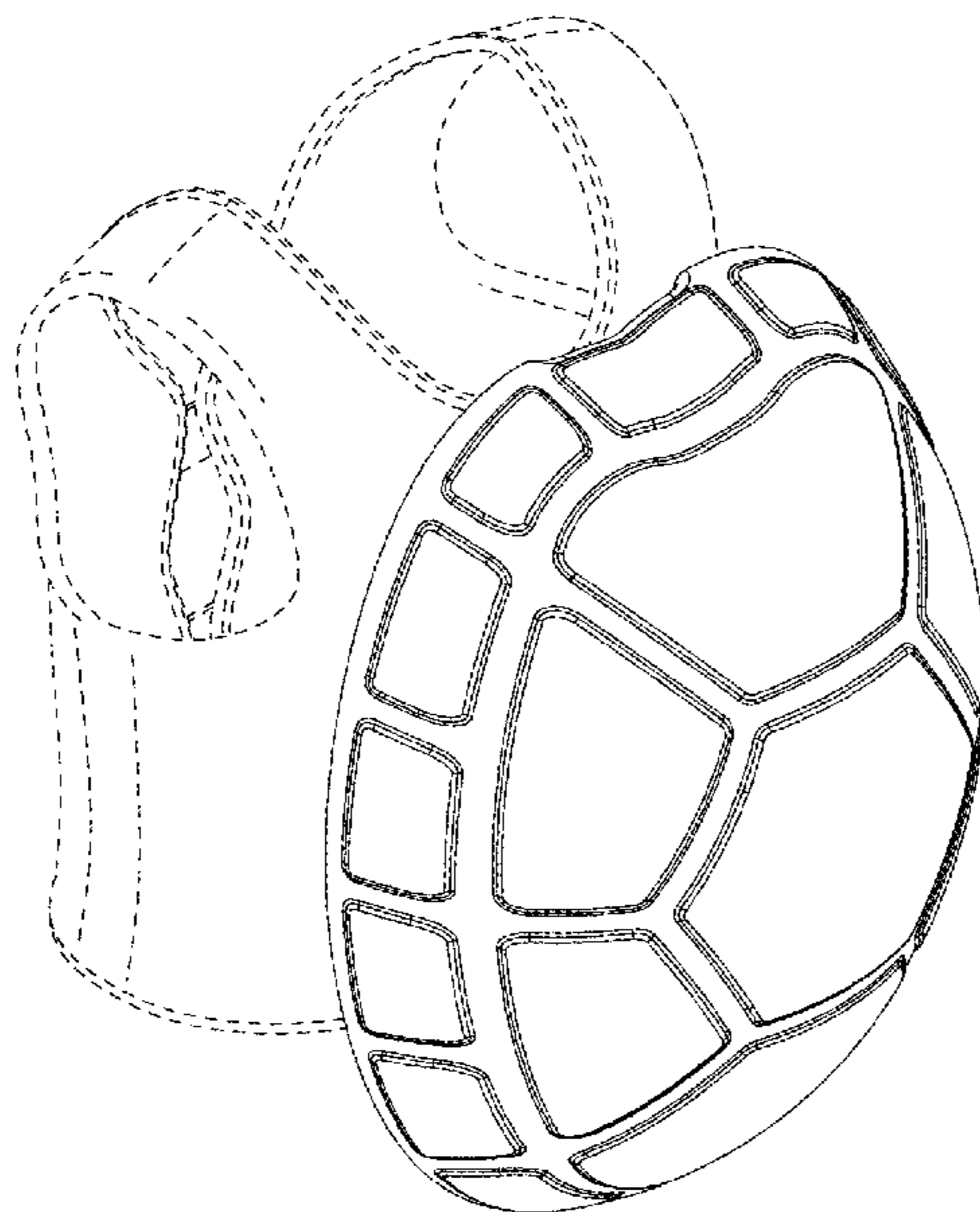

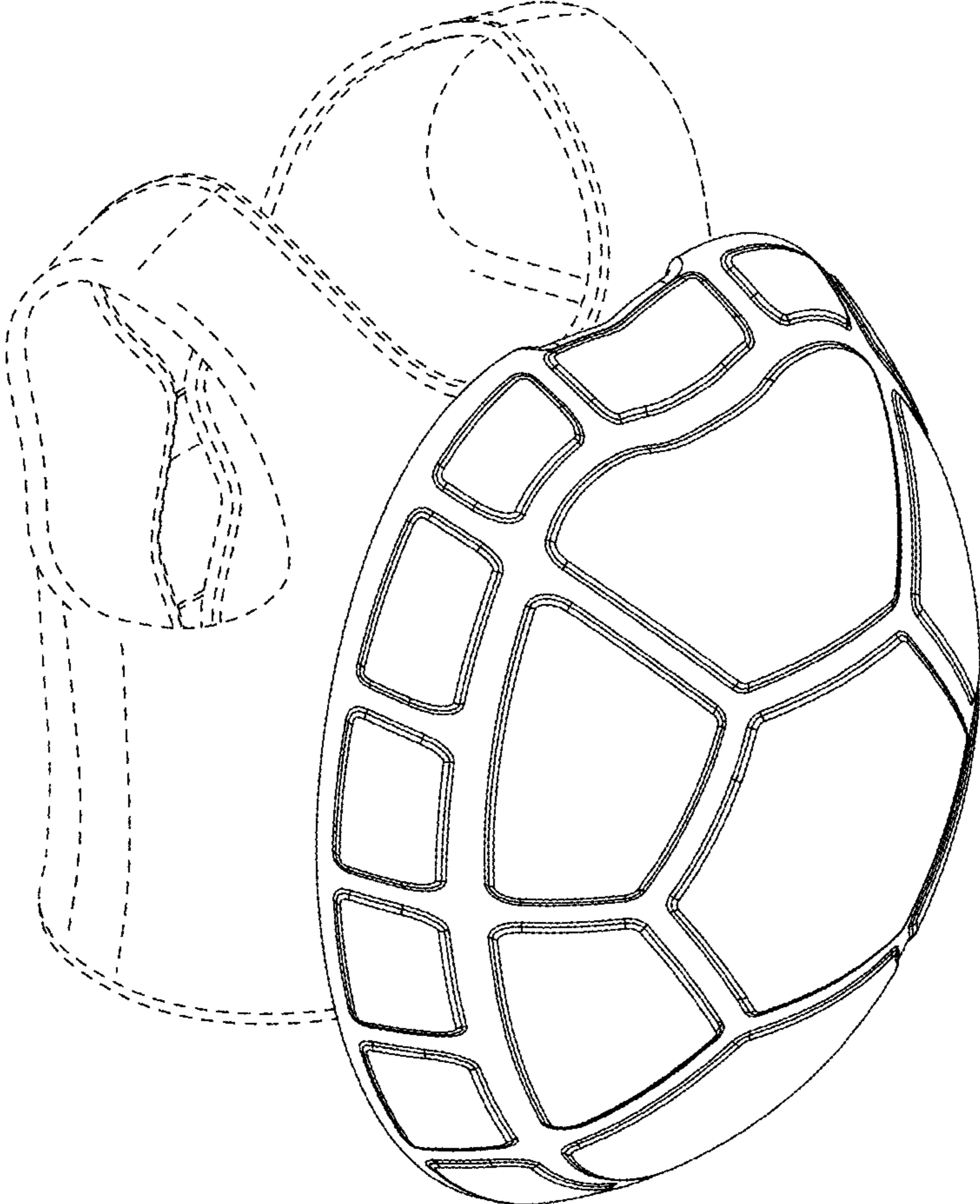
The ornamental design for a swimming float, as shown and described.

**DESCRIPTION**

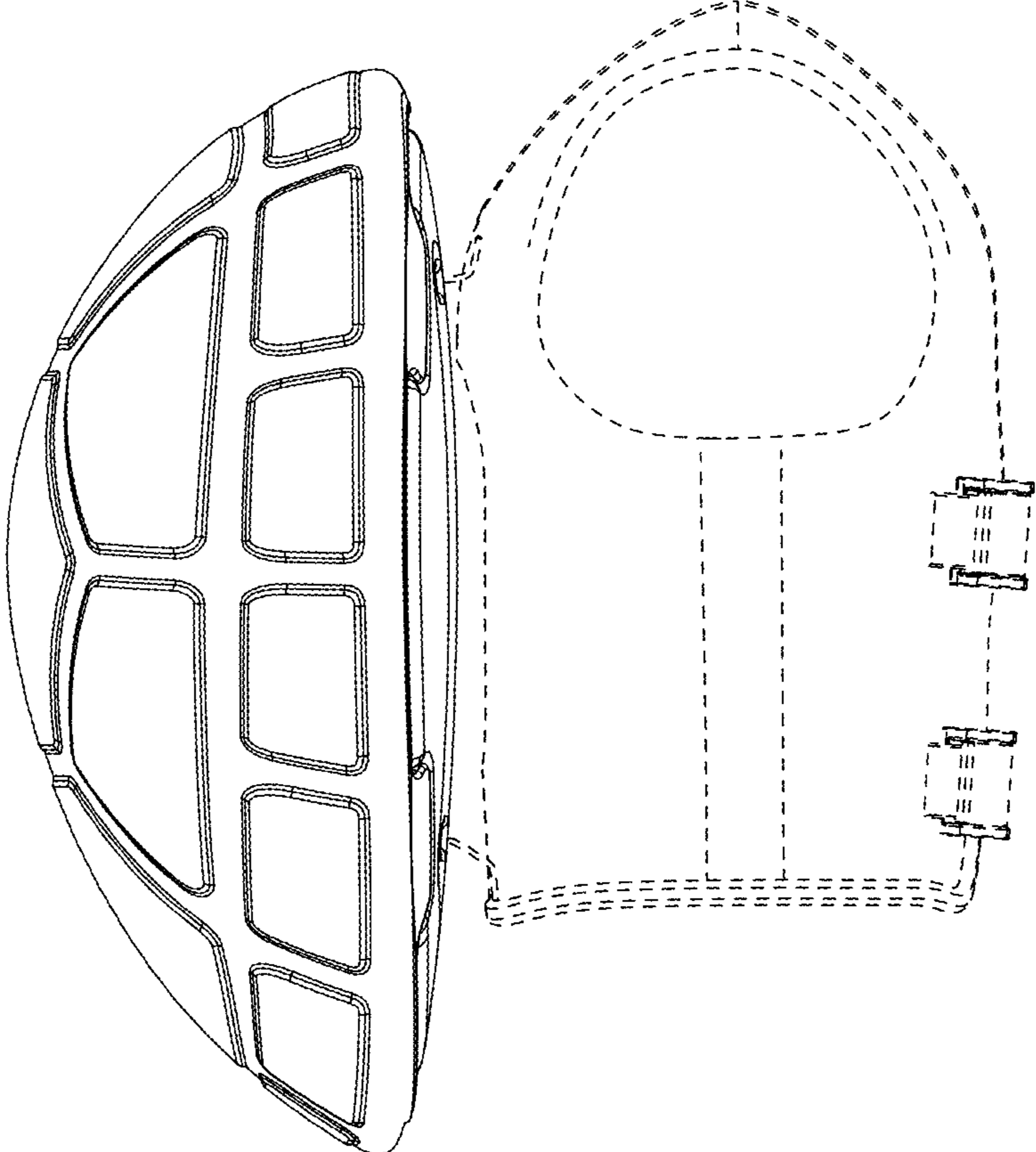
FIG. 1 is a top, front, right perspective view of a swimming float showing our new design;

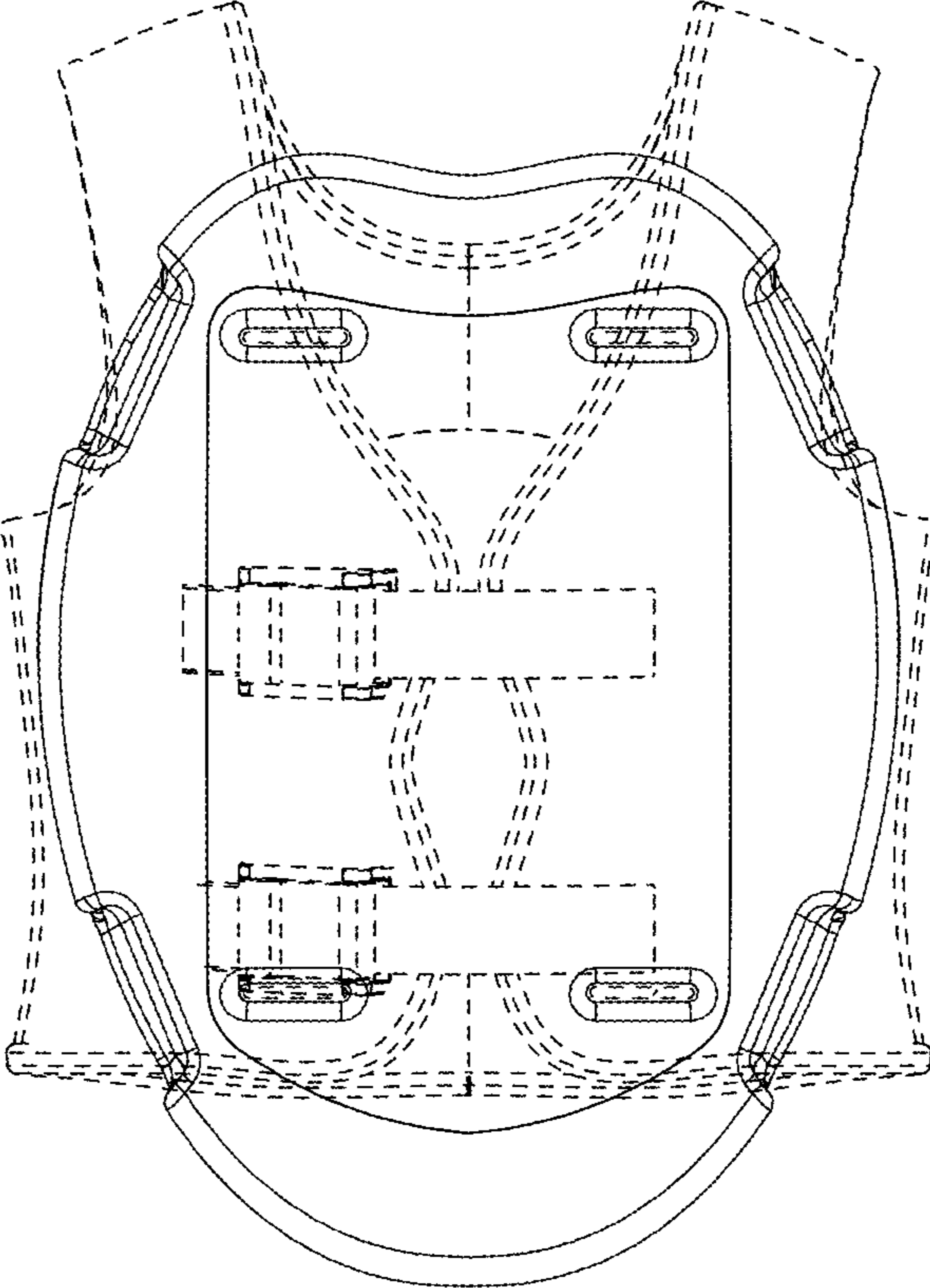




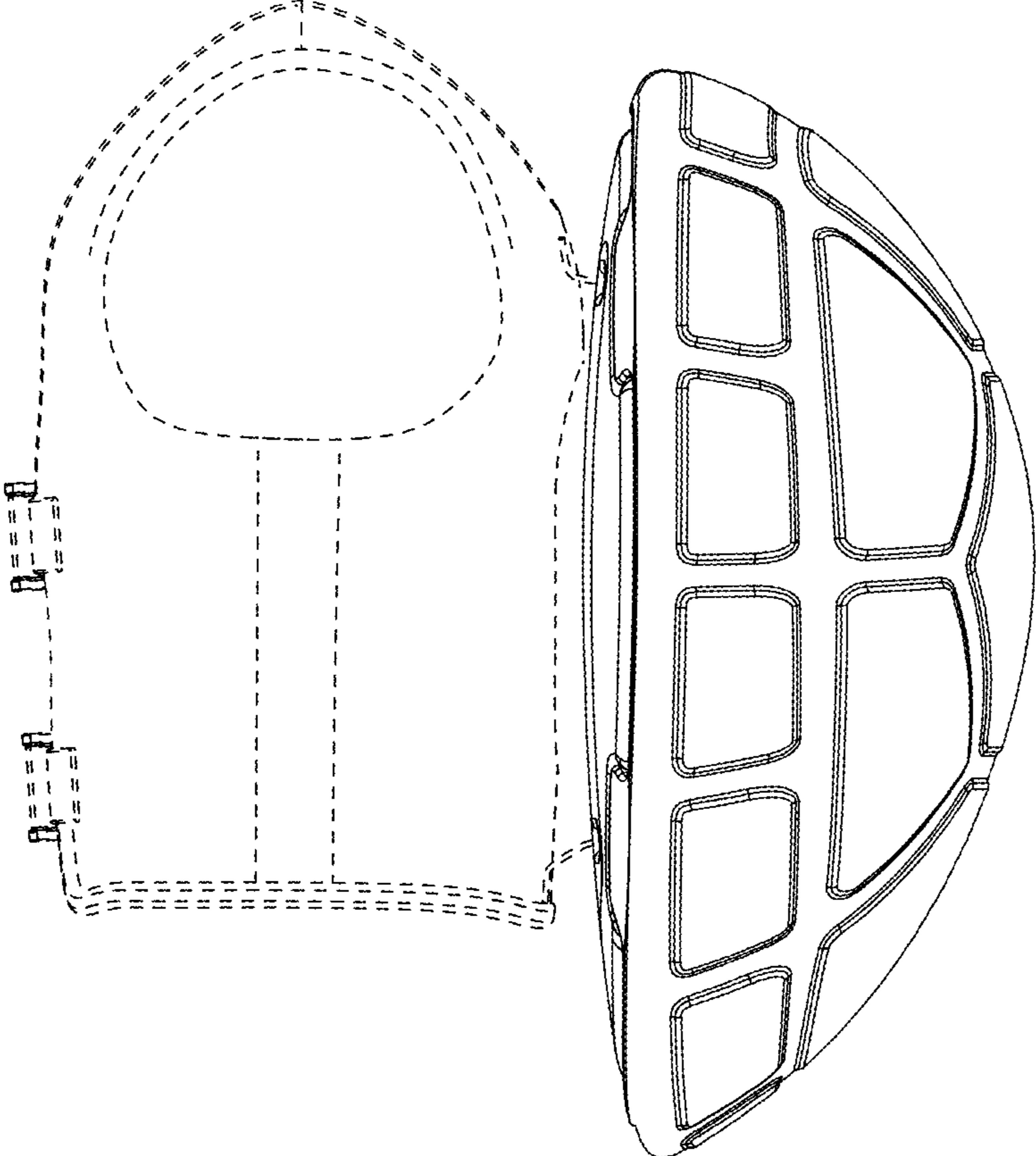

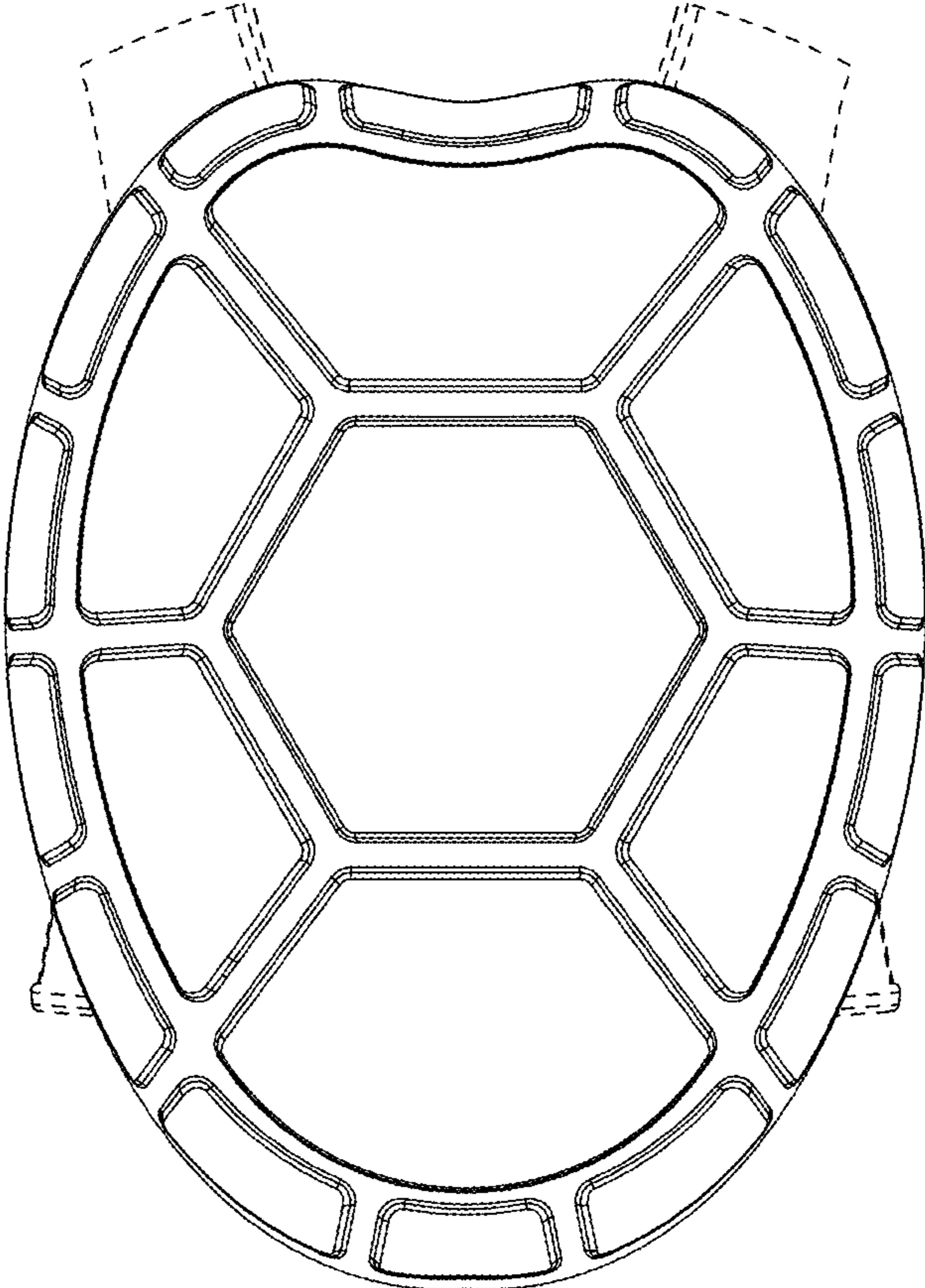

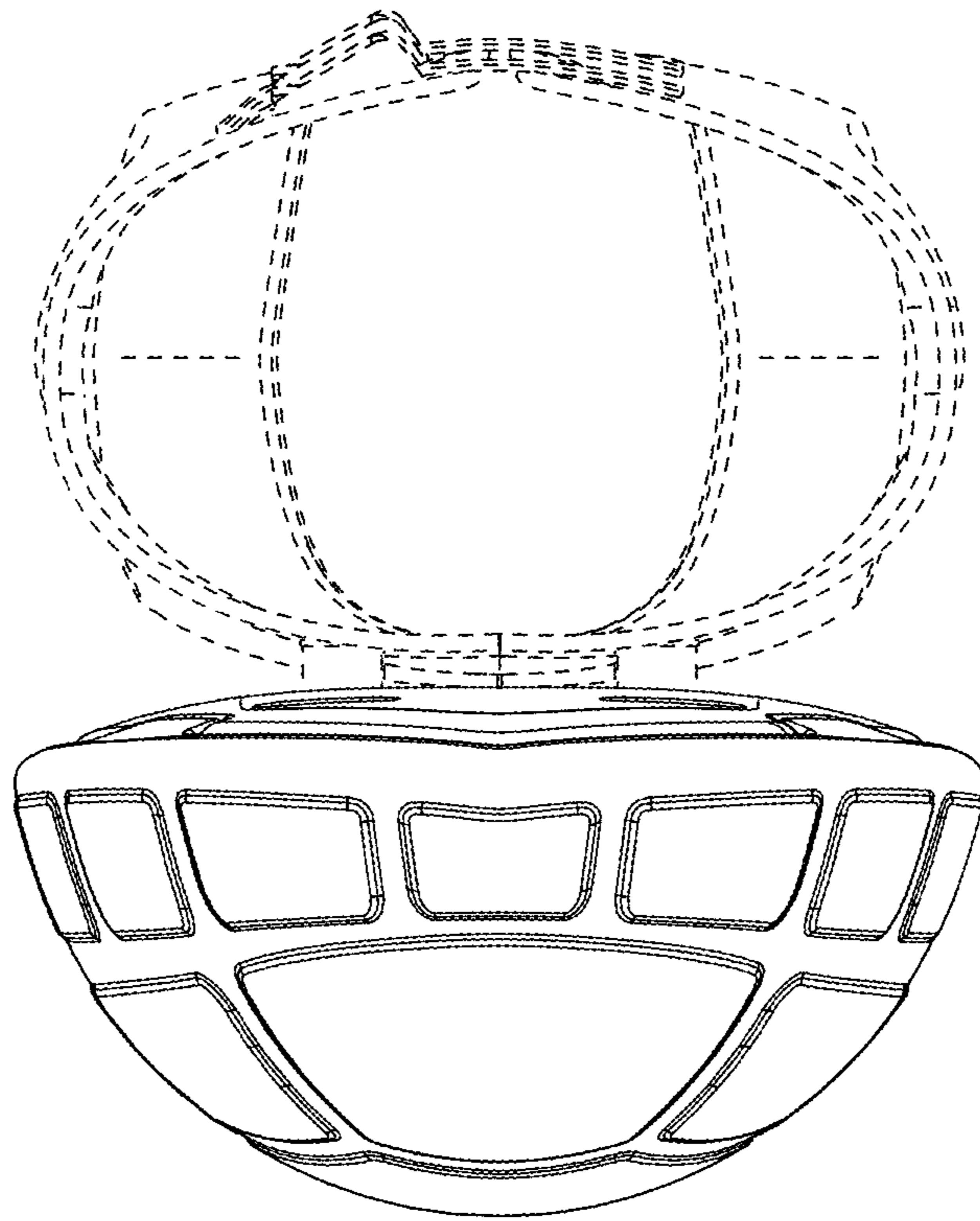

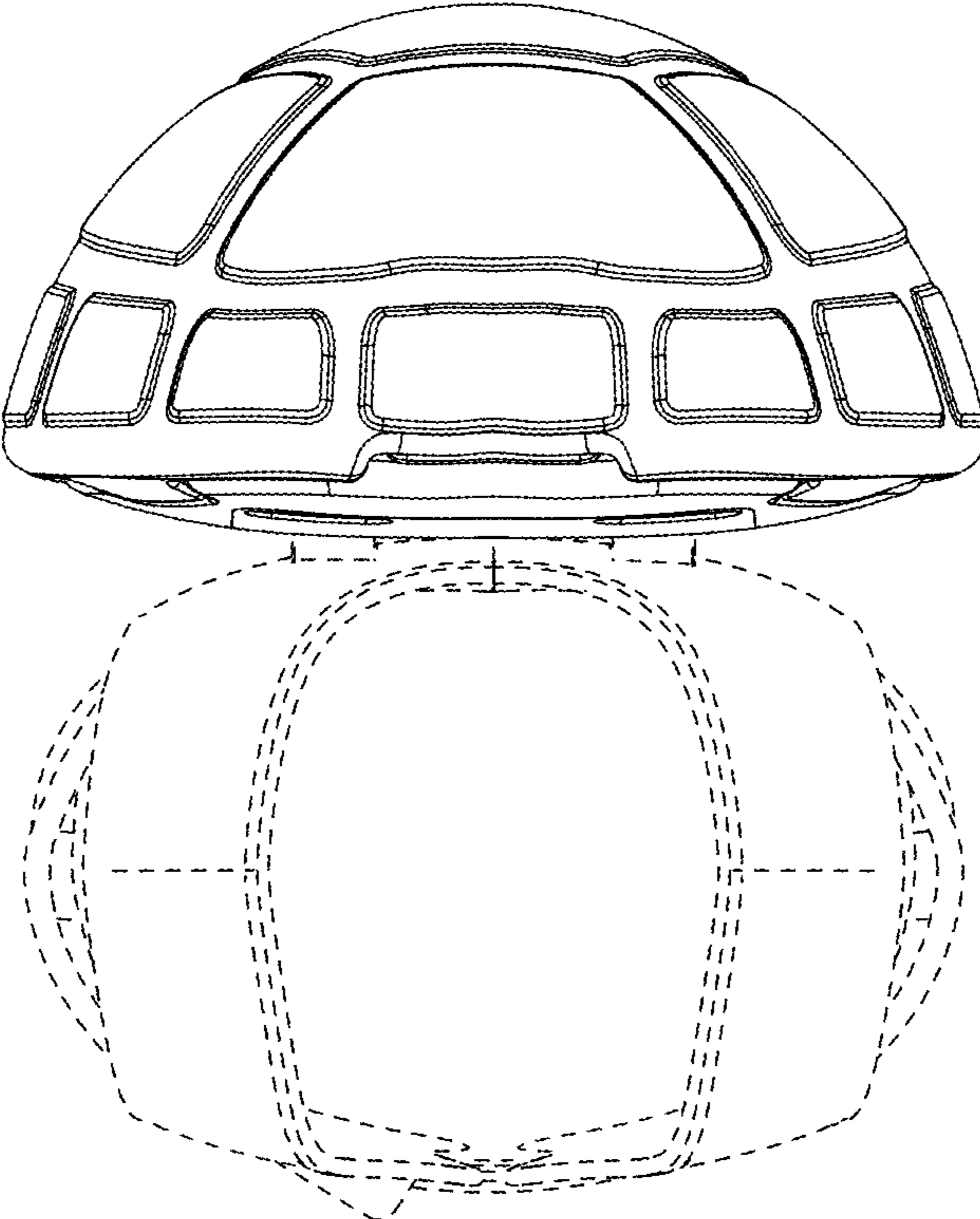

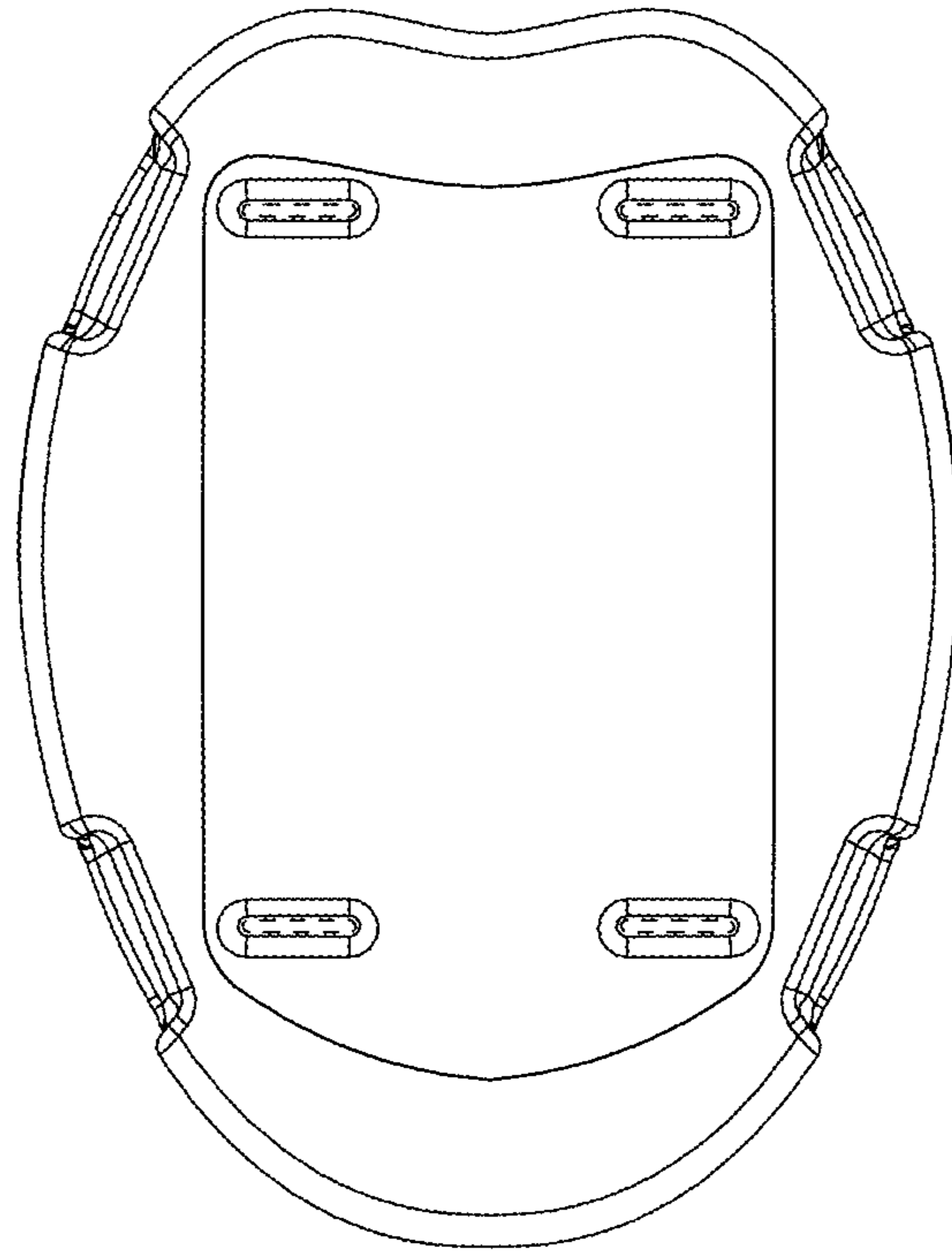
