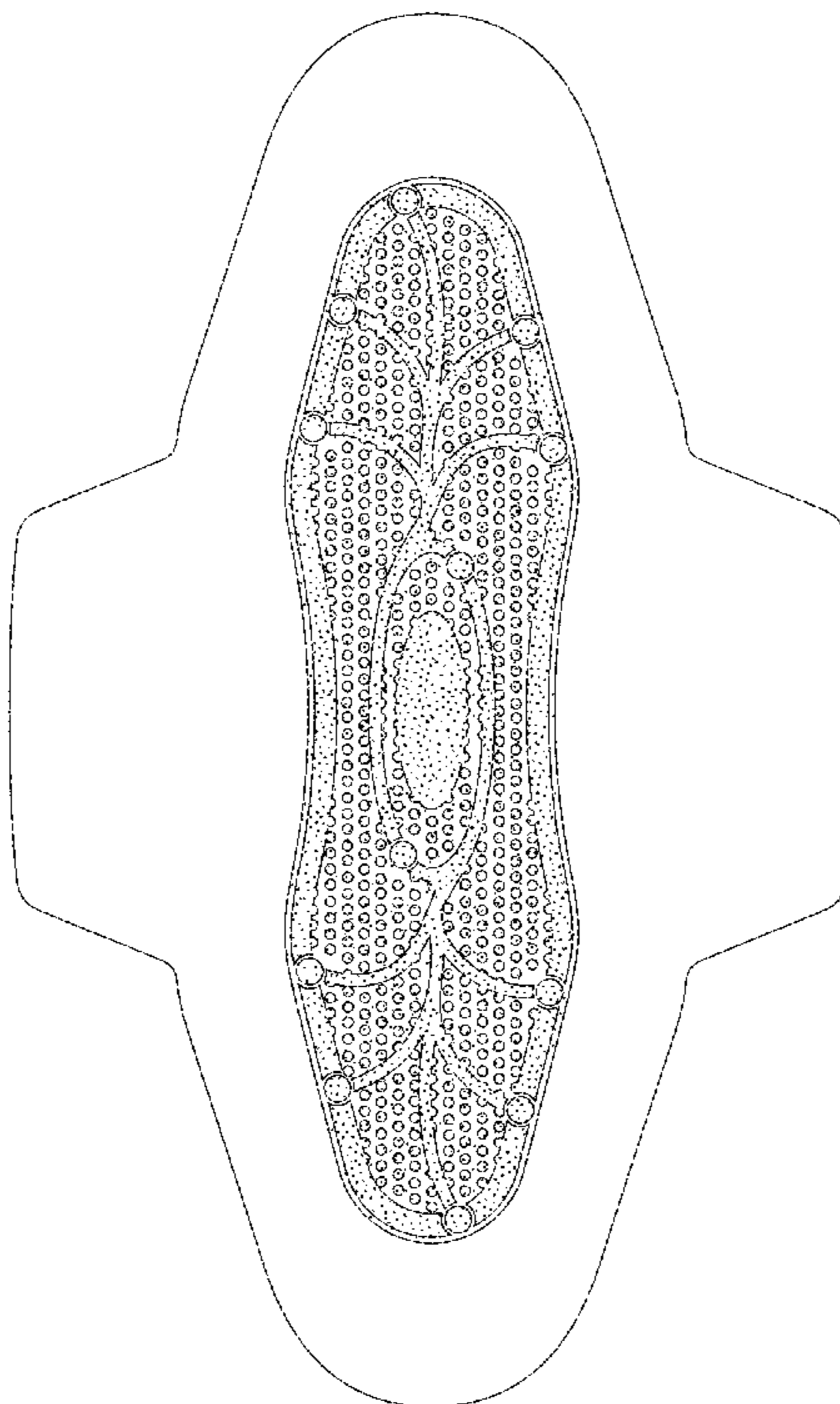
(57) **CLAIM**

We claim the ornamental design for a sanitary product, as shown and described.

DESCRIPTION

FIG. 1 is a top elevational view of a sanitary product, showing a surface pattern on a body-contacting surface of the sanitary product; and, FIG. 2 is a top elevational view of the sanitary product, showing the surface pattern of FIG. 1, with the body-contacting surface of the sanitary product removed. The entirety of both the surface pattern and the body-contacting surface of the sanitary product are flat, two-dimensional surfaces.

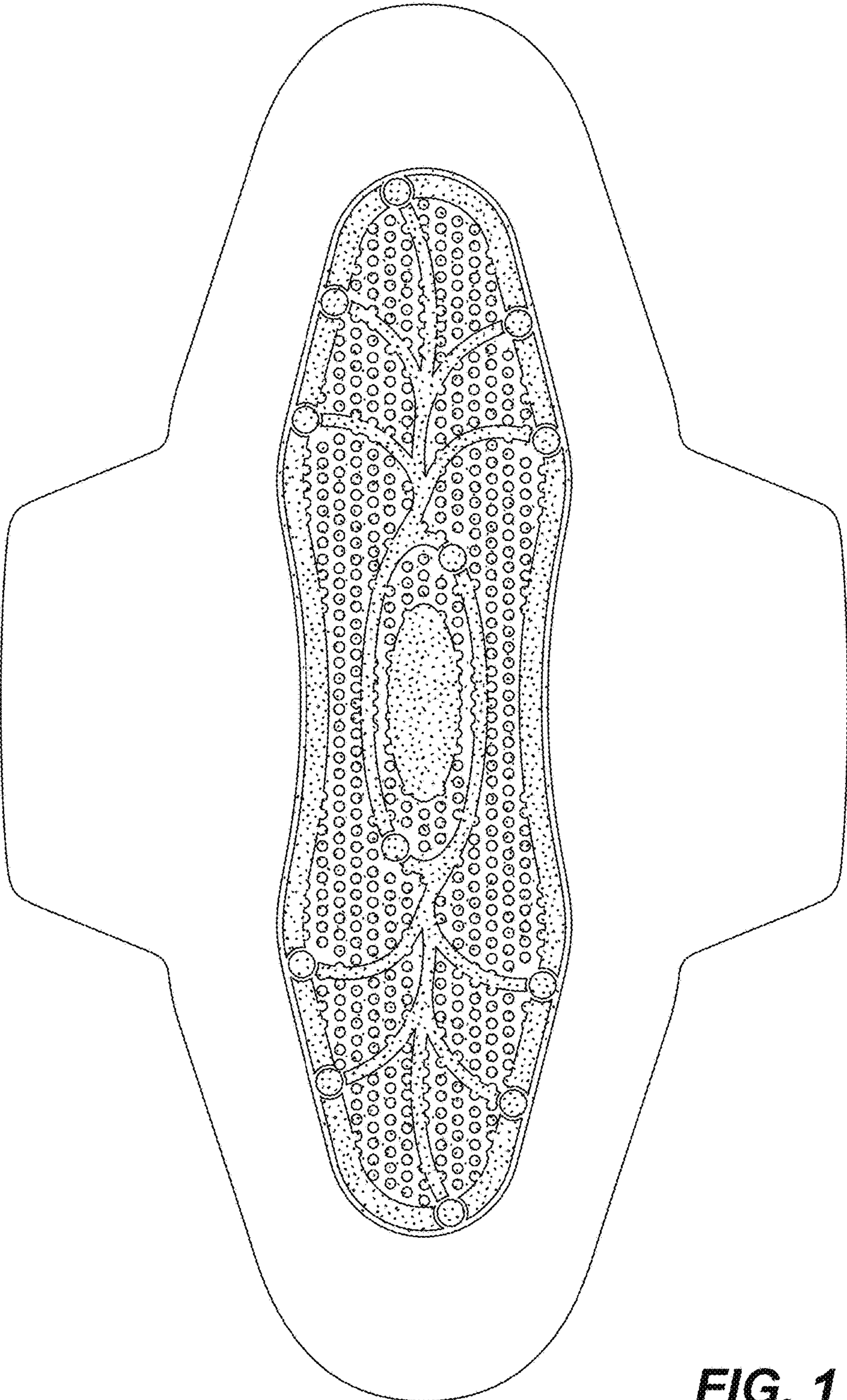

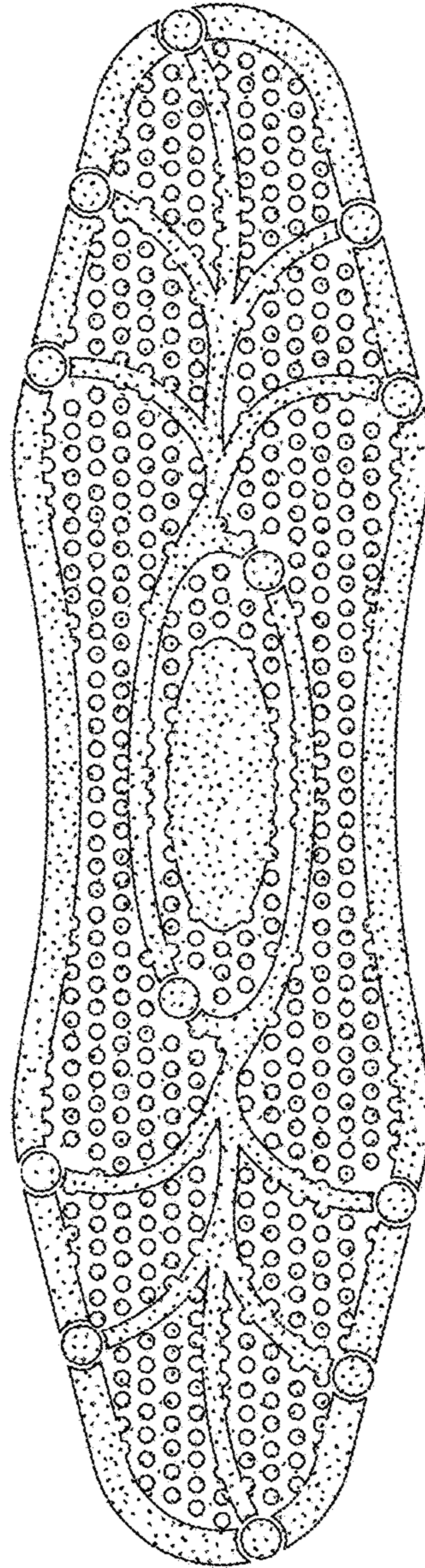
