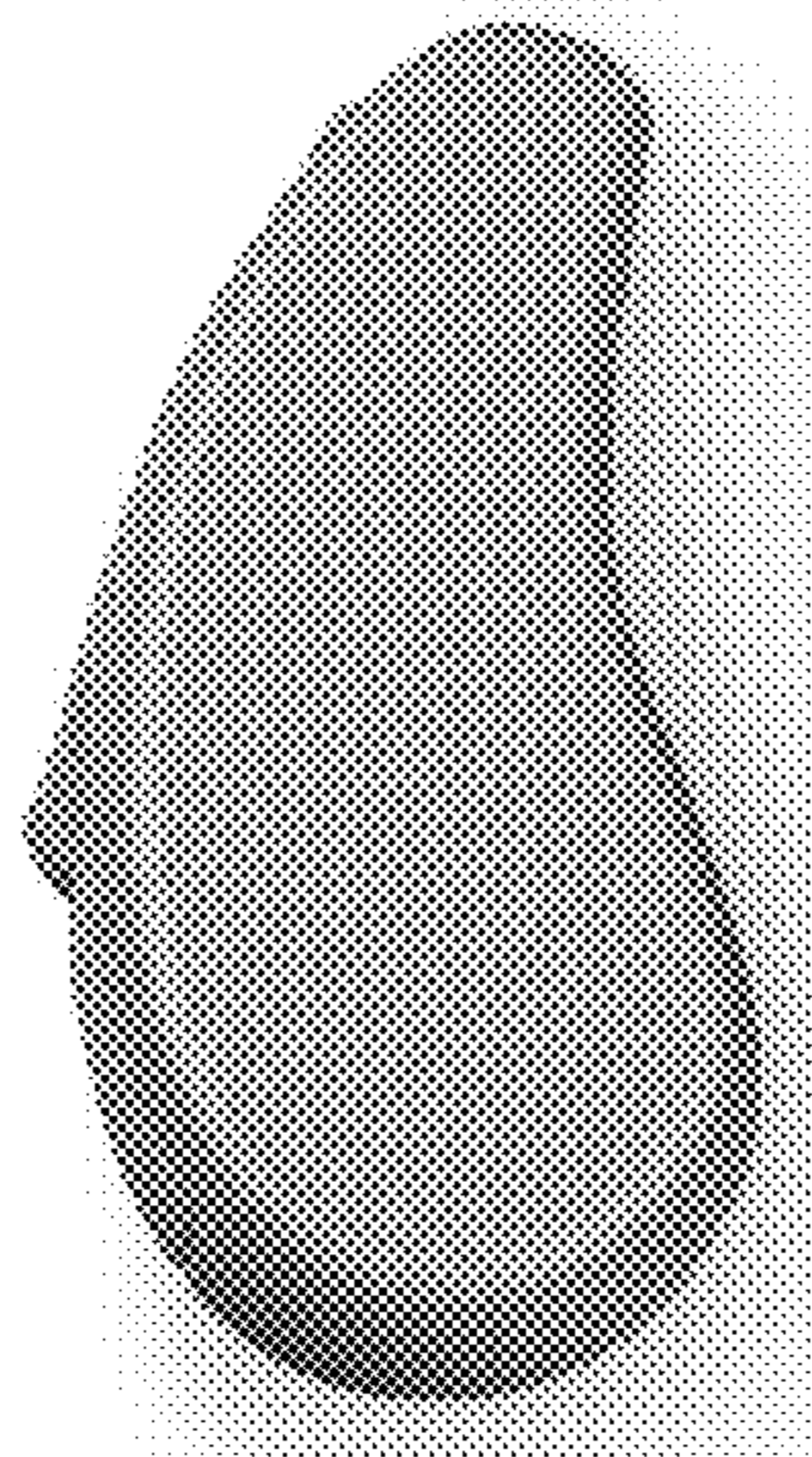
The ornamental design for a hearing aid, as shown and described.

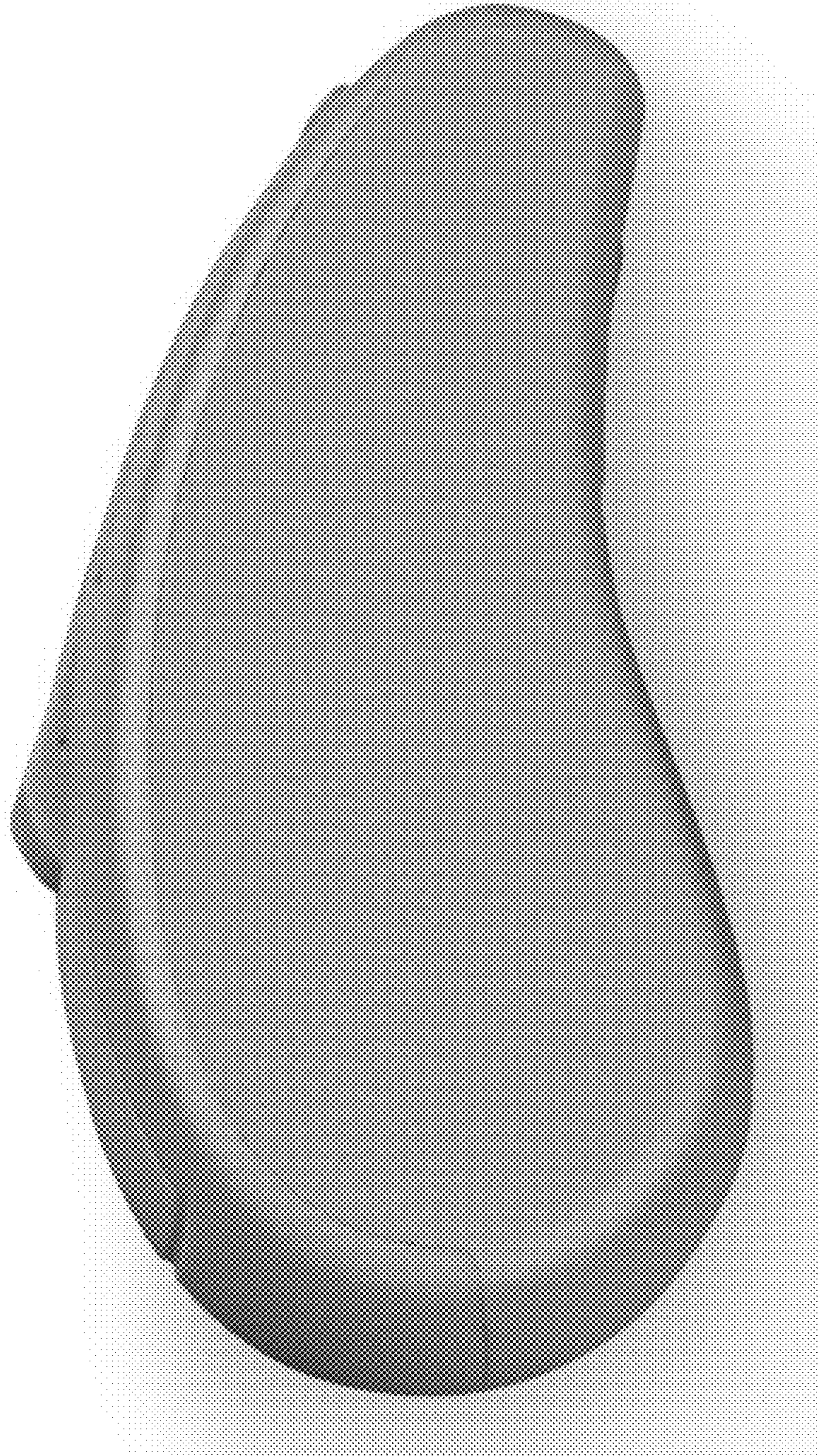

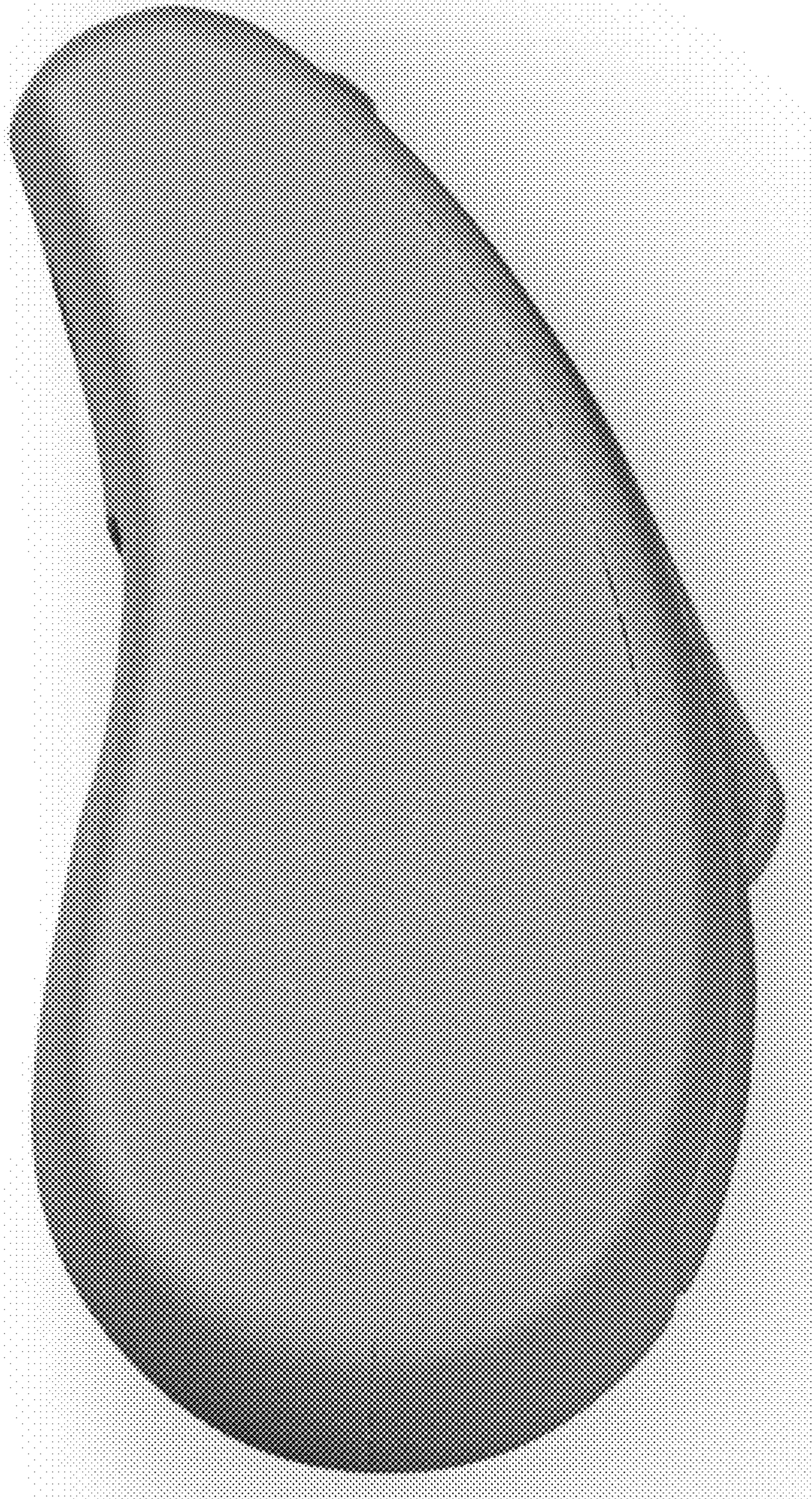

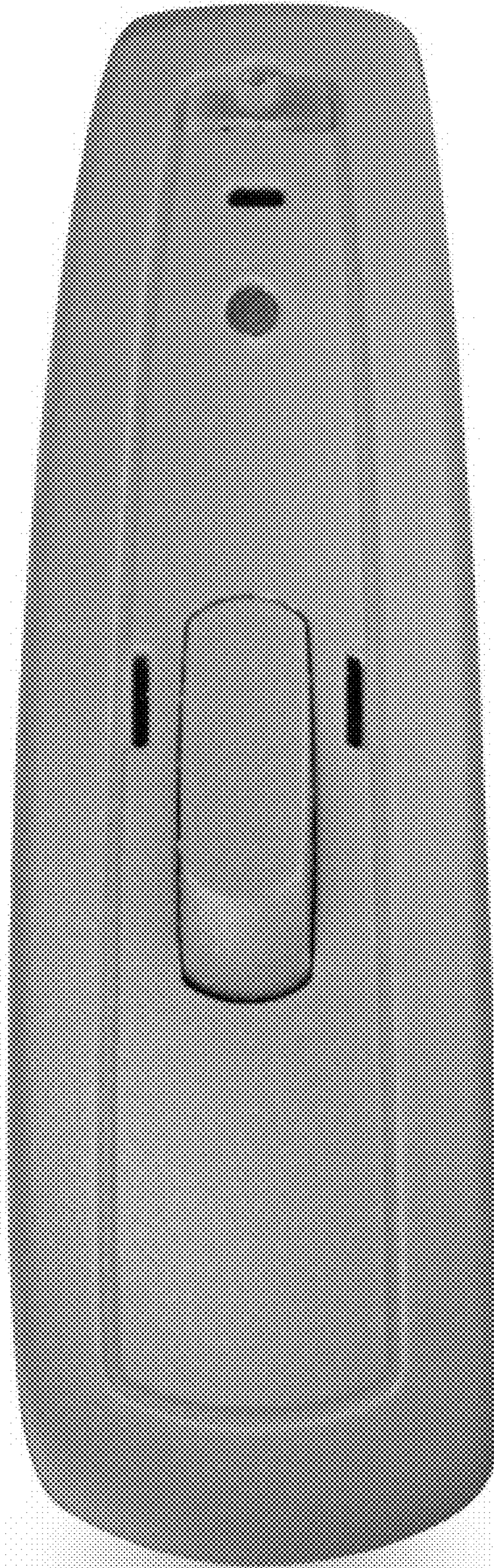

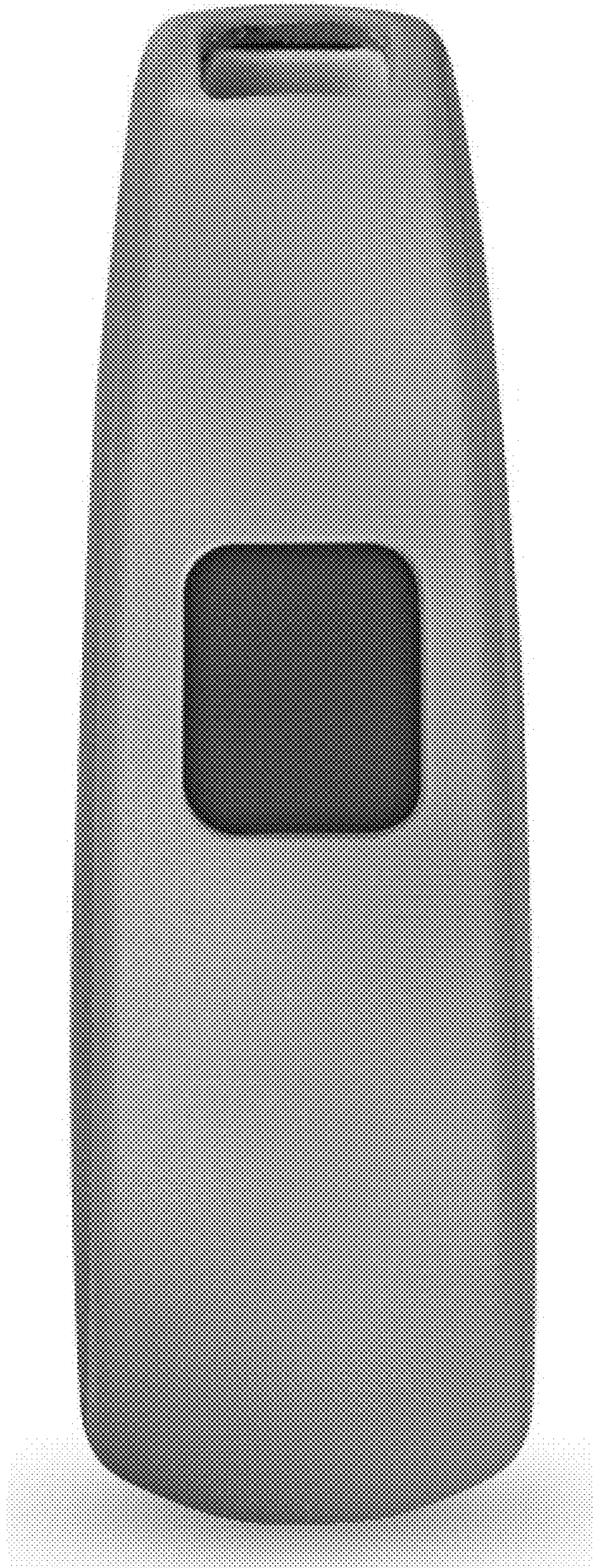
