**DESCRIPTION**

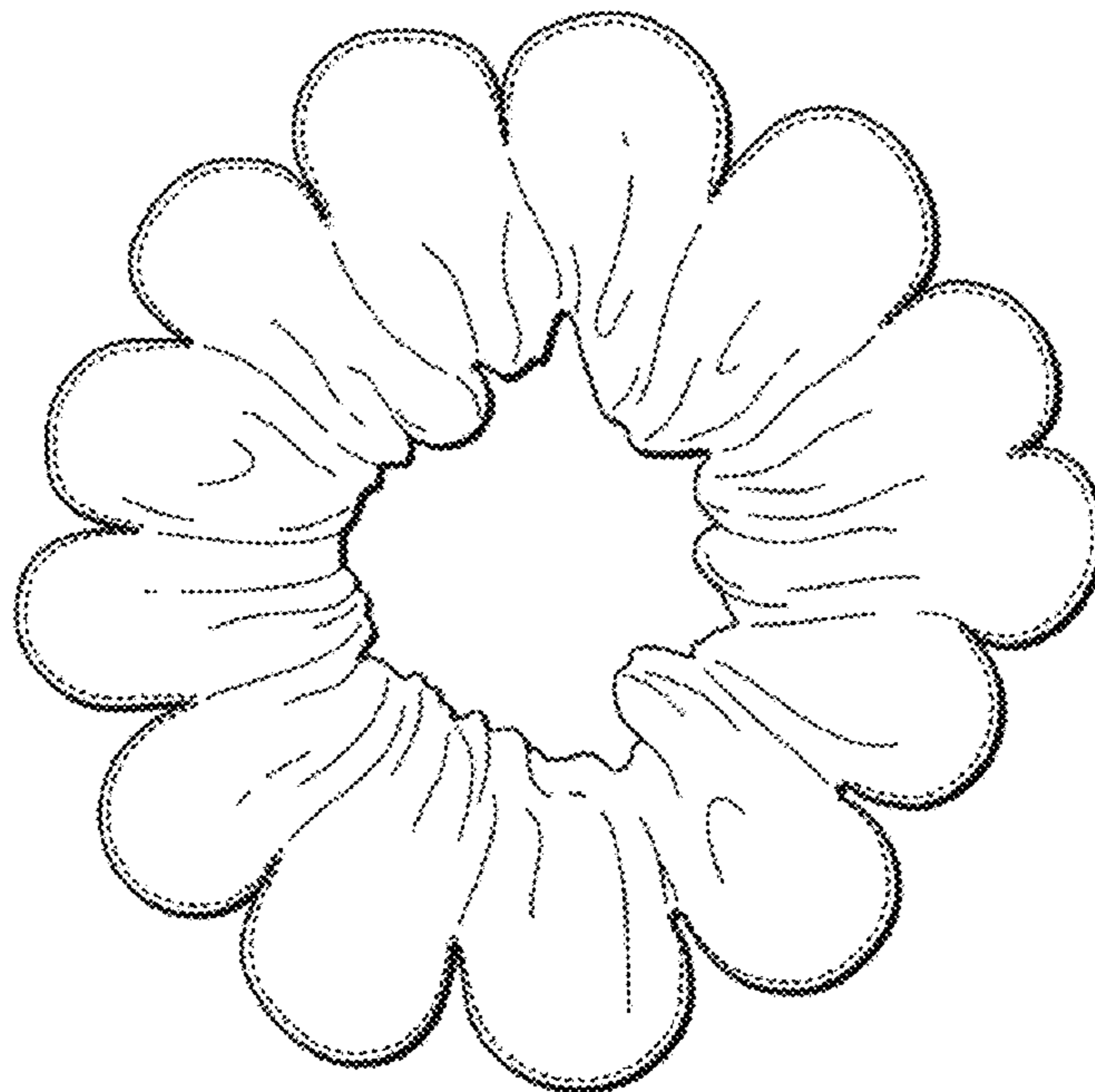
FIG. 1 is a front perspective view of a scrunchie according to an embodiment;

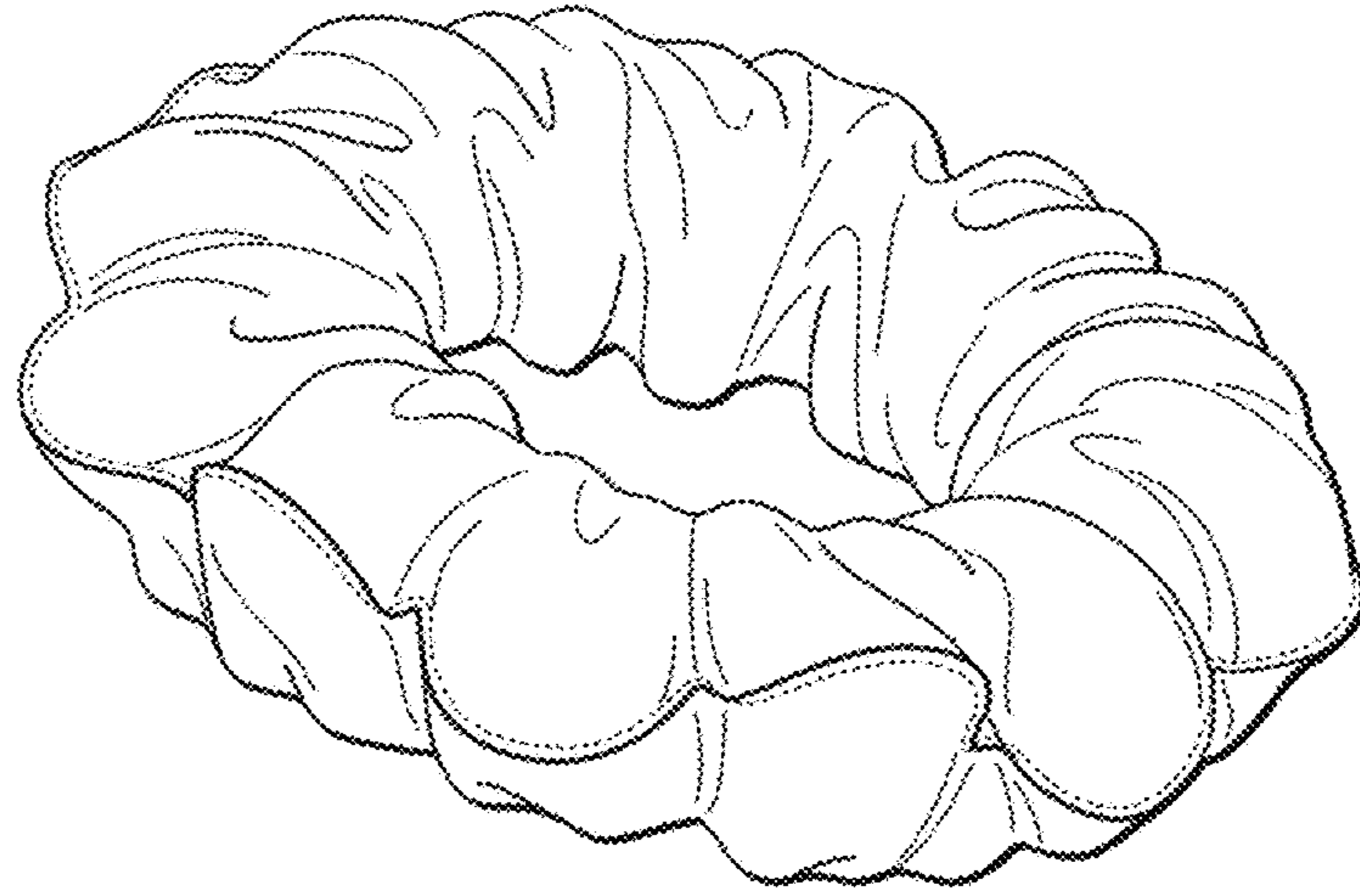

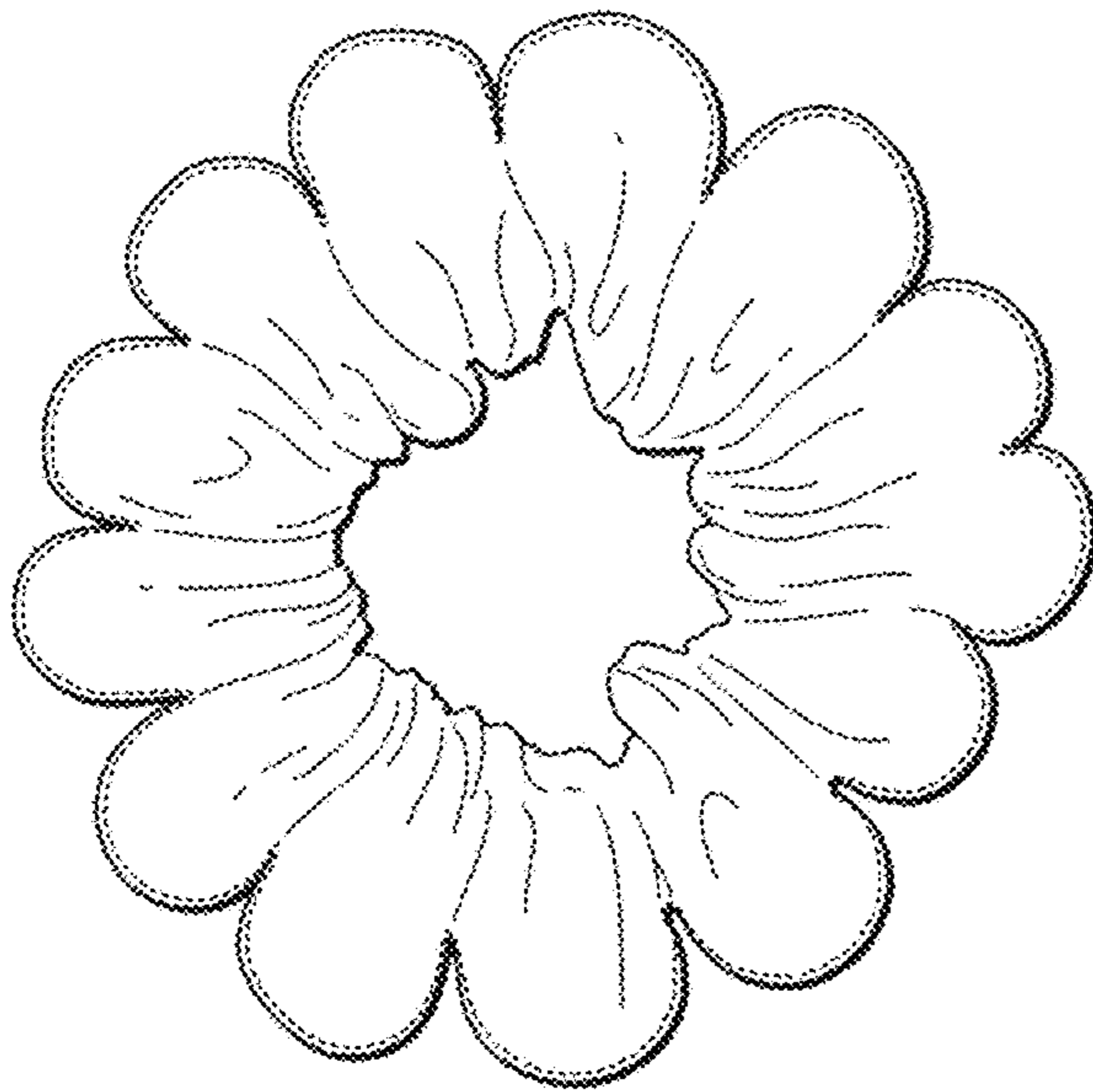

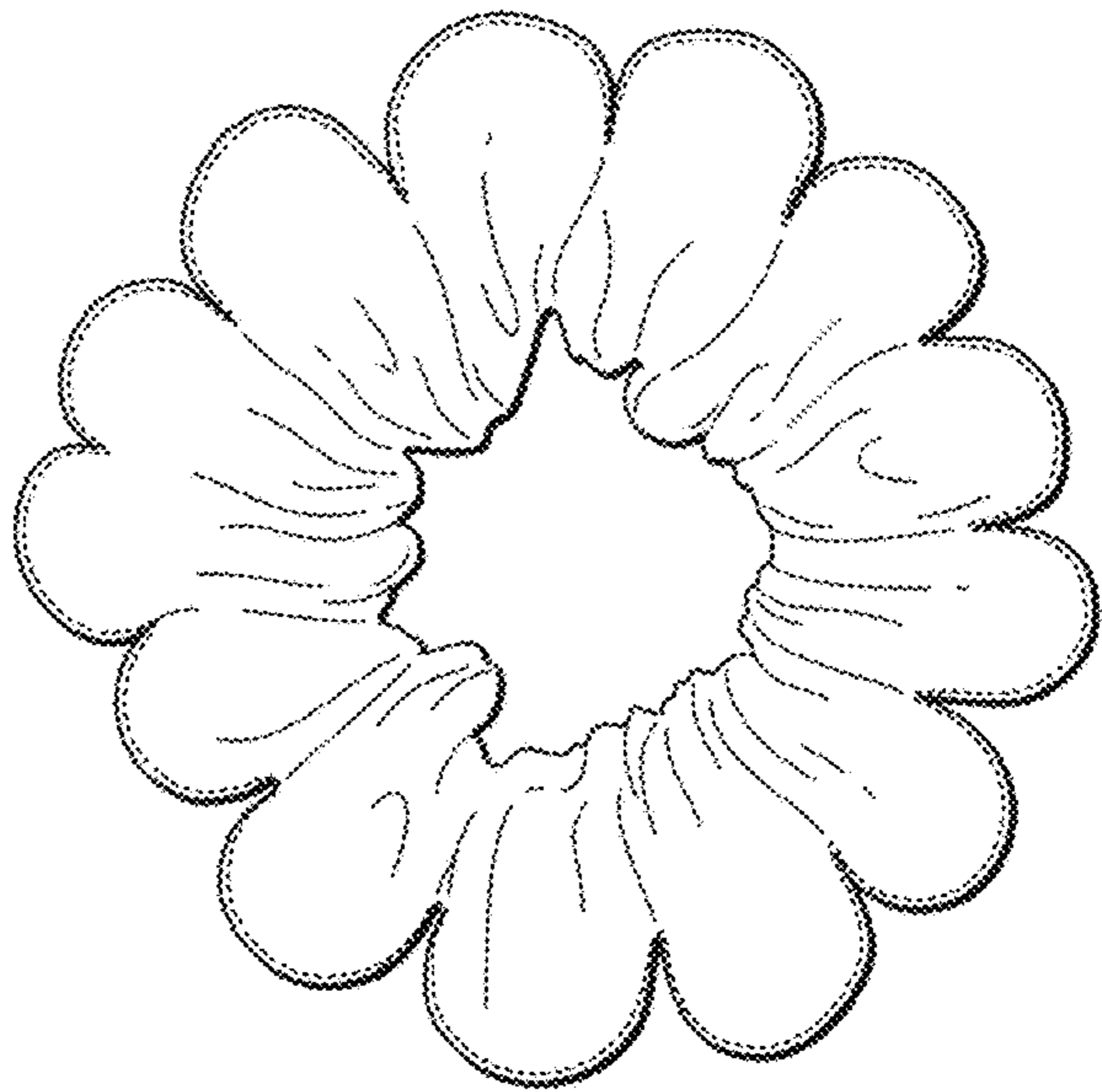

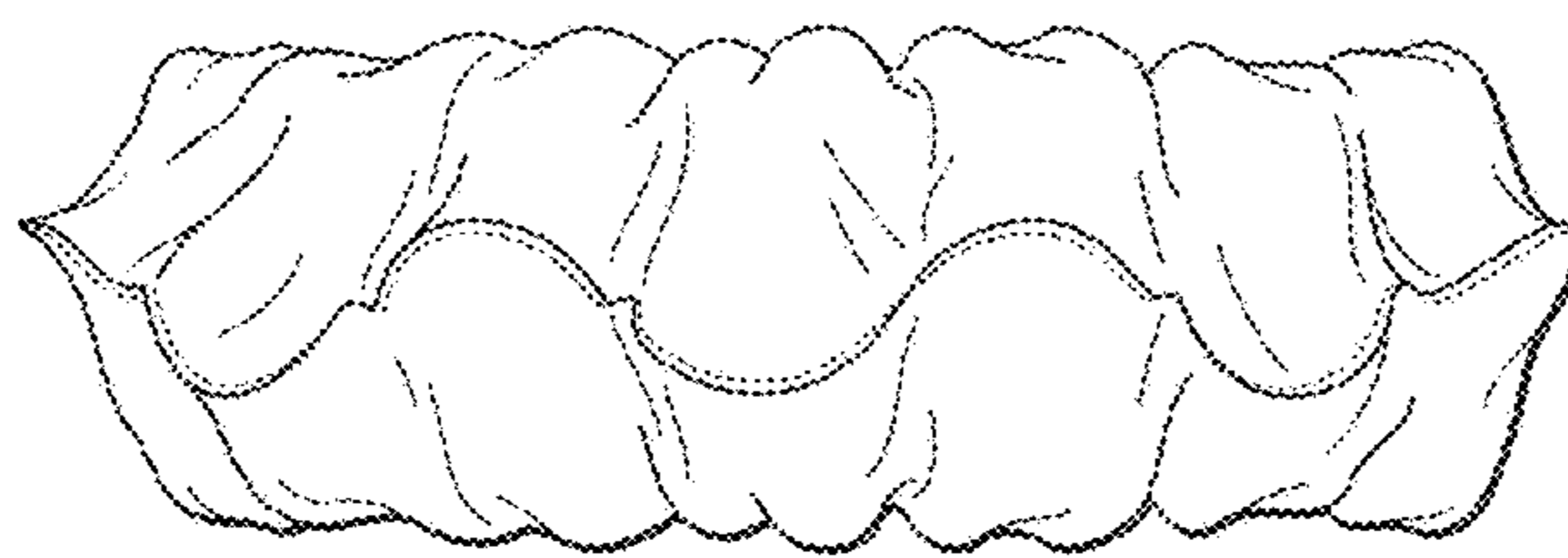

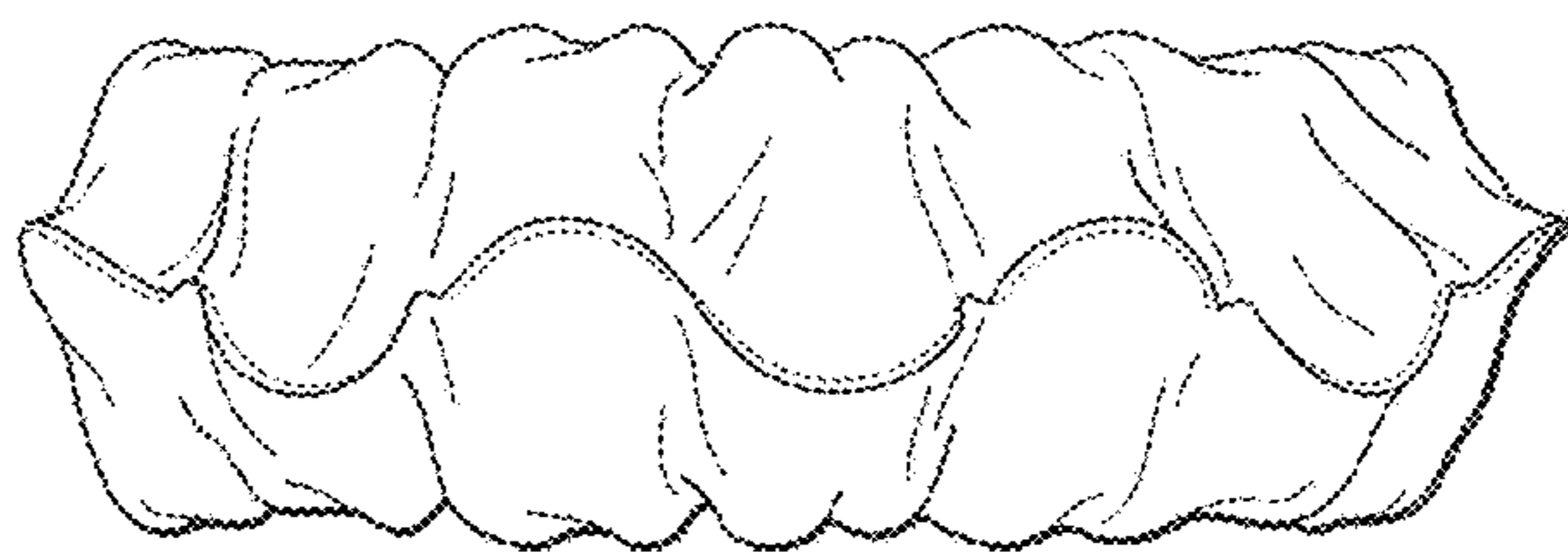
