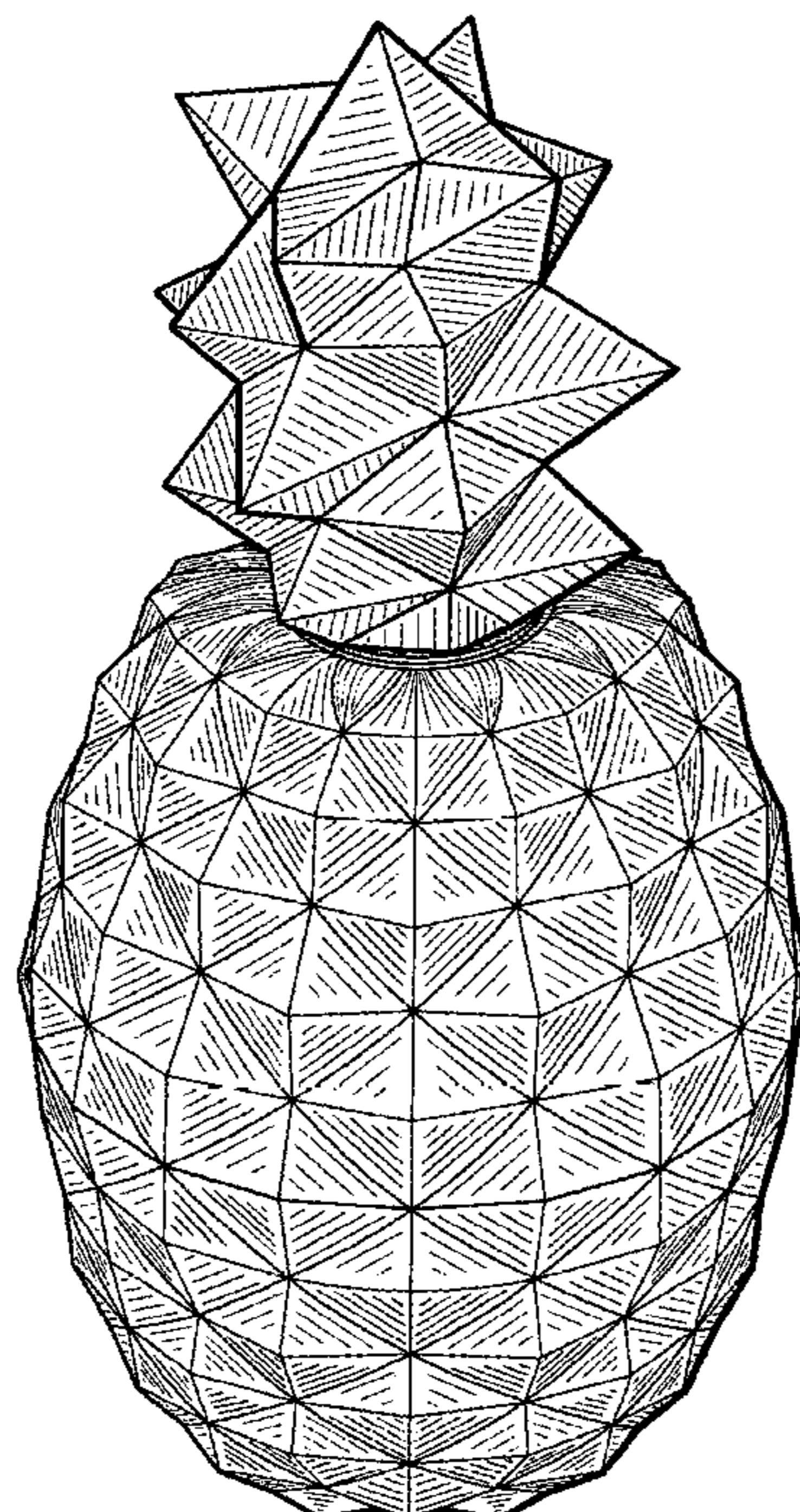
(57) **CLAIM**

I claim the ornamental design for a cosmetic container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the cosmetic container

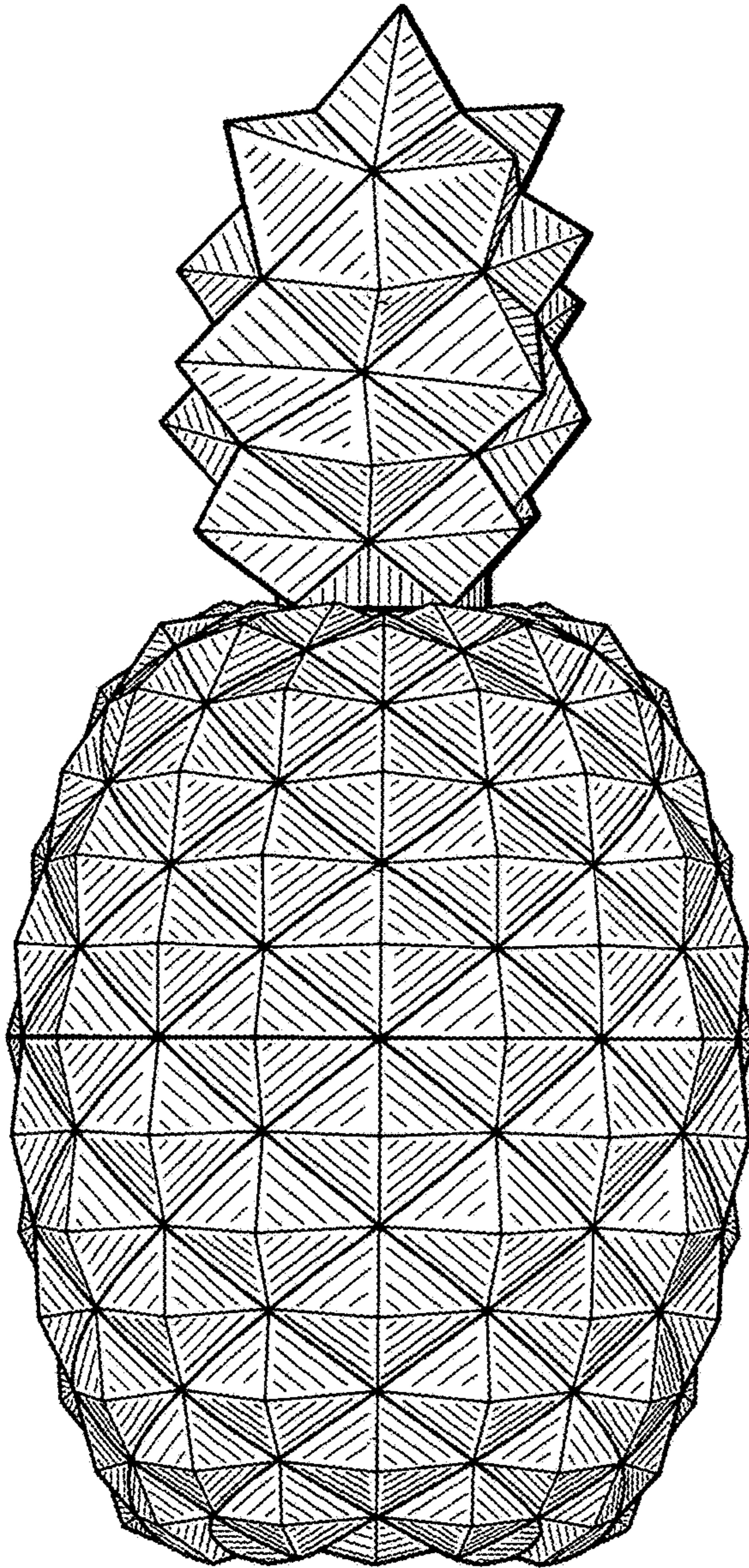

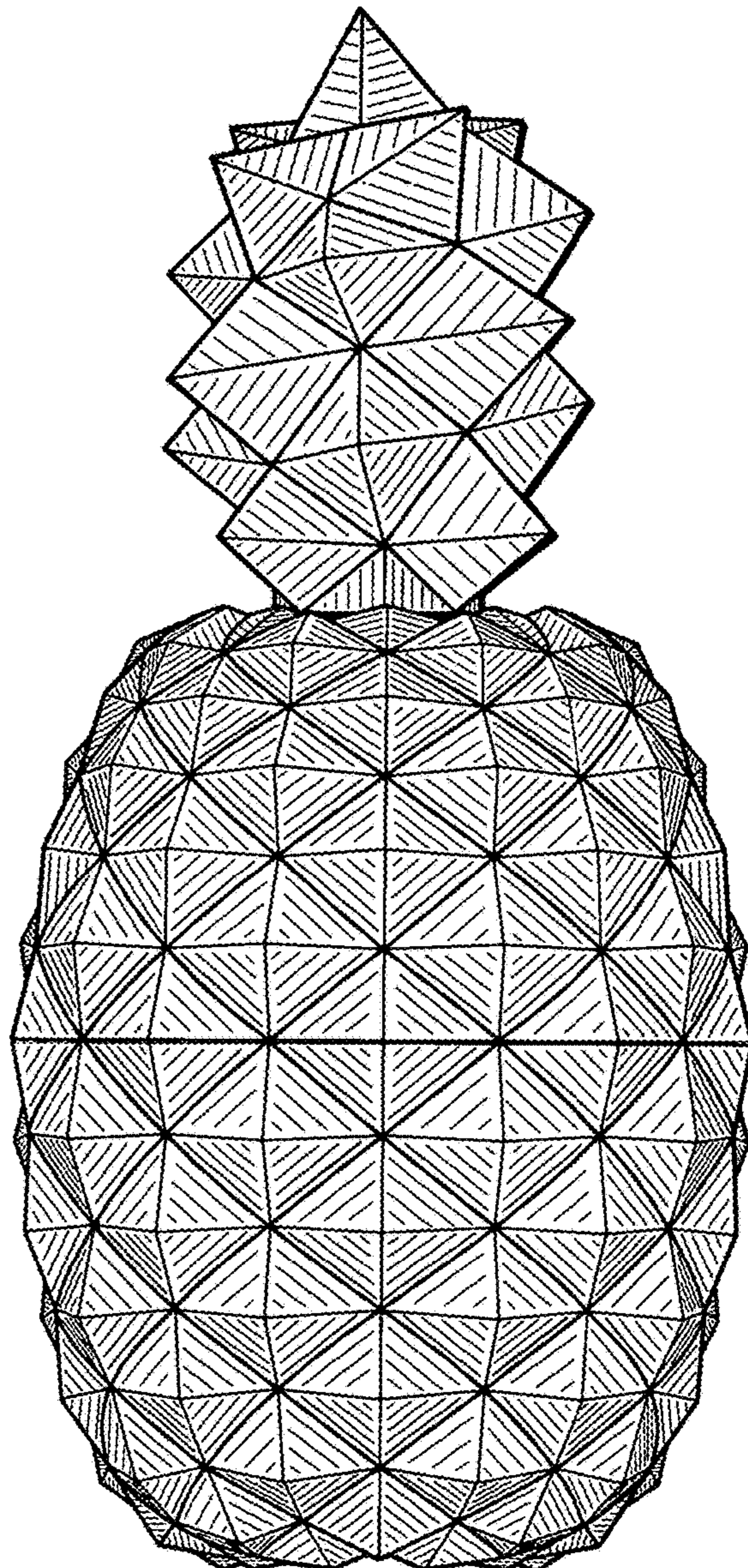

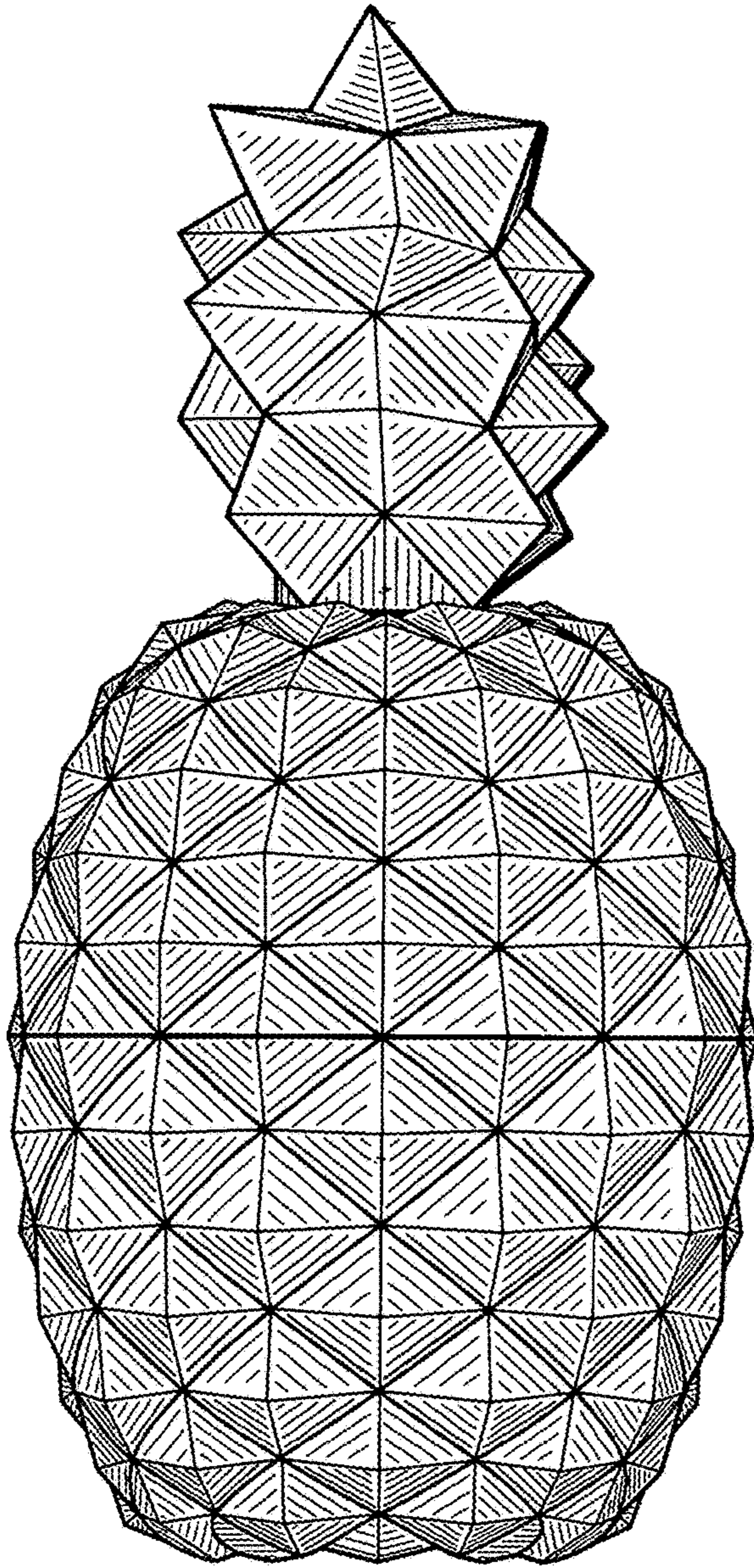

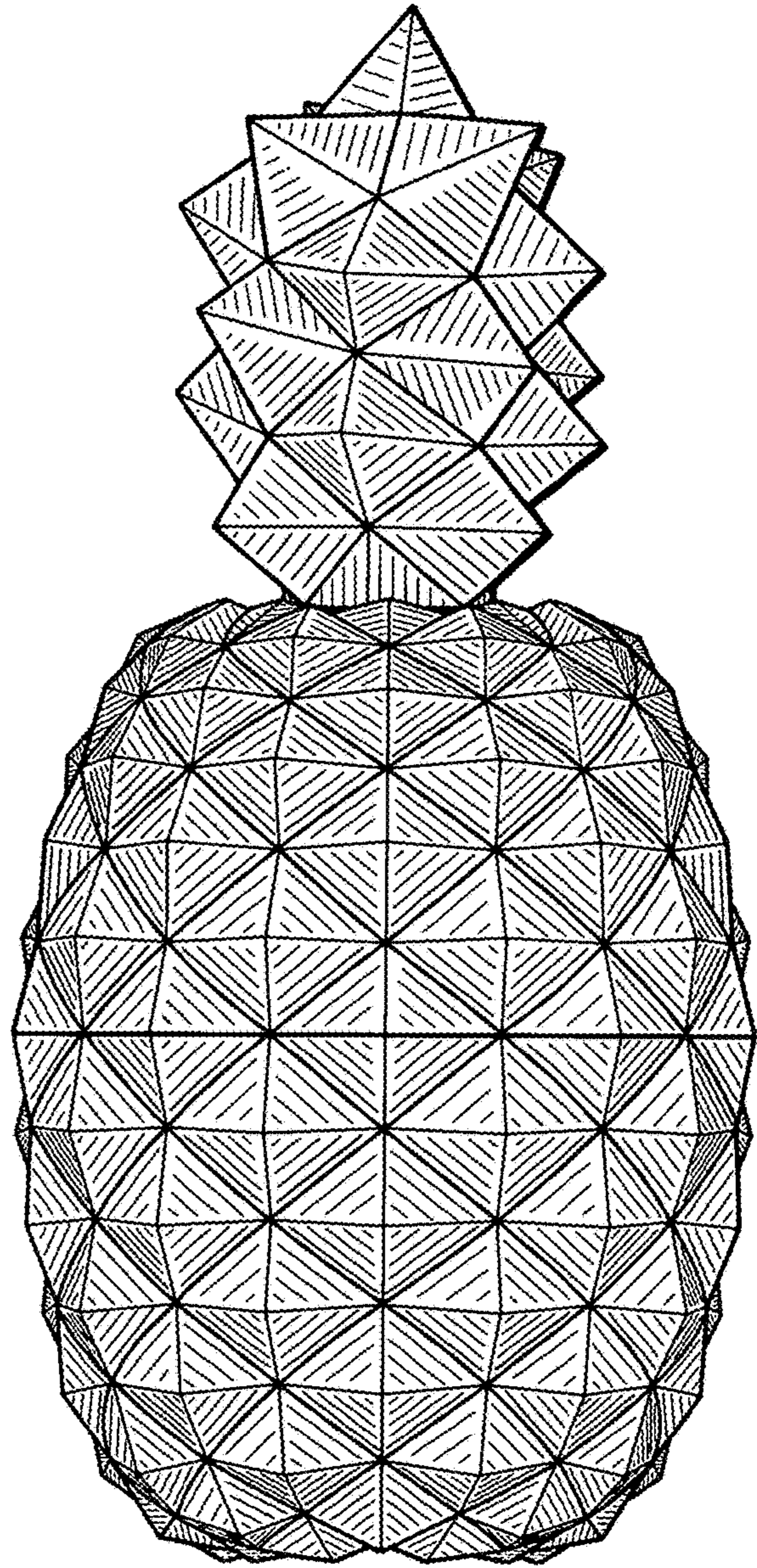

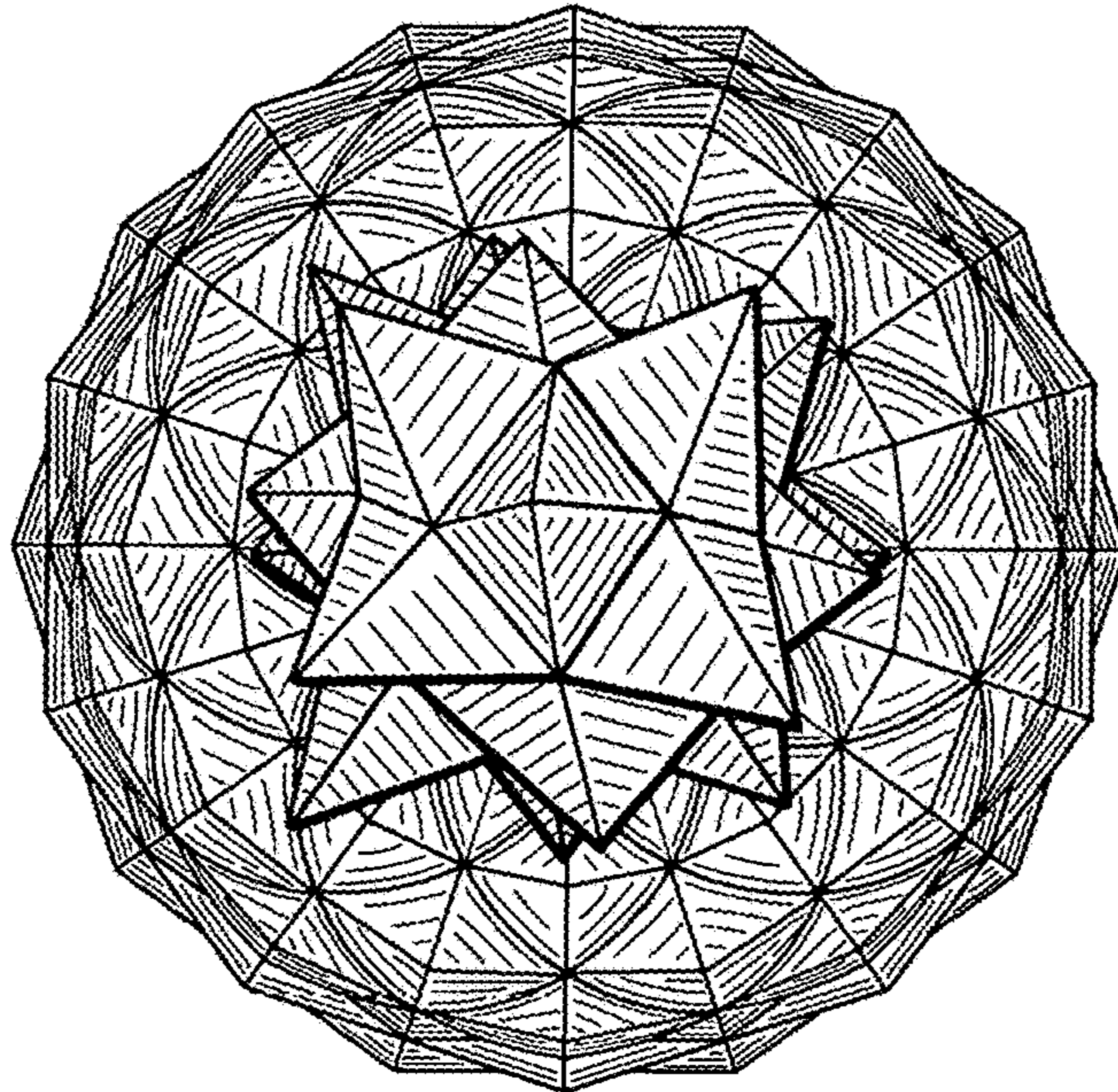

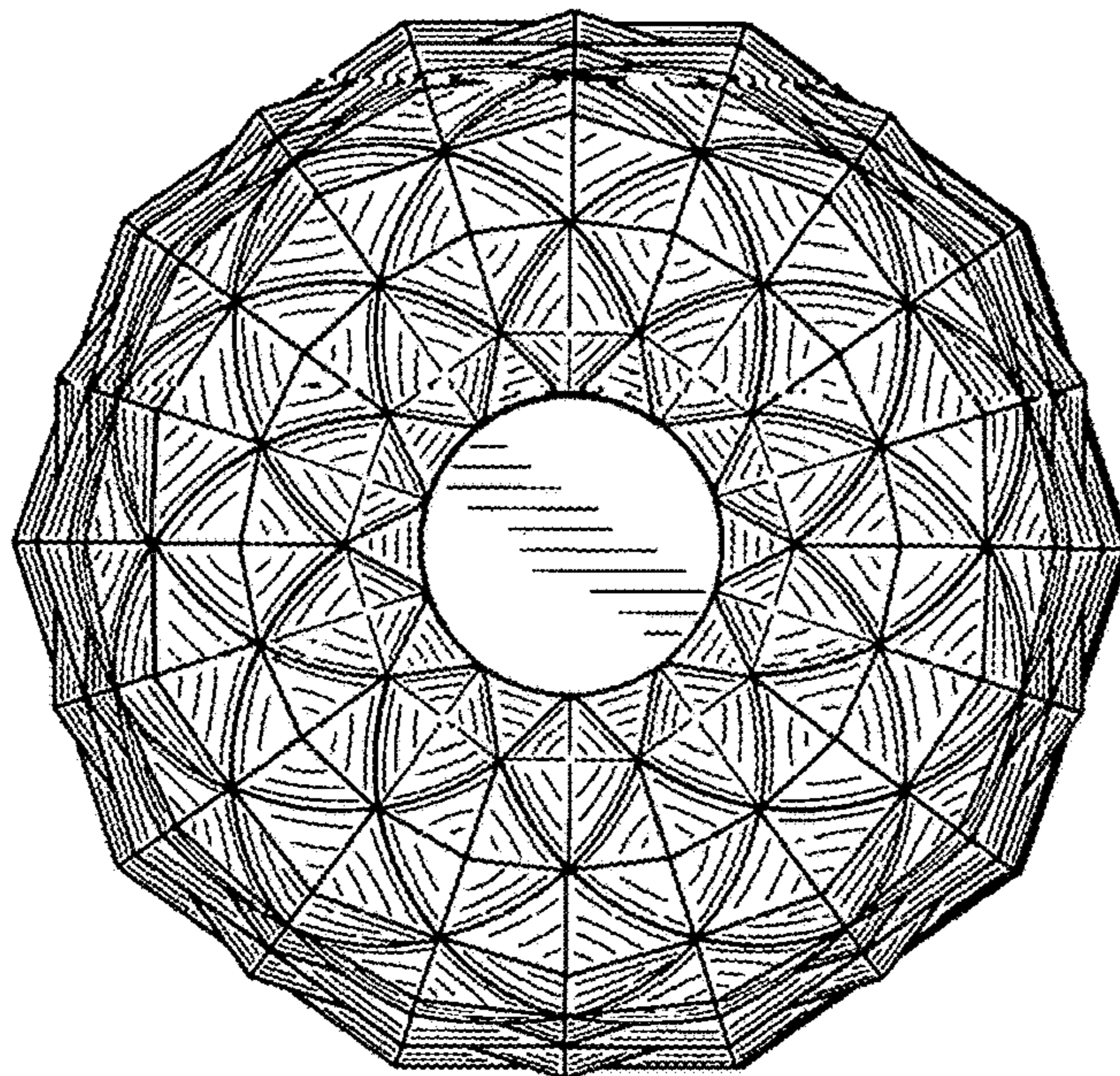

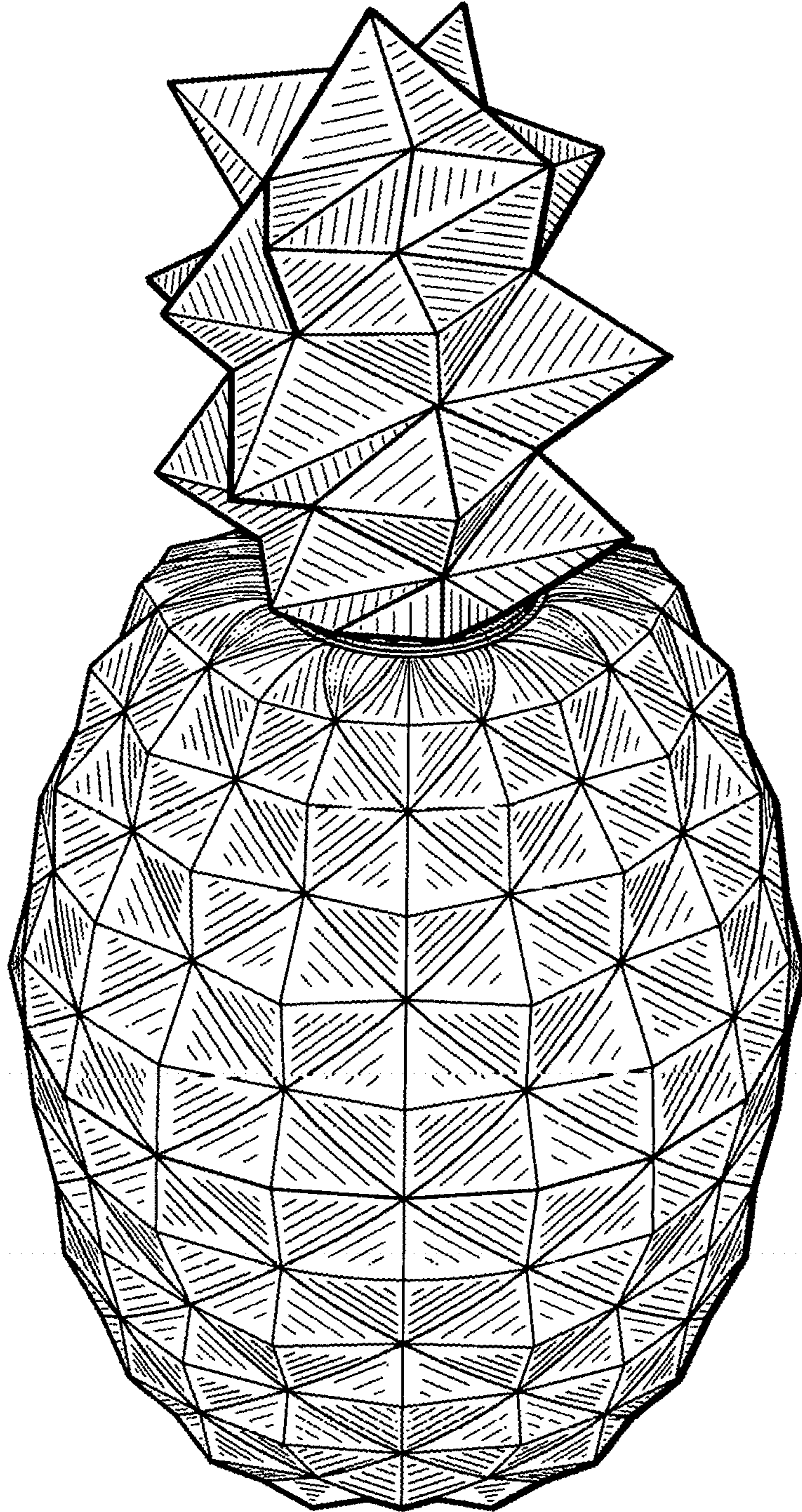
