The ornamental design for a hearing protection headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hearing protection headset showing my new design;

FIG. 2 is a front elevation view of FIG. 1;

FIG. 3 is a rear elevation view of FIG. 1;

FIG. 4 is a left side elevation view of FIG. 1;

FIG. 5 is a right side elevation view of FIG. 1;

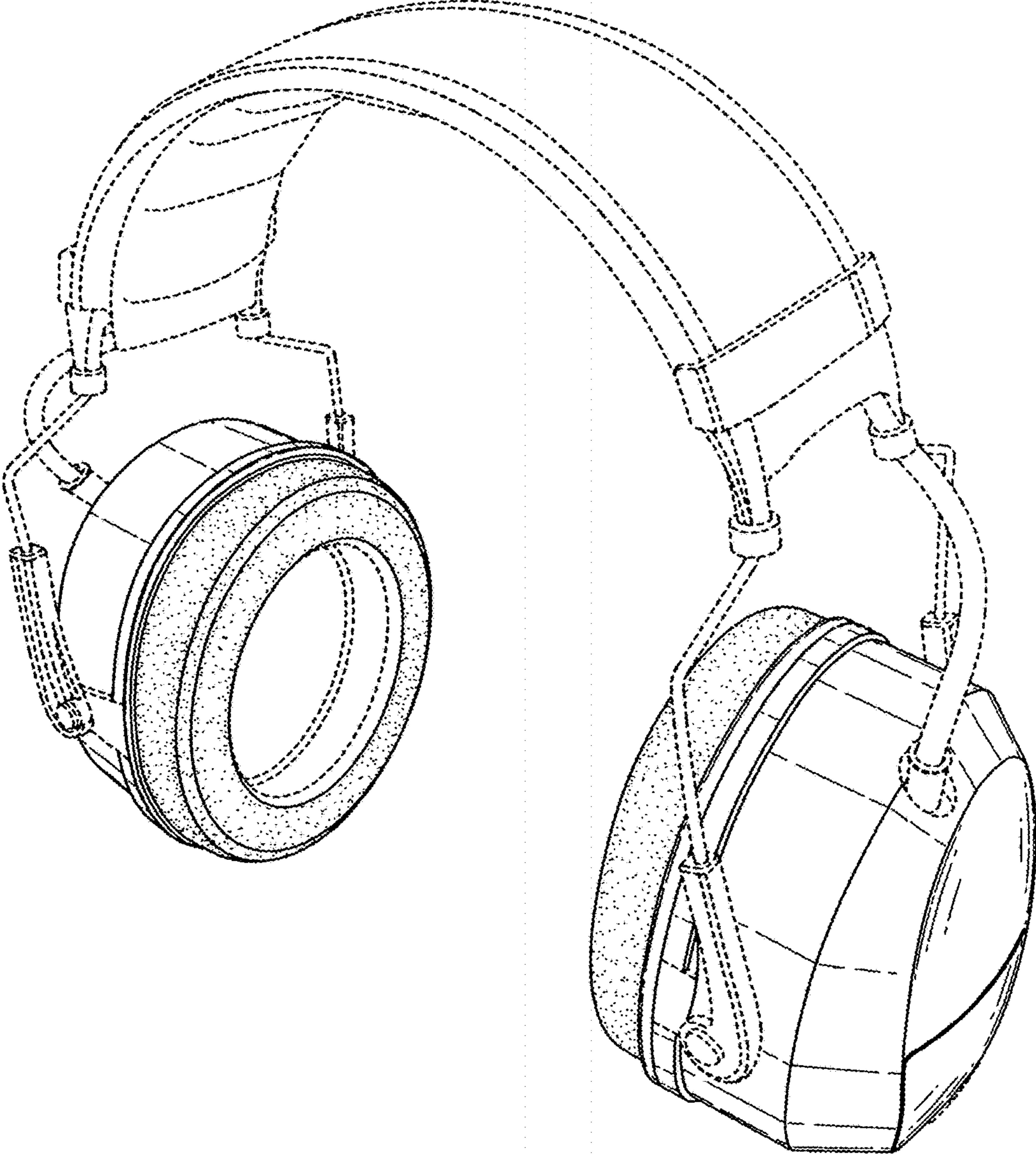

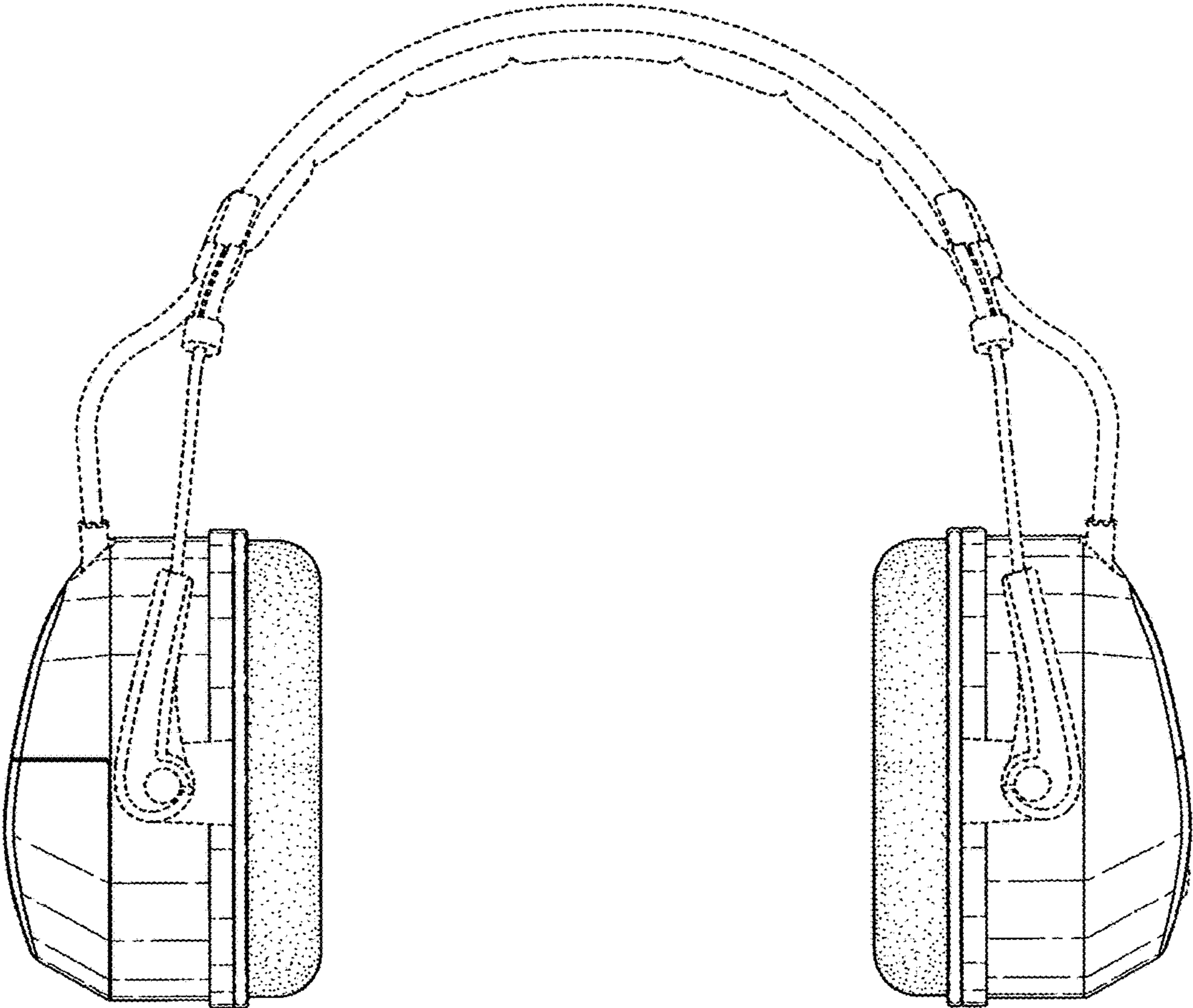

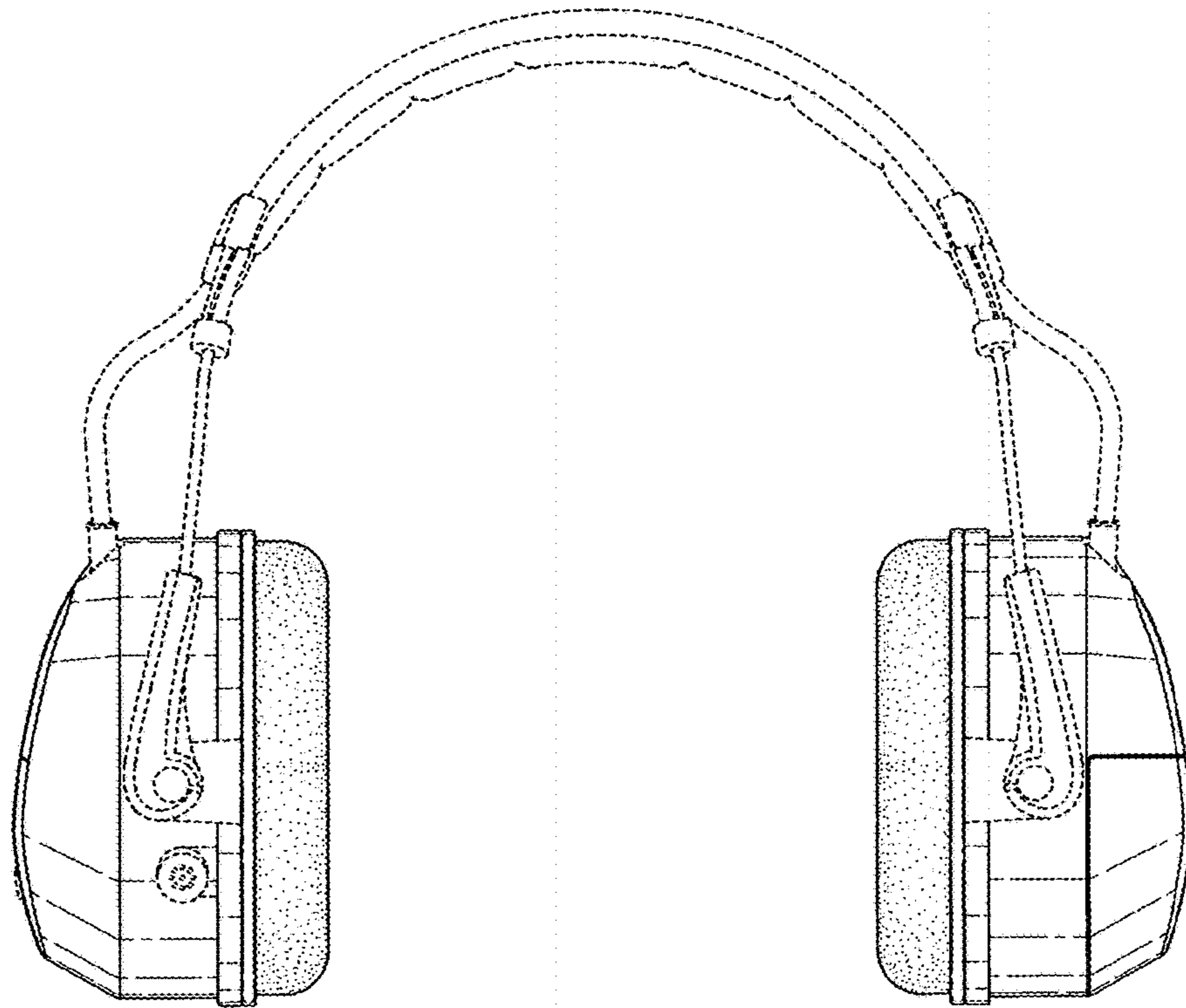

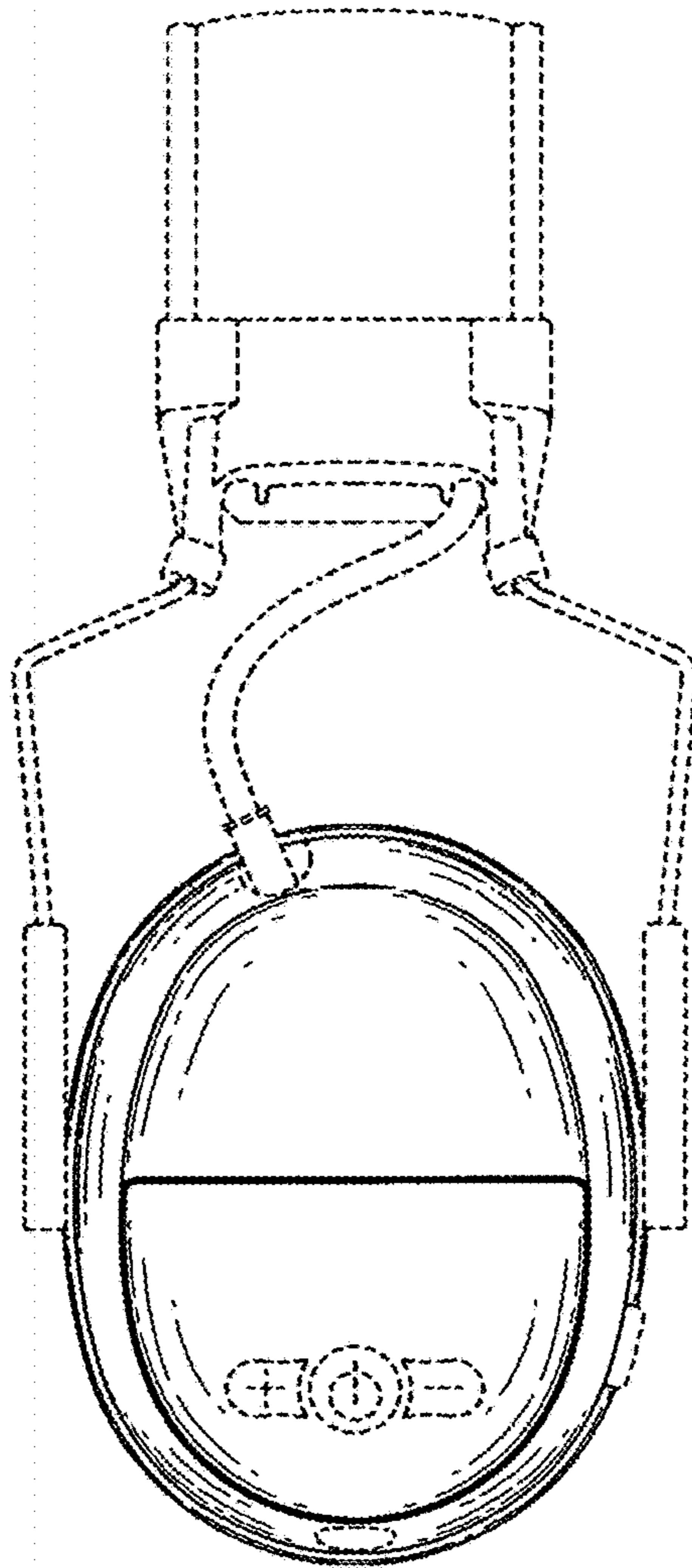

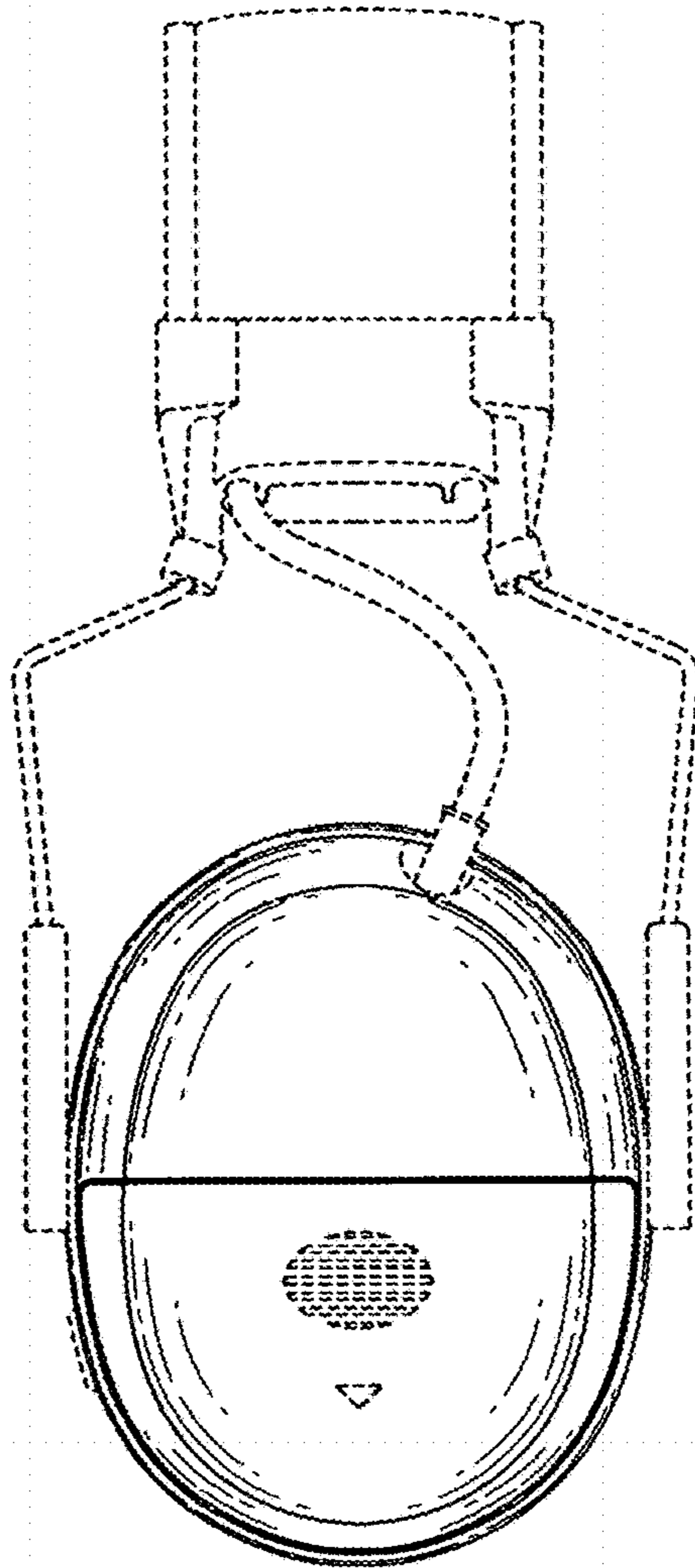

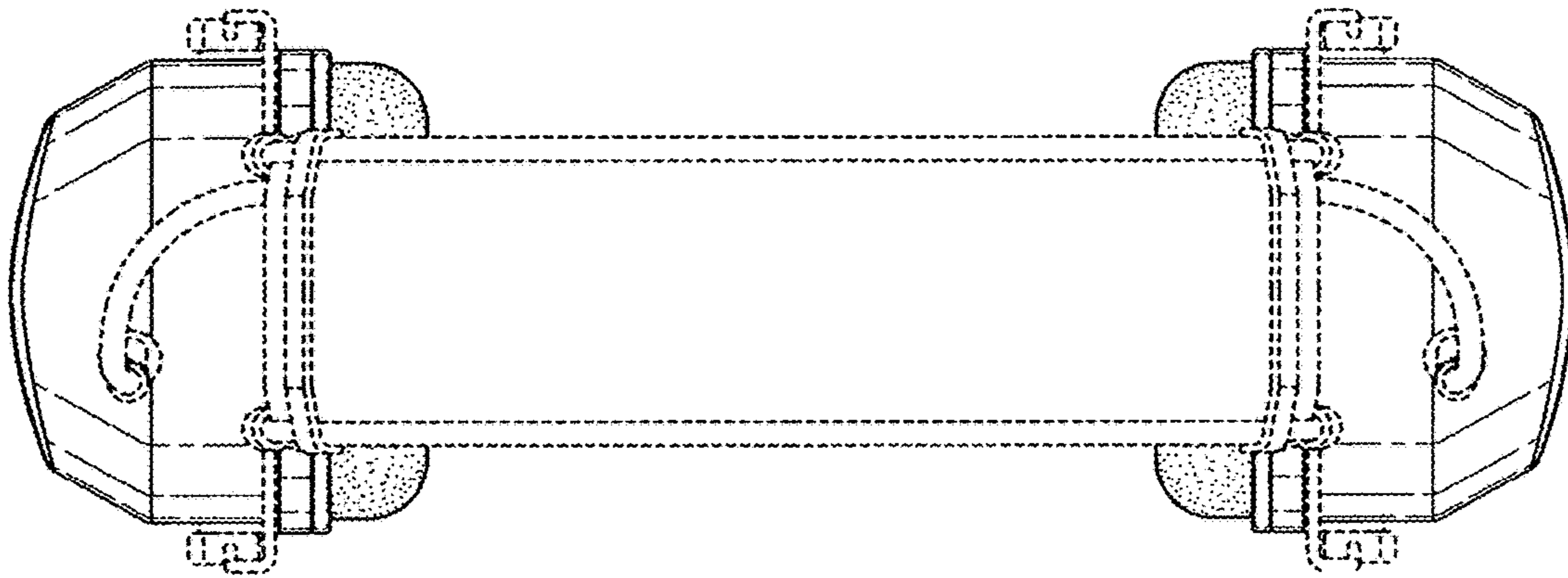

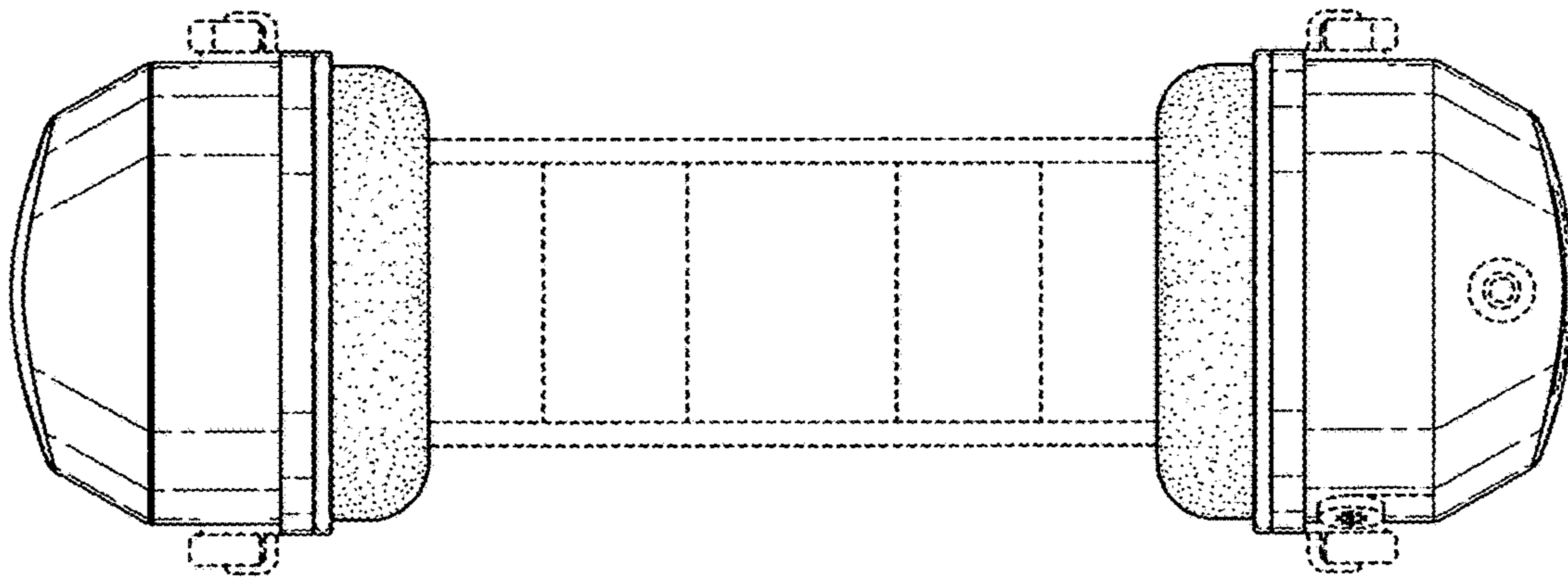
