The ornamental design for a football patterned cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a football patterned cap; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right side elevational view thereof; and, FIG. 6 is a top plan view thereof.

The broken line showing of stitching on the cap is included to show a stitching pattern and forms a part of the claimed design.

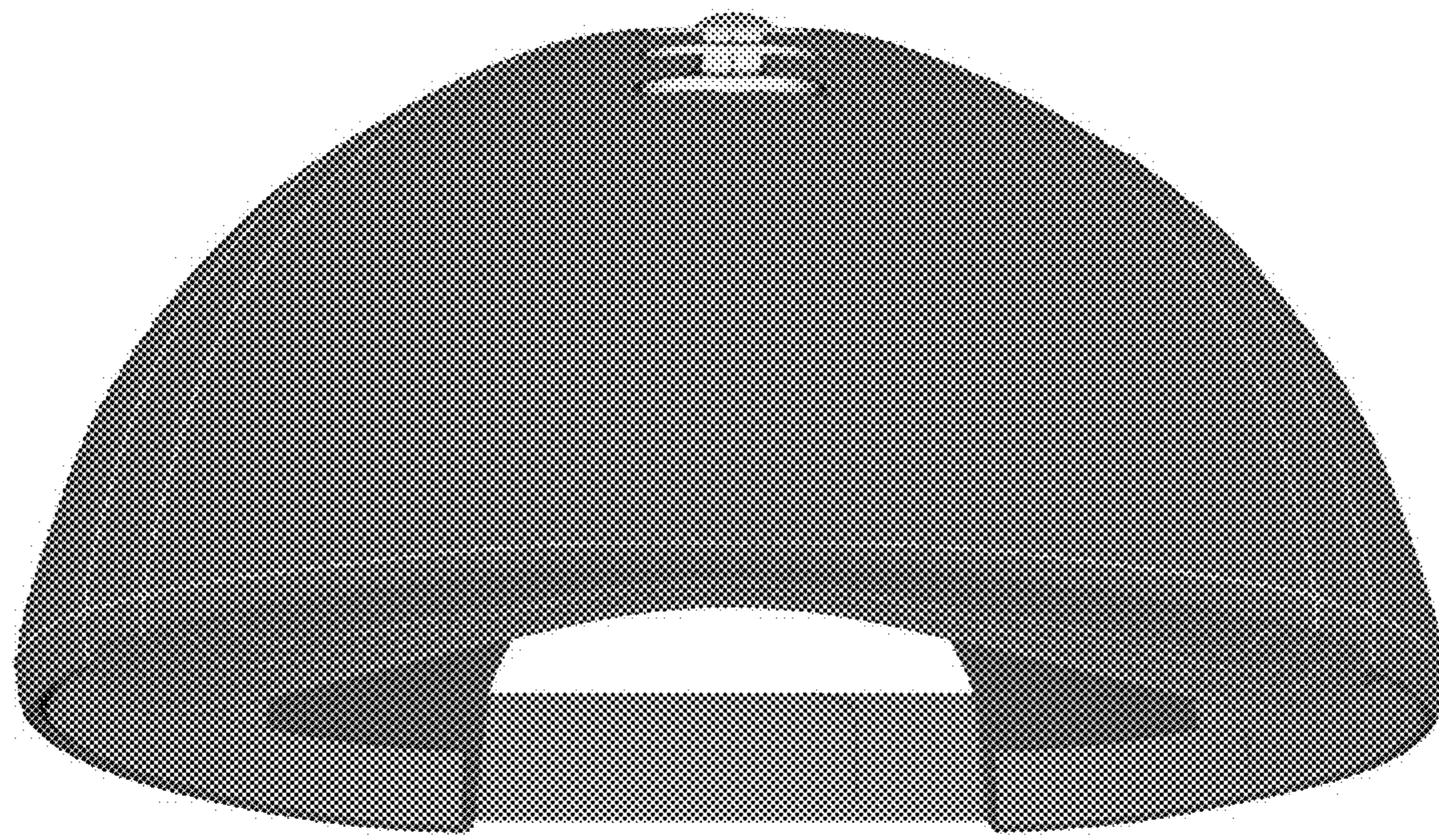

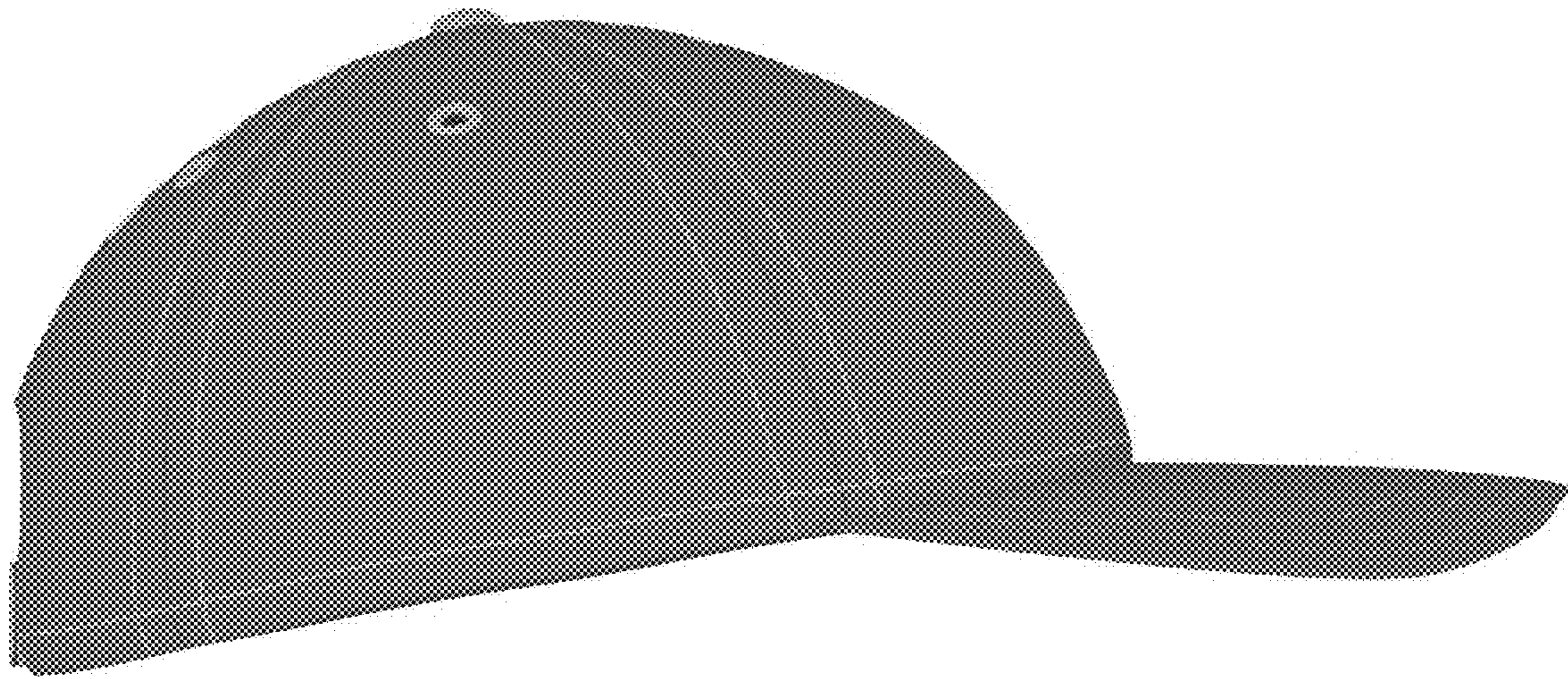

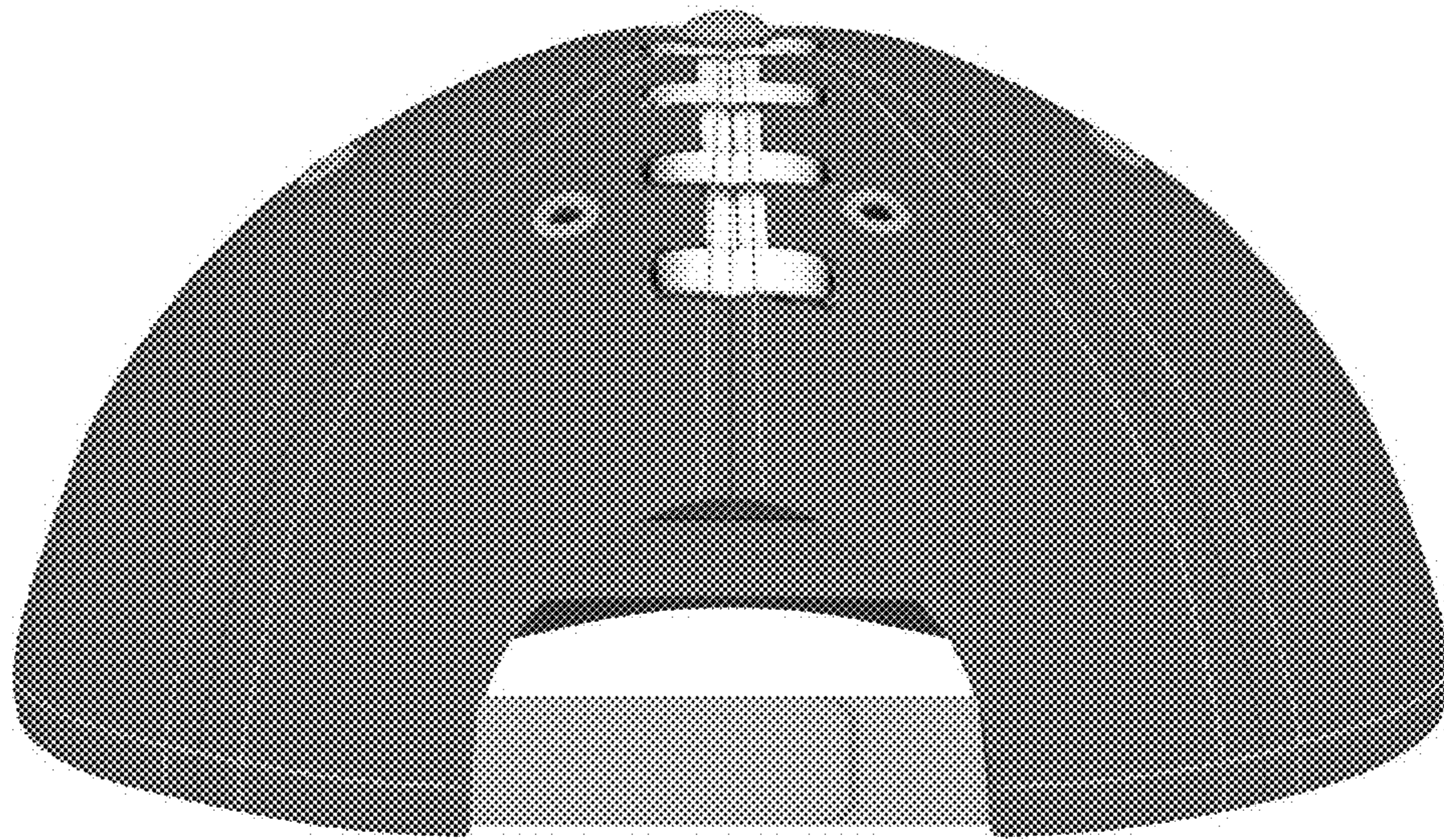

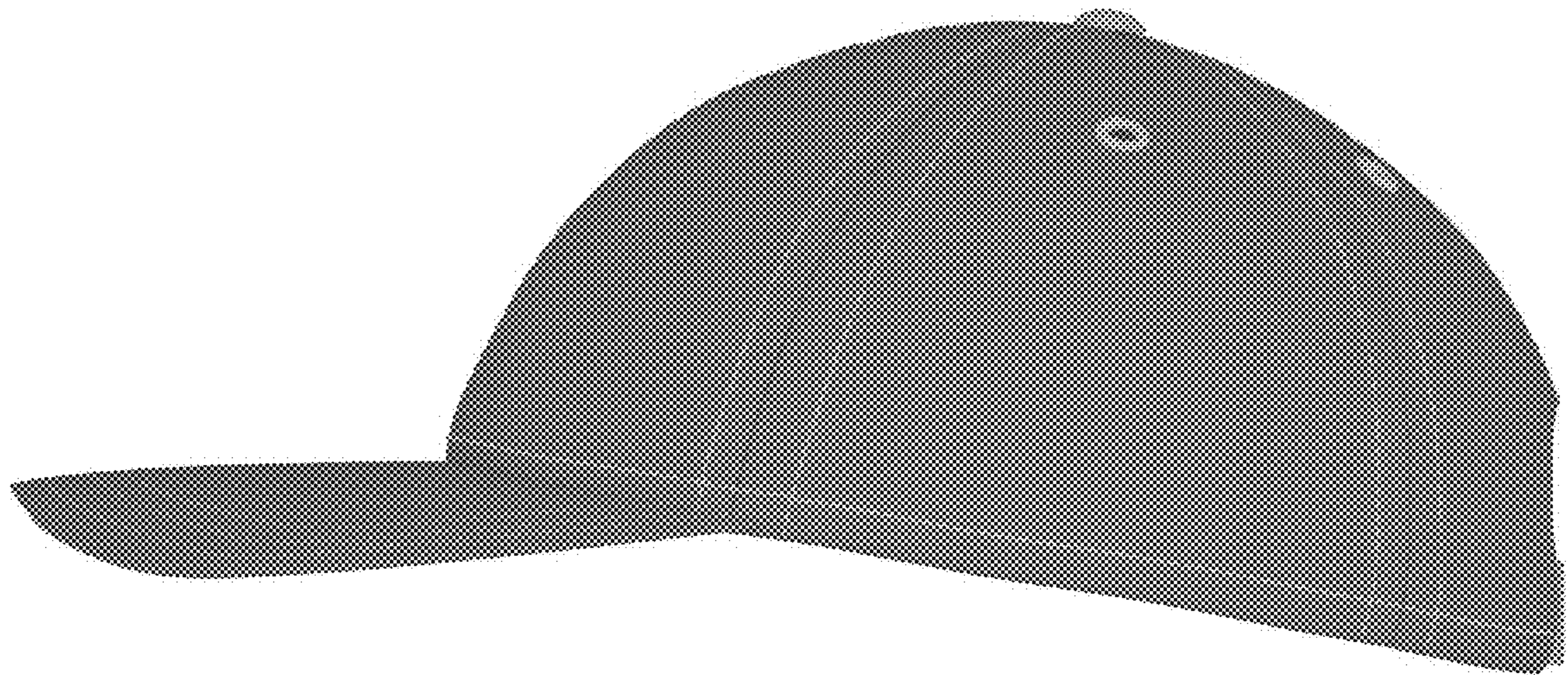

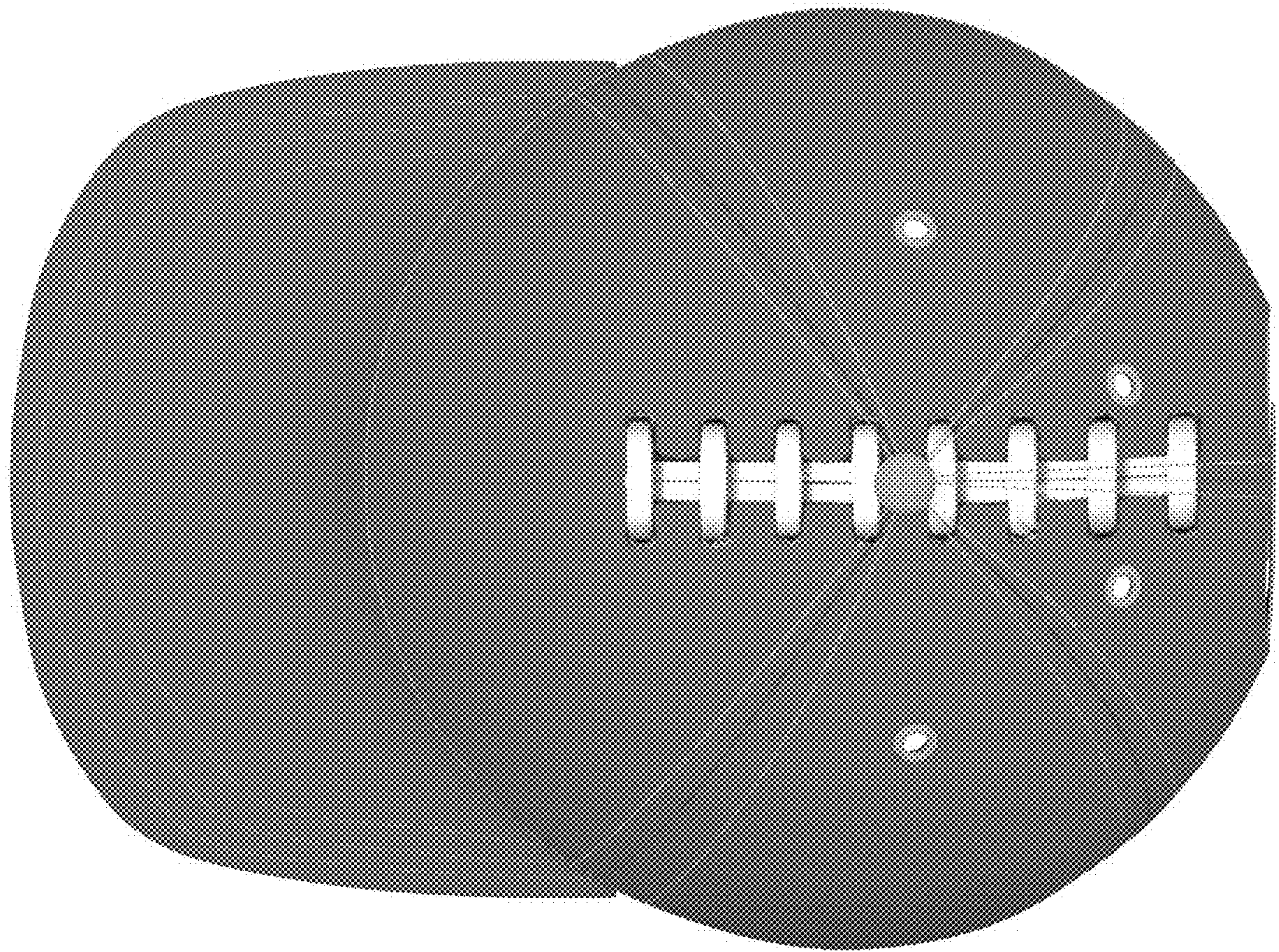
