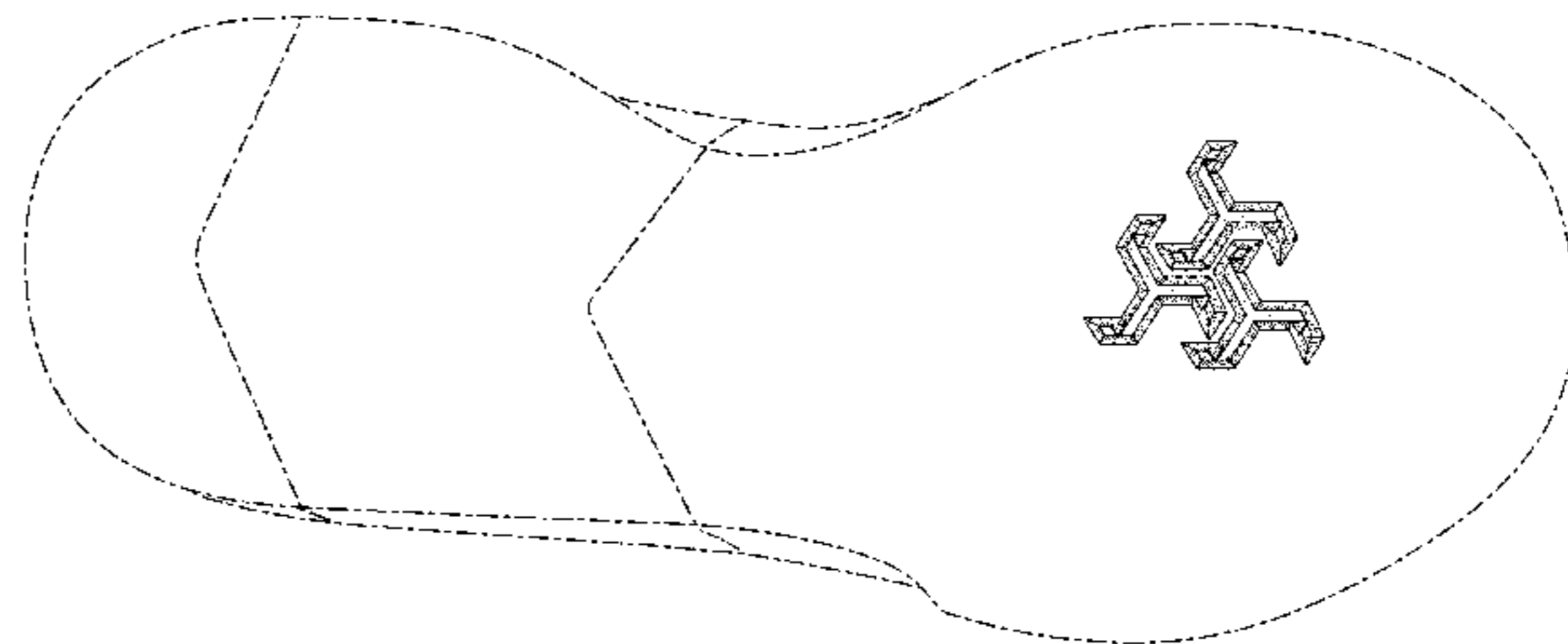
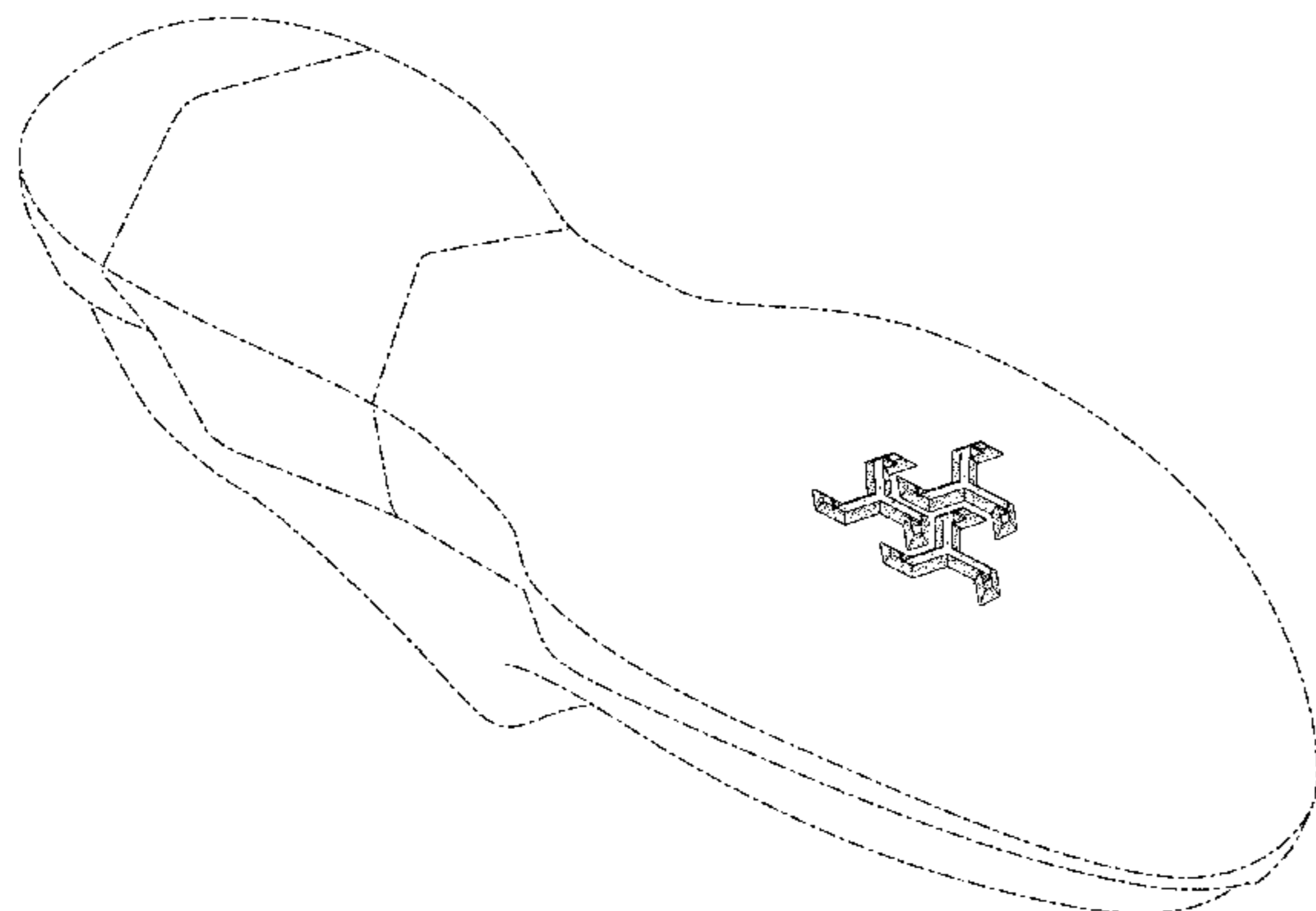
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is an enlarged partial view of FIG. 1; and,  
FIG. 5 is an enlarged partial view of FIG. 2.

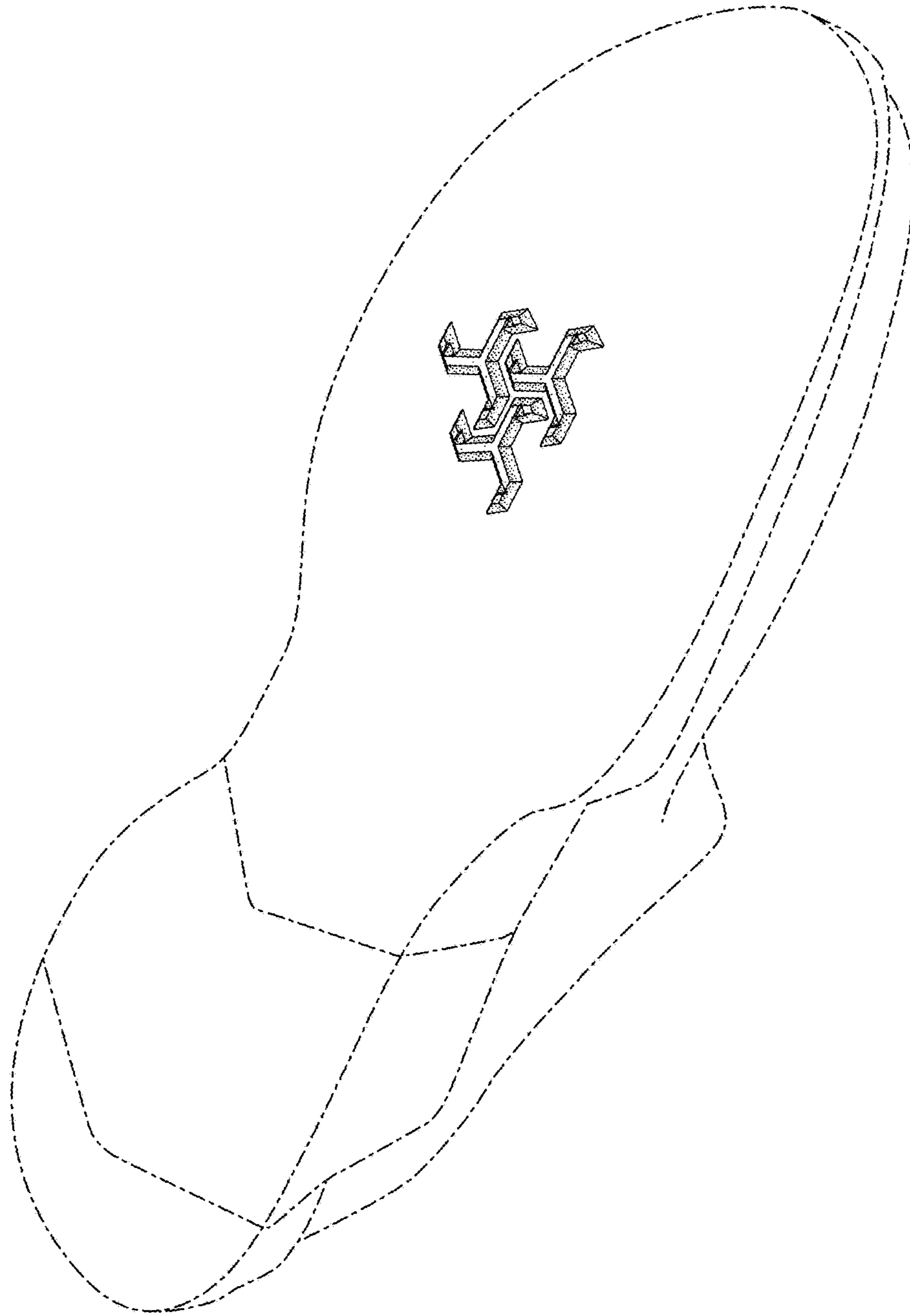

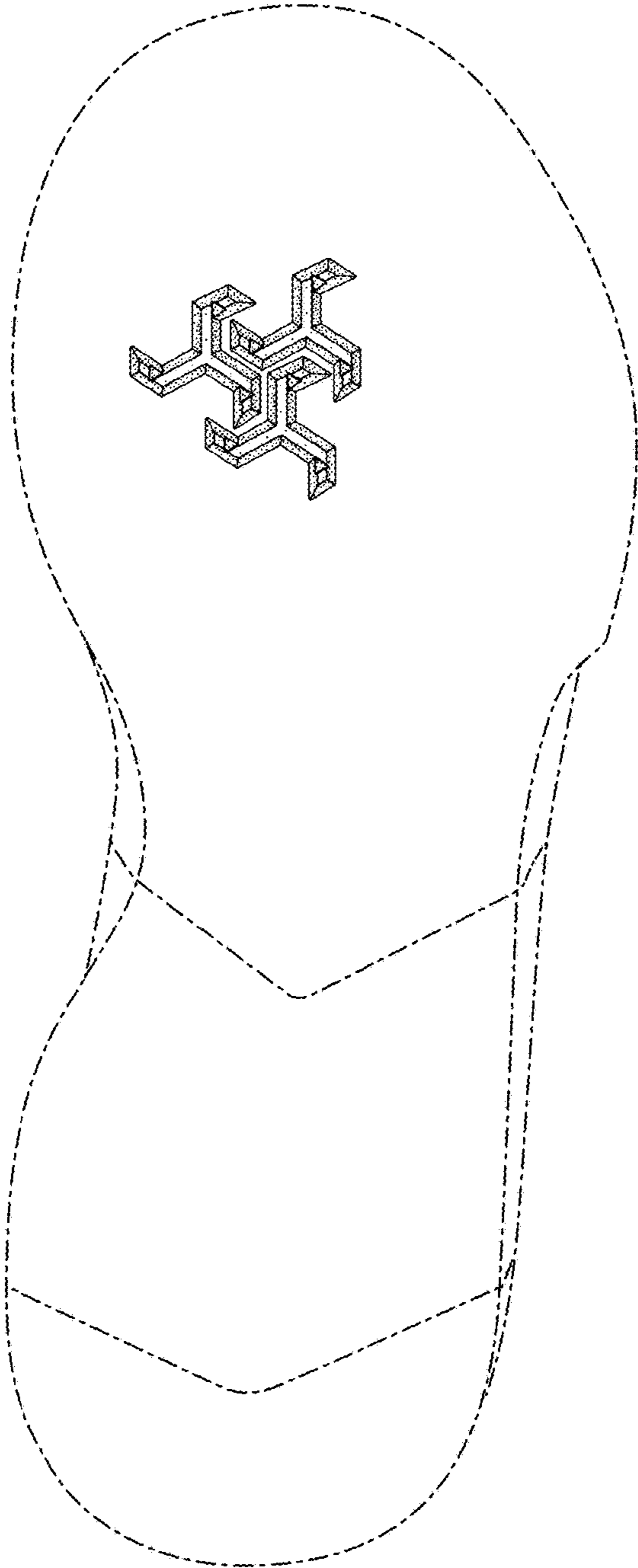

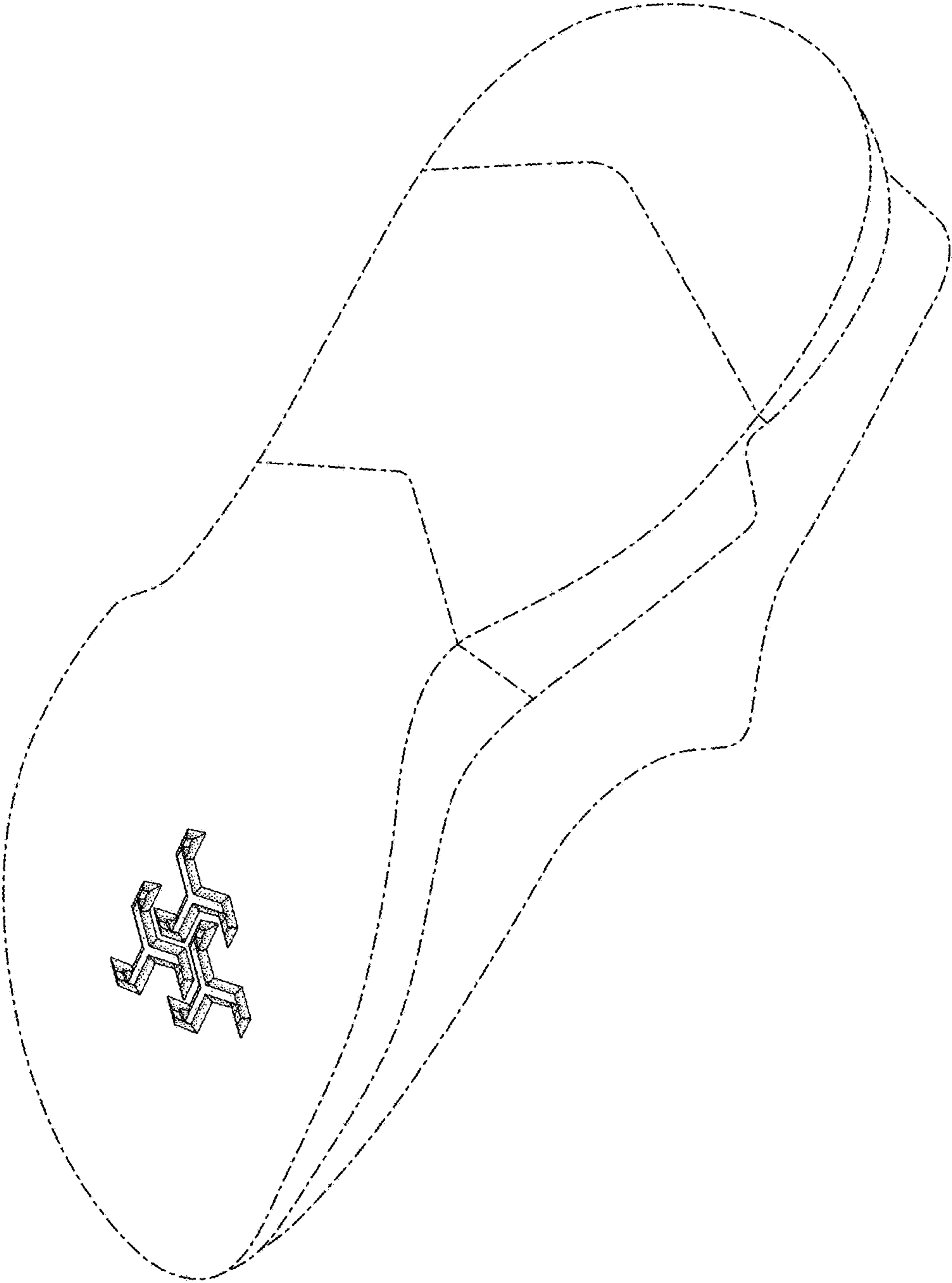

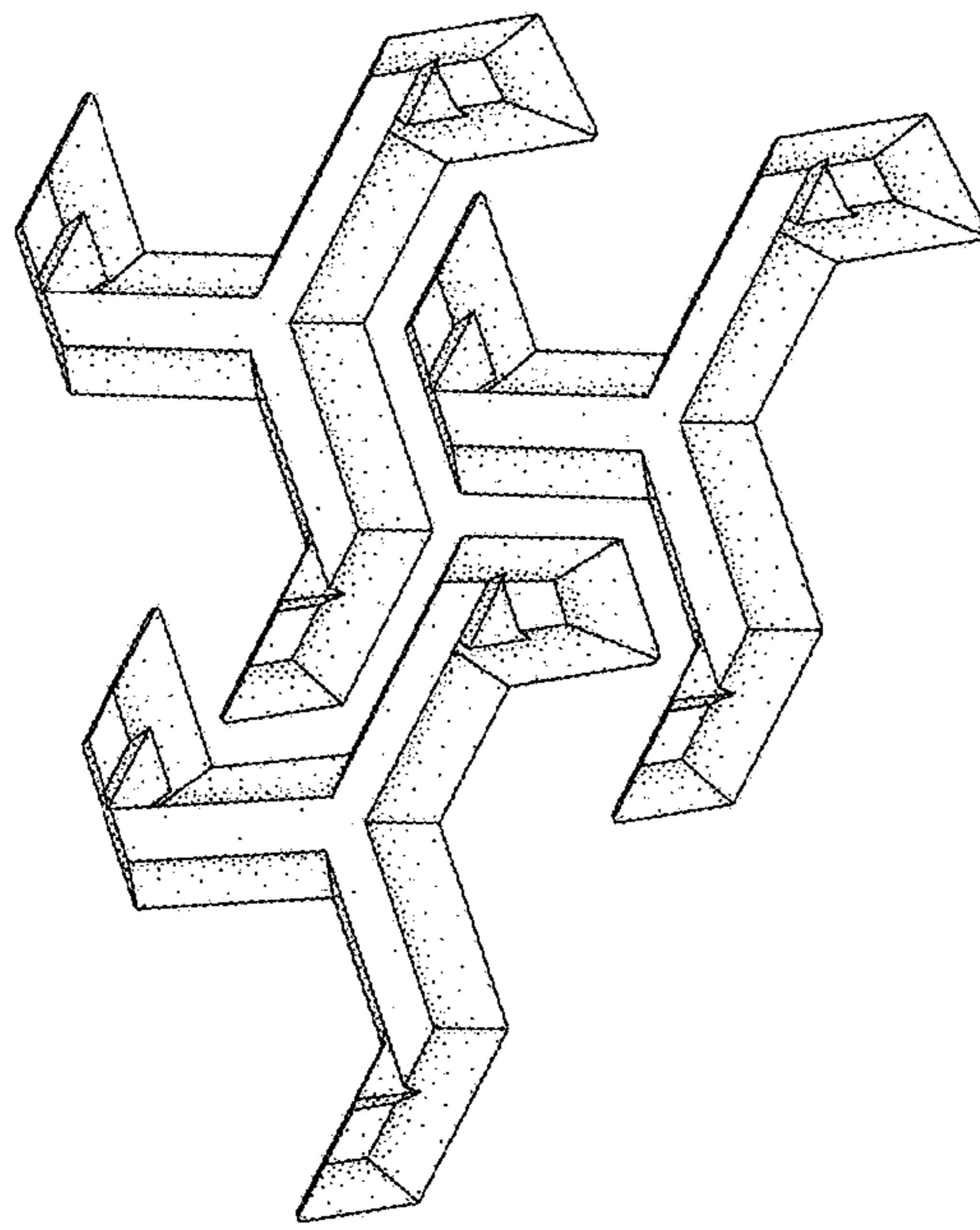

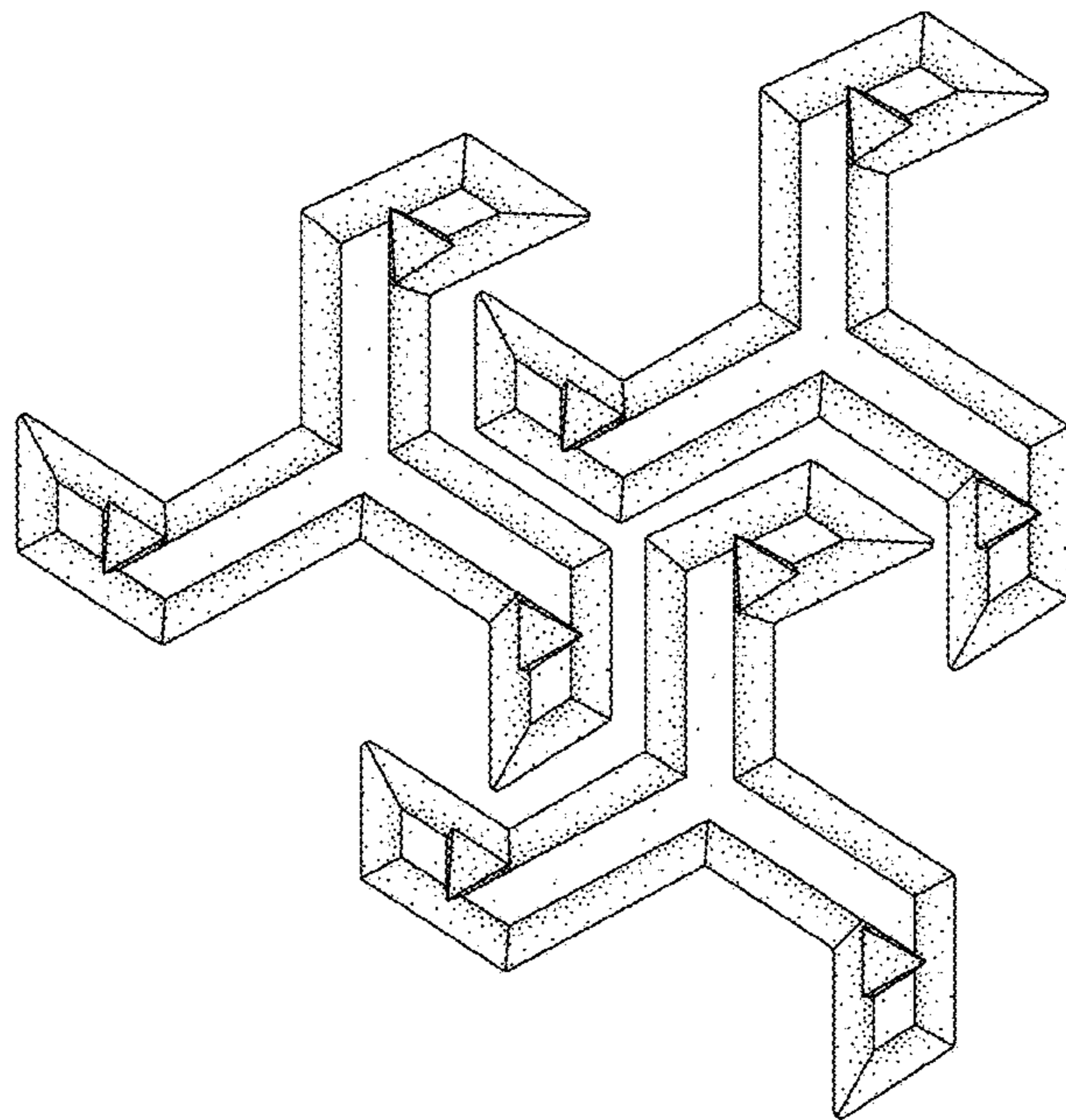
