The ornamental design for a pick holder, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a pick holder according to a preferred embodiment of the present invention;

FIG. 2 is a rear and left side perspective view of the pick holder of FIG. 1;

FIG. 3 is a front side elevational view of the pick holder of FIG. 1;

FIG. 4 is a left side elevational view of the pick holder of FIG. 1;

FIG. 5 is a right side elevational of the pick holder of FIG. 1;

FIG. 6 is a rear elevational view of the pick holder of FIG. 1;

FIG. 7 is a top plan view of the pick holder of FIG. 1;

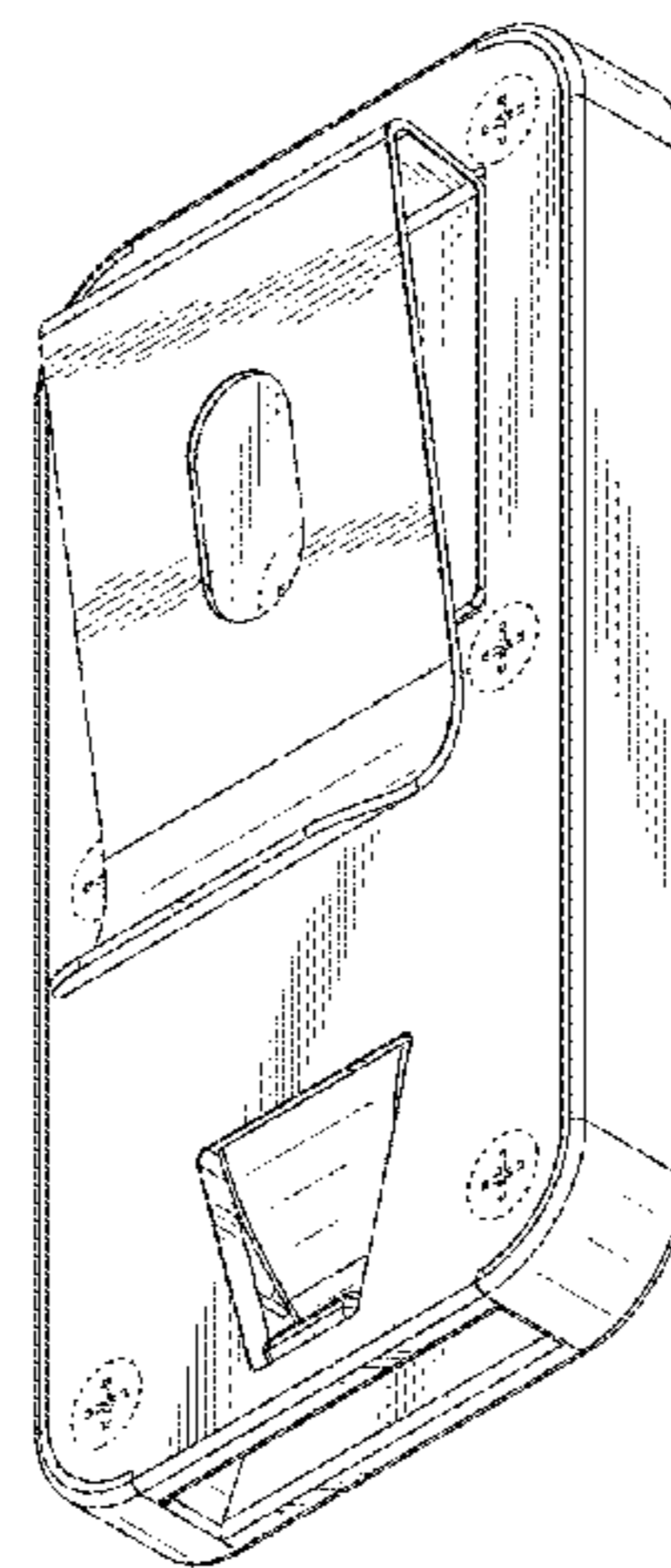
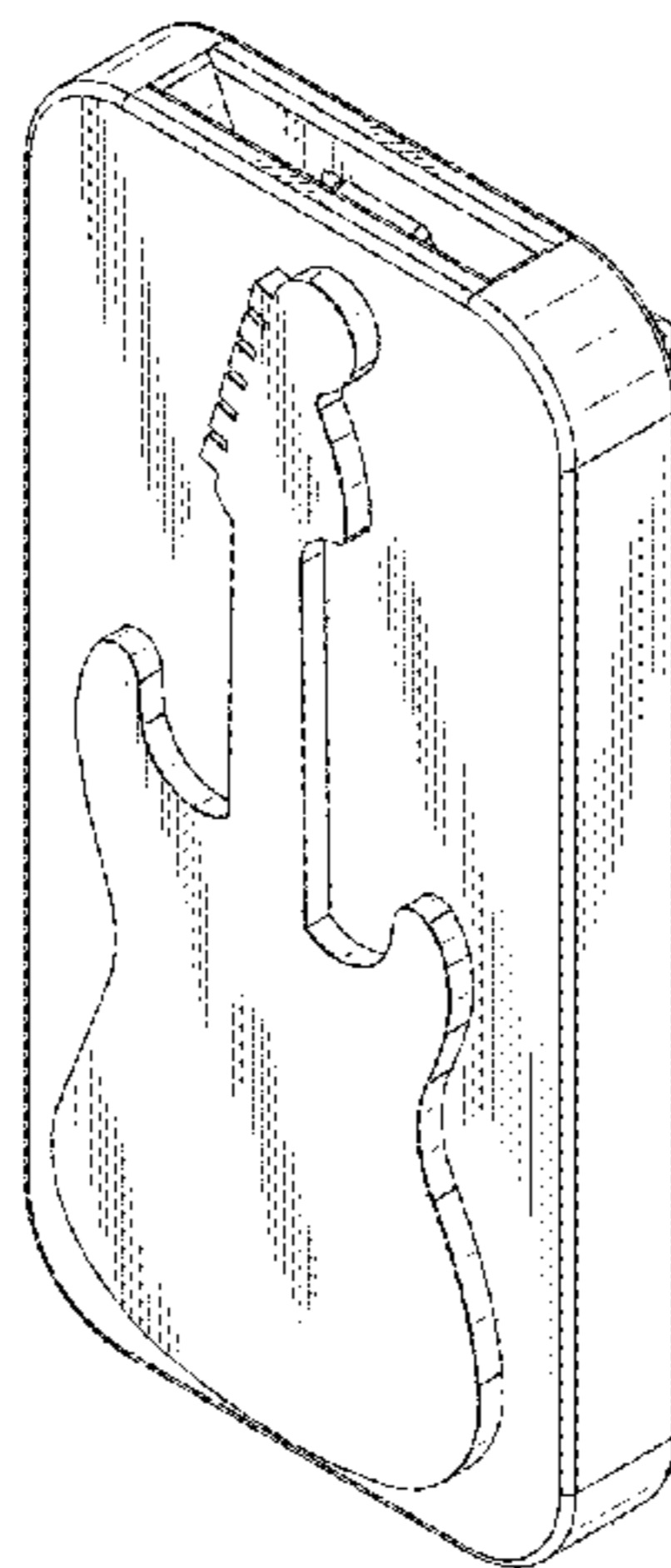
FIG. 8 is a bottom plan view of the pick holder of FIG. 1;

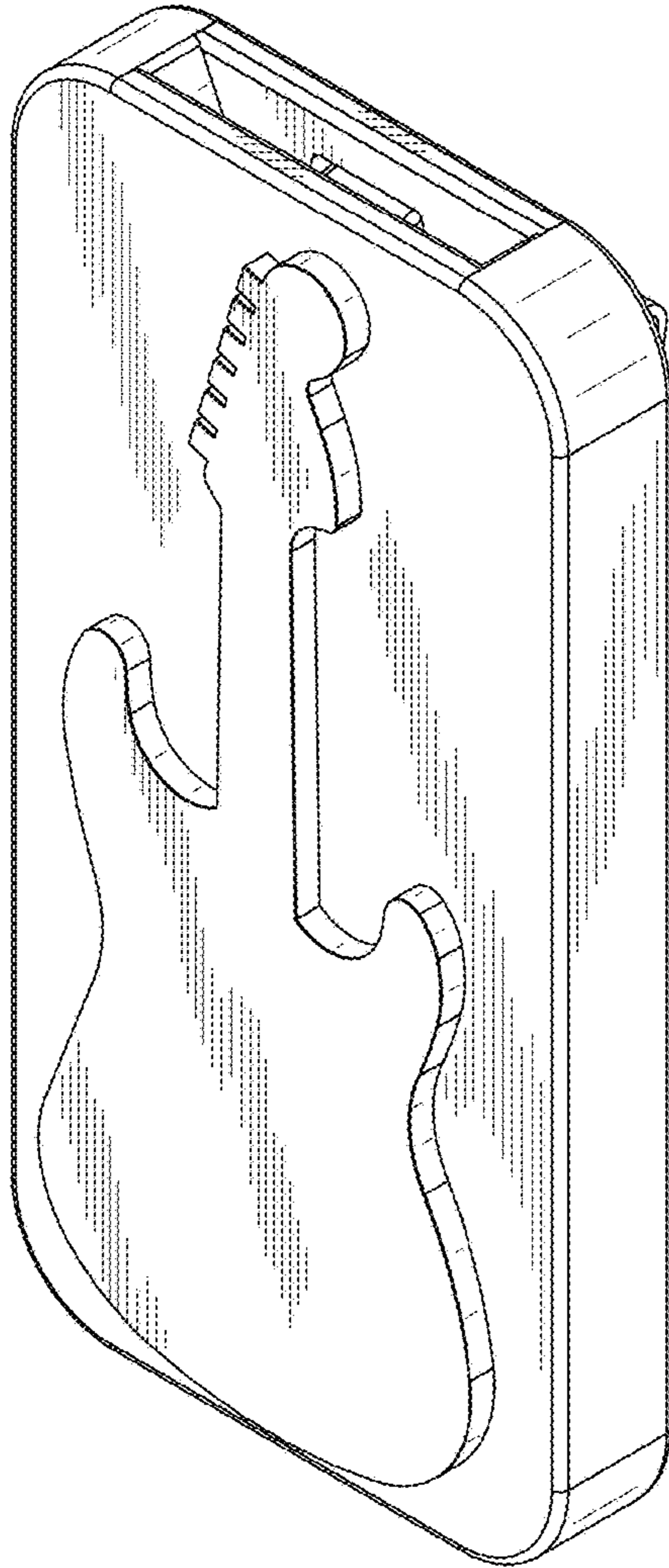

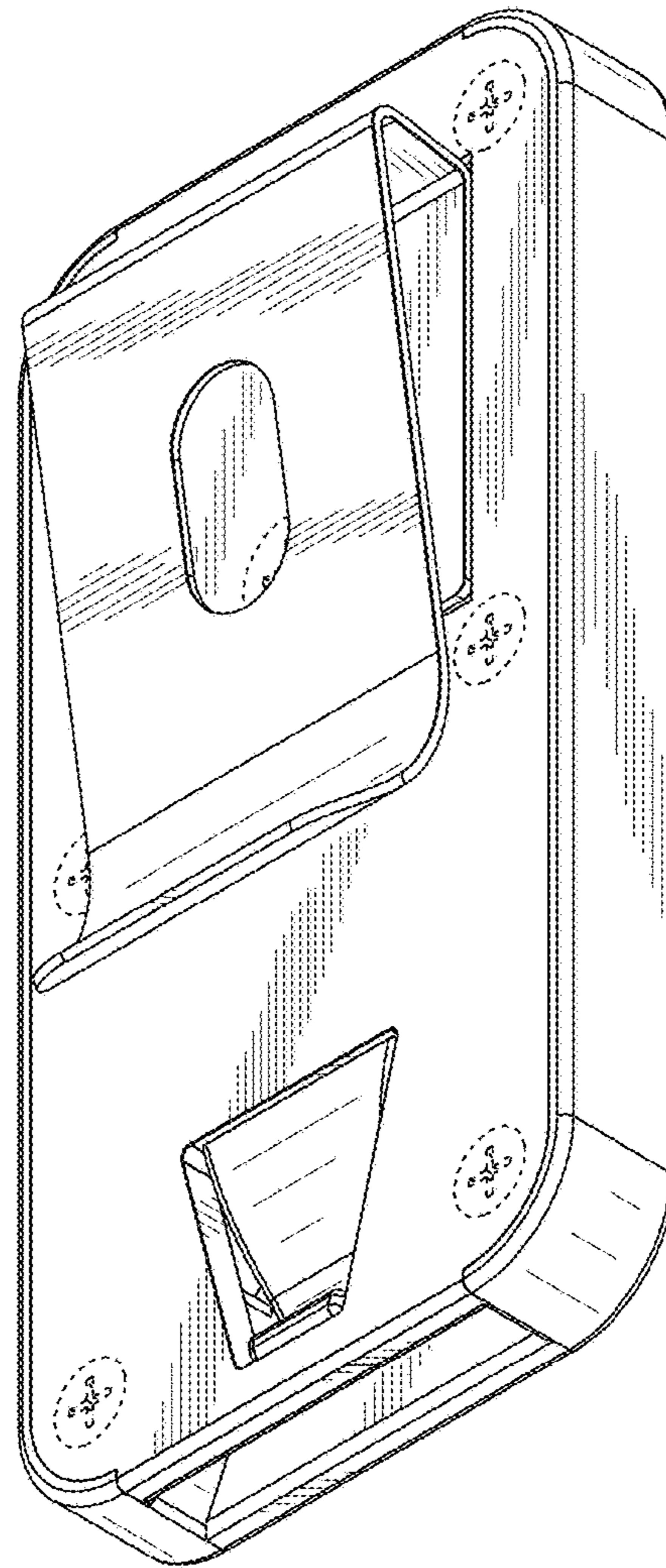

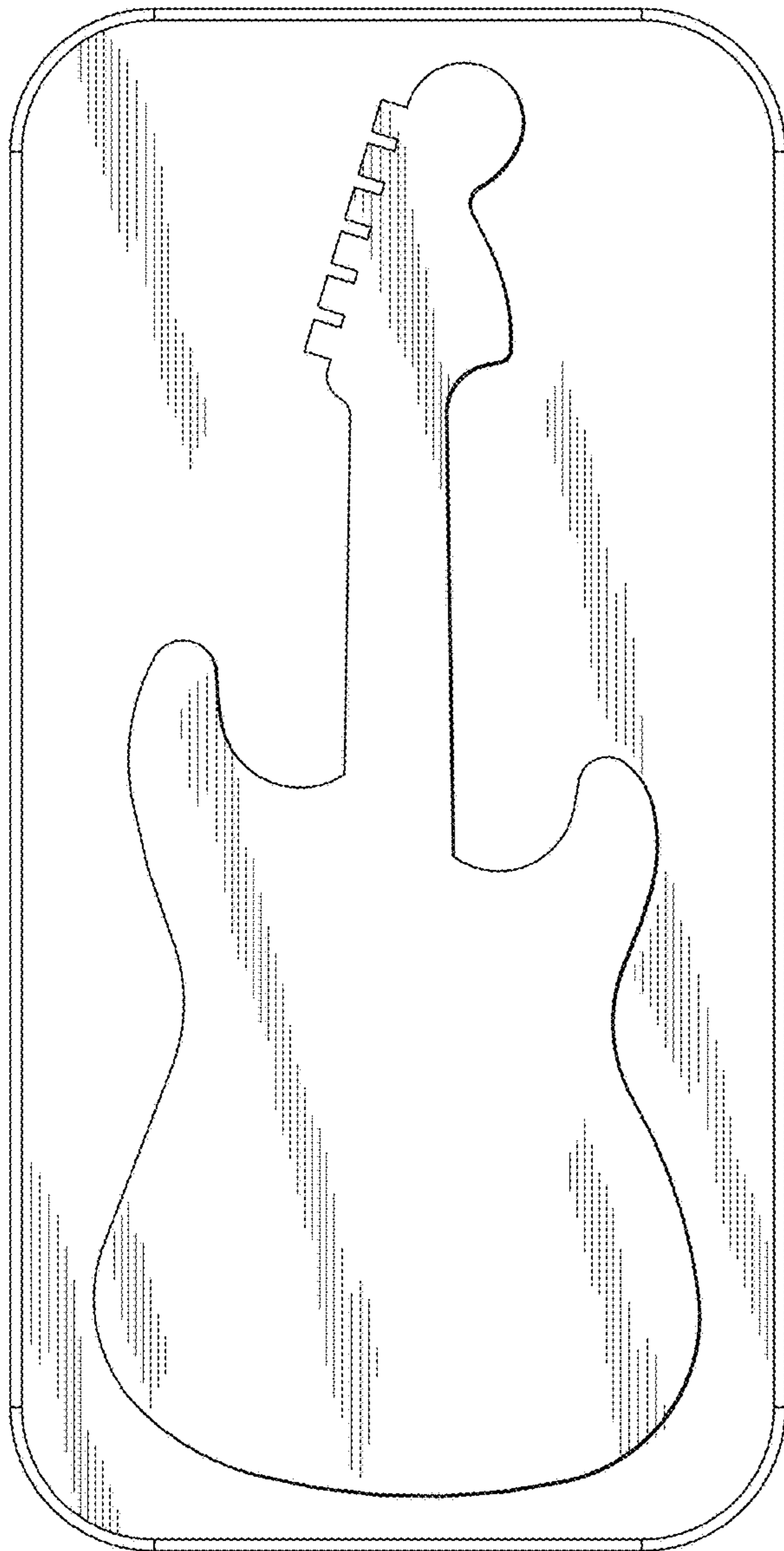

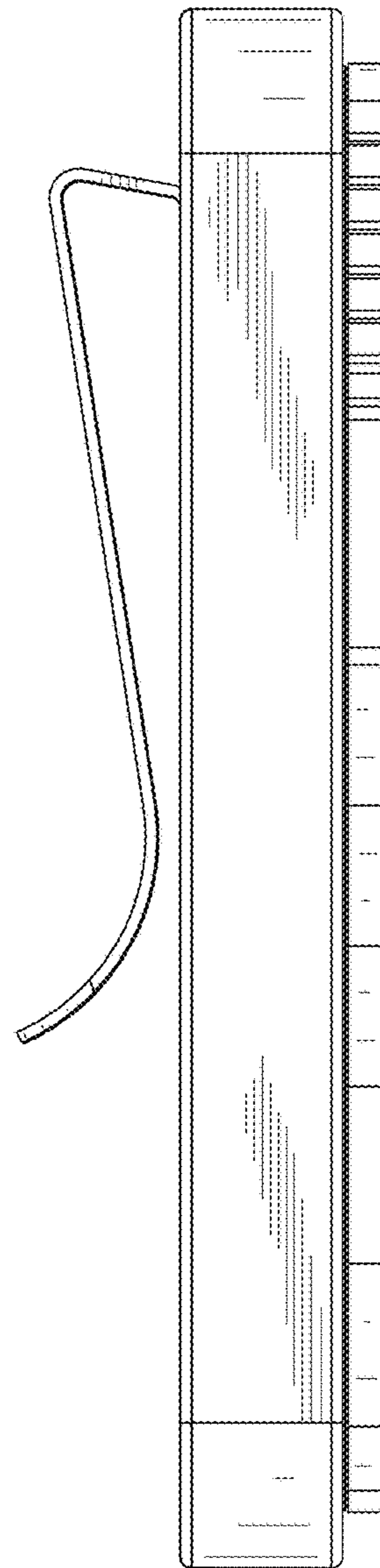

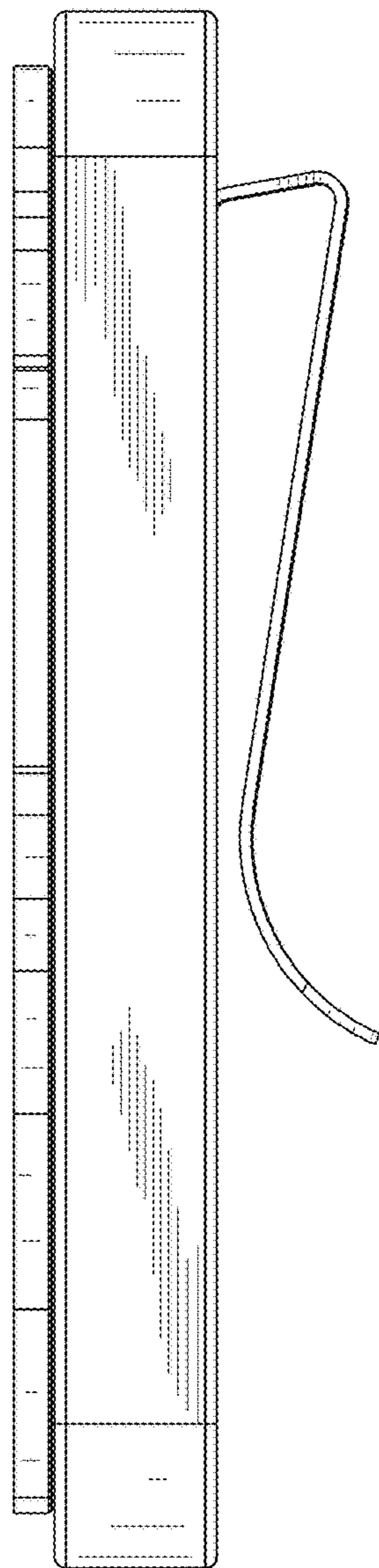

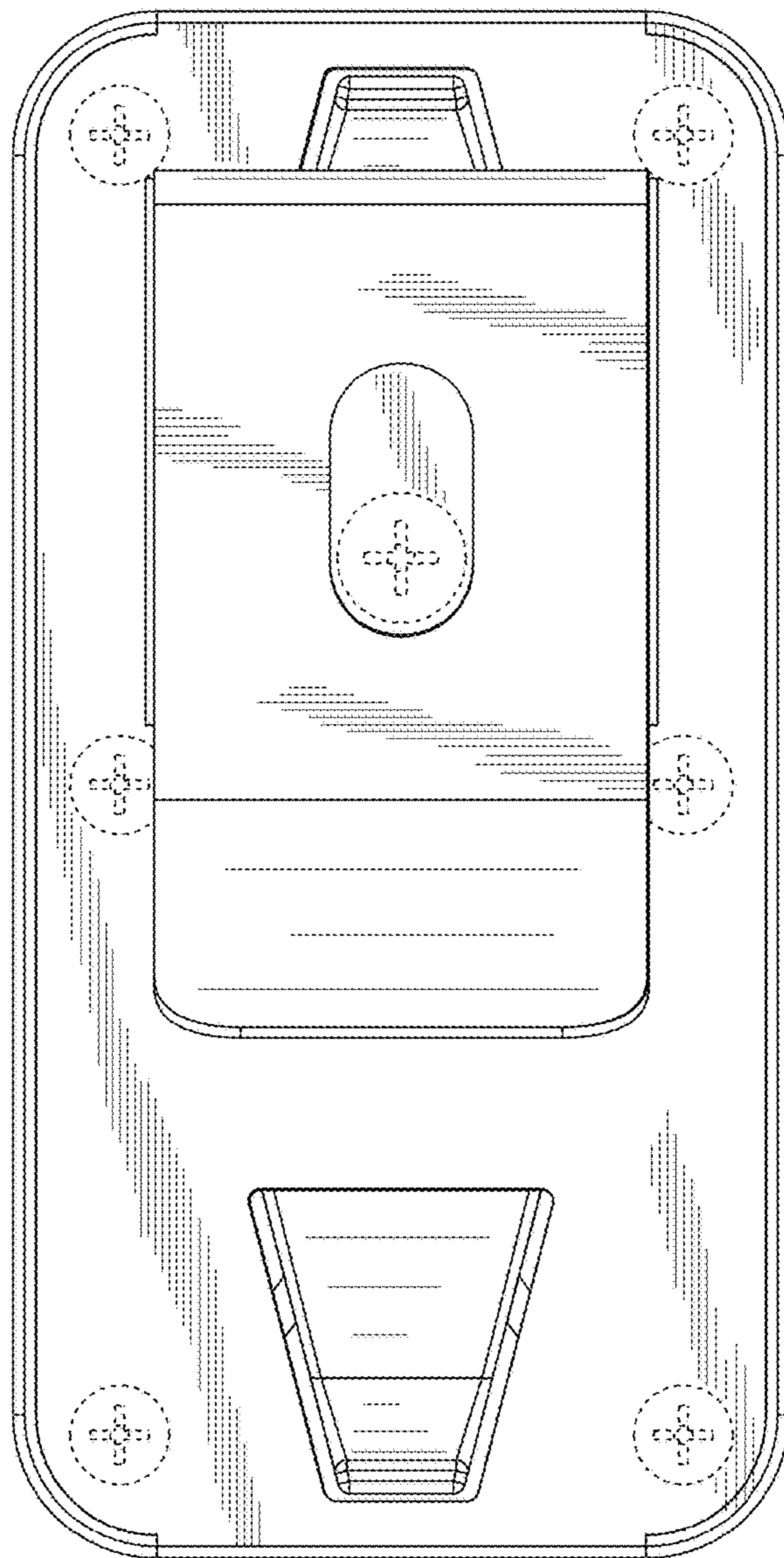

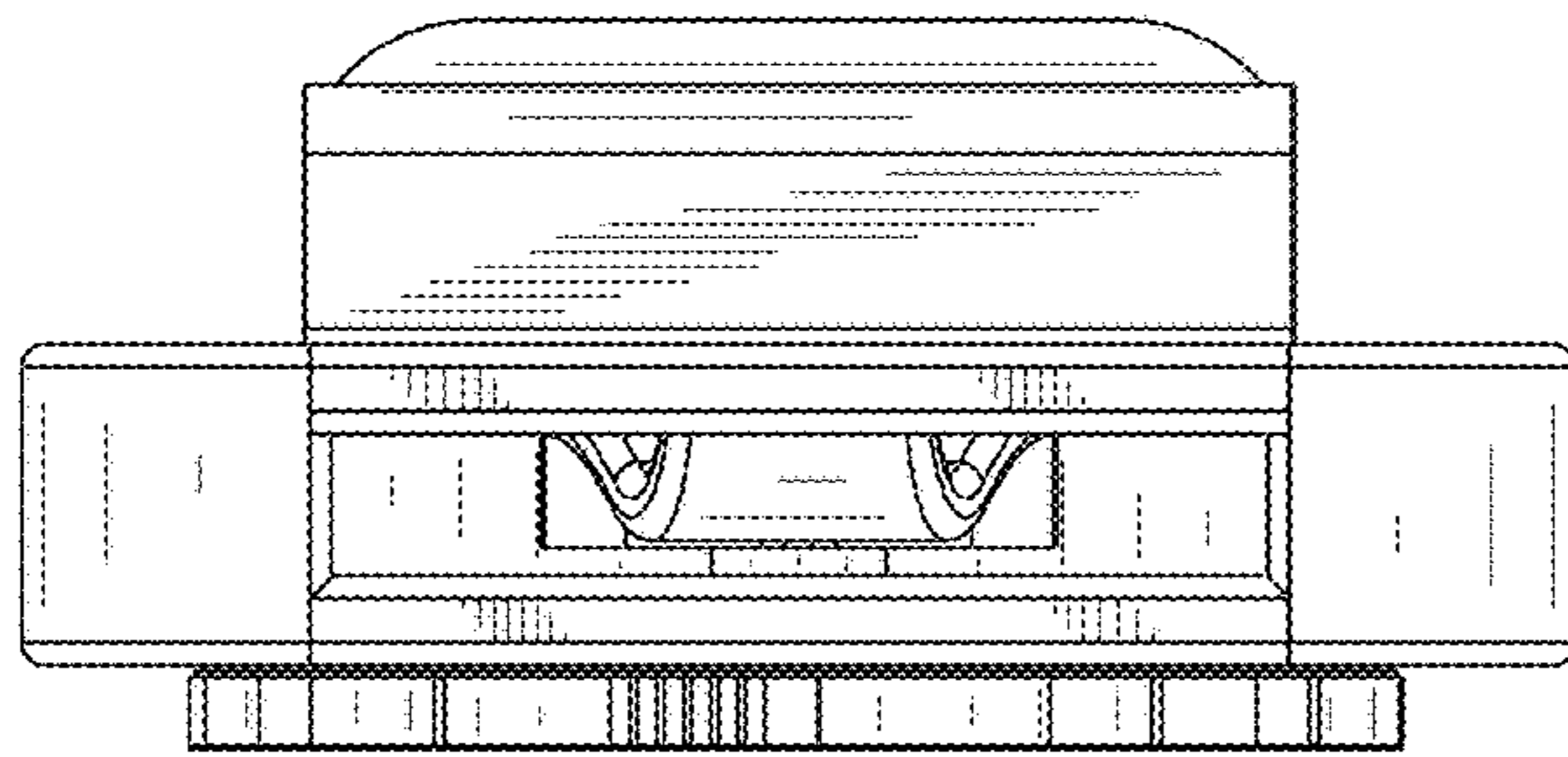

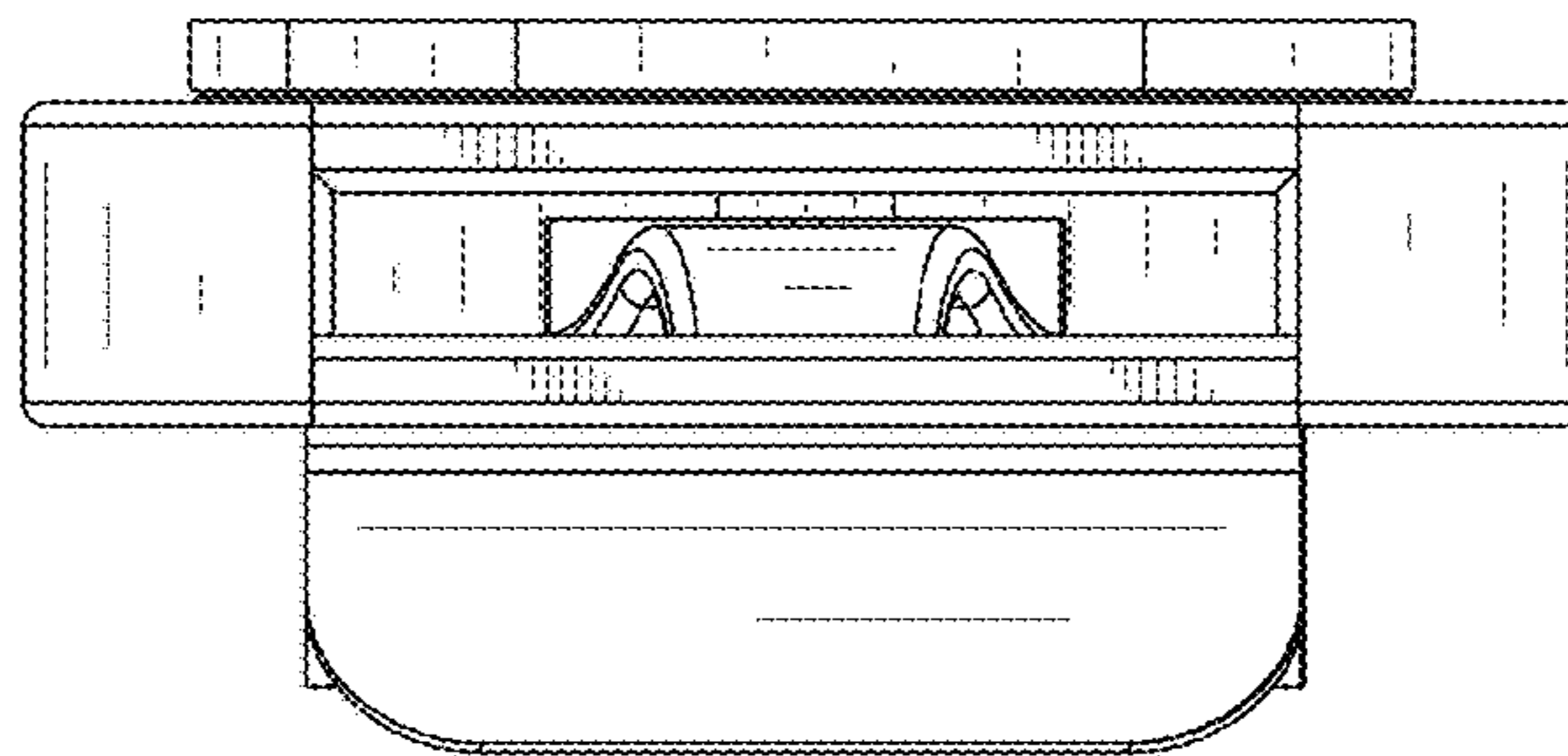

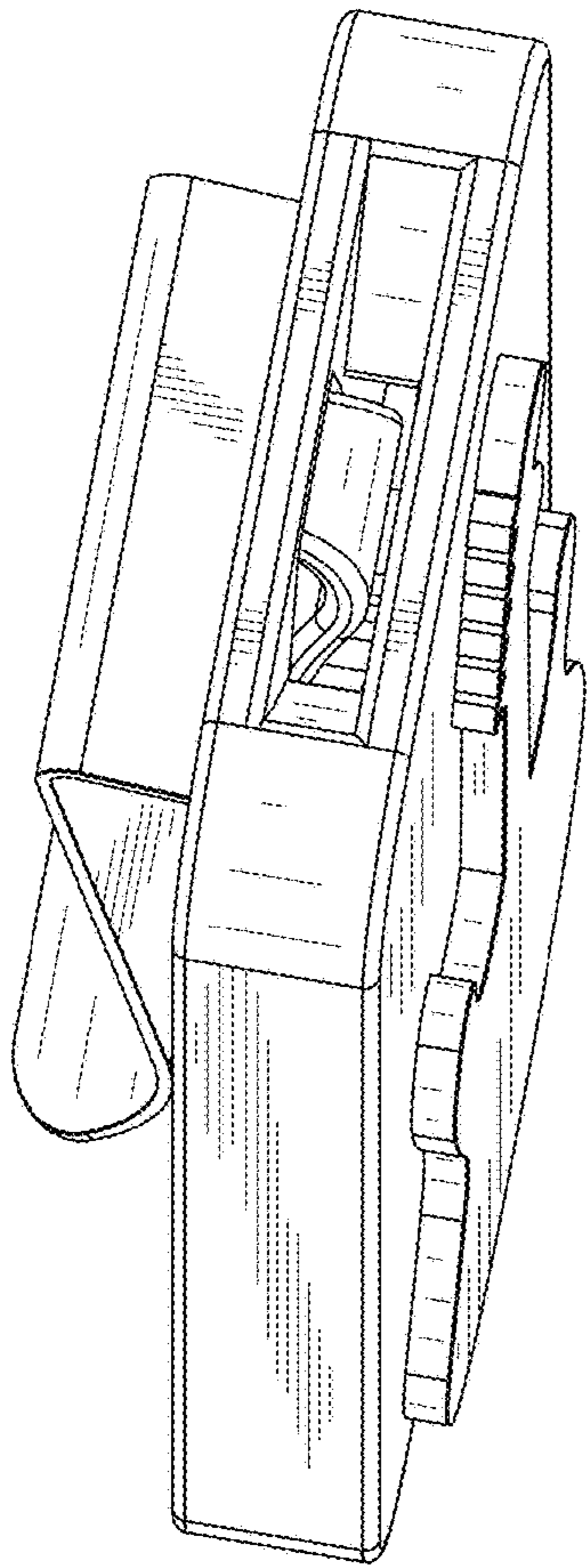

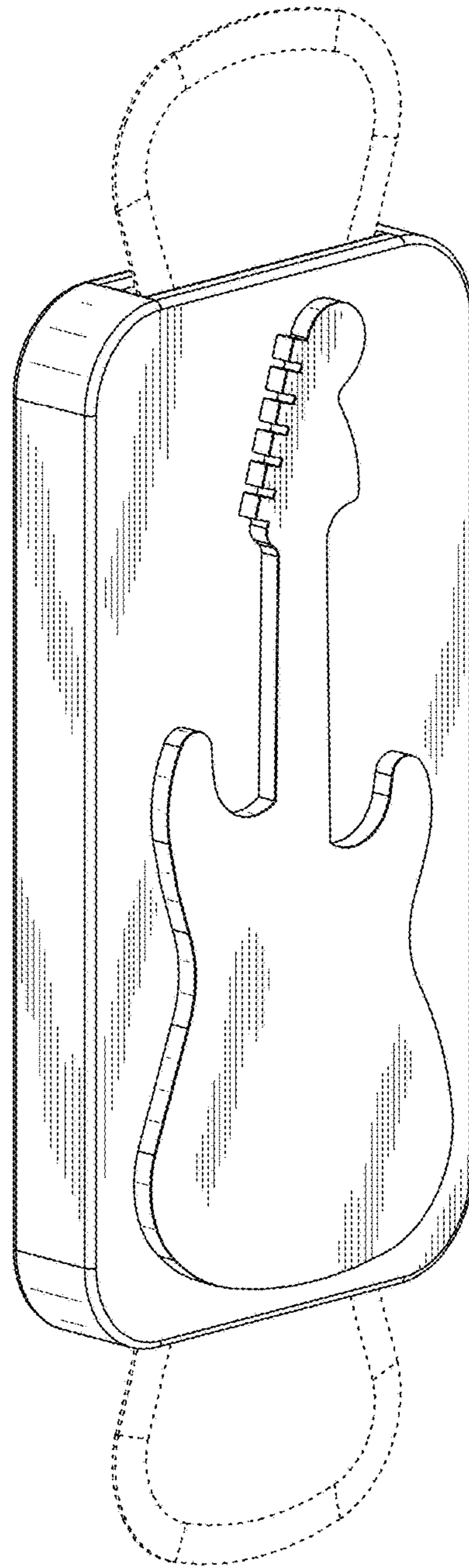
