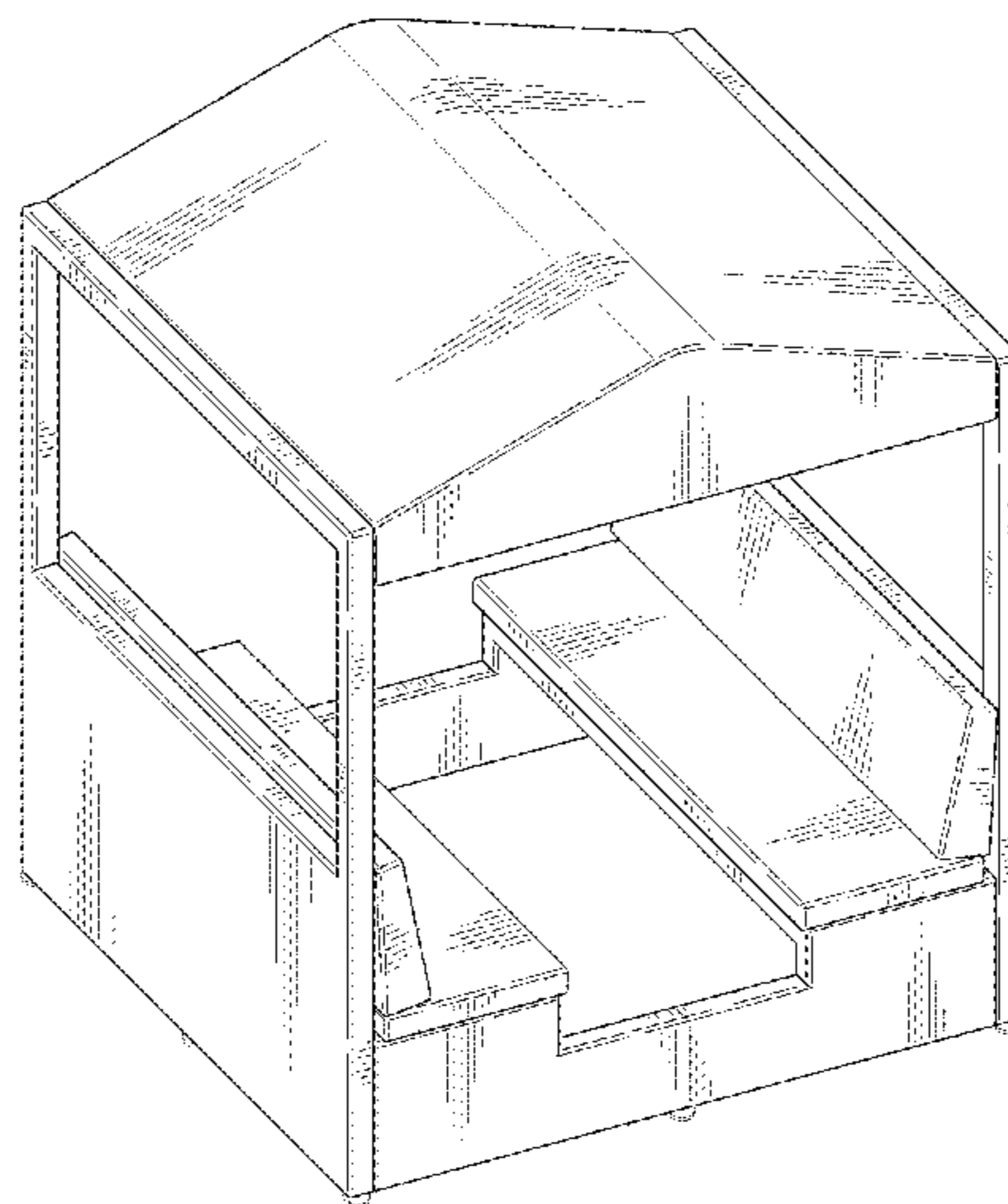
(57) **CLAIM**

The ornamental design for a cabana, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a cabana showing my new design;

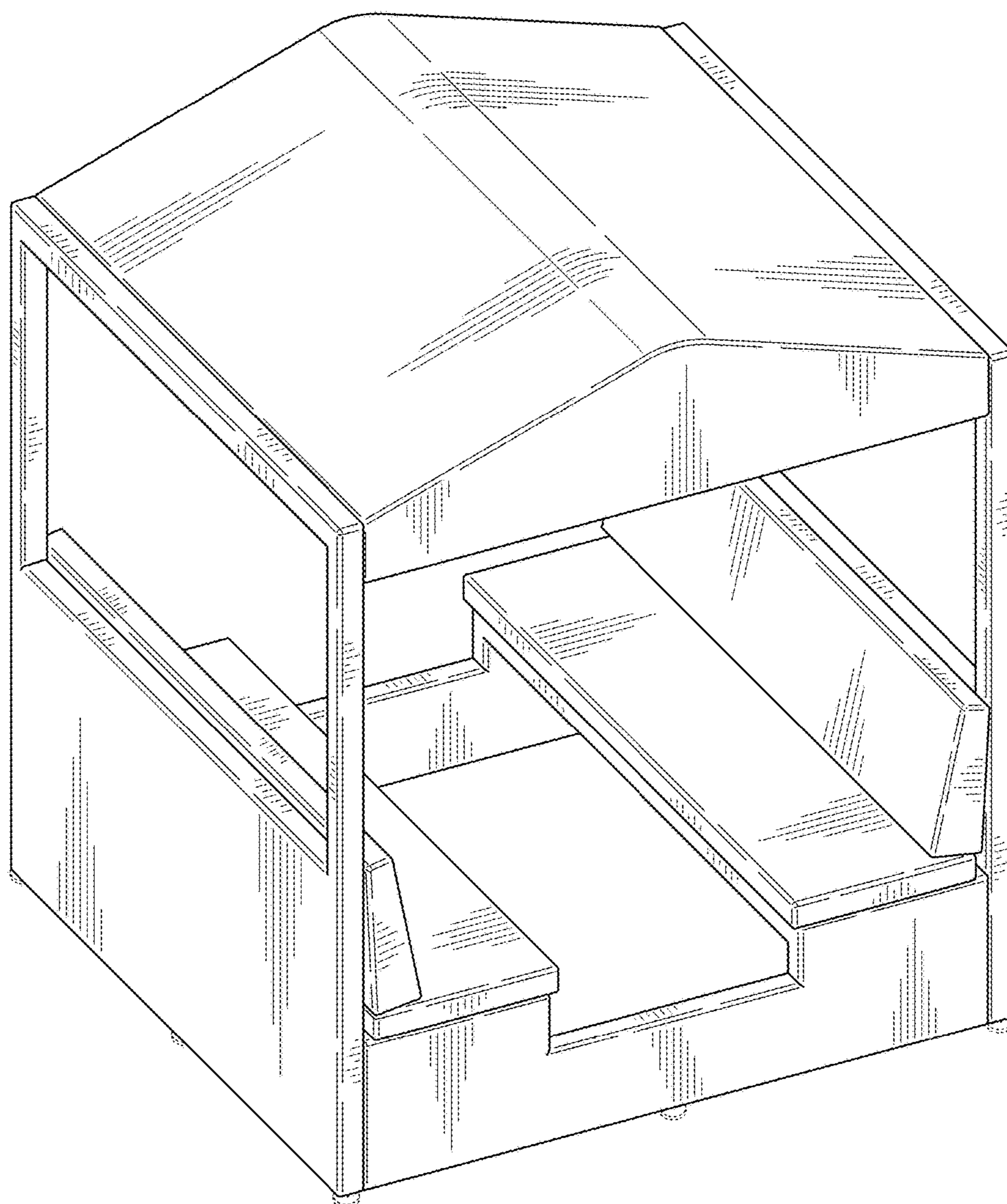

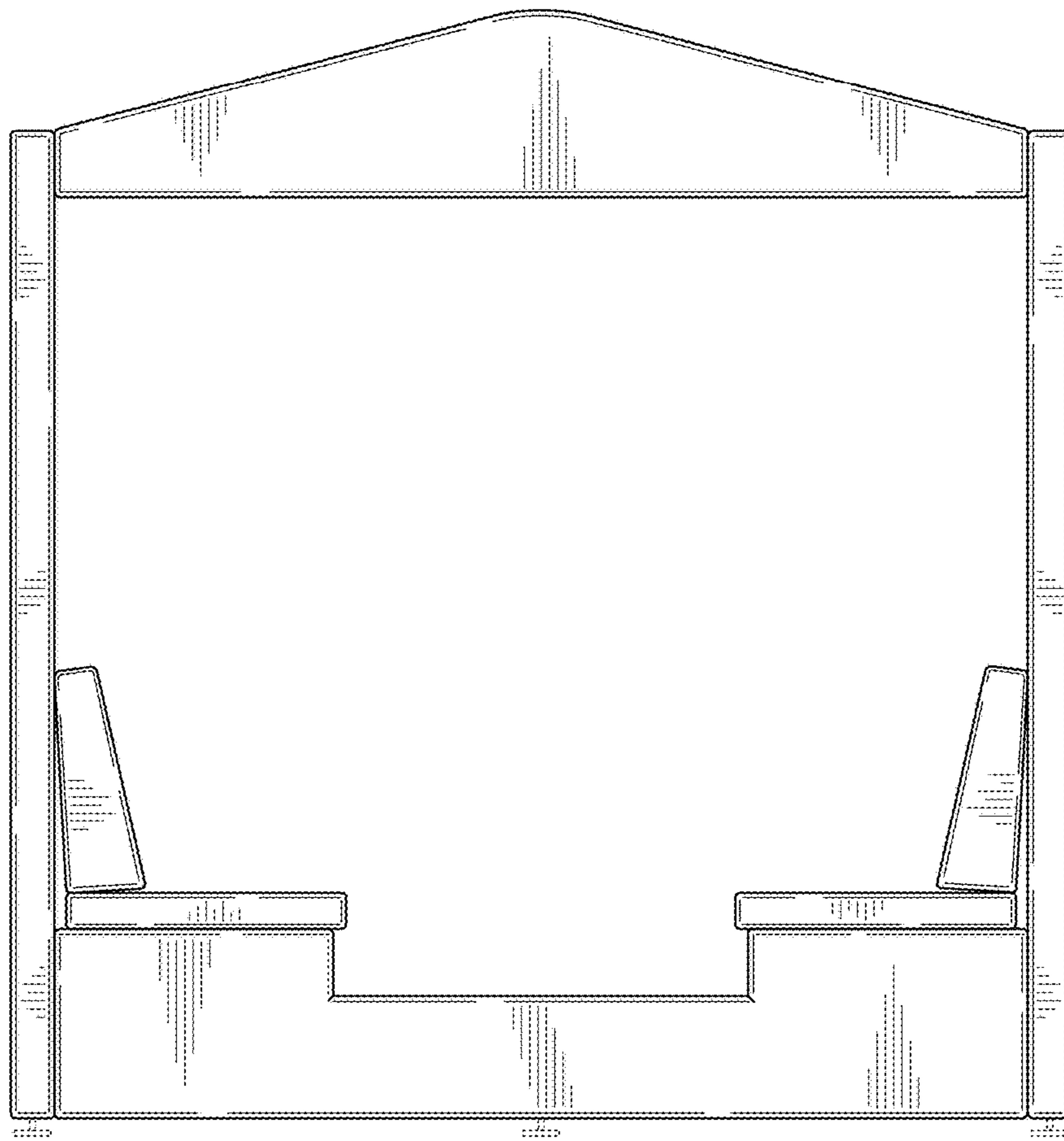

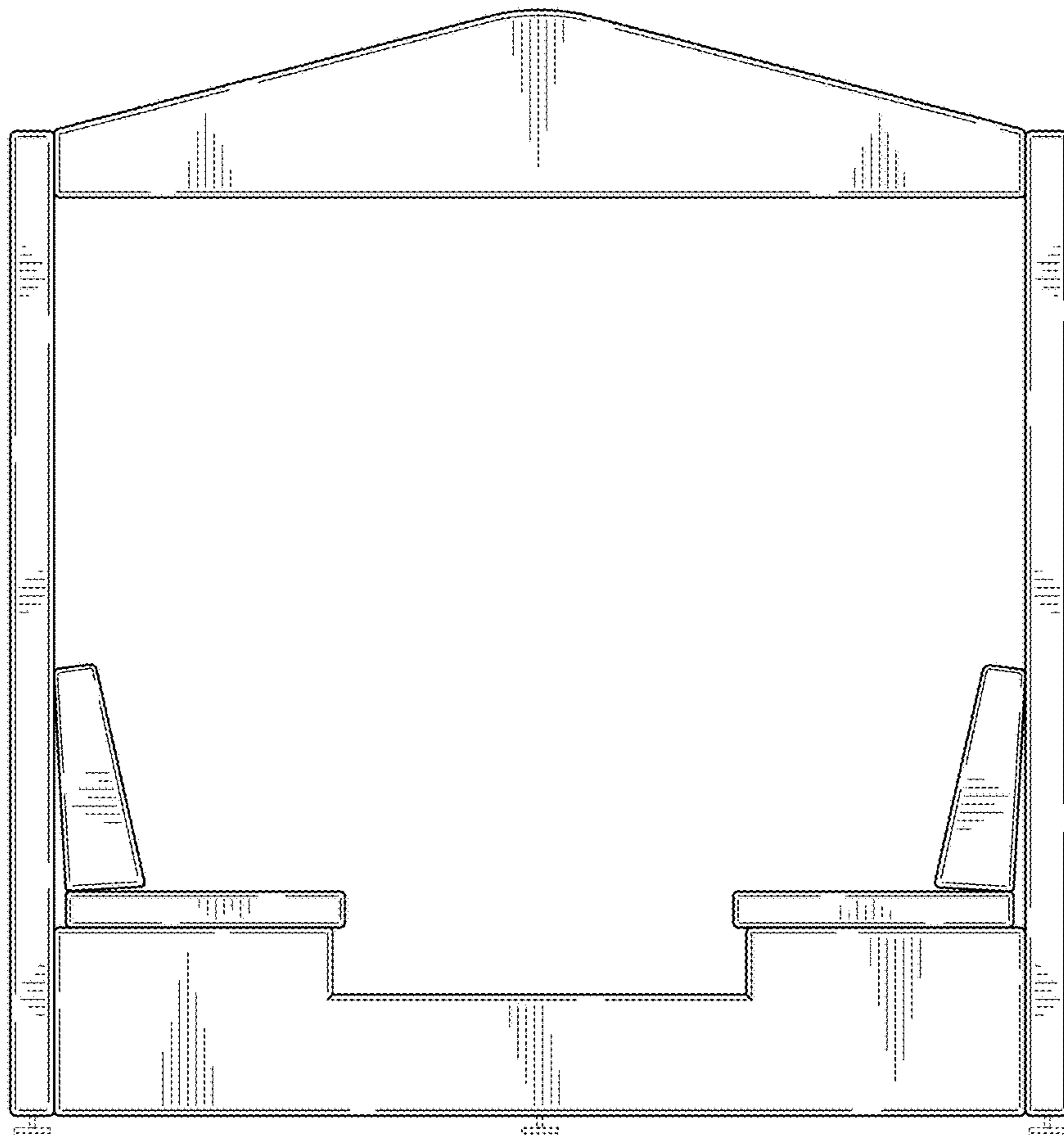

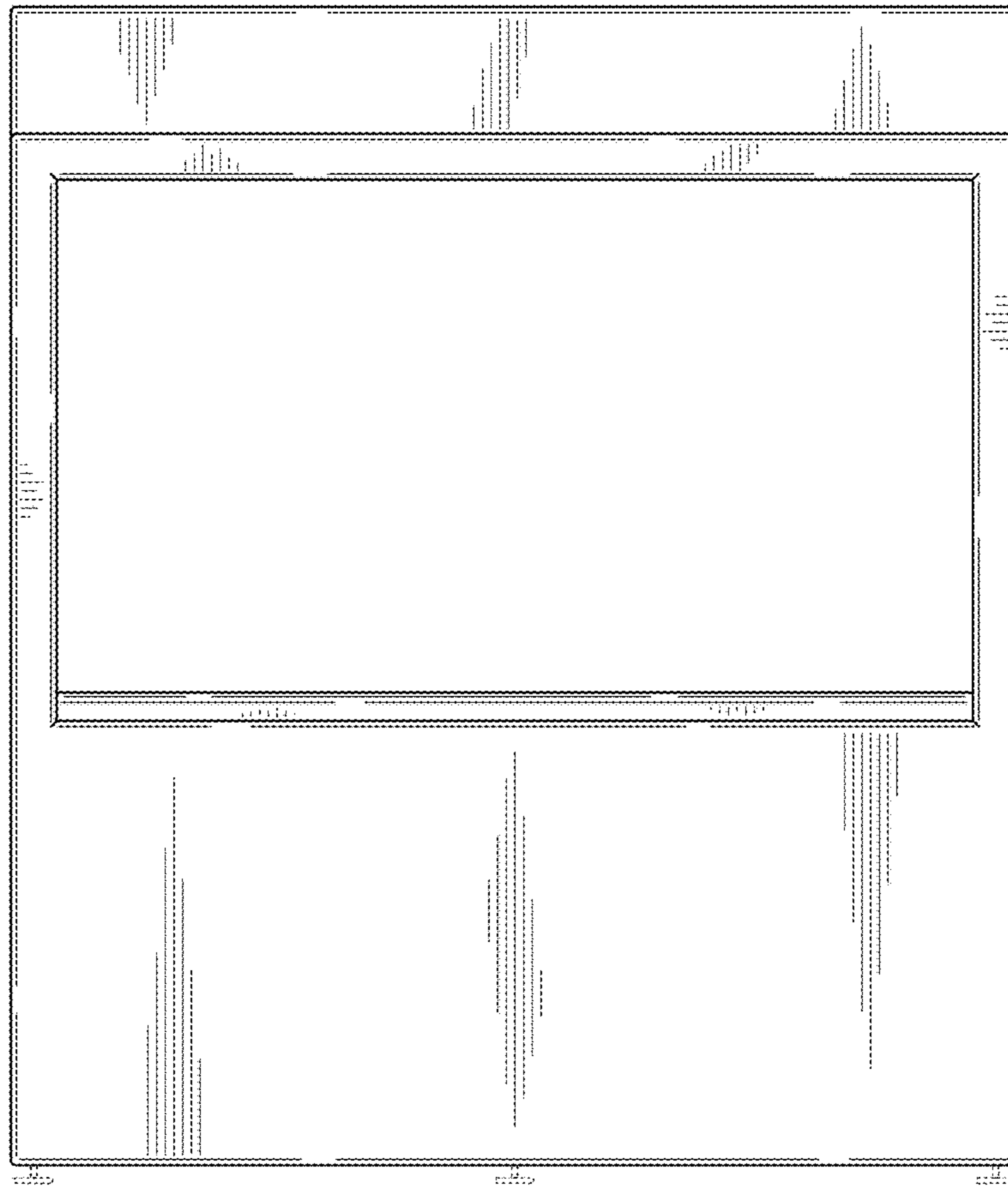

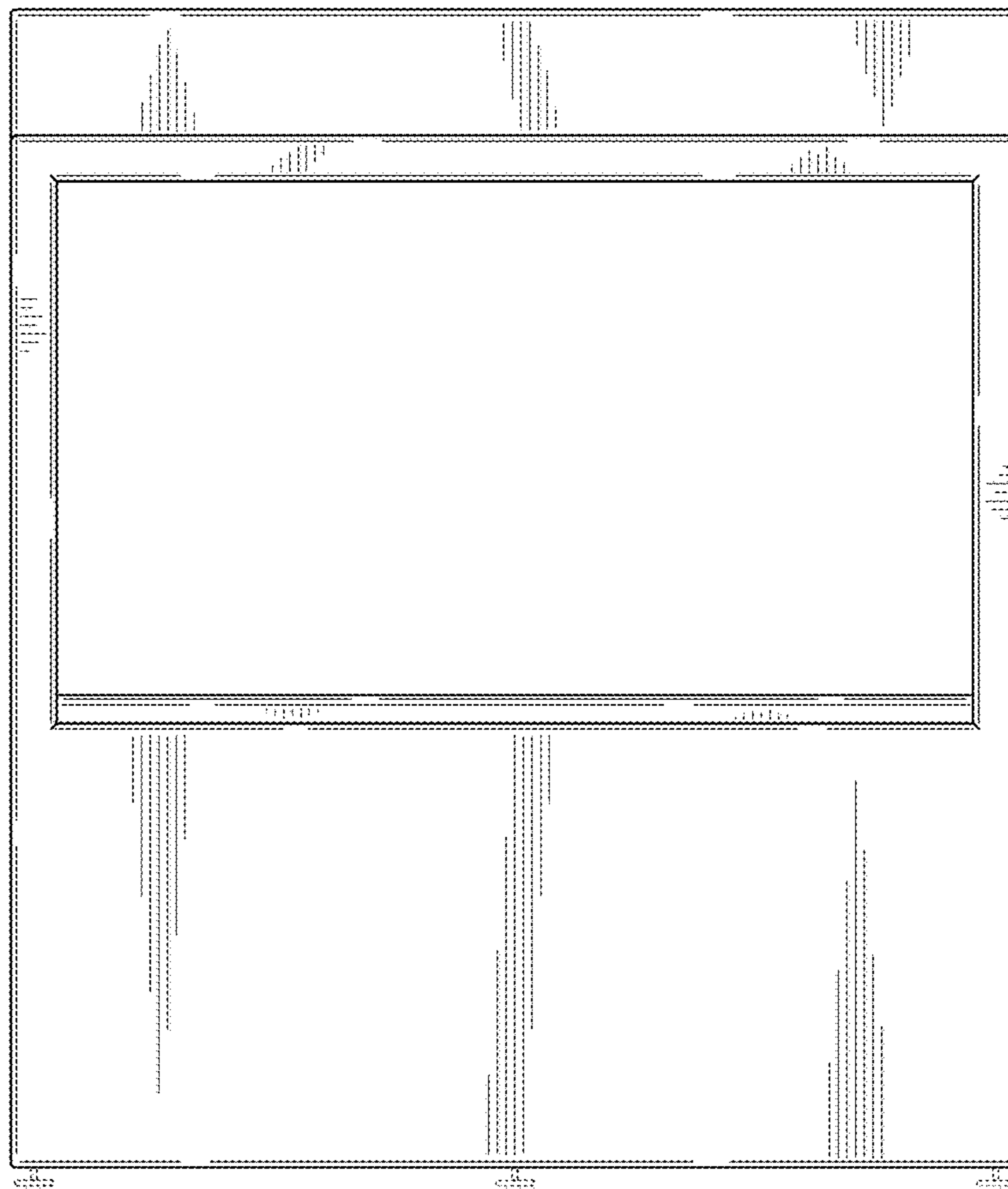

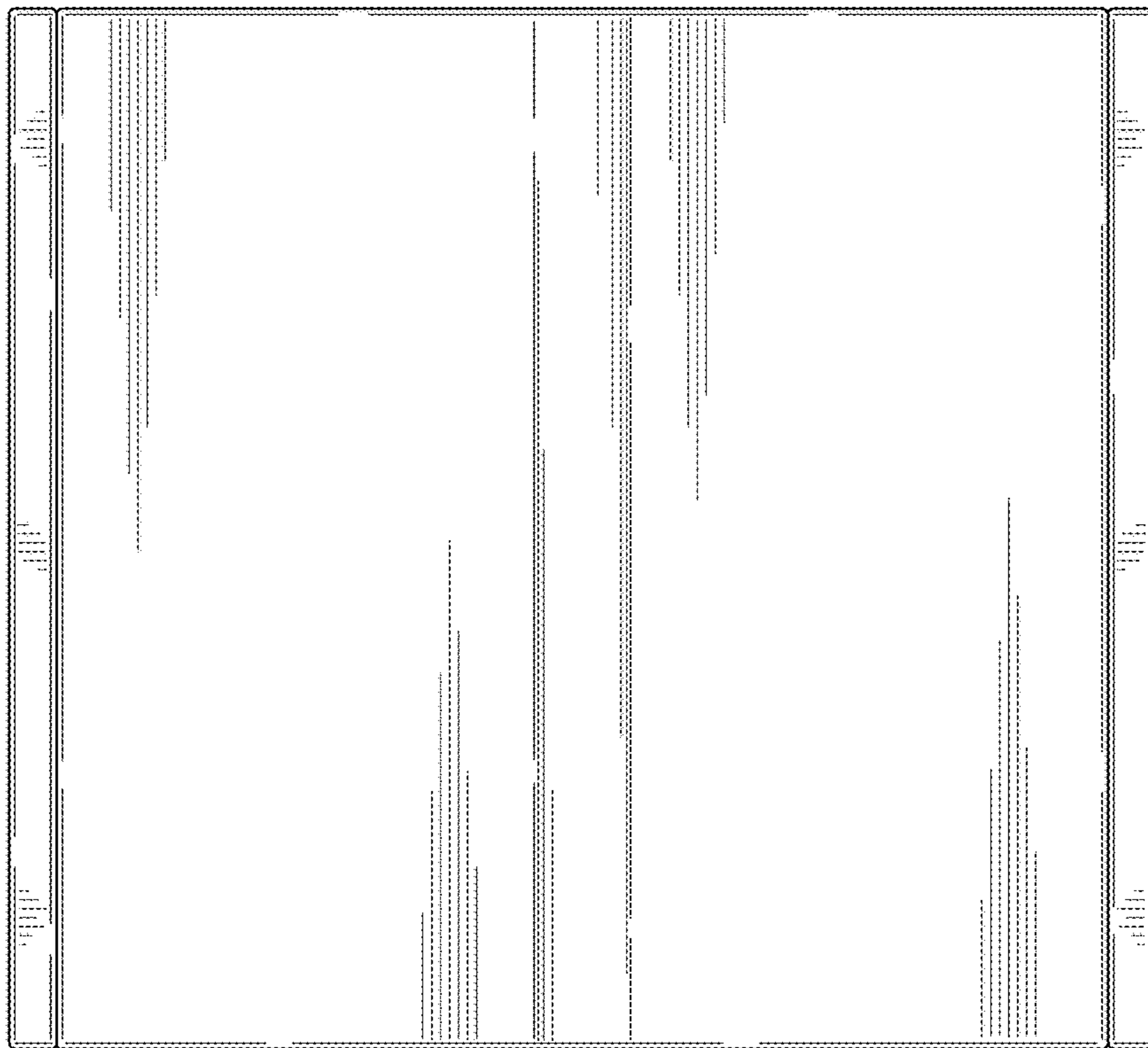
