The ornamental design for a desk, as shown and described.

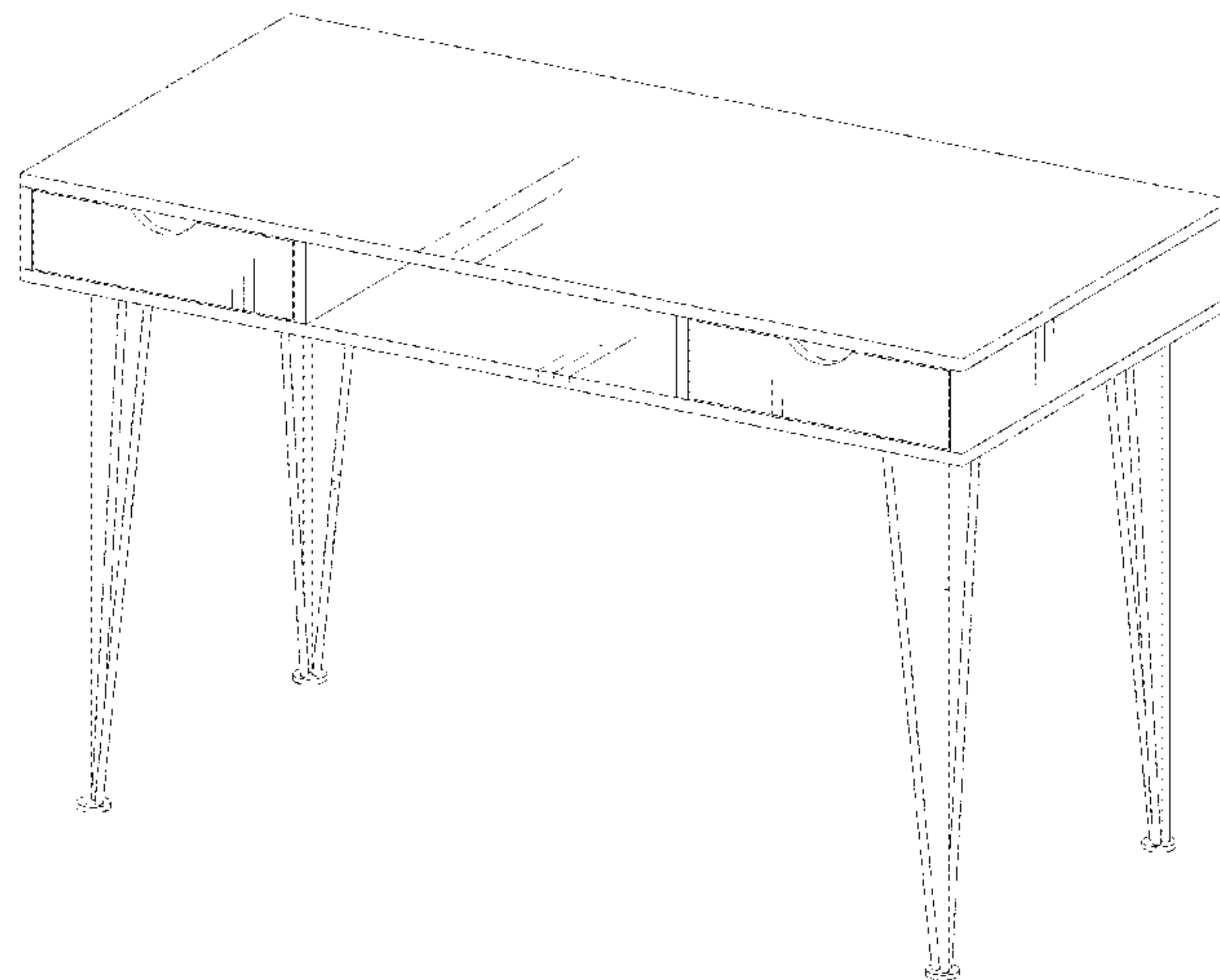
DESCRIPTION

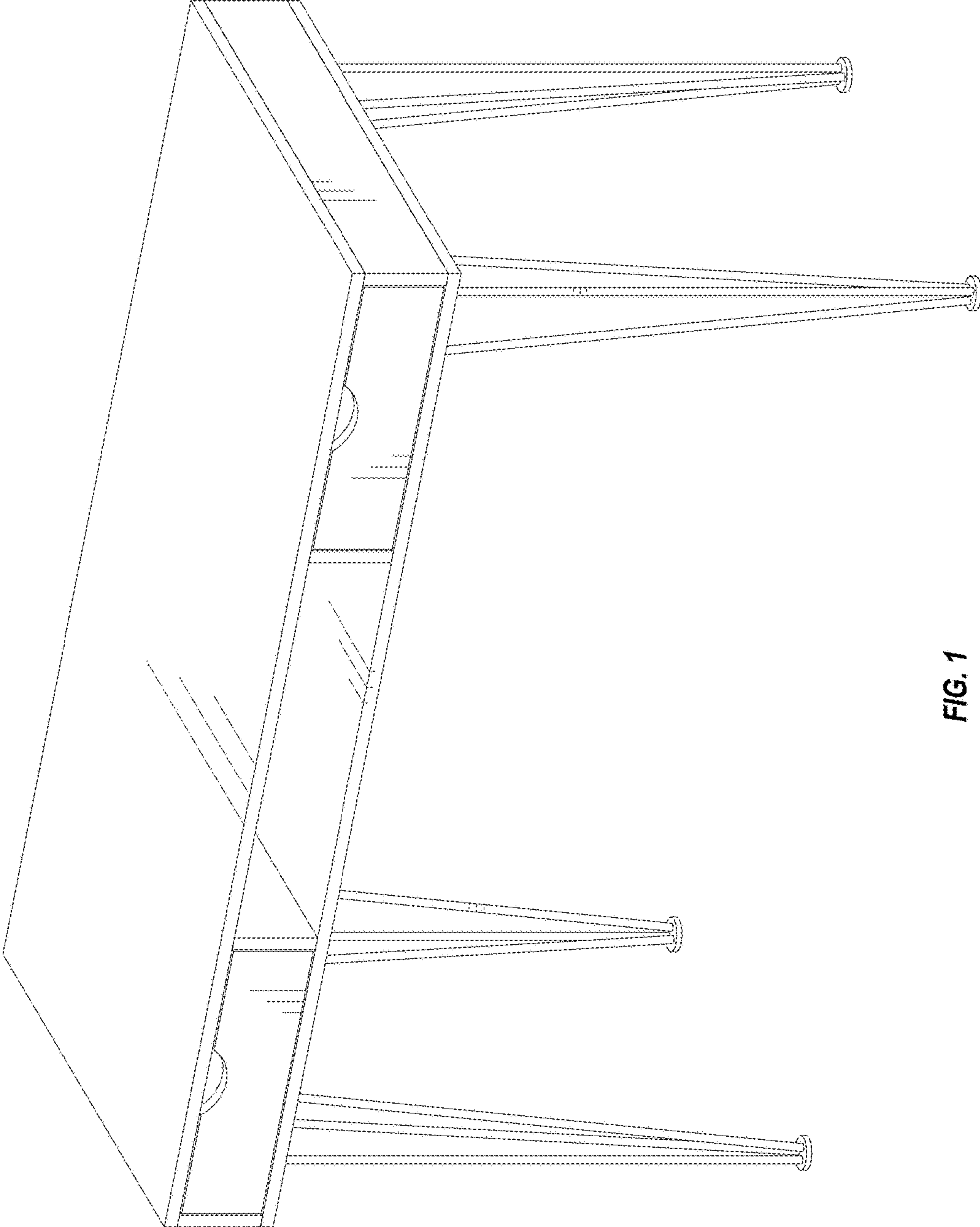

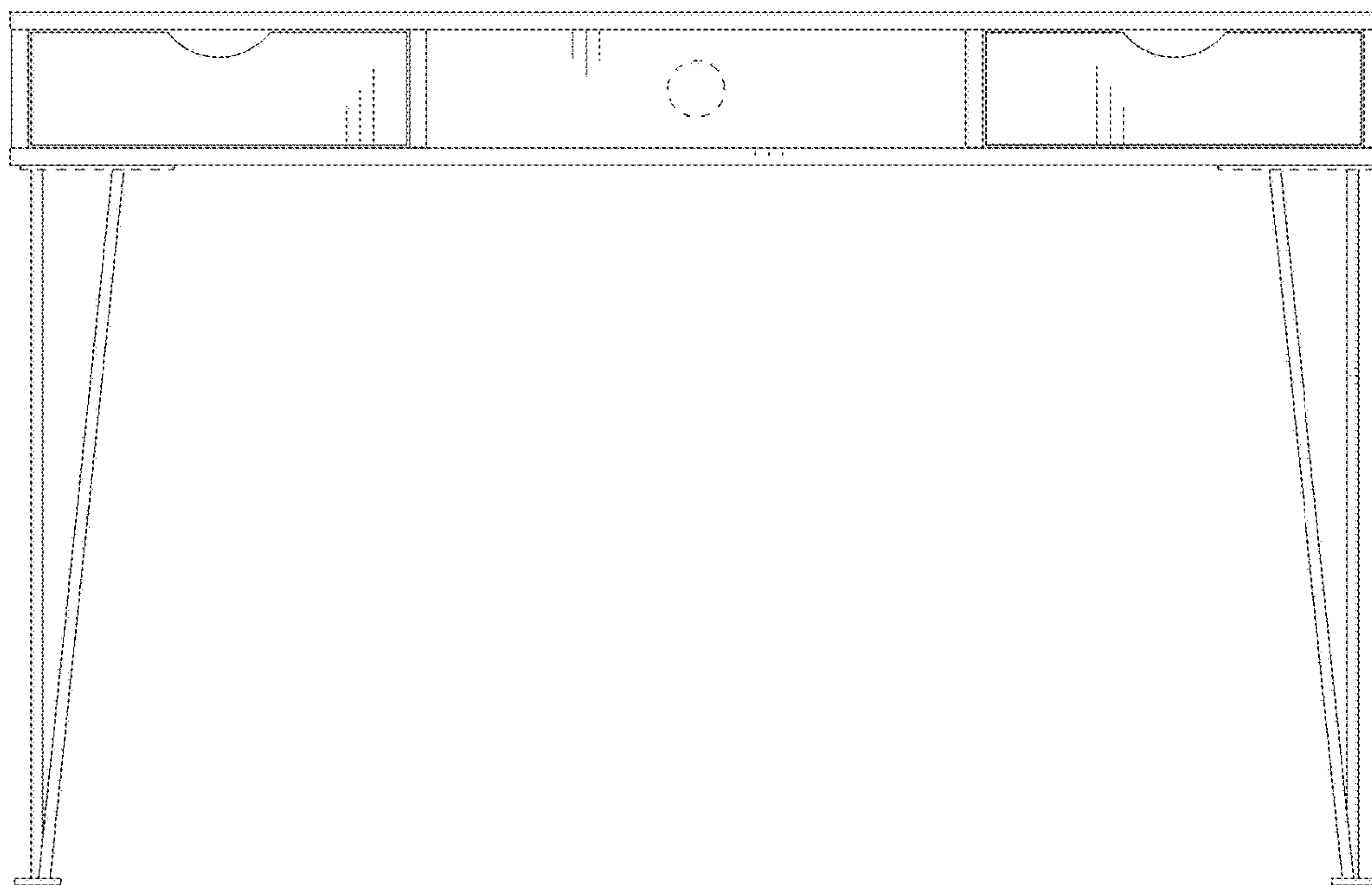

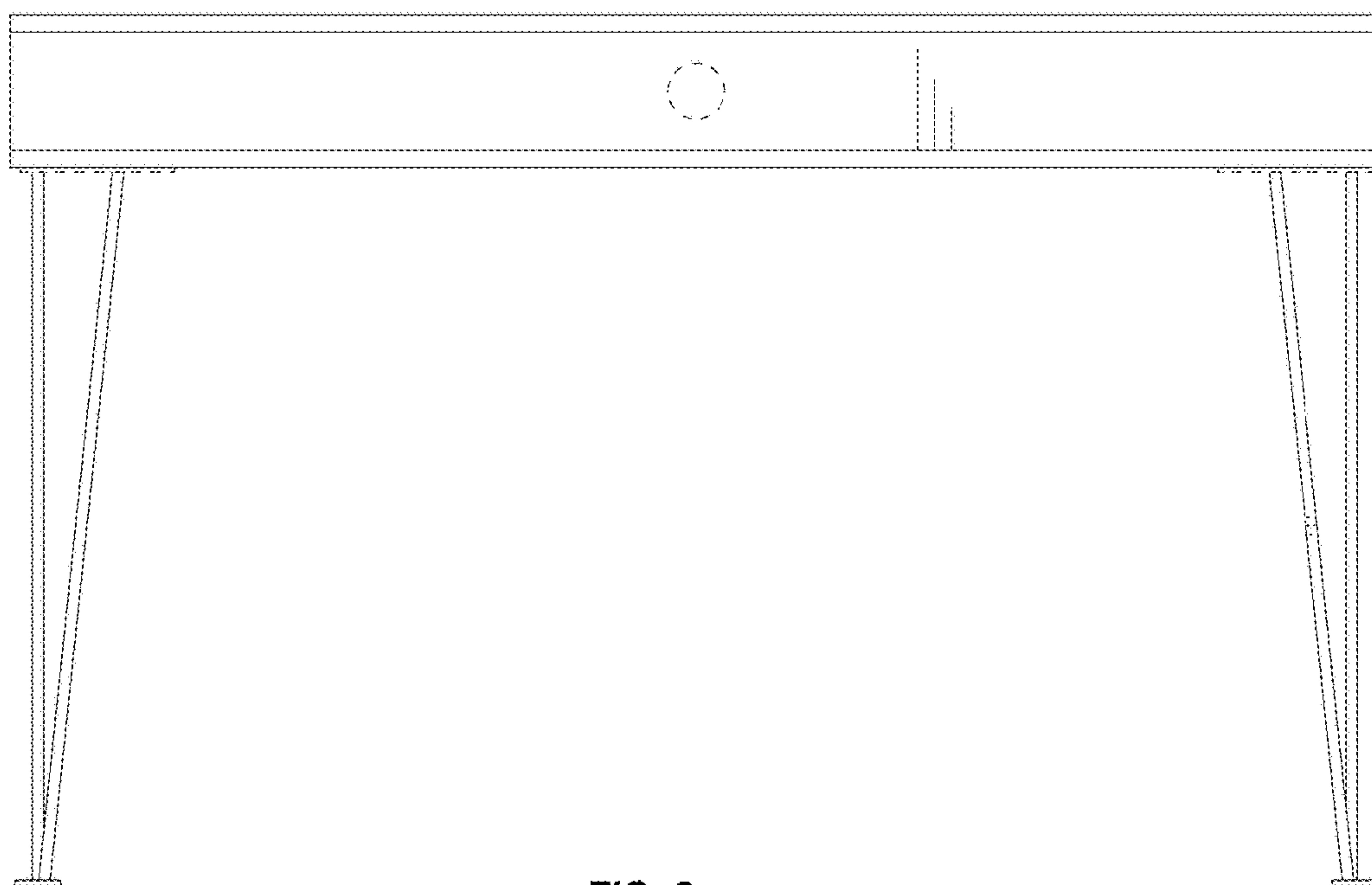

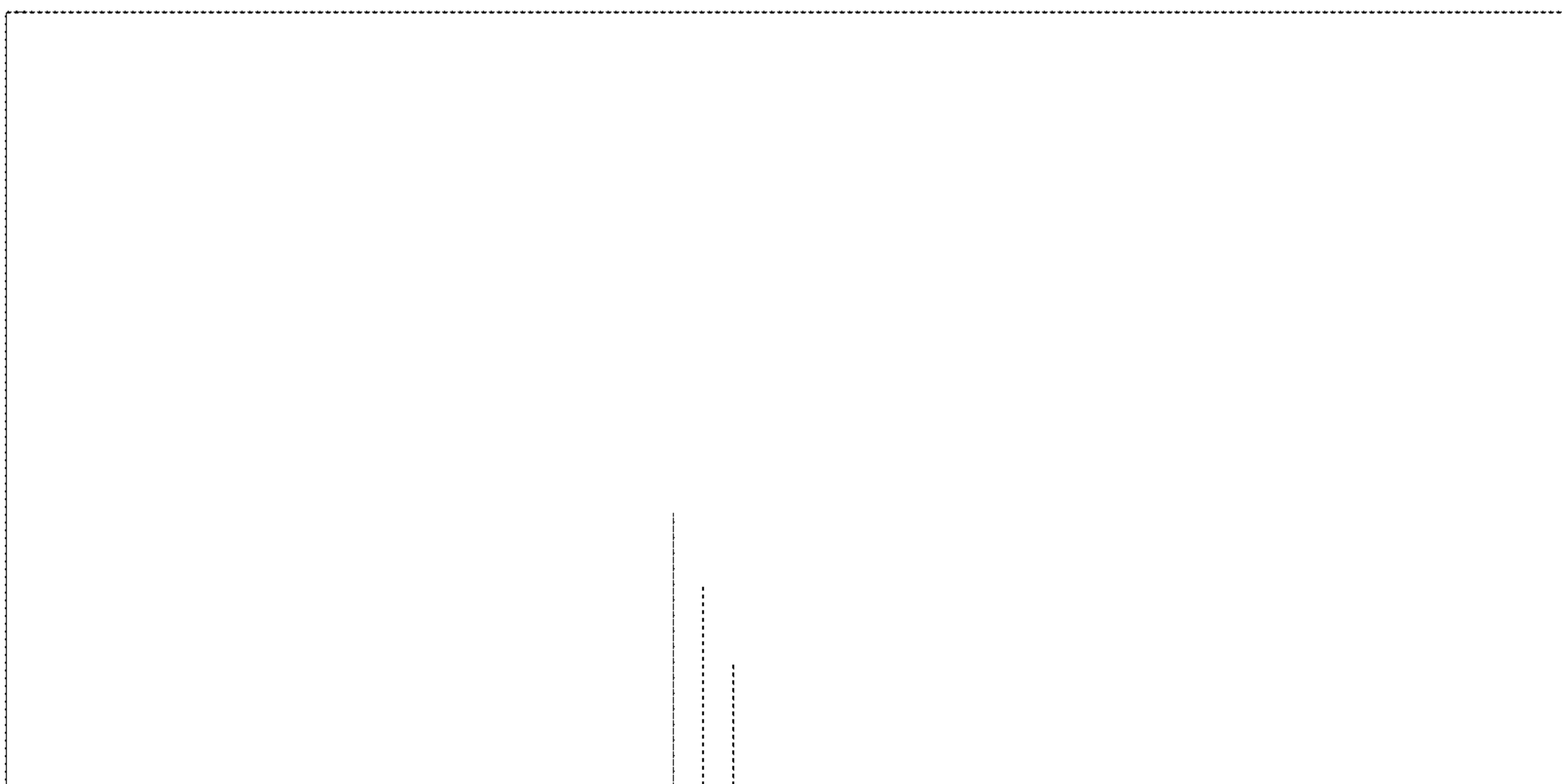

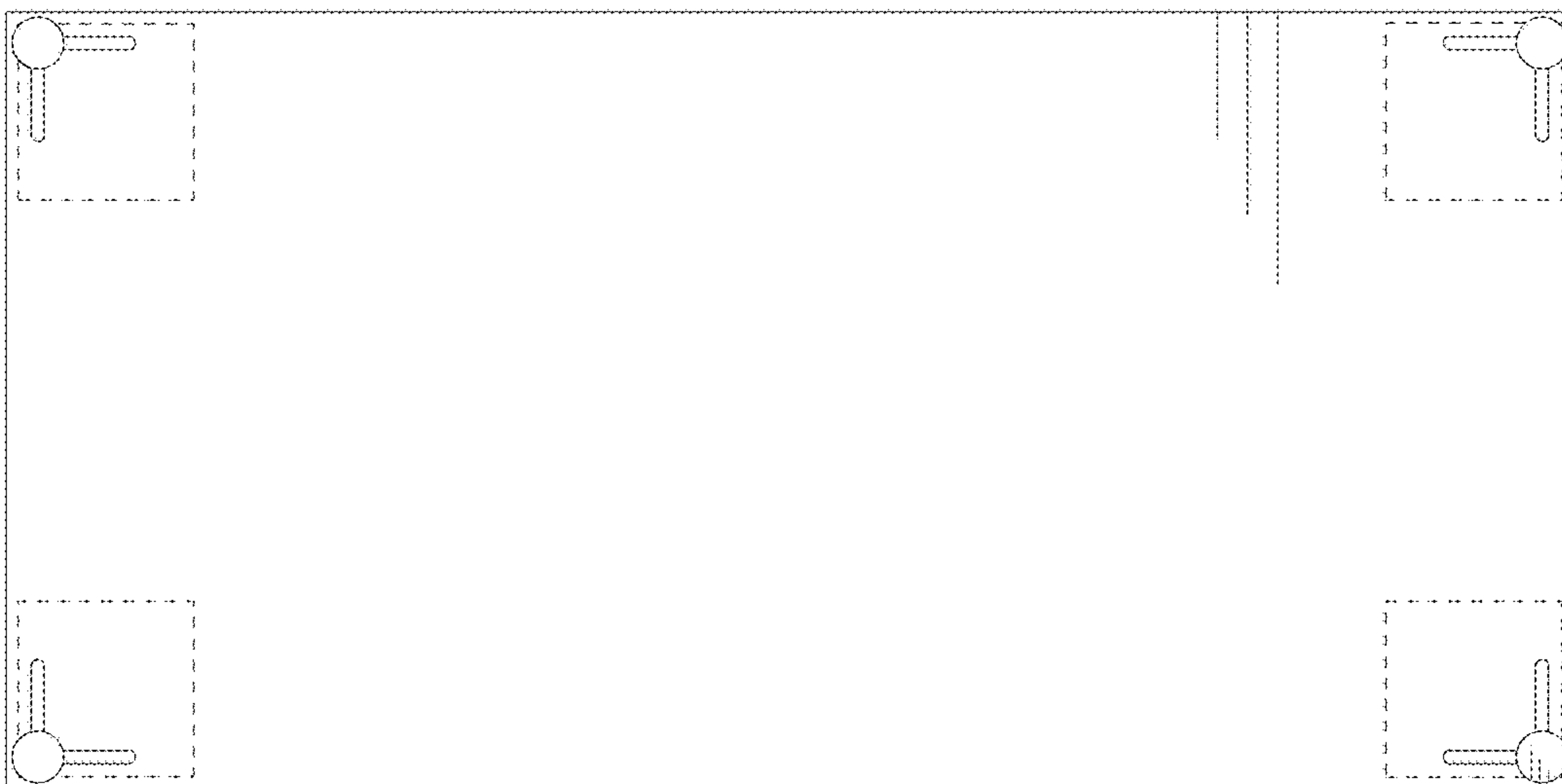

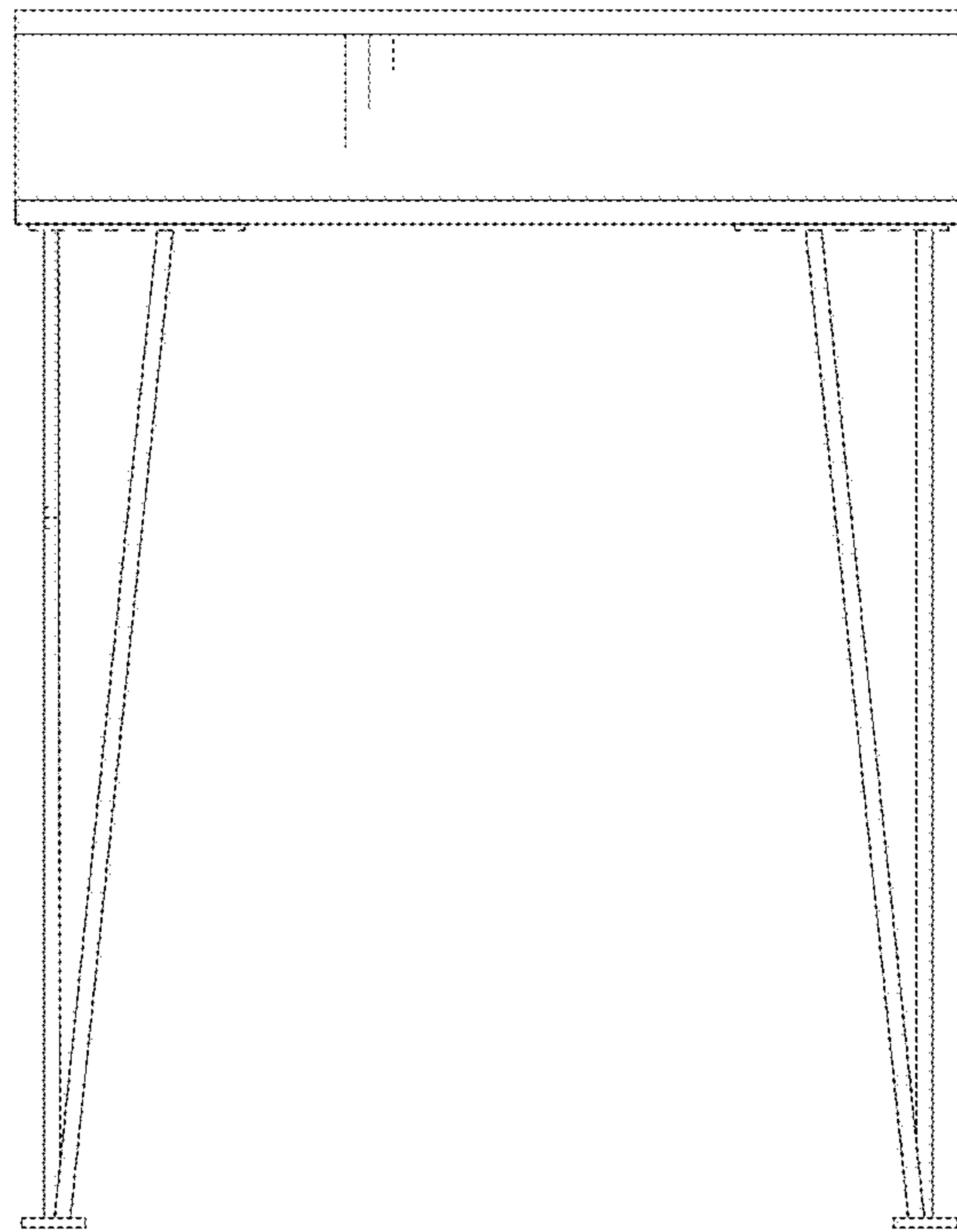

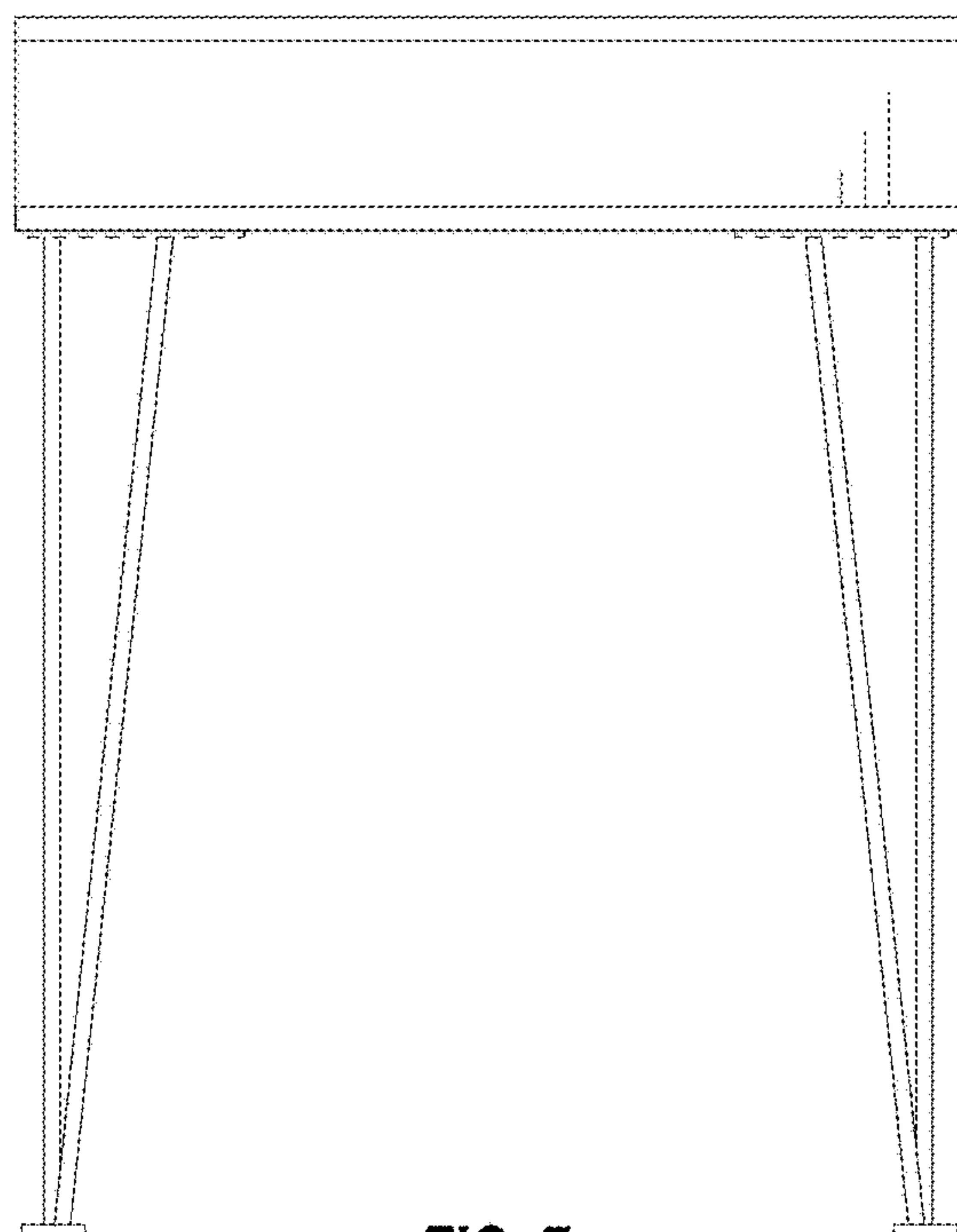
