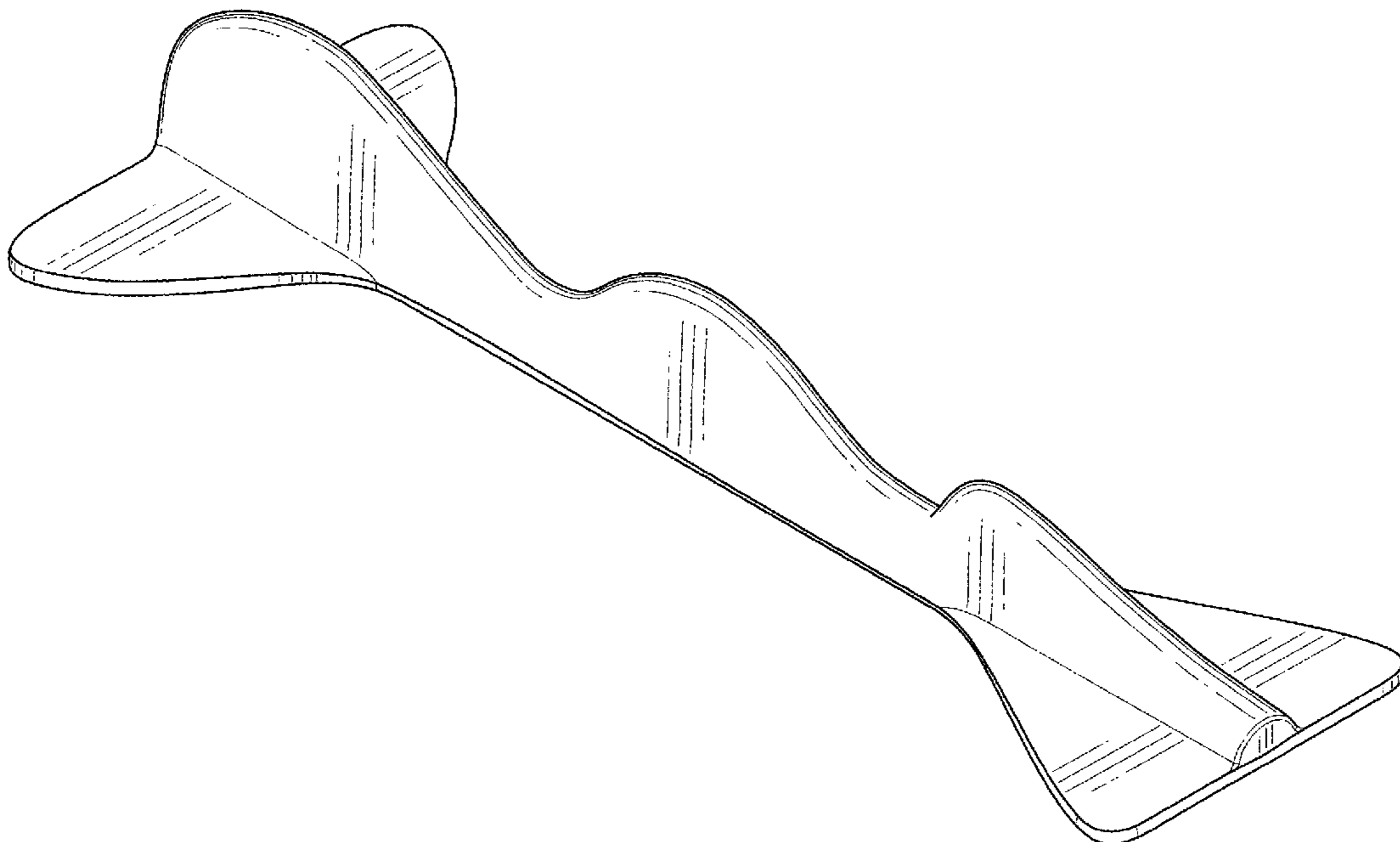
FIG. 1 is a top perspective view thereof;

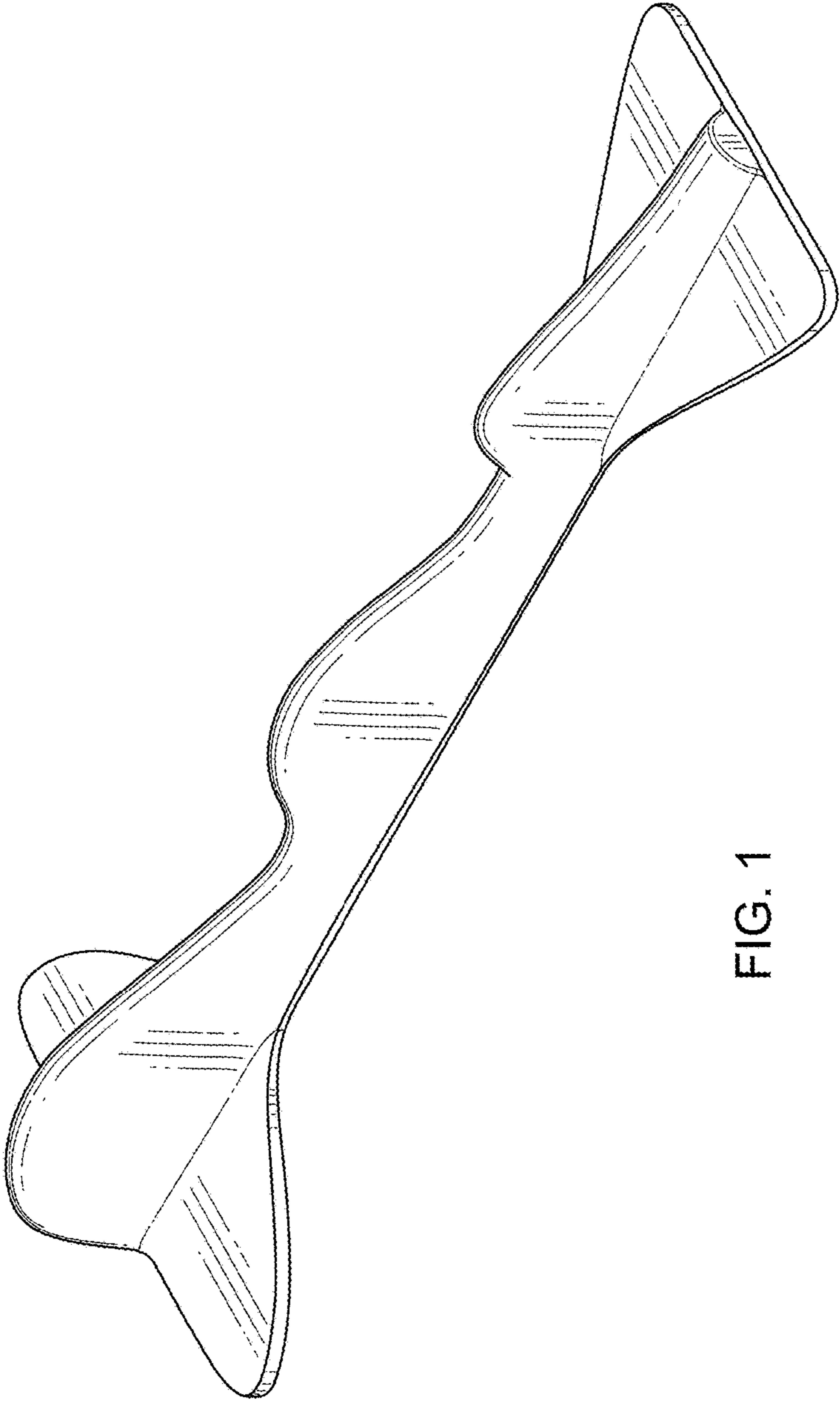

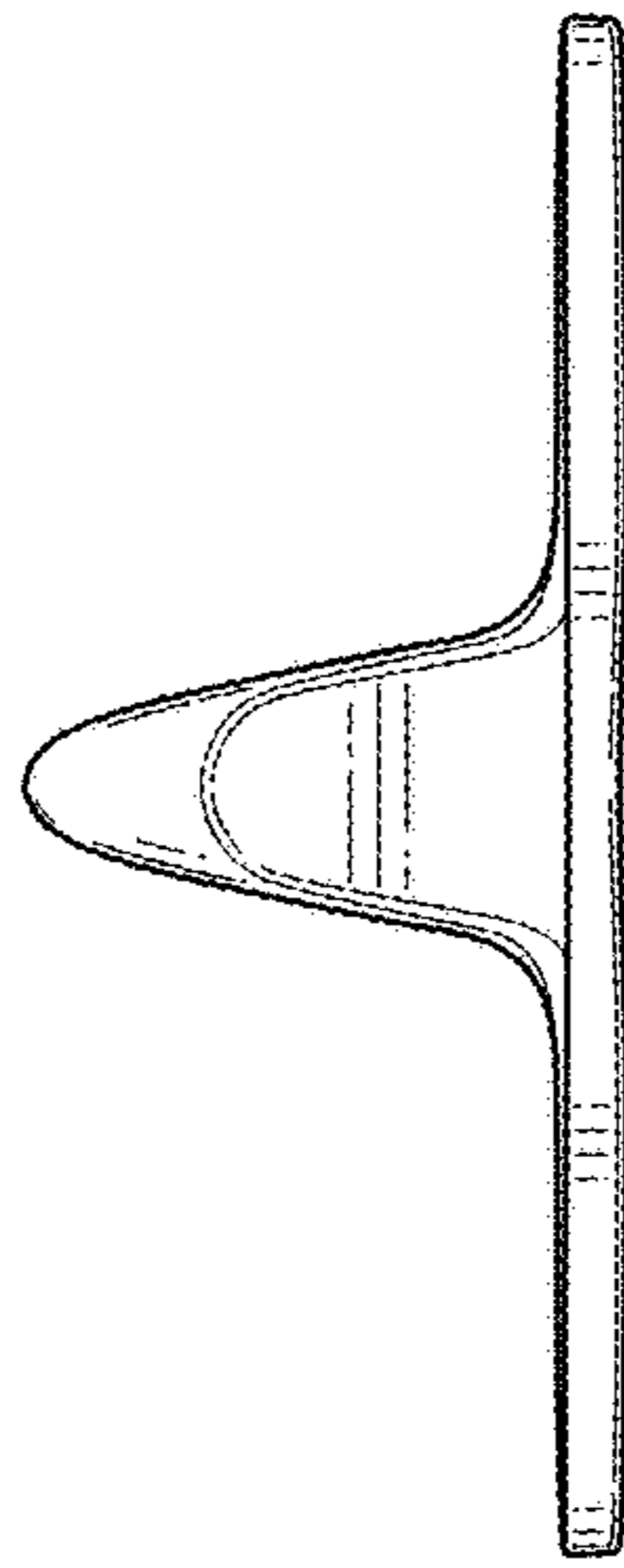

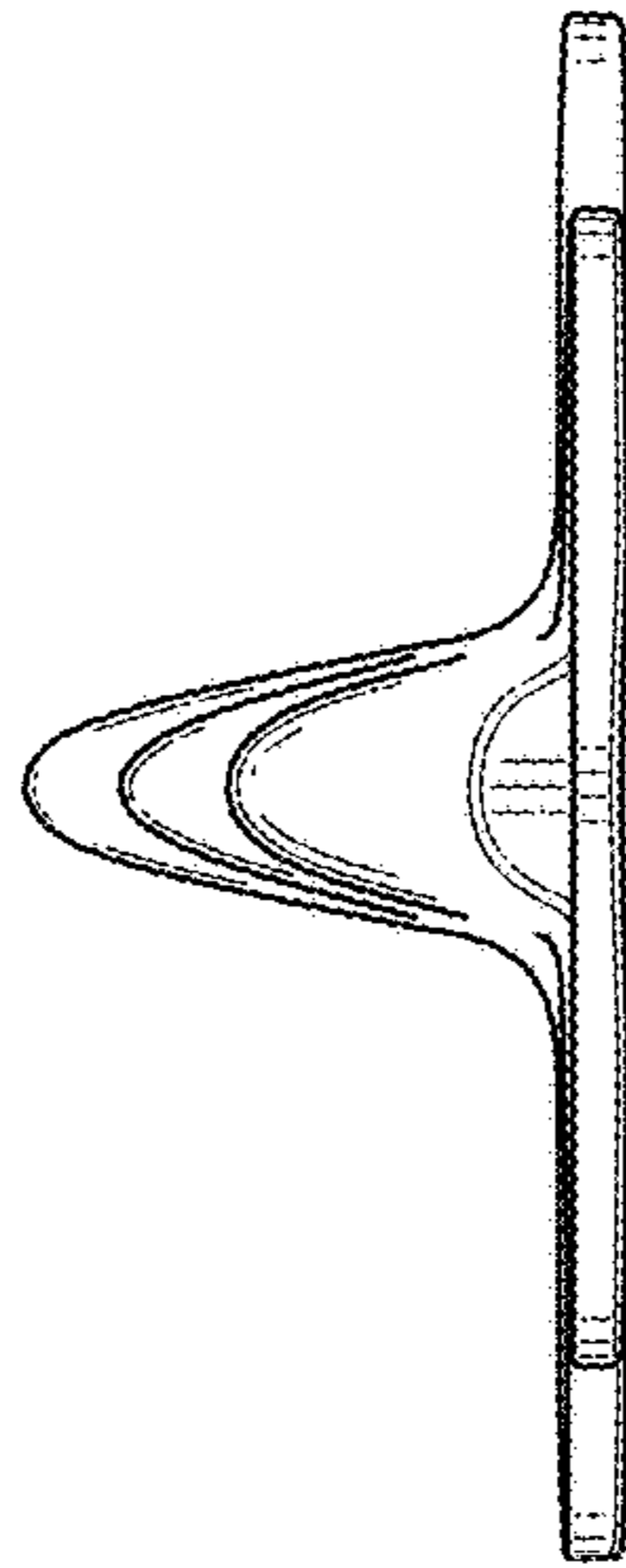

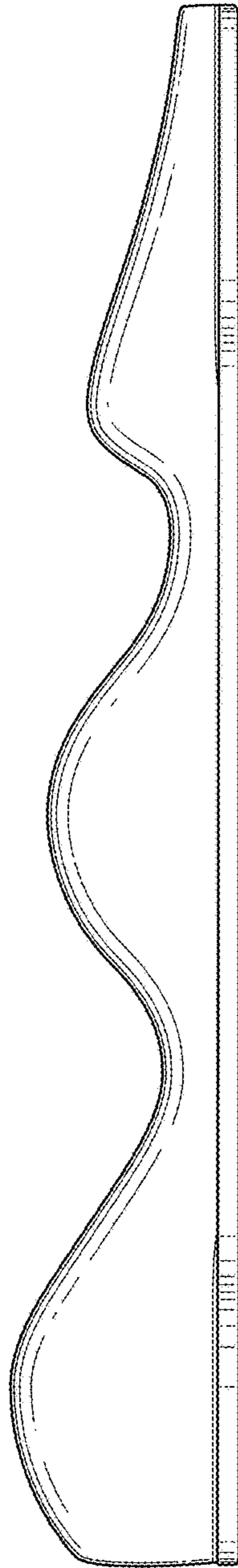

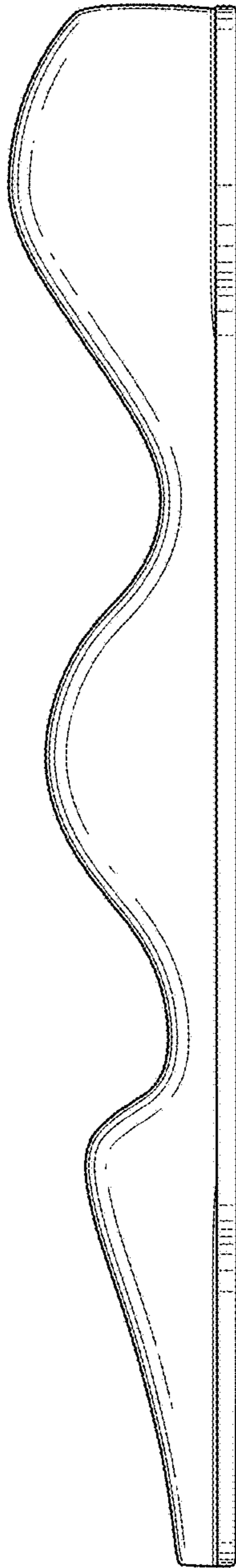

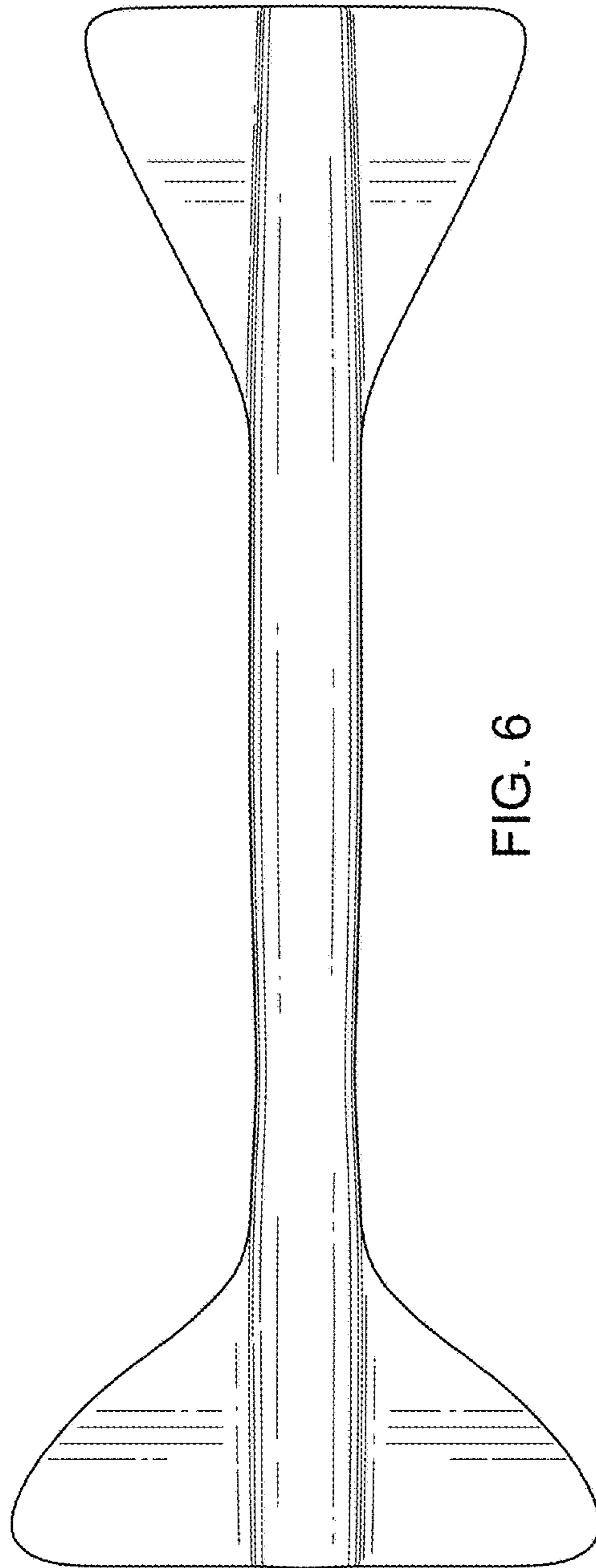

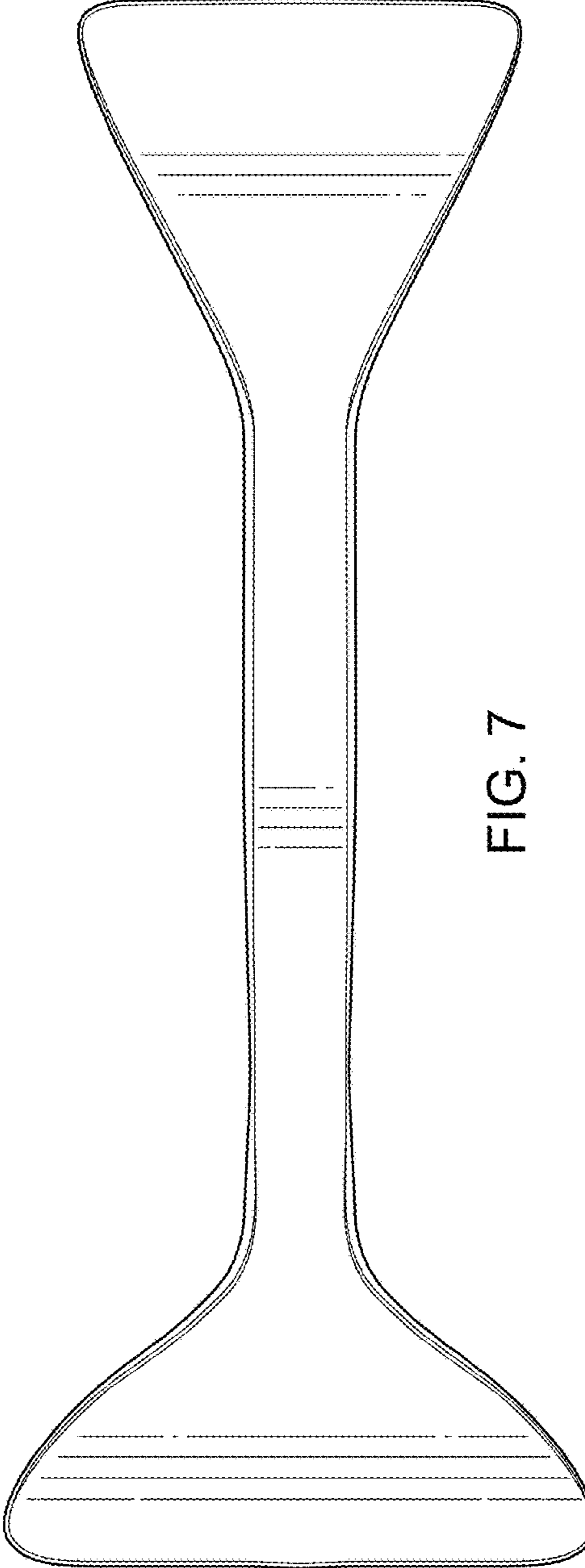
