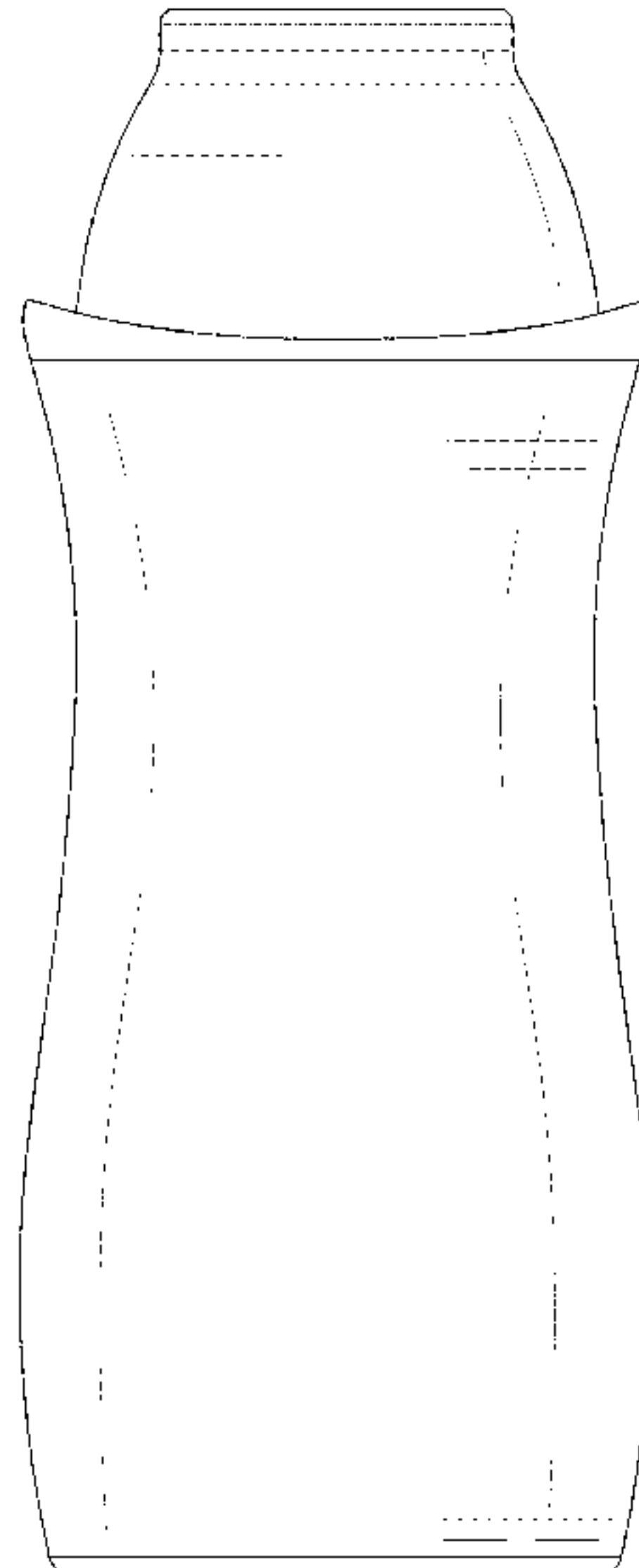
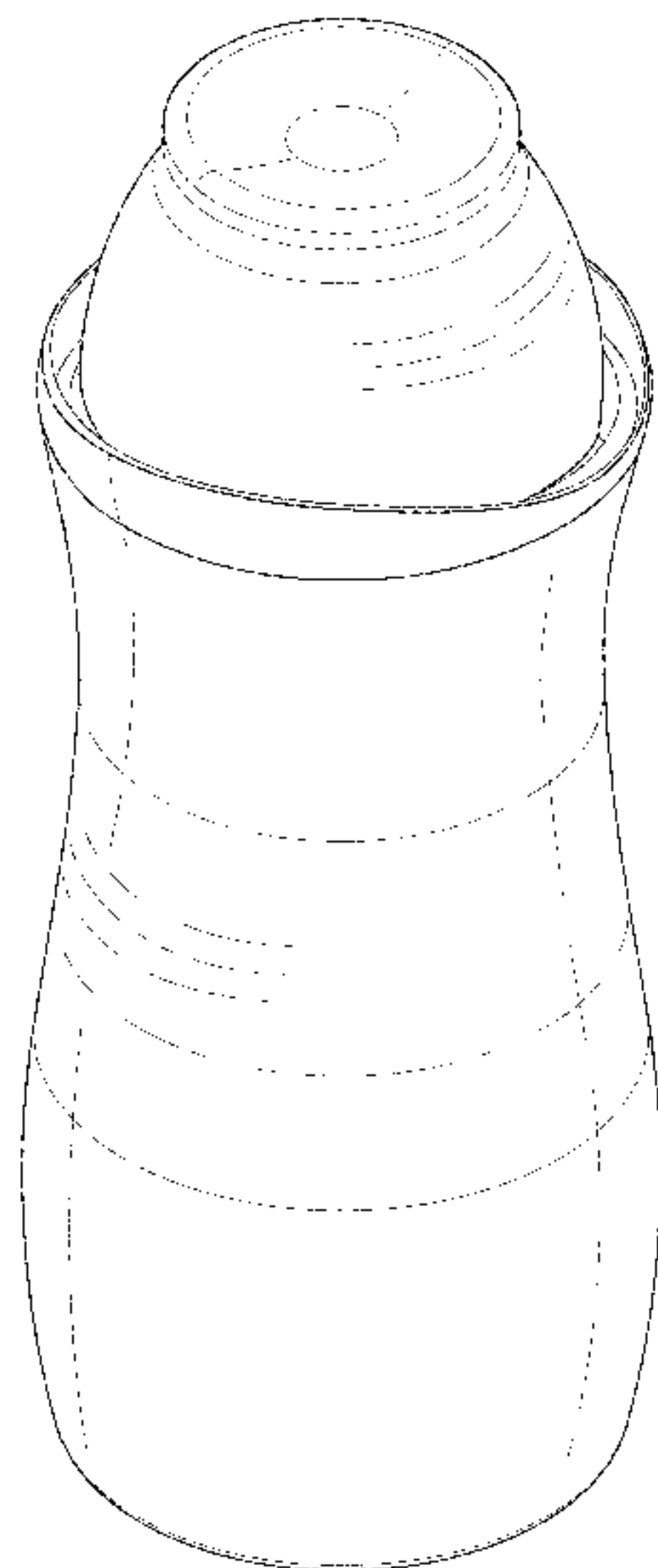
(57) **CLAIM**

The ornamental design for a cocktail shaker with reamer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cocktail shaker with reamer;
FIG. 2 is a top view of a cocktail shaker with reamer;
FIG. 3 is a front-side view of a cocktail shaker with reamer;
FIG. 4 is a bottom view of a cocktail shaker with reamer;
FIG. 5 is a back view of a cocktail shaker with reamer; and,
FIG. 6 is an exploded view of a cocktail shaker with reamer.

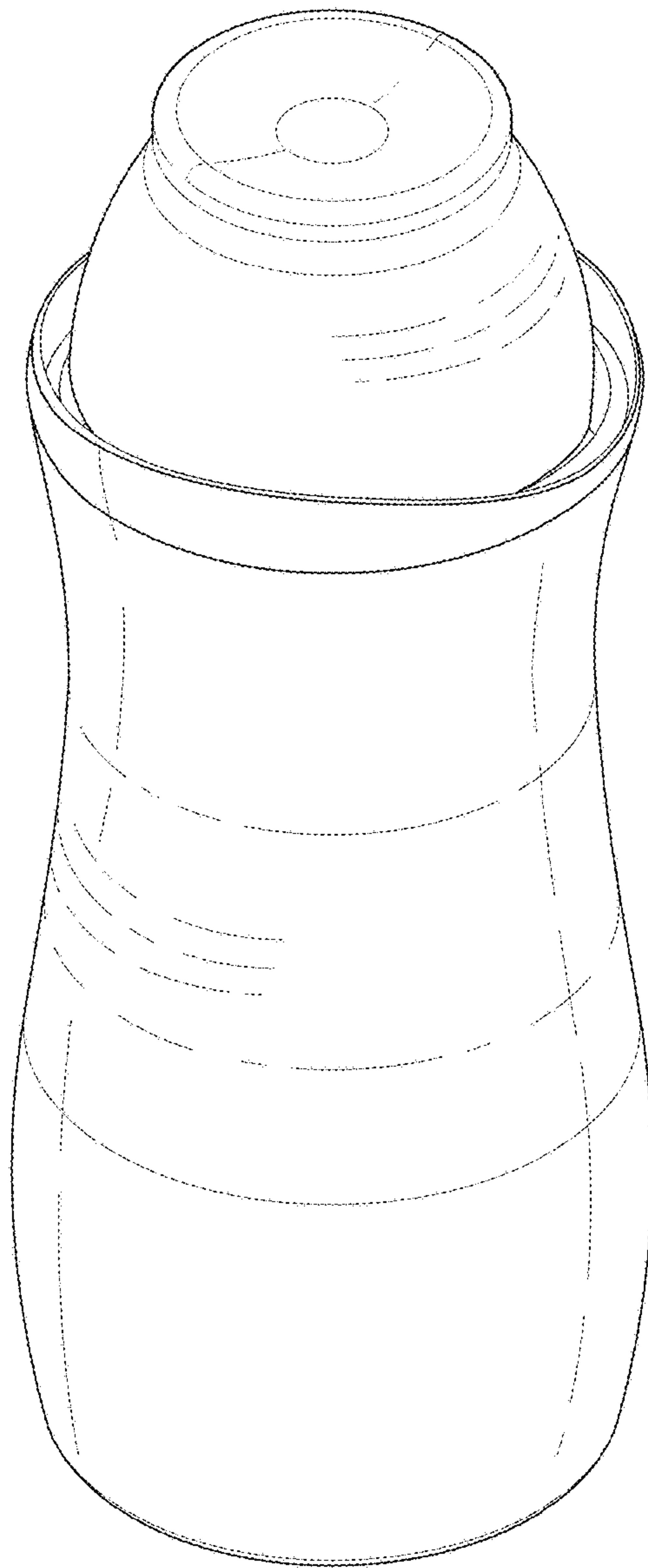

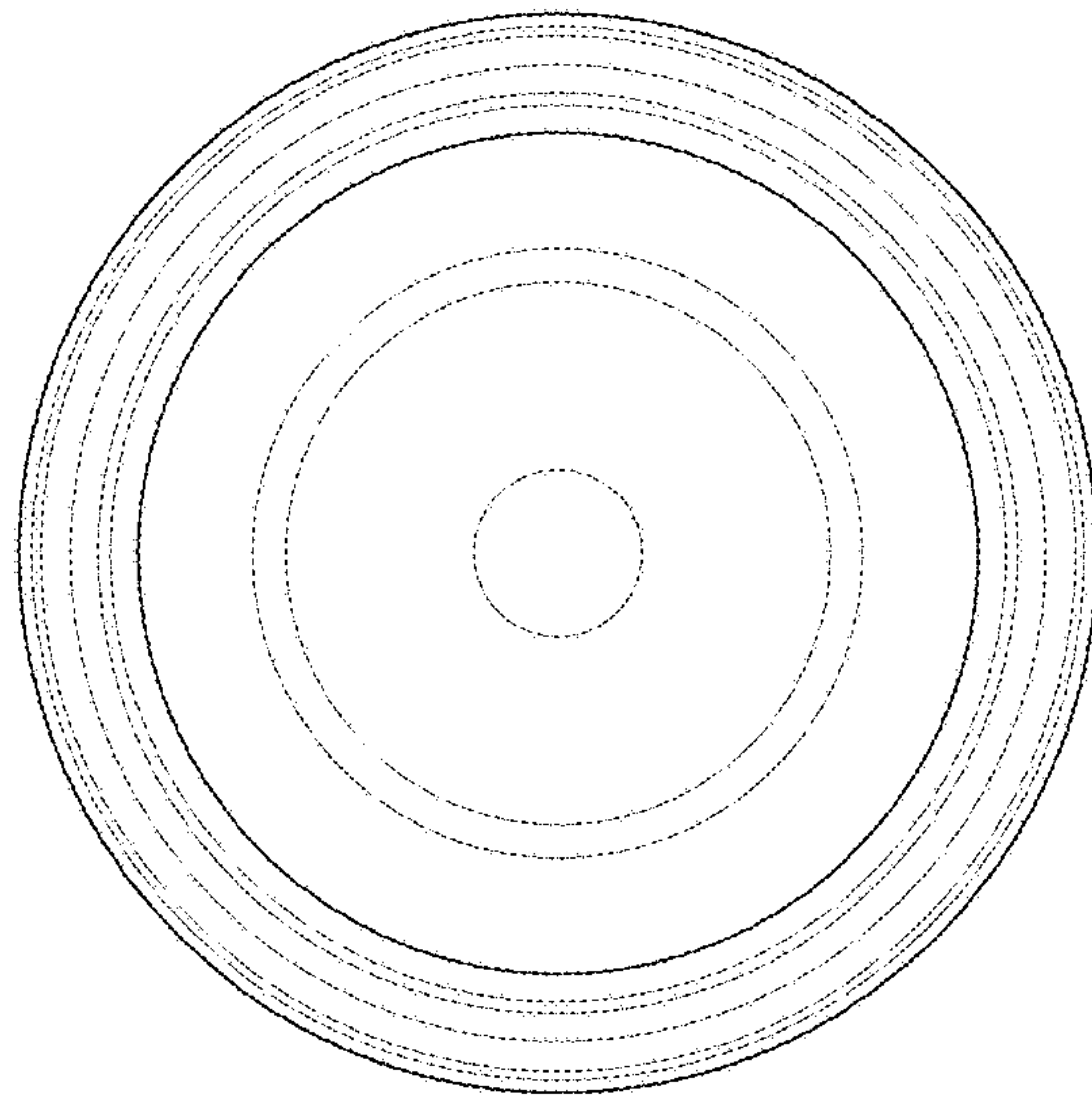

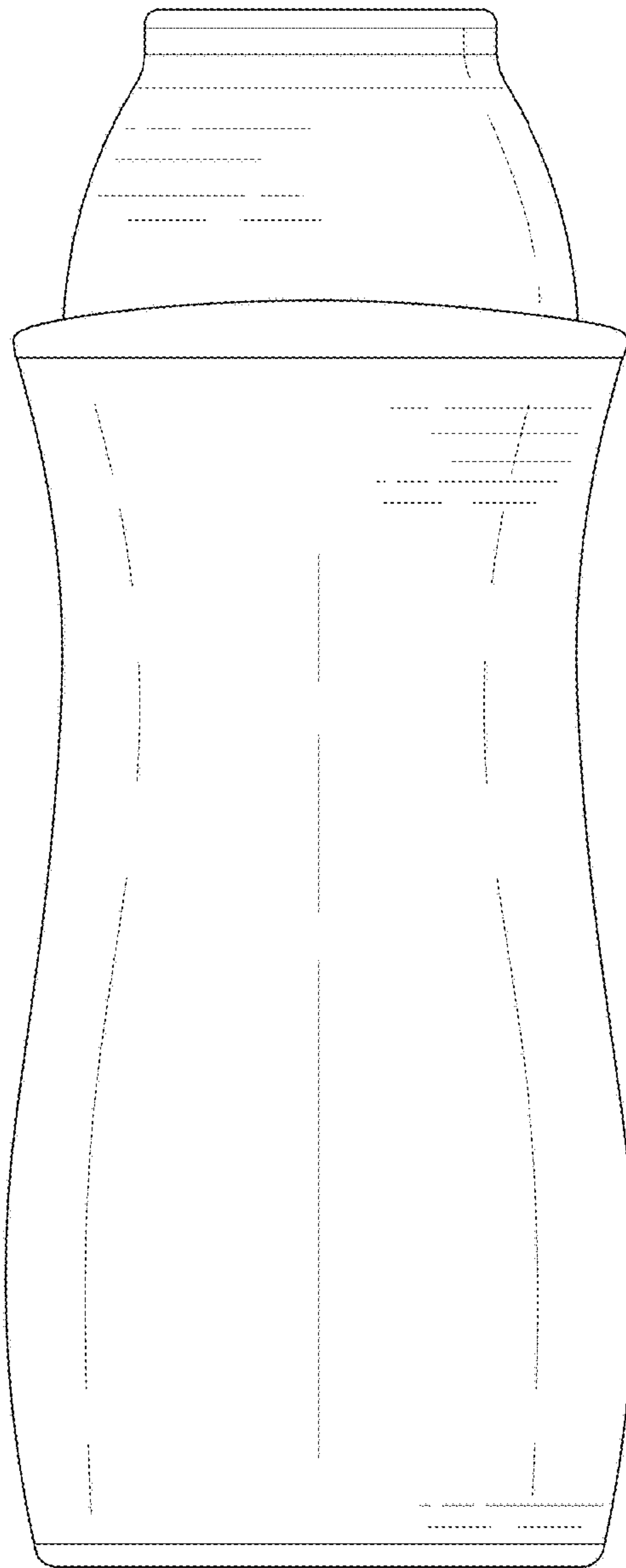

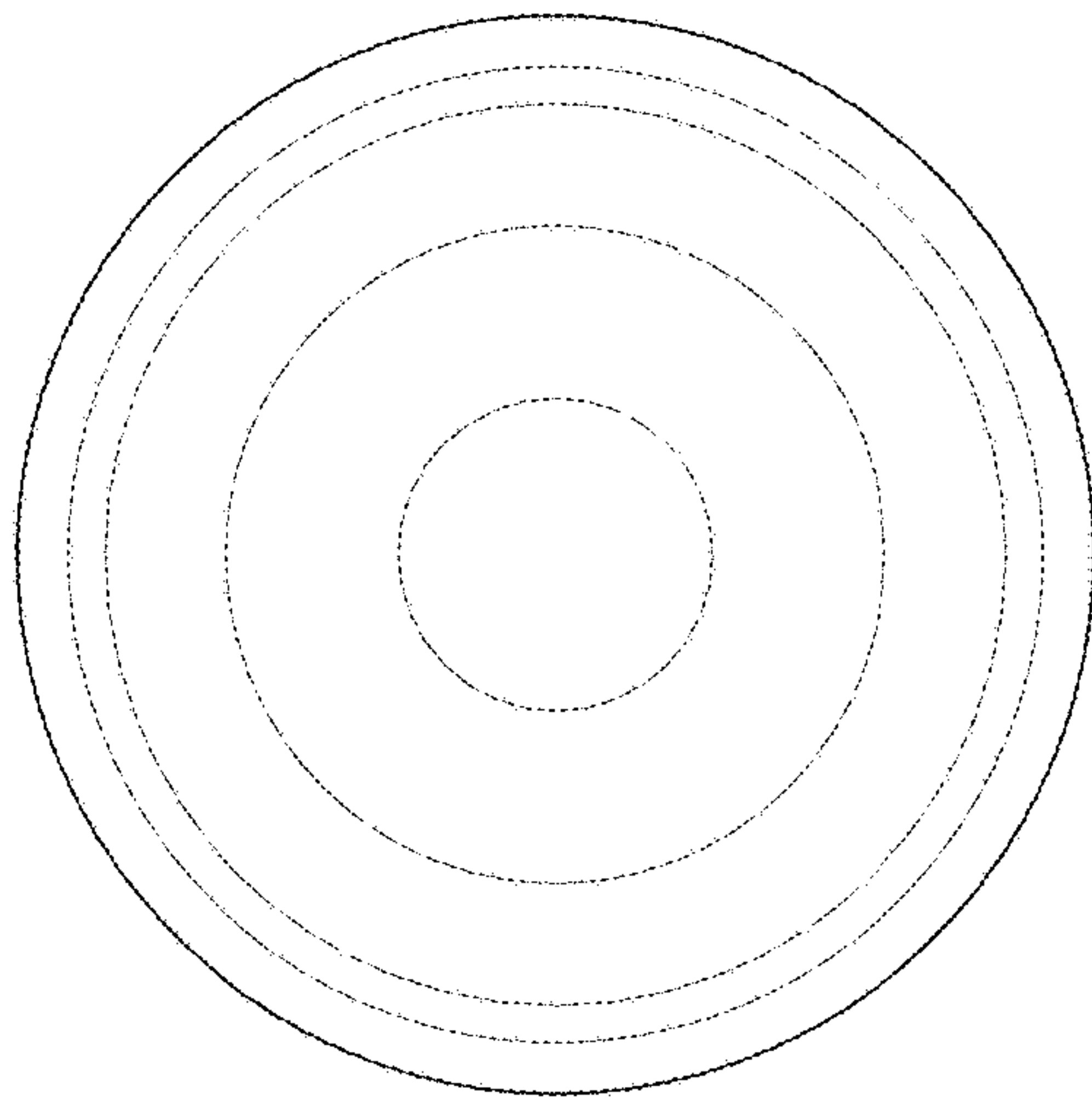

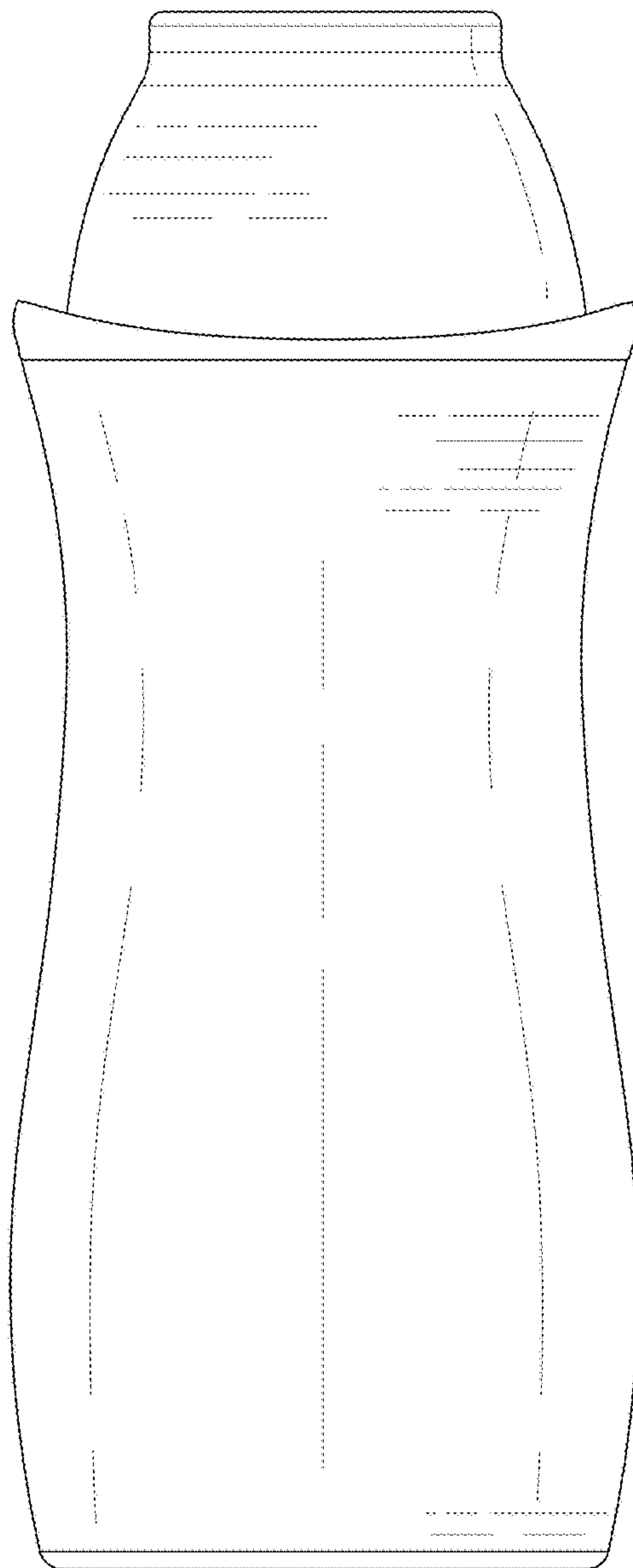

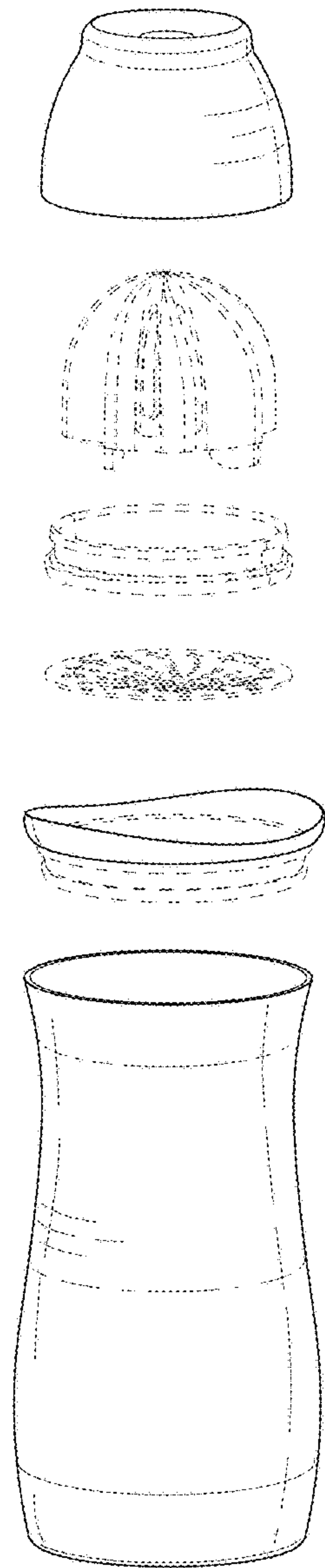
