The ornamental design for a packing box with hollow patterns, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a packing box with hollow patterns according to a first embodiment, showing my new design;

FIG. 2 is a front elevational view of the packing box with hollow patterns of FIG. 1;

FIG. 3 is a rear elevational view of the packing box with hollow patterns of FIG. 1;

FIG. 11 is a left side elevational view of the packing box with hollow patterns of FIG. 8;

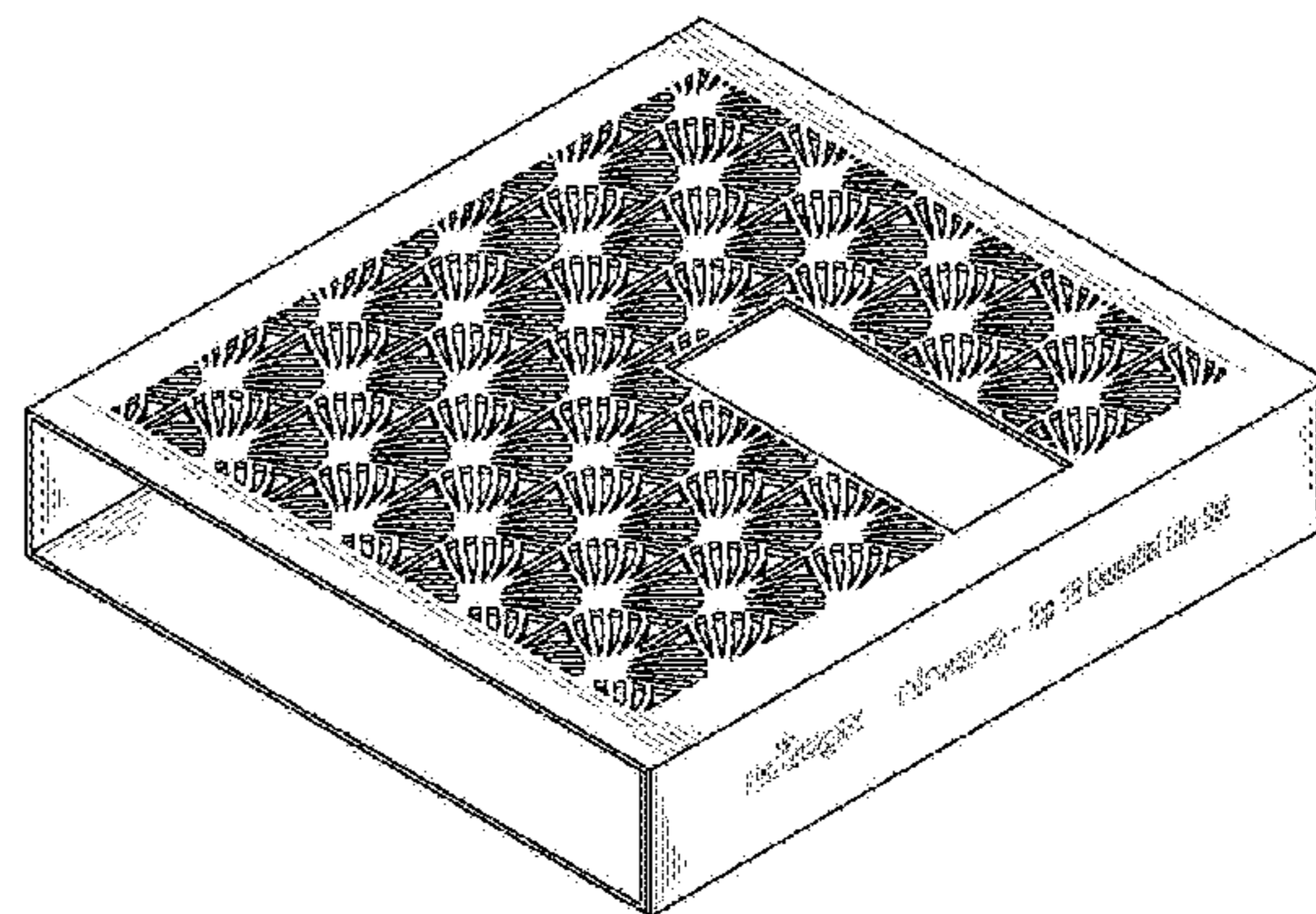
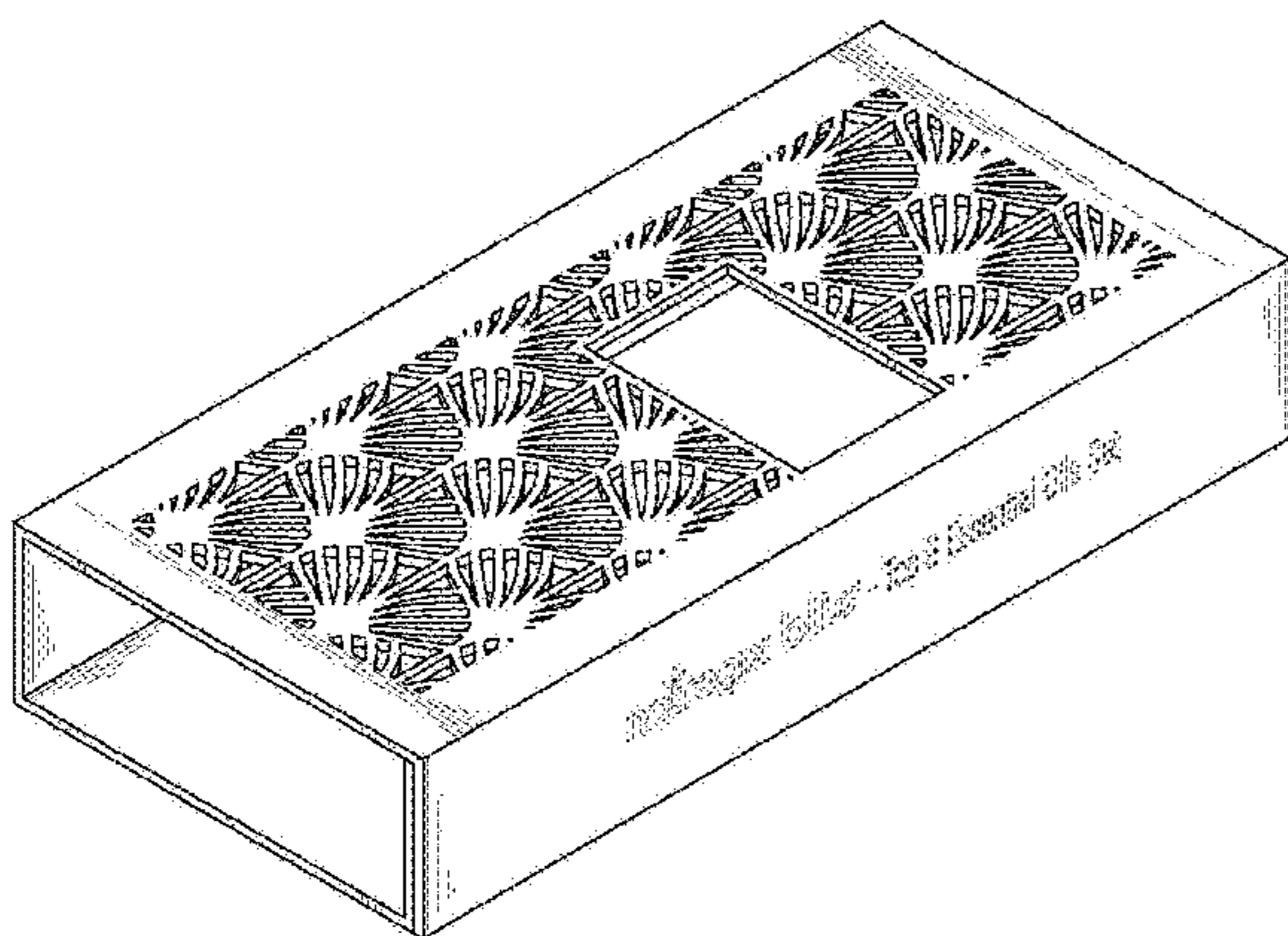
FIG. 12 is a right side elevational view of the packing box with hollow patterns of FIG. 8;

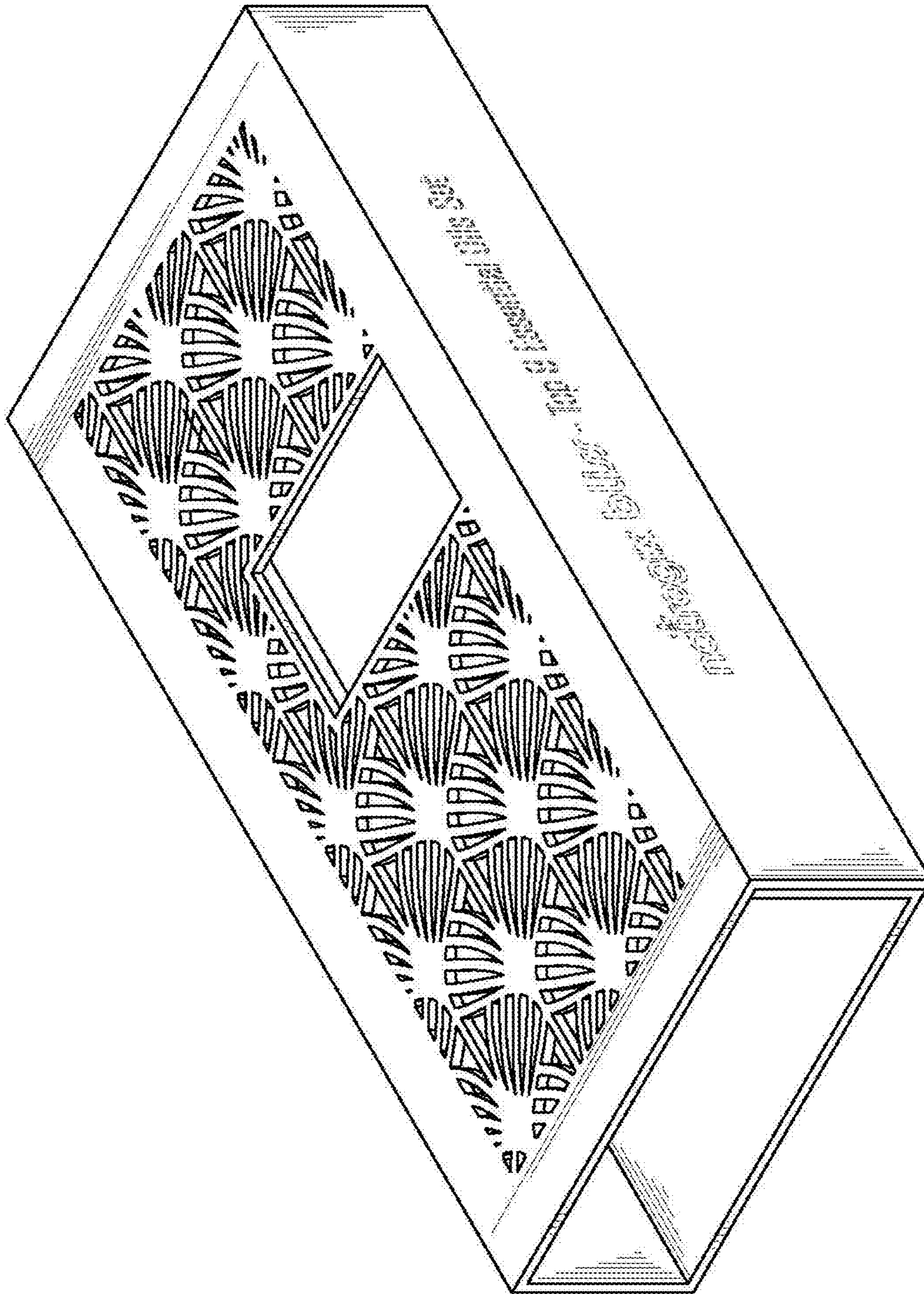

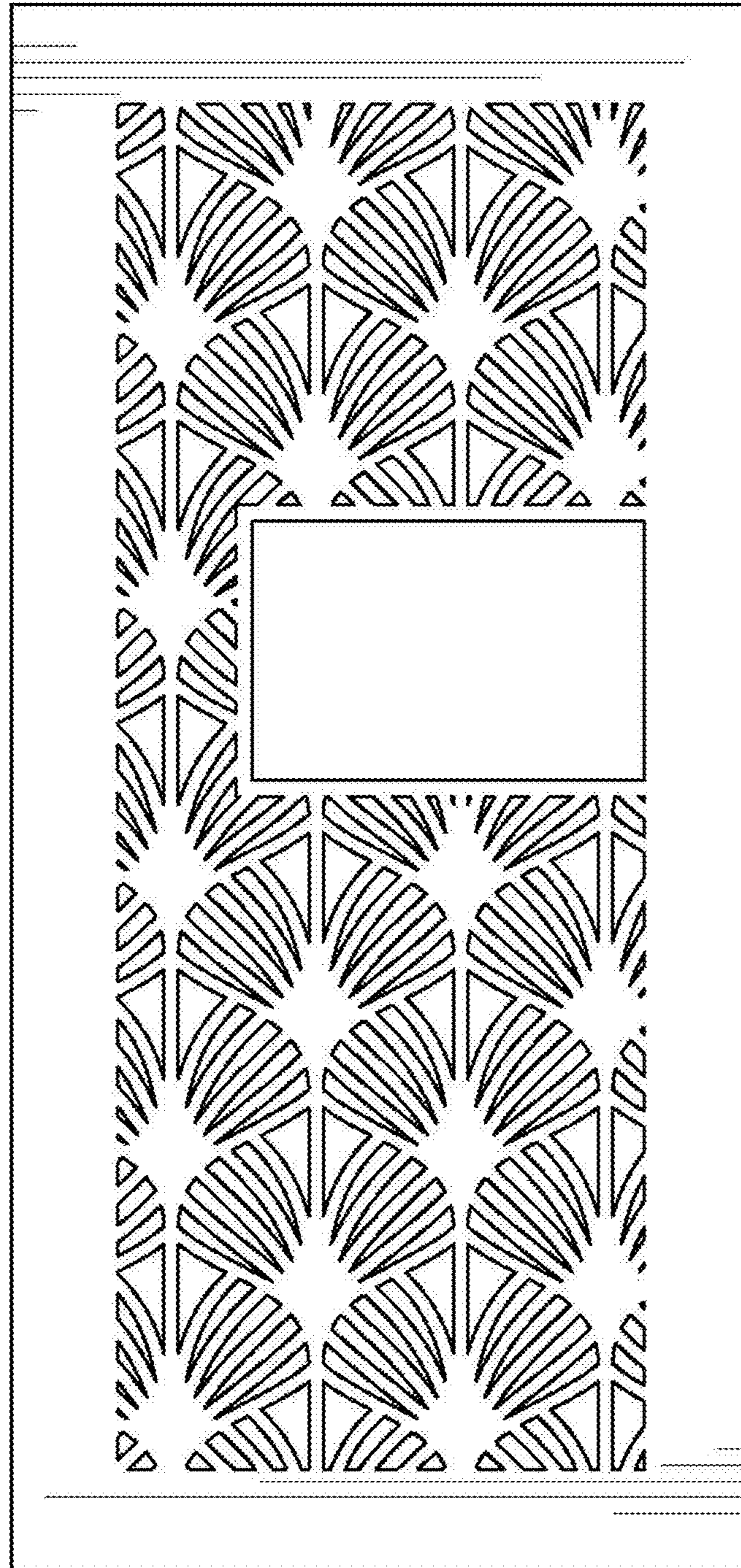

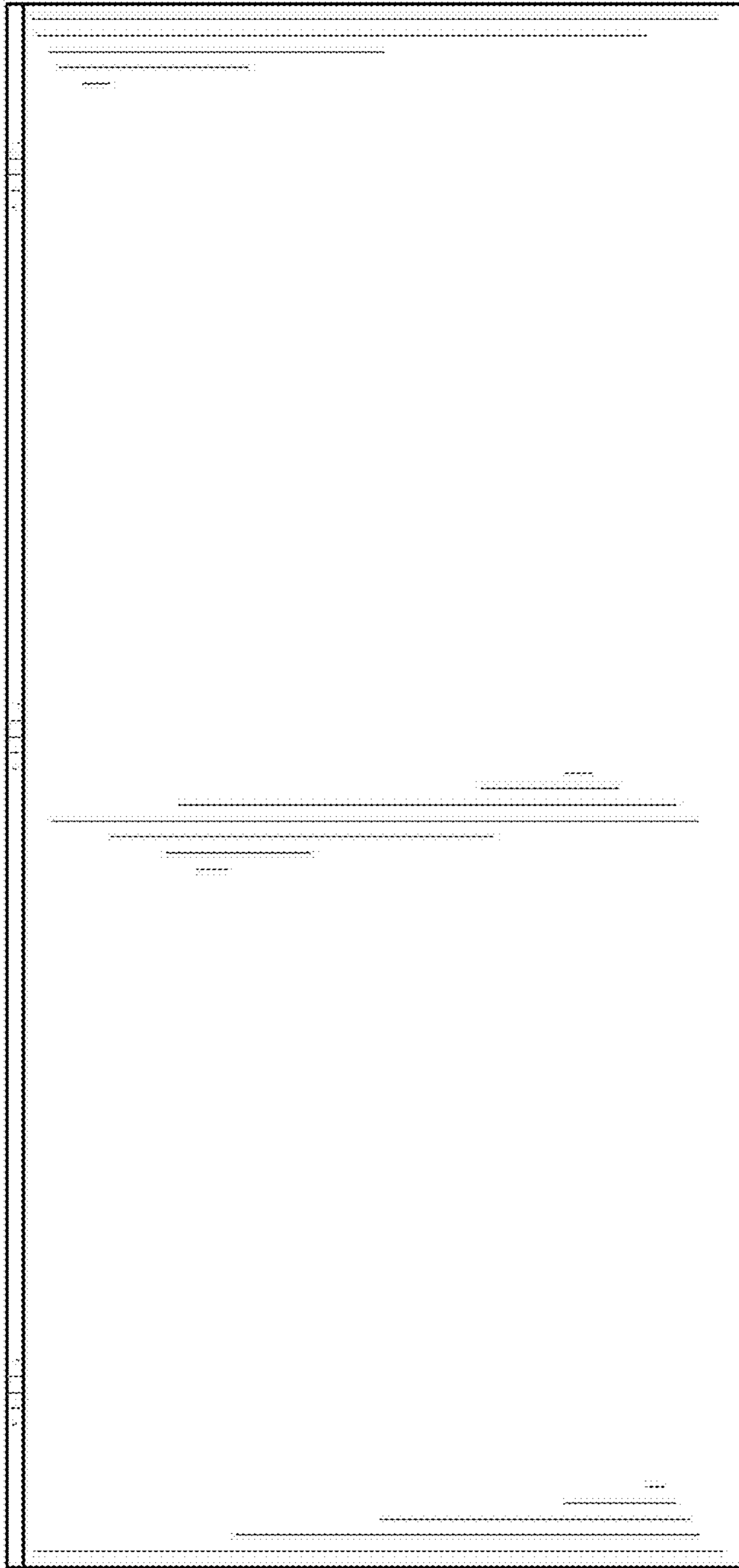

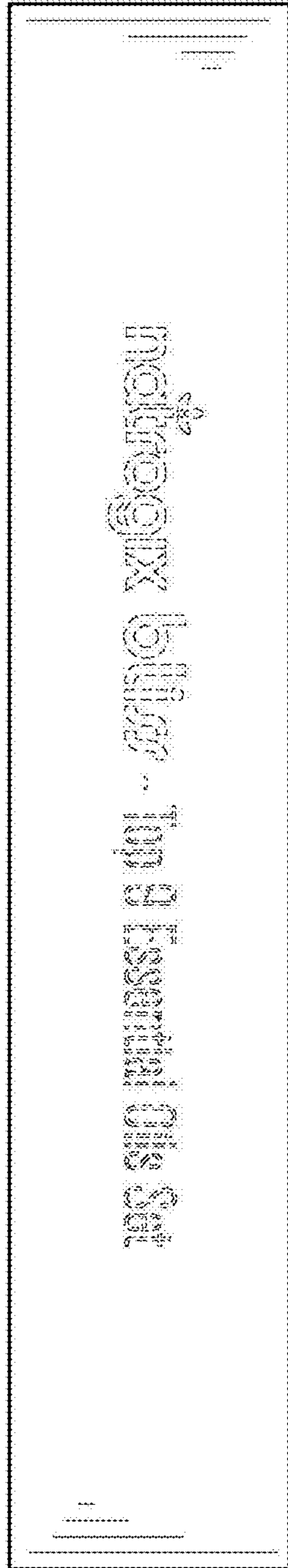

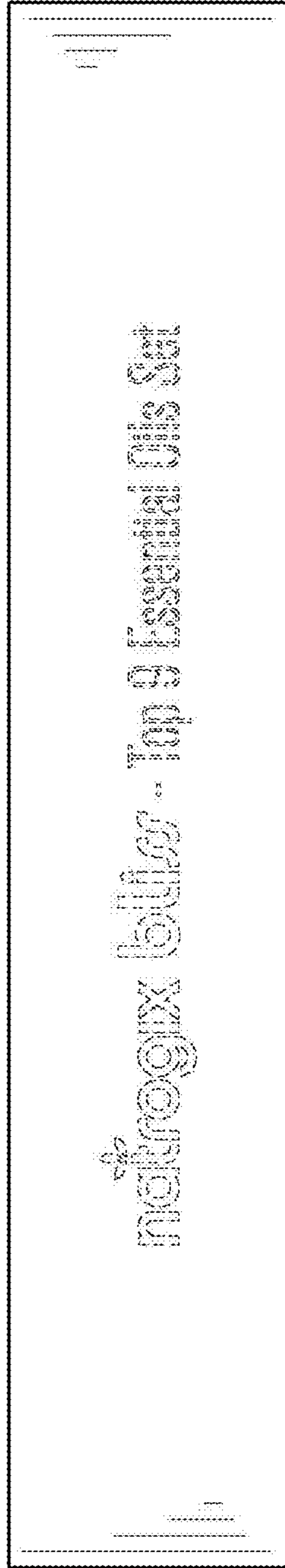

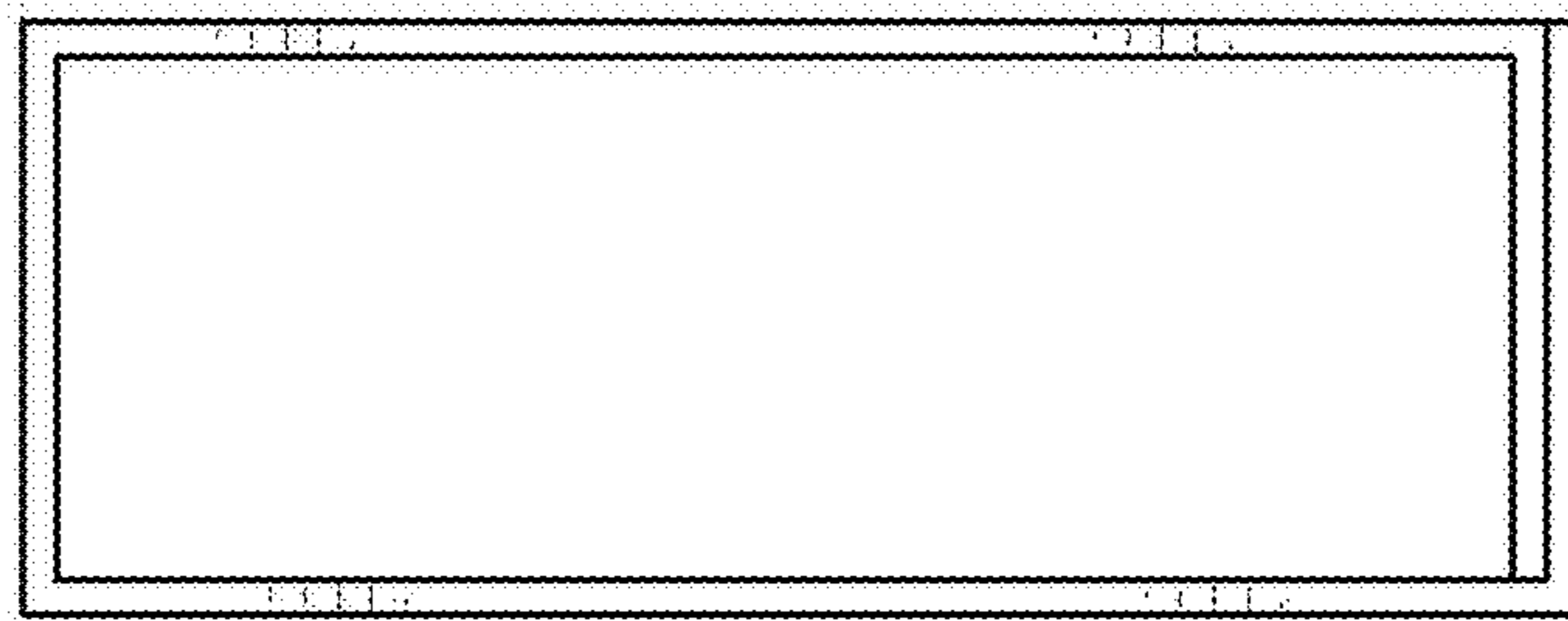

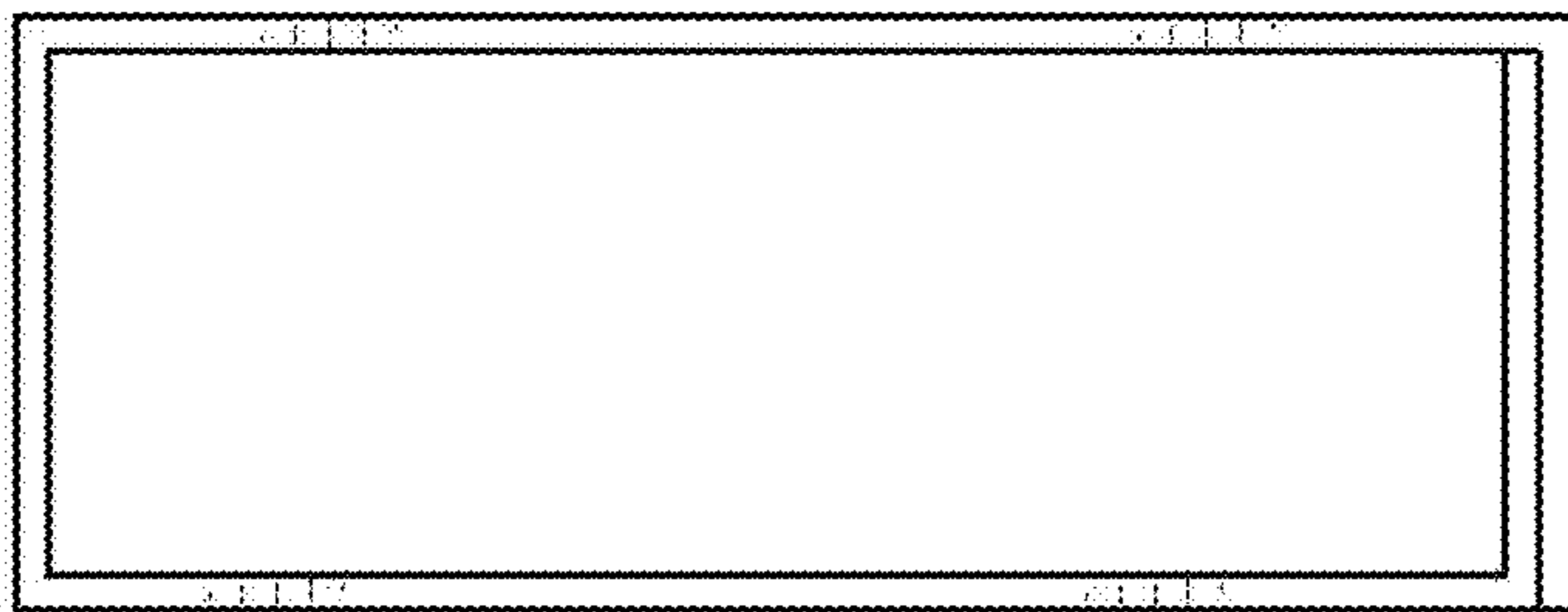

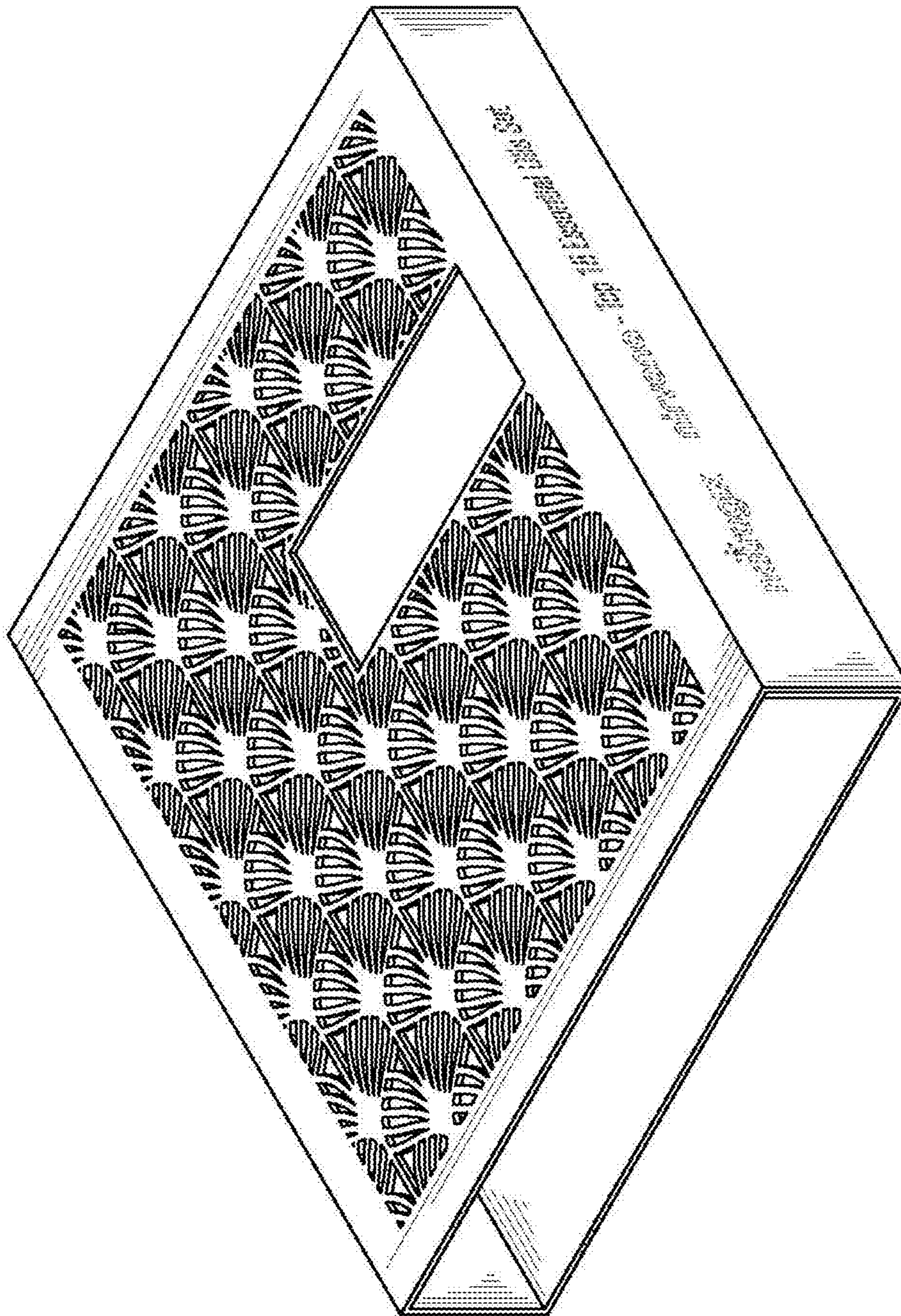

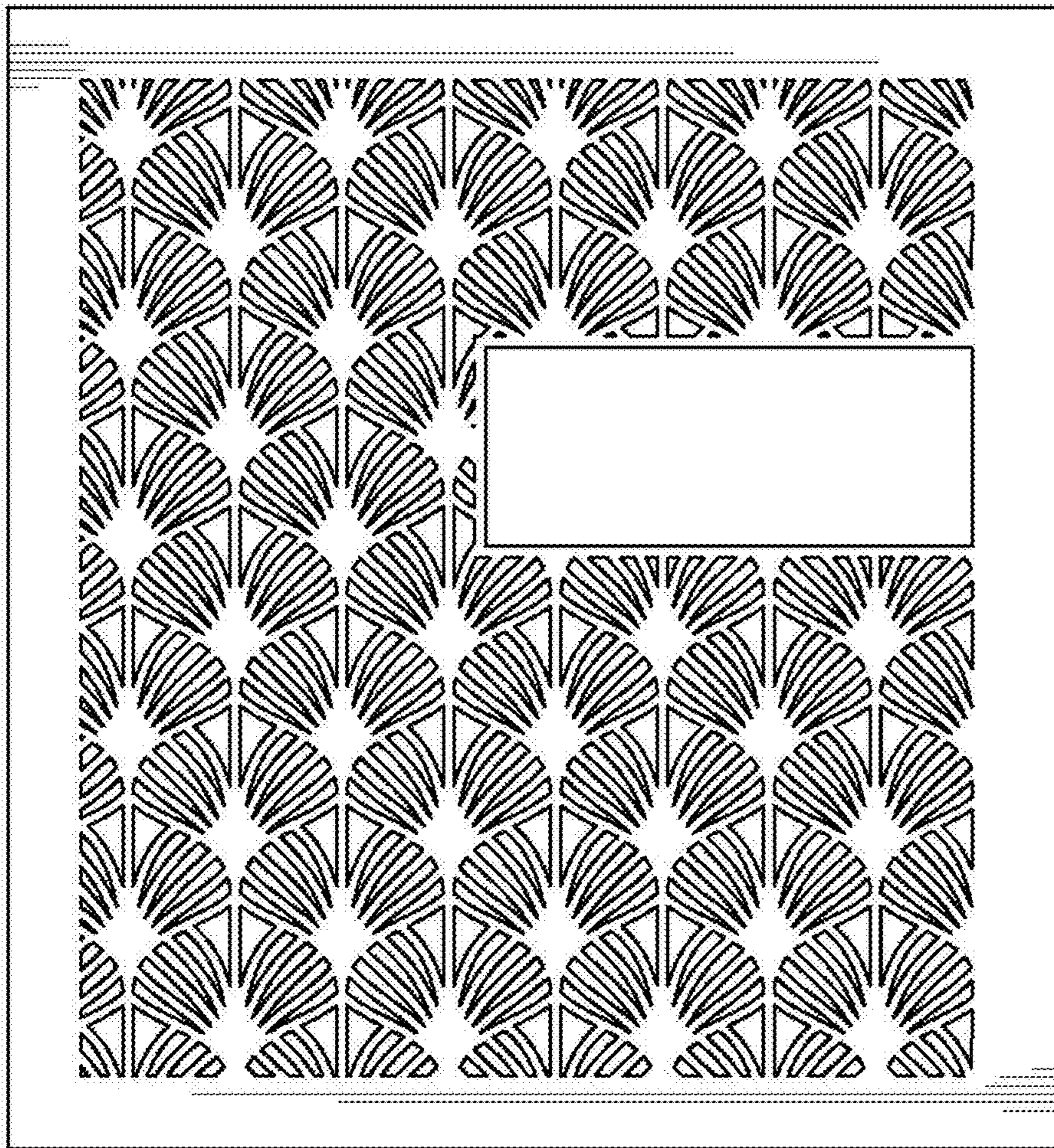

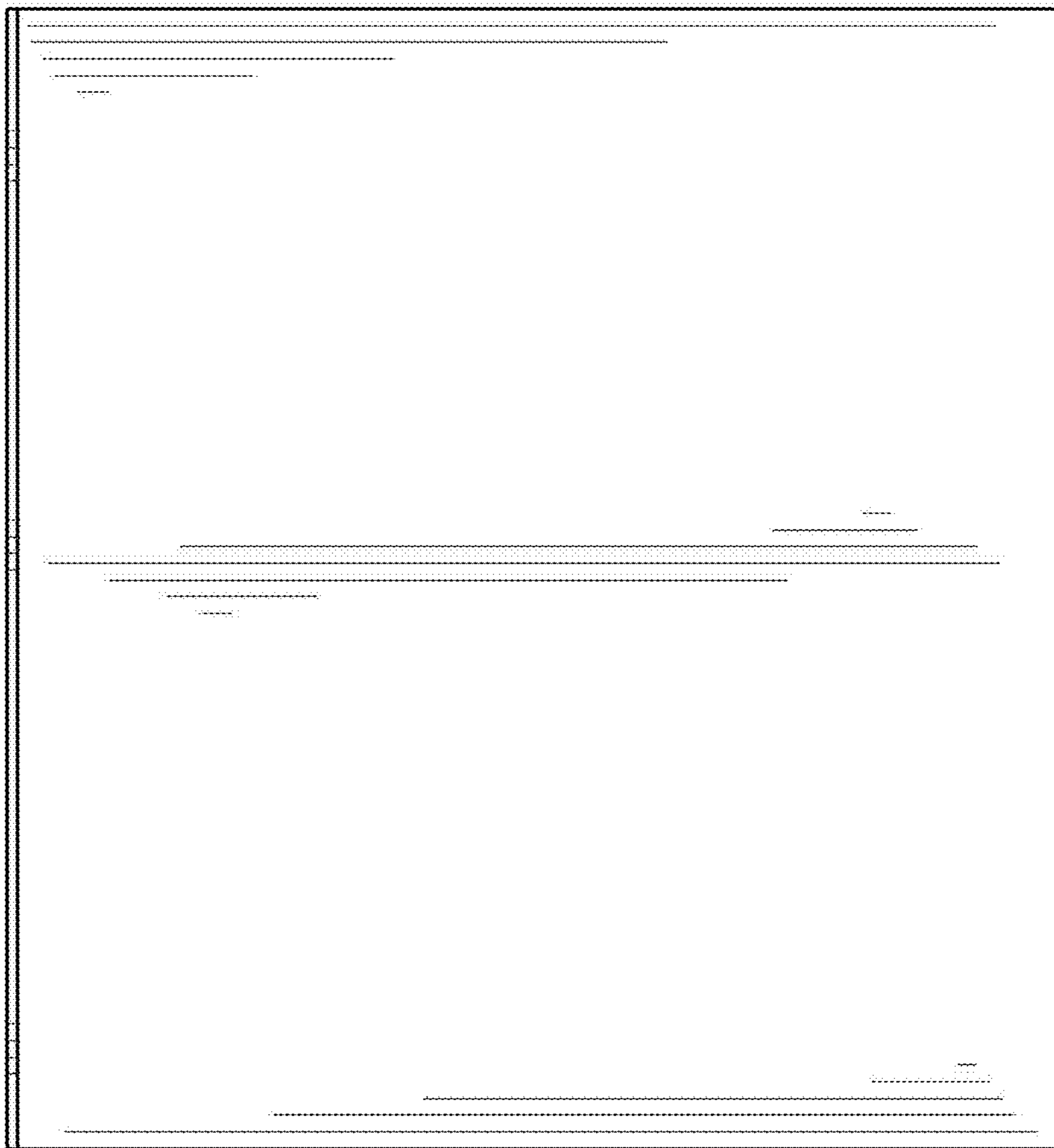

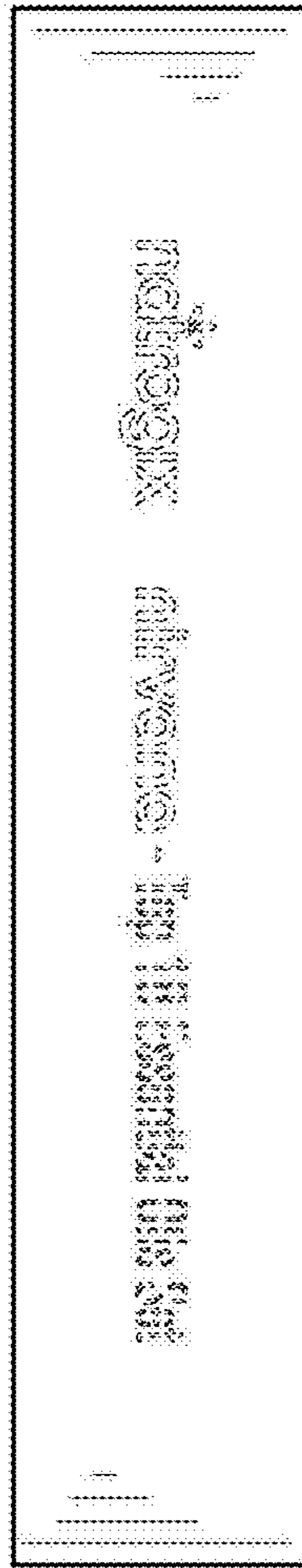

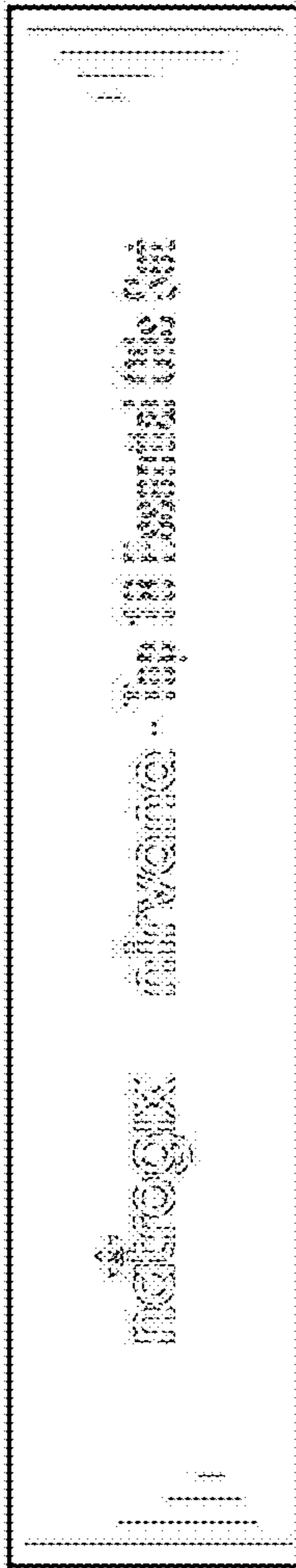
