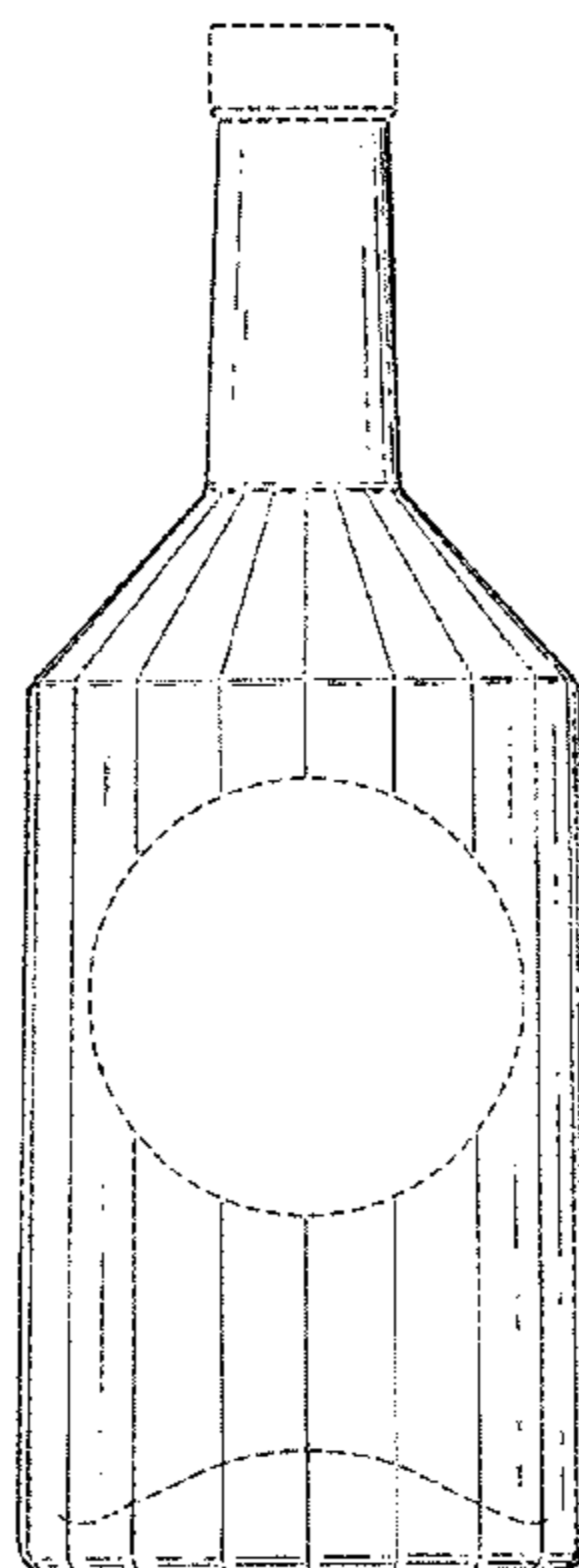
The ornamental design for a bottle, as shown and described.

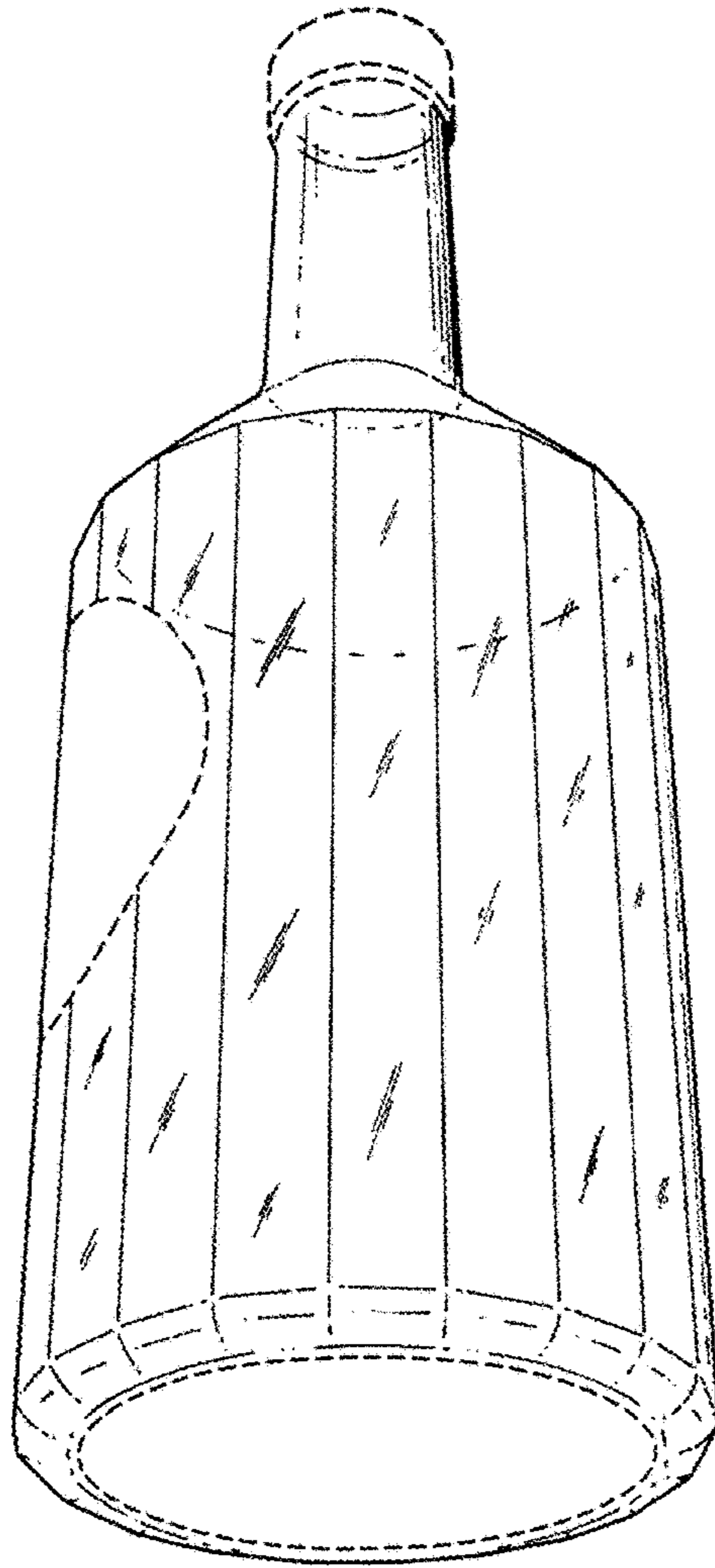

The portions of the bottle shown in broken lines form no part of the claimed design.

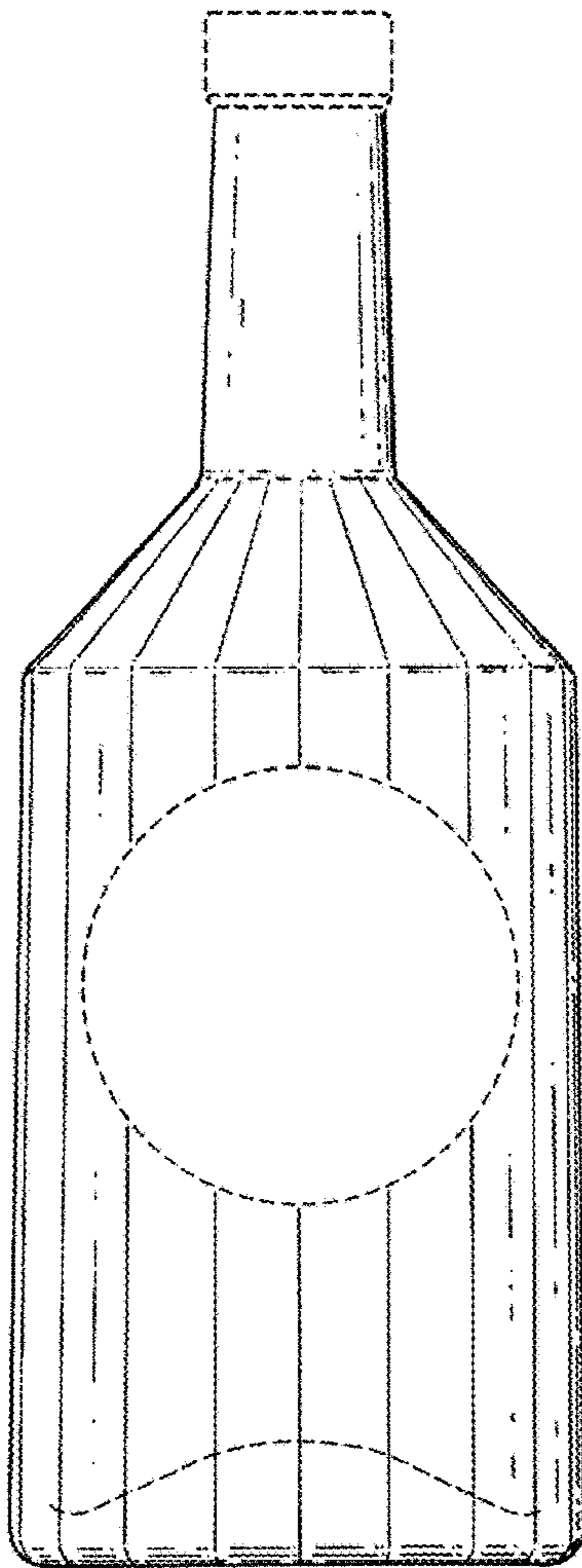

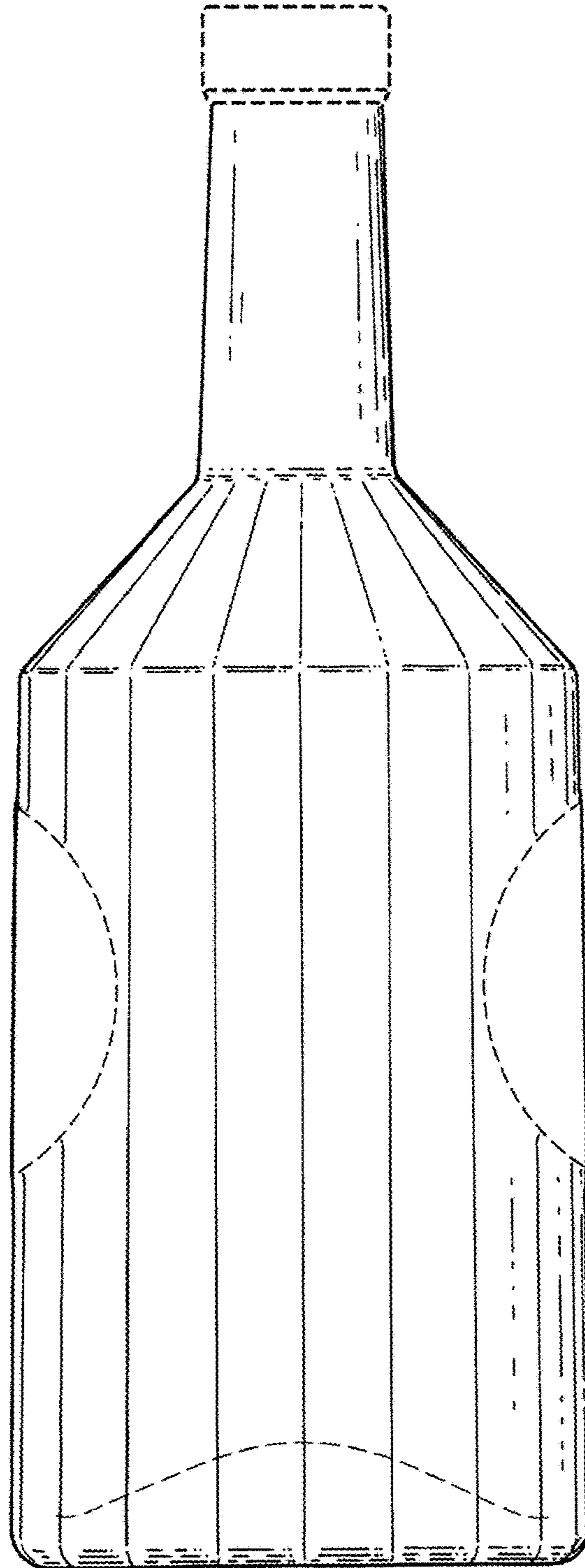

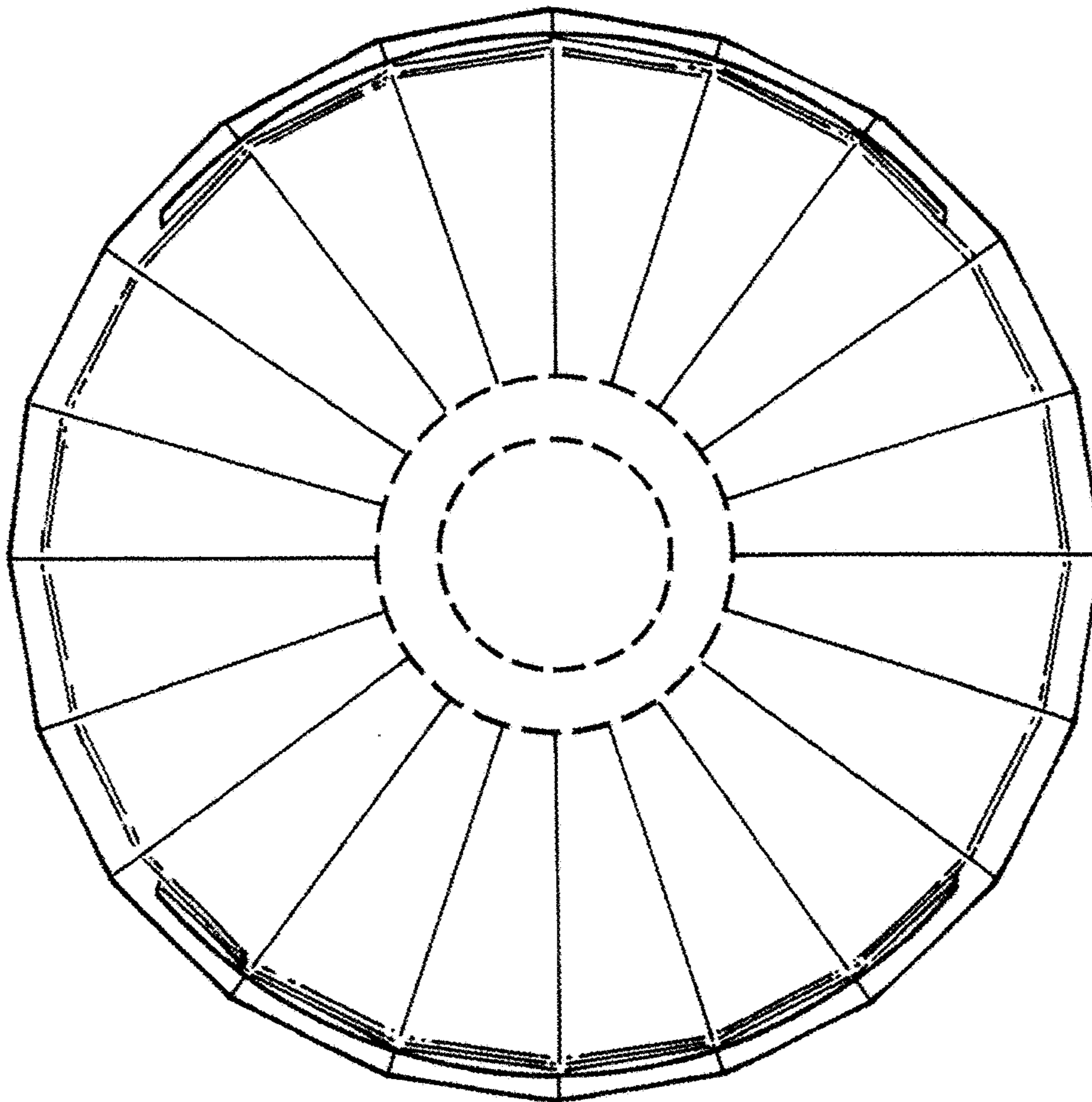

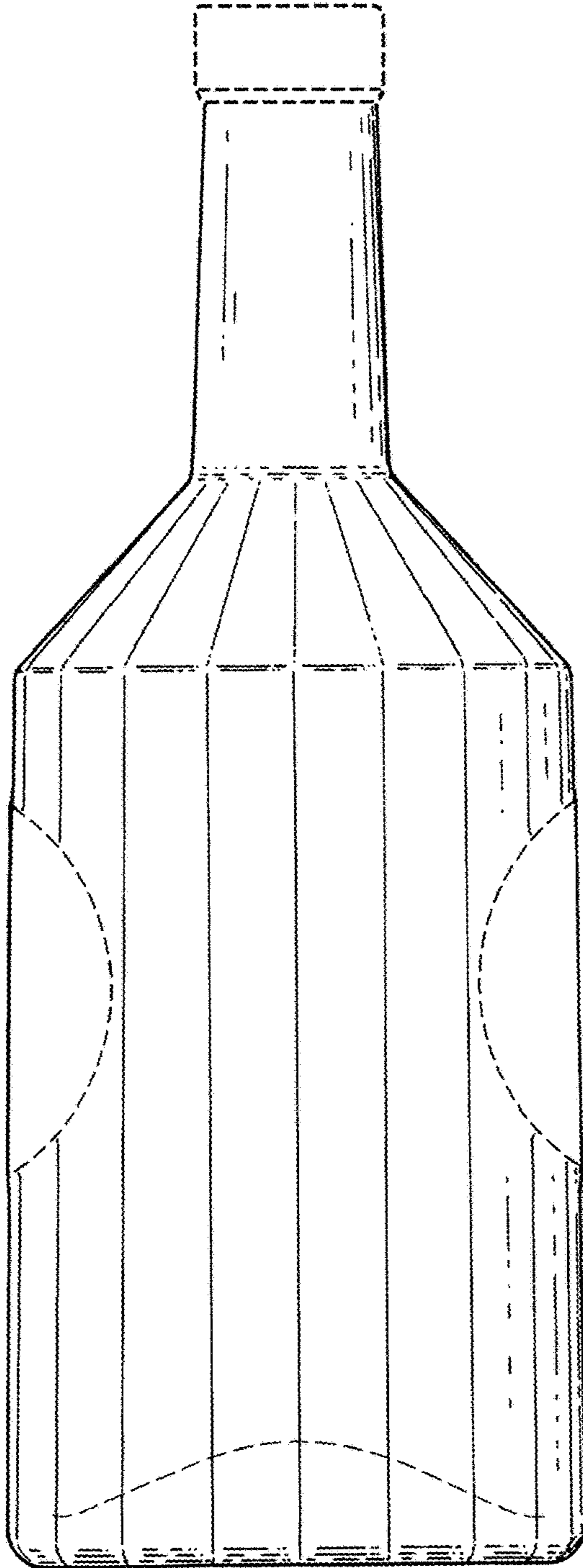

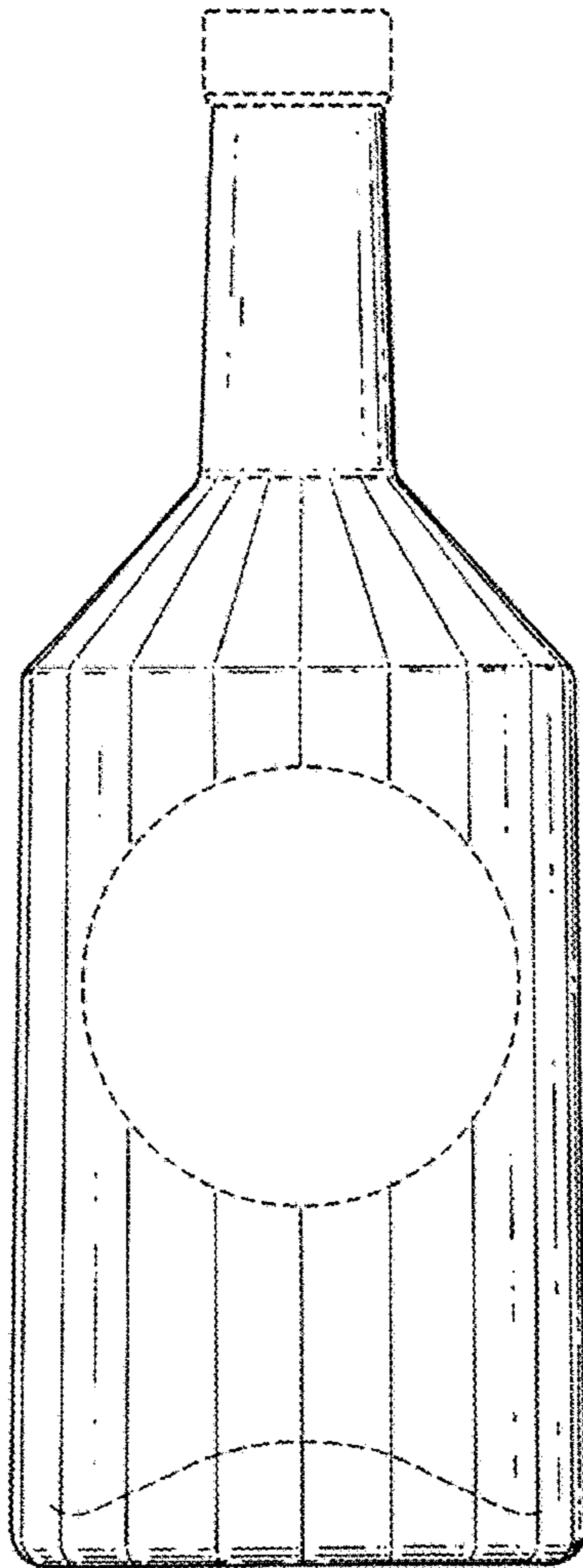
