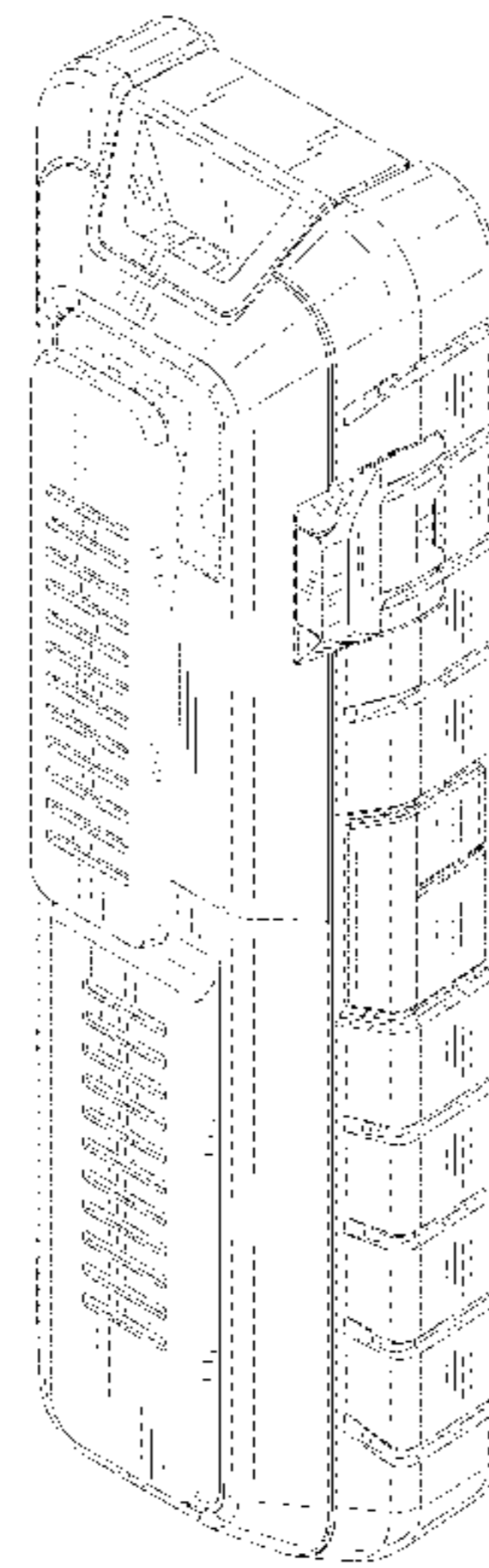
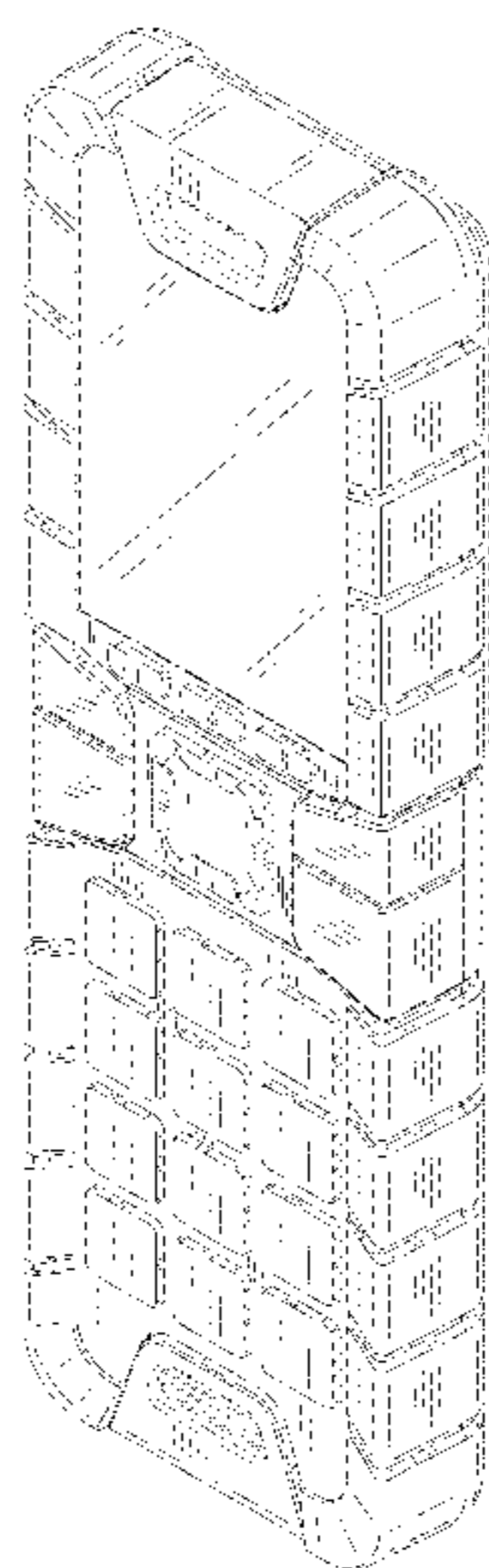
We claim the ornamental design for a telephone handset, as shown and described.

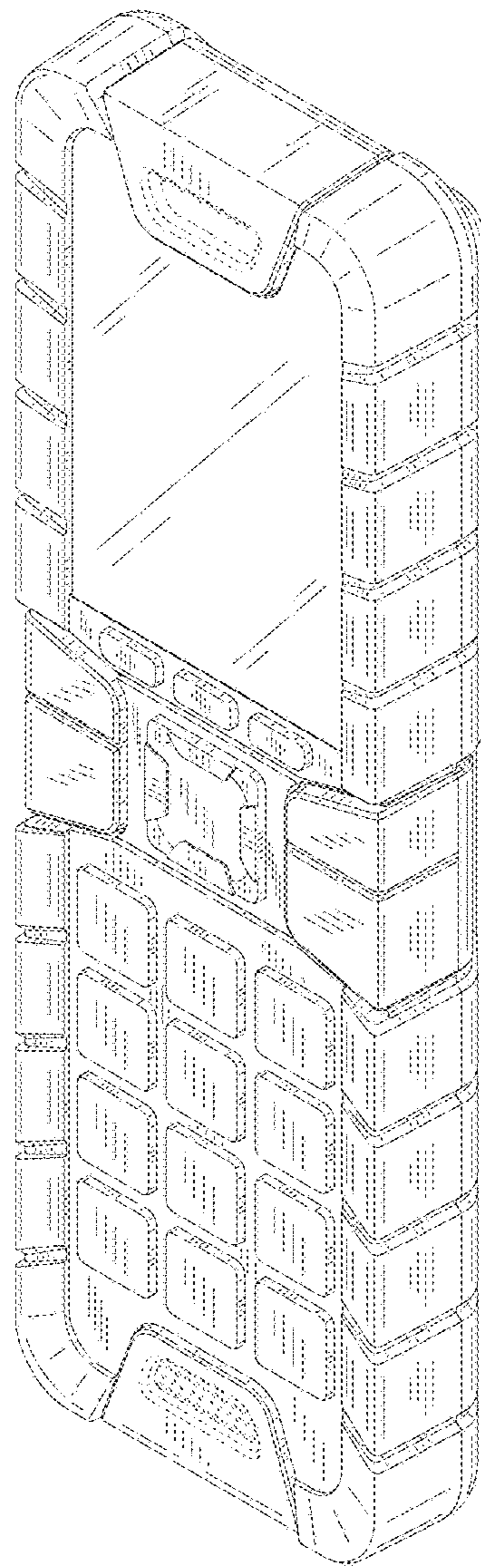

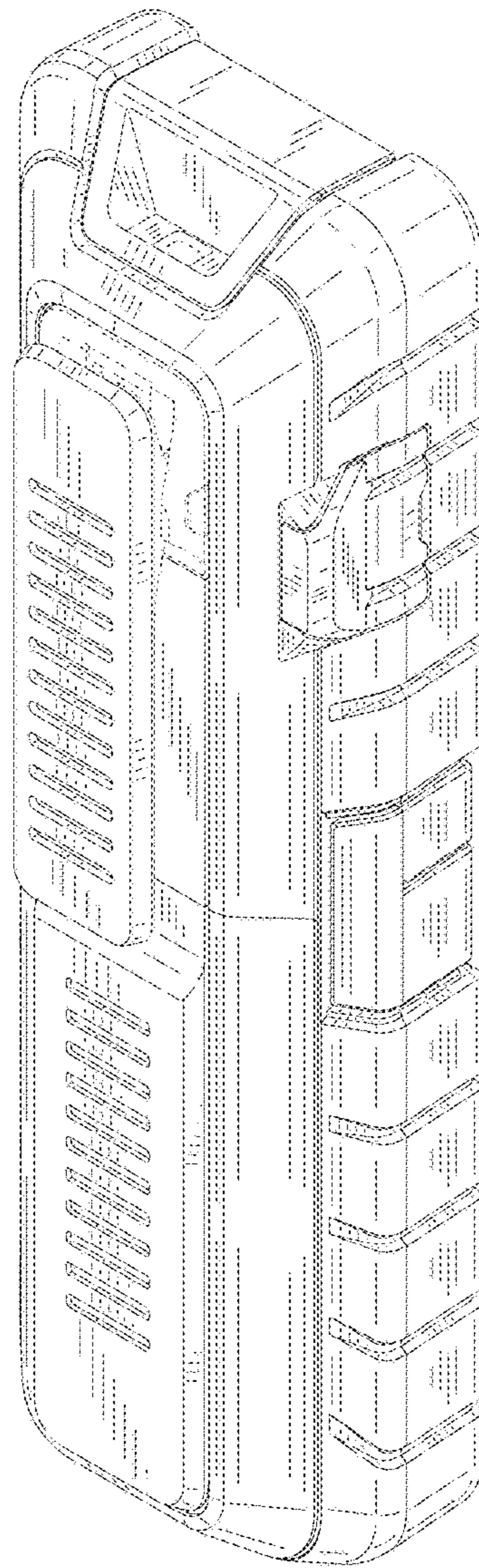

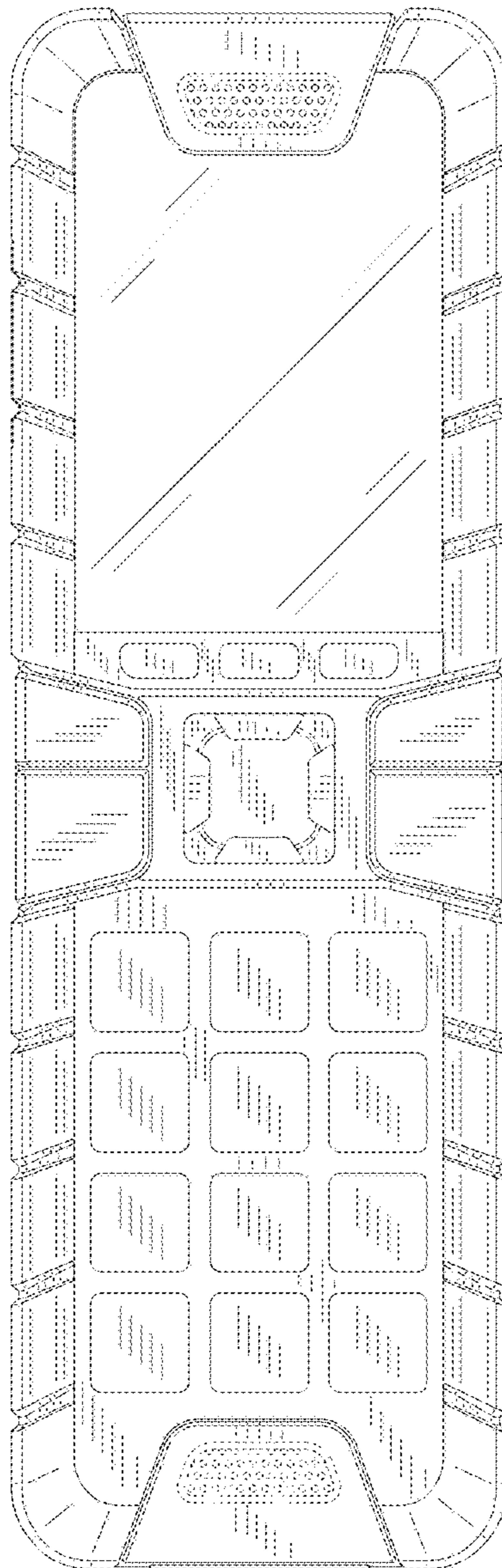

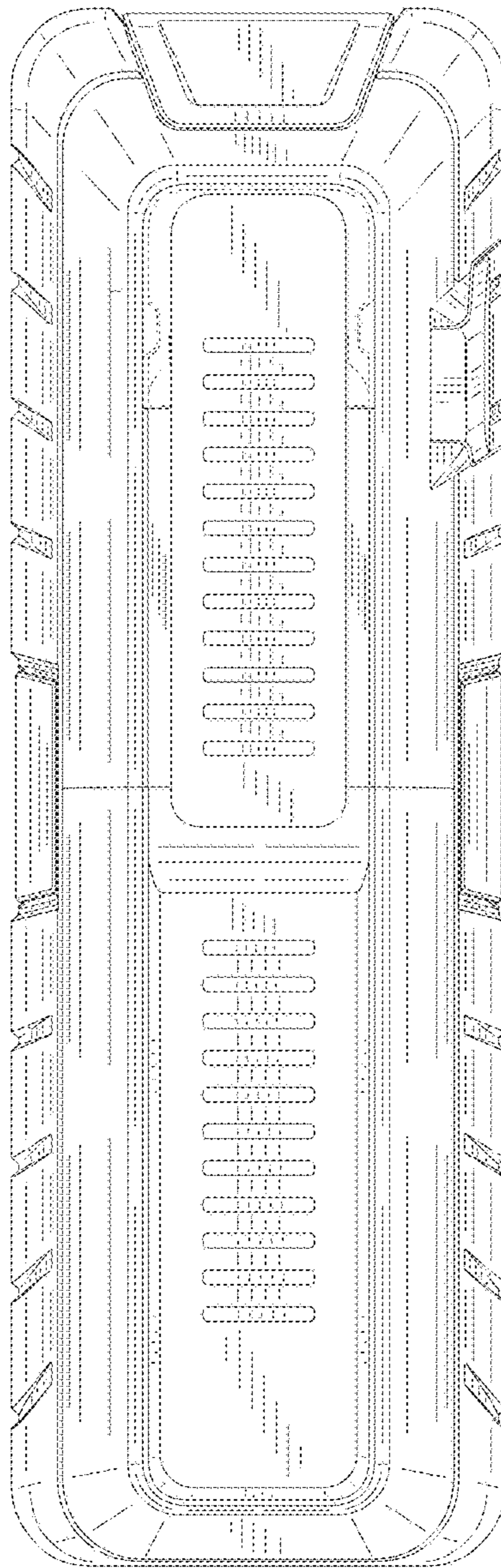

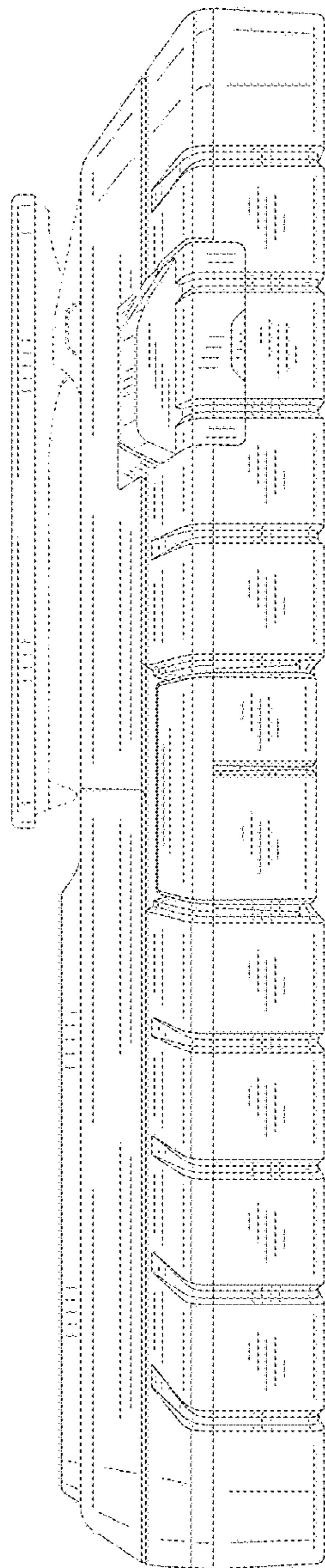

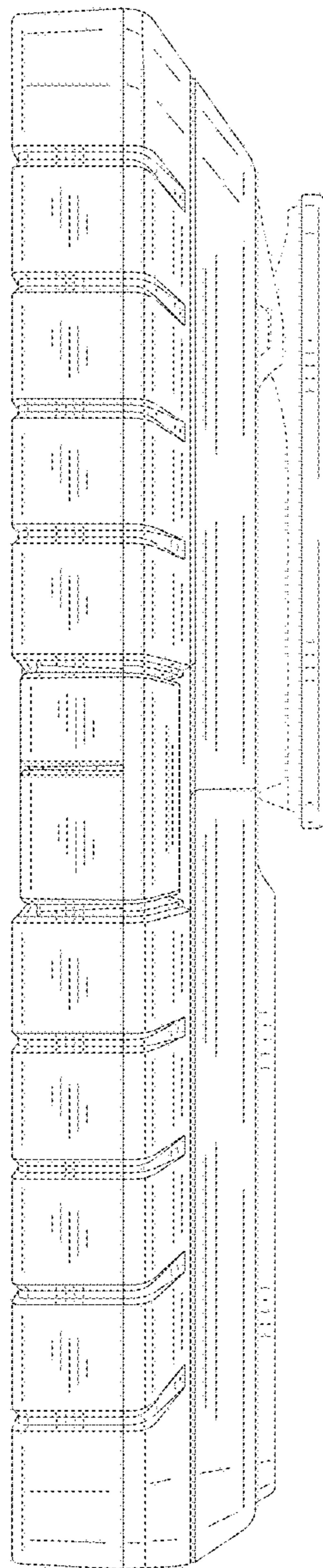

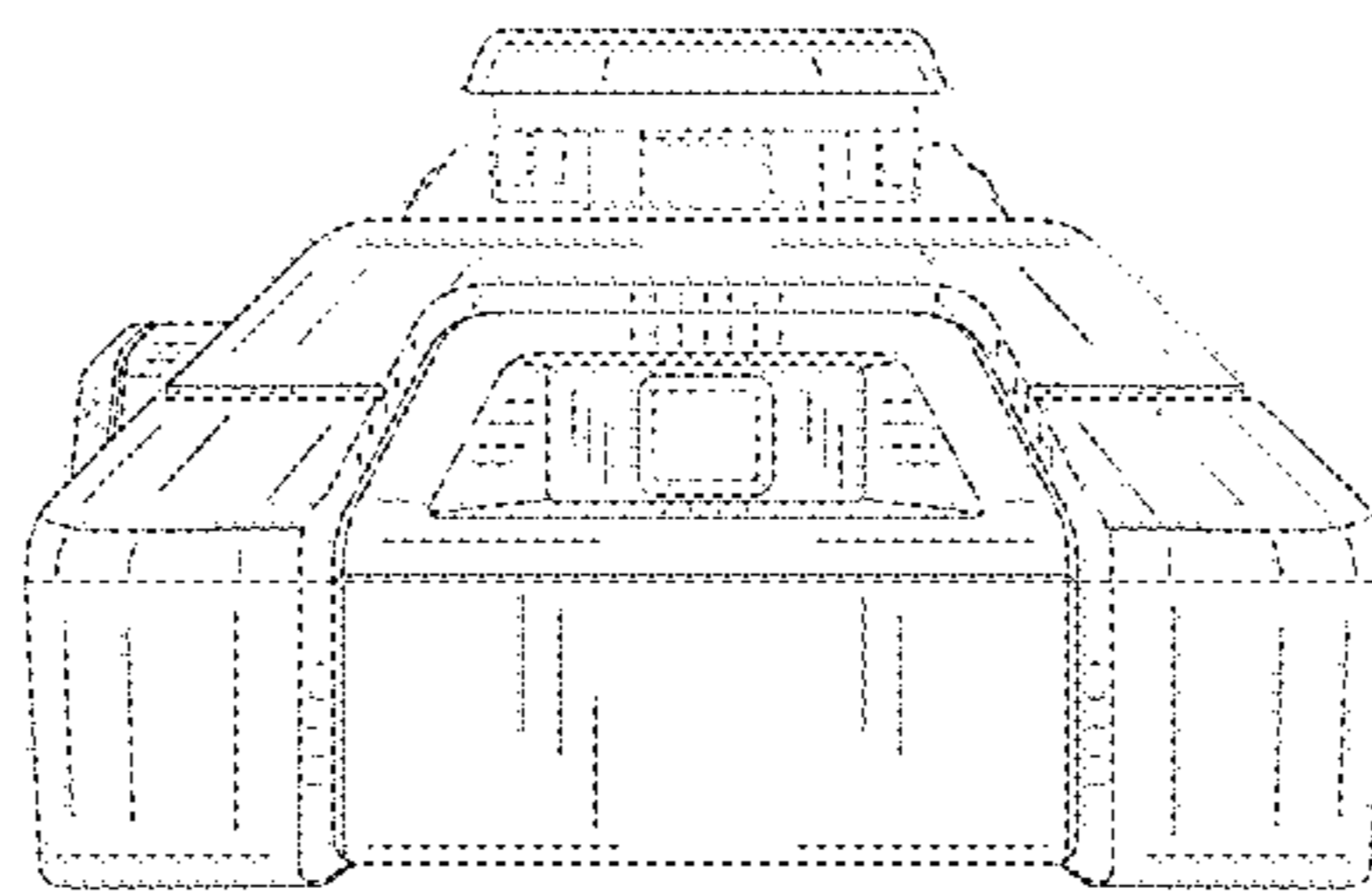
