The ornamental design for a mobile phone case, as shown and described.

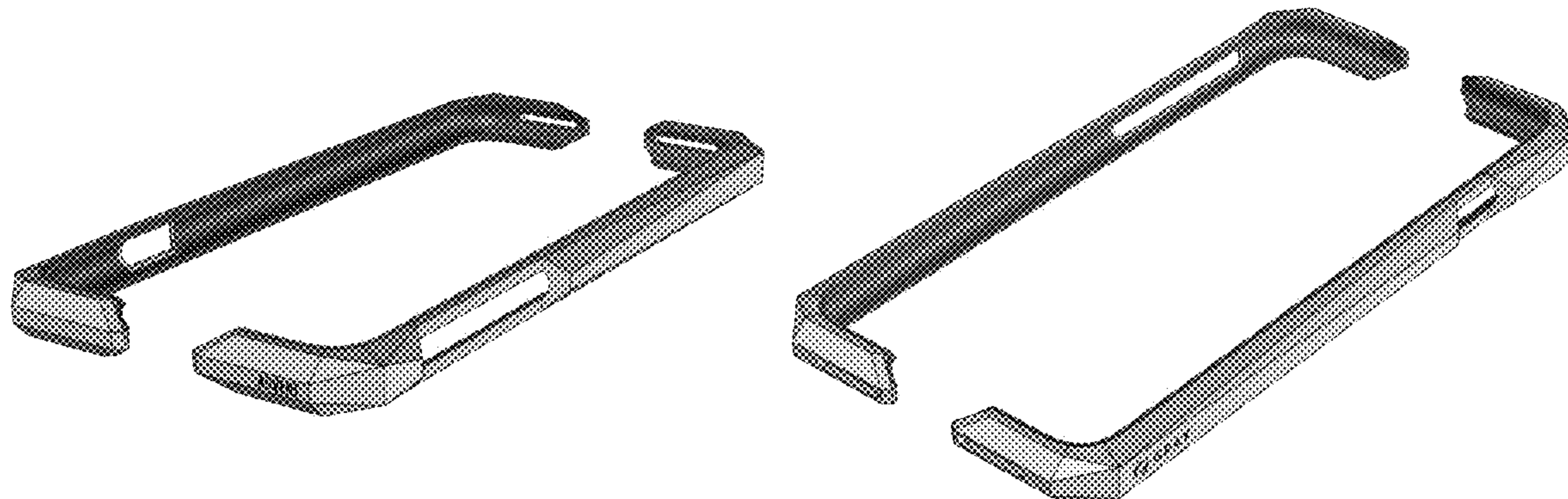
DESCRIPTION

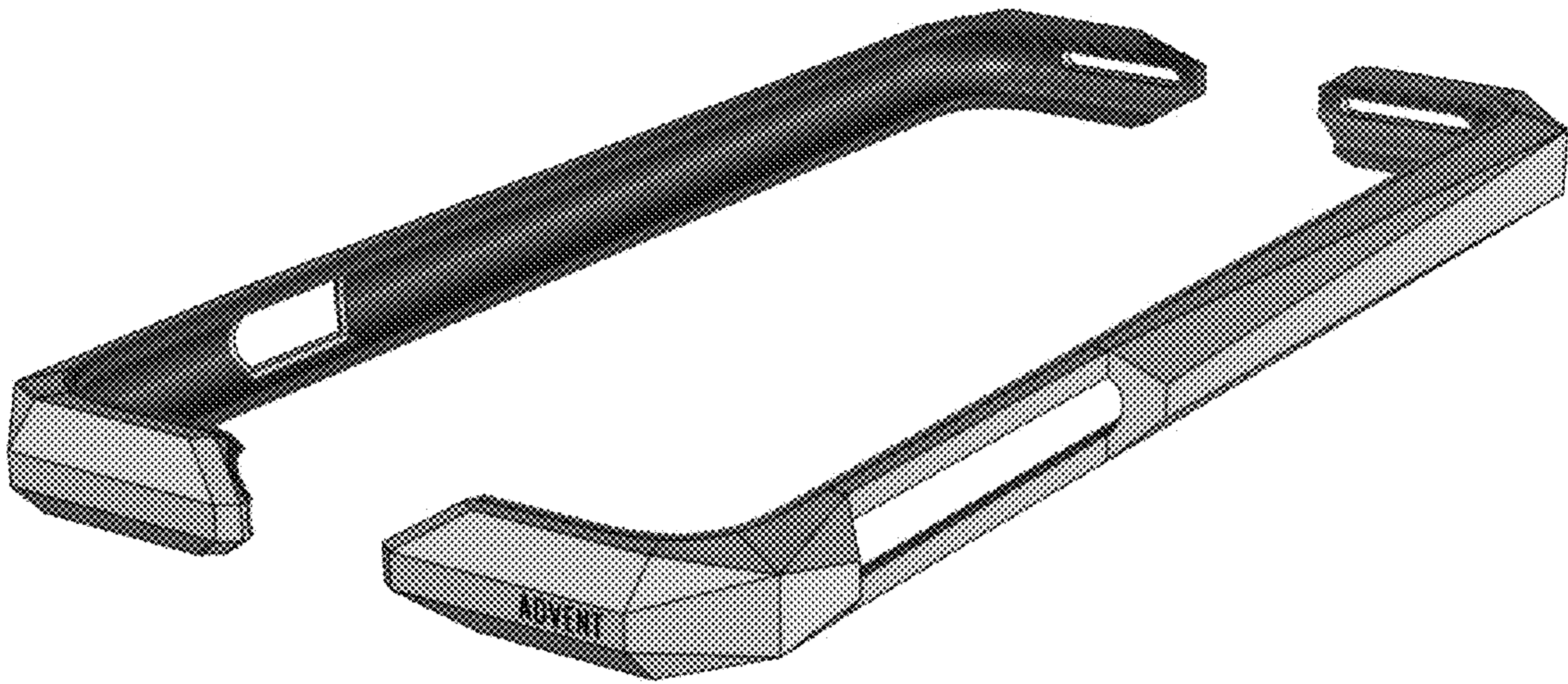
- 1. Mobile phone case

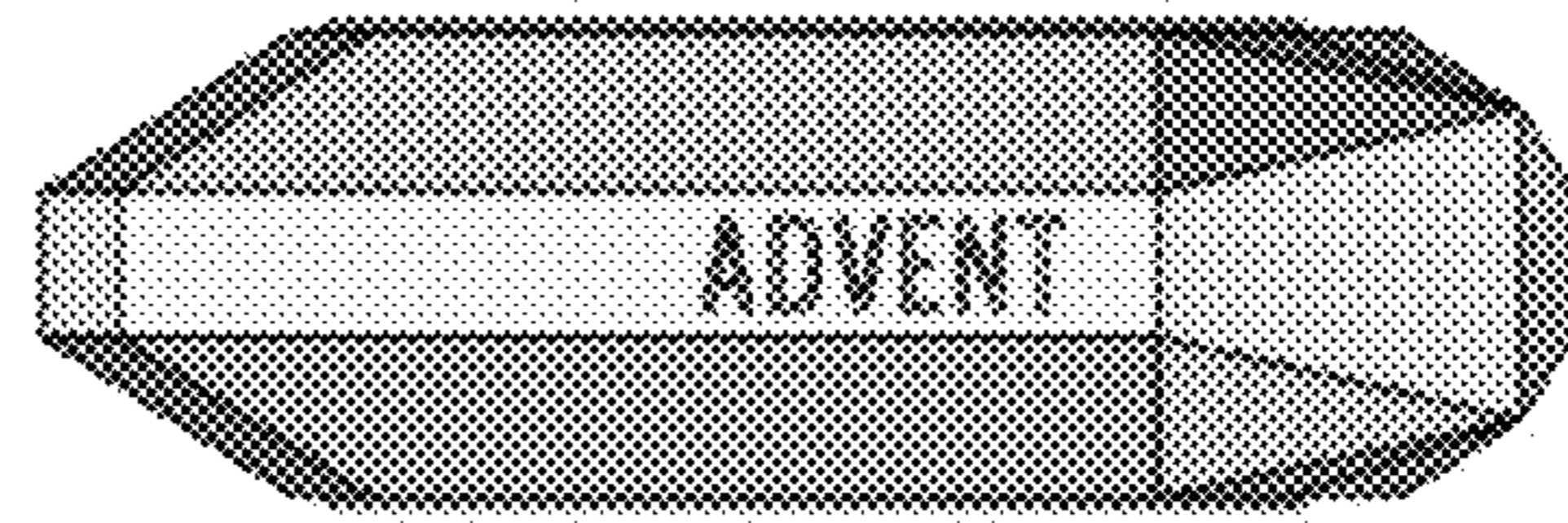
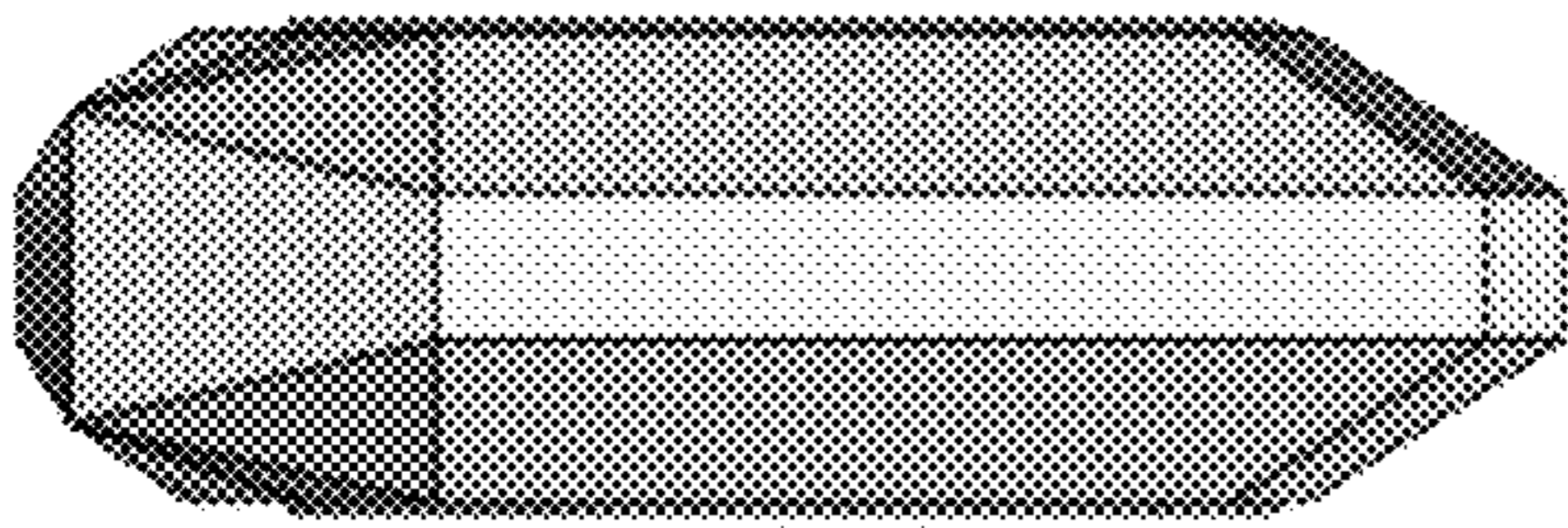

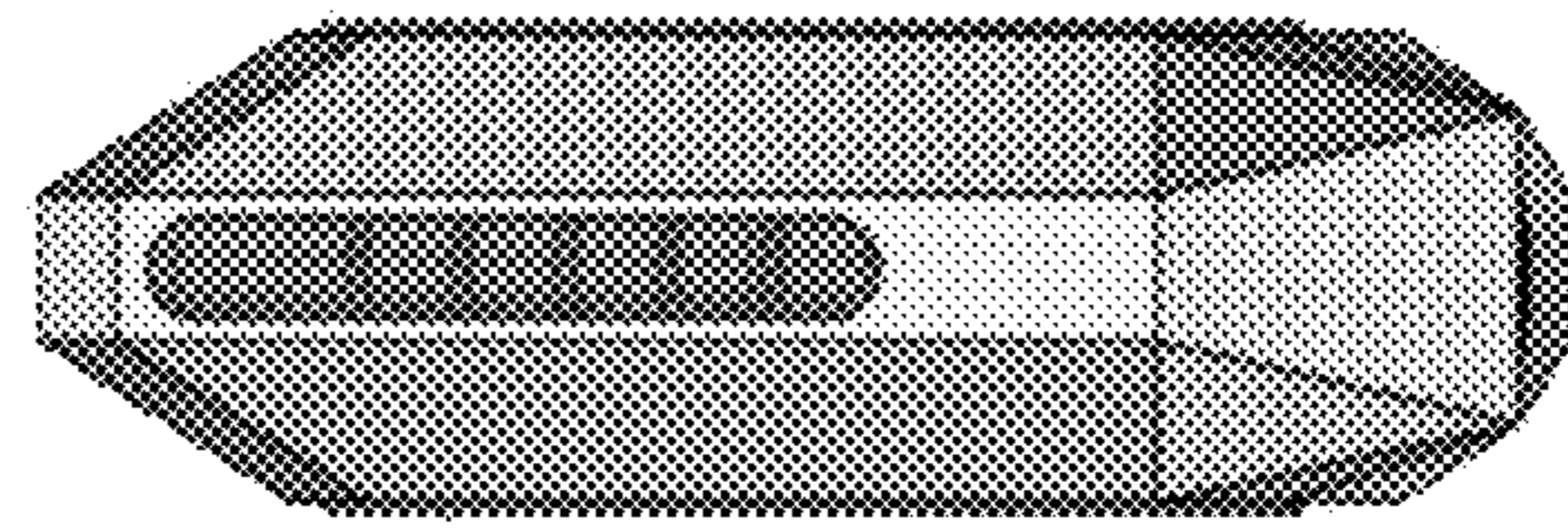
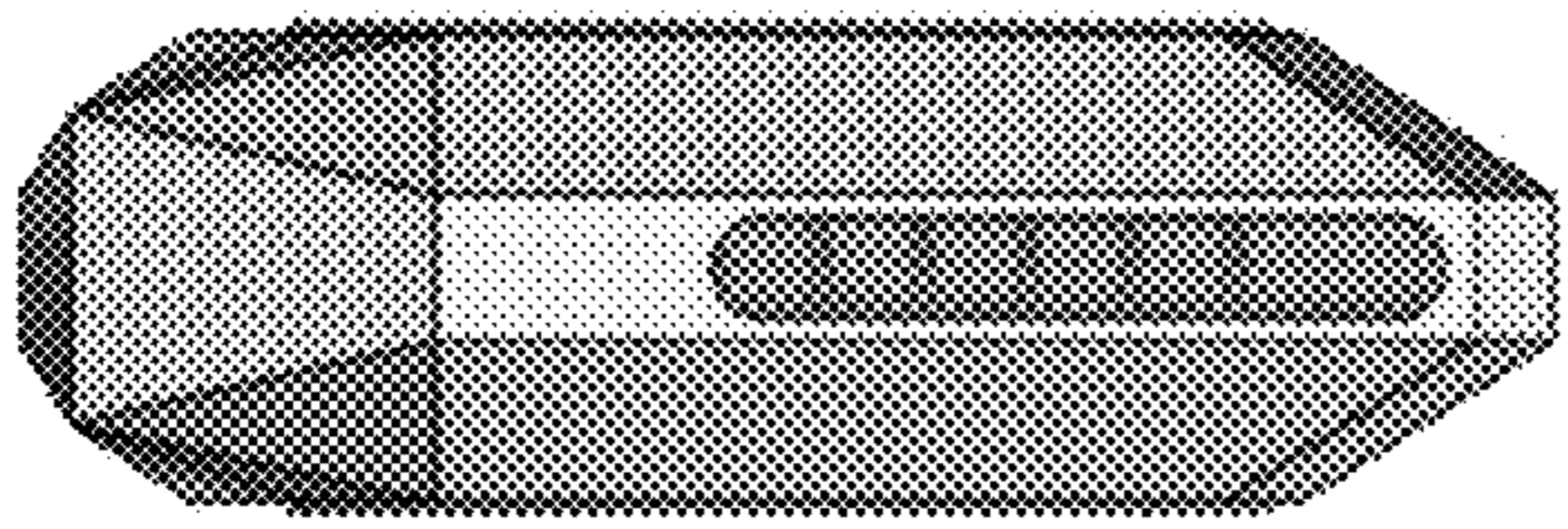

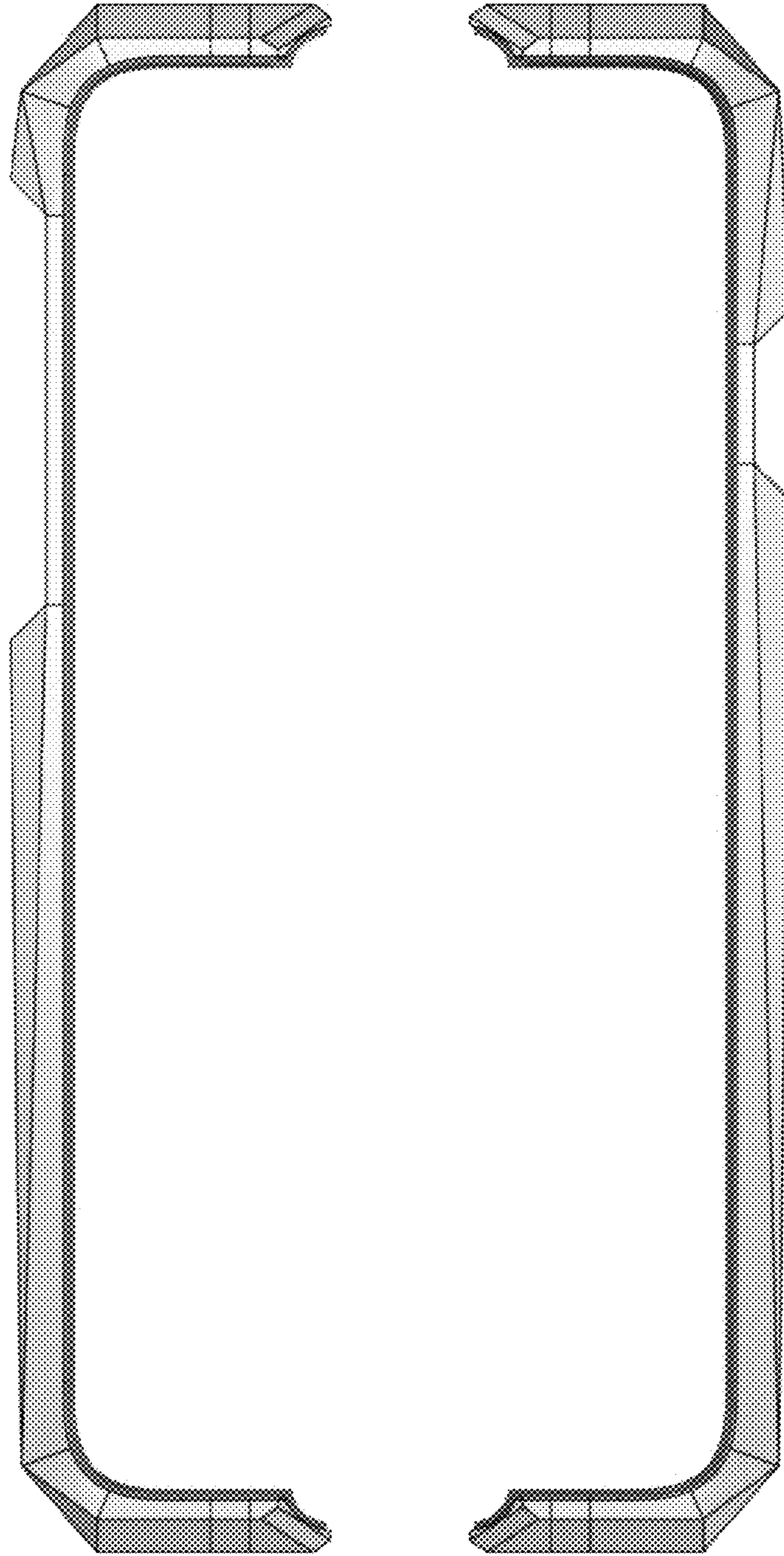
