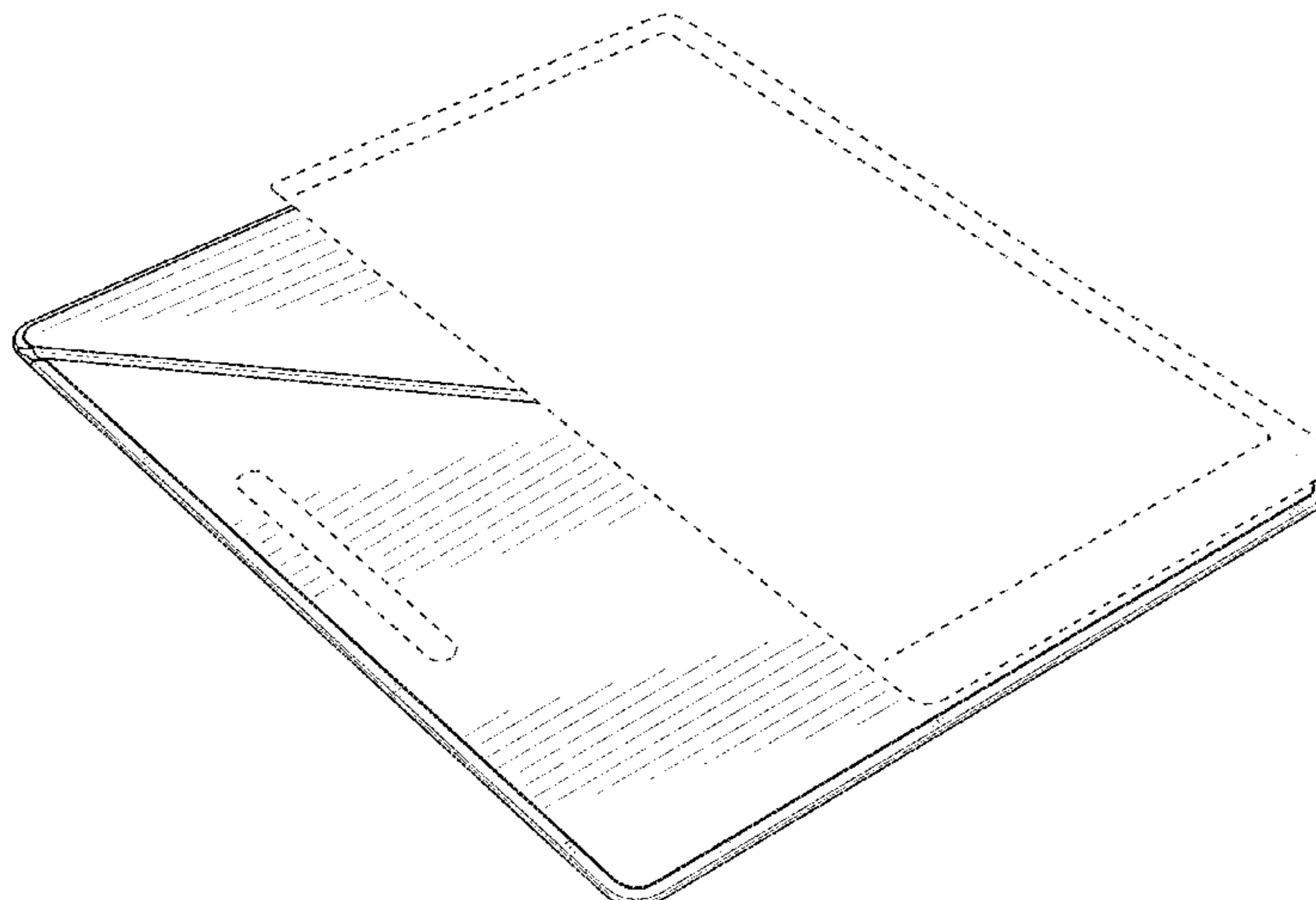
FIG. 1 is a back perspective view of an electronic device cover;

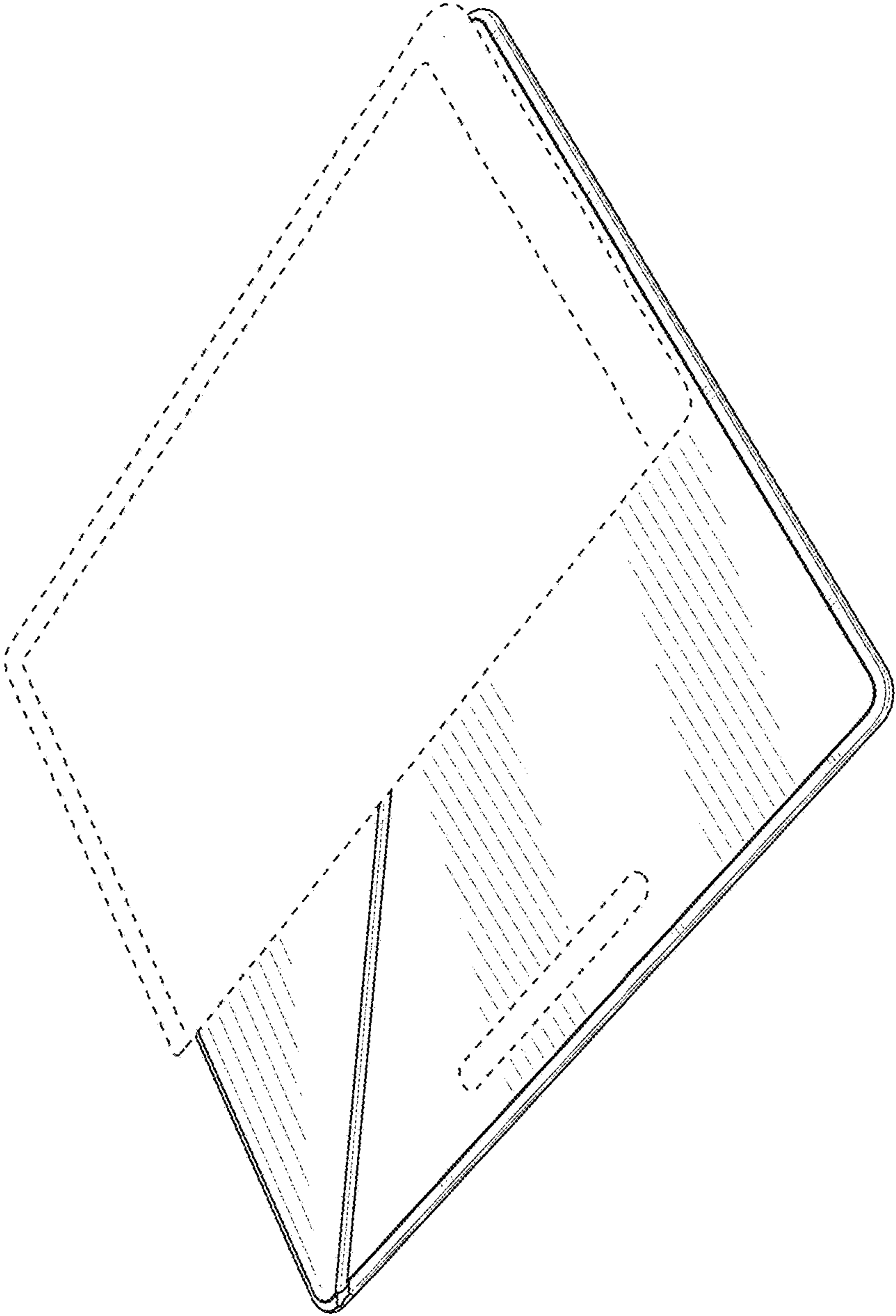

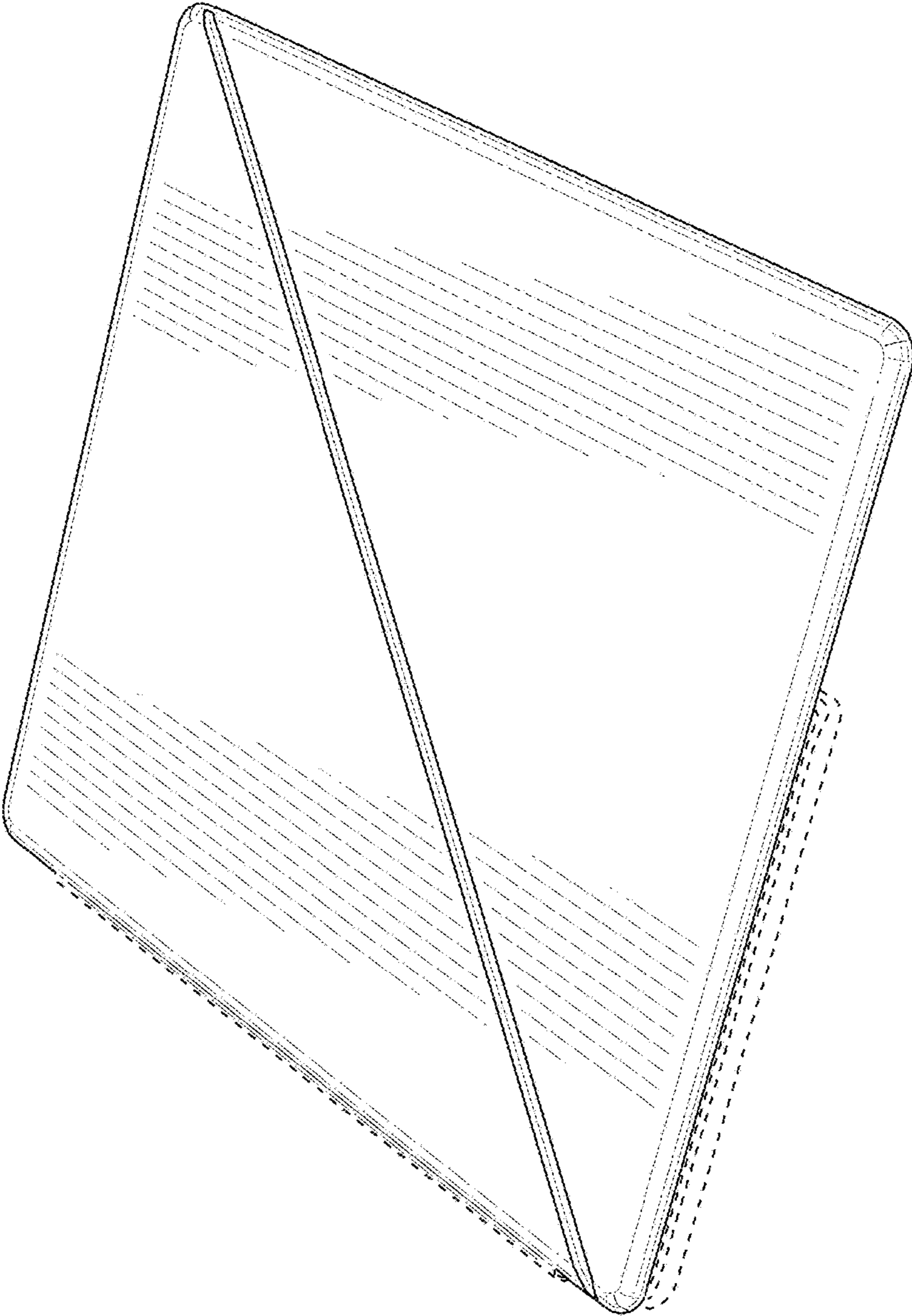

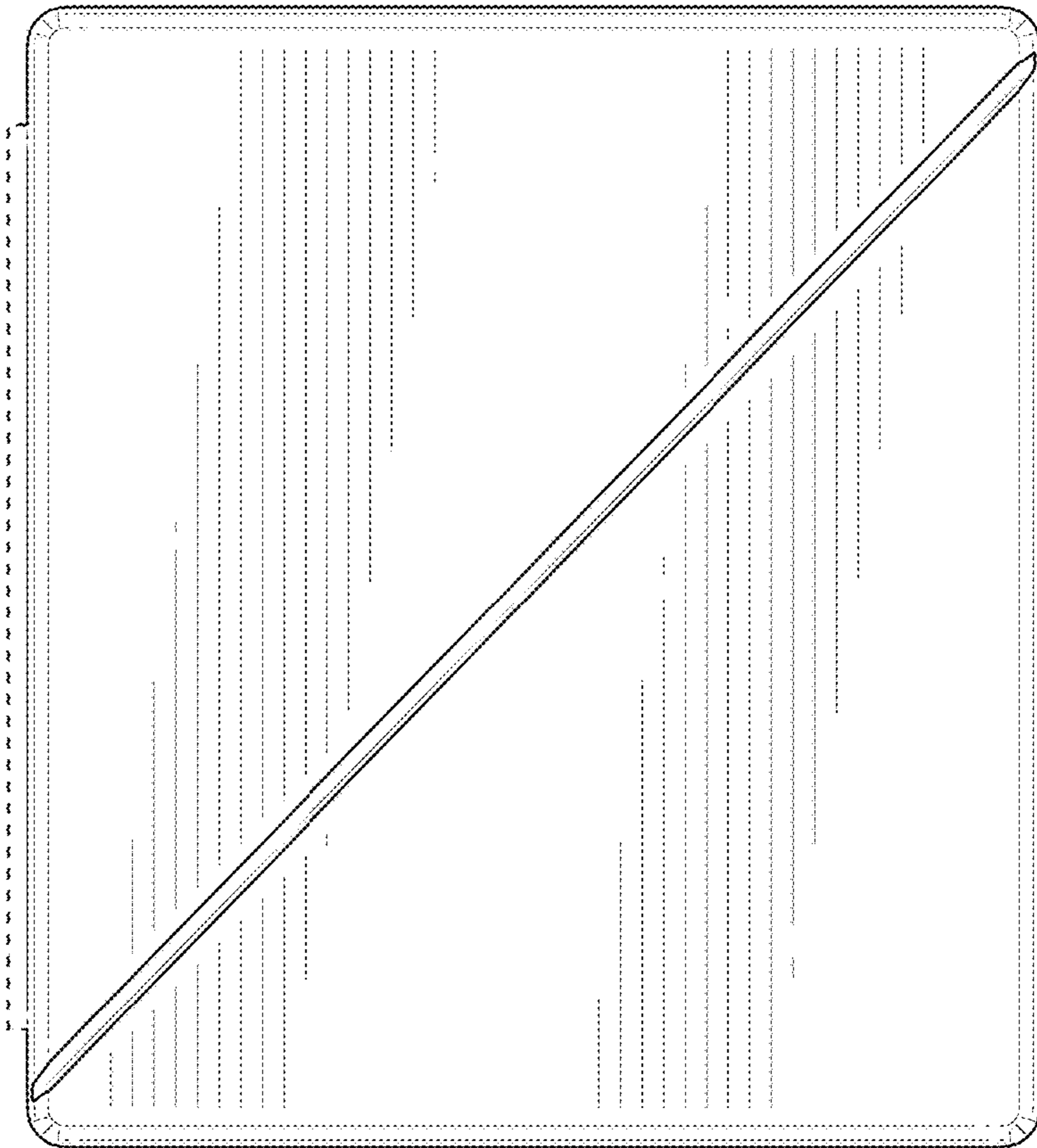

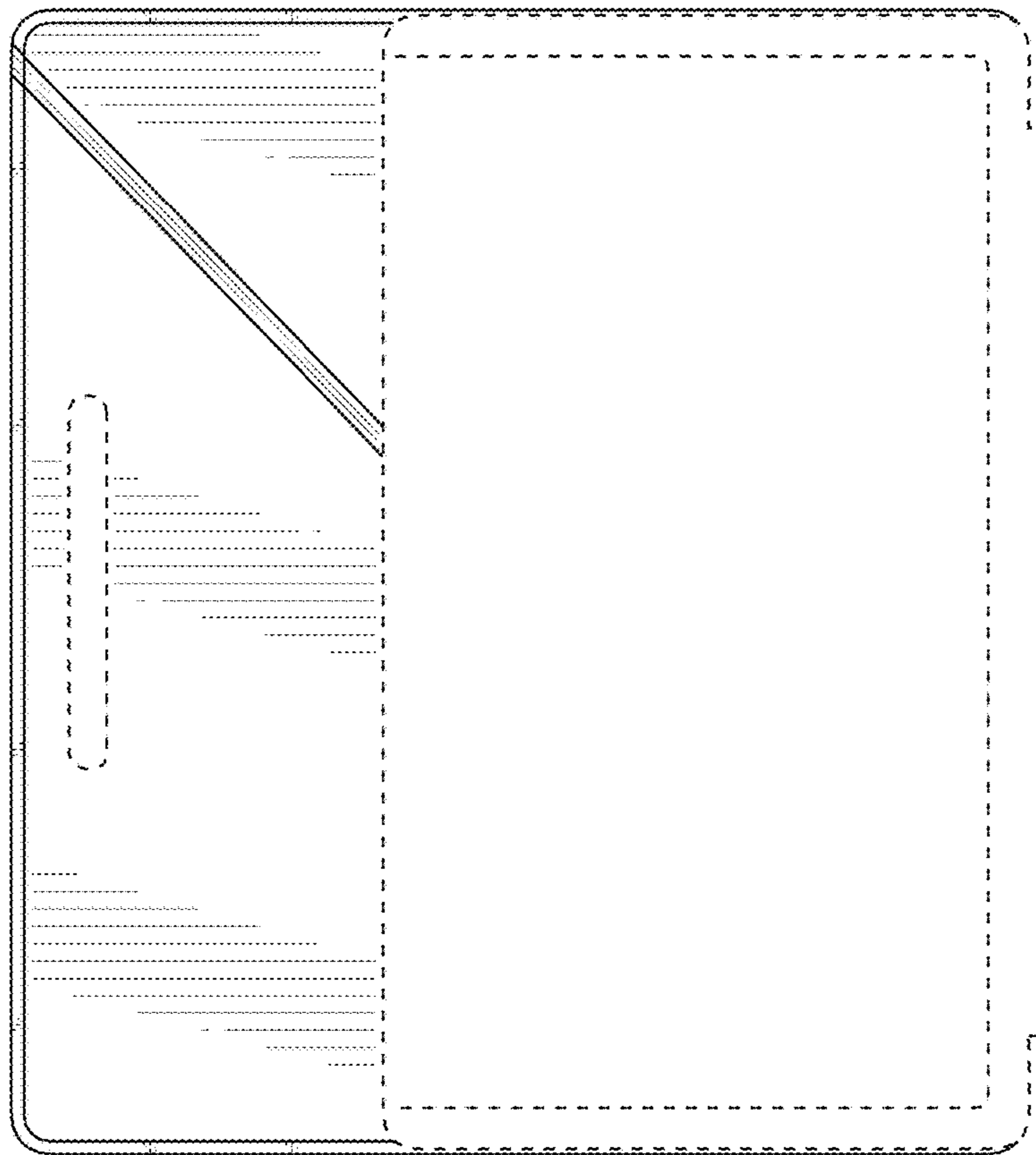

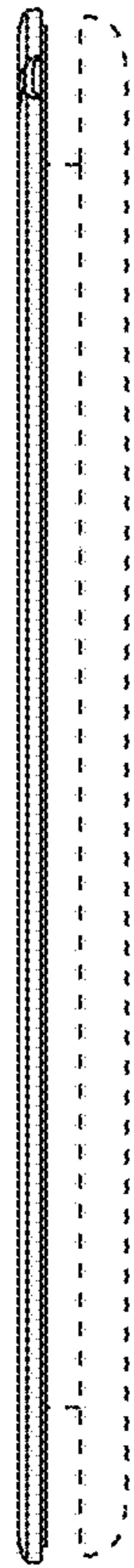

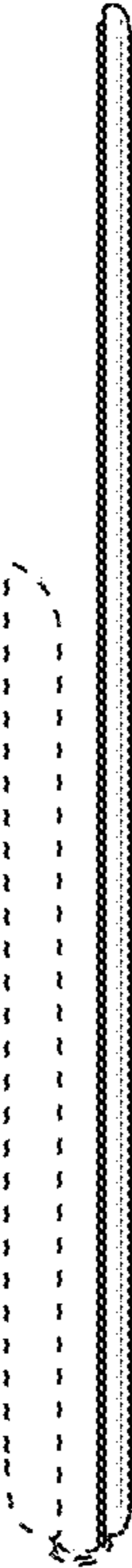

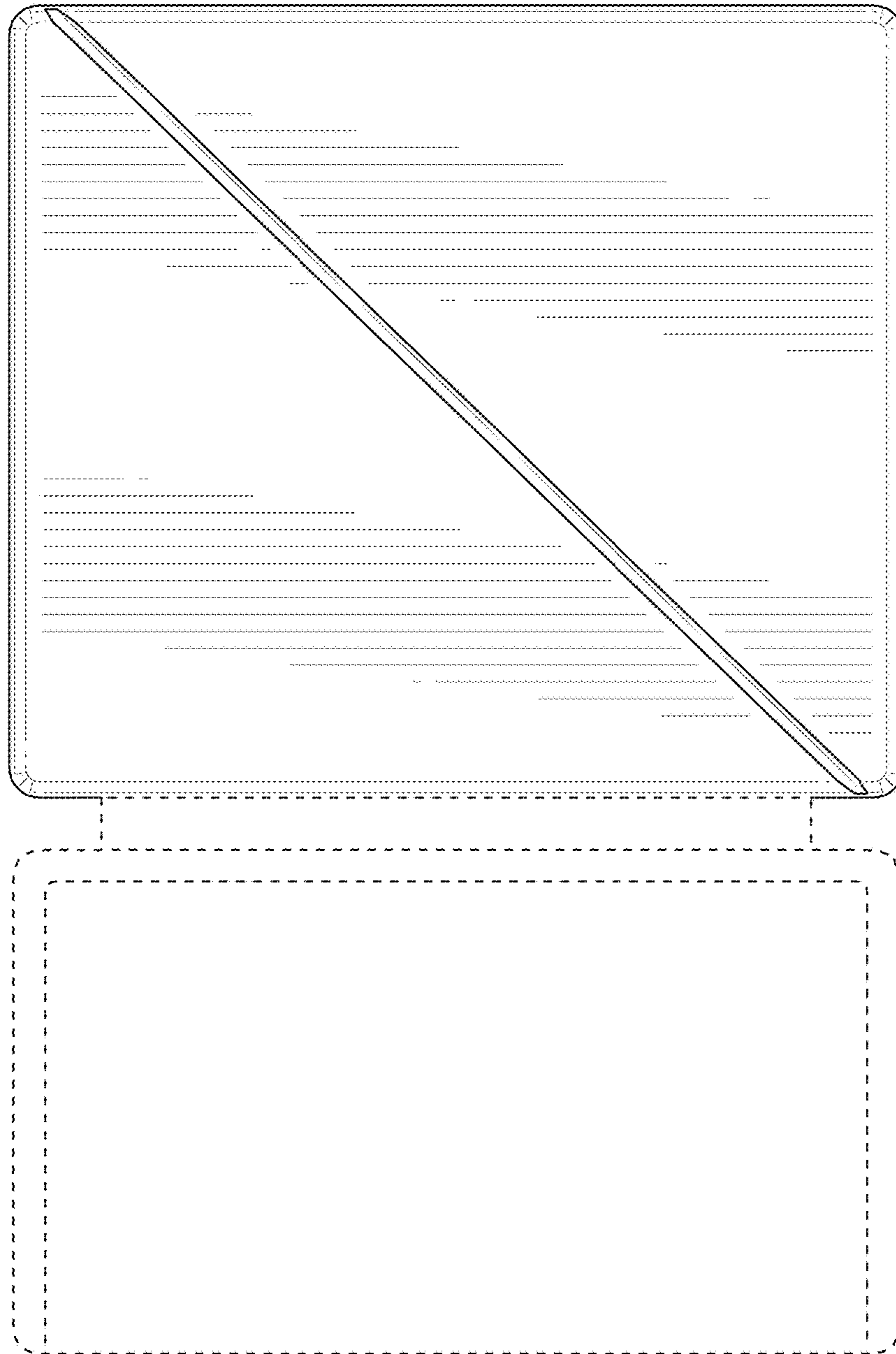

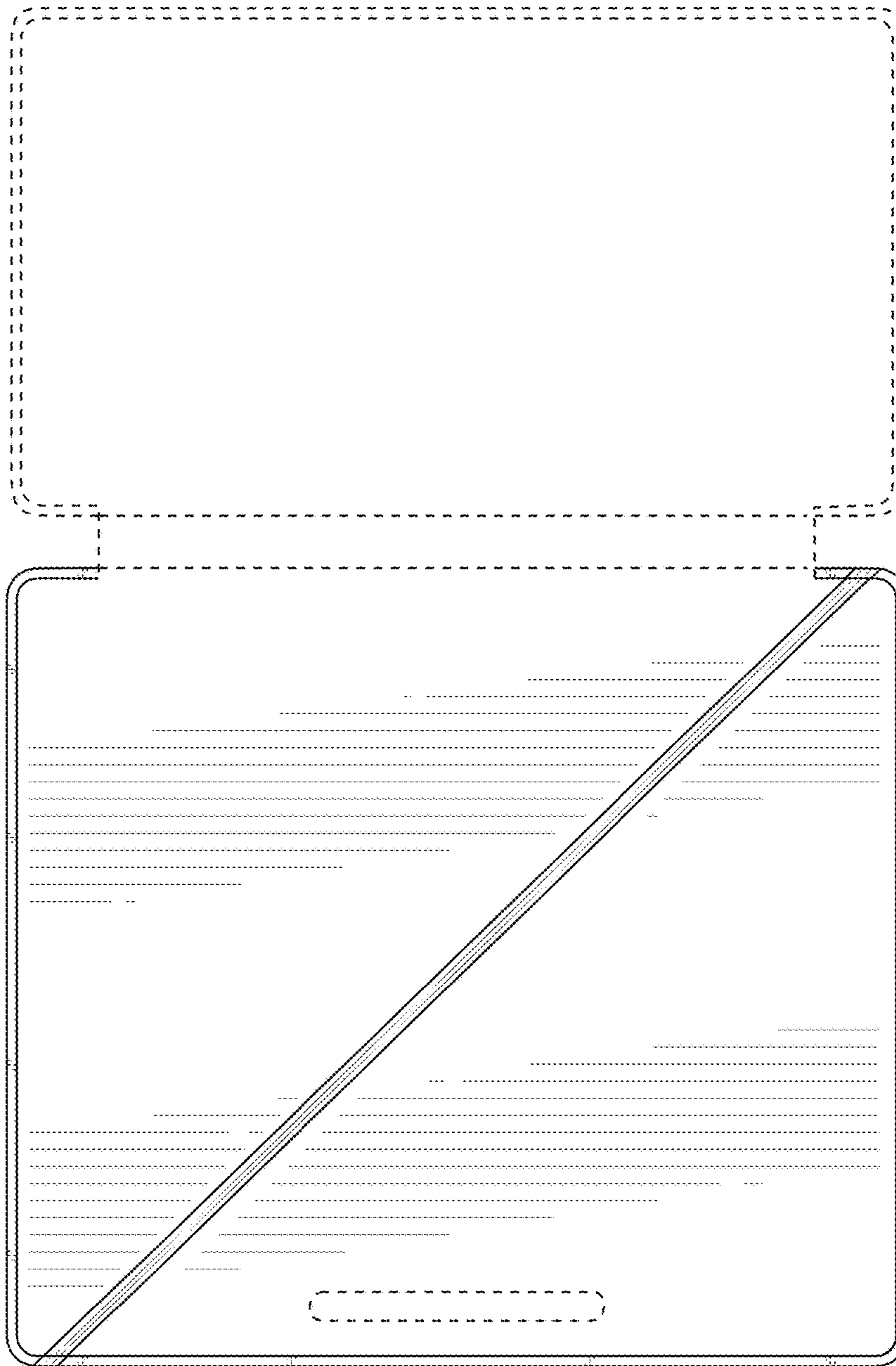
