(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

Fig. 1.1 is a front view of a display screen or portion thereof with graphical user interface according to a first embodiment of the claimed design;

Fig. 1.2 is a front view of a display screen or portion thereof with graphical user interface according to a second embodiment of the claimed design; and,

Fig. 1.3 is a front view display screen or portion thereof with graphical user interface according to a third embodiment of the claimed design.

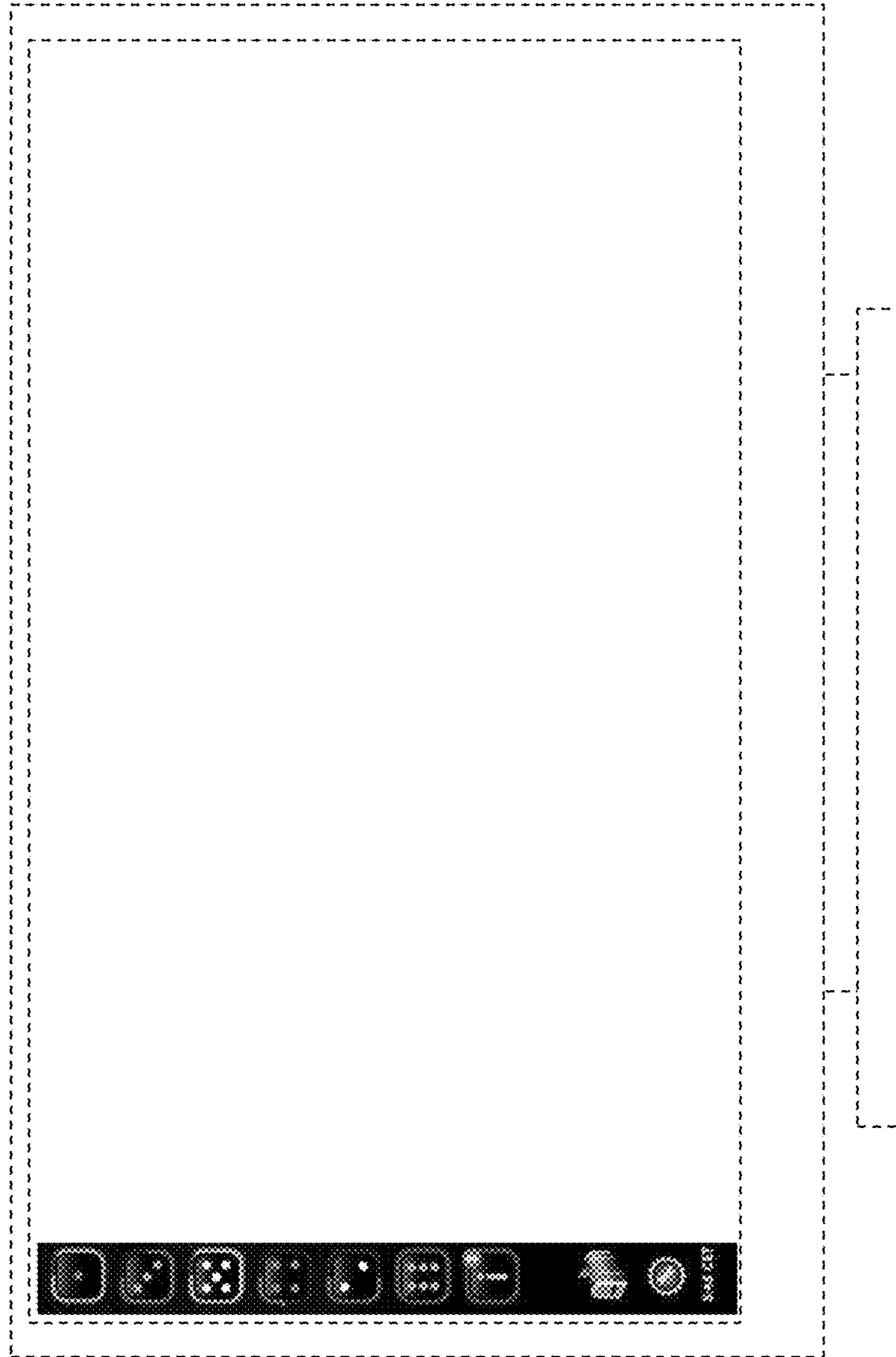

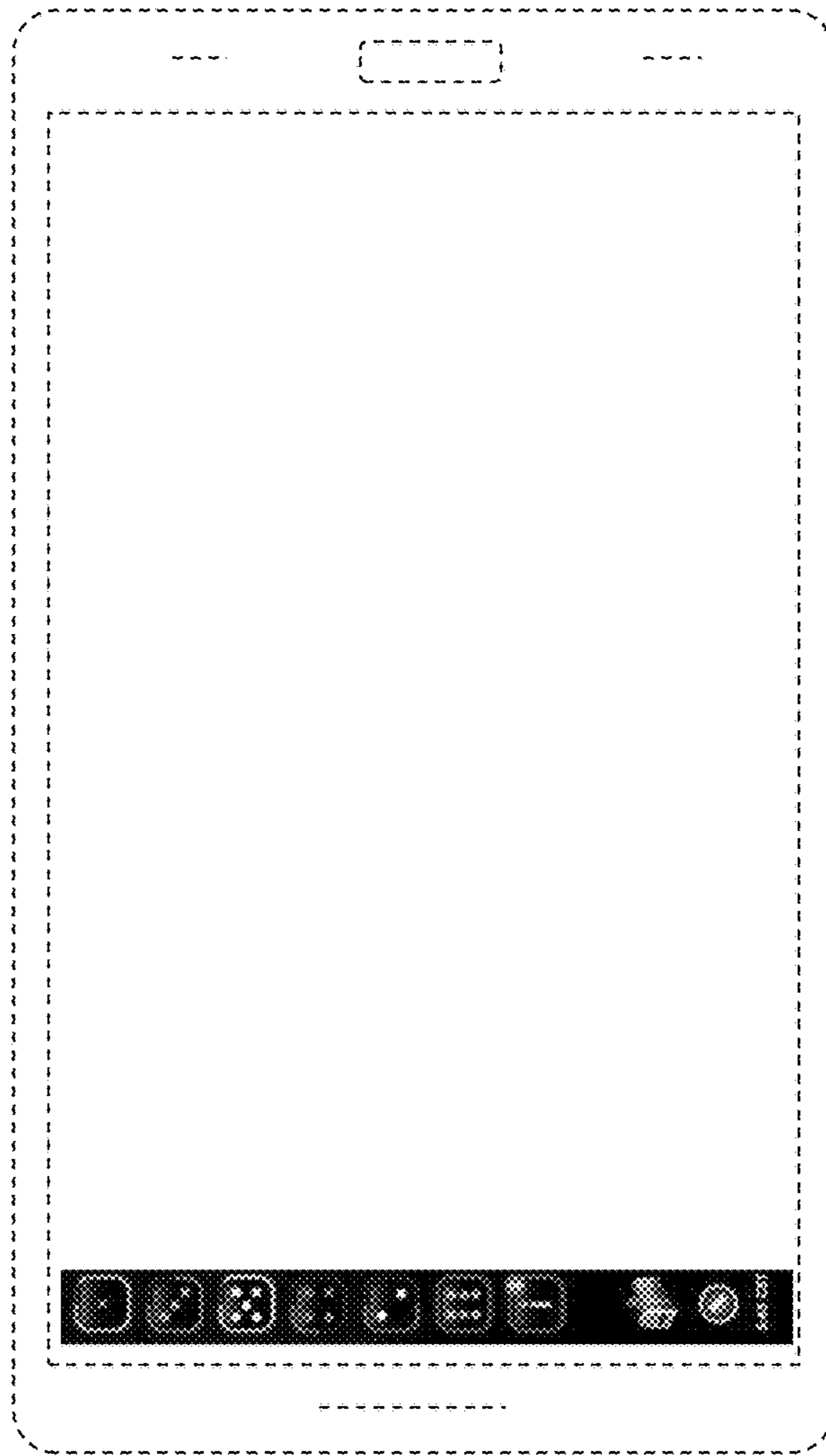

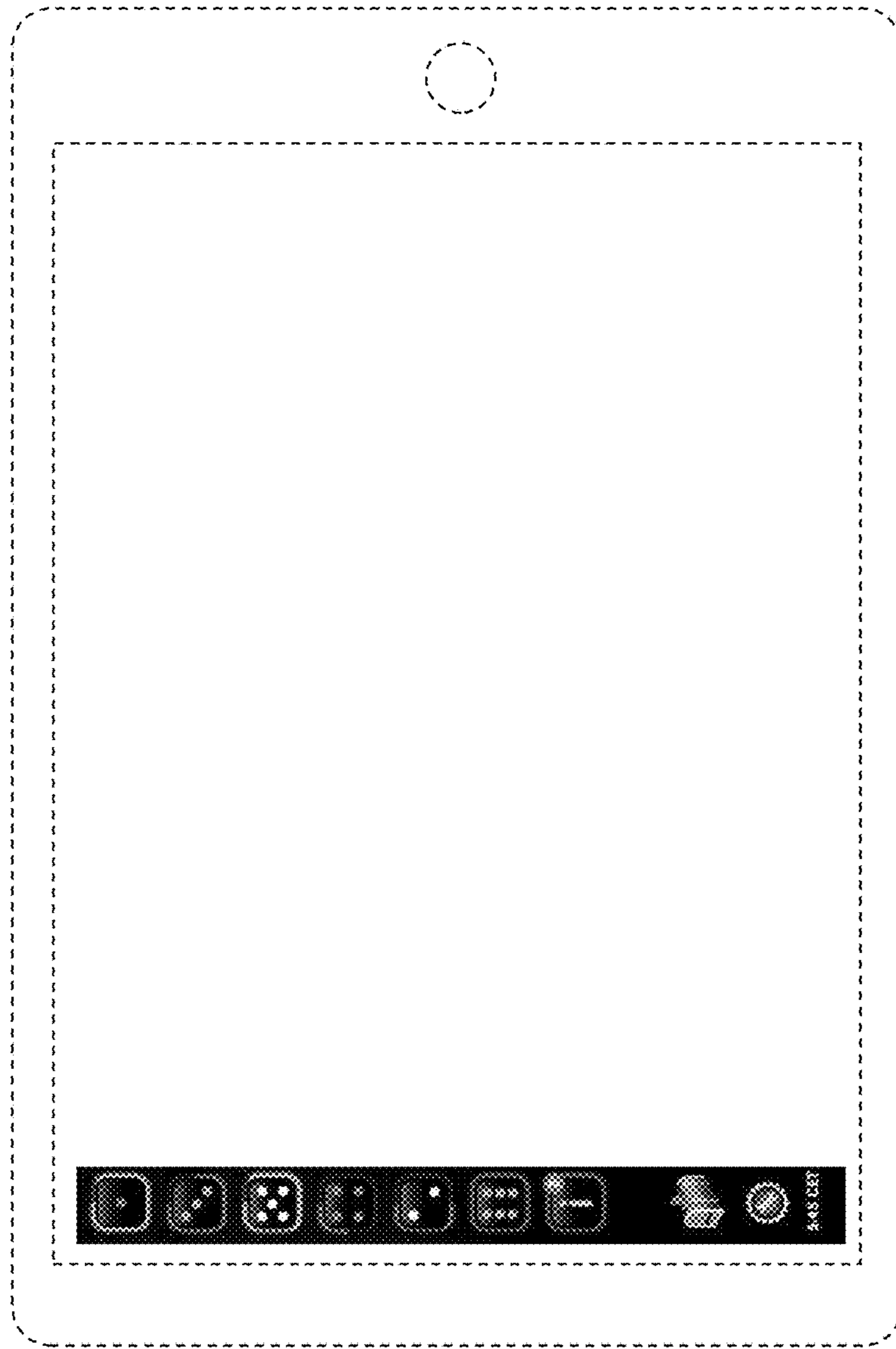
