FIG. 13 is the seventh image thereof;

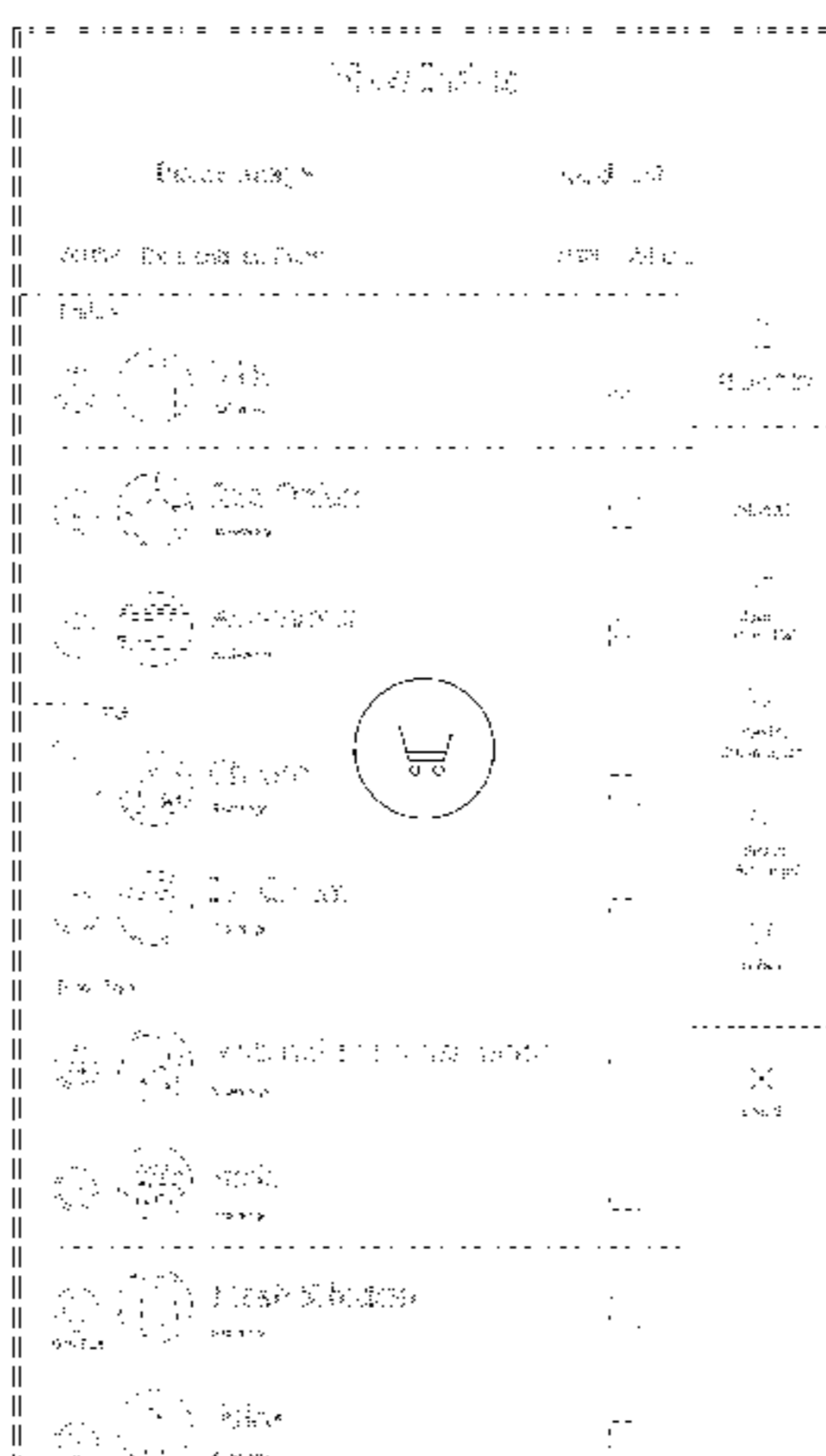
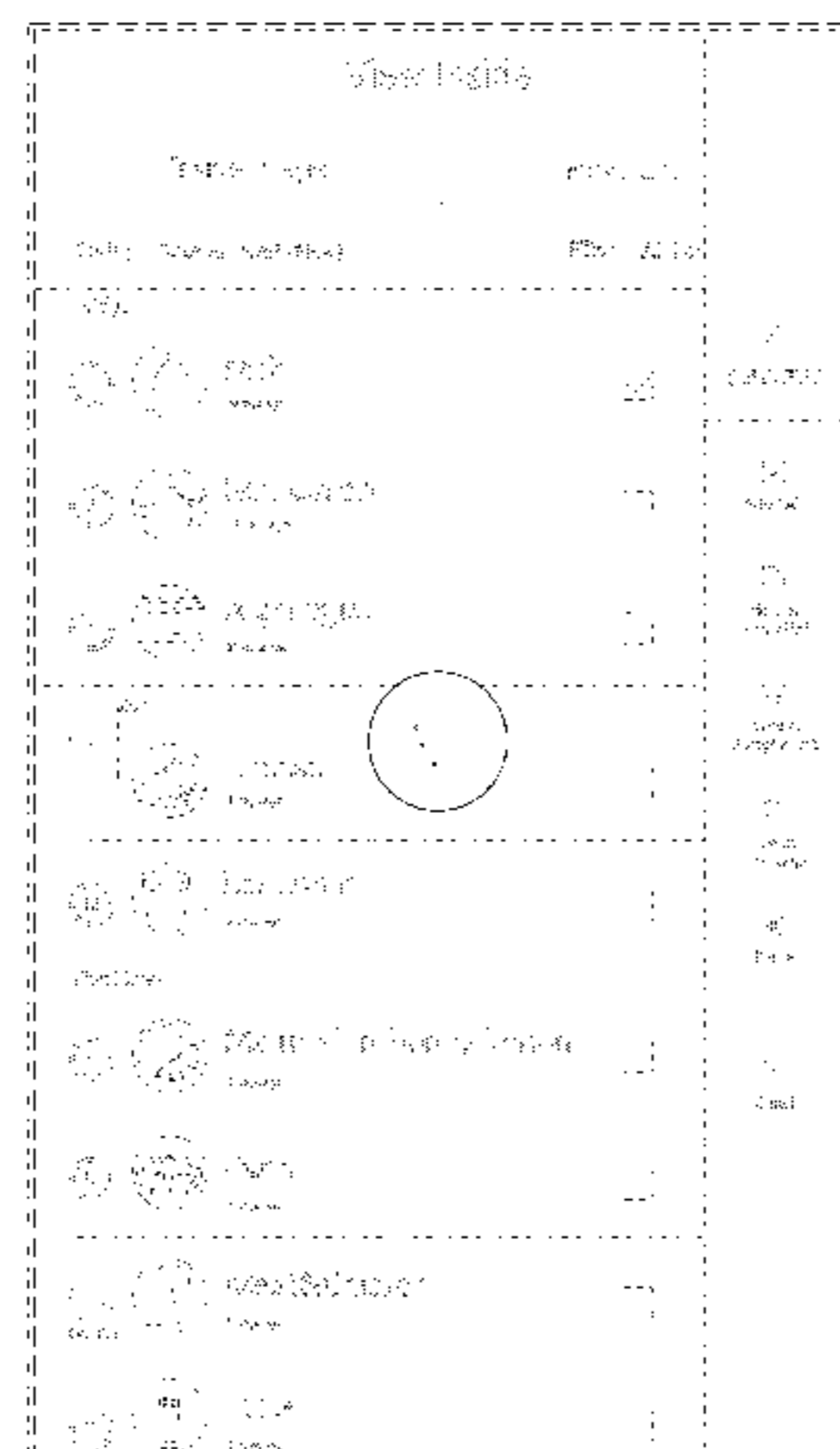
FIG. 14 is the eighth image thereof;

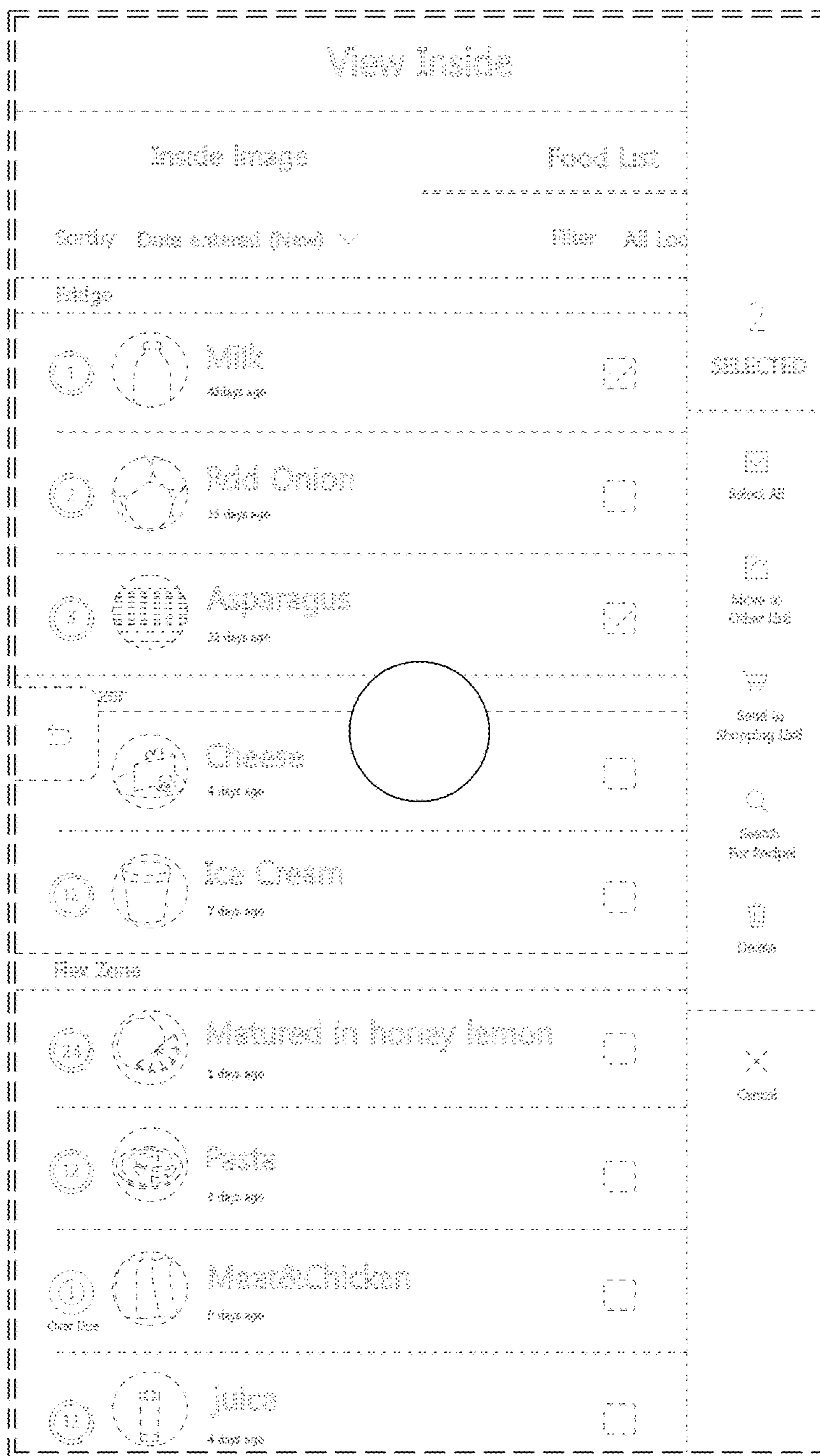

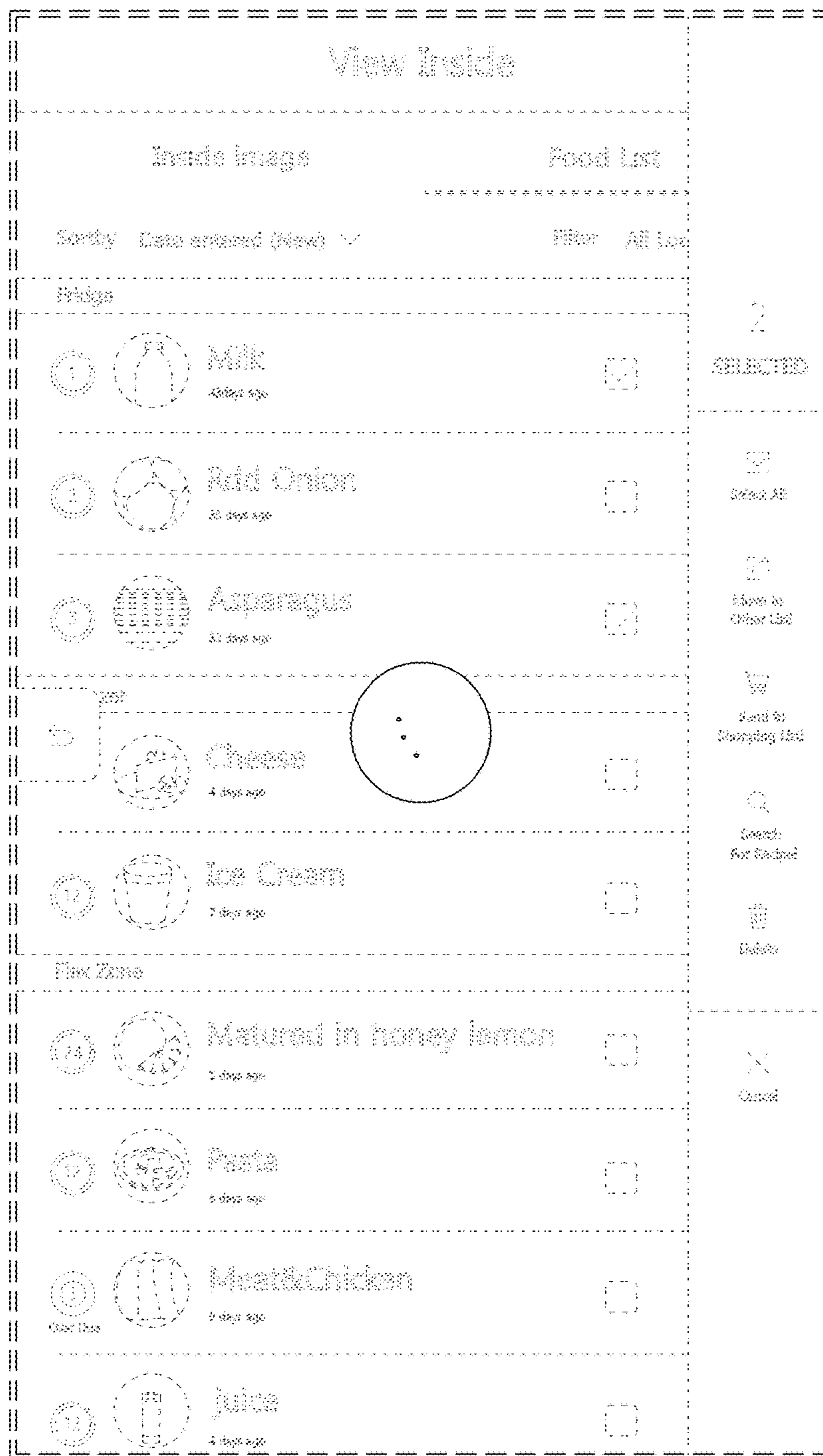

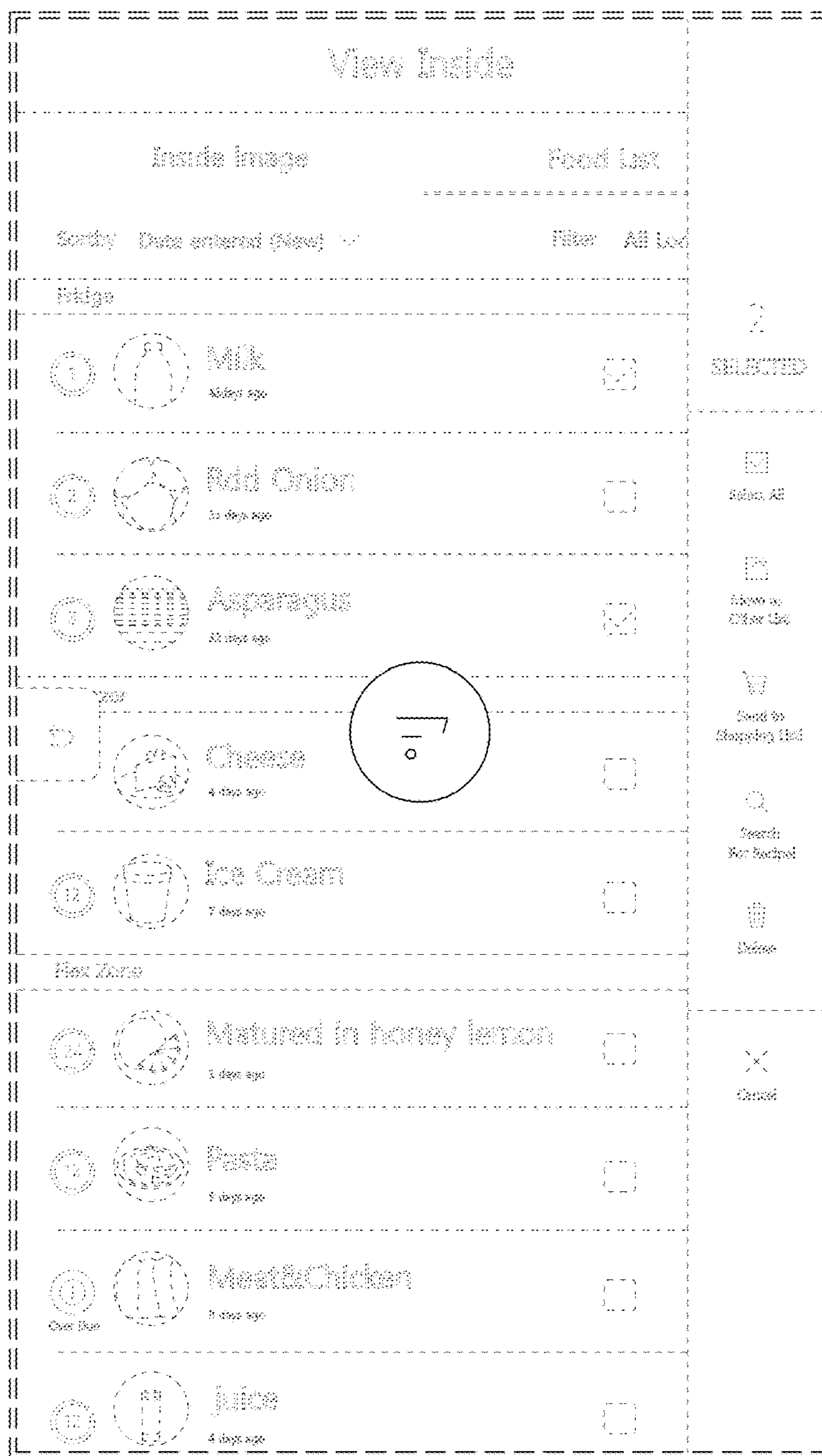

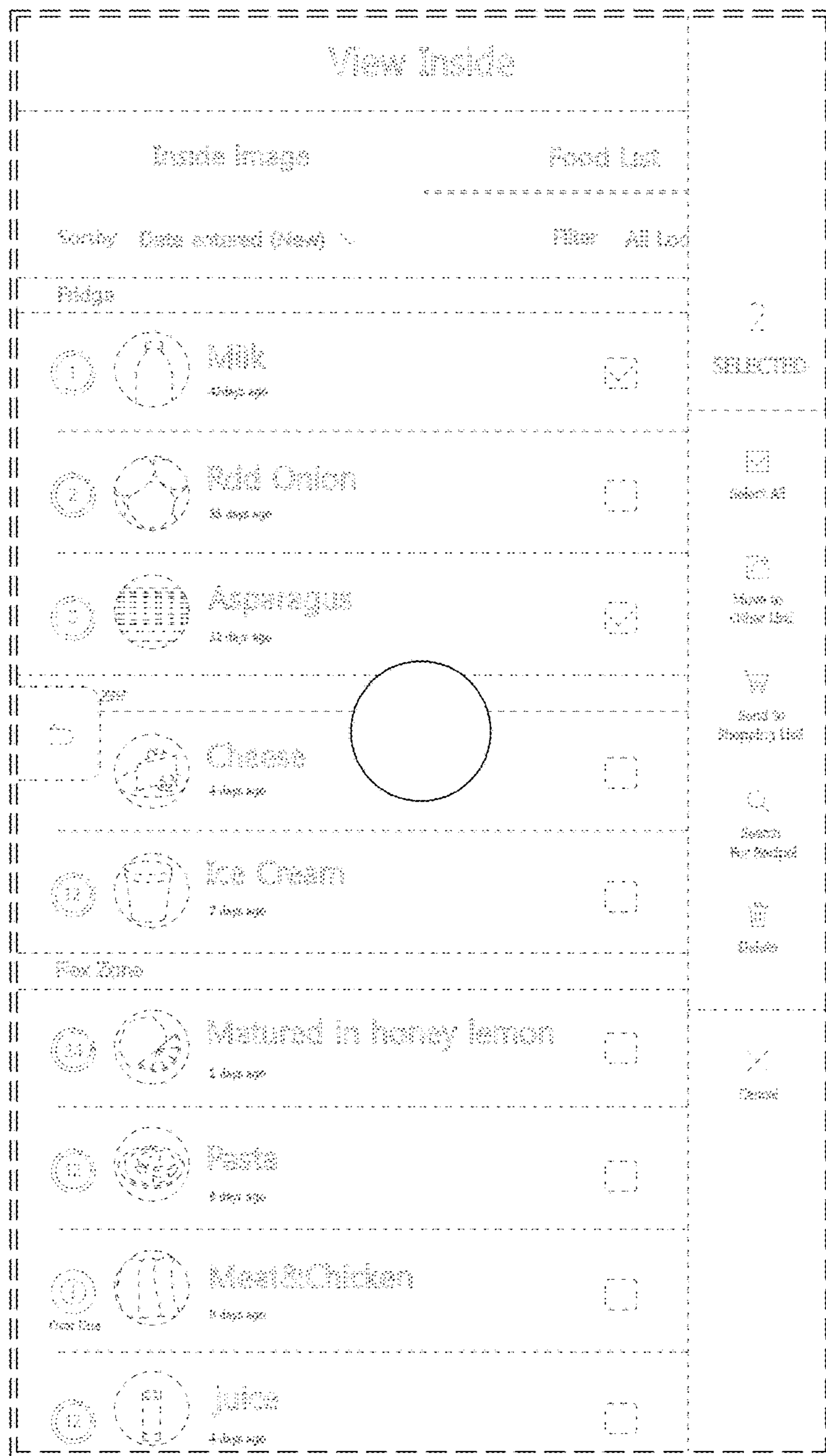

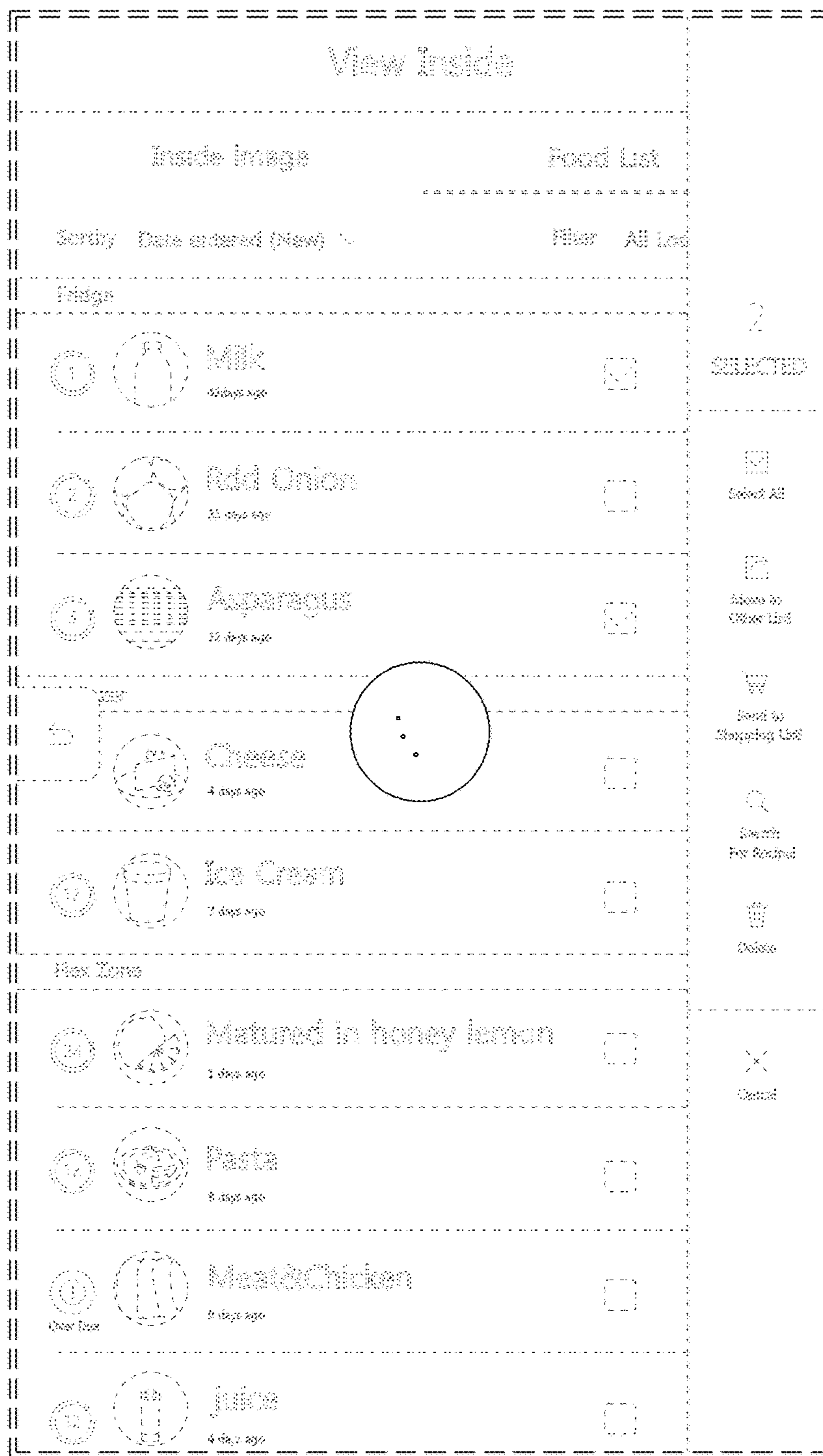

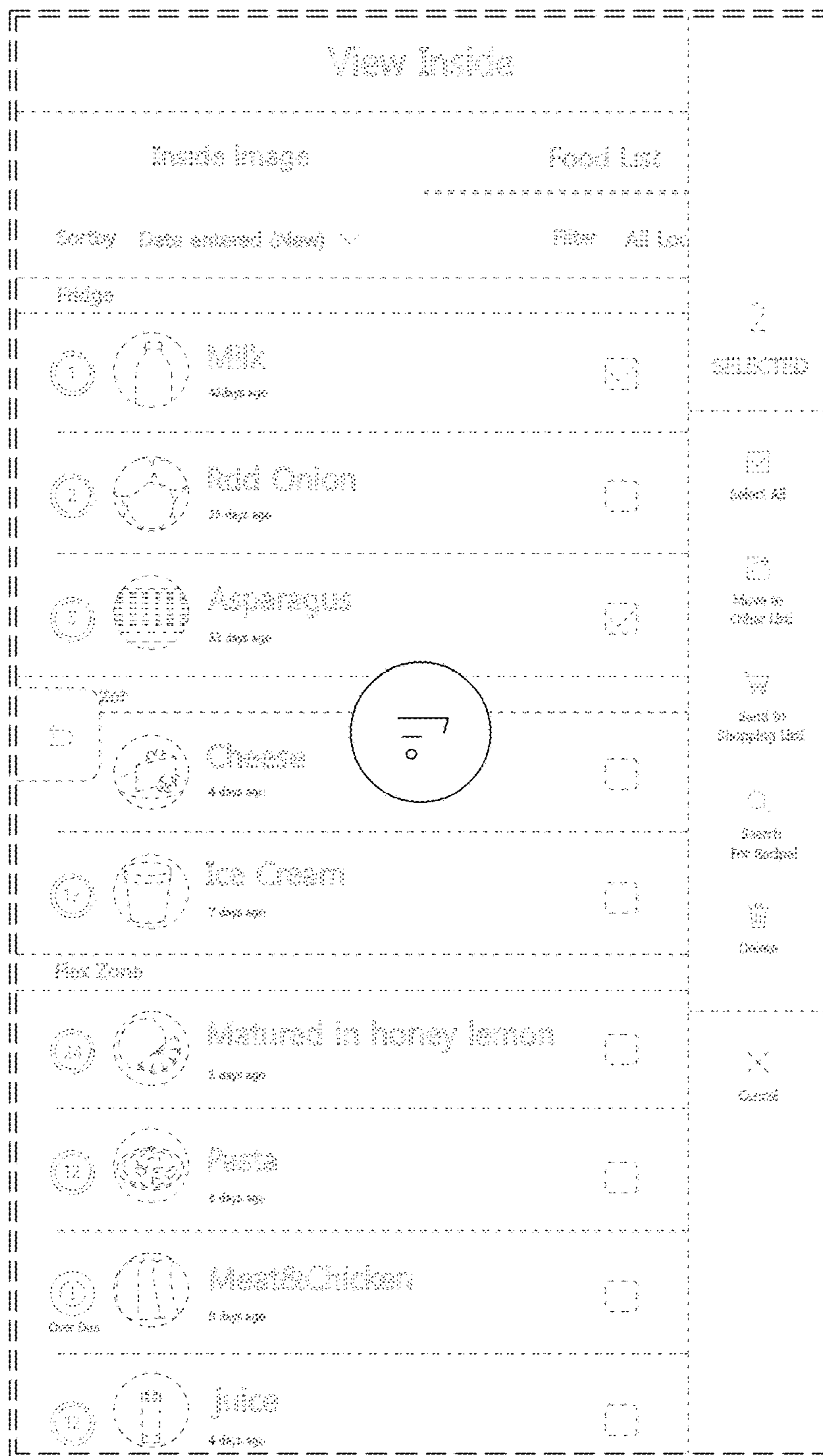

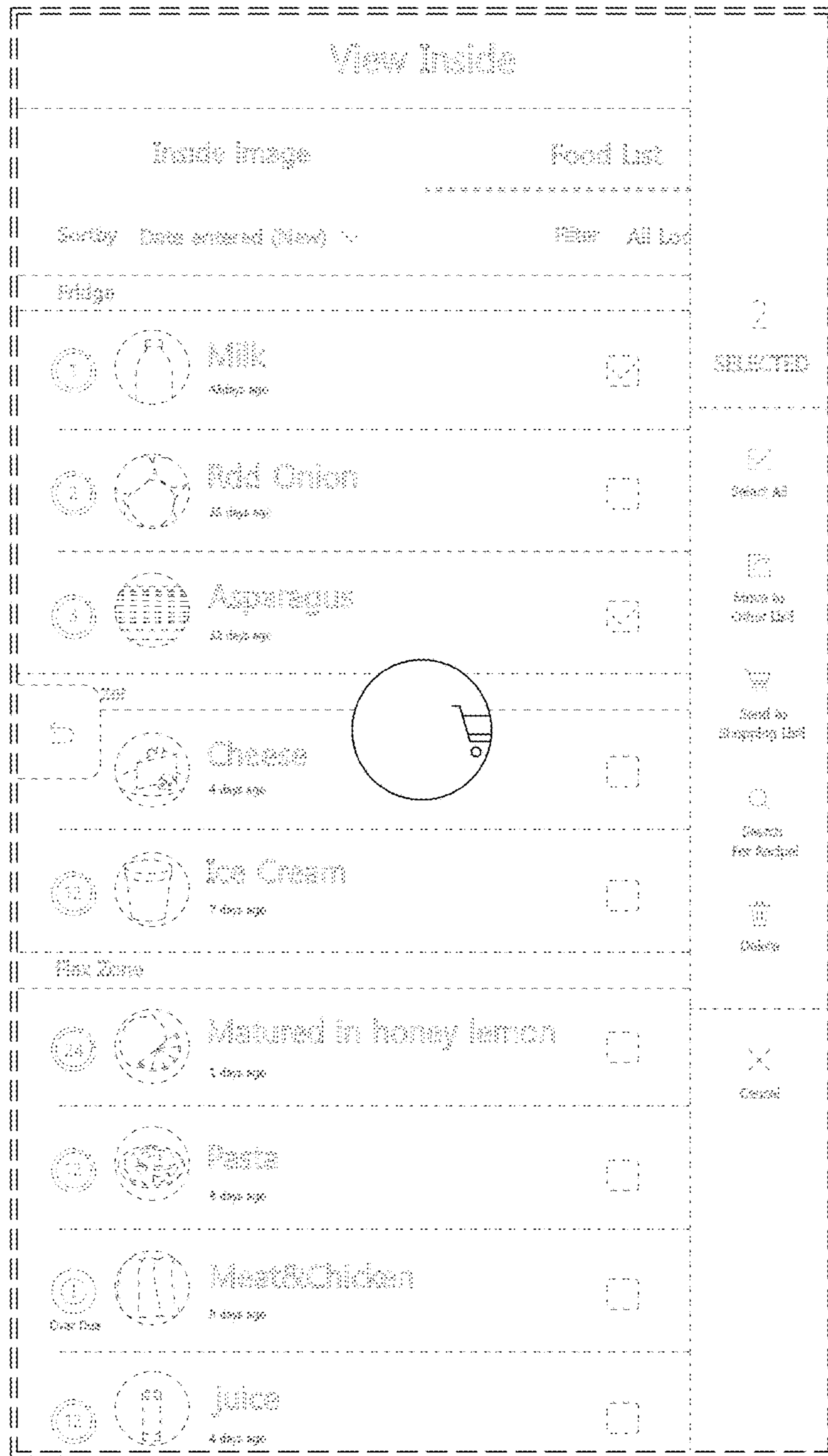
