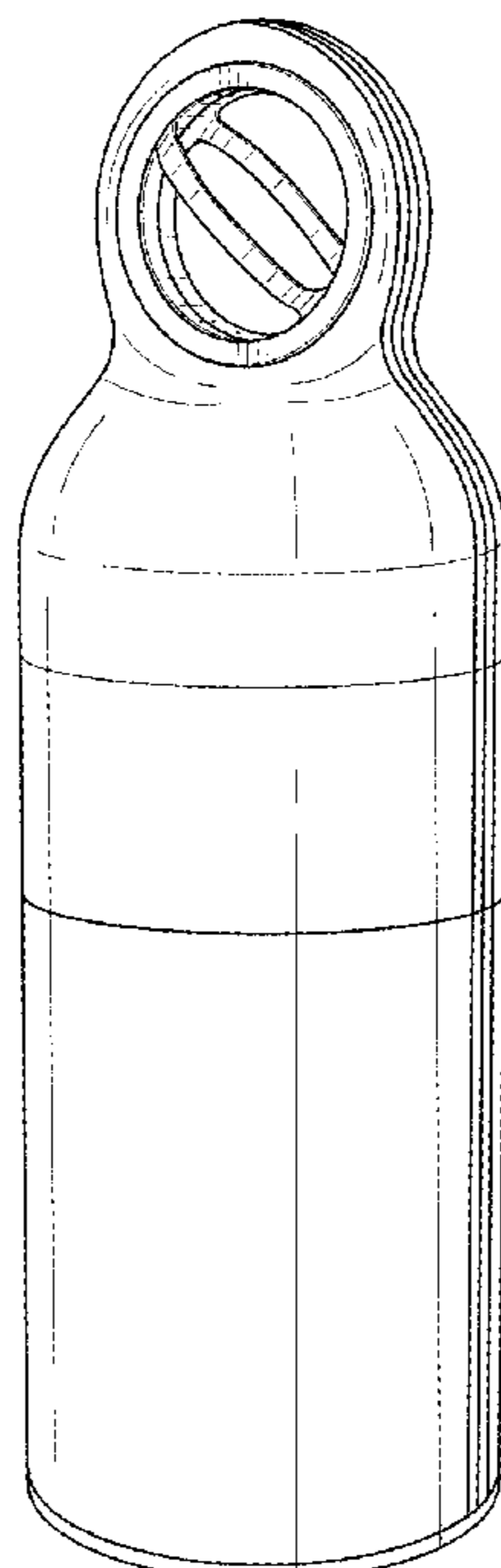
(57) **CLAIM**

The ornamental design for a fire prevention kit, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of the fire prevention kit showing my new design;
FIG. 2 is a left side perspective elevational view thereof;
FIG. 3 is a top plan view thereof when the upper half portion of the kit is disposed at its closed position;
FIG. 4 is a top perspective view thereof when the upper half portion of the kit is disposed at its open position; and,
FIG. 5 is a bottom plan view thereof.

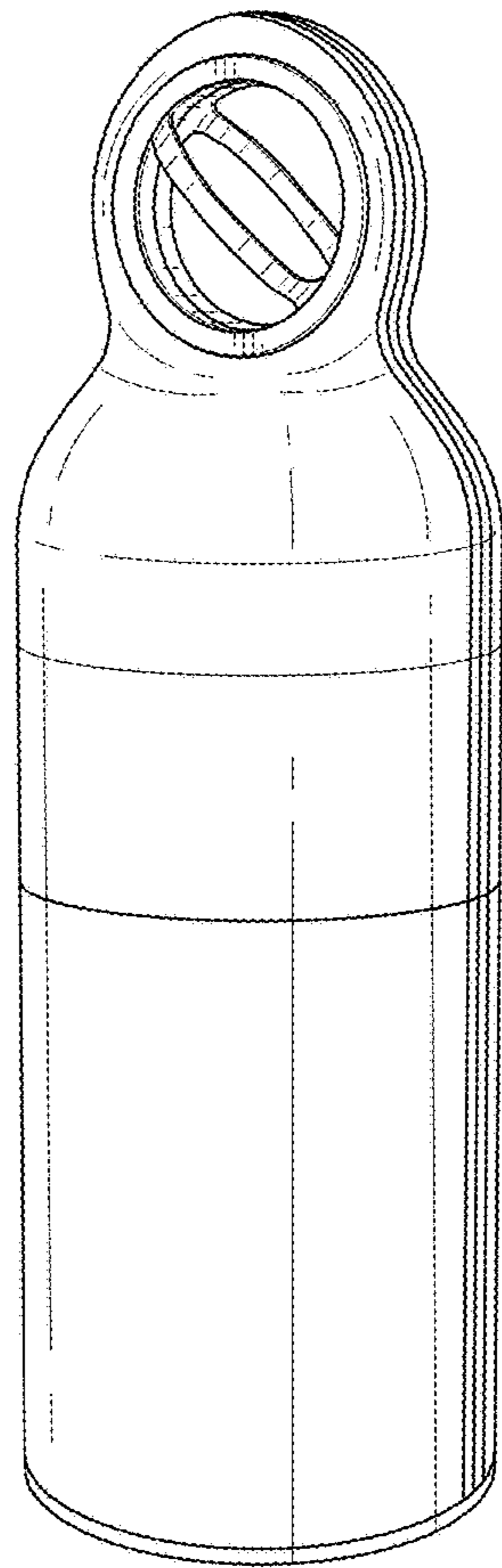

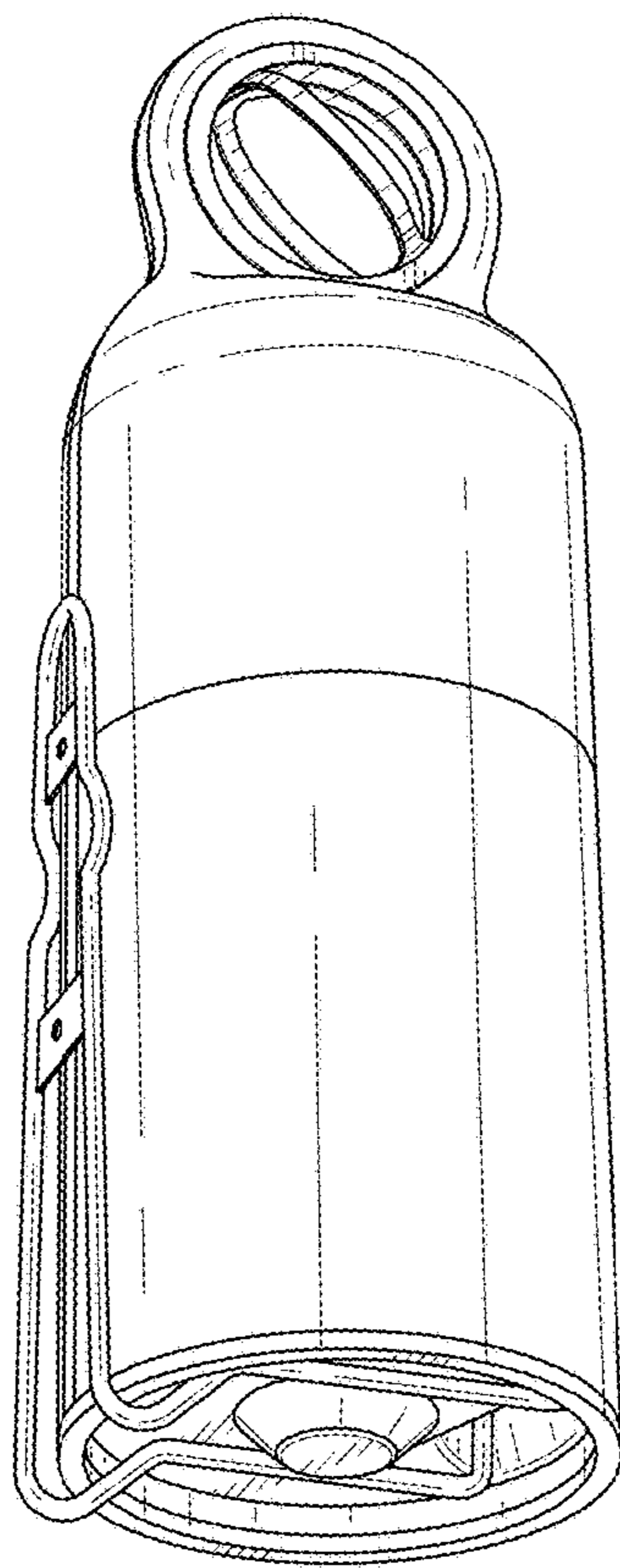

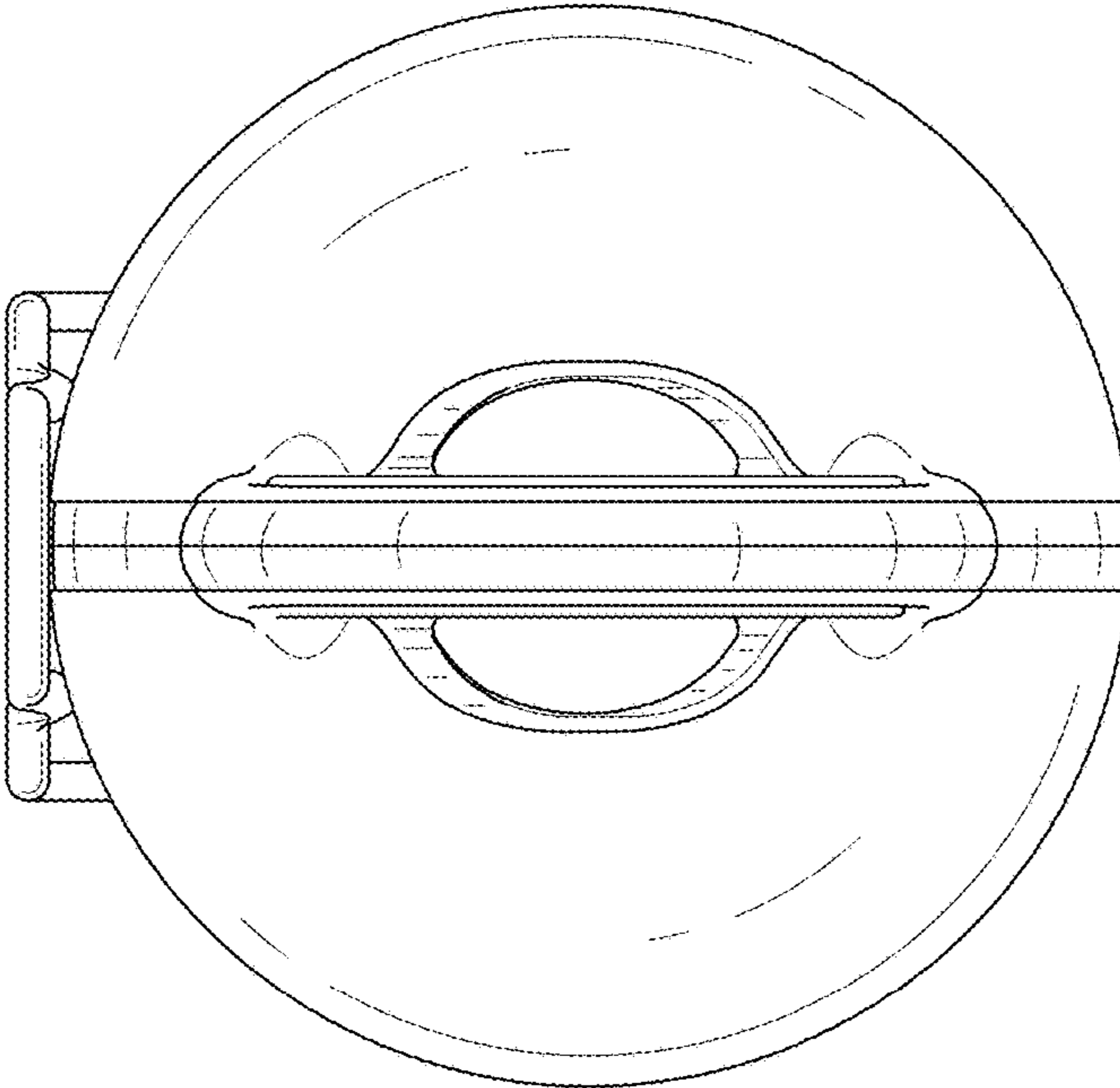

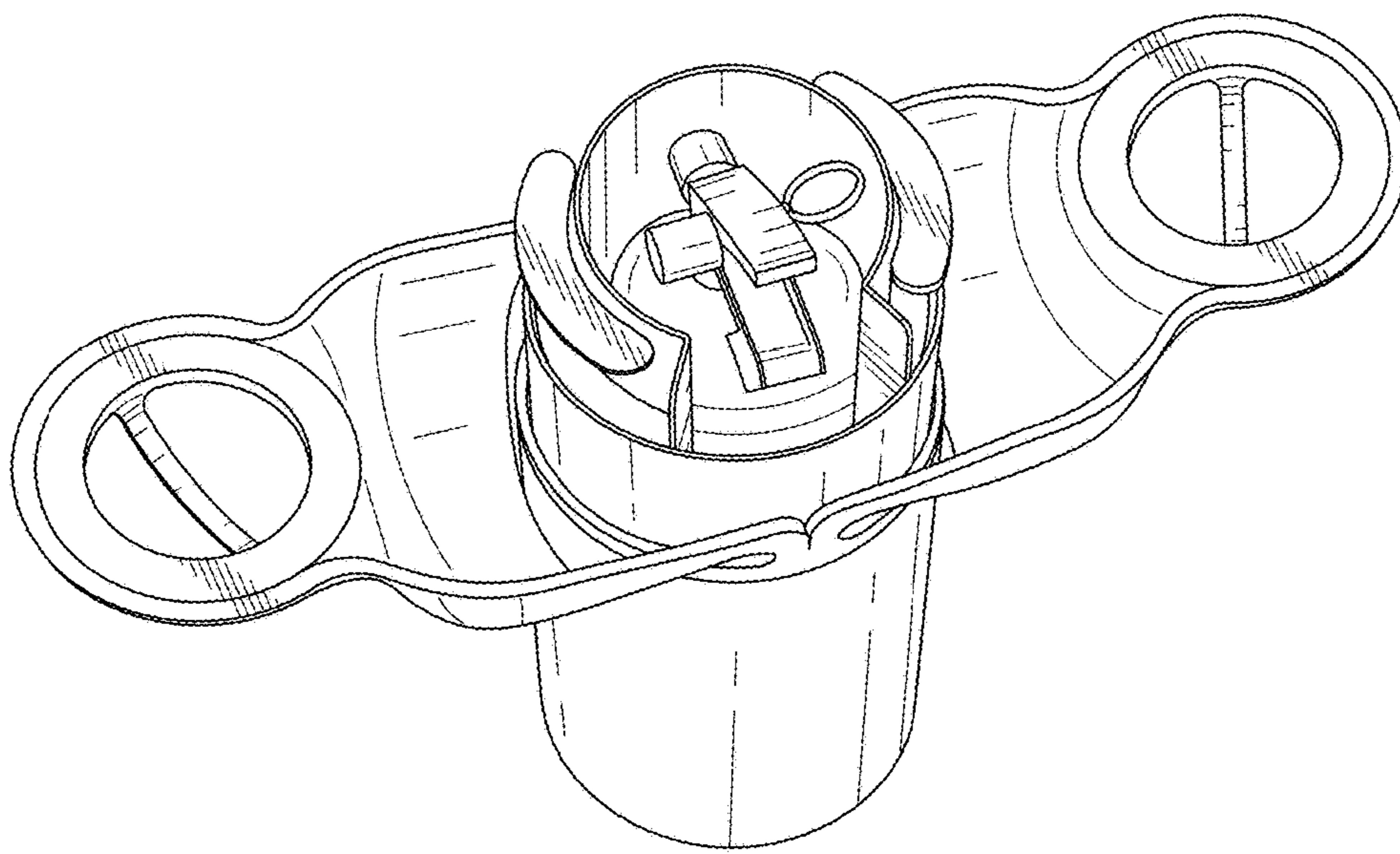

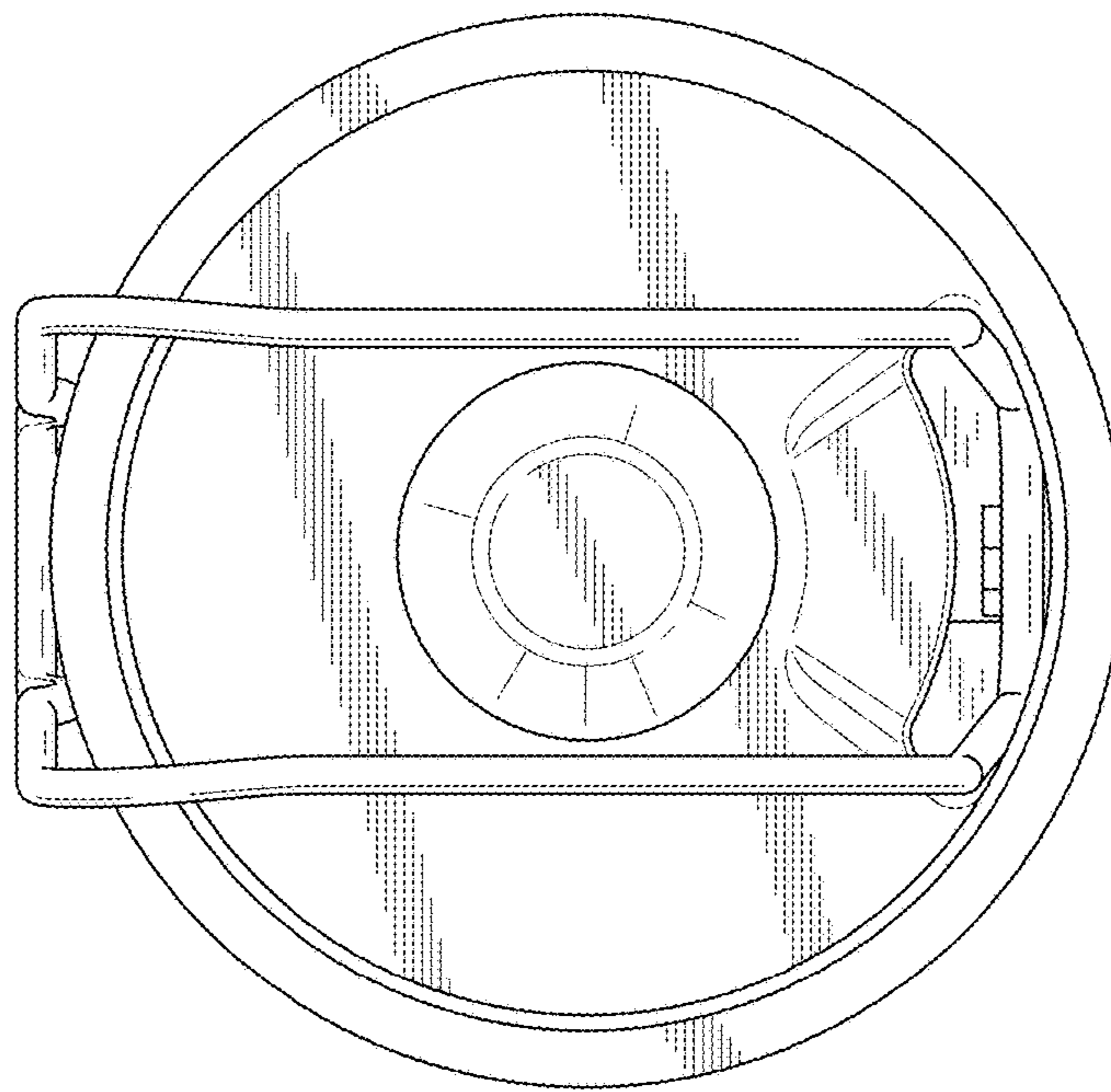
