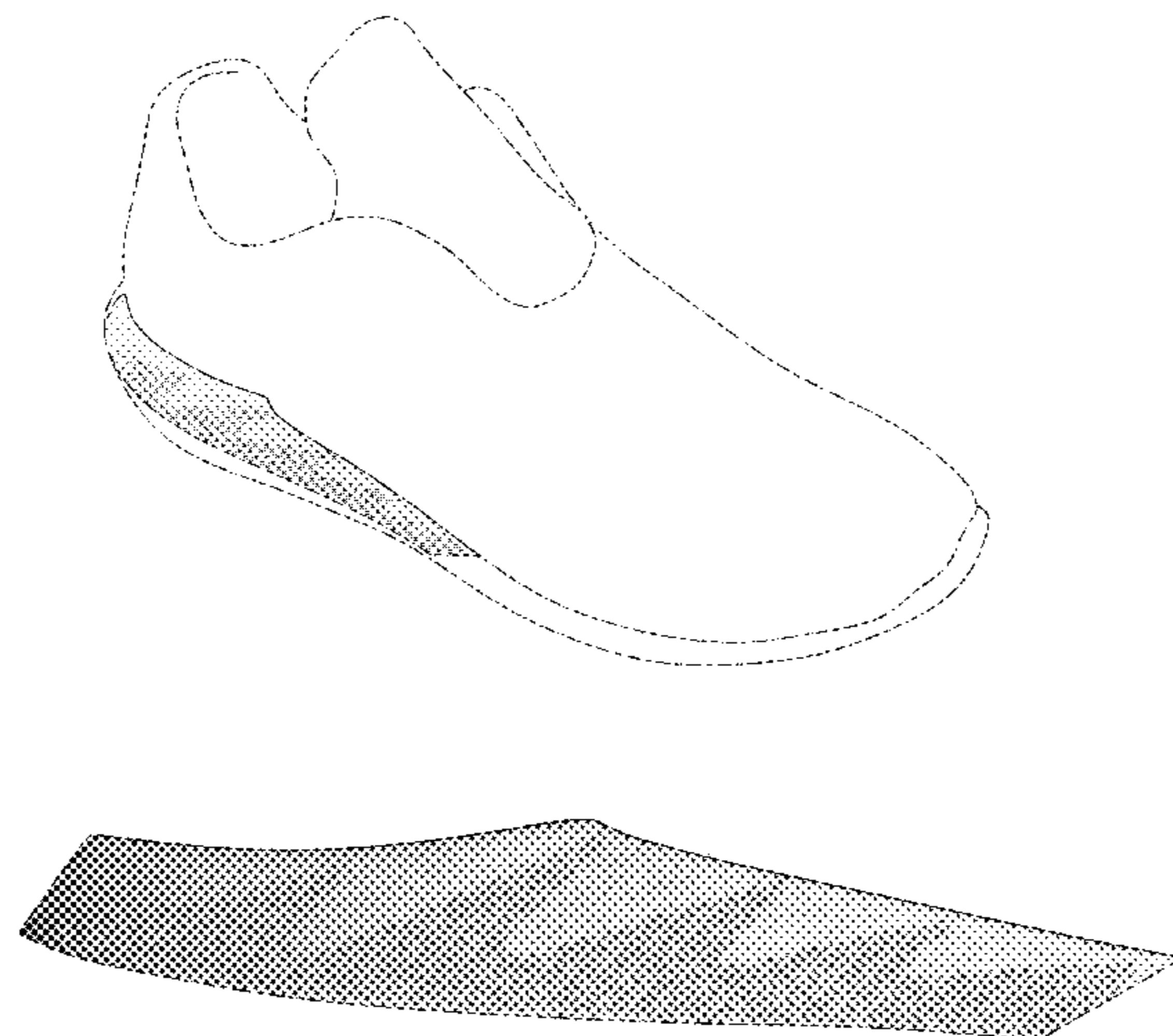
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a photographic front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is an enlarged partial view of FIG. 2; and,
FIG. 5 is an enlarged partial rear view.
The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

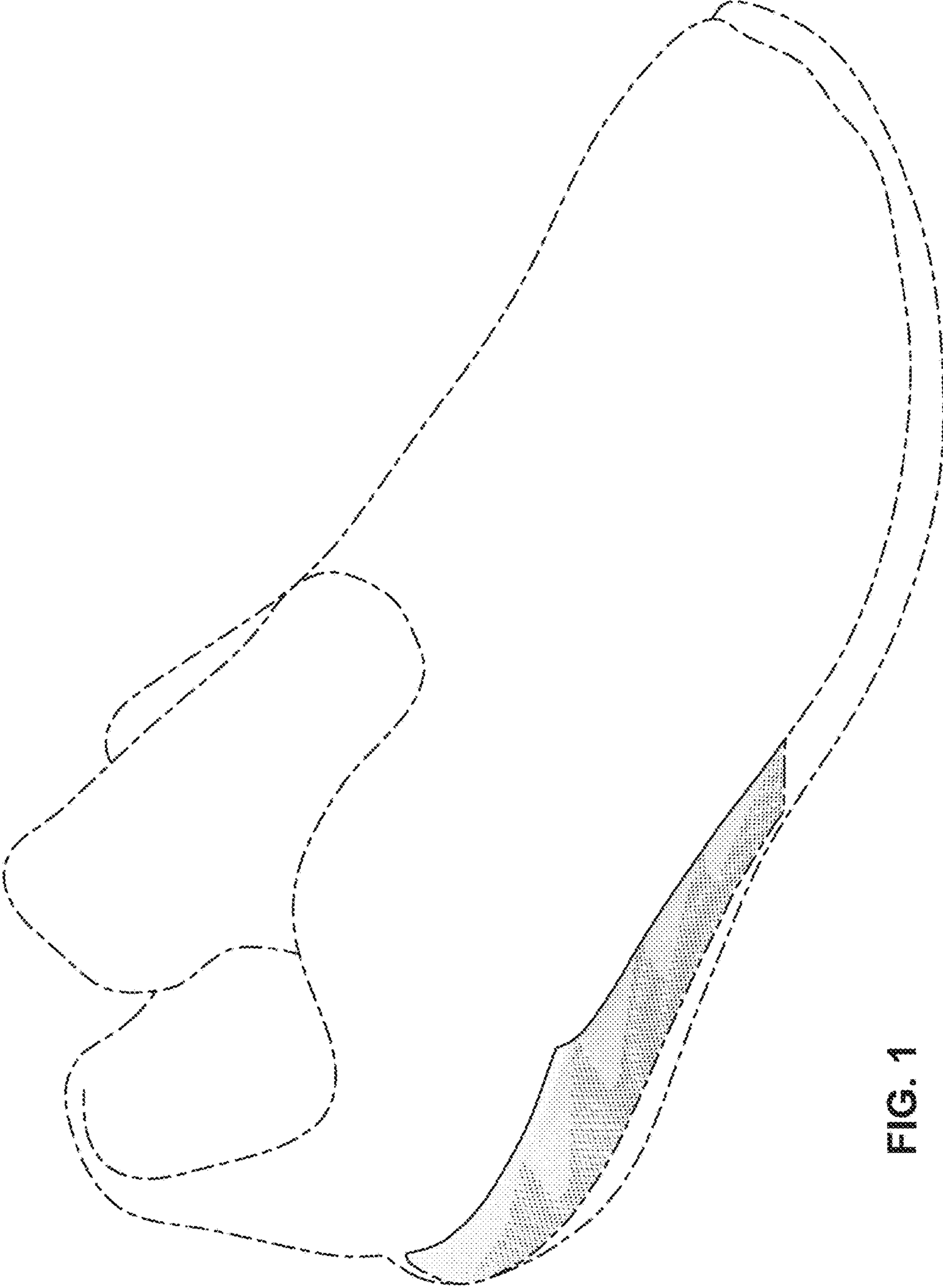

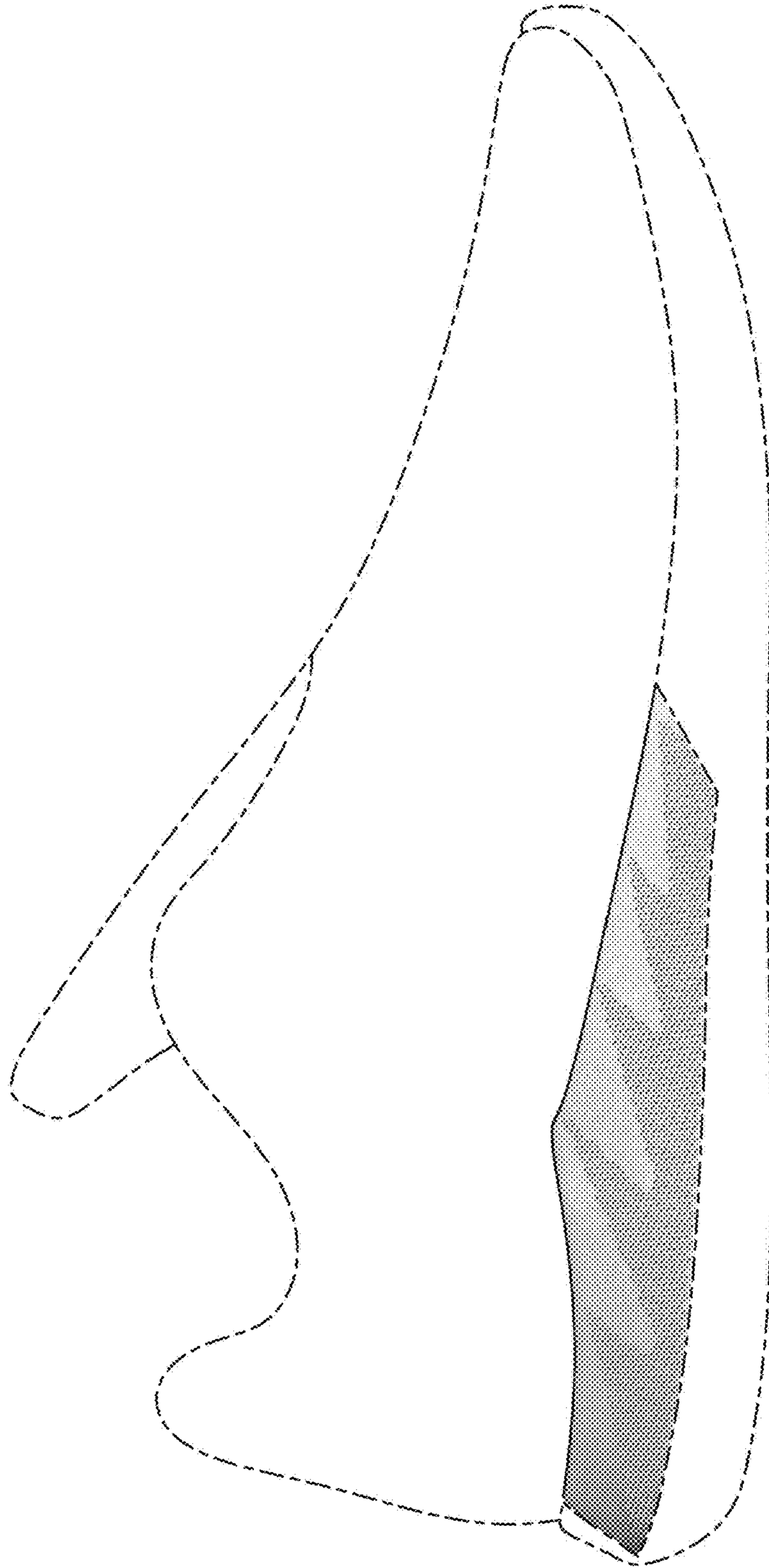

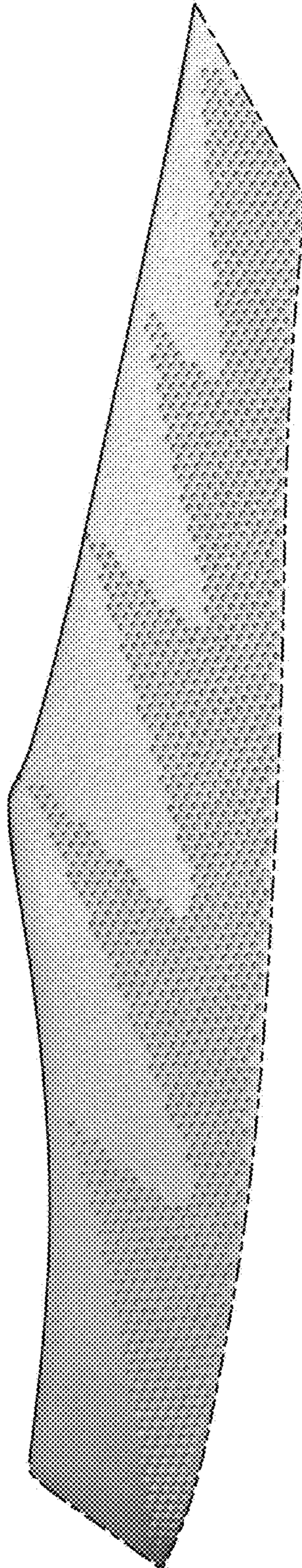

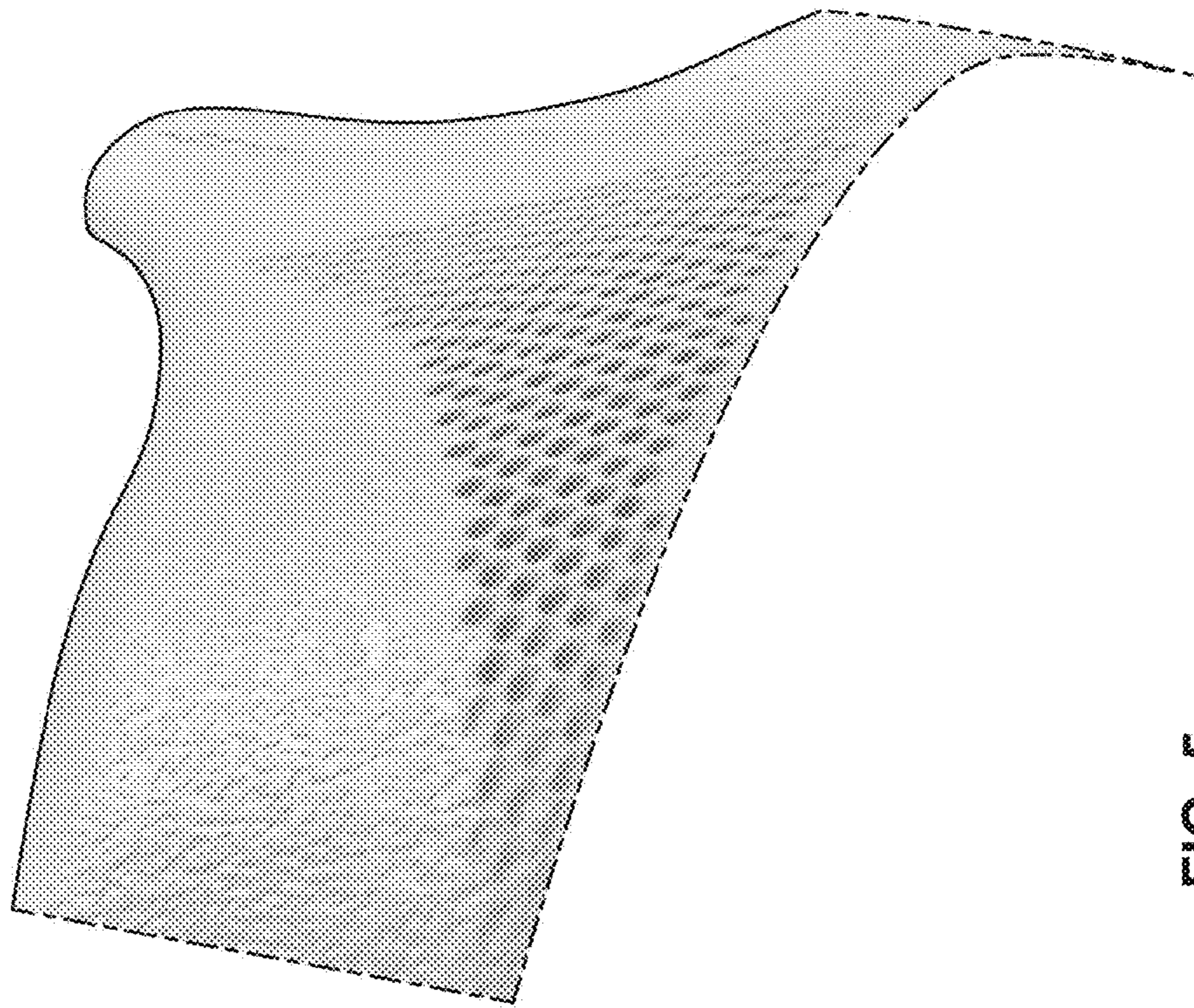
