(57) **CLAIM**

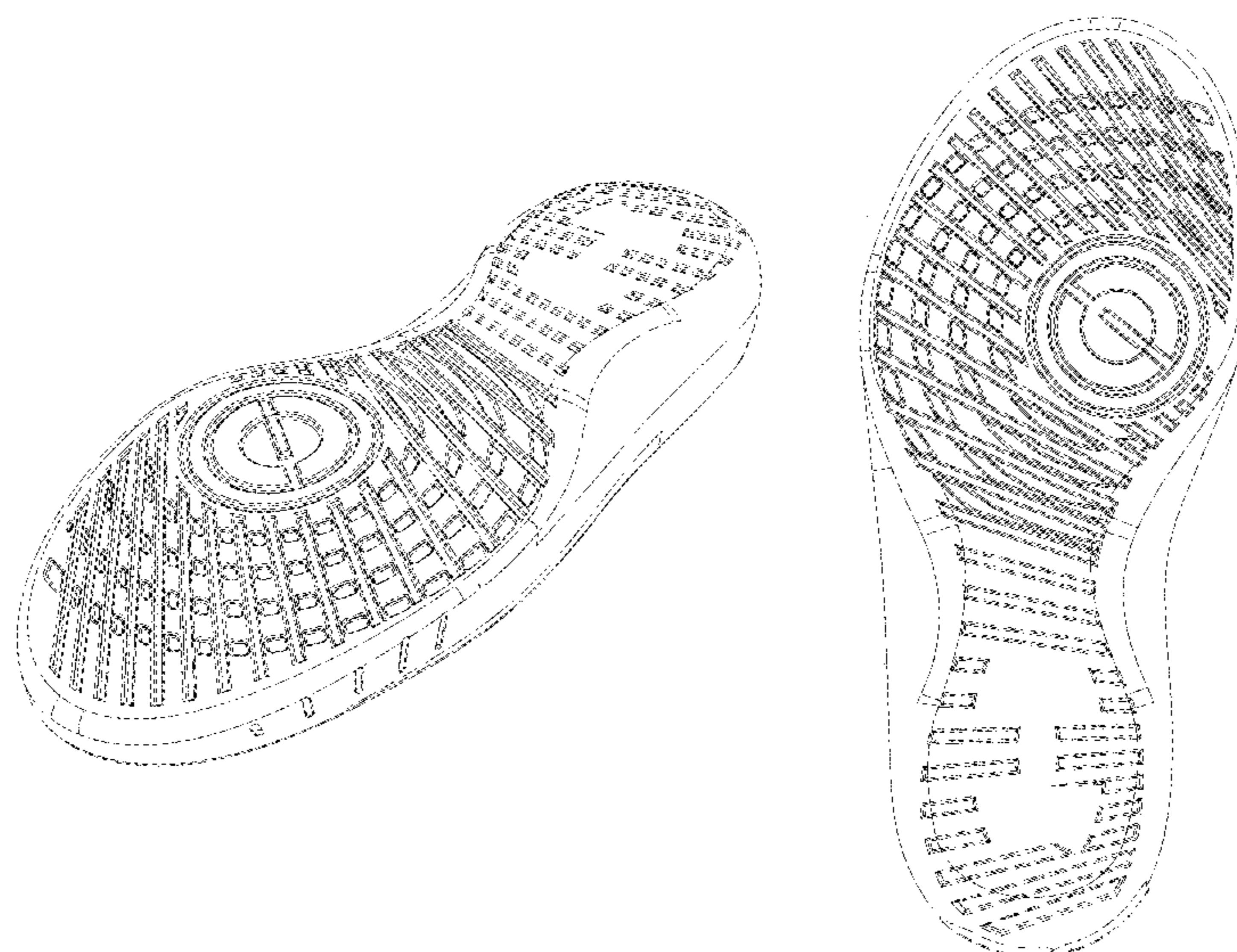
The ornamental design for a sole structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom and front view in perspective of a sole structure showing my new design;  
FIG. 2 is a bottom and rear view in perspective of the sole structure of FIG. 1;  
FIG. 3 is a top view in plan of the sole structure of FIG. 1;  
FIG. 4 is a bottom view in plan of the sole structure of FIG. 1;  
FIG. 5 is a lateral side view in elevation of the sole structure of FIG. 1;  
FIG. 6 is a medial side view in elevation of the sole structure of FIG. 1;  
FIG. 7 is a front view in elevation of the sole structure of FIG. 1; and,  
FIG. 8 is a rear view in elevation of the sole structure of FIG. 1.

The sole structure illustrated is a first embodiment showing a right-footed form of the sole structure for a shoe. A second embodiment of the sole structure is for the left-footed form of the sole structure for a shoe, which is a mirror image of the right-footed form, and which is not illustrated. The broken line illustration in the drawings is for the purpose of depicting unclaimed portions of the sole structure. The broken lines and portions they depict form no part of the claimed design. Further, the broken boundary line depicted in FIG. 3 is for the purpose of depicting an unclaimed portion enclosed by the broken boundary line in the view of FIG. 3, and this portion enclosed within the broken boundary line of FIG. 3 forms no part of the claimed design.

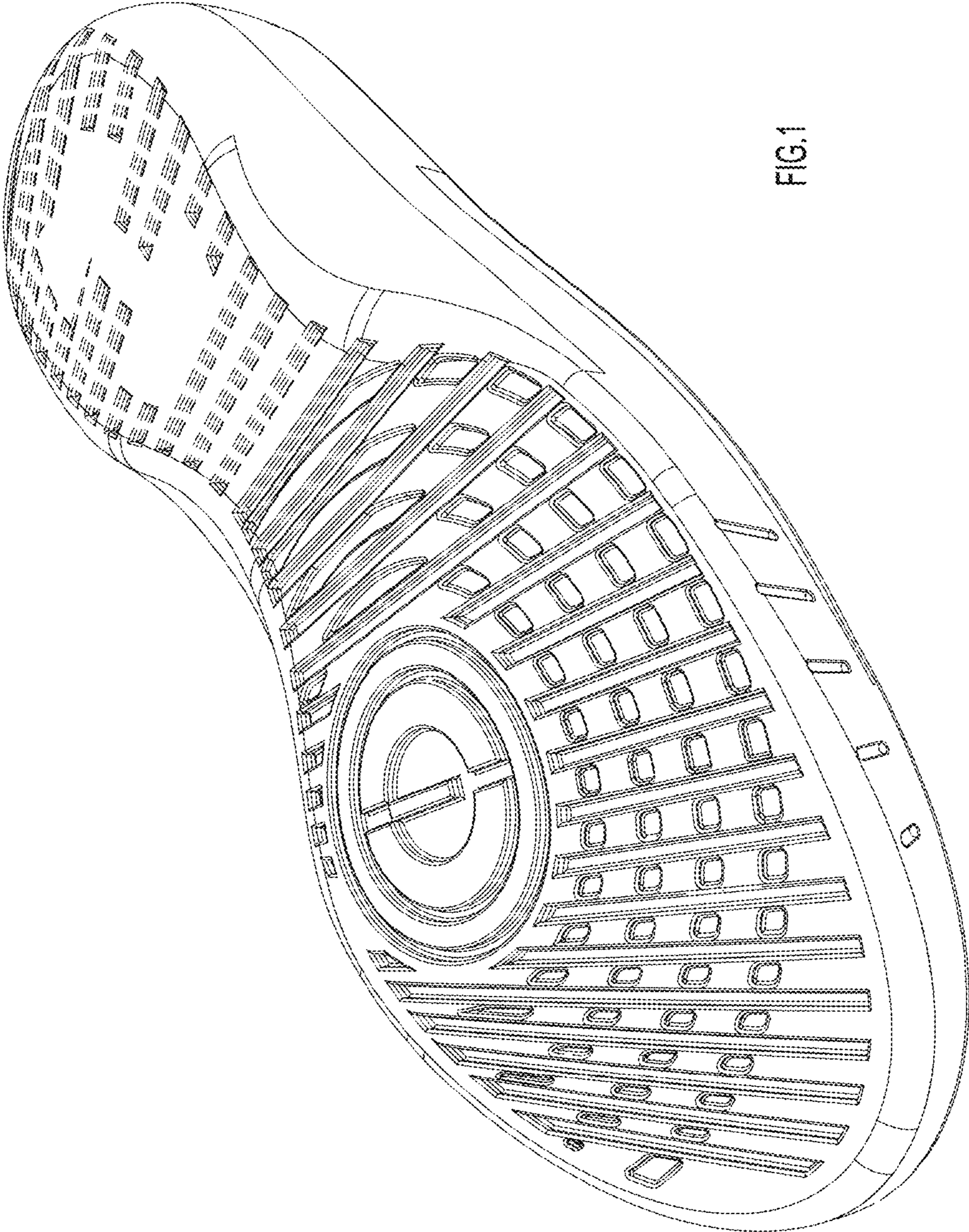

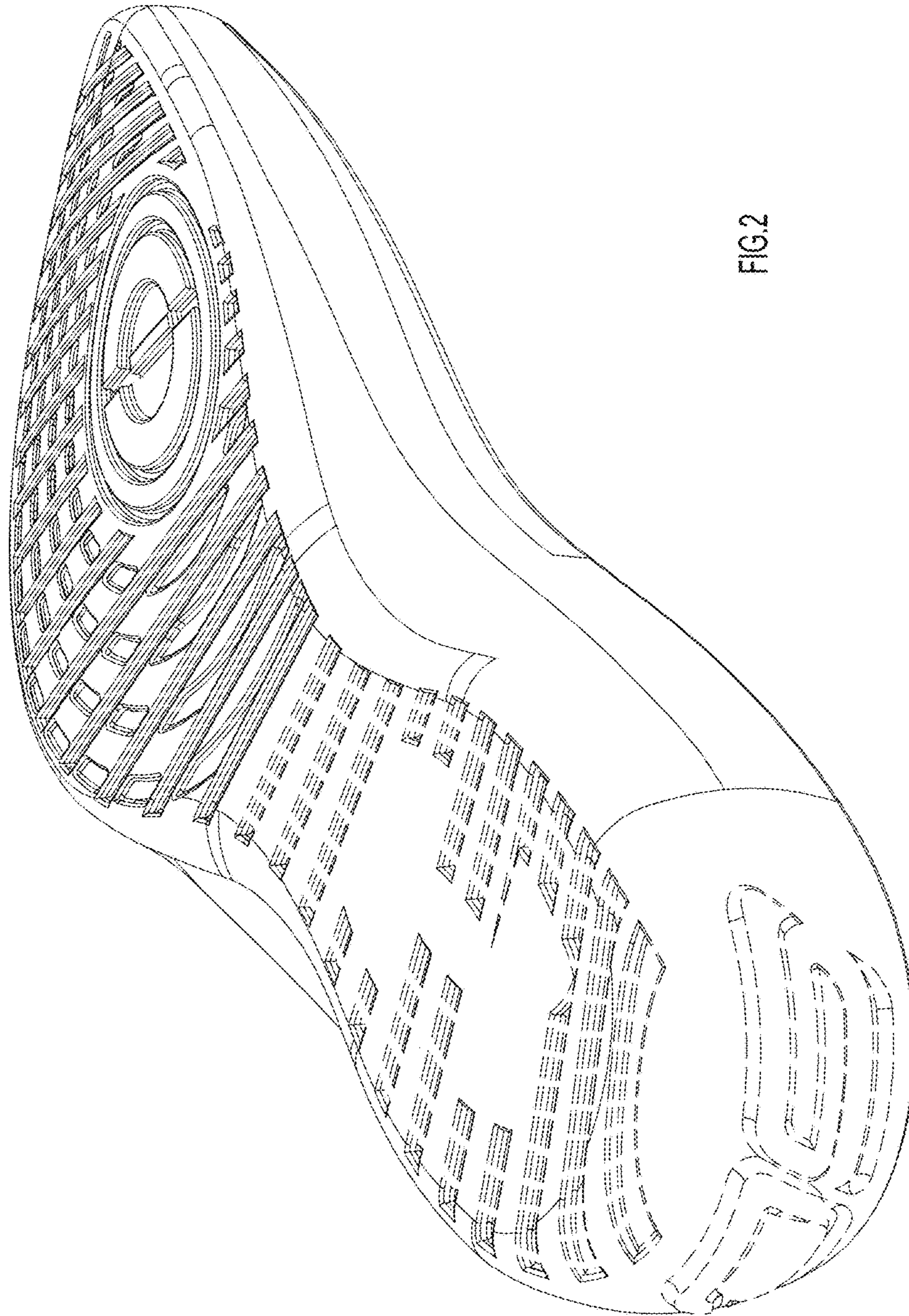

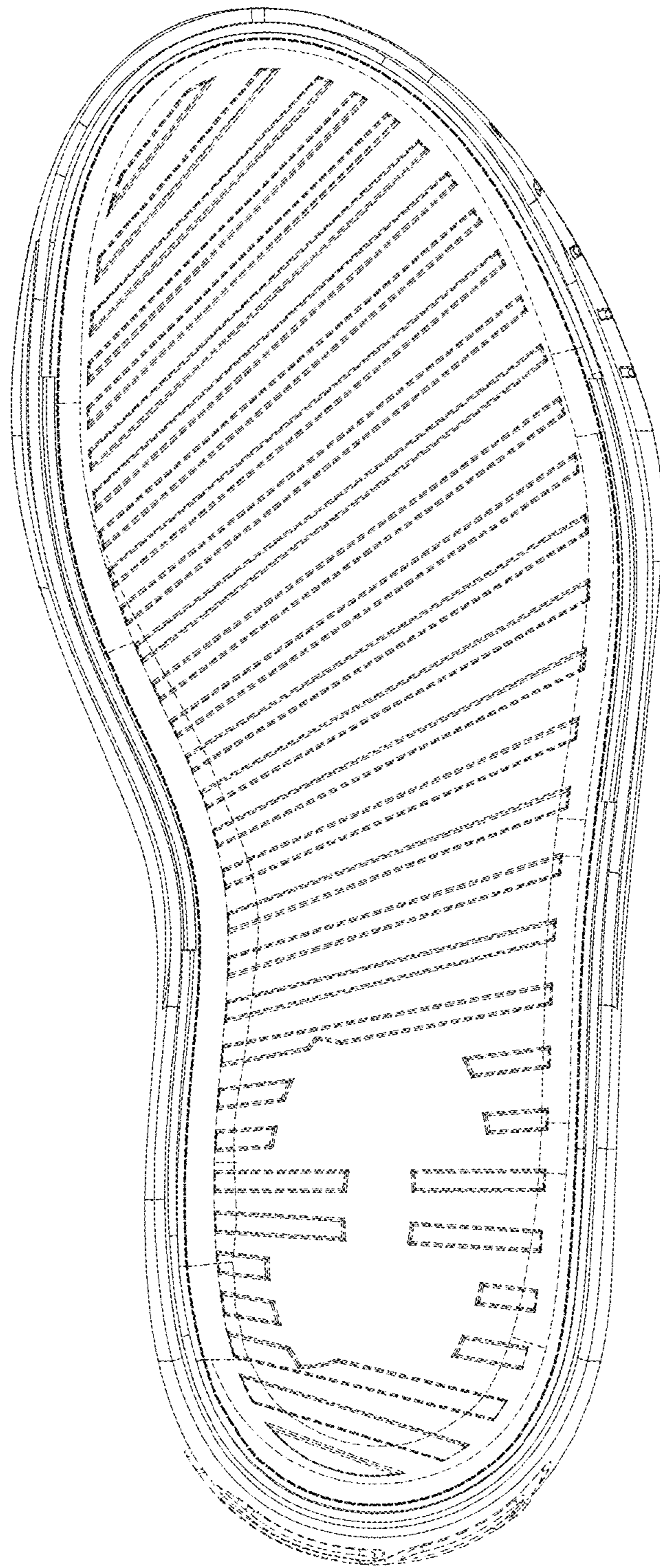

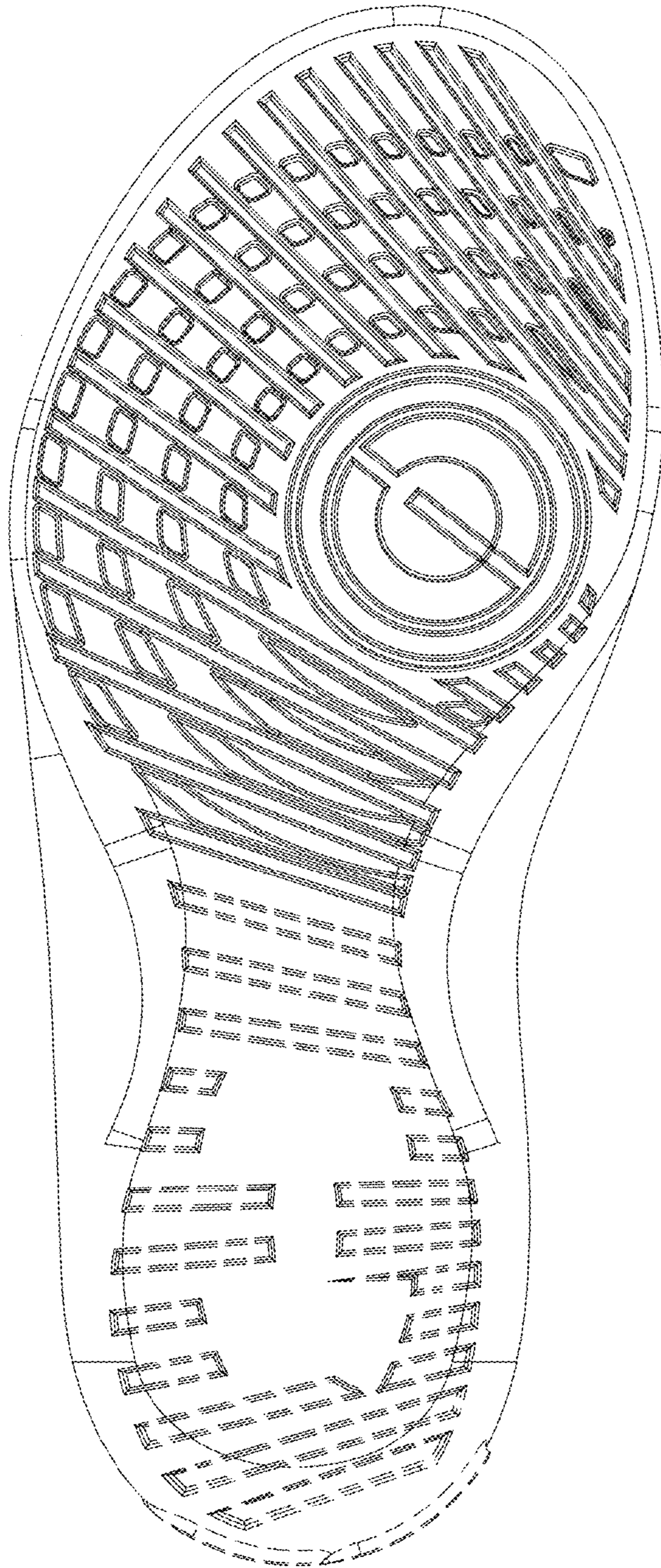

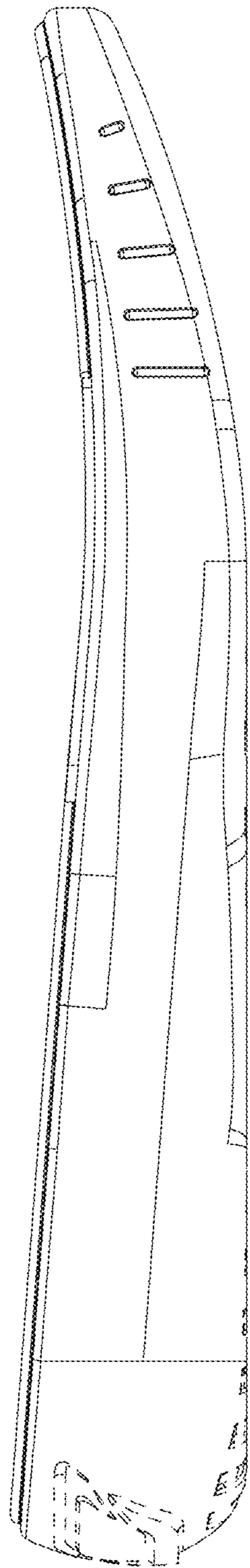

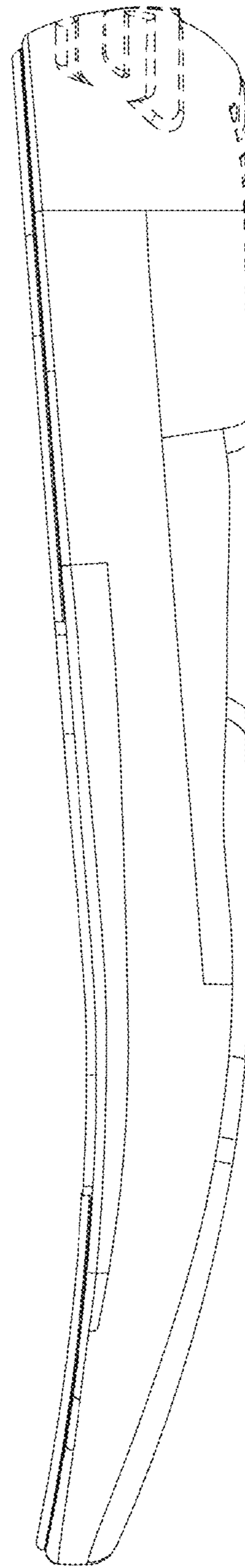

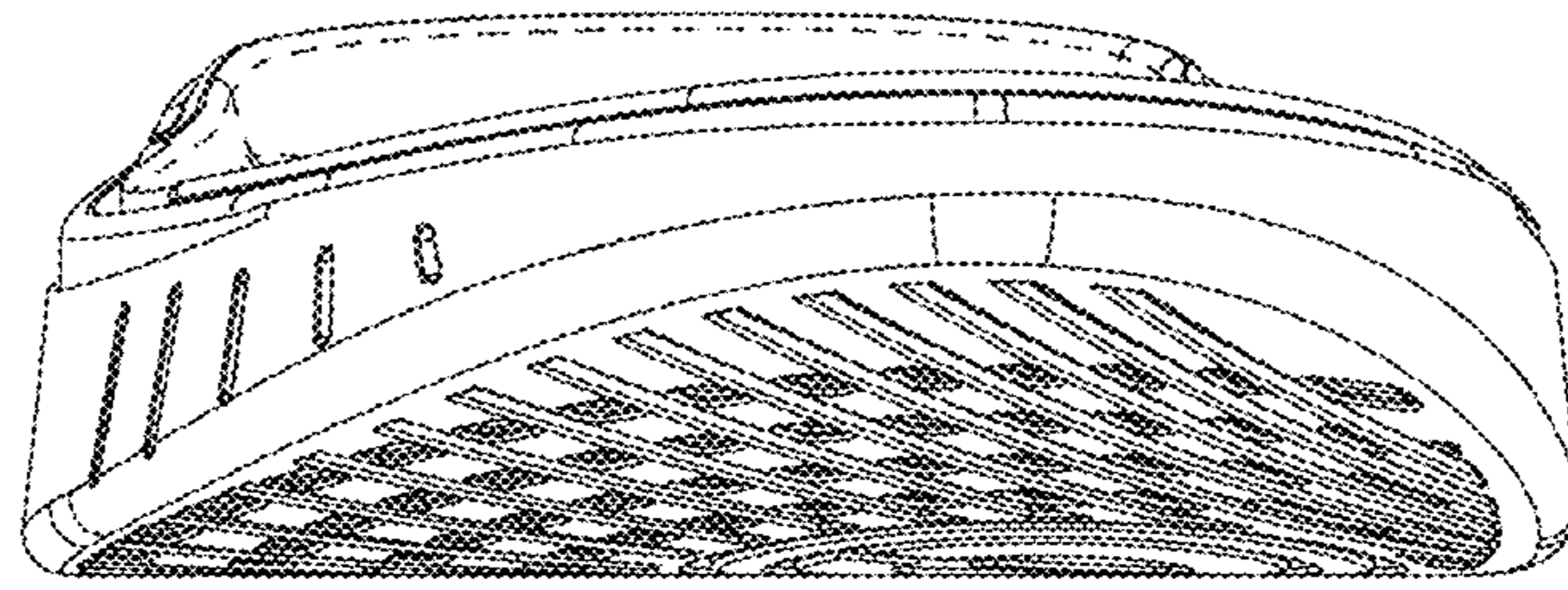

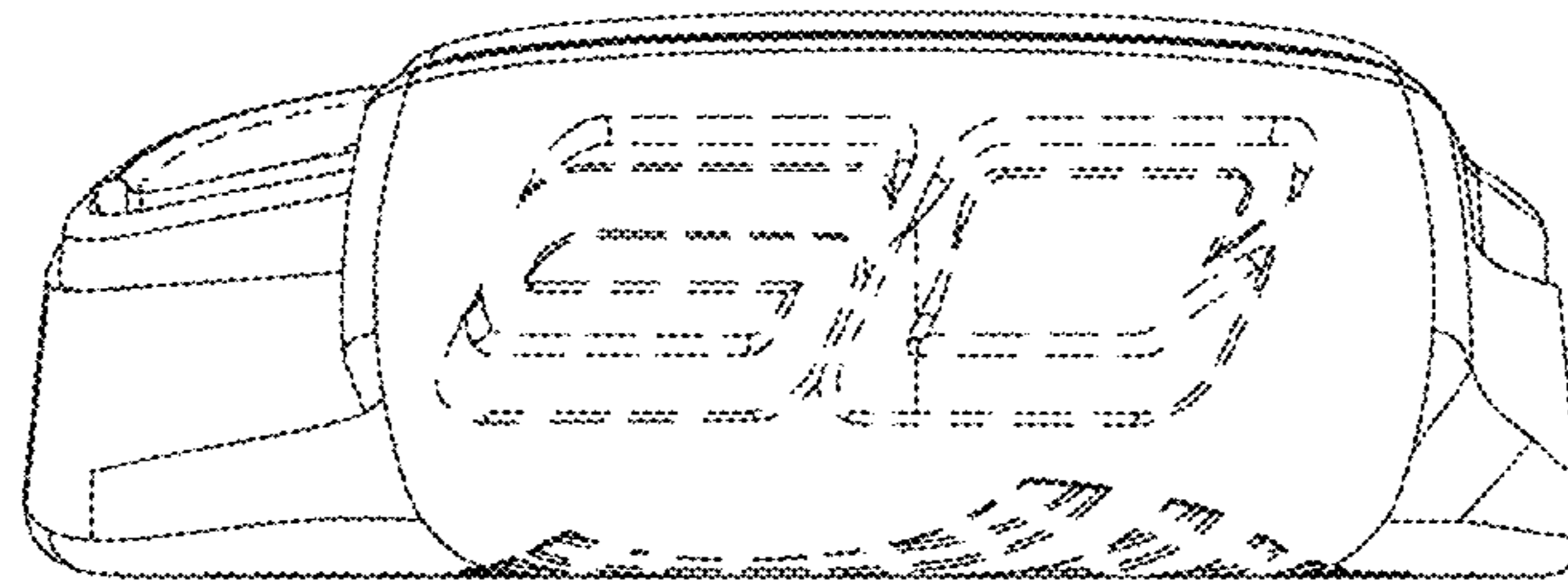
