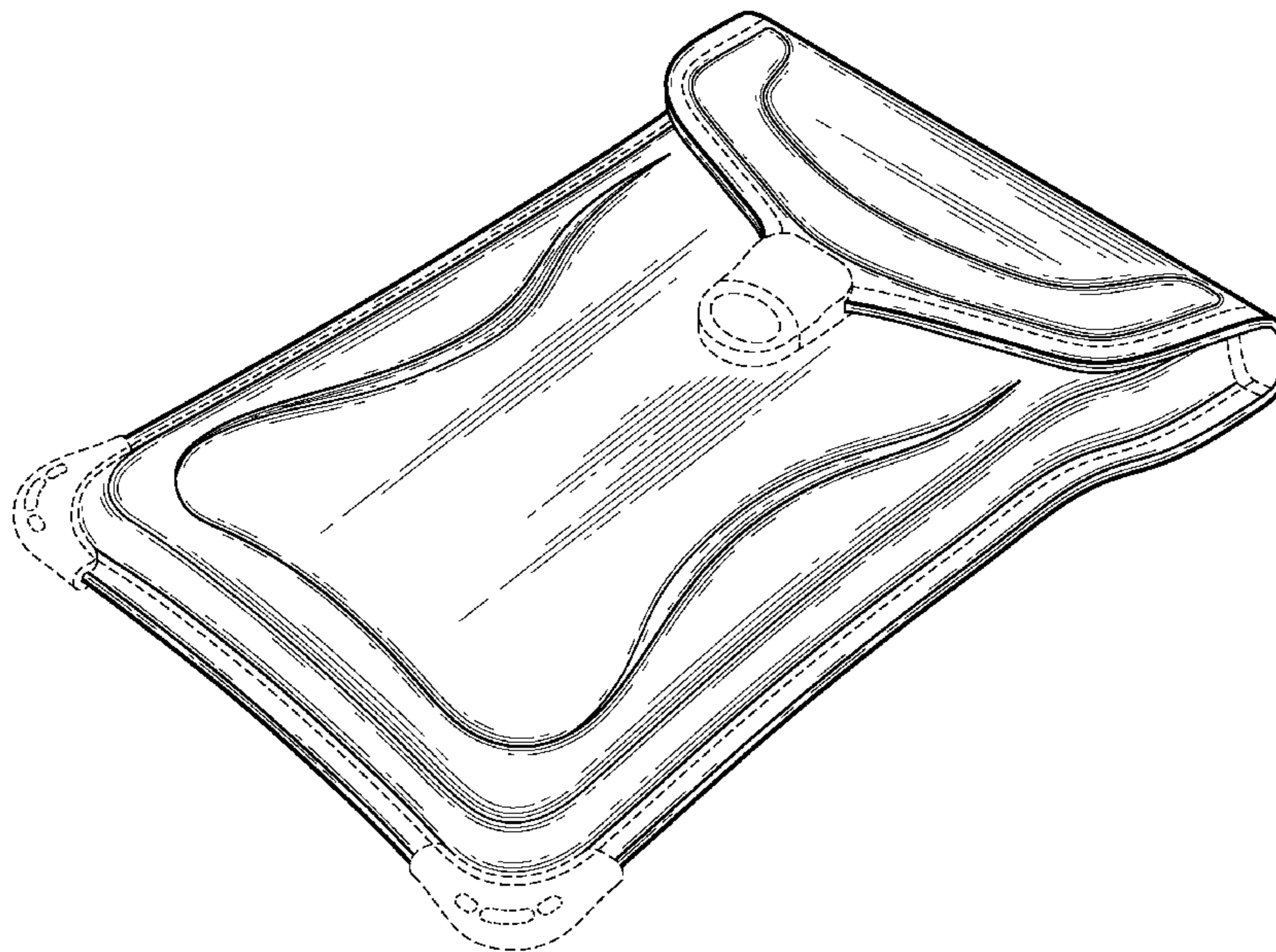

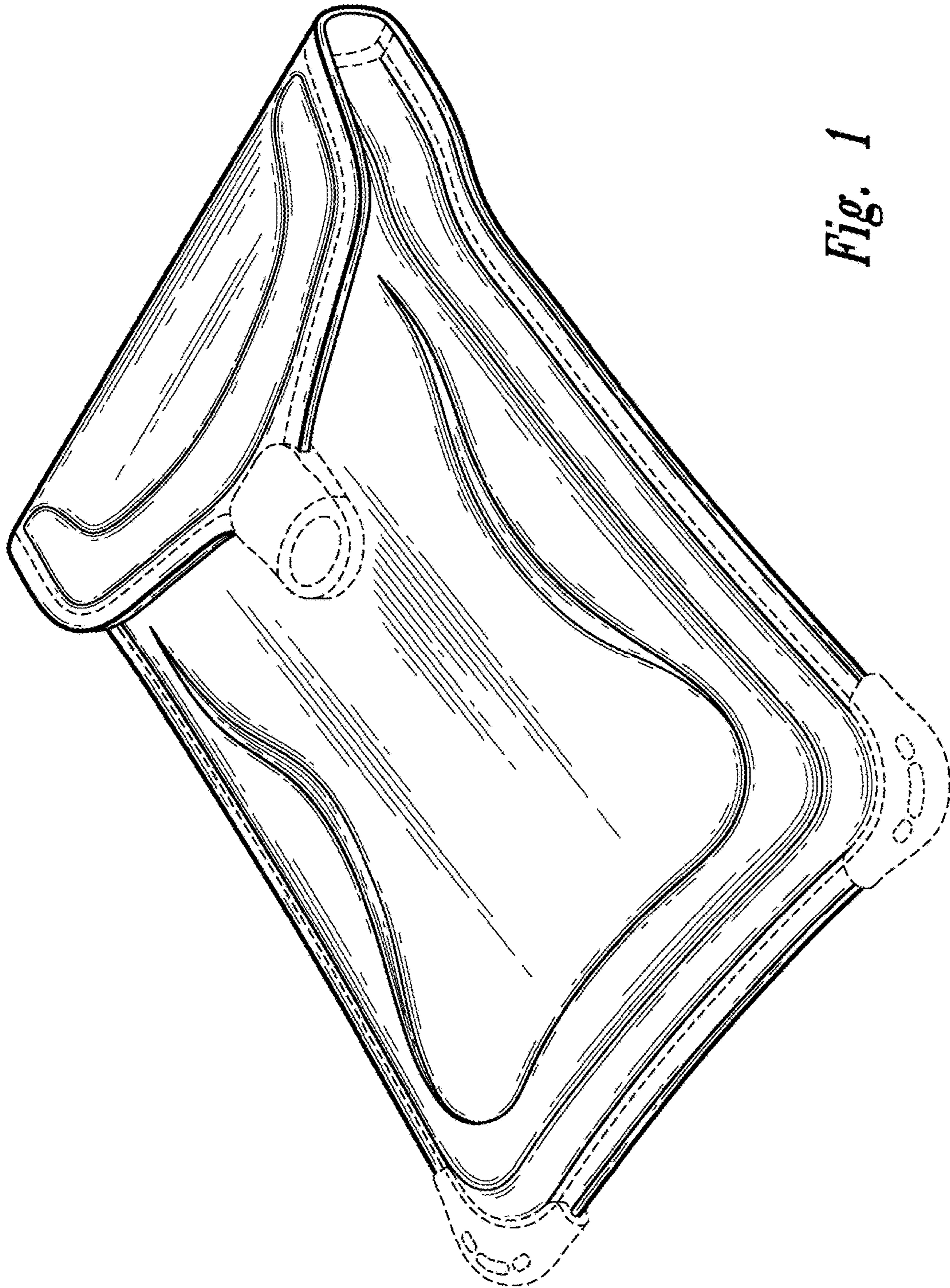
The ornamental design for a device case, as shown and described.

**DESCRIPTION**

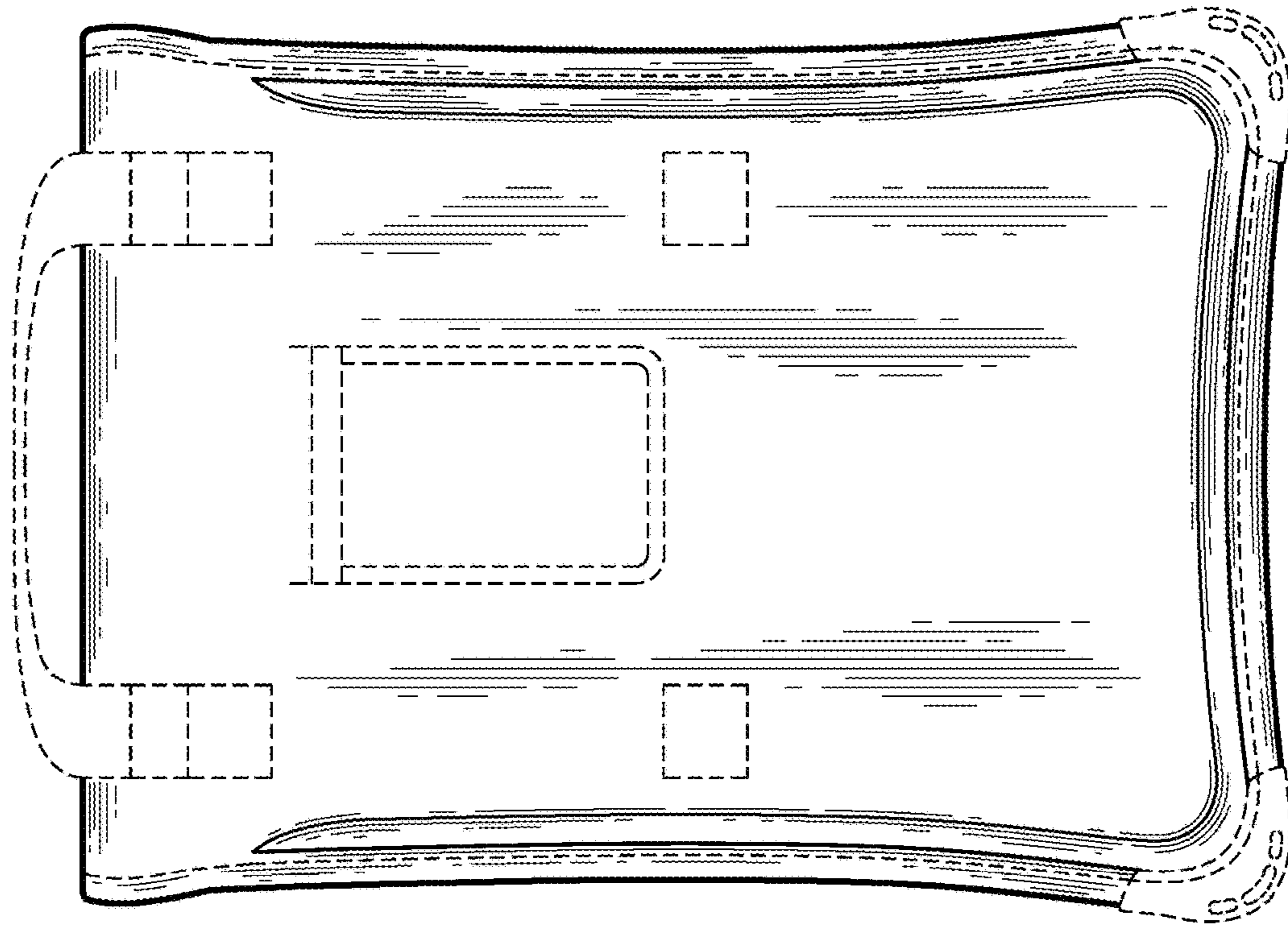
FIG. 1 is a top perspective view of a first embodiment thereof.

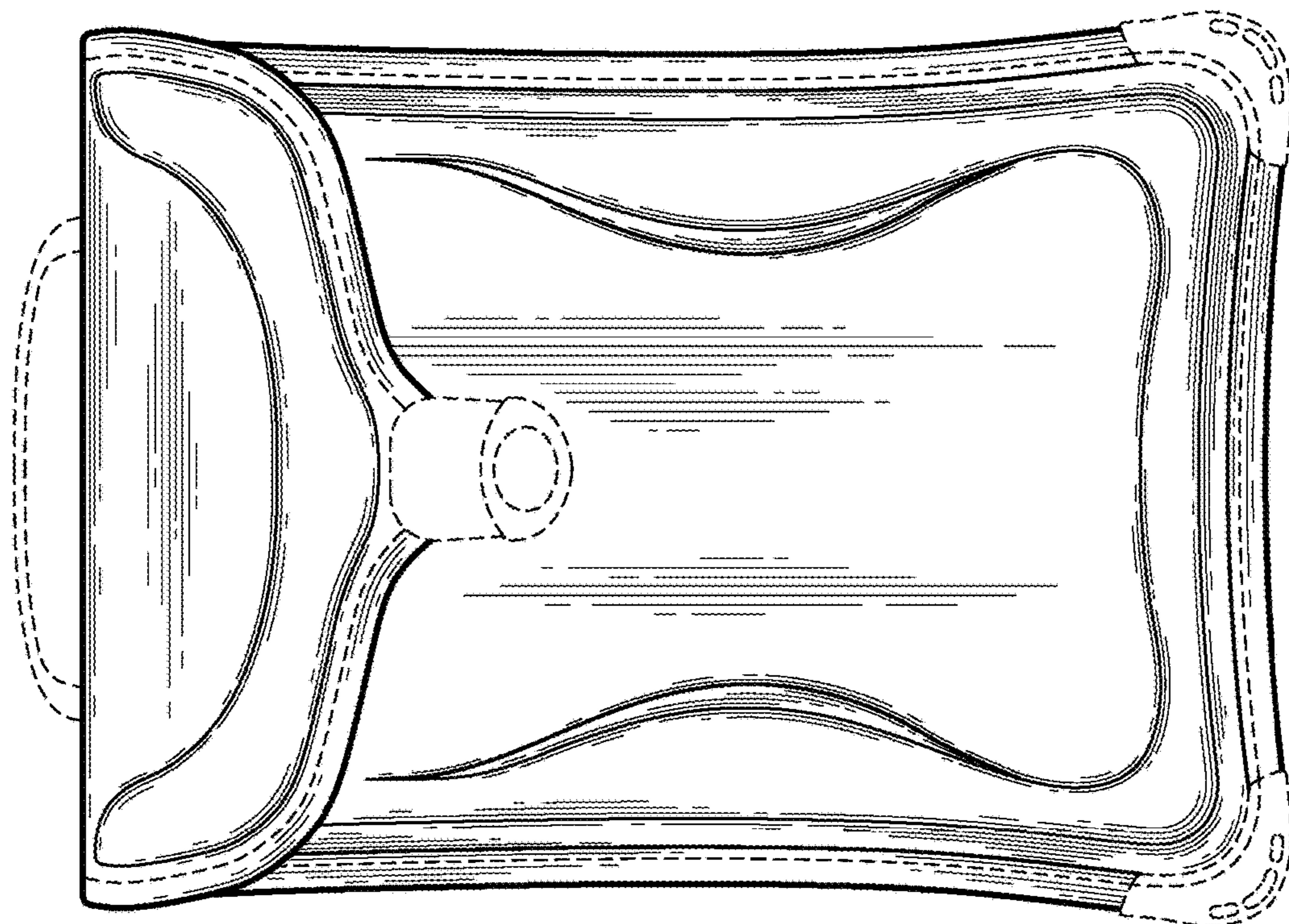




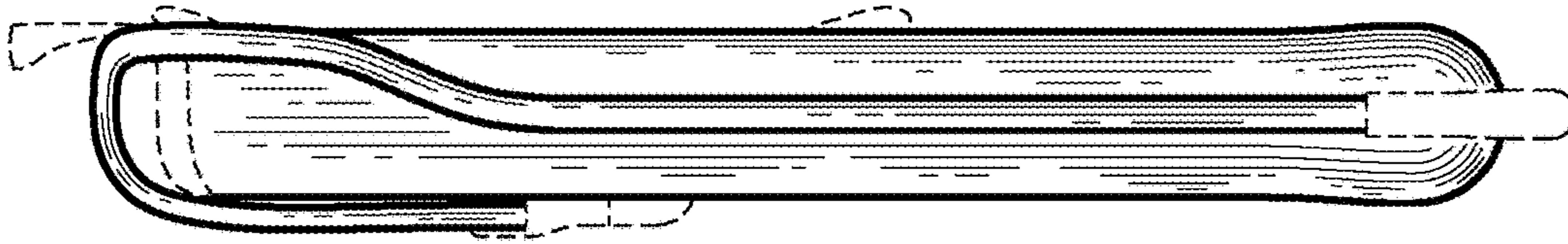

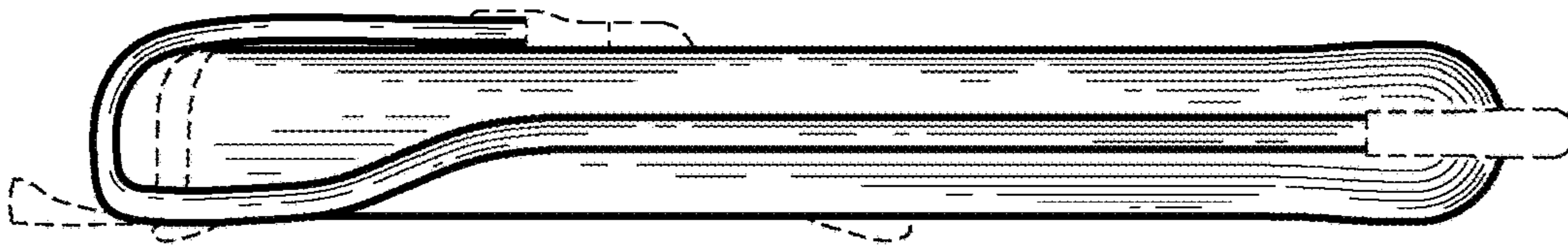

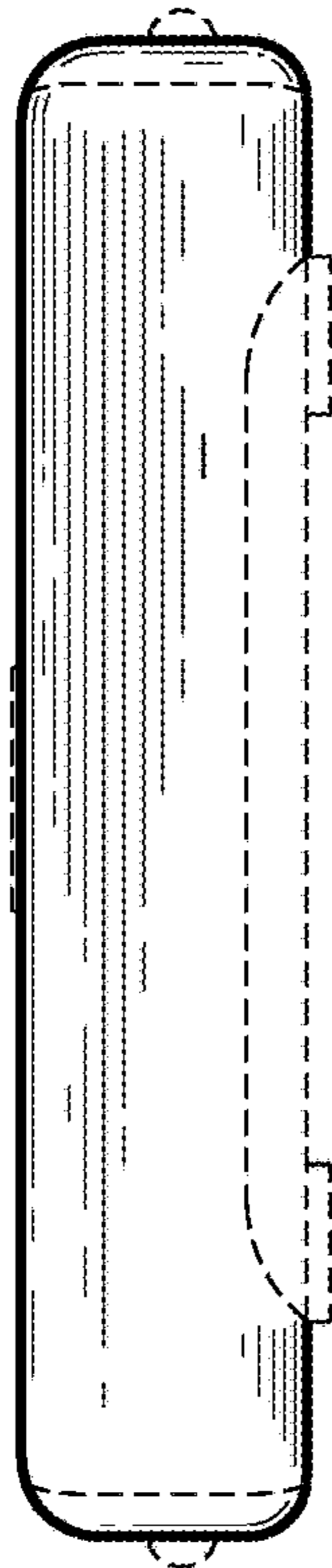

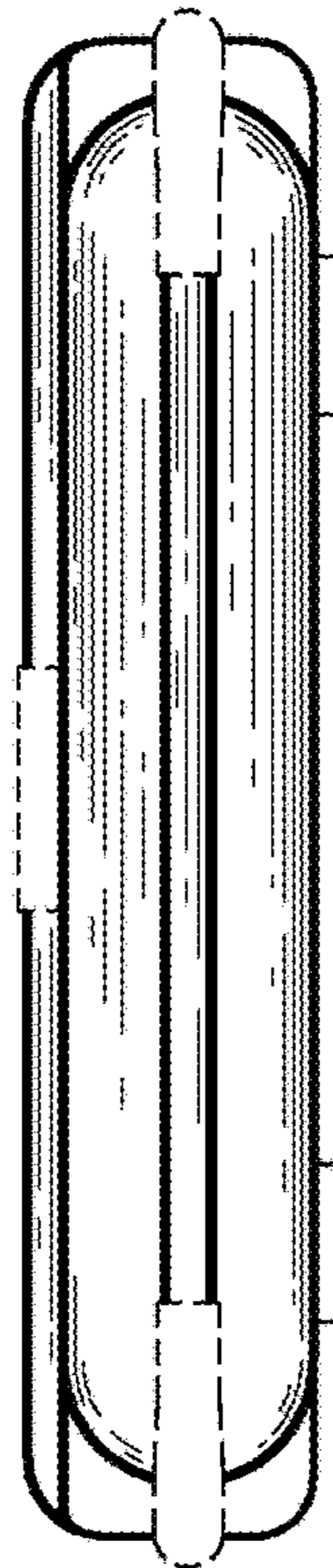
