FIG. 2 shows a bottom and side perspective thereof.

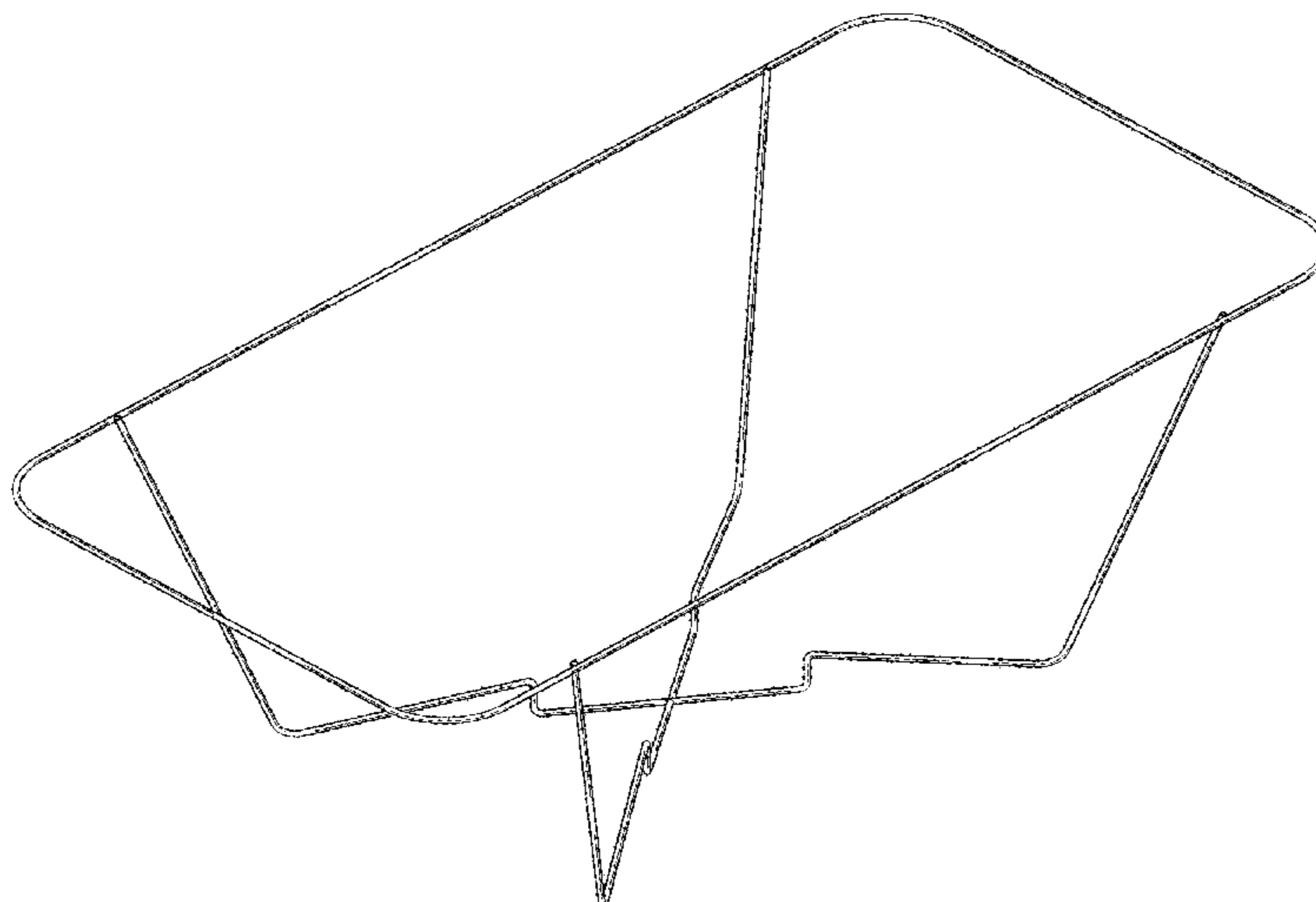
FIG. 3 shows a top view thereof.

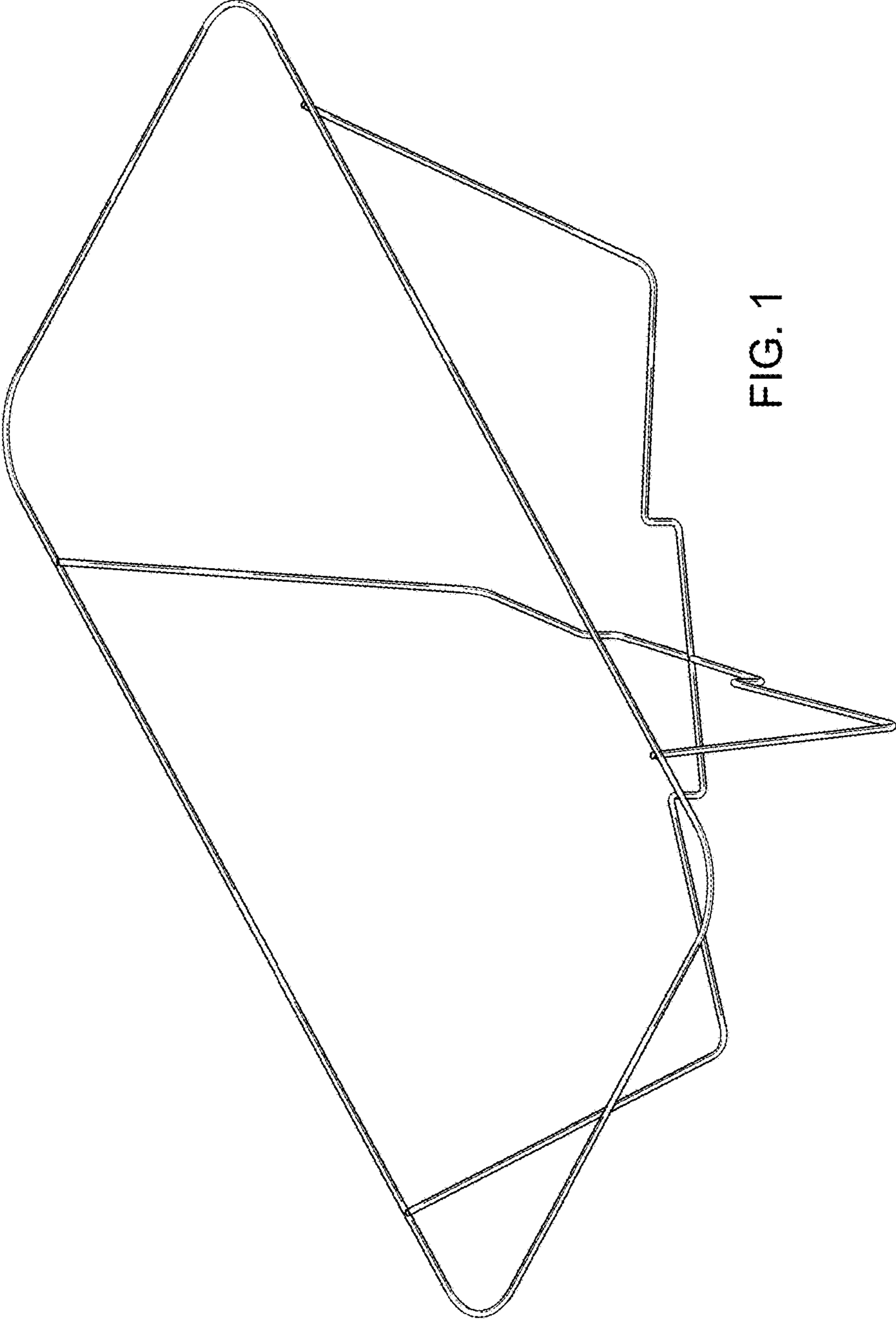

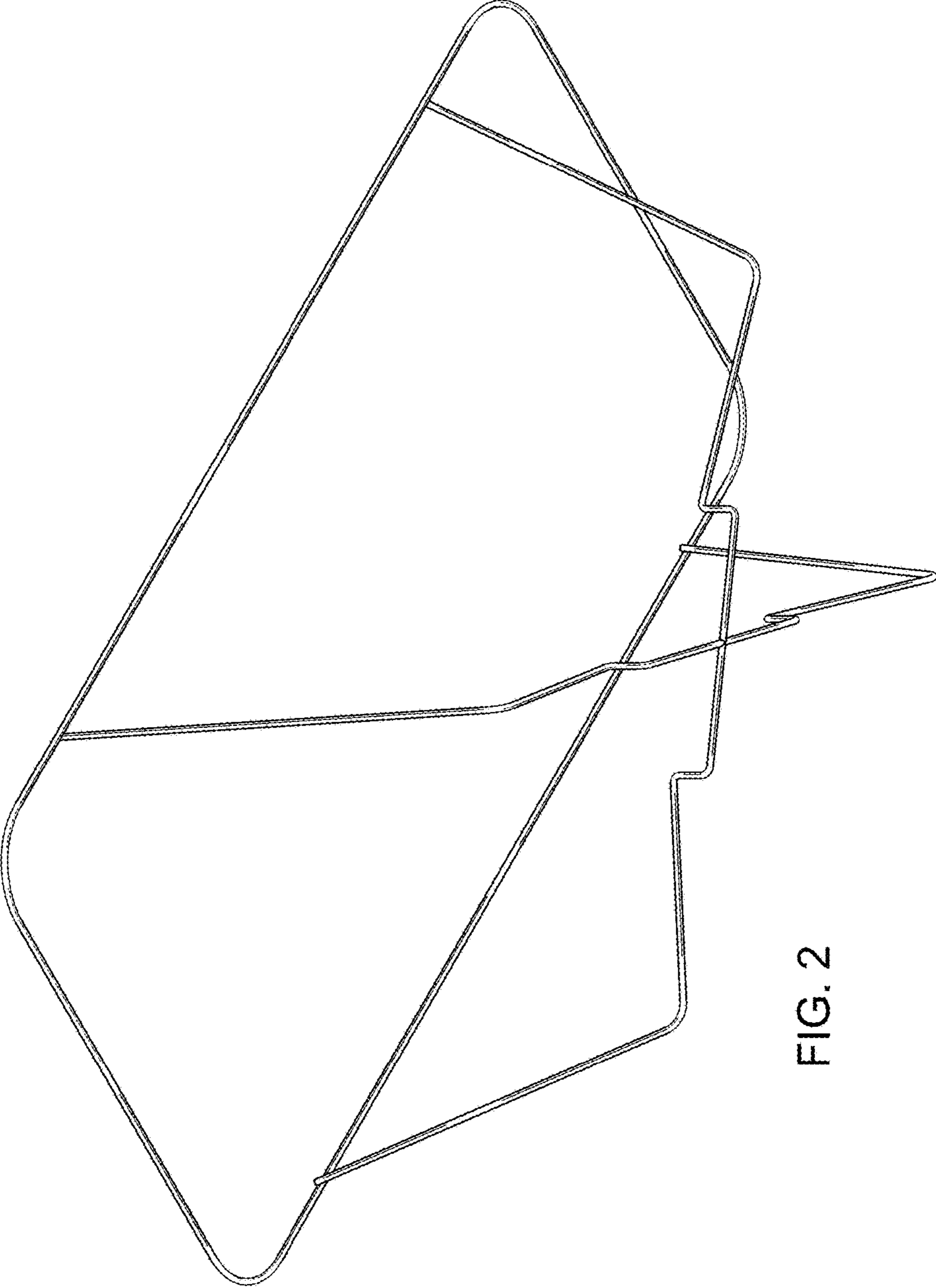

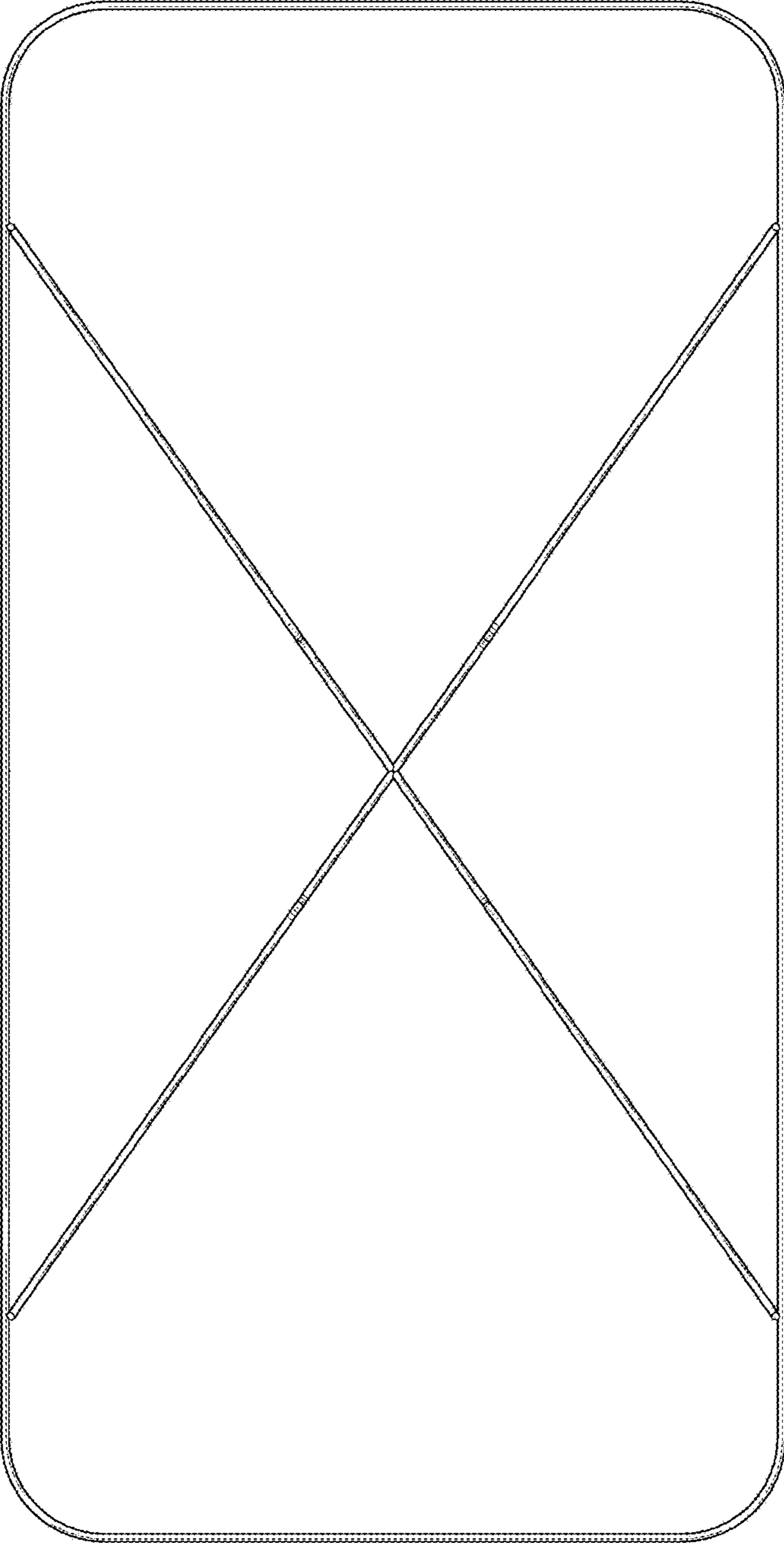

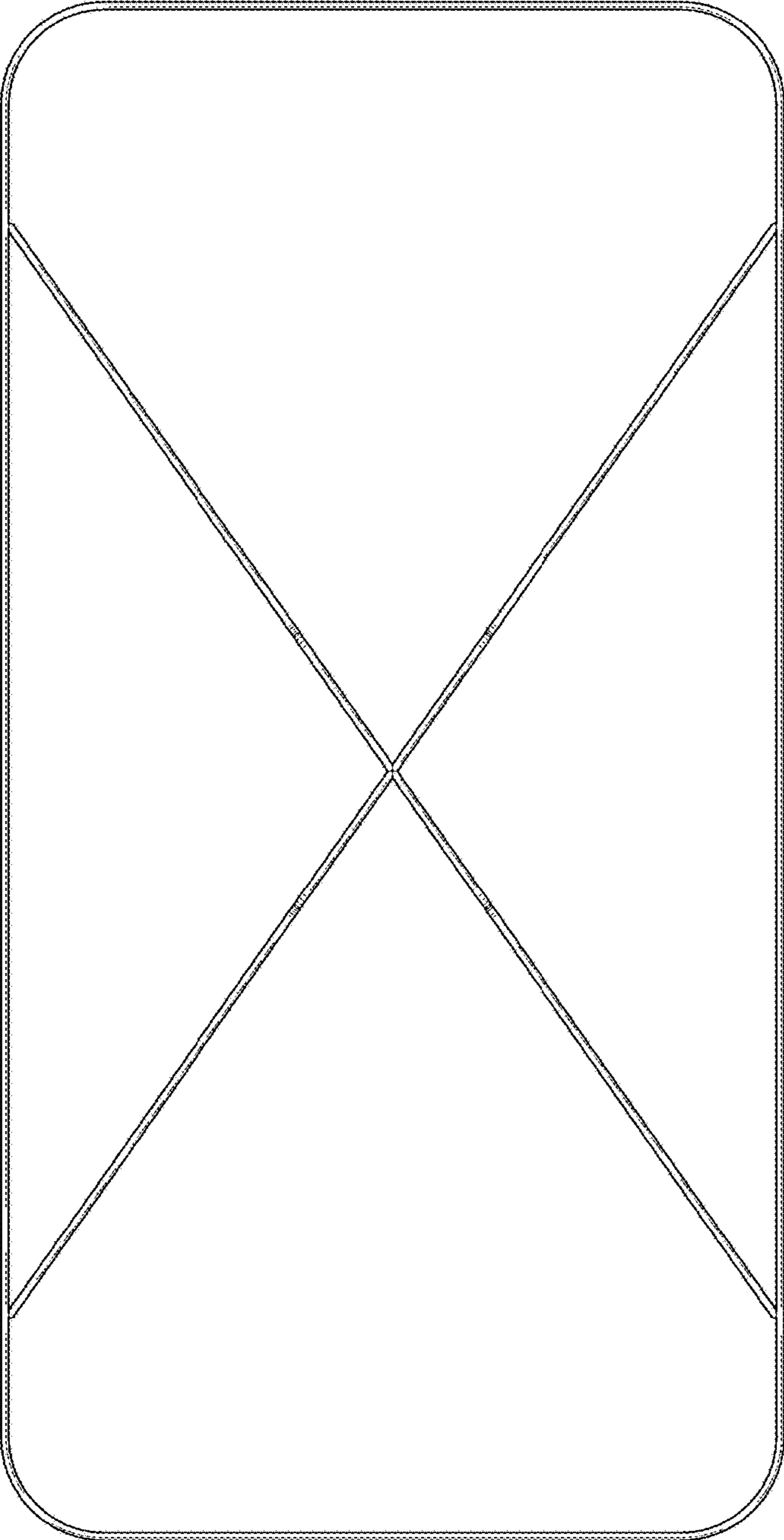

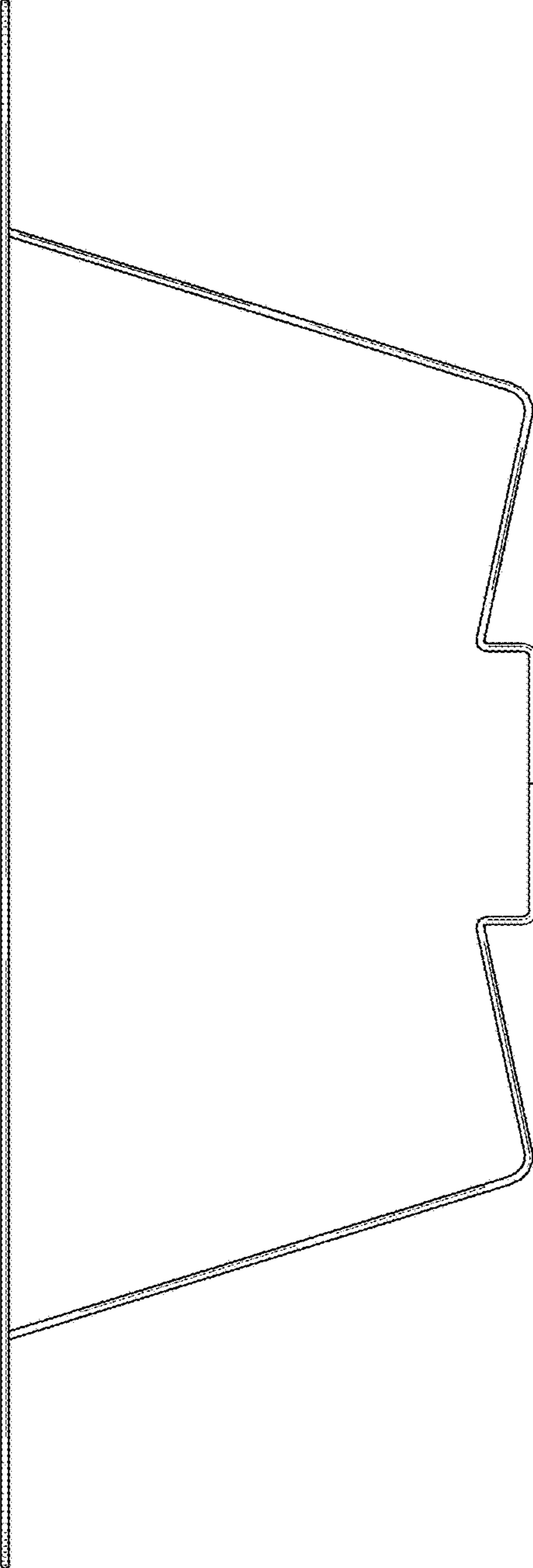

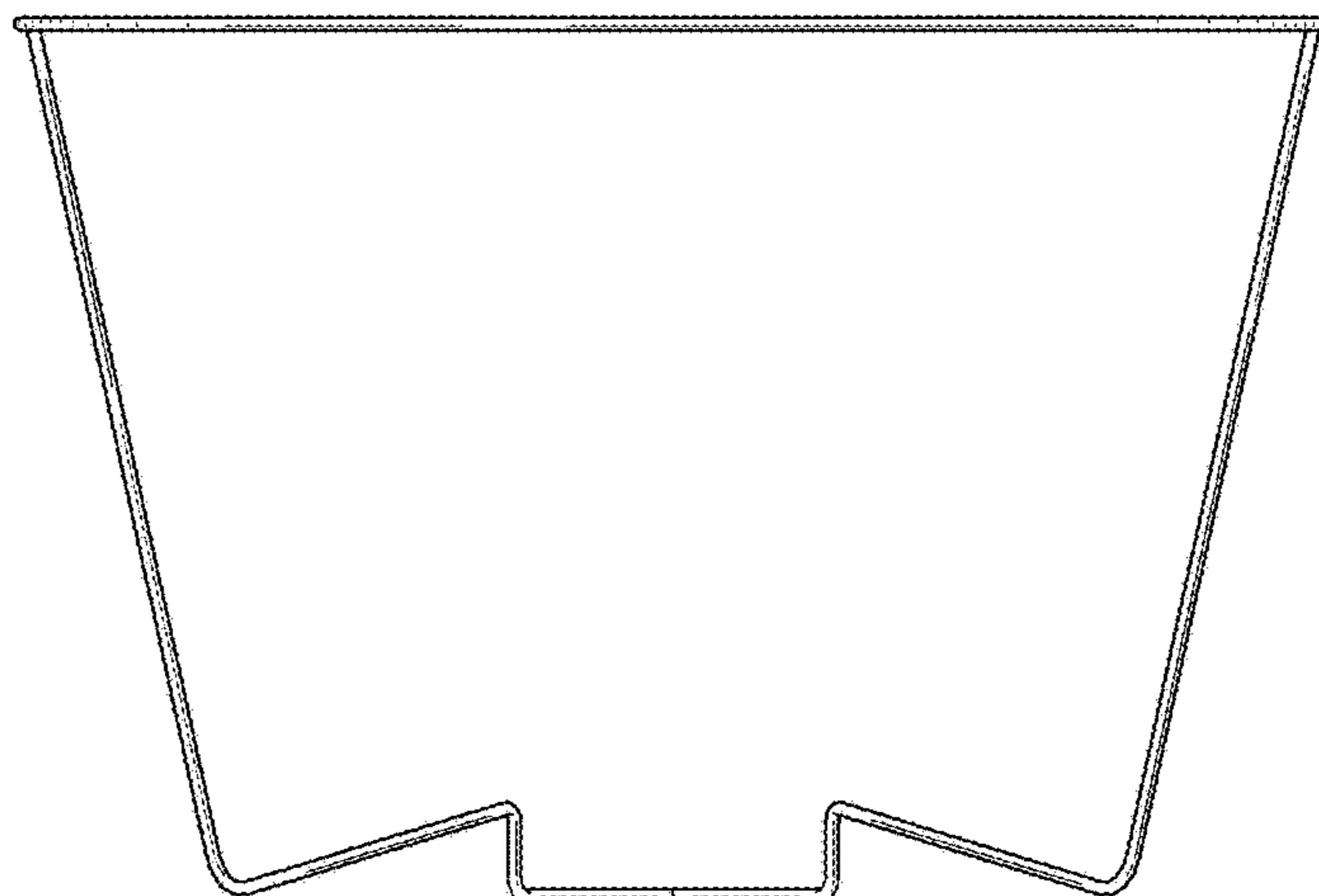
