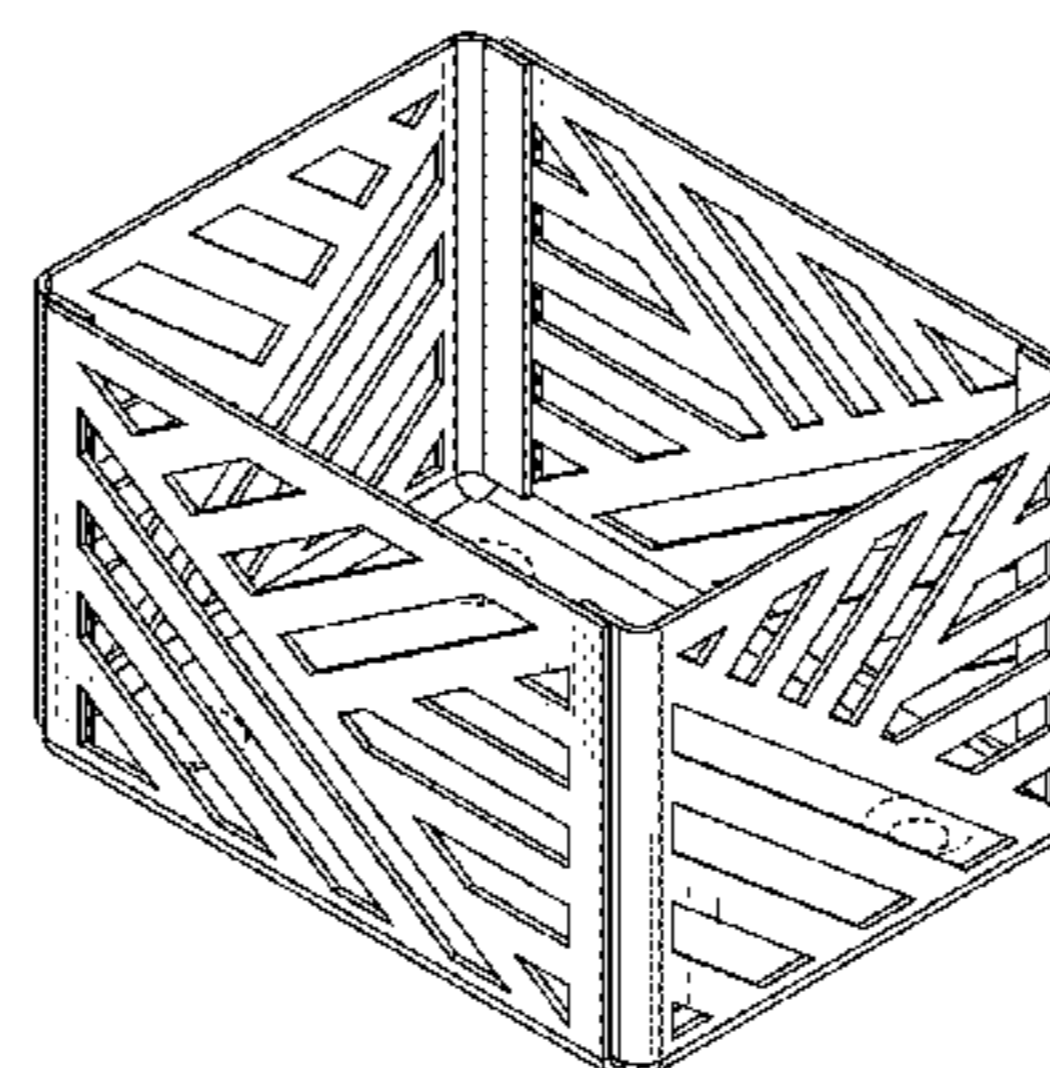
(57) **CLAIM**

The ornamental design for a sugar packet holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sugar packet holder showing a new design;
FIG. 2 is a front view of the sugar packet holder of FIG. 1;
FIG. 3 is a rear view of the sugar packet holder of FIG. 1;
FIG. 4 is a right side view of the sugar packet holder of FIG. 1;
FIG. 5 is a left side view of the sugar packet holder of FIG. 1;
FIG. 6 is a top view of the sugar packet holder of FIG. 1; and,
FIG. 7 is a bottom view of the sugar packet holder of FIG. 1.
The broken lines shown in the figures depict portions of the sugar packet holder that form no part of the claimed design.

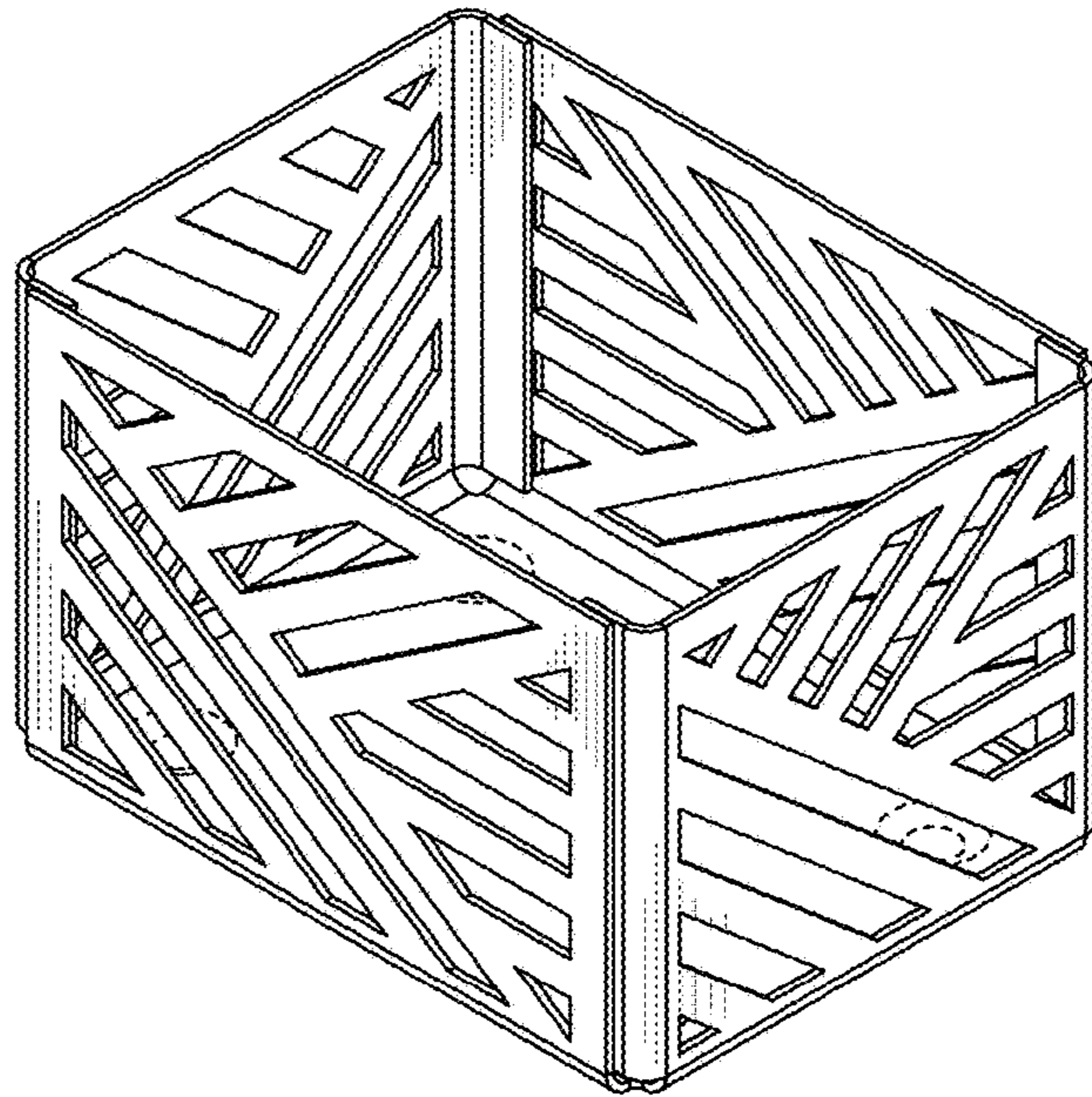

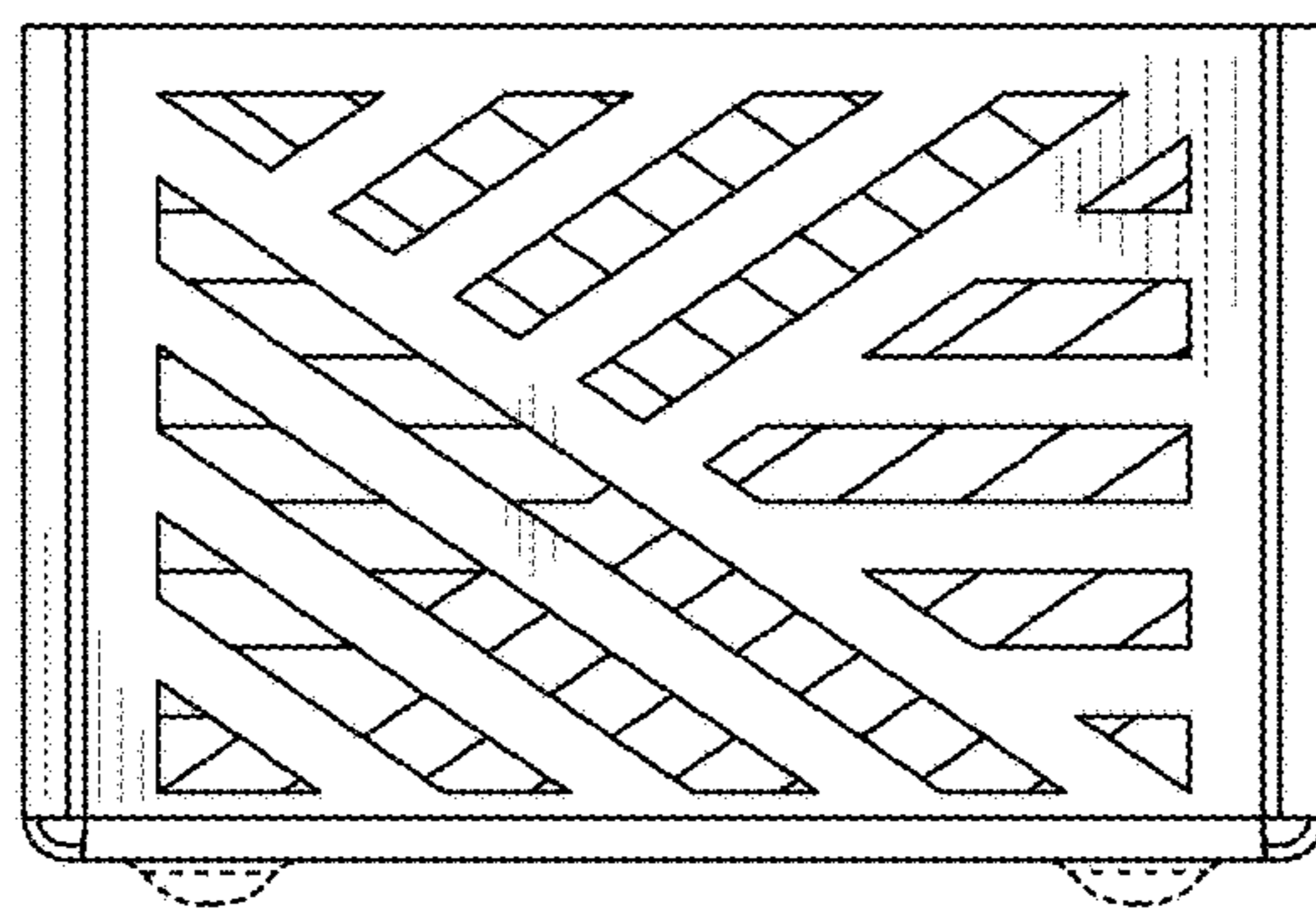

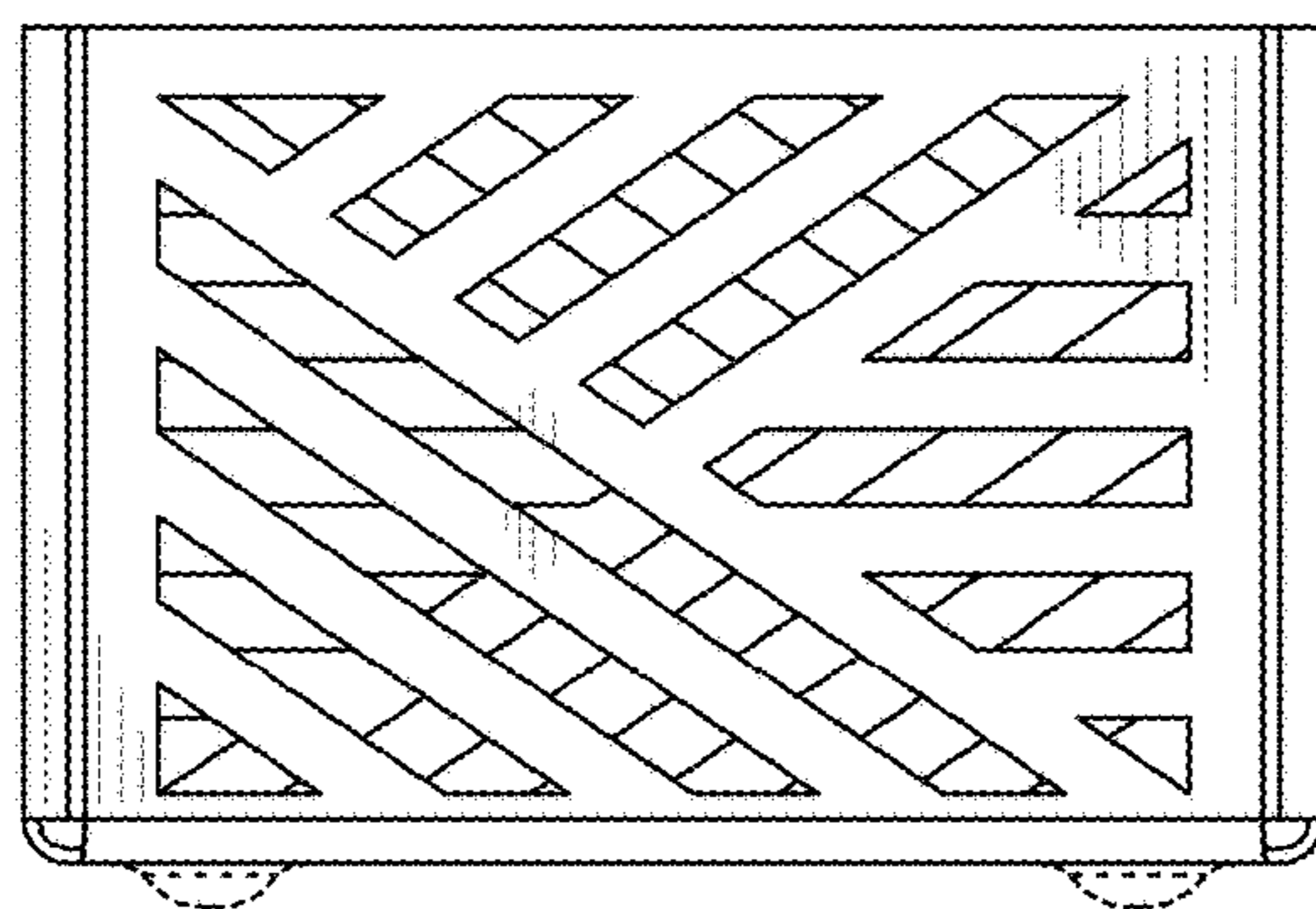

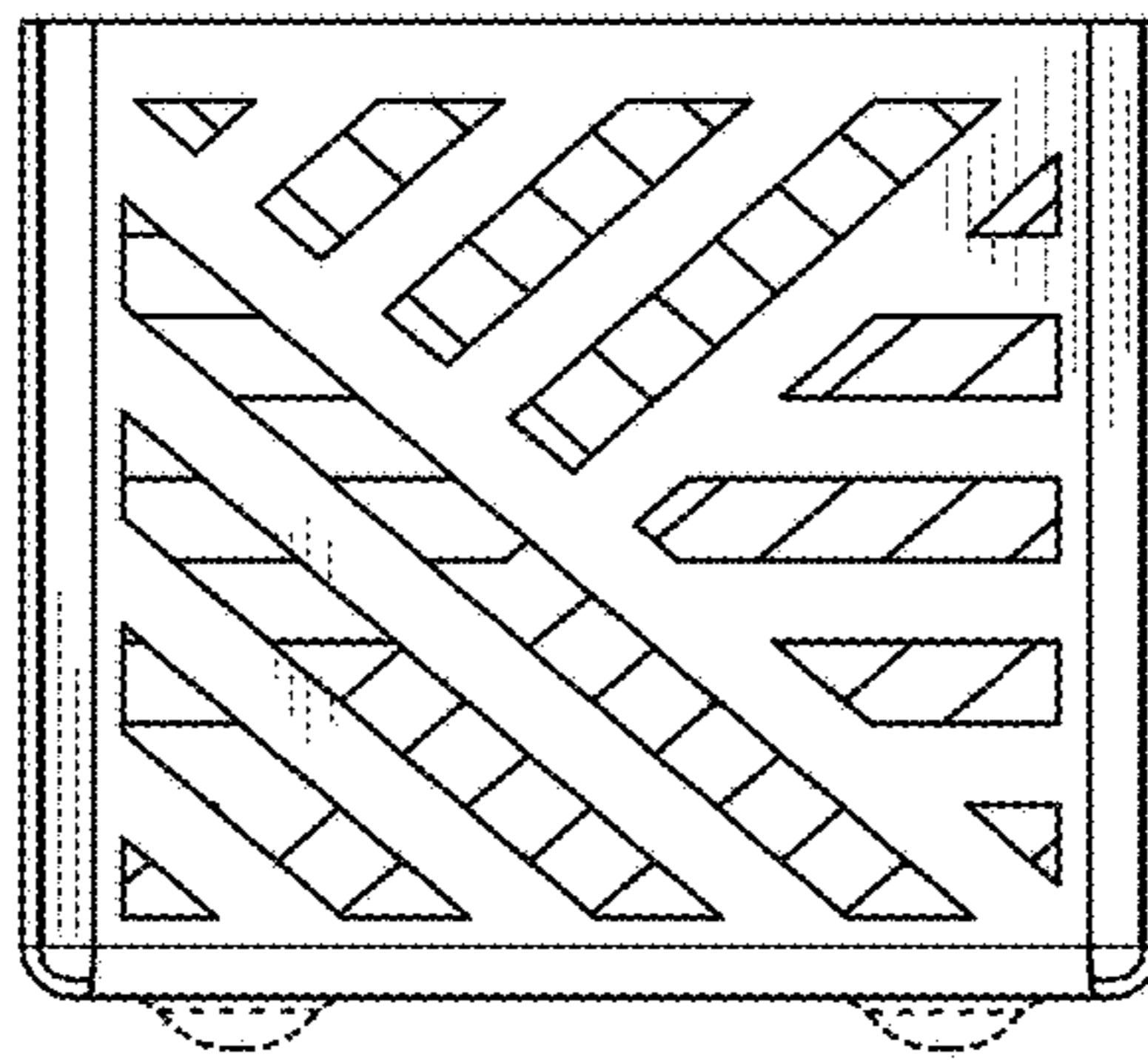

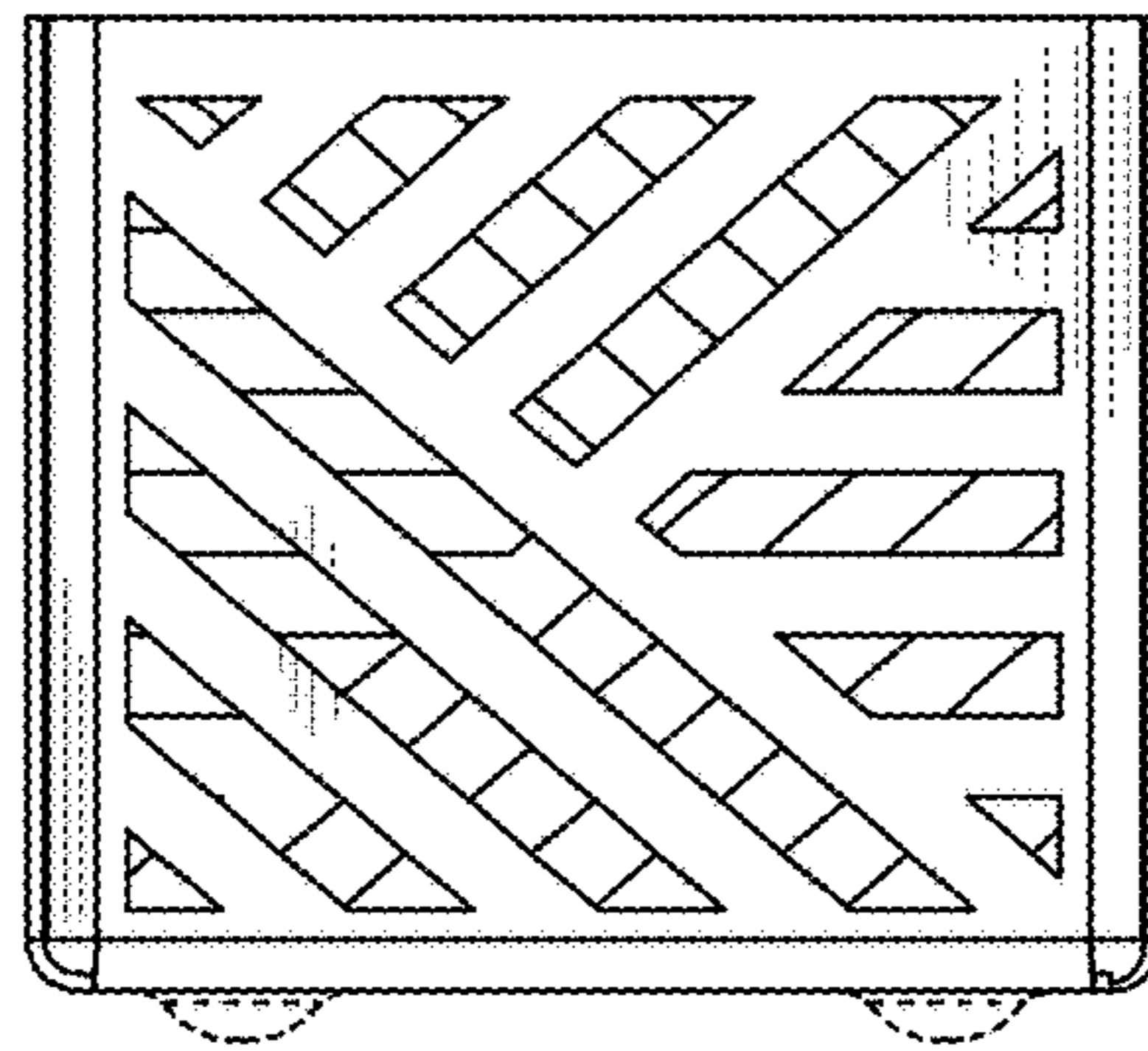

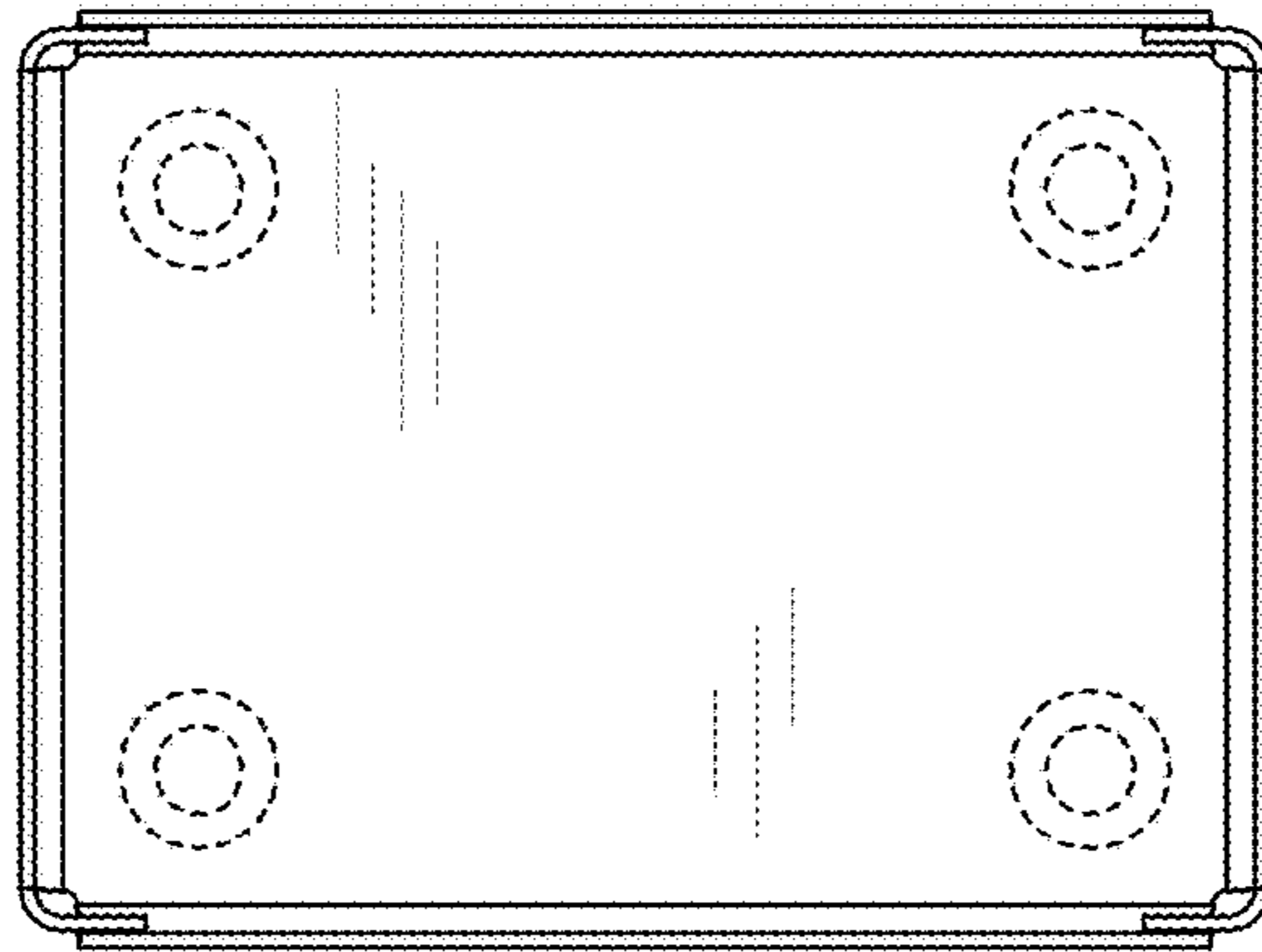

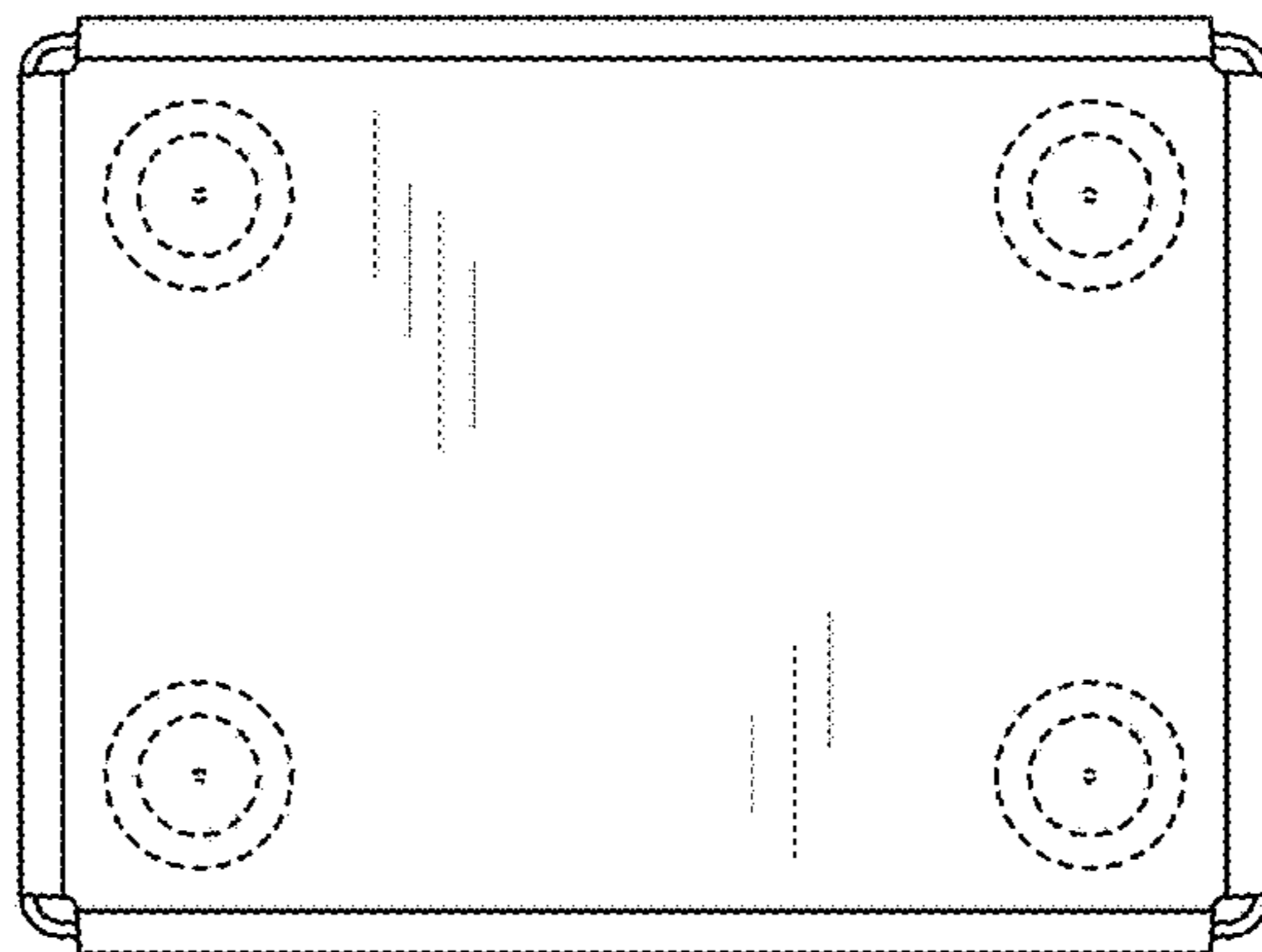
