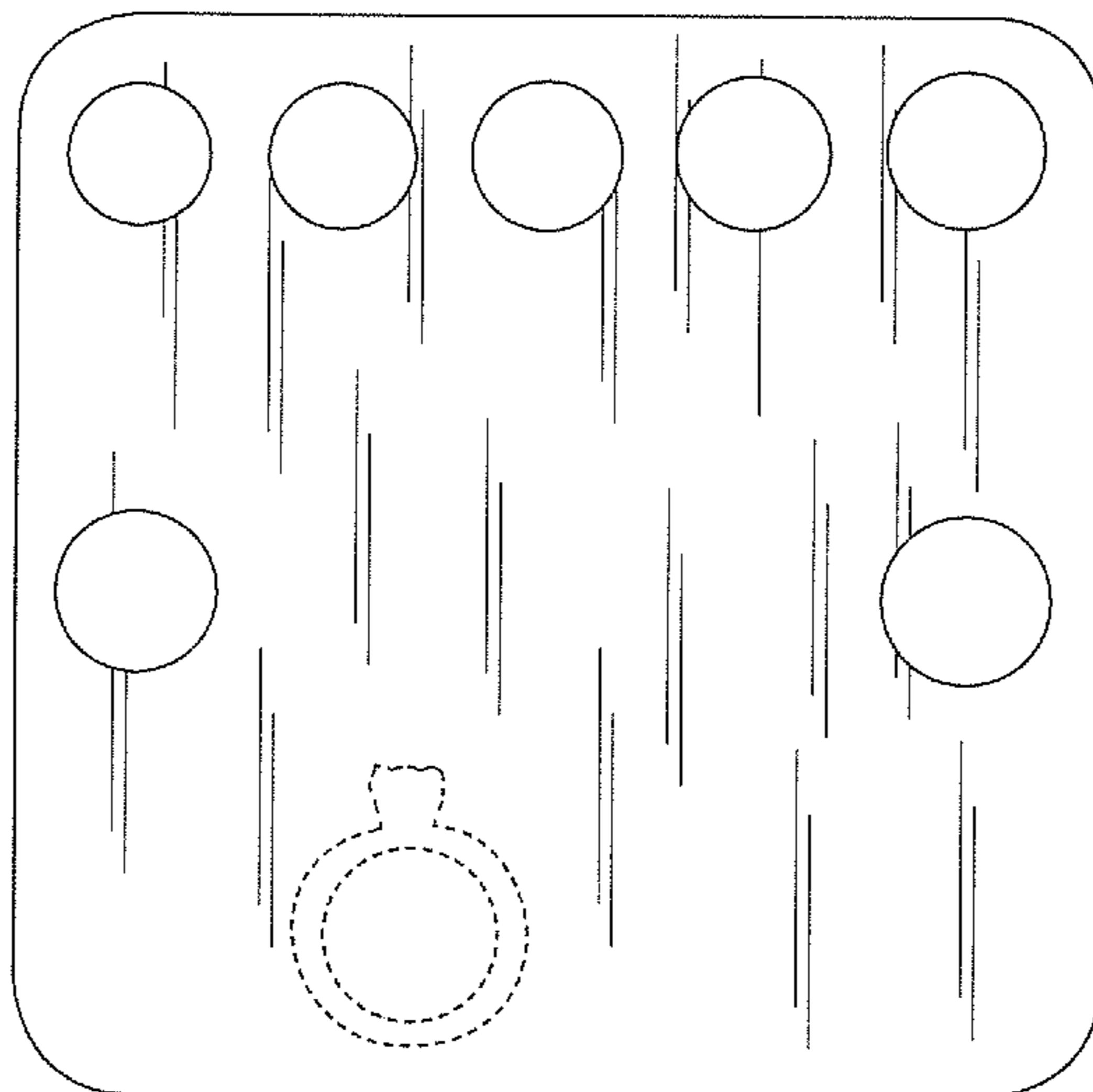
(57) **CLAIM**

The ornamental design for a combination coaster and ring sizer, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a combination coaster and ring sizer showing my new design; FIG. 2 is a bottom plan view thereof; and, FIG. 3 is a side elevation view thereof. The broken lines and the area within them depict portions of the combinations coaster and ring sizer that form no part of the claimed design.

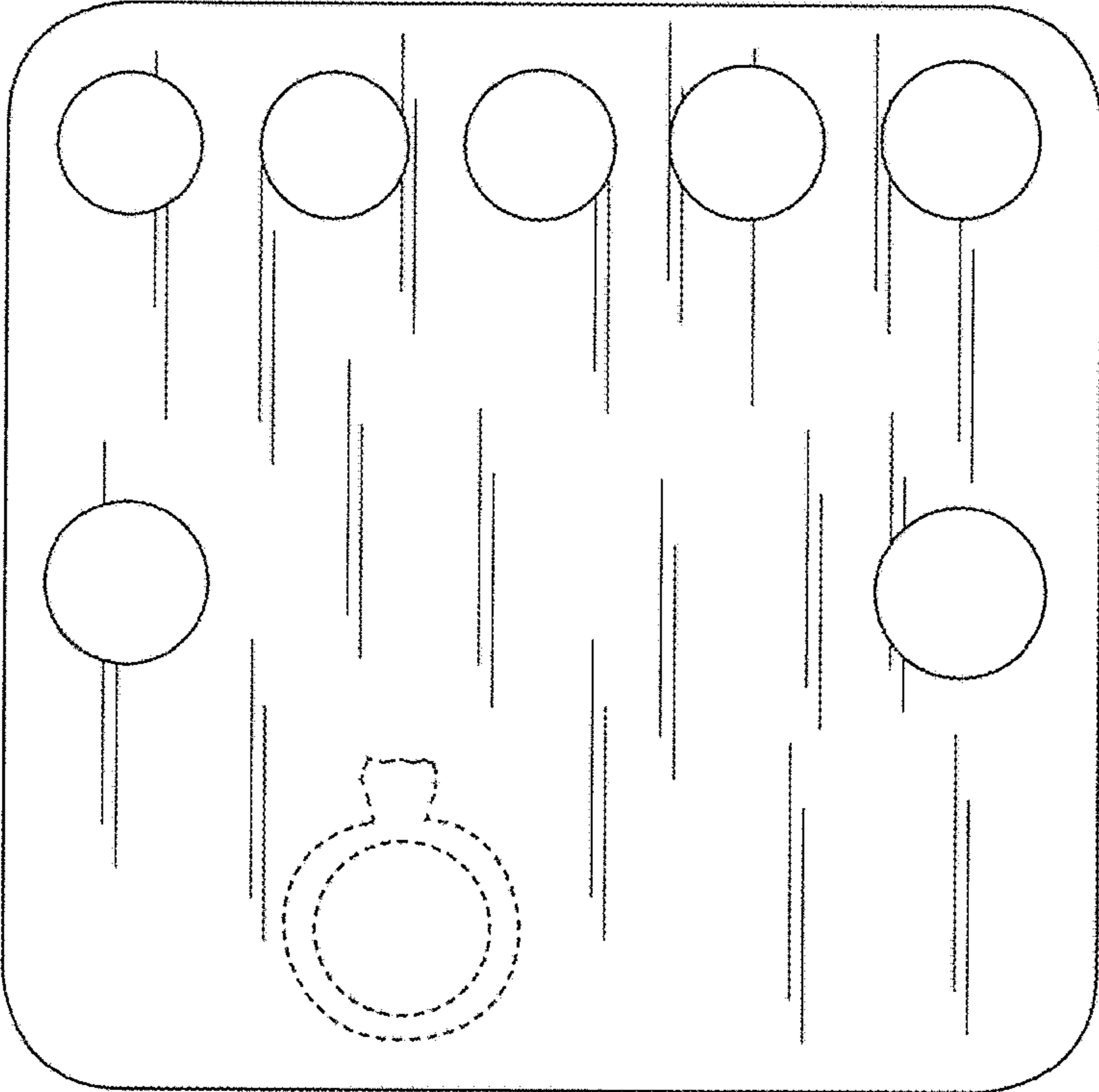

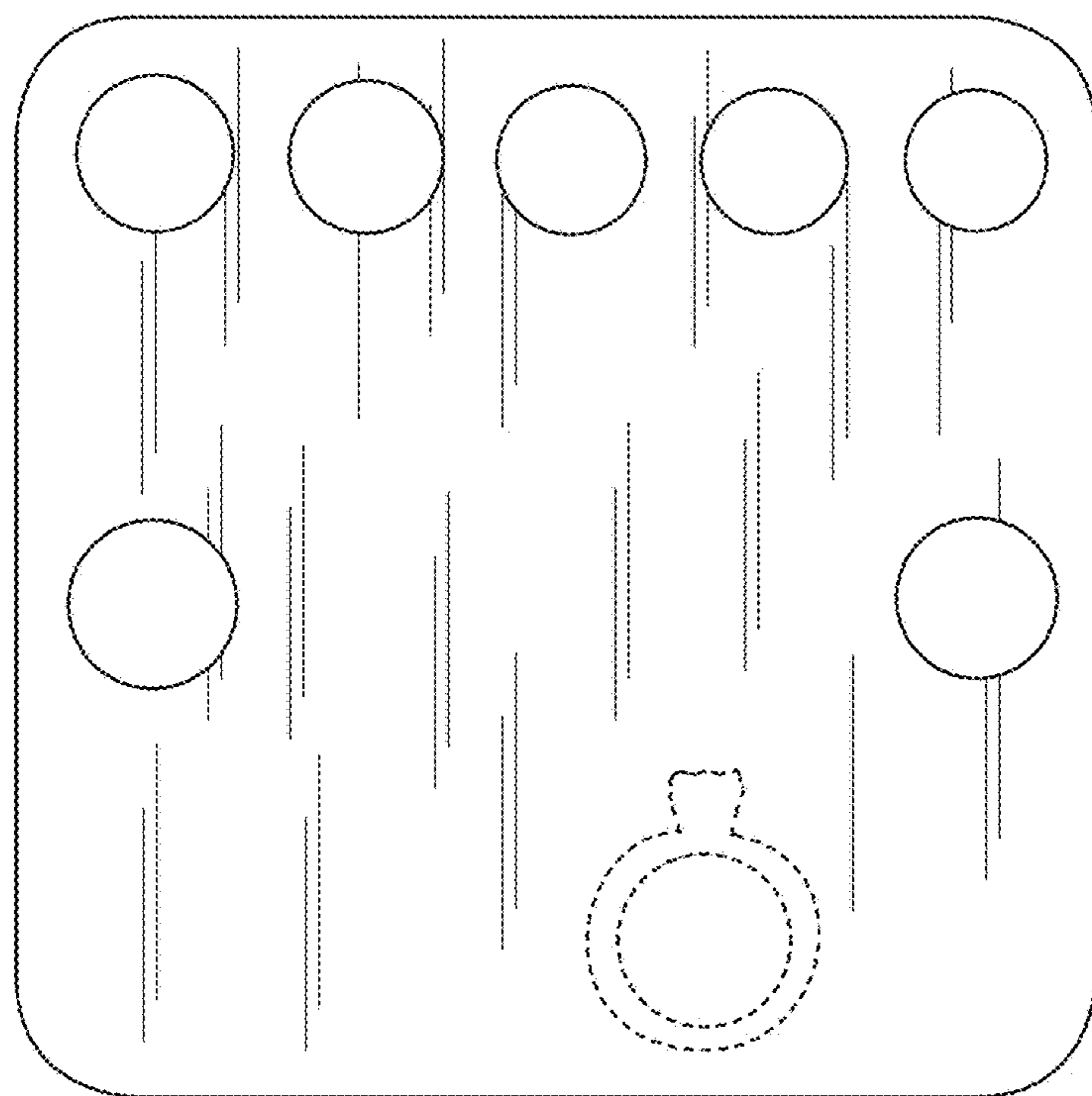

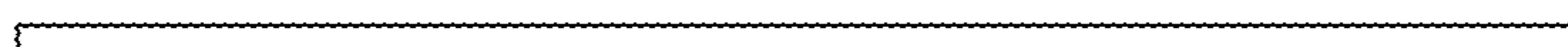
