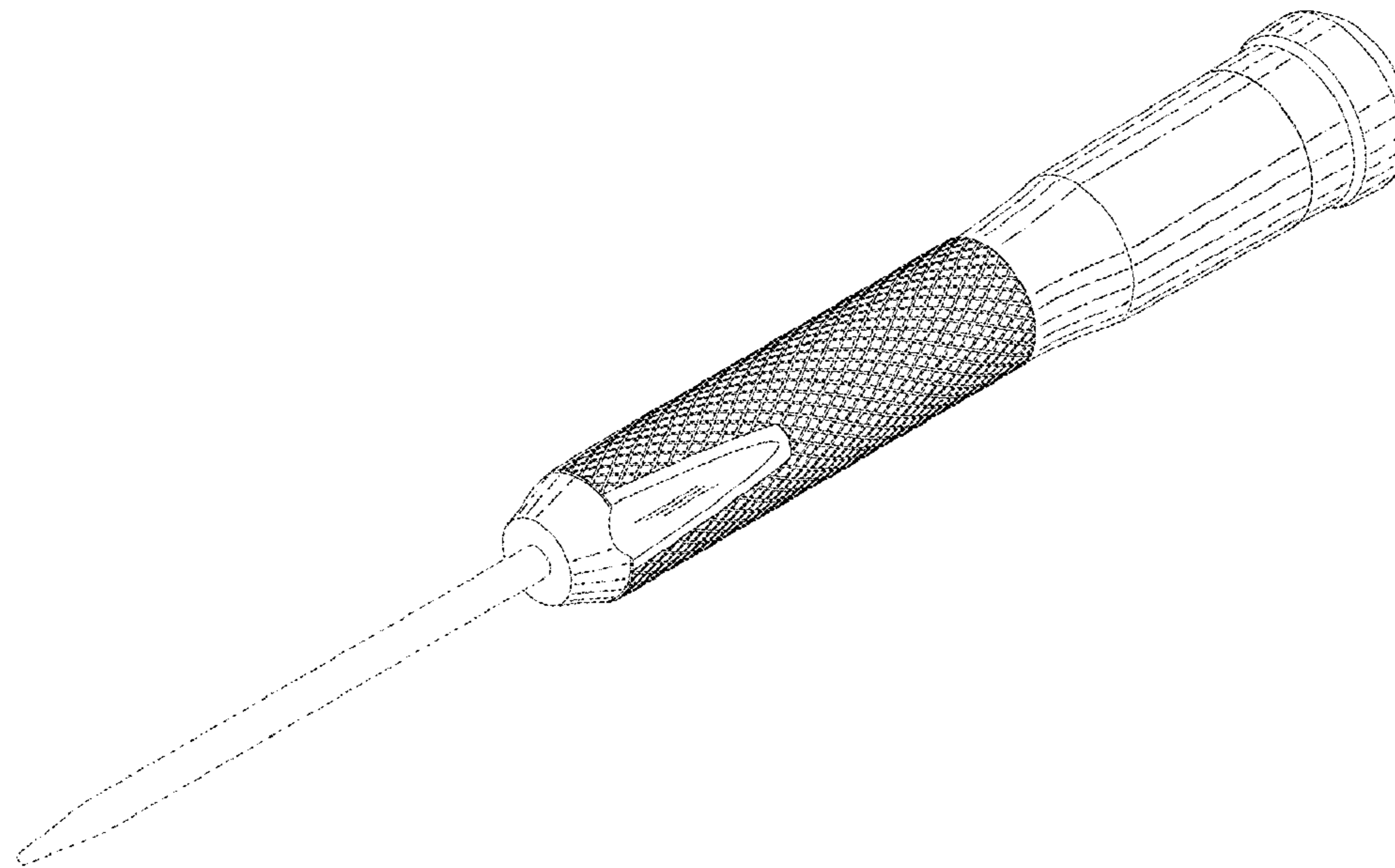
(57) **CLAIM**

The ornamental design for a tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a tool handle showing the new design;
 FIG. 2 is a top view of FIG. 1;
 FIG. 3 is a bottom view of FIG. 1;
 FIG. 4 is a side view of FIG. 1, the opposite side being a mirror image;
 FIG. 5 is a front view of FIG. 1;

 FIG. 7 is a perspective view of a second embodiment of a tool handle showing the new design;

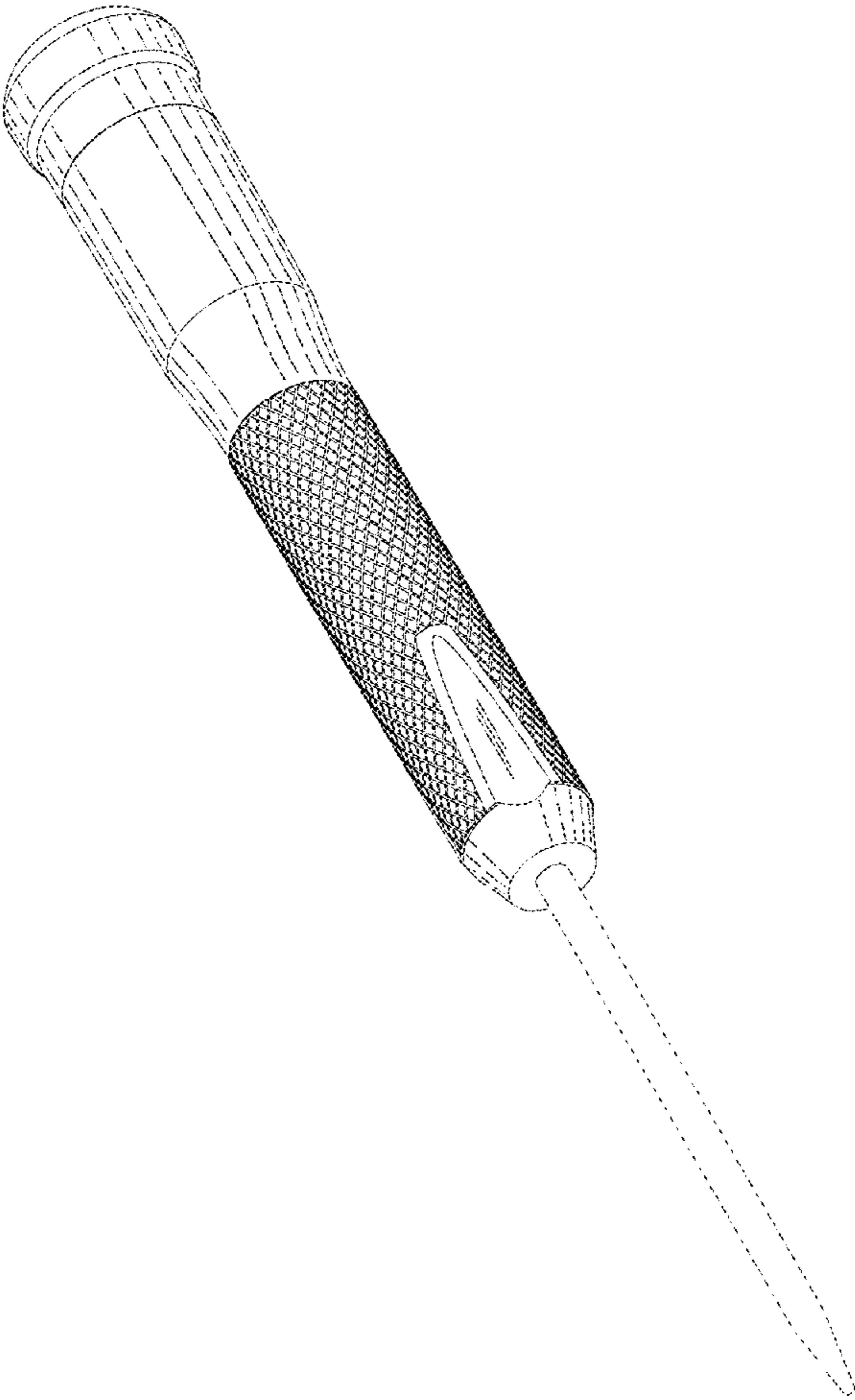

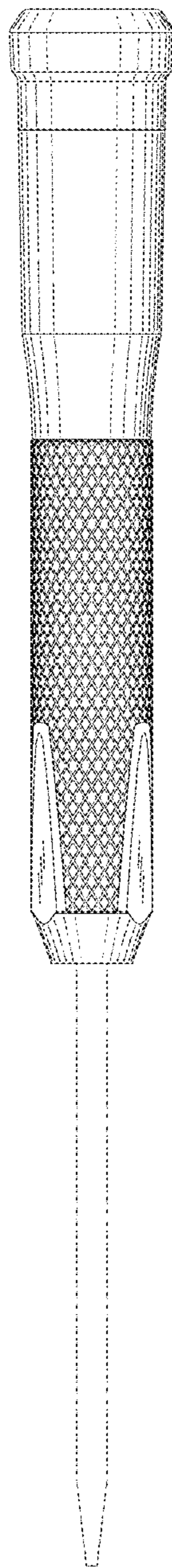

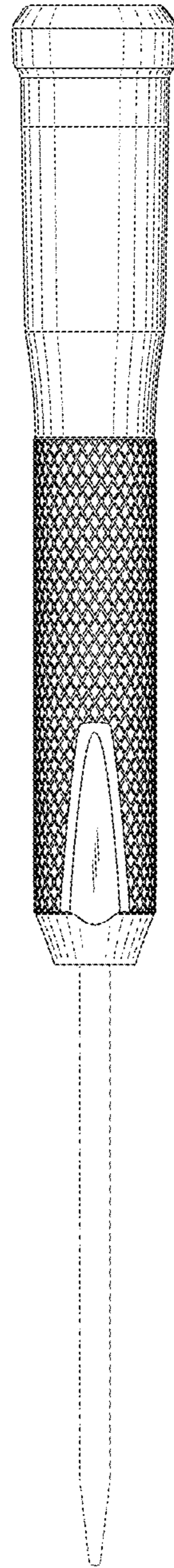

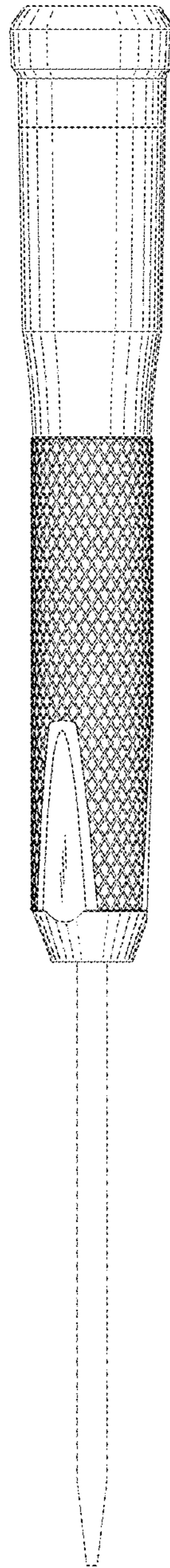

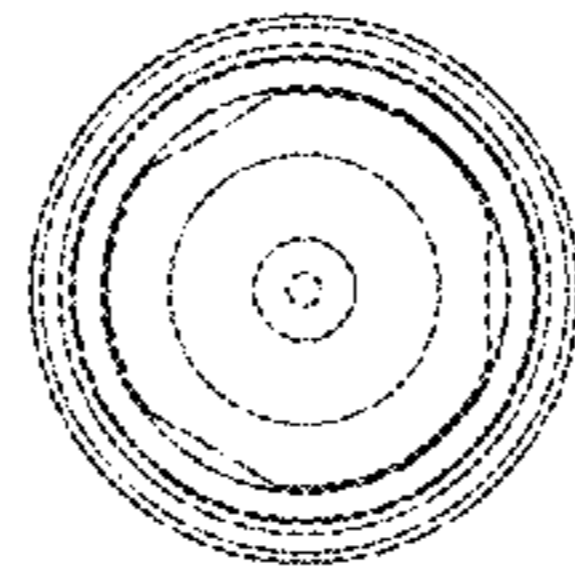

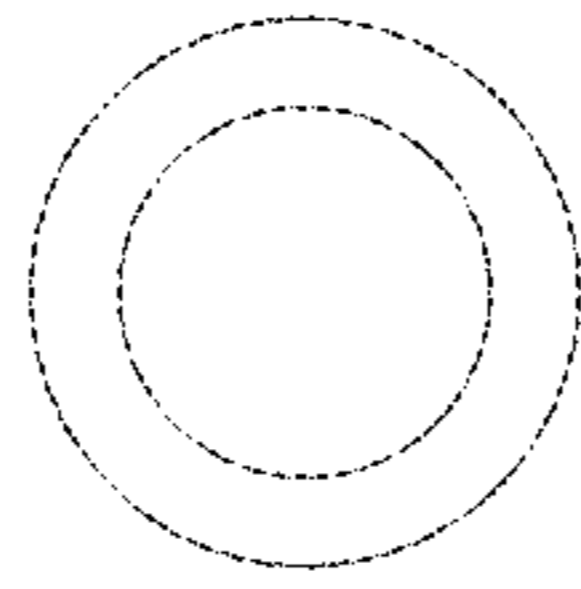

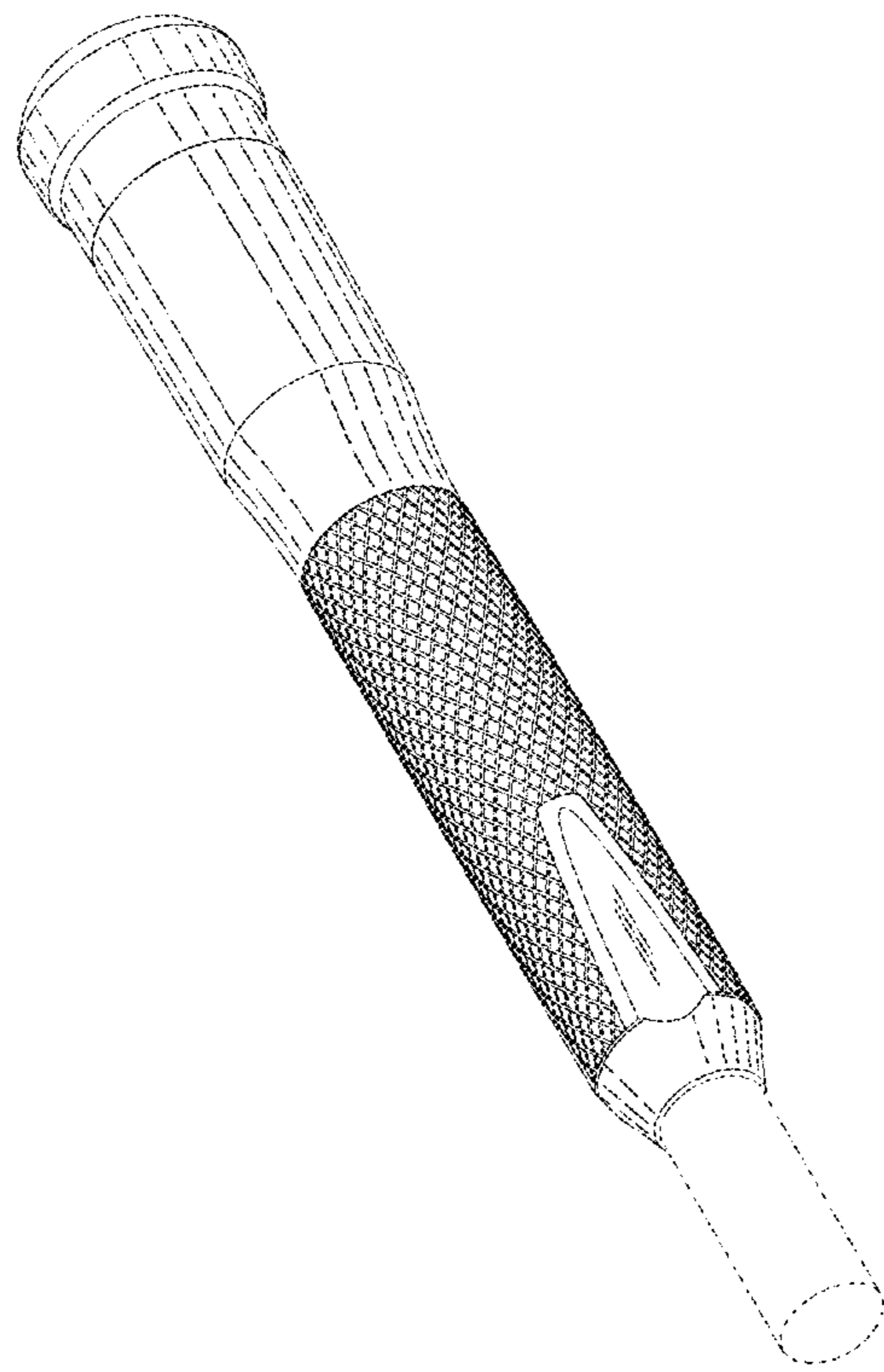

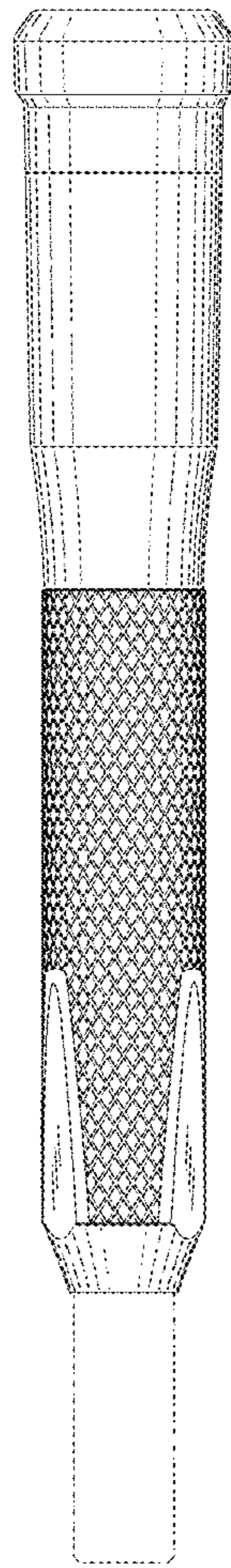

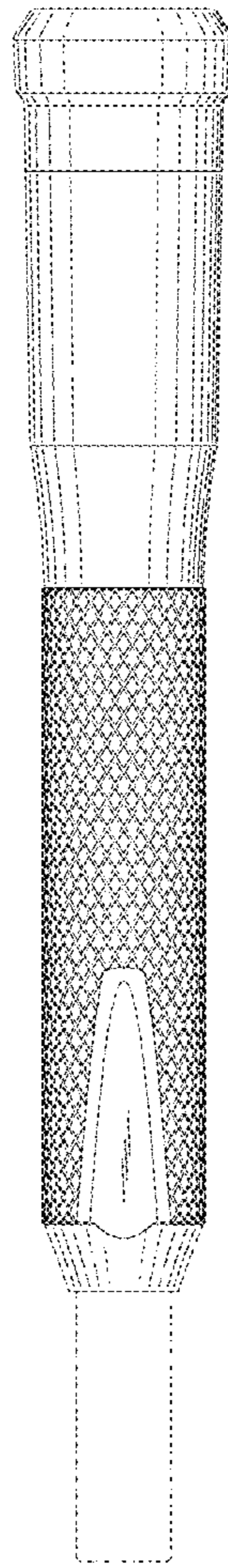

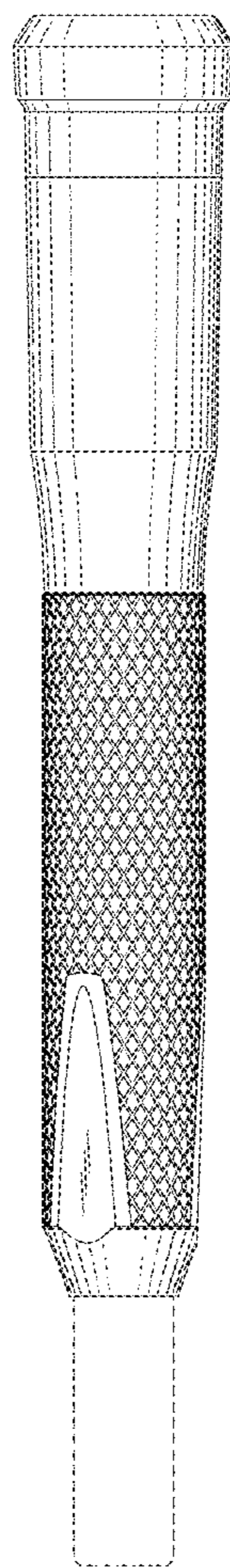

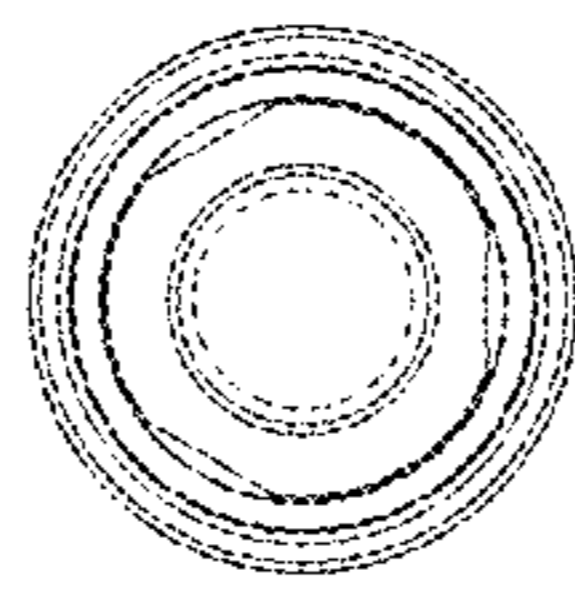

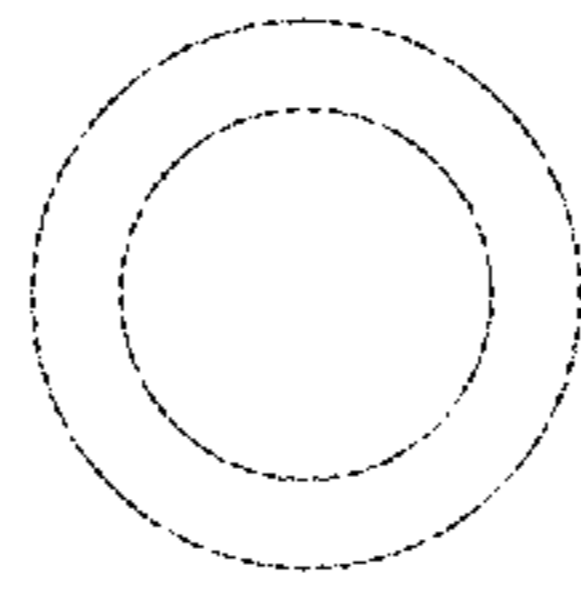
