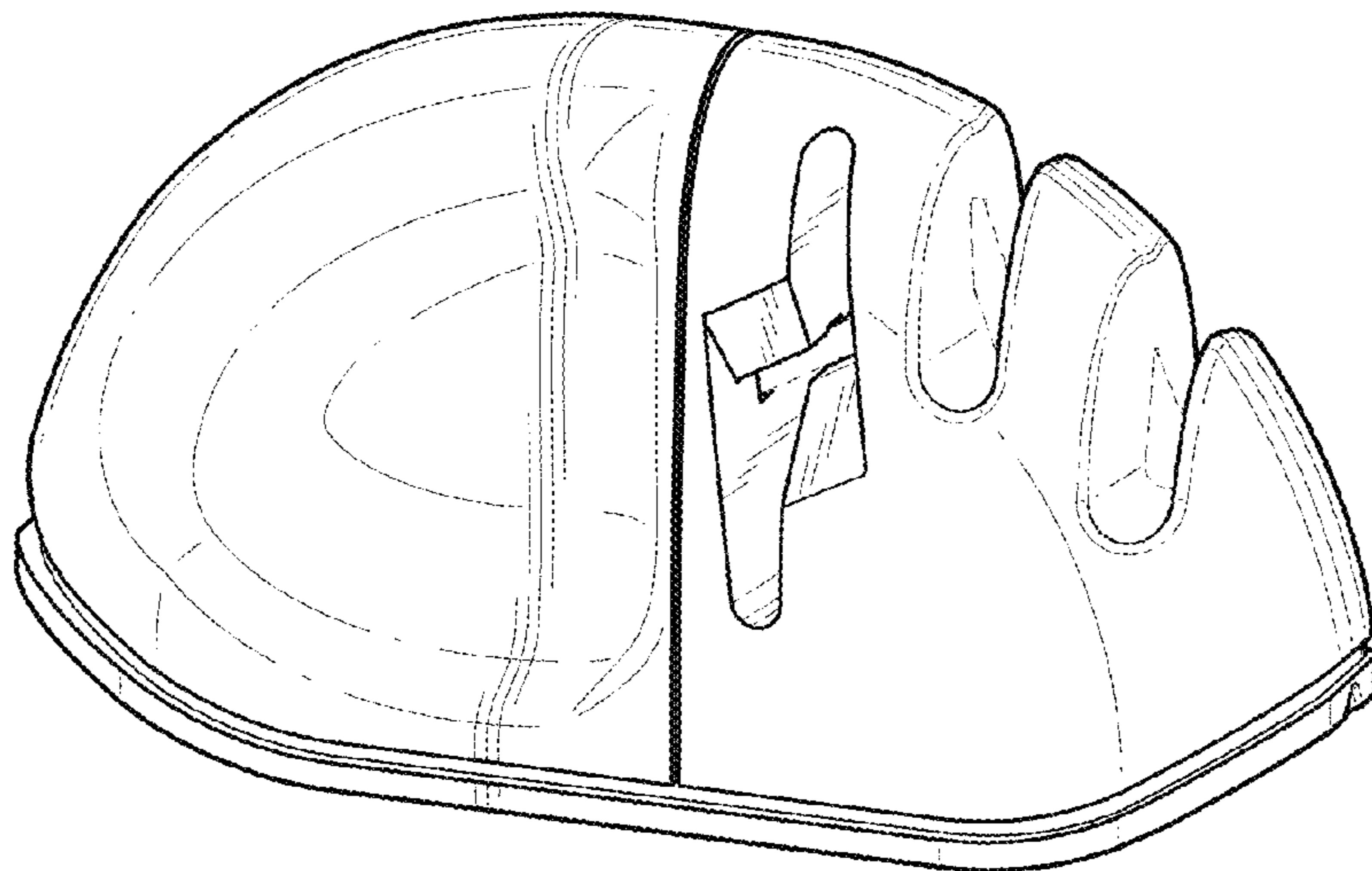
(57) **CLAIM**
The ornamental design for a knife sharpener, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knife sharpener embodying the new design;
FIG. 2 is a right side elevation view of the knife sharpener, the left side elevation view being a mirror image of the right side;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear elevation view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines depict portions of the knife sharpener in which the design is embodied that are not considered part of the claimed design.

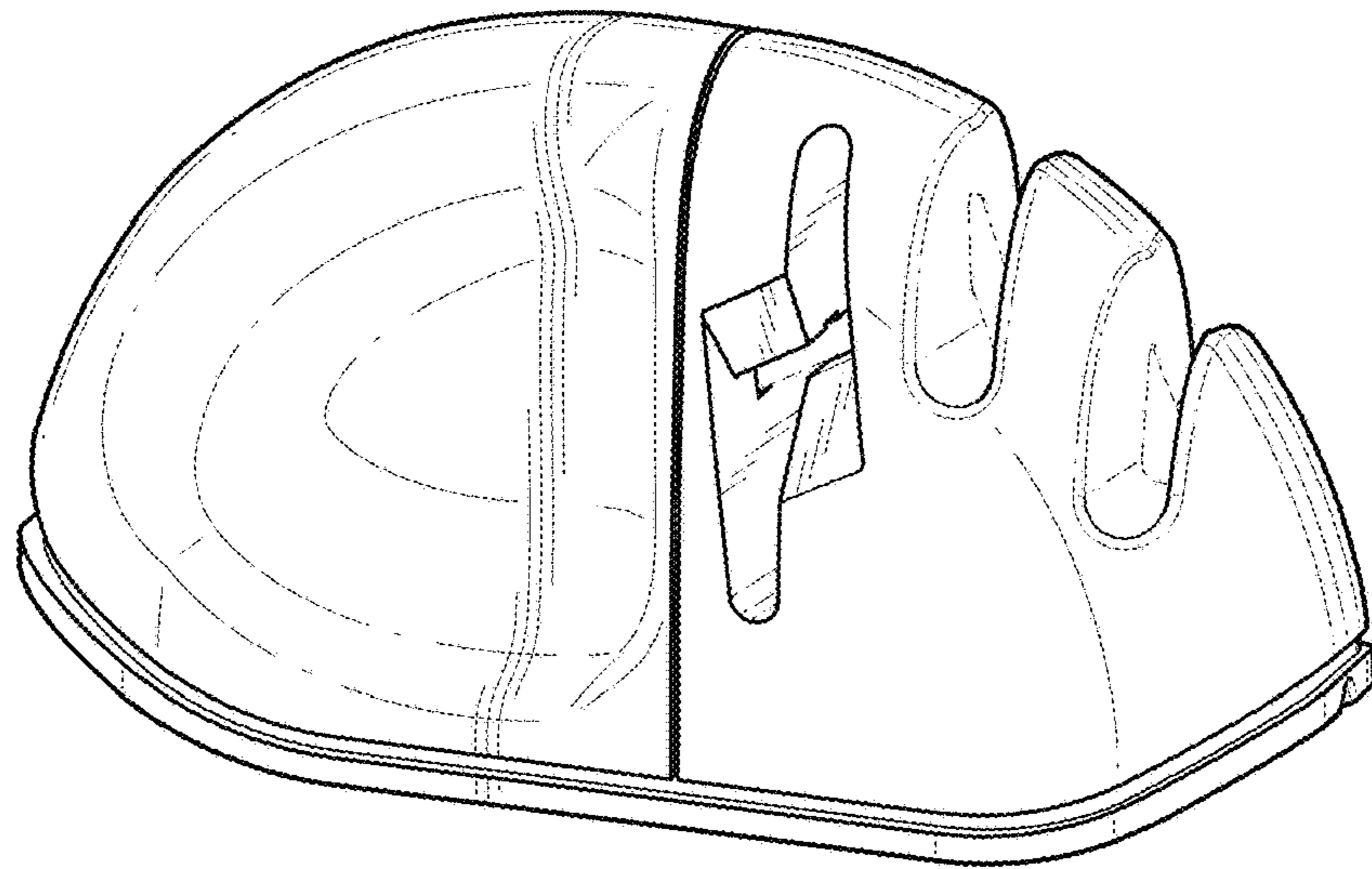

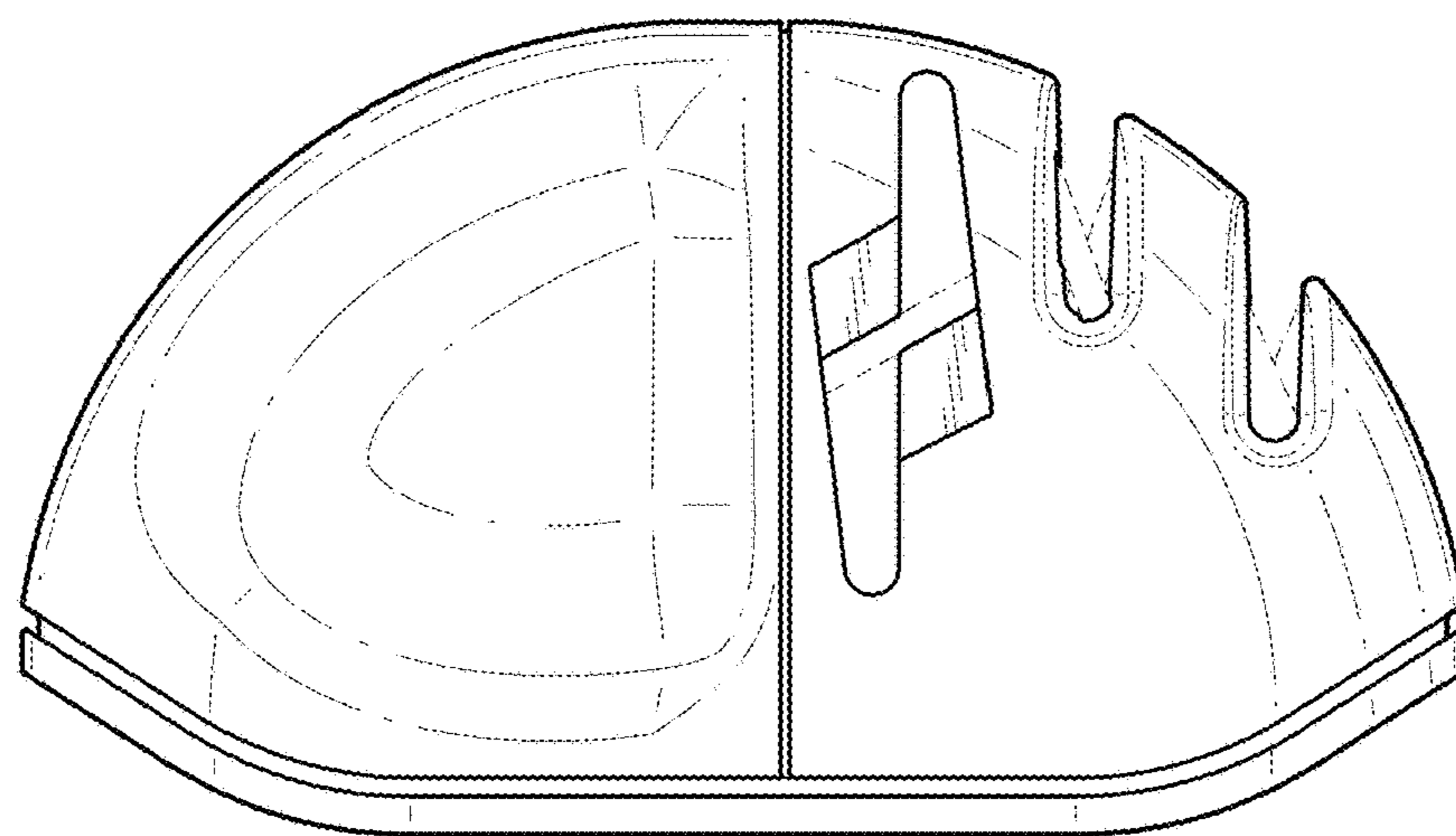

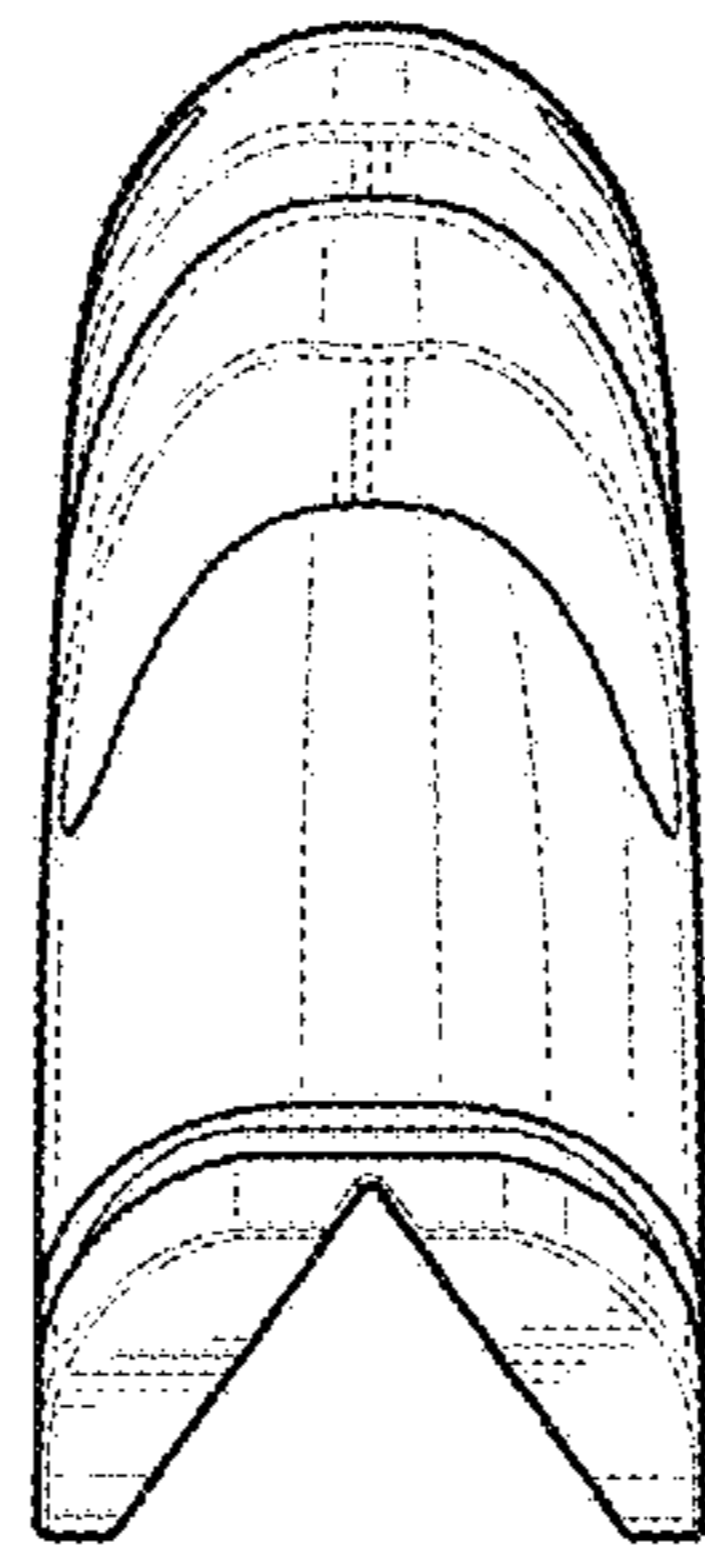

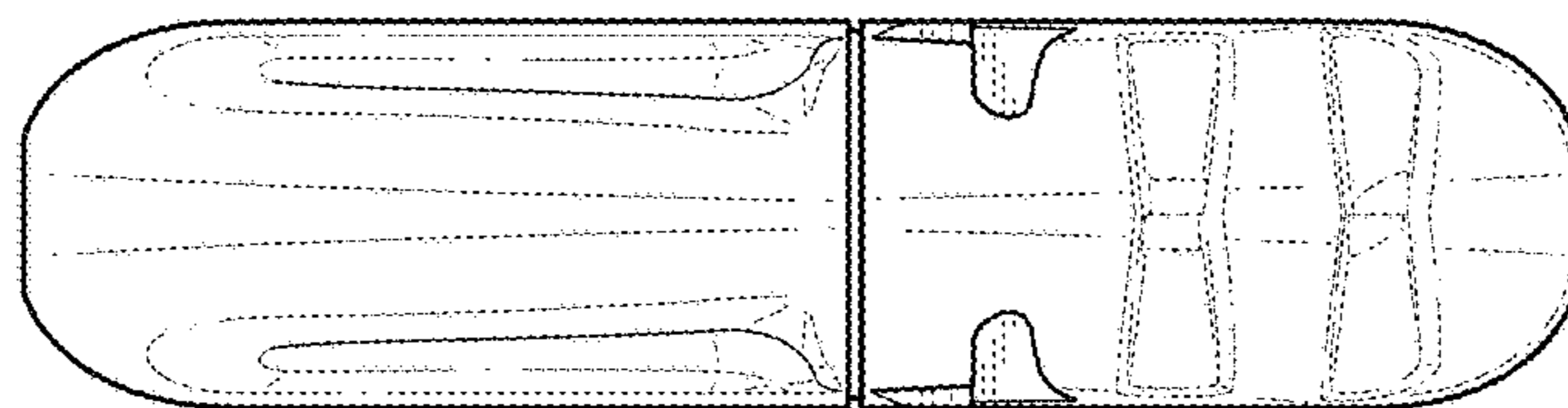

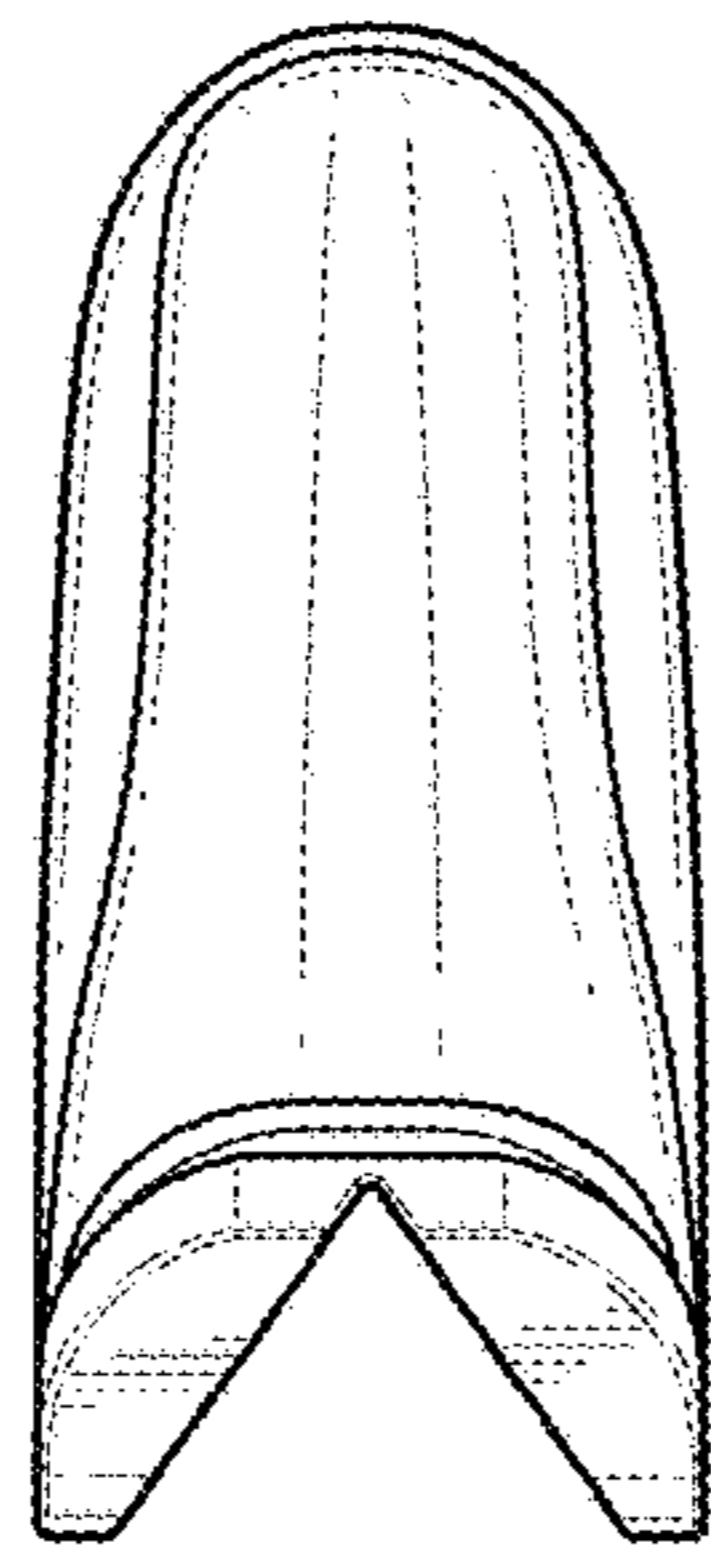

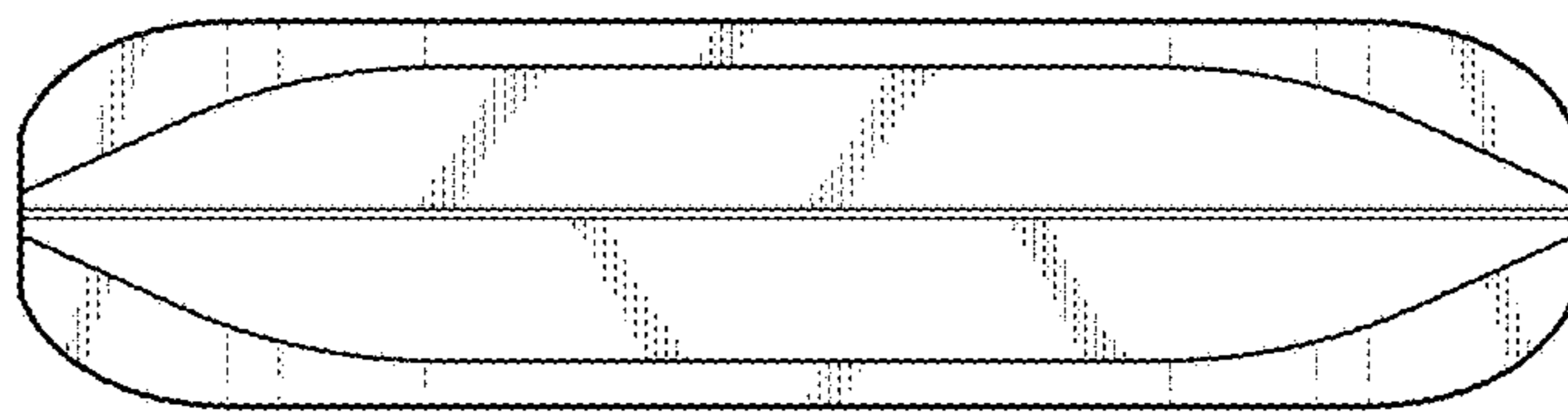
