(57) **CLAIM**

The ornamental design for a packaging receptacle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left-side isometric view of a packaging receptacle showing the new design.

FIG. 2 is a top plan view of the packaging receptacle.

FIG. 3 is a left-side elevation view of the packaging receptacle.

FIG. 4 is a front elevation view of the packaging receptacle.

FIG. 5 is a right-side elevation view of the packaging receptacle.

FIG. 6 is a back elevation view of the packaging receptacle.

FIG. 7 is a bottom, back, and right-side isometric view of the packaging receptacle.

FIG. 8 is a bottom plan view of the packaging receptacle.

FIG. 9 is a top, front, and right-side isometric view of the packaging receptacle.

FIG. 10 is a bottom, front, and right-side isometric view of the packaging receptacle.

FIG. 11 is a bottom, front, and left-side isometric view of the packaging receptacle.

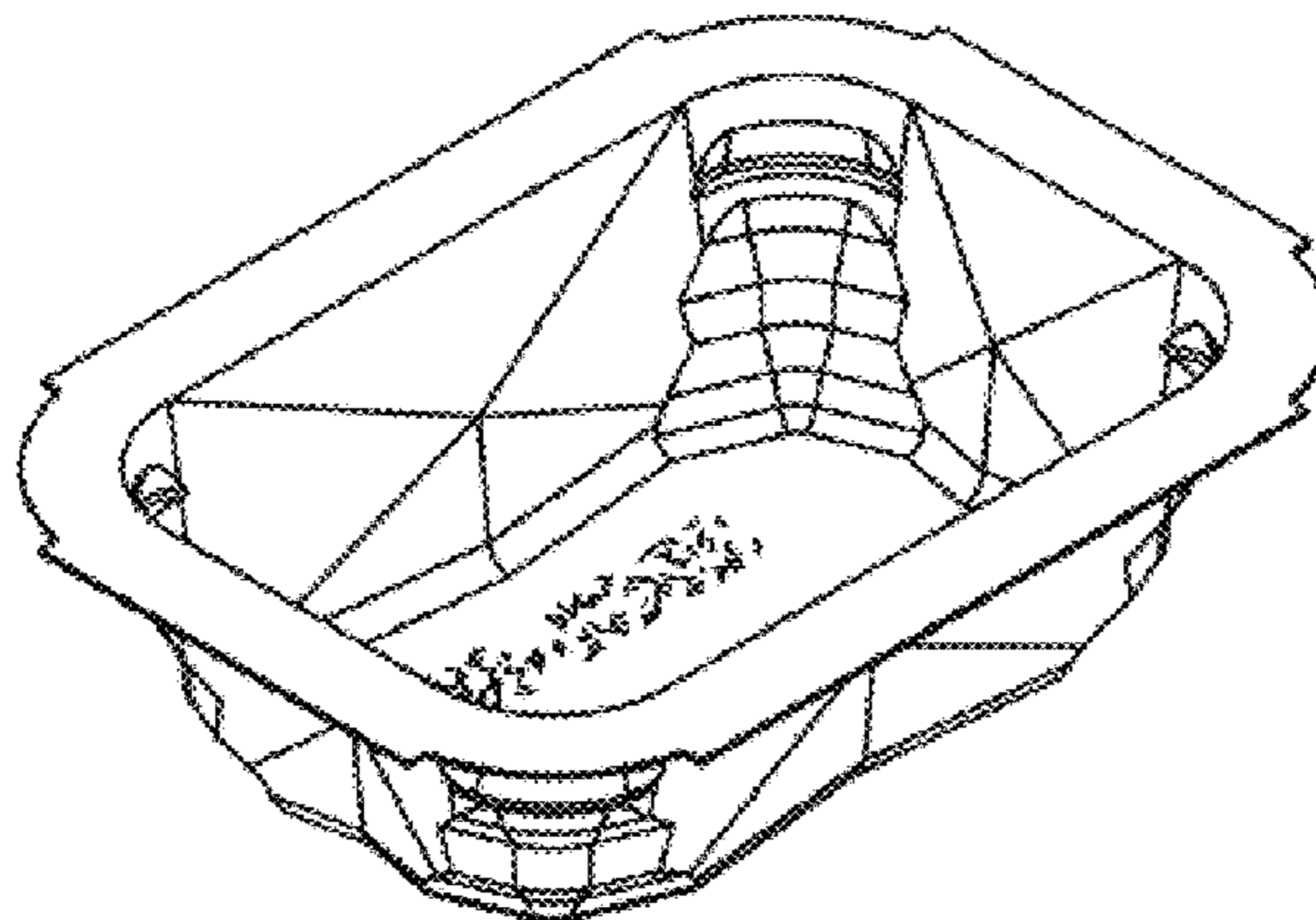
FIG. 12 is a top, back, and right-side isometric view of the packaging receptacle.

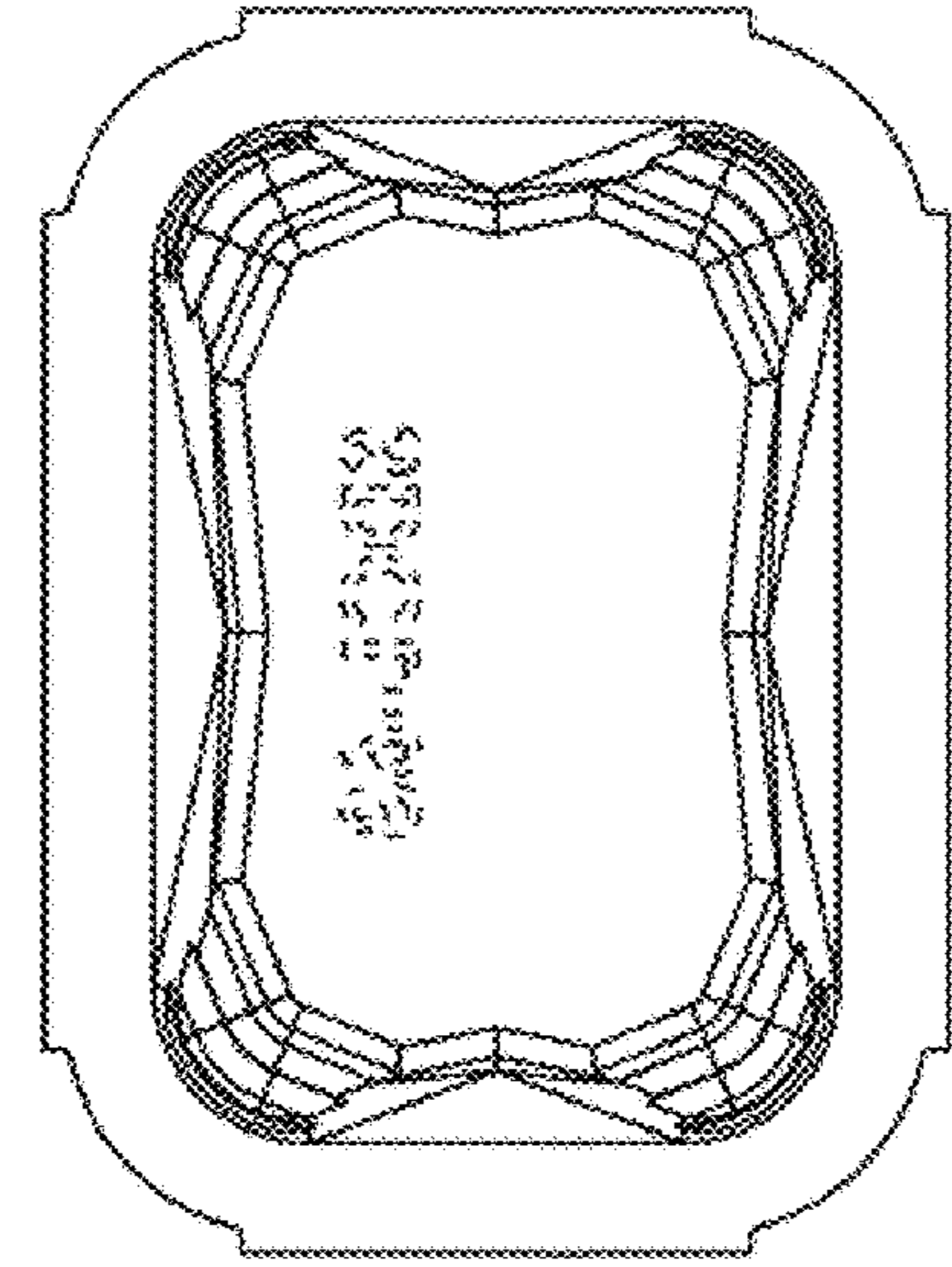

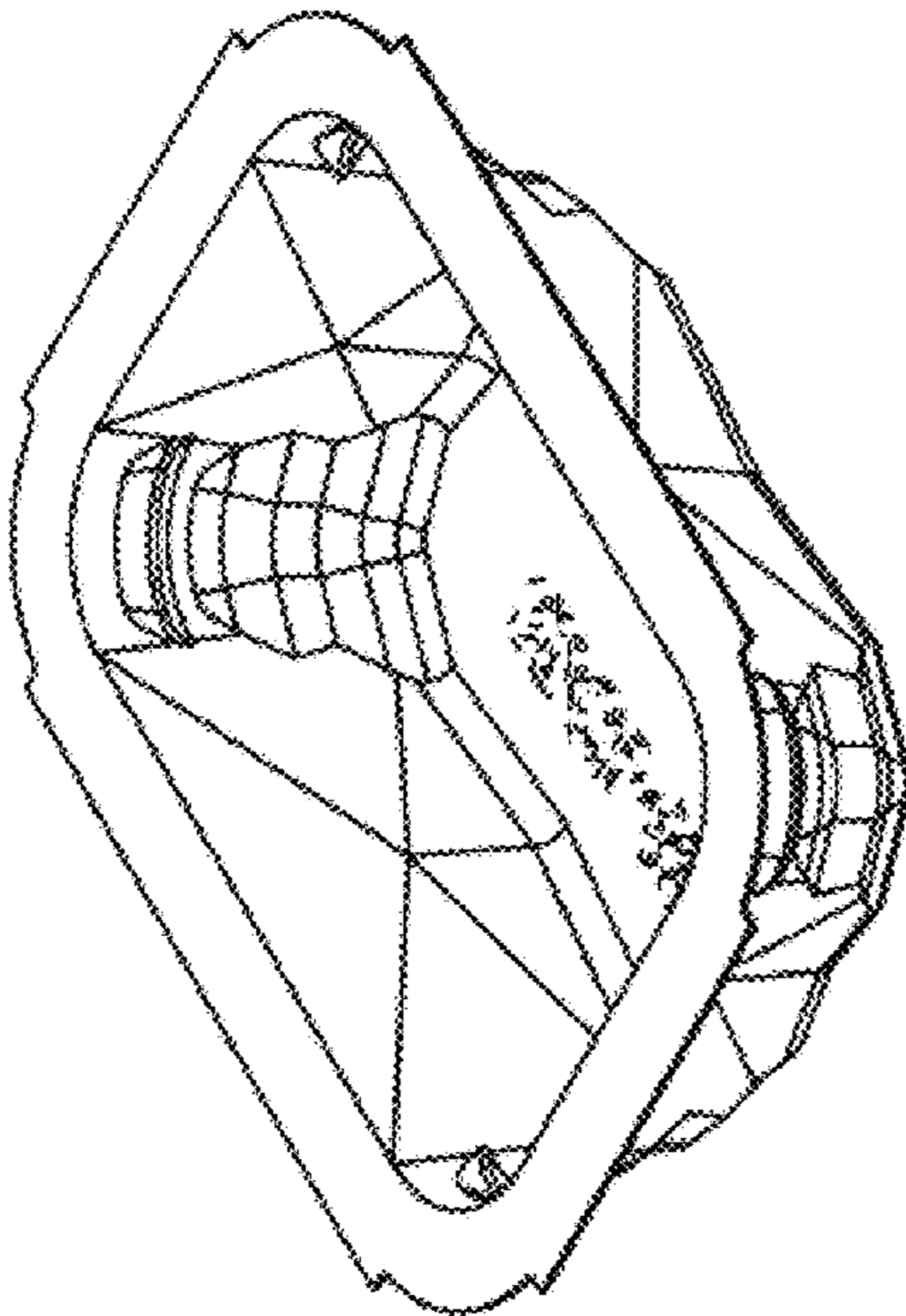

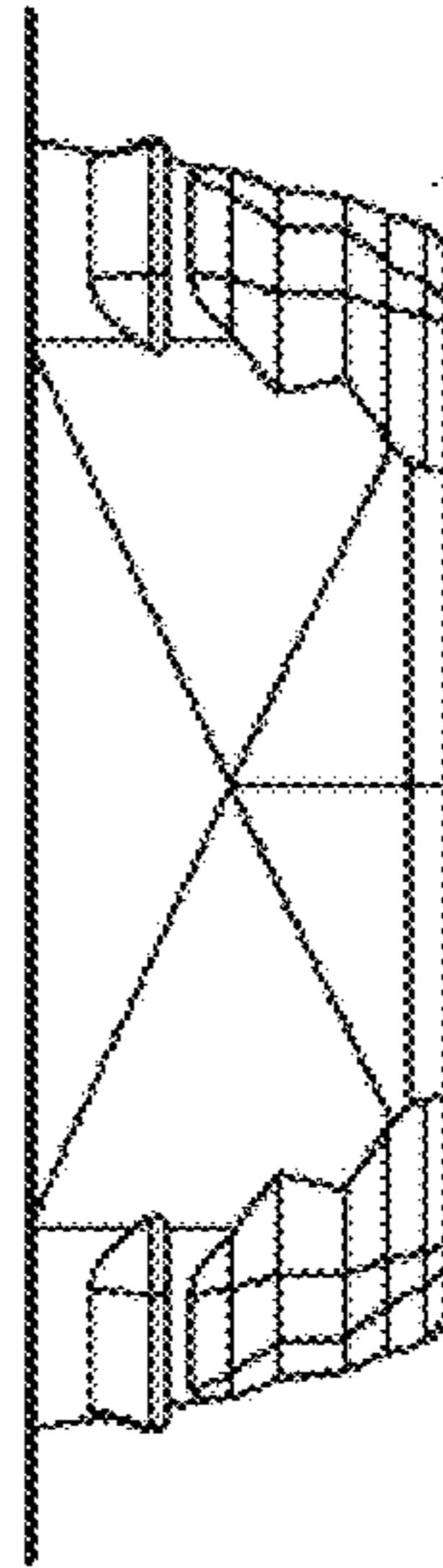

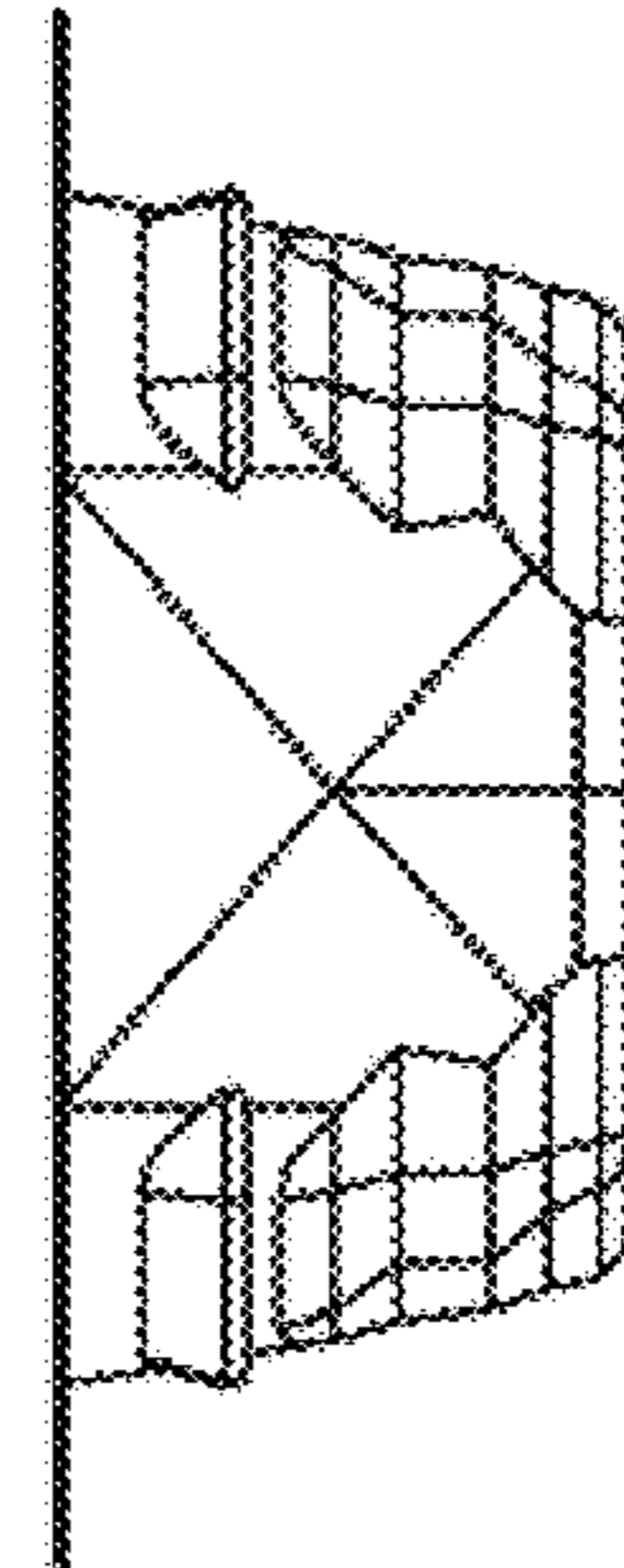

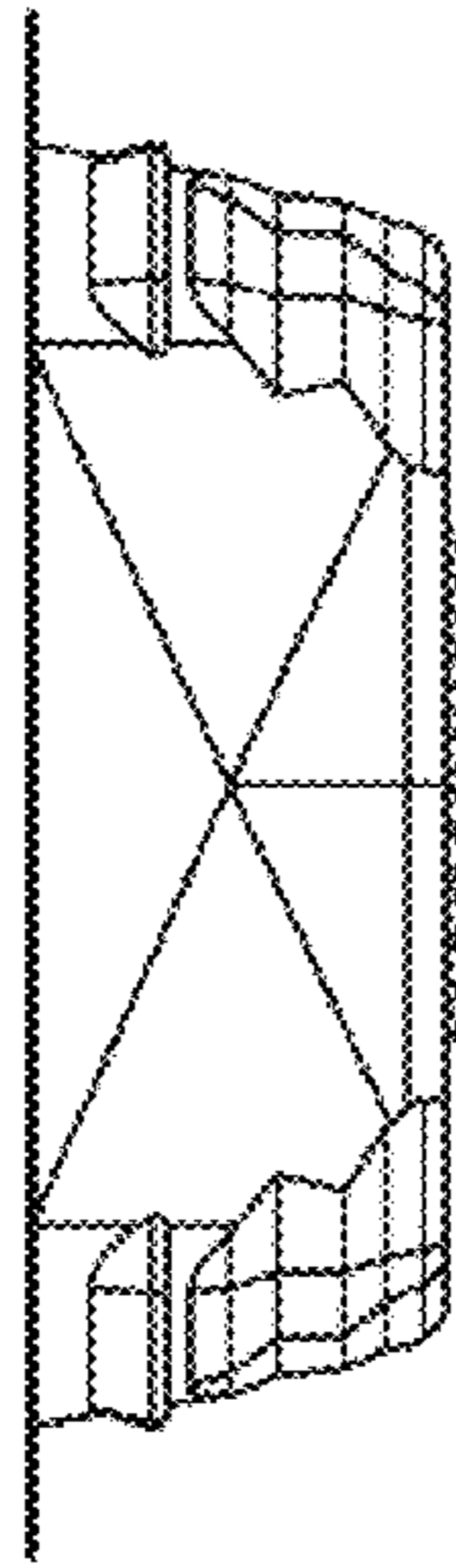

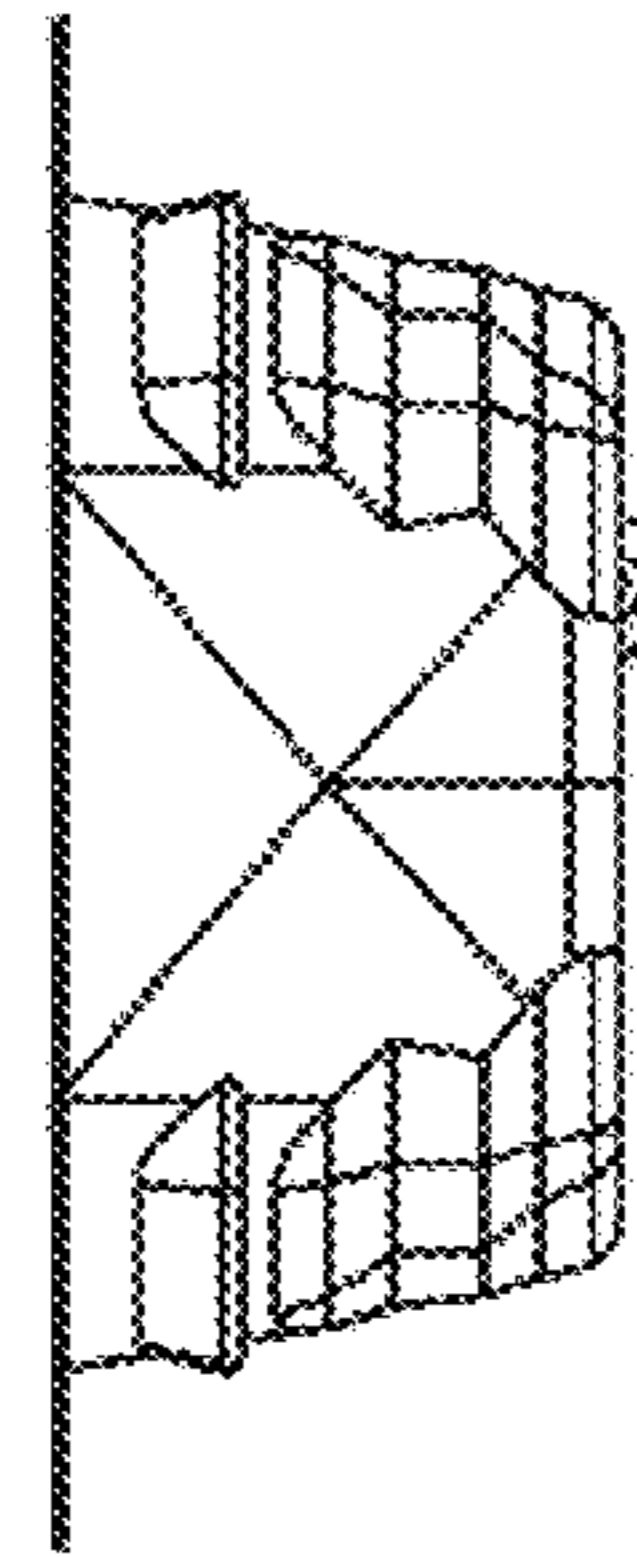

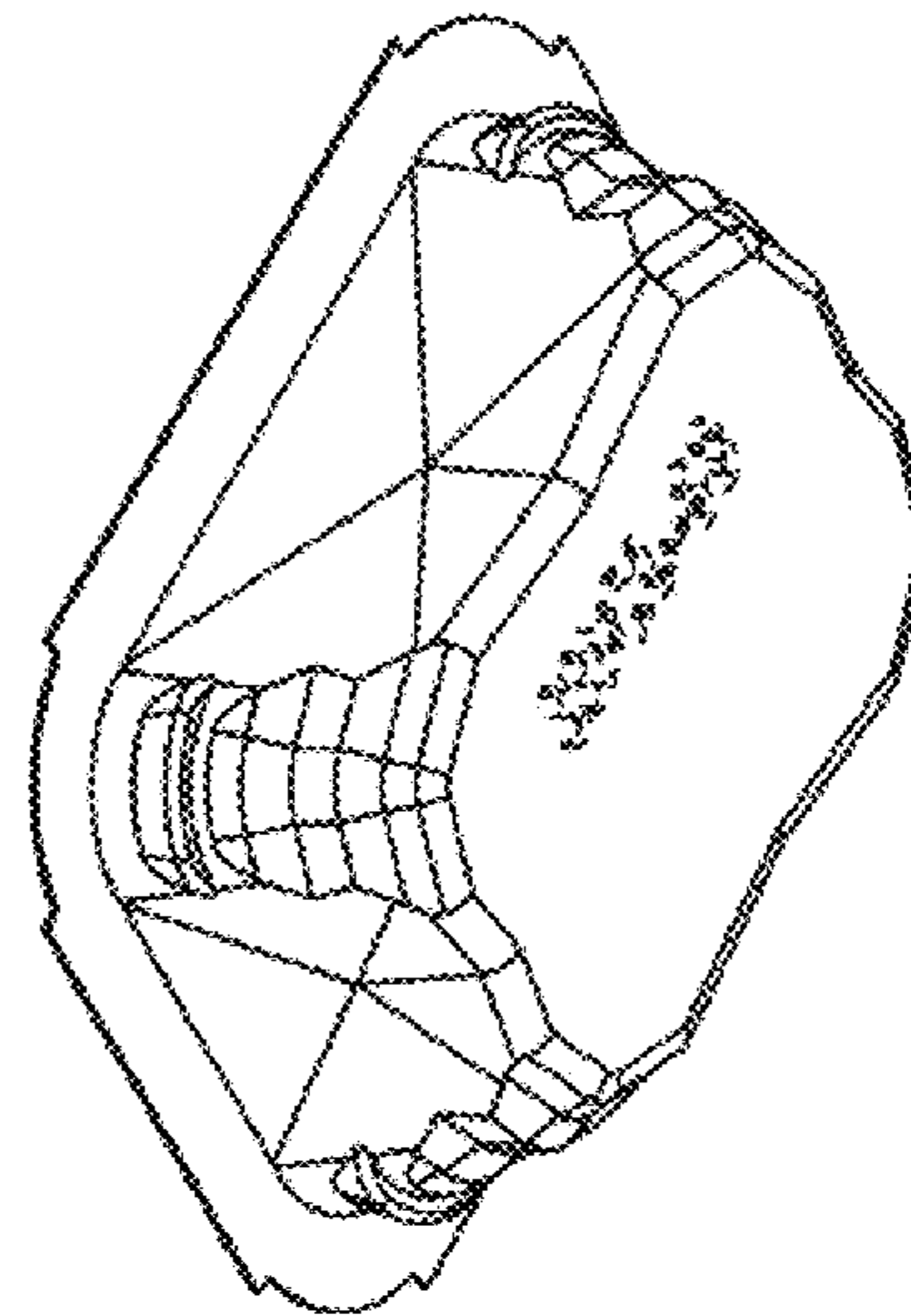

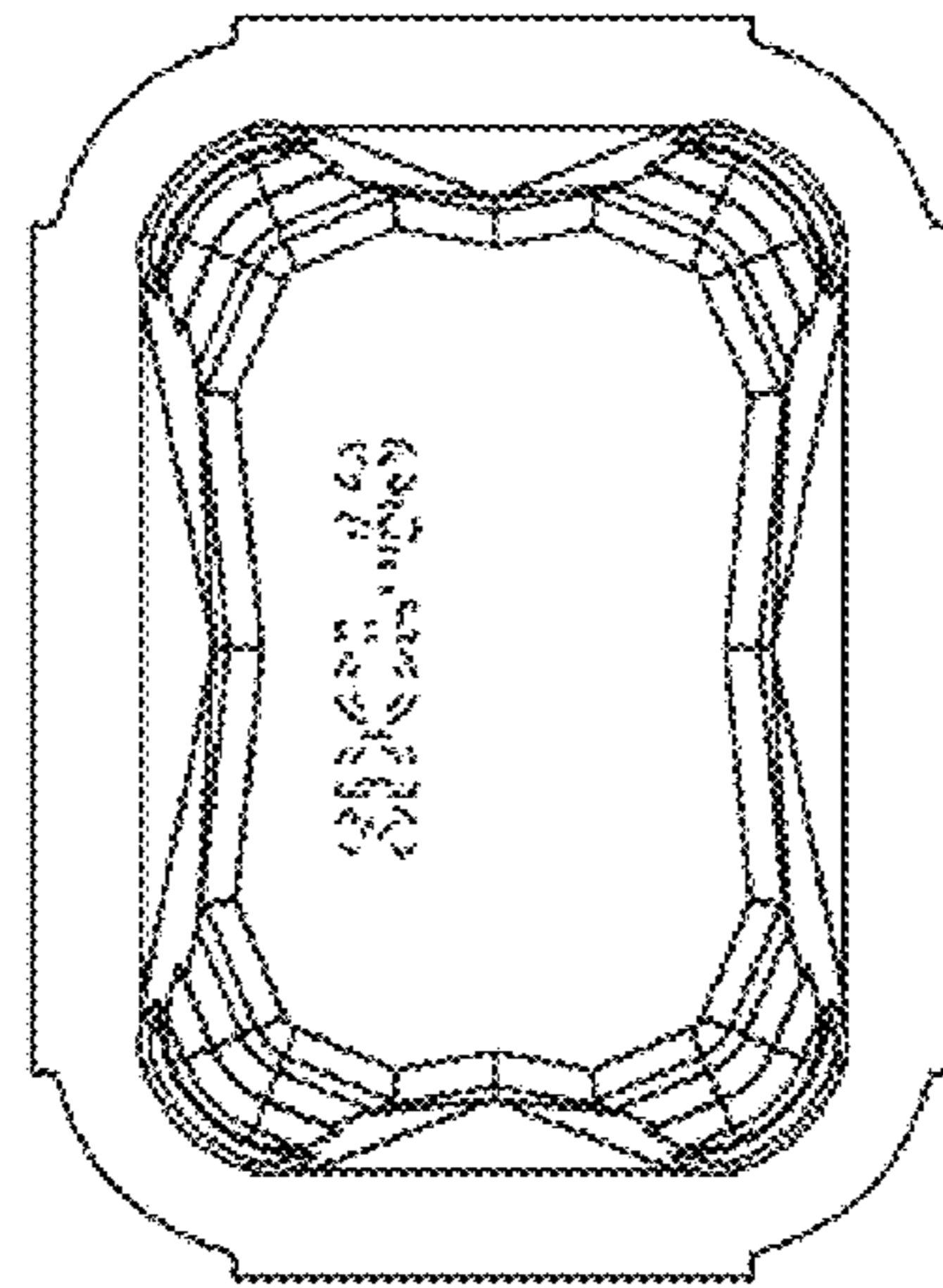

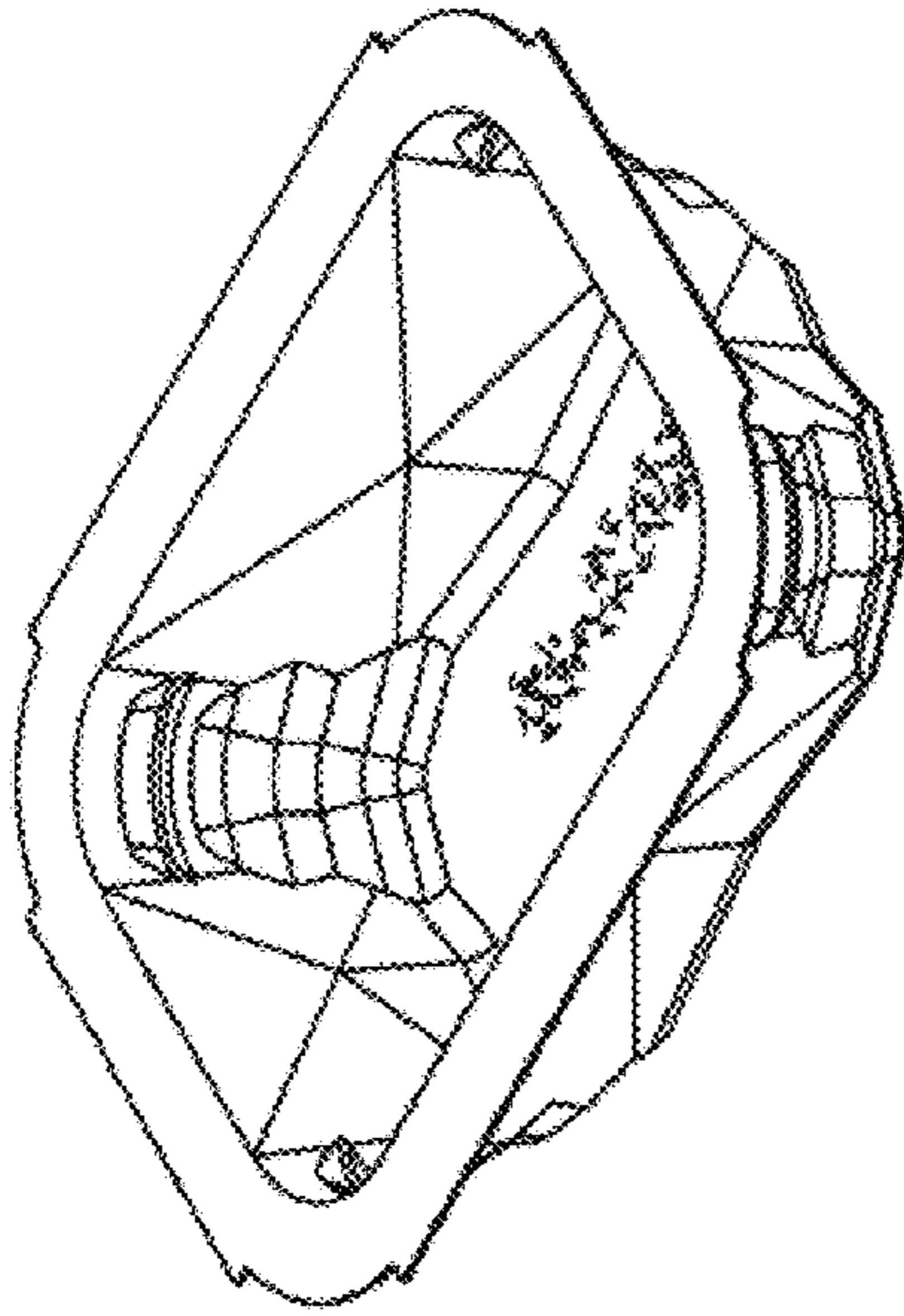

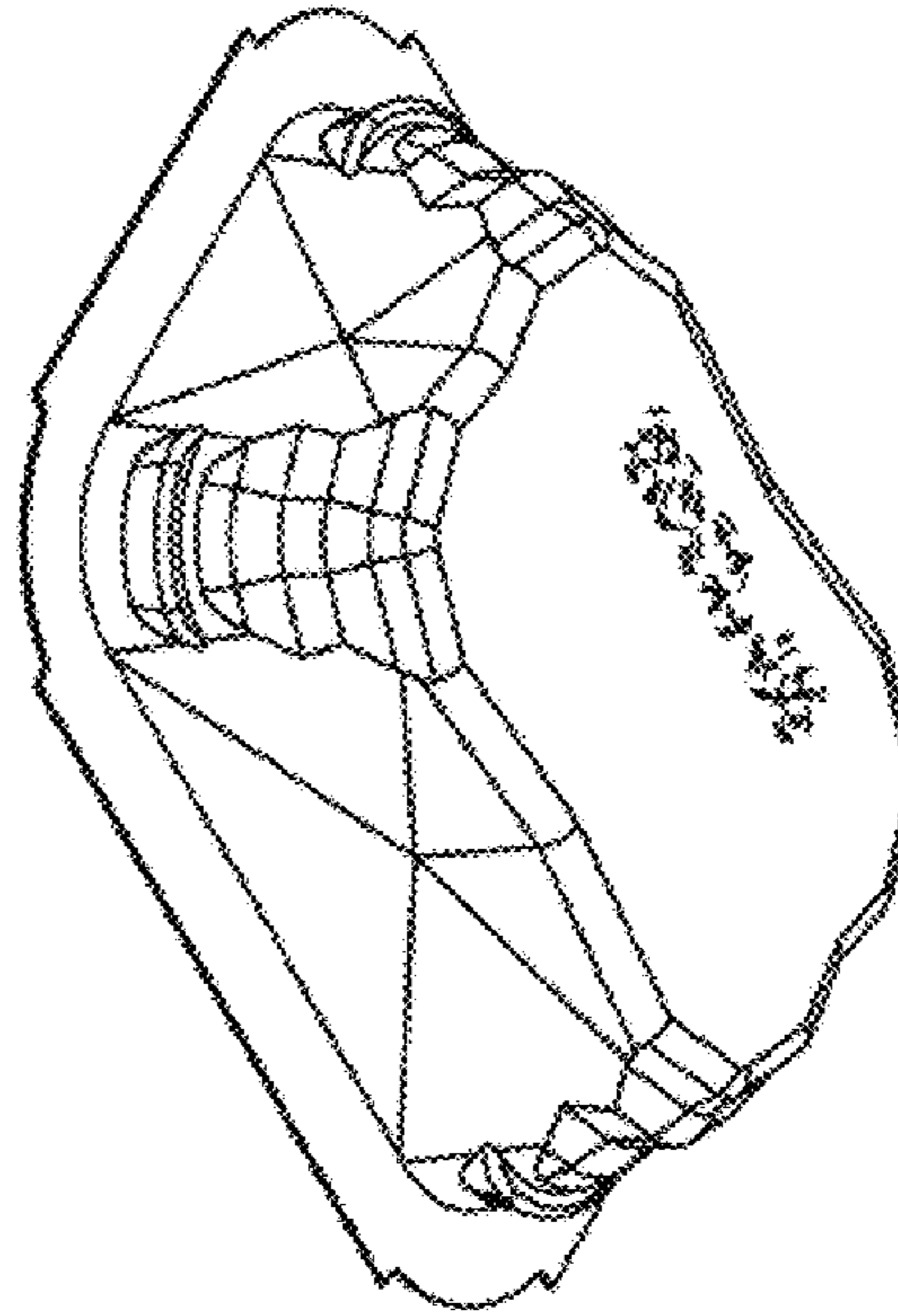

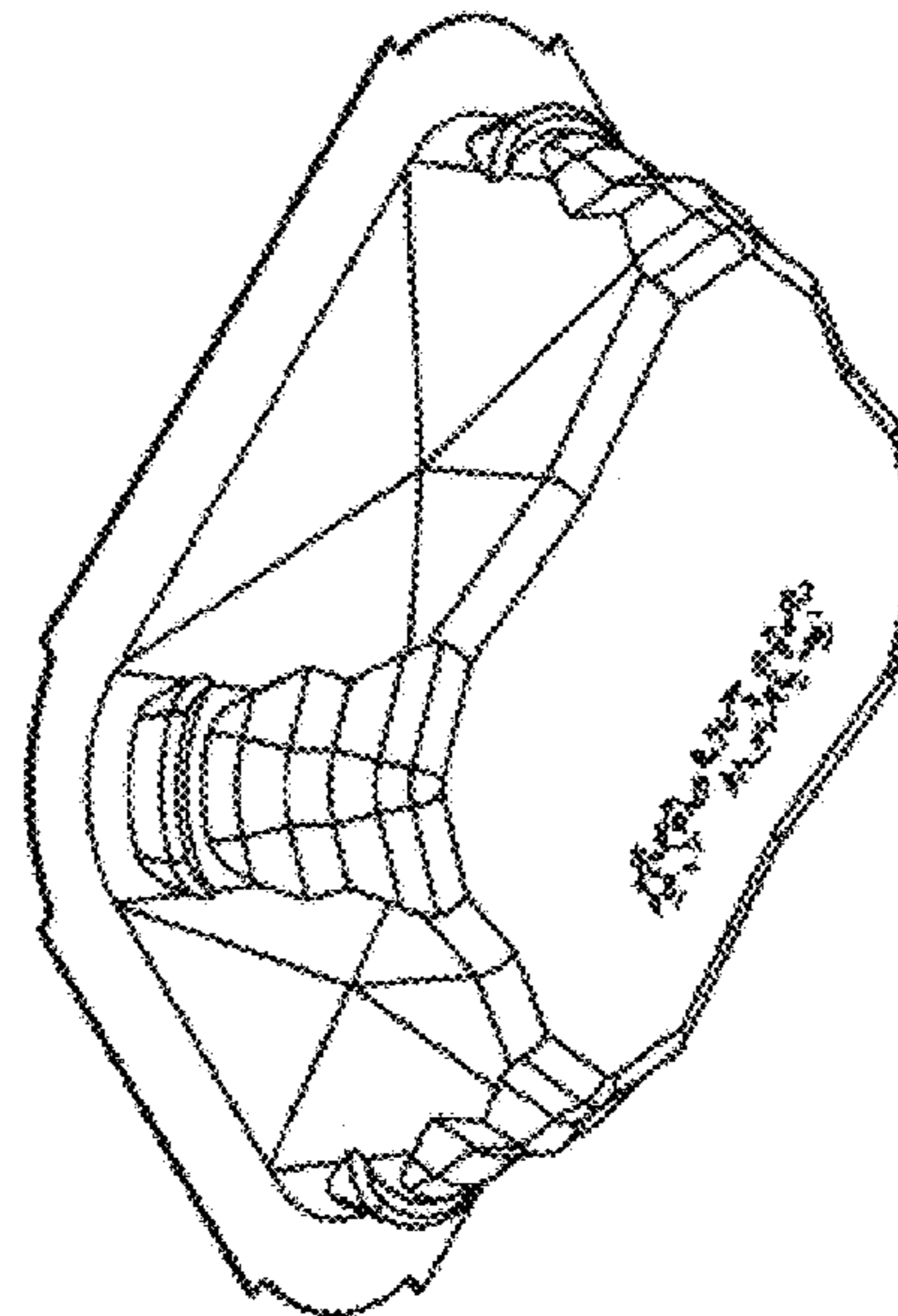

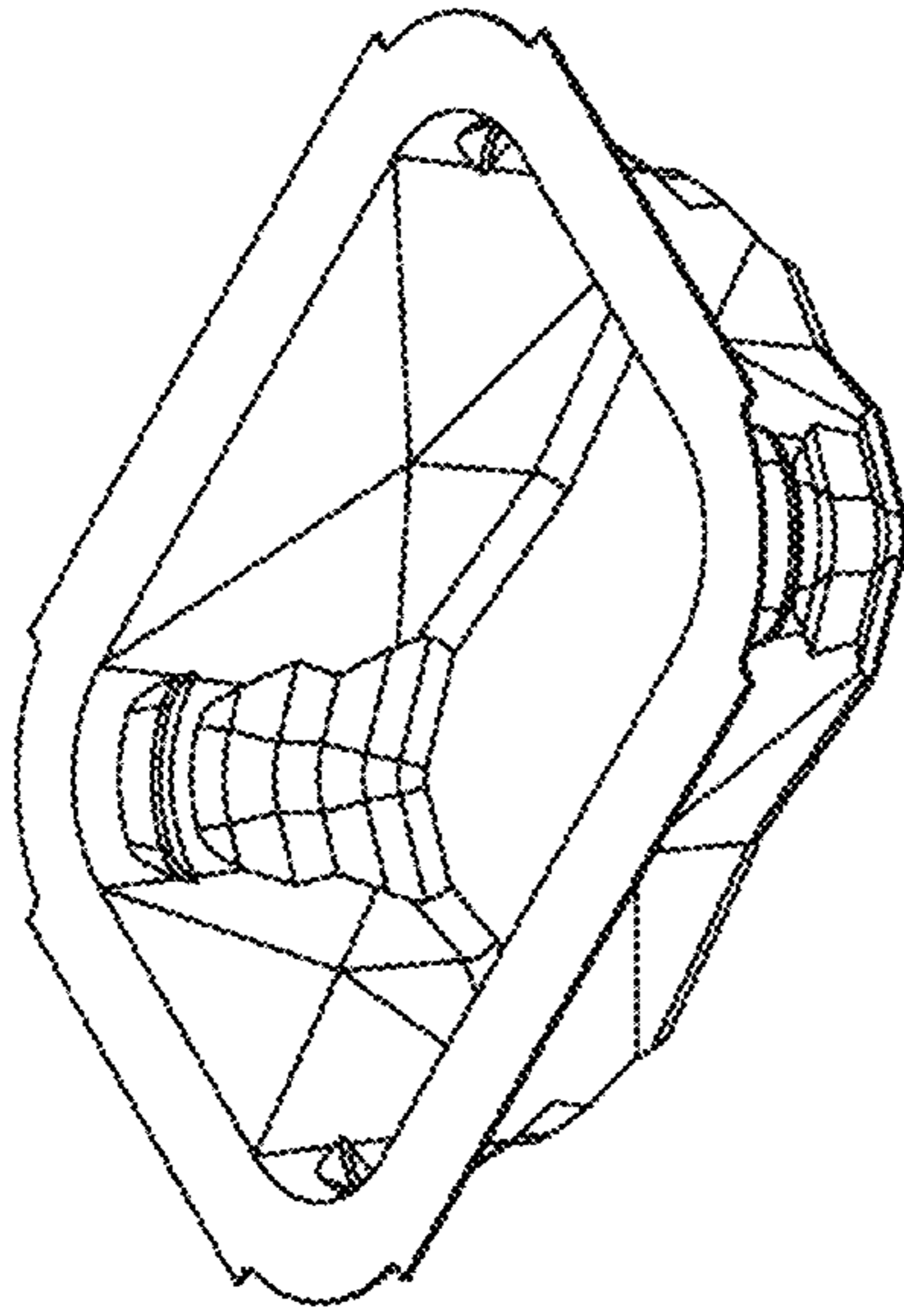

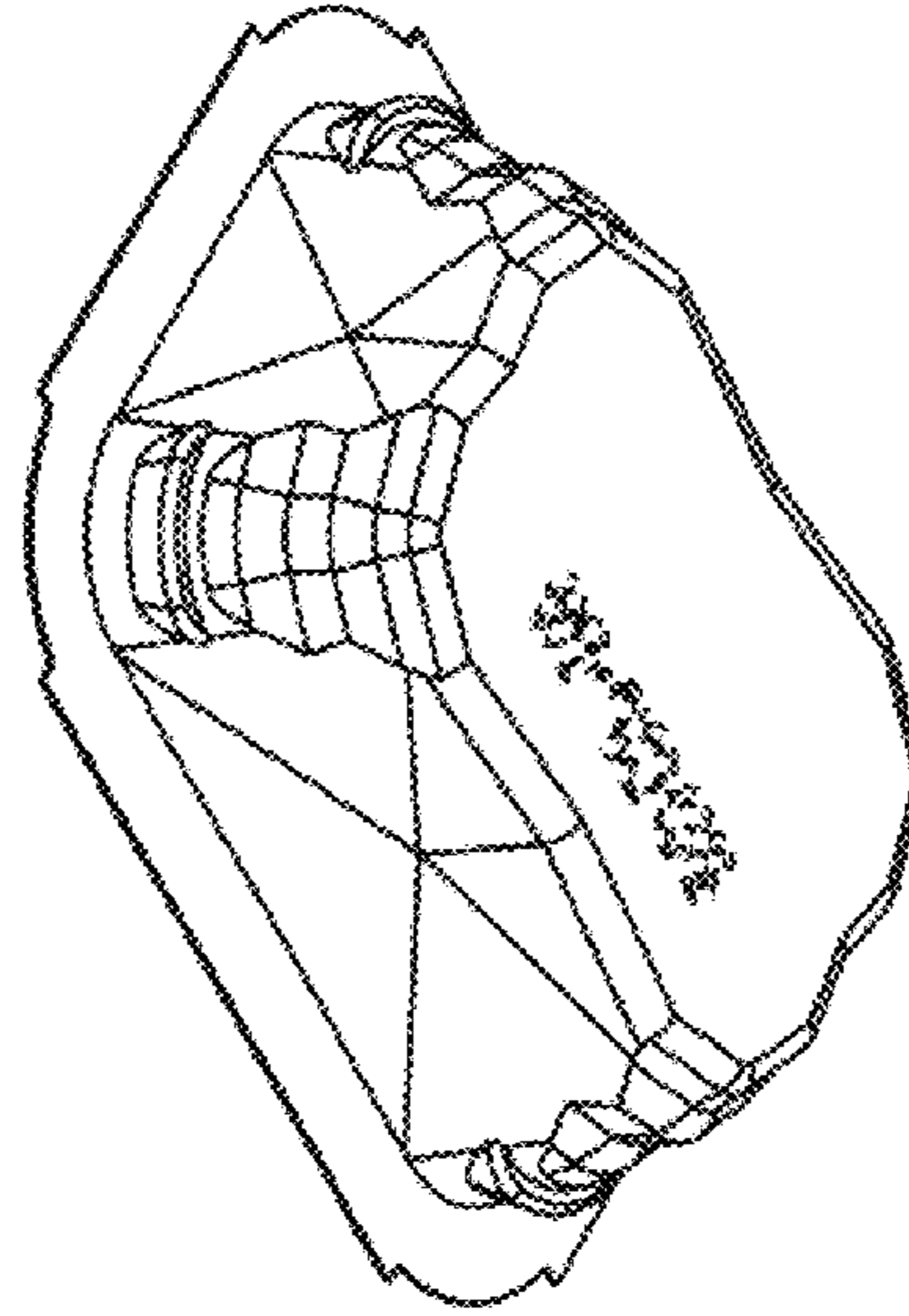

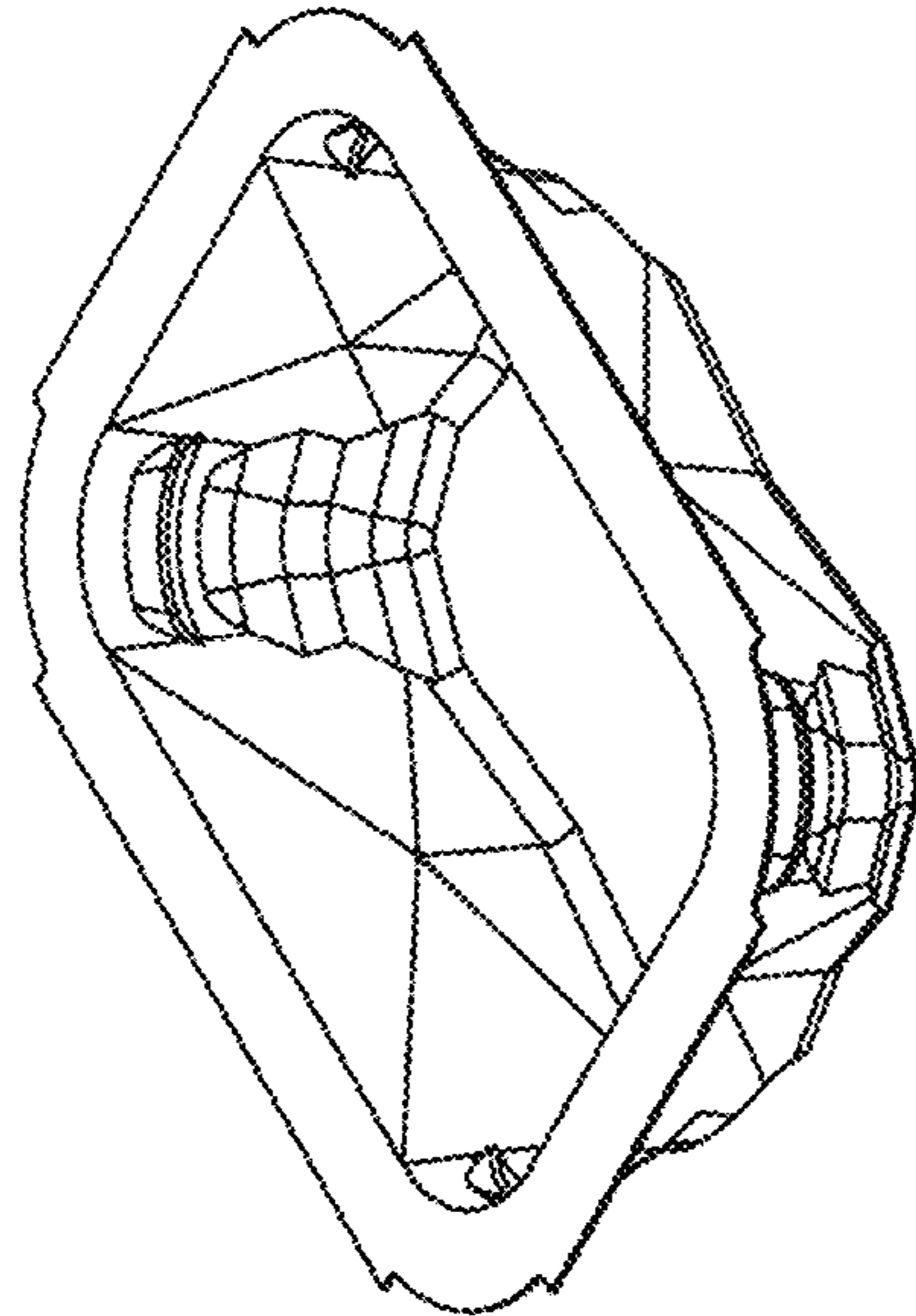
