(57) **CLAIM**

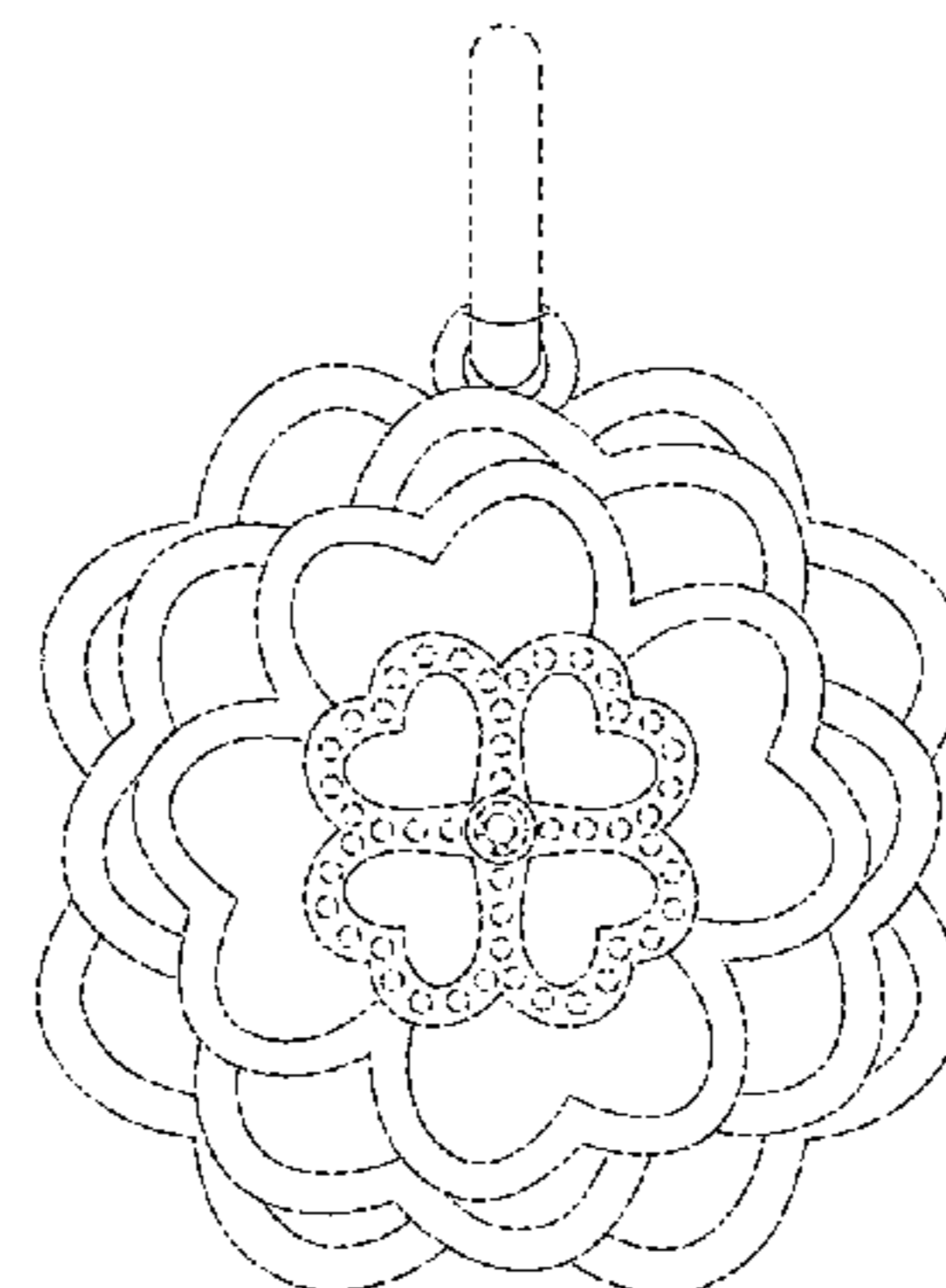
I claim the ornamental design for a pendant, as shown and described.

DESCRIPTION

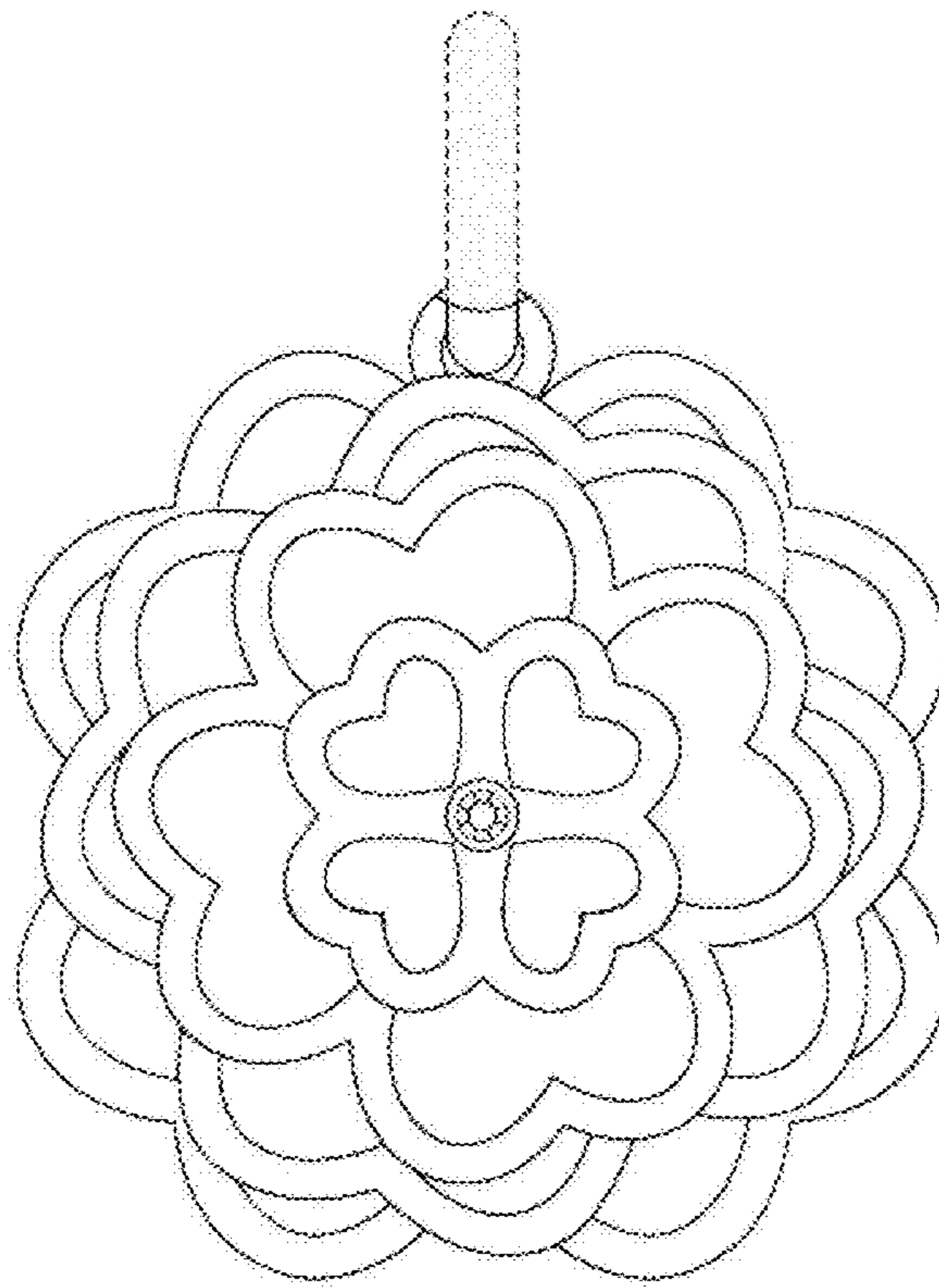

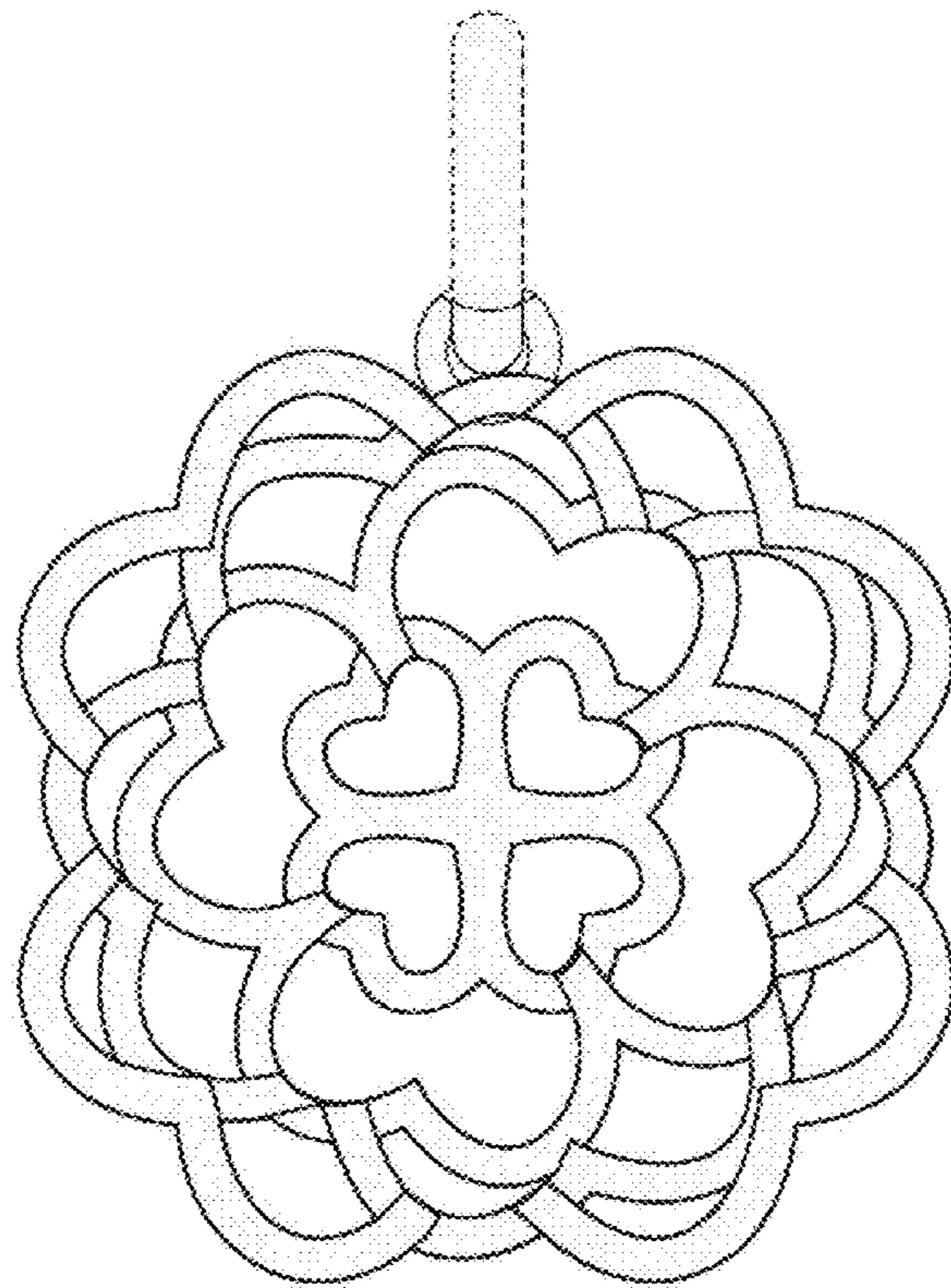

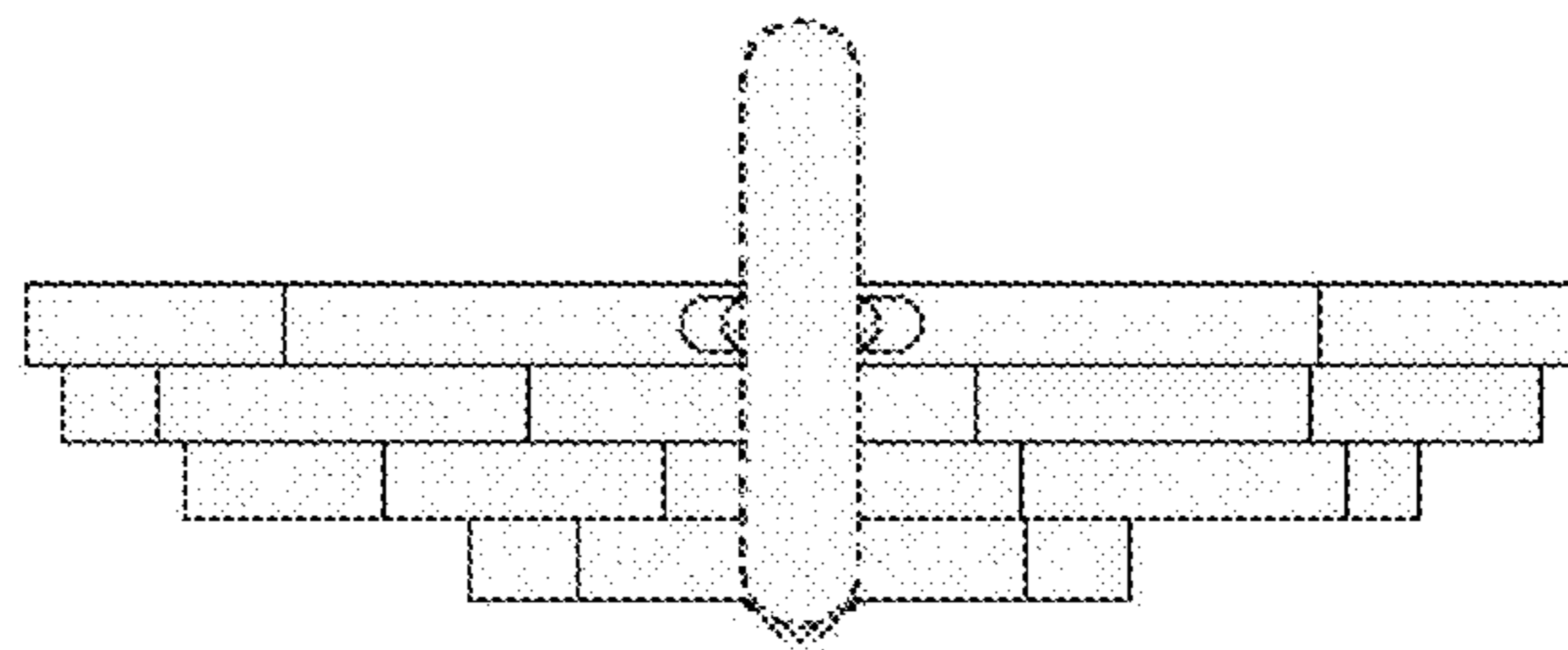

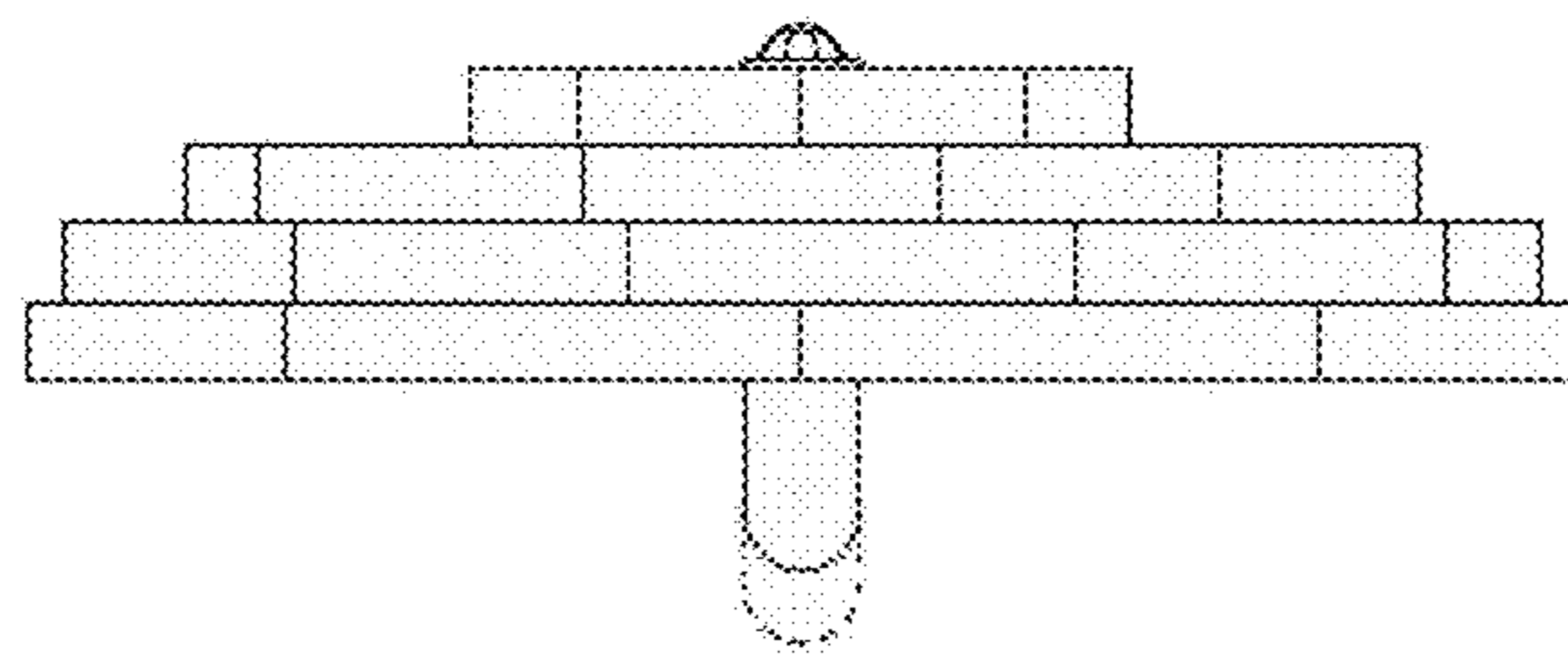

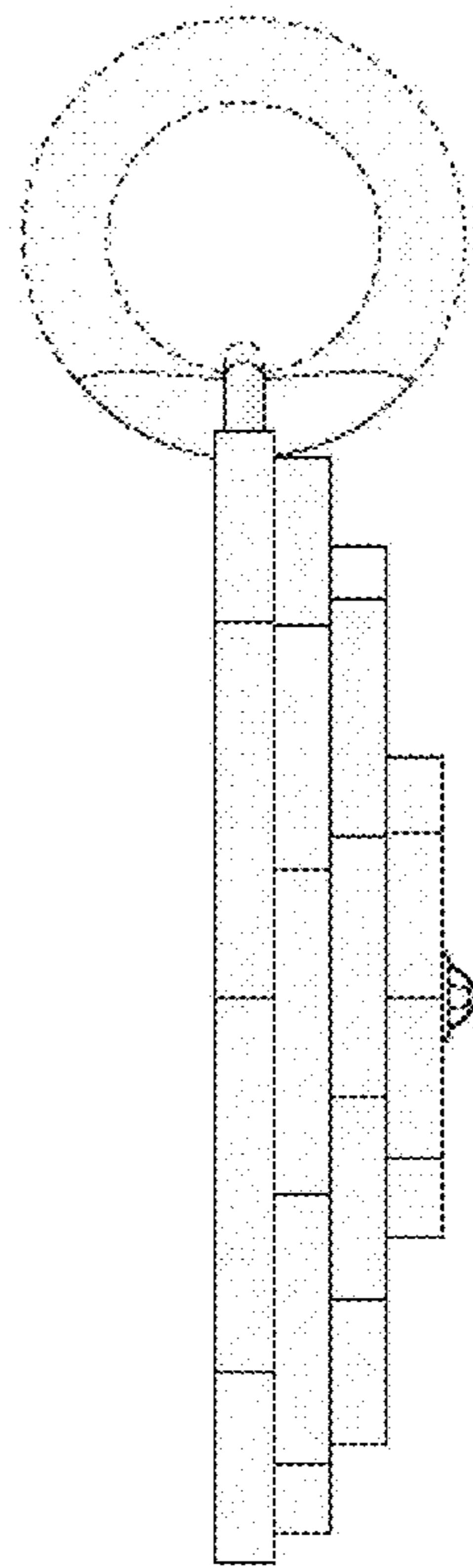

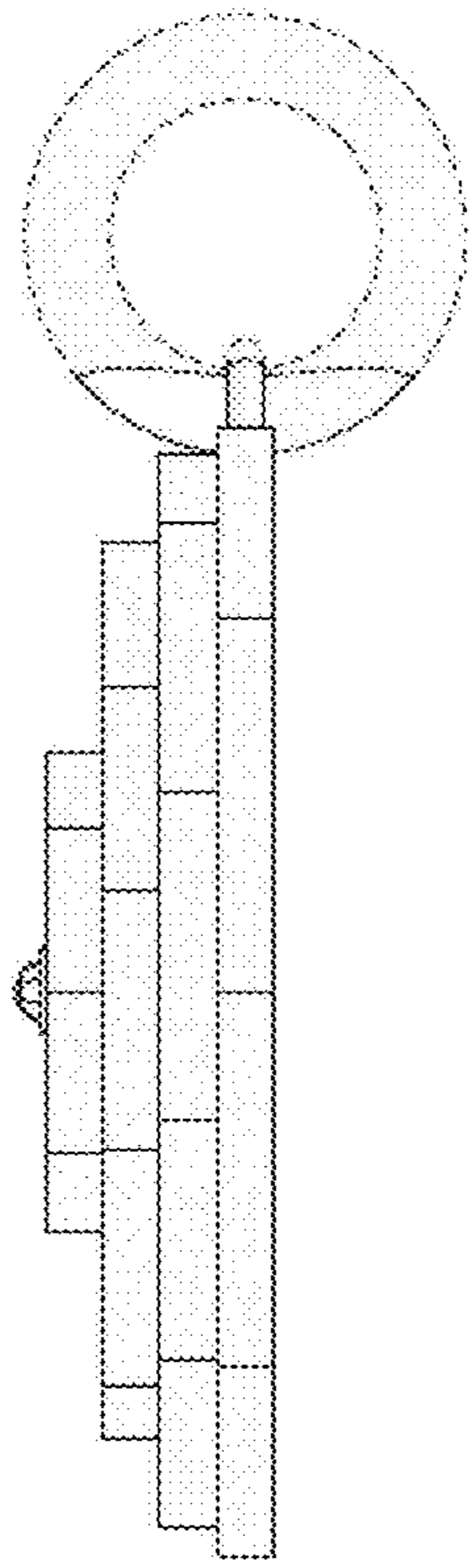

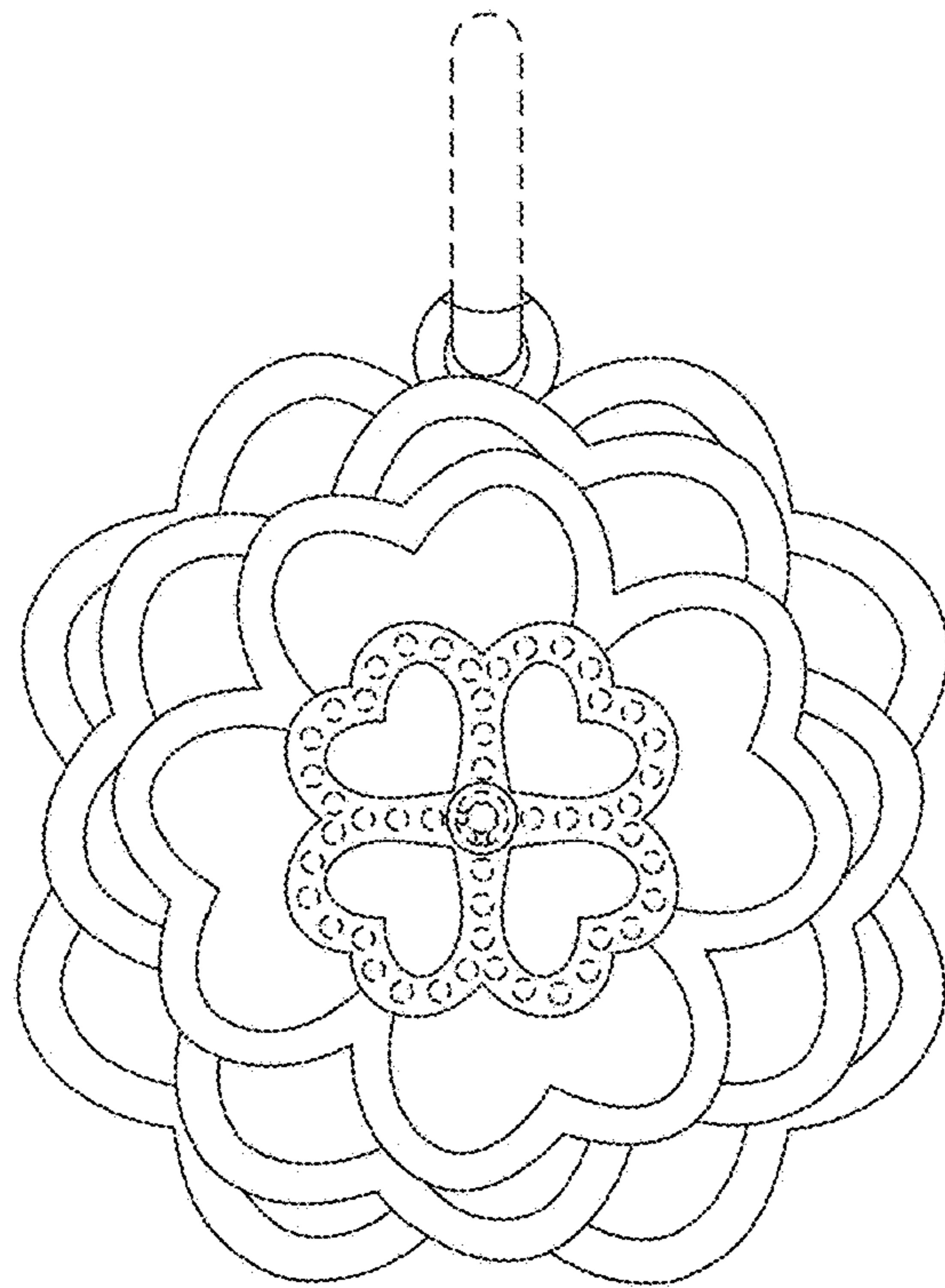

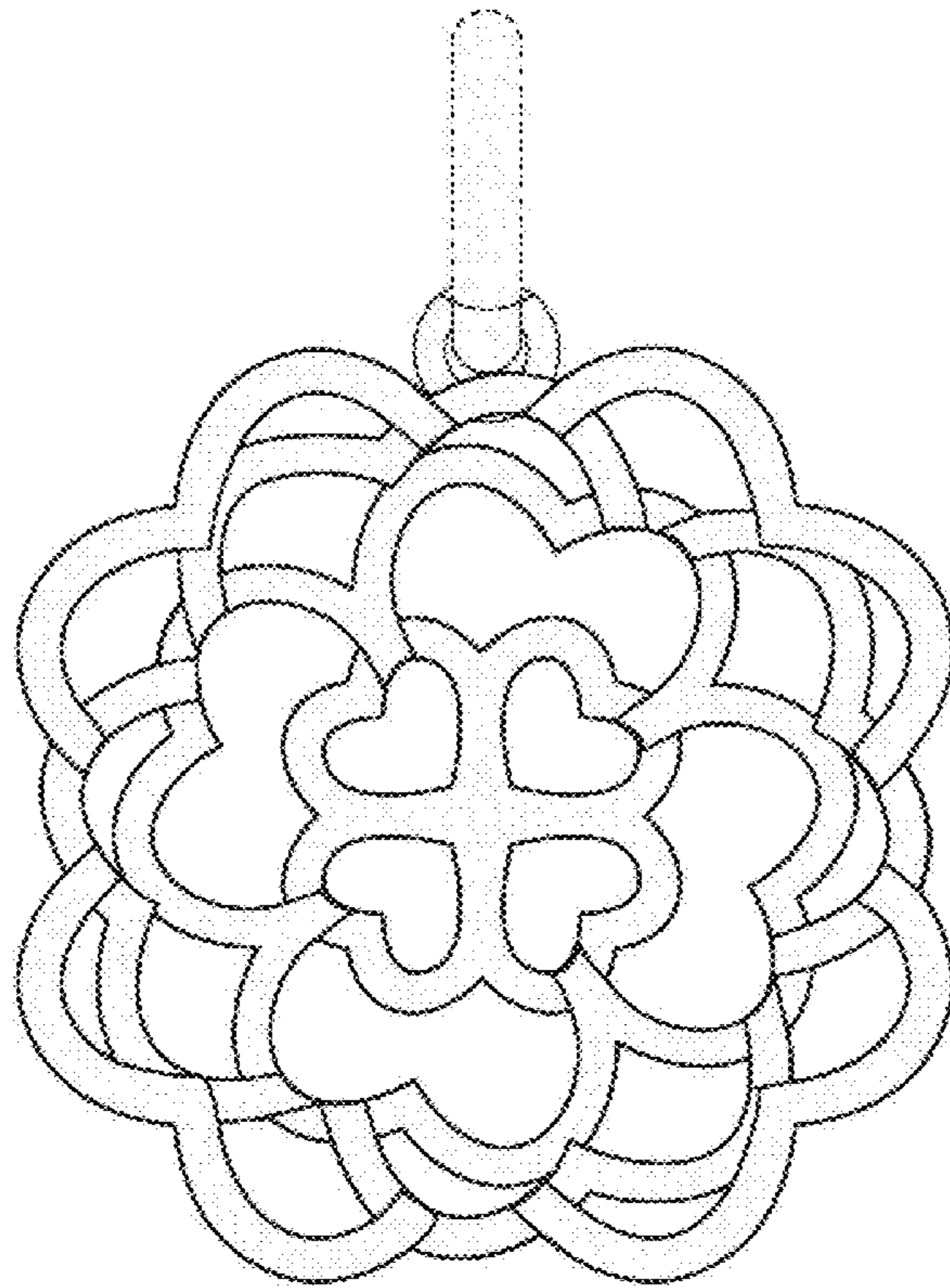

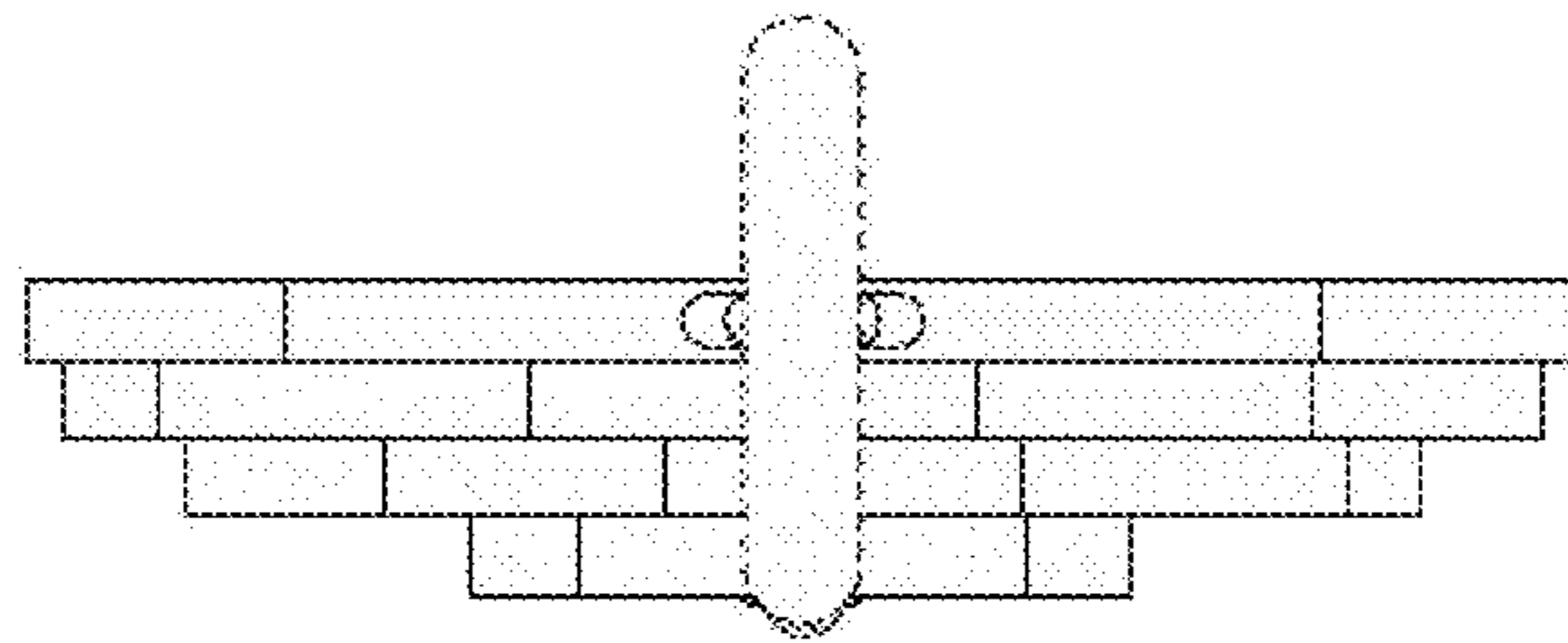

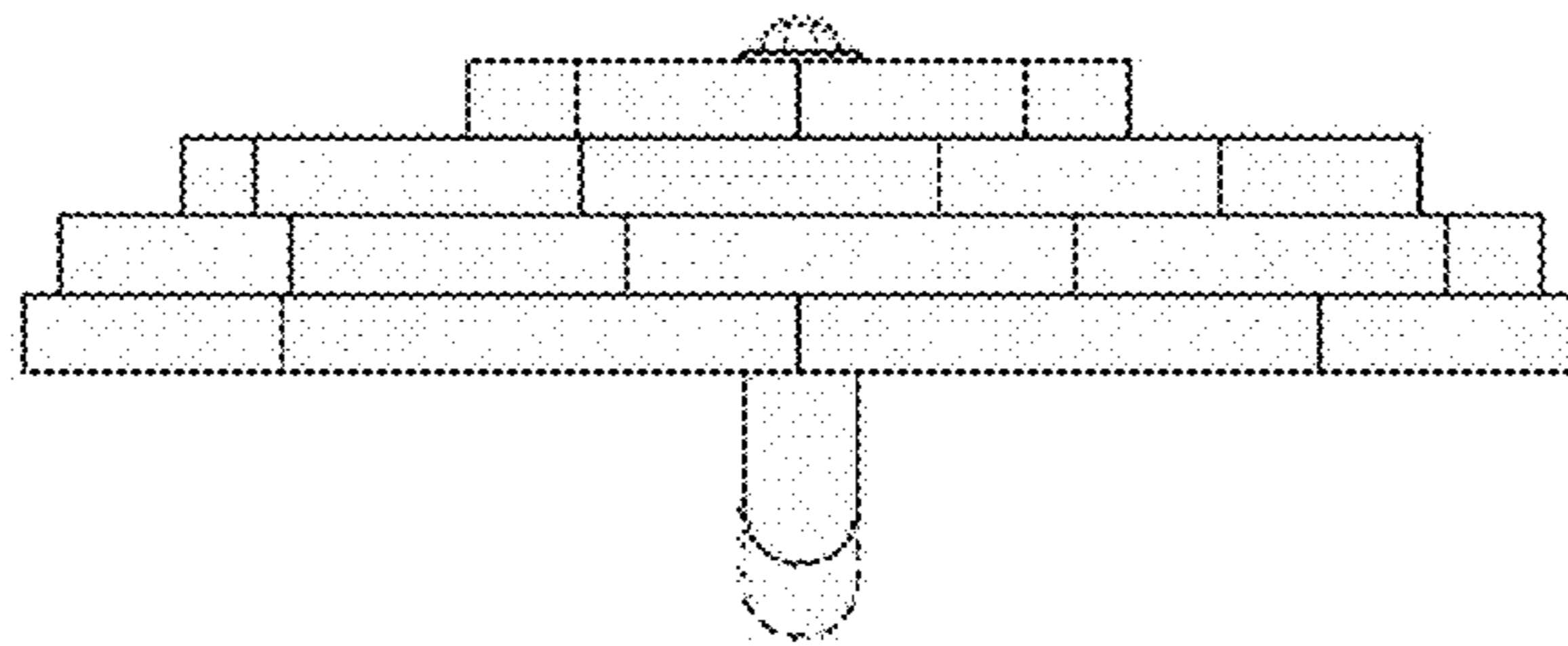

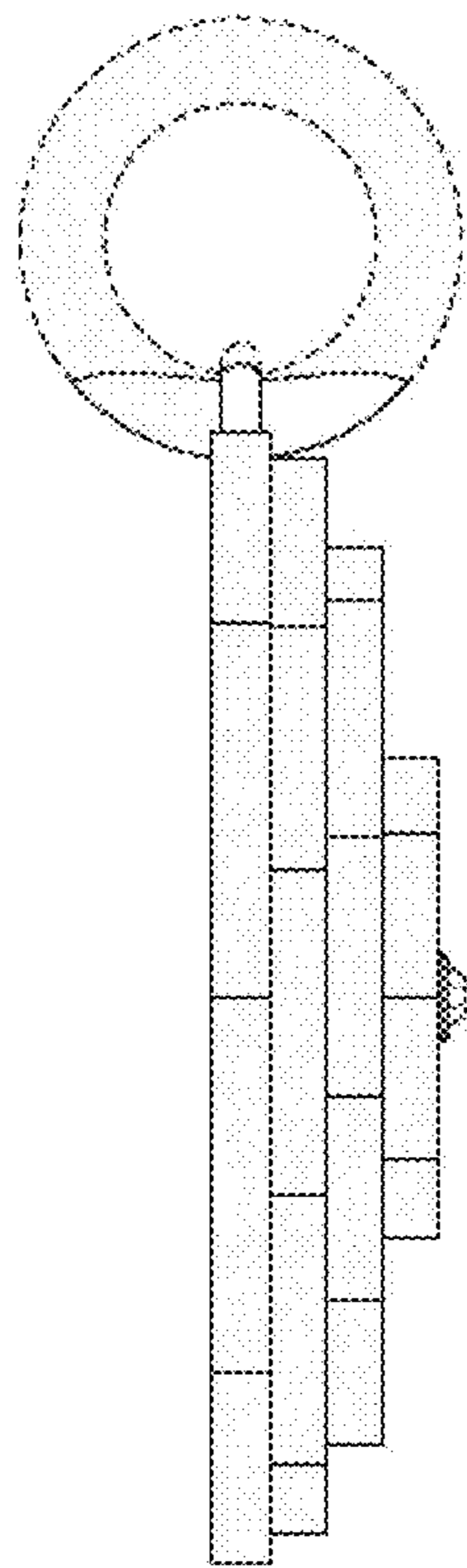

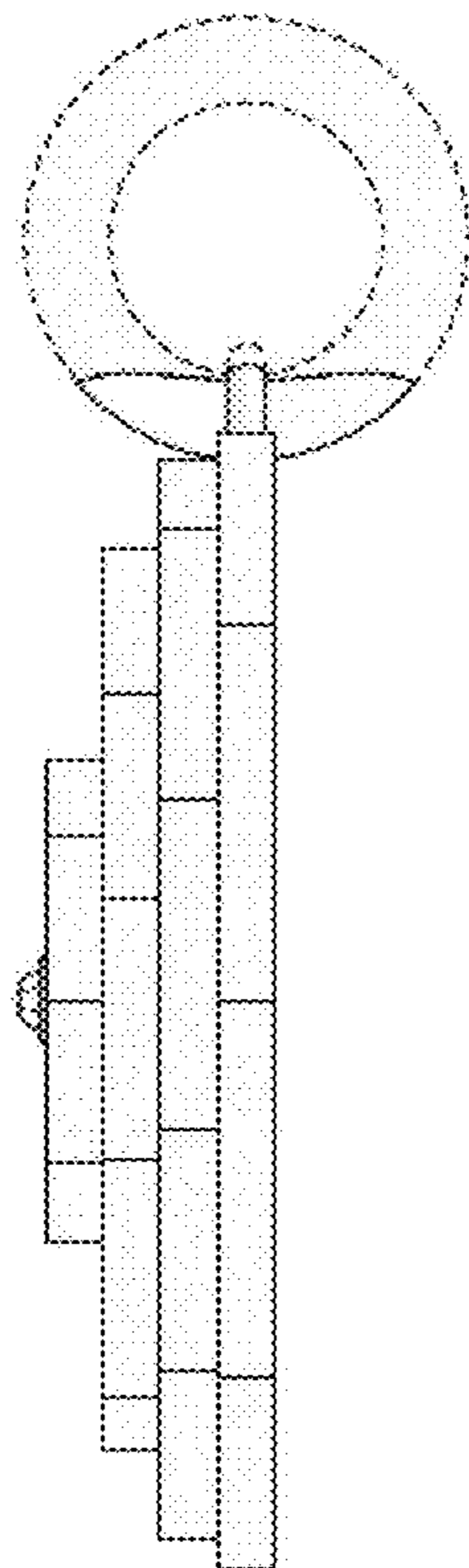

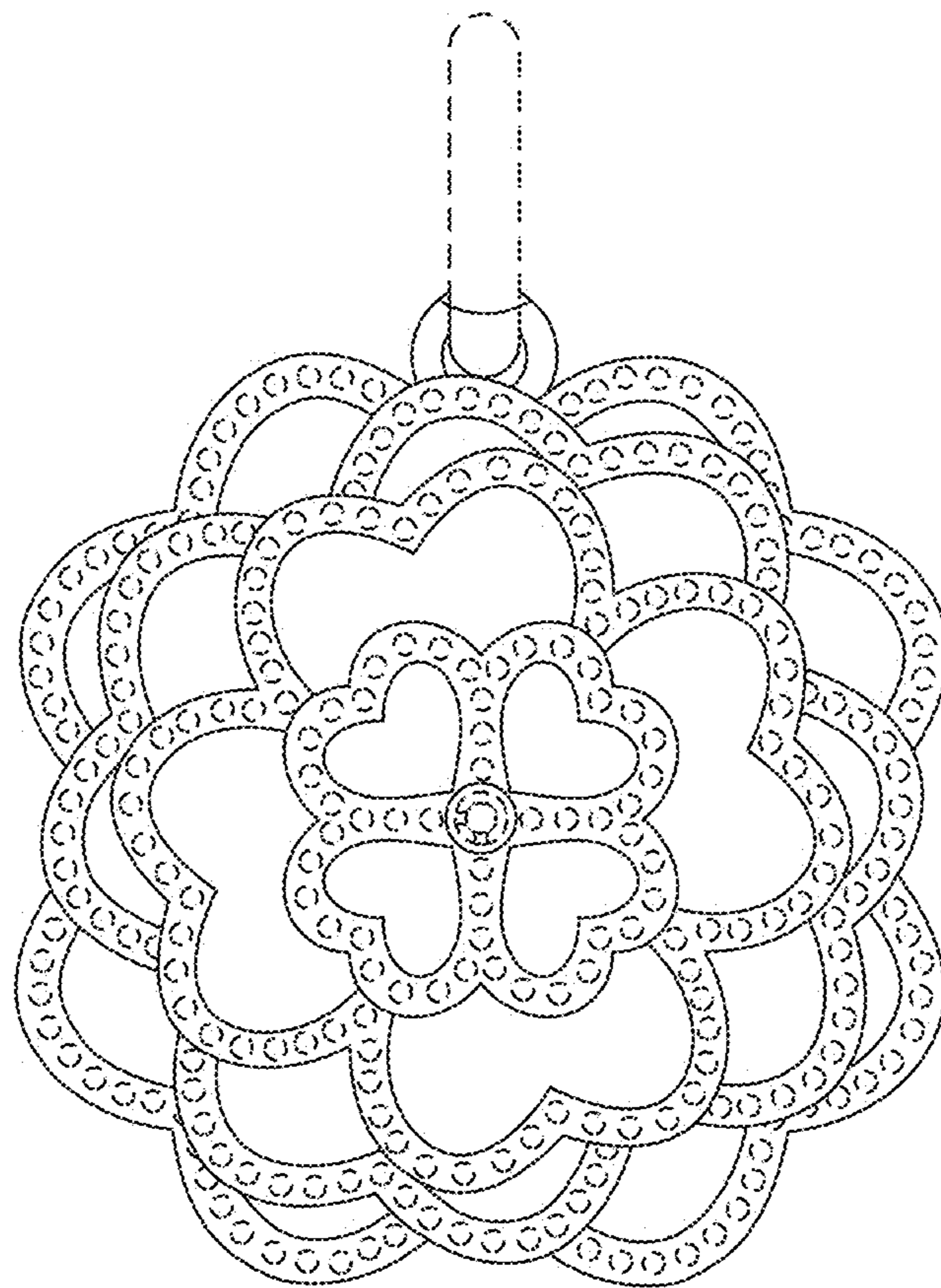

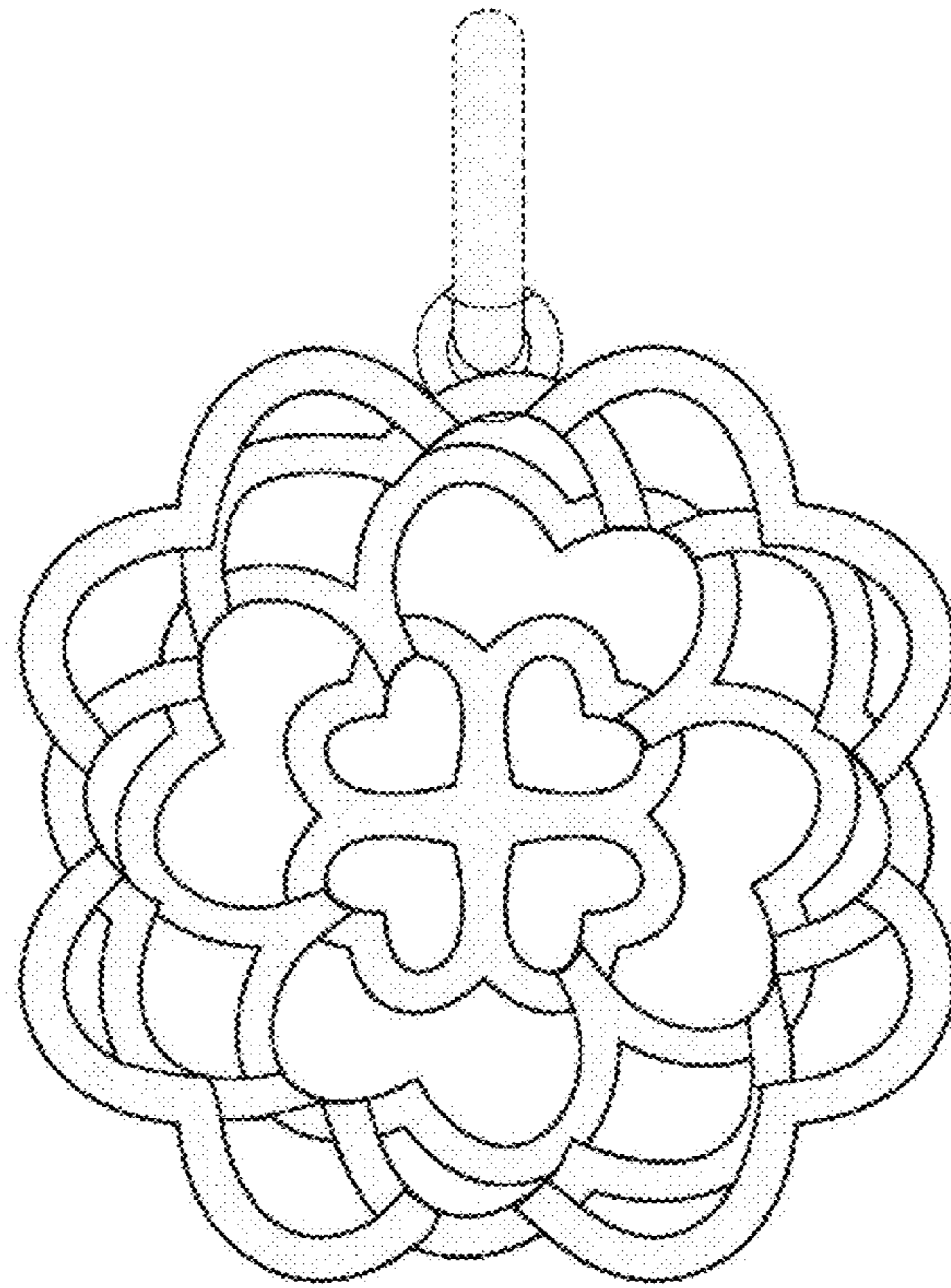

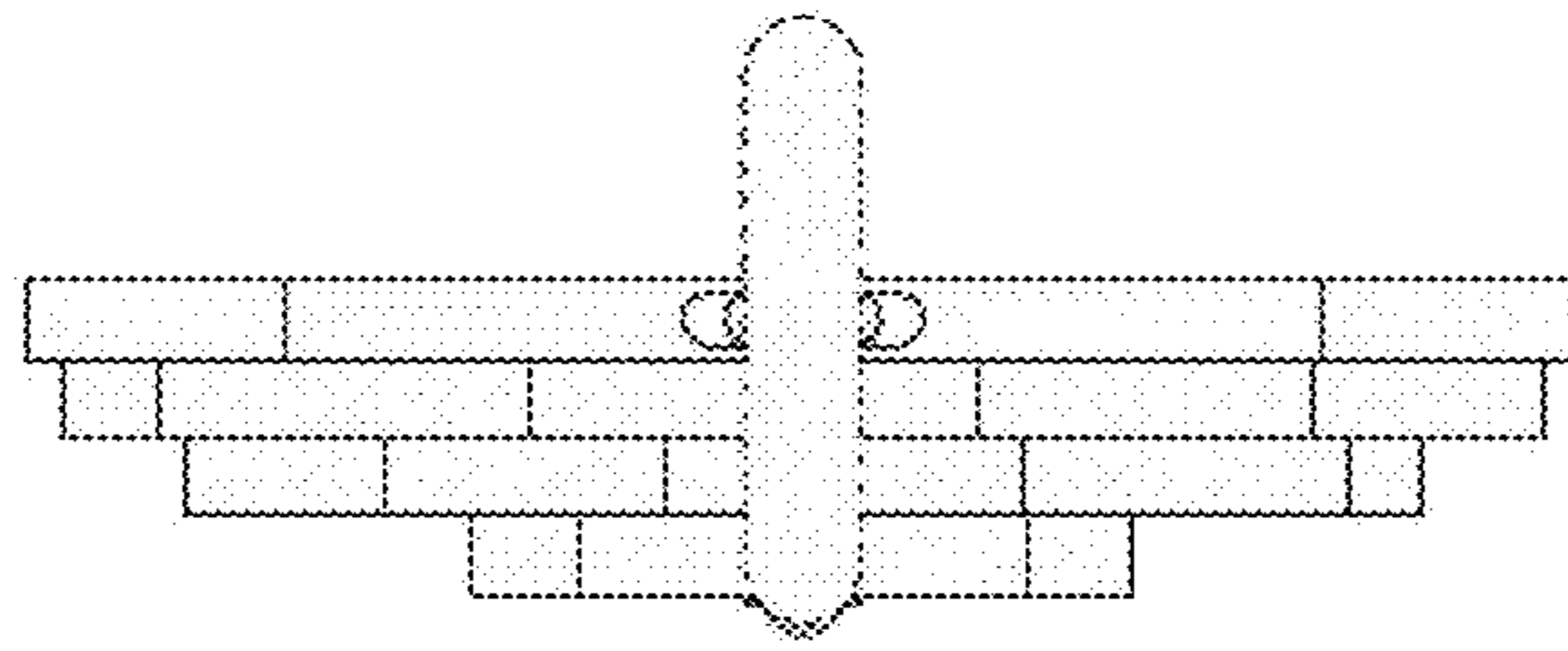

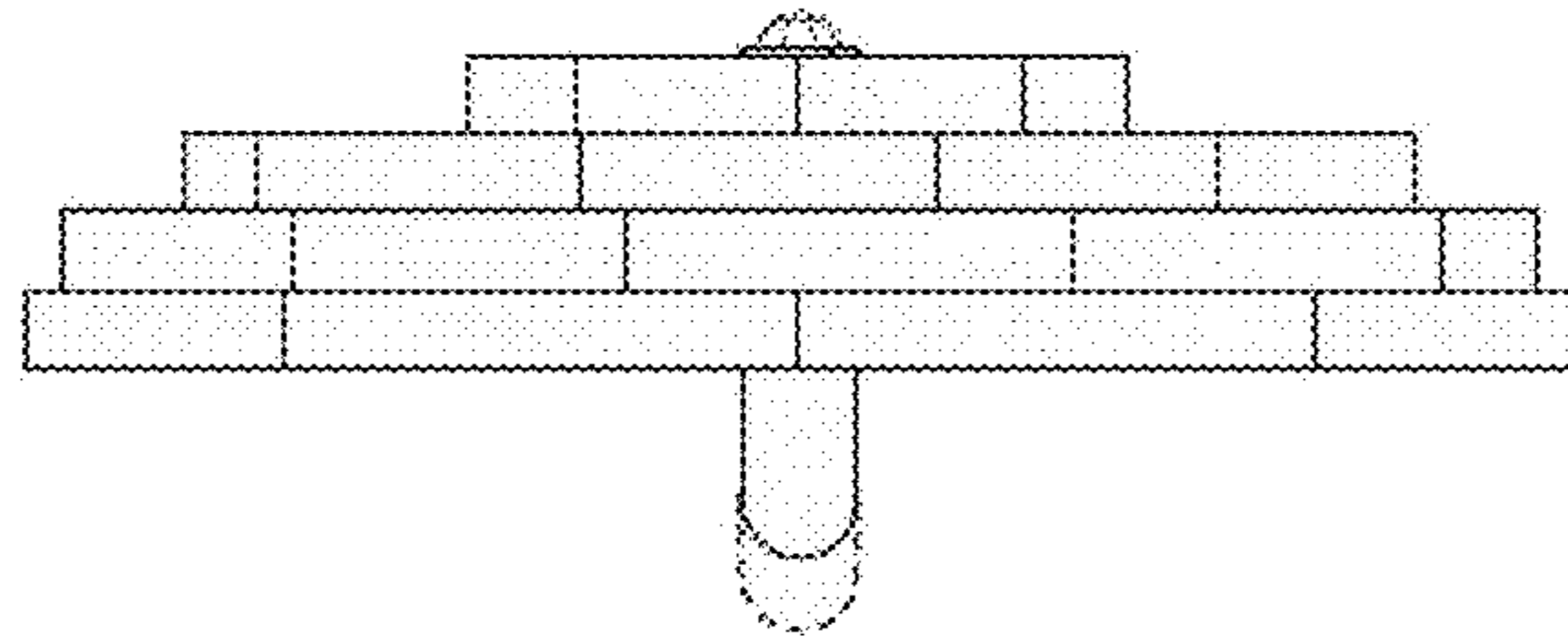

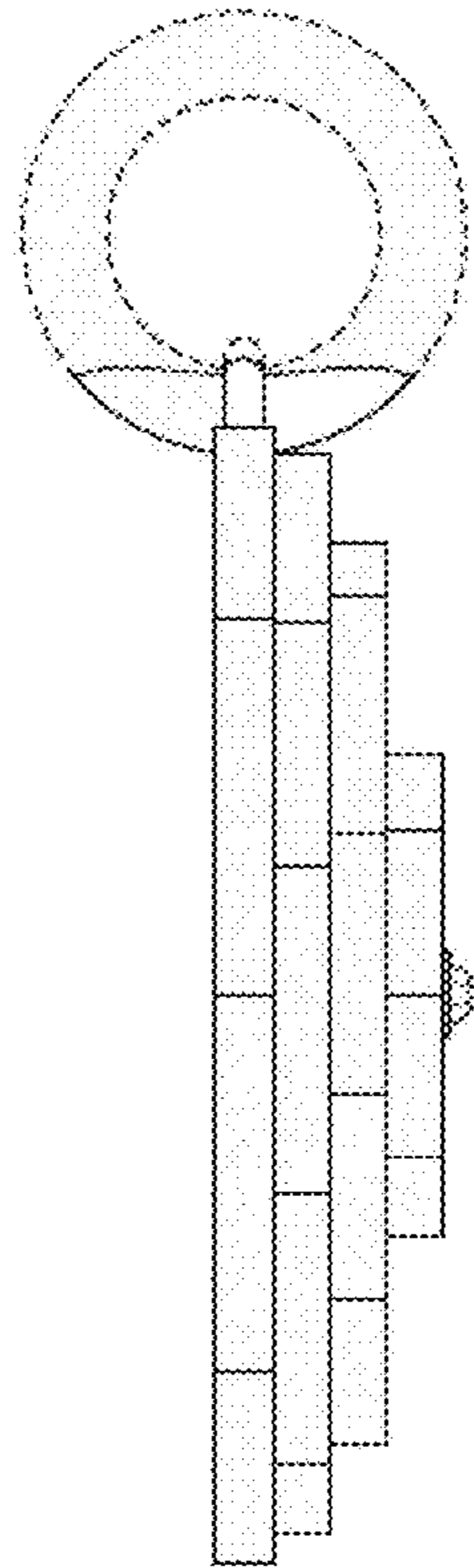

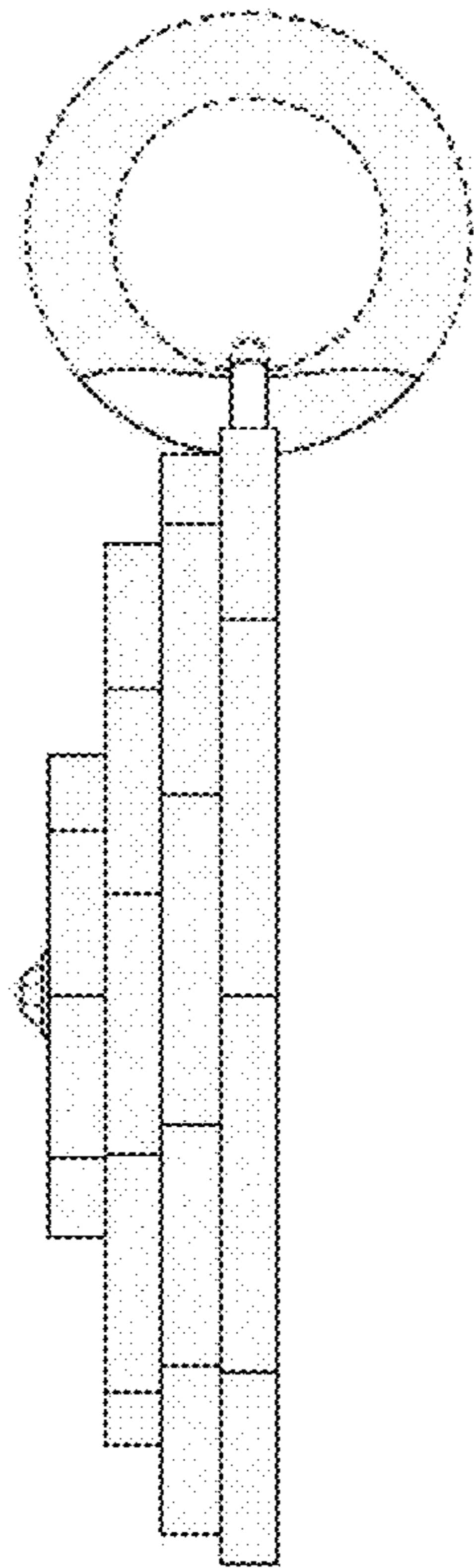
