FIG. 9 is a top view thereof; and,

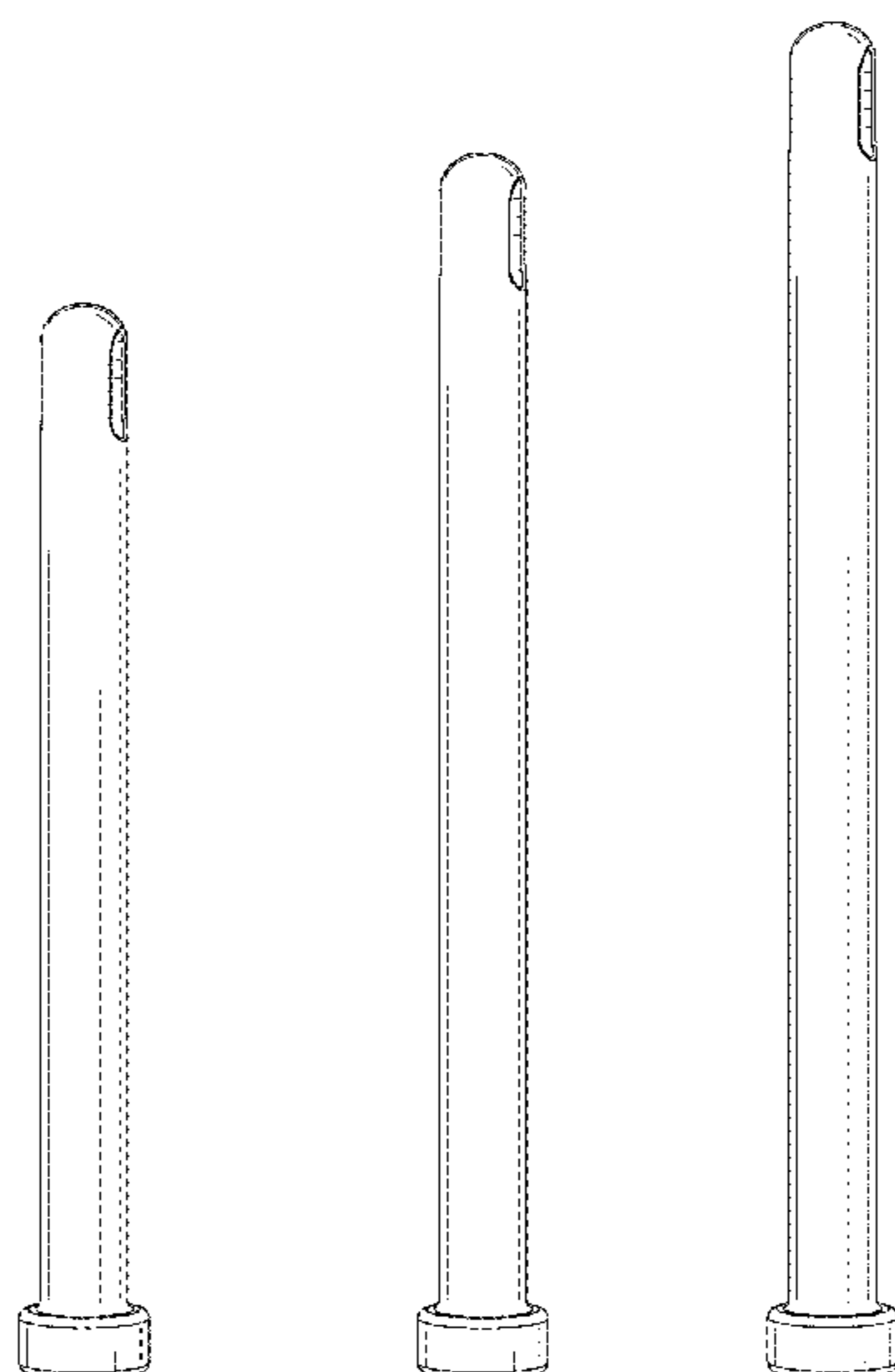
FIG. 10 is a bottom view thereof.

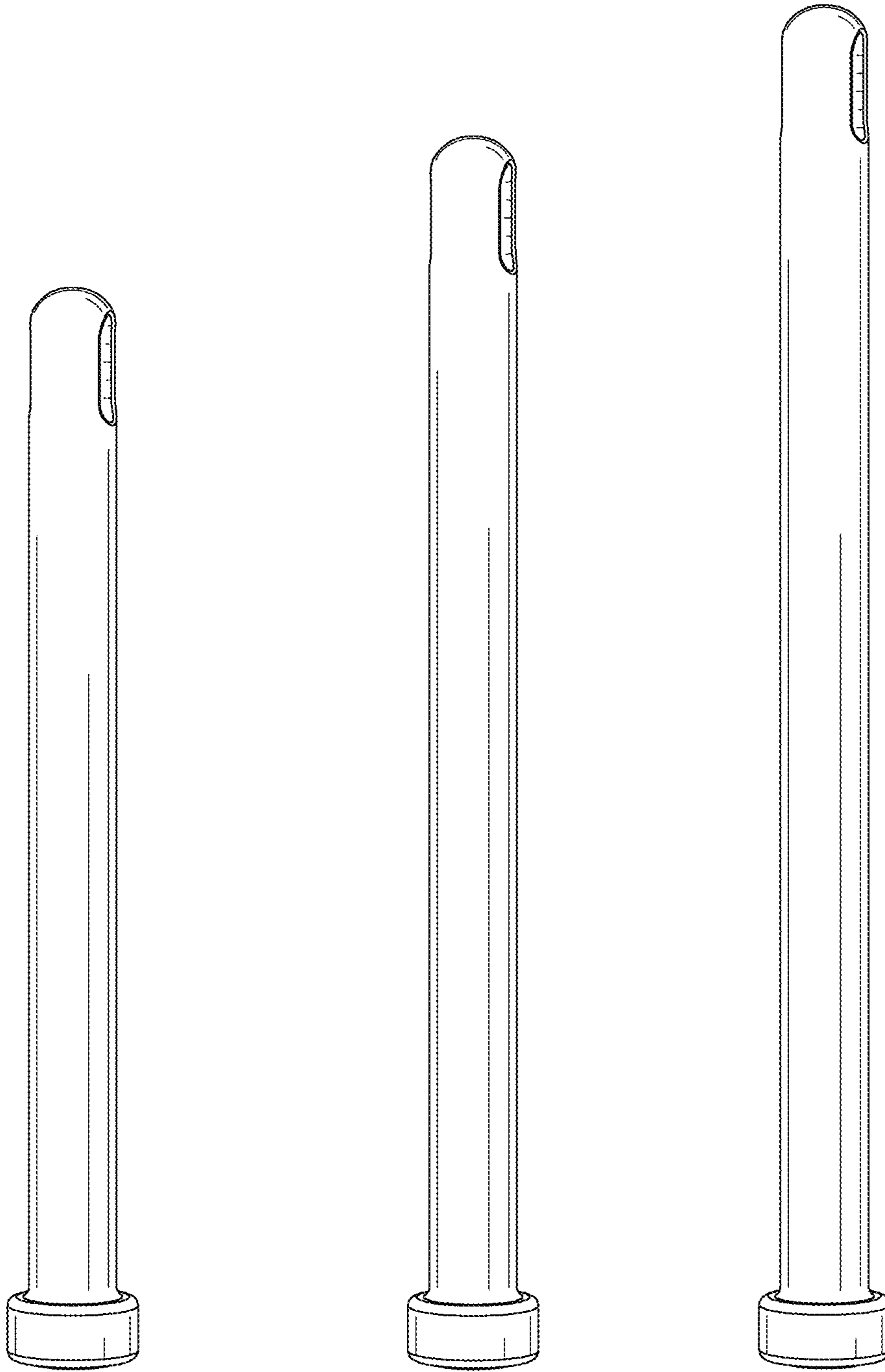

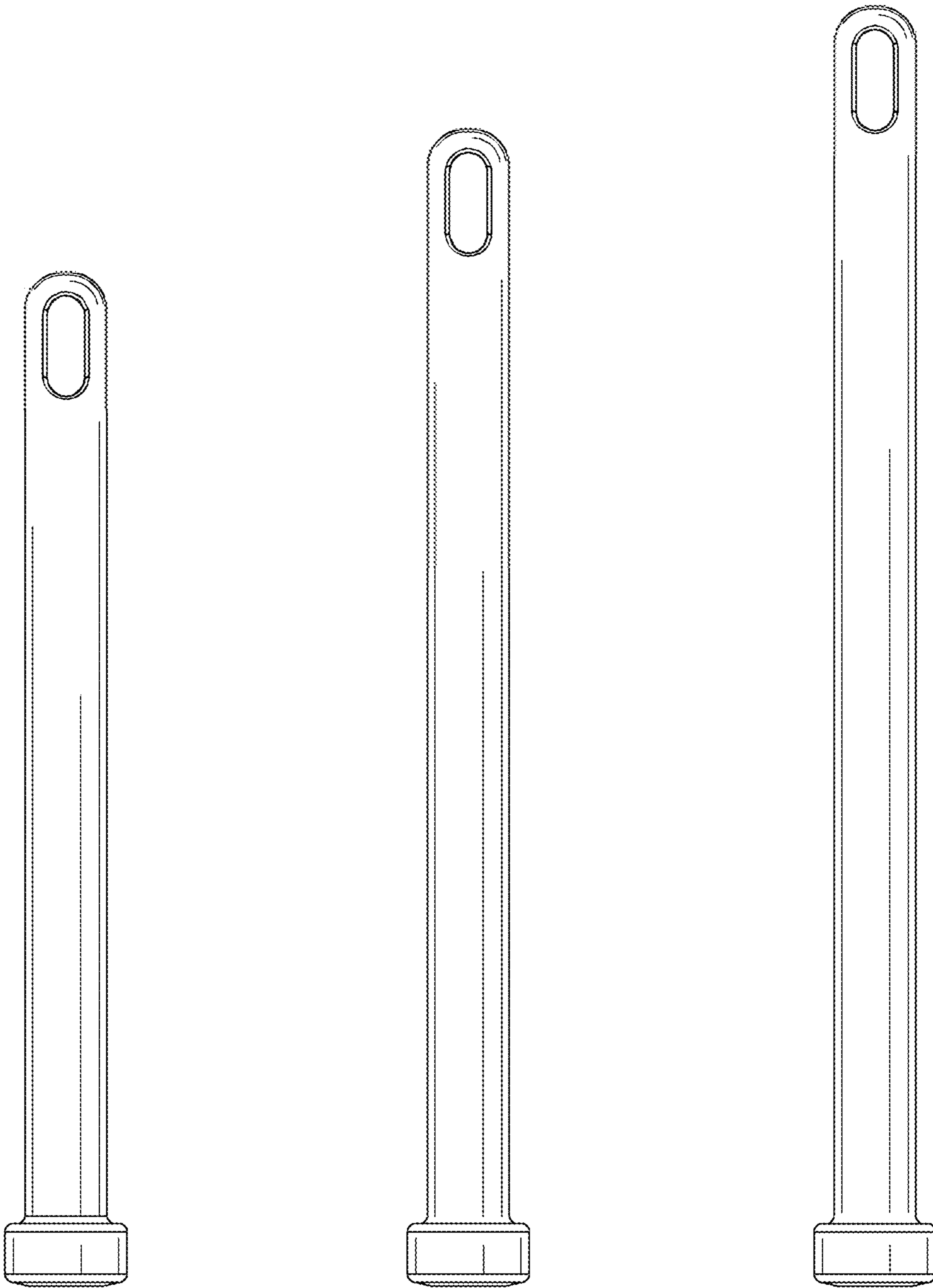

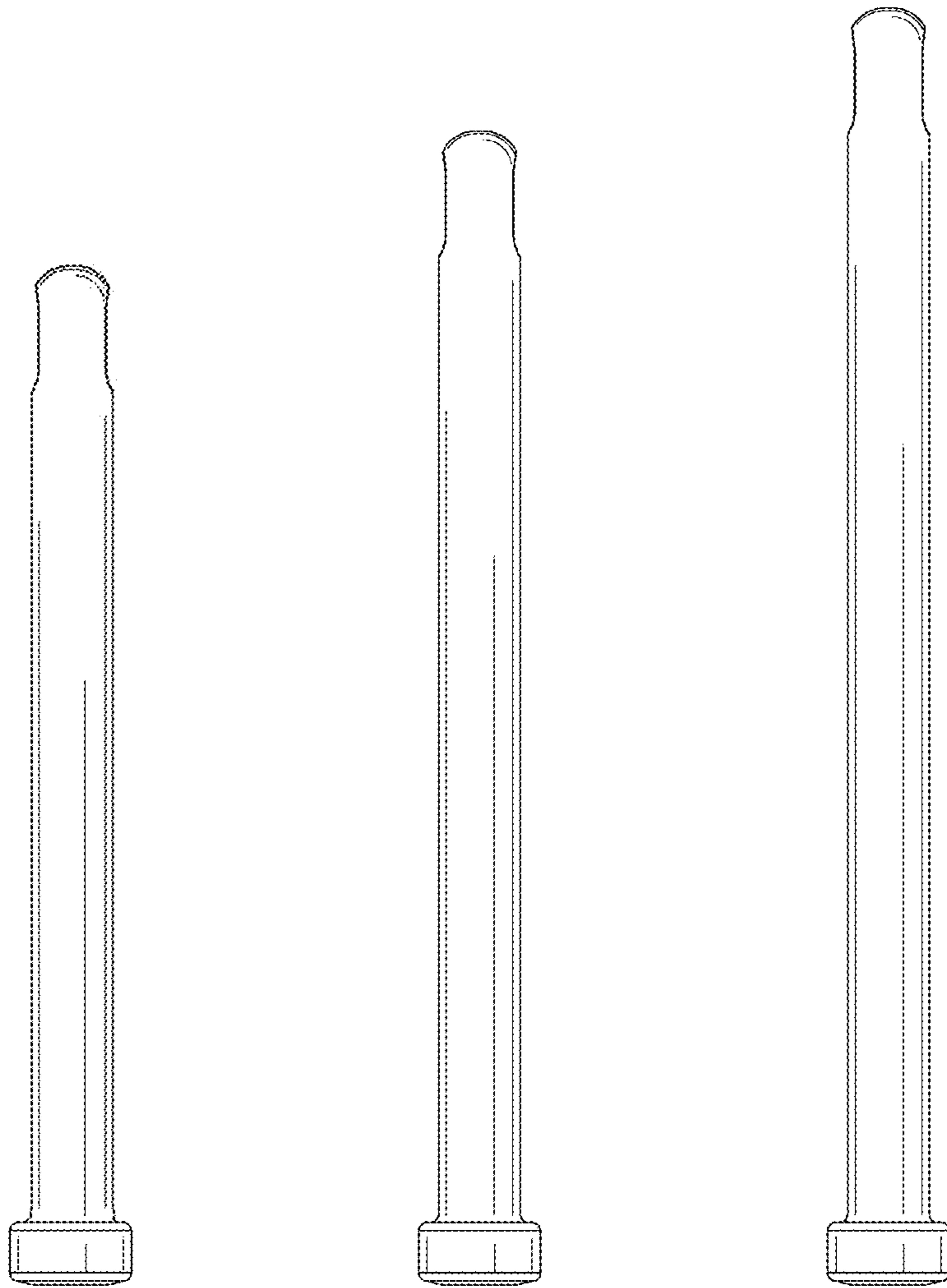

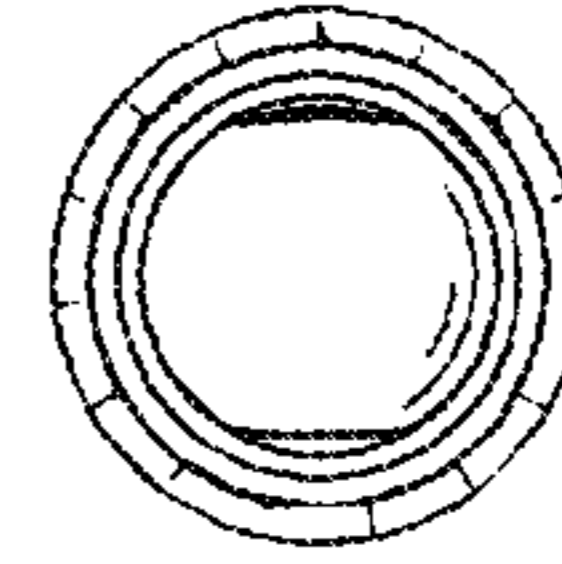
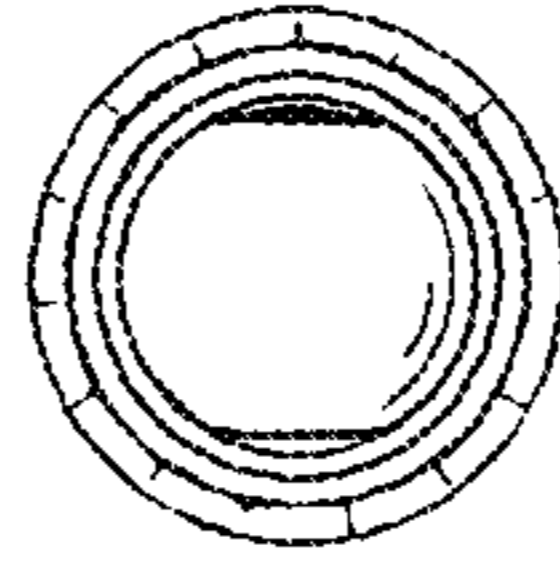
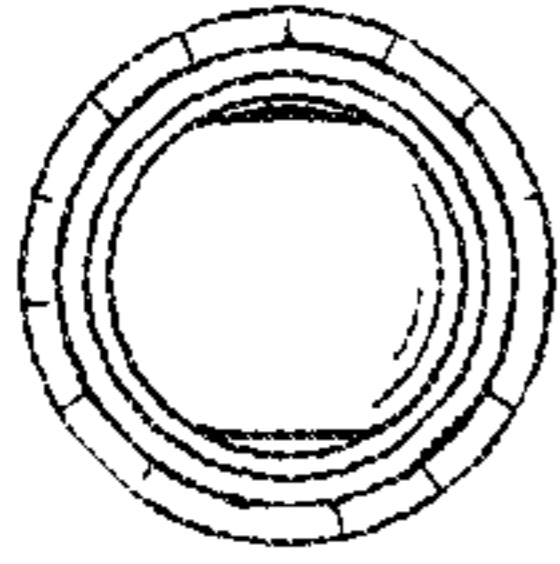

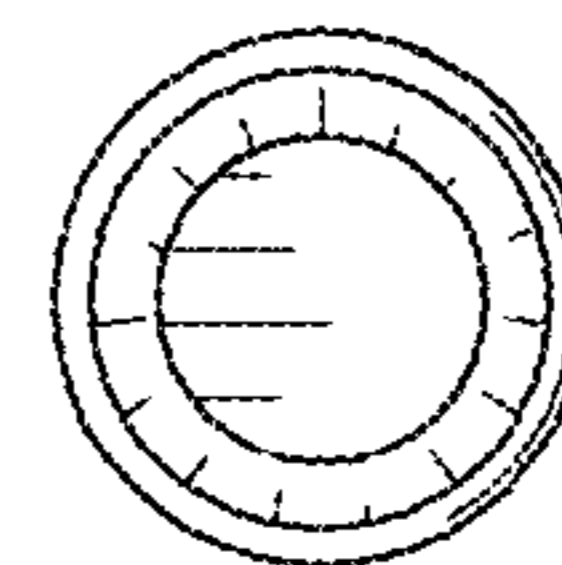
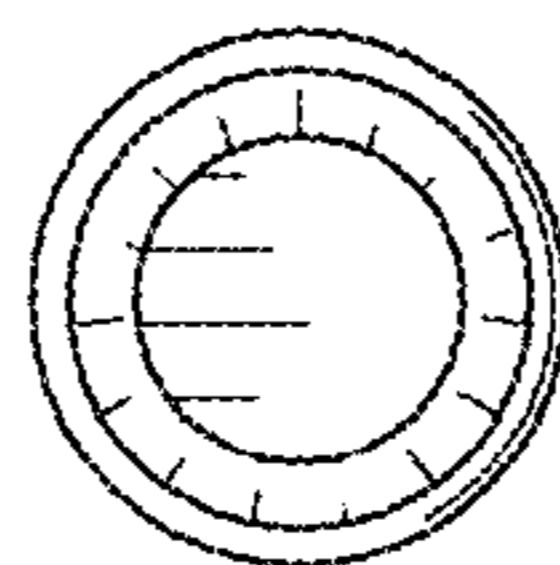
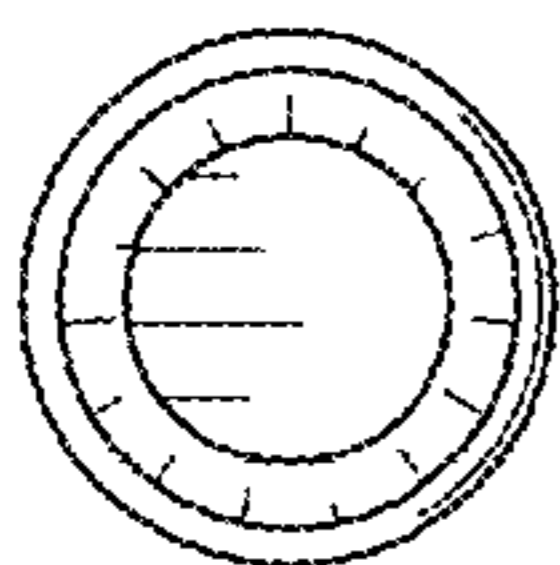

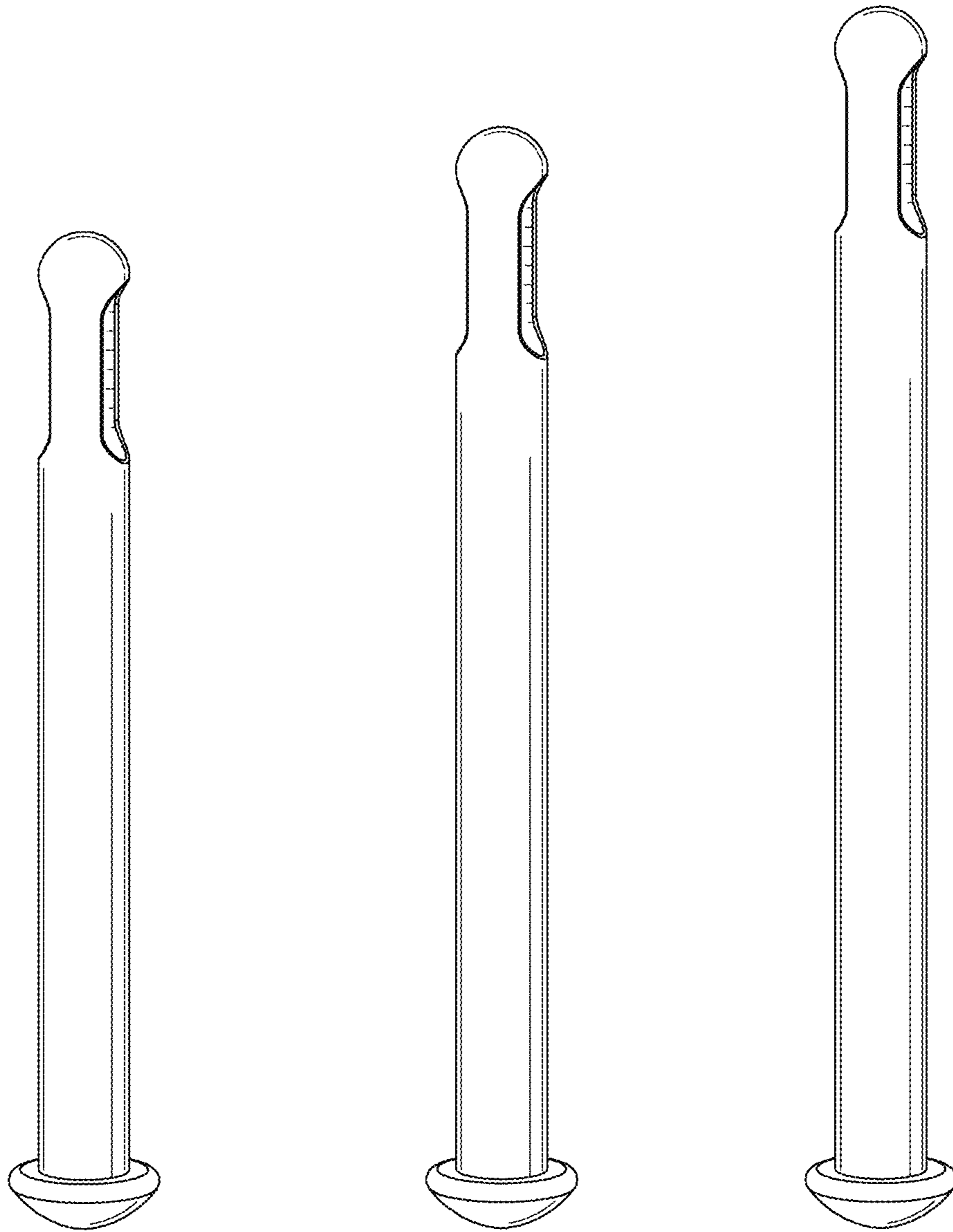

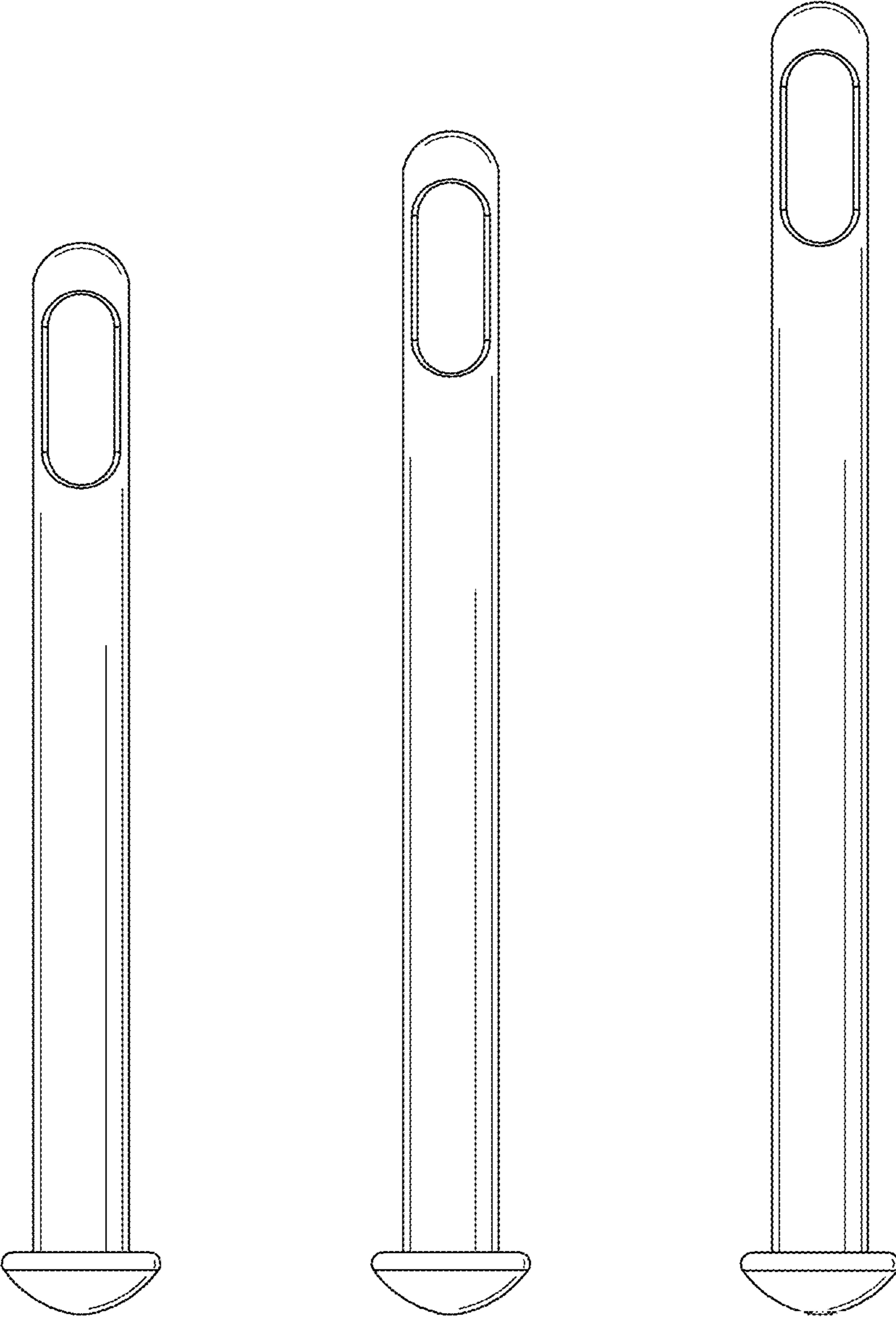

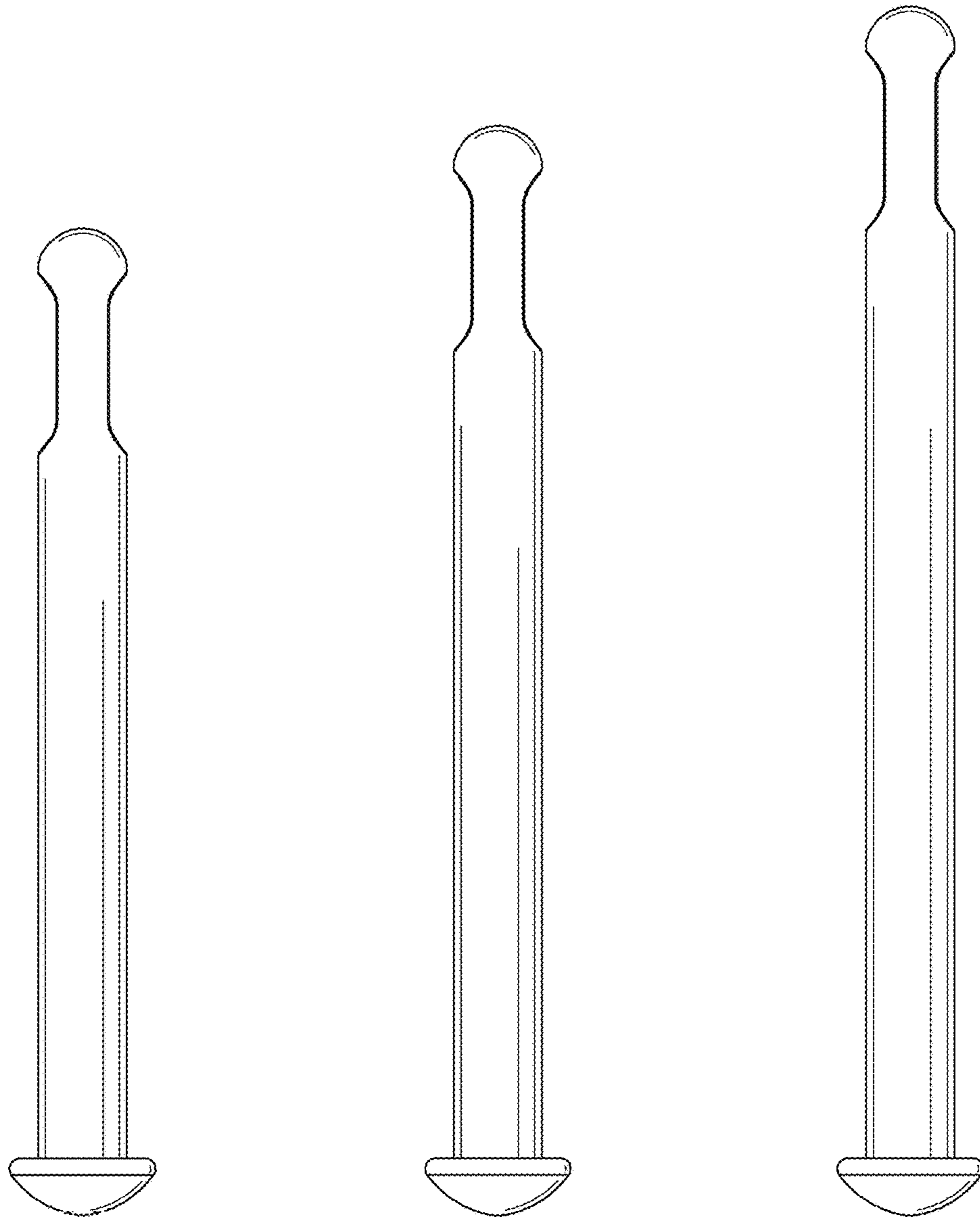

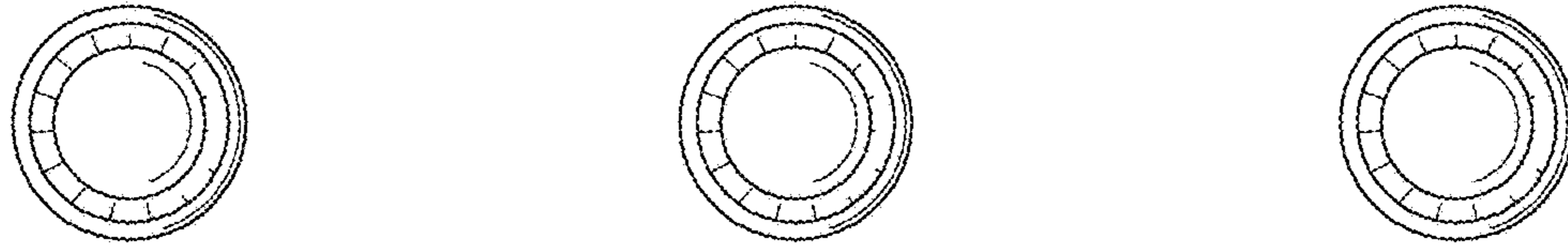

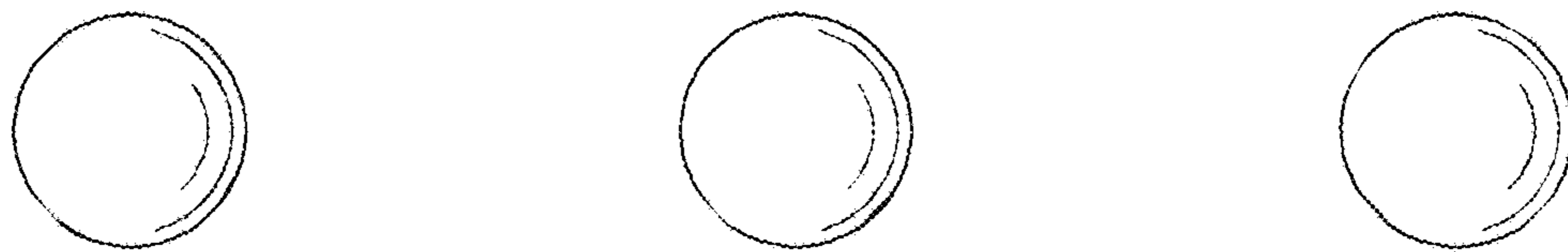
