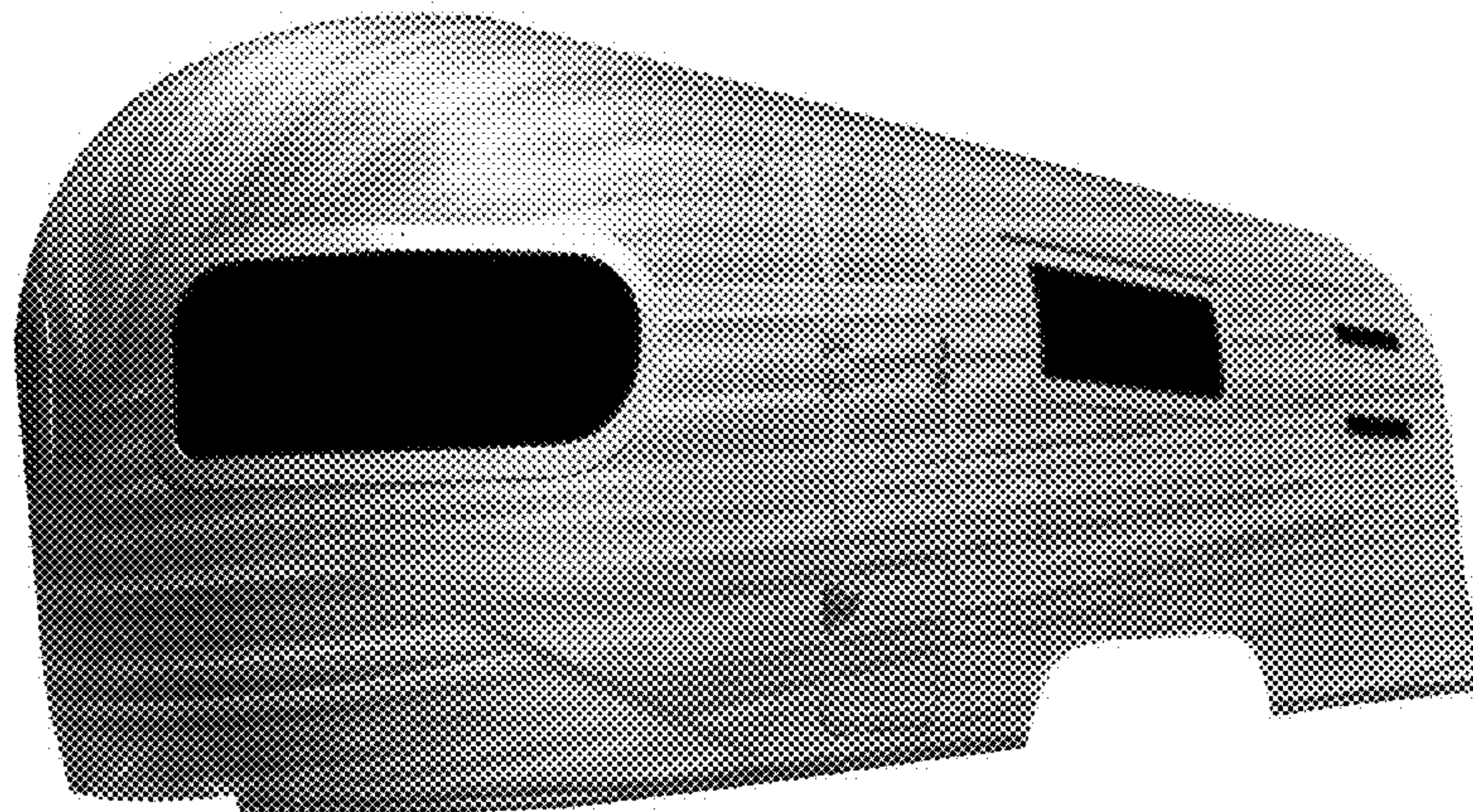
The ornamental design for a caravan, as shown and described.

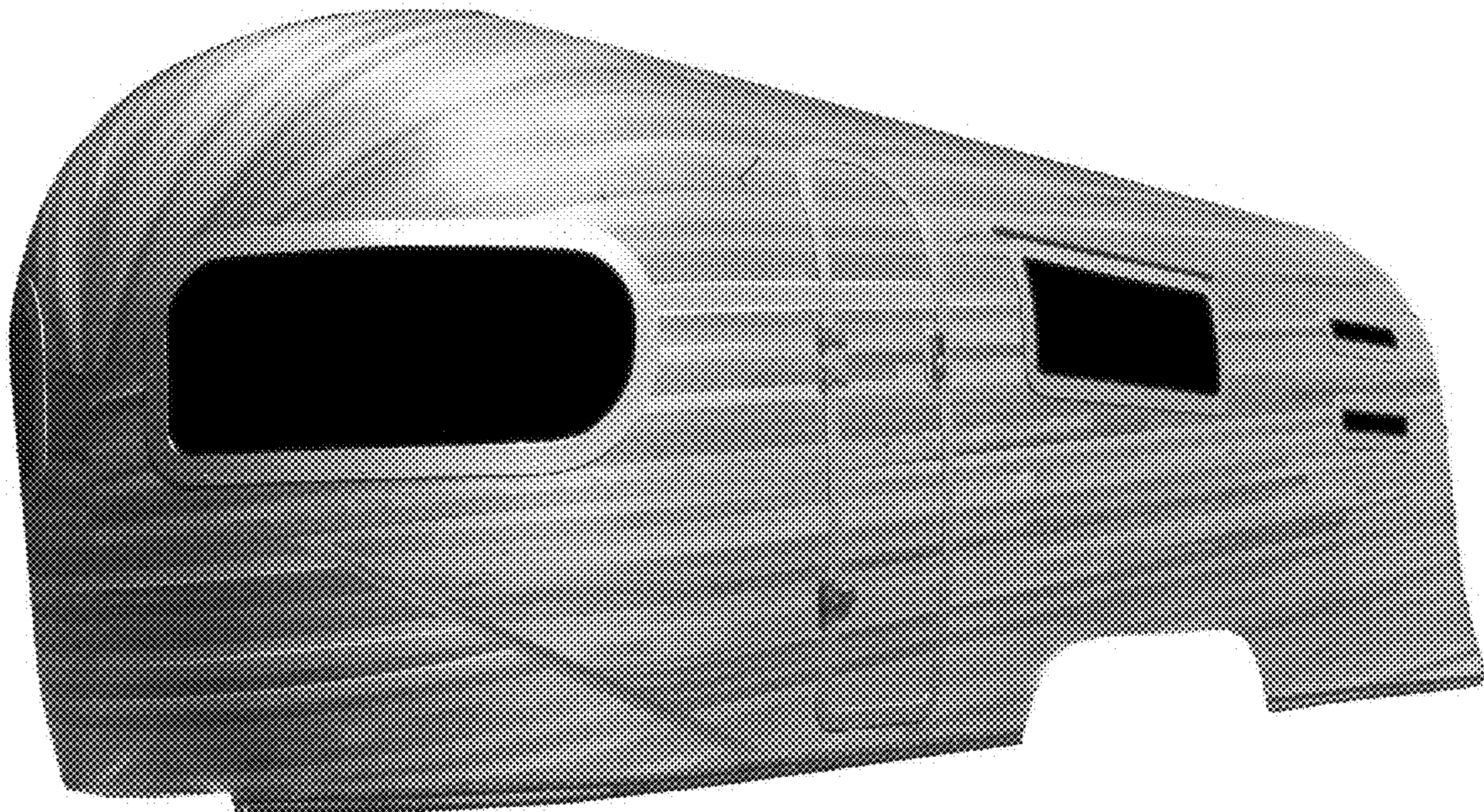

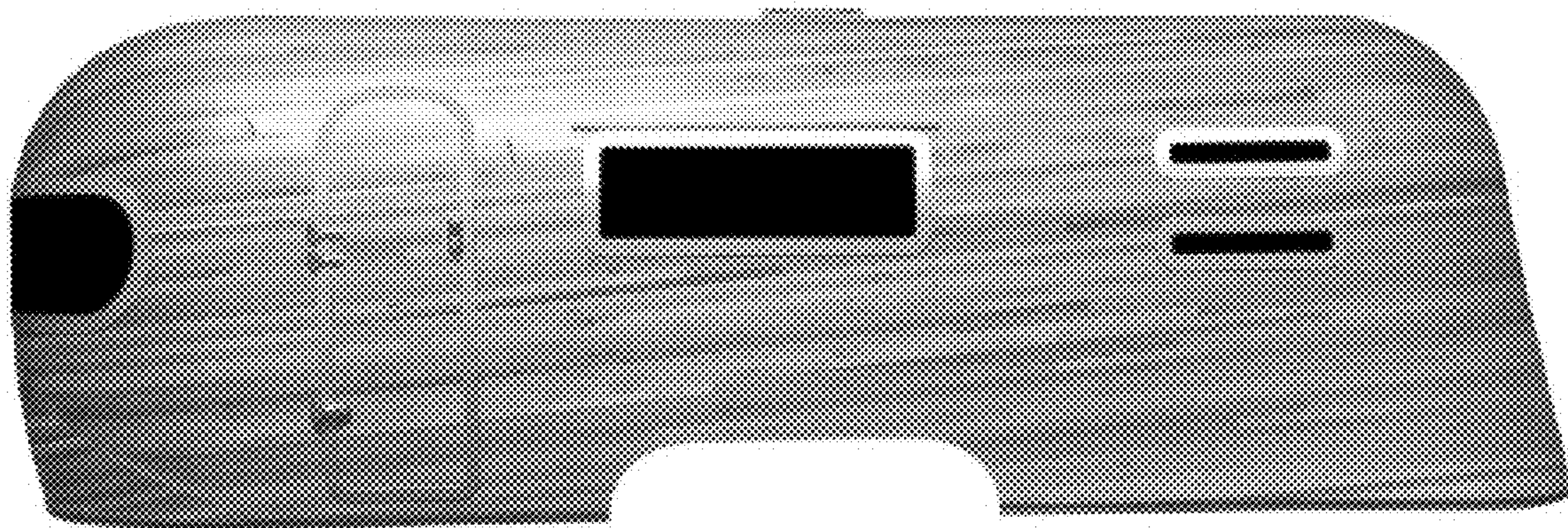

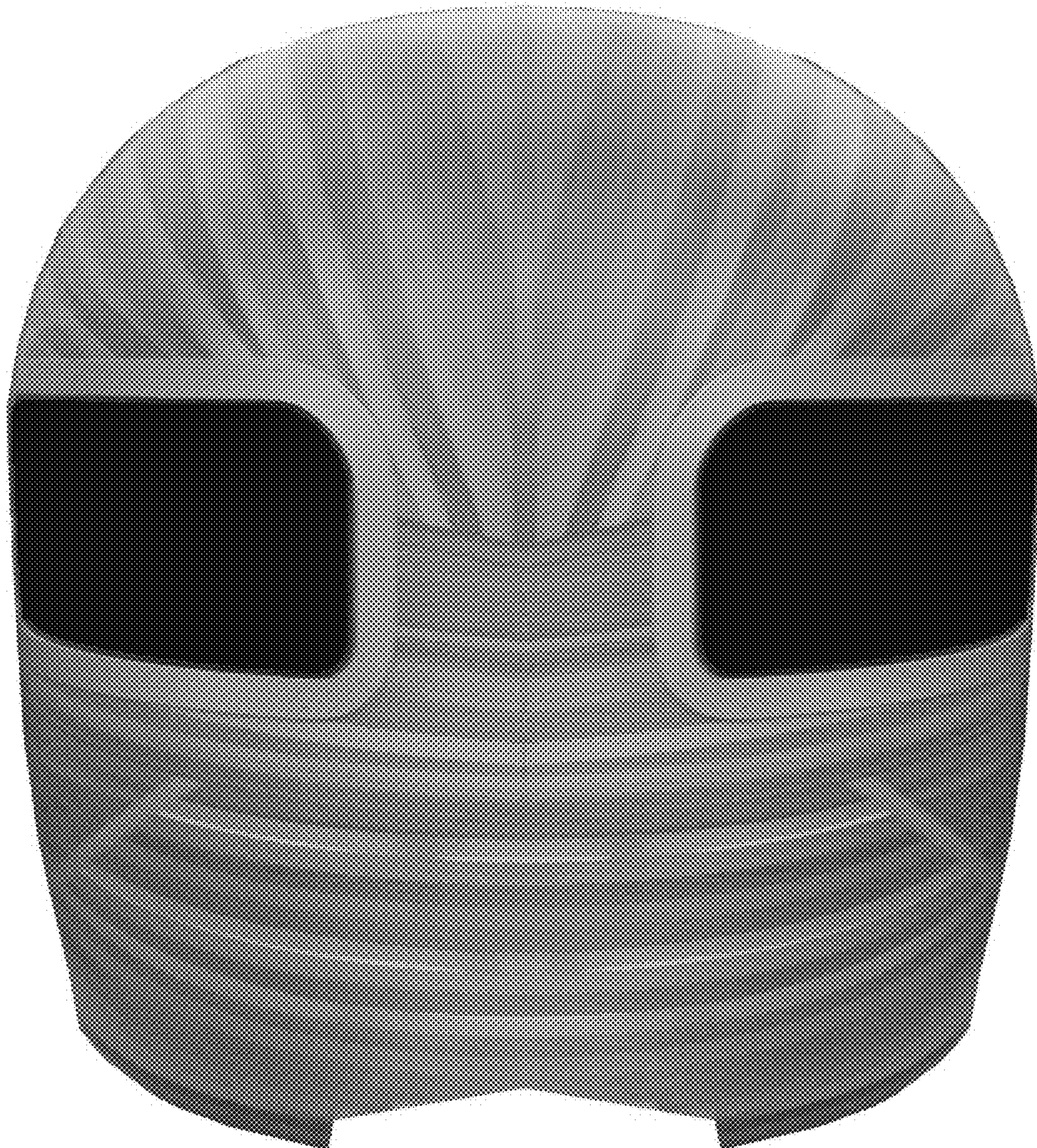

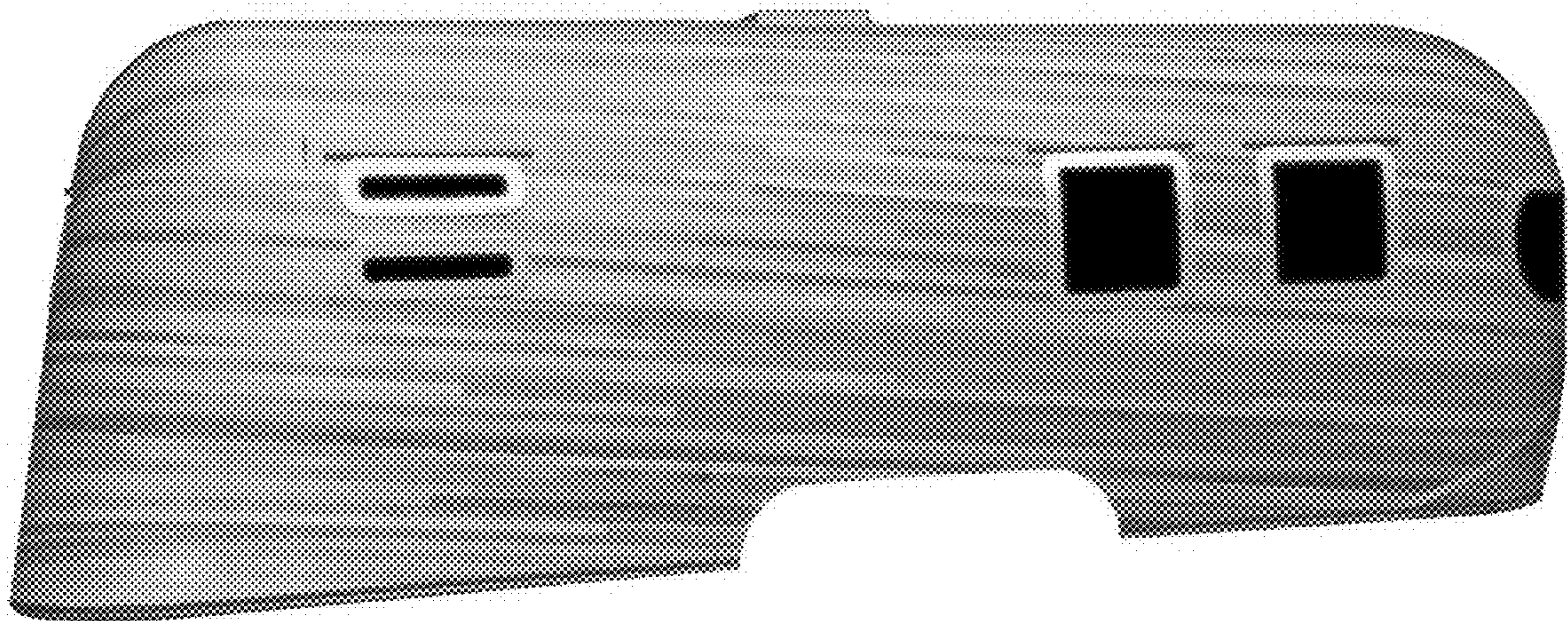
