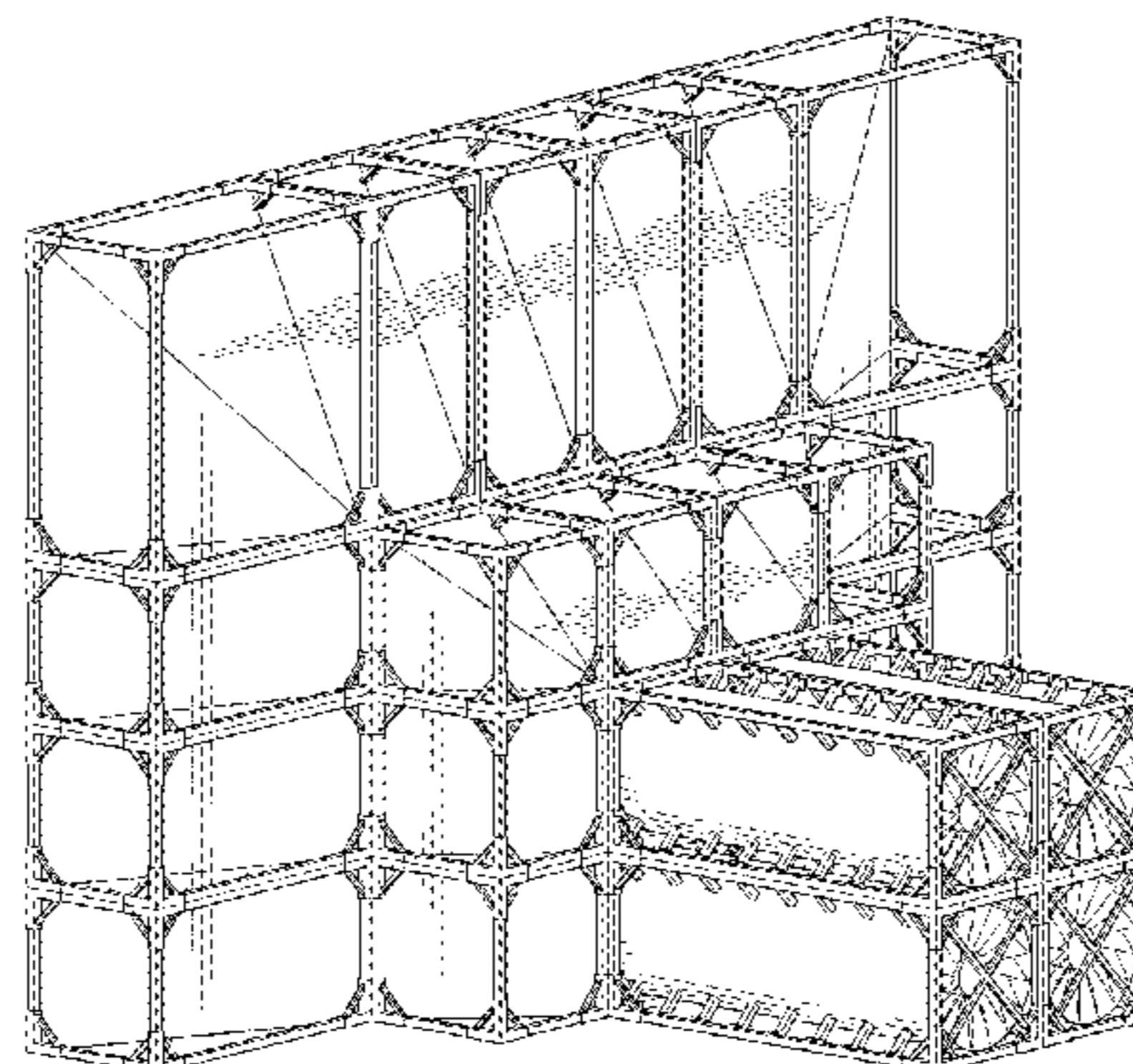
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a rear, top, right-side perspective view of a wind  
power generation apparatus;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a right-side elevational view thereof, the left-side  
elevational view being a mirror image thereof;

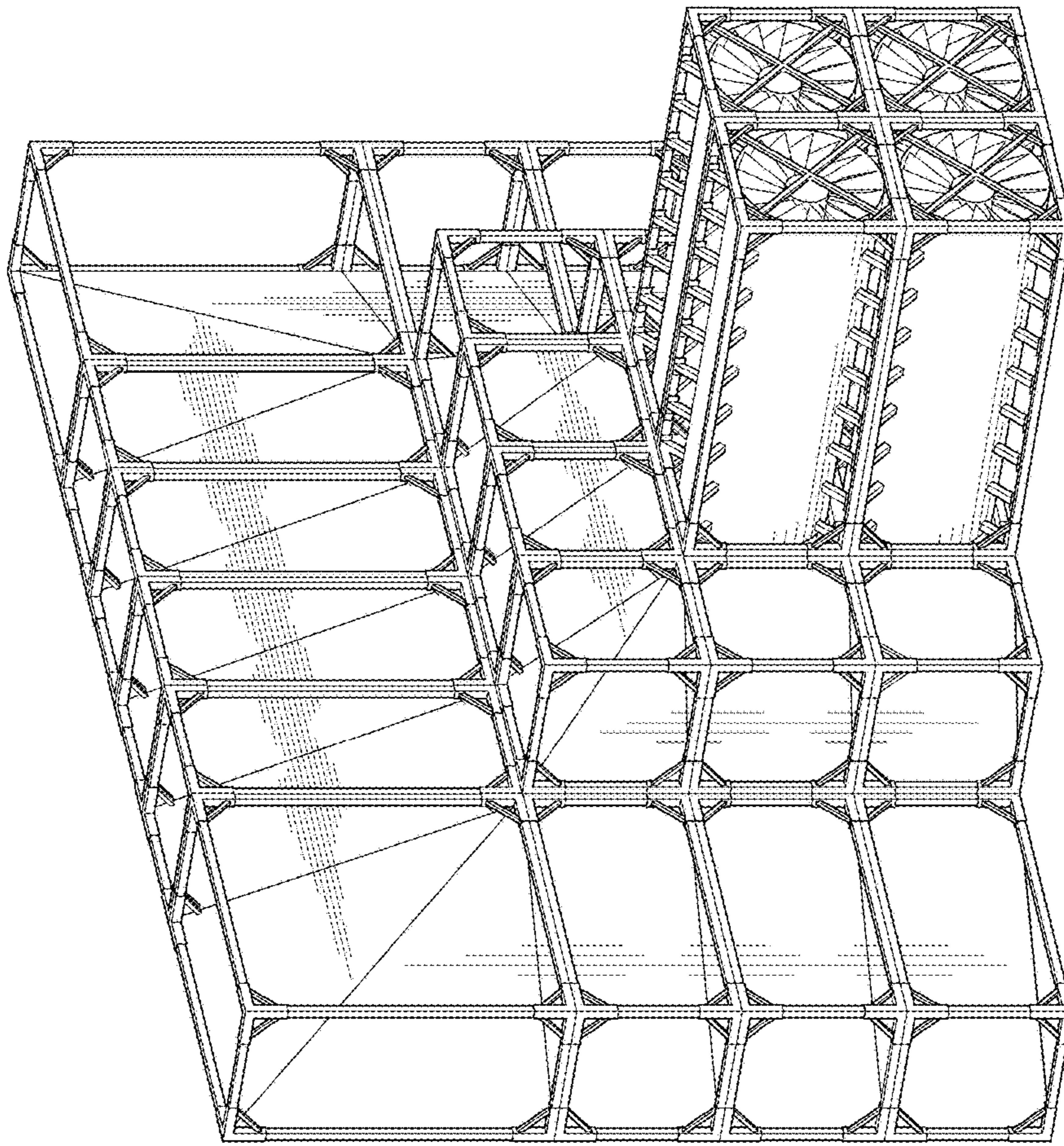

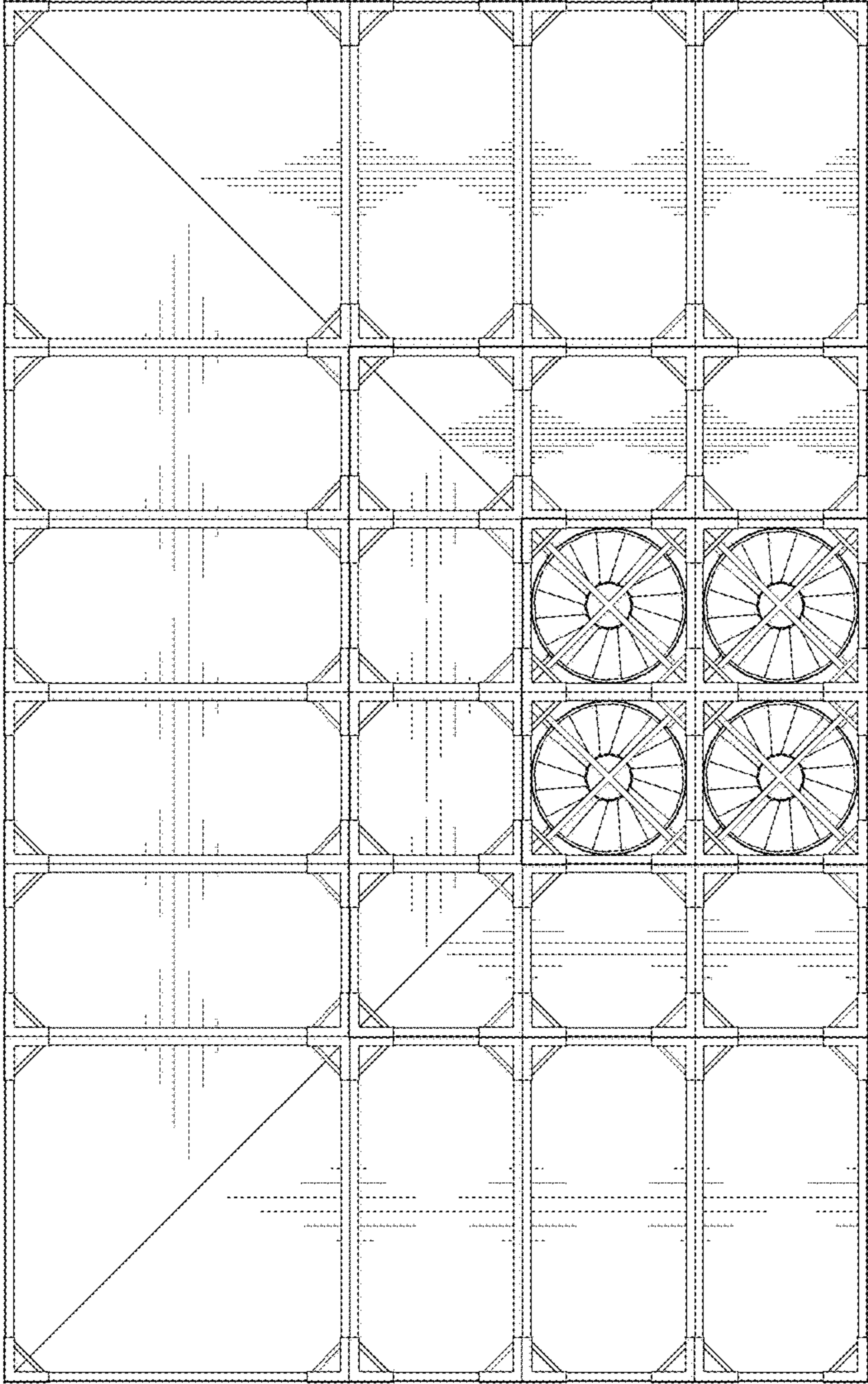

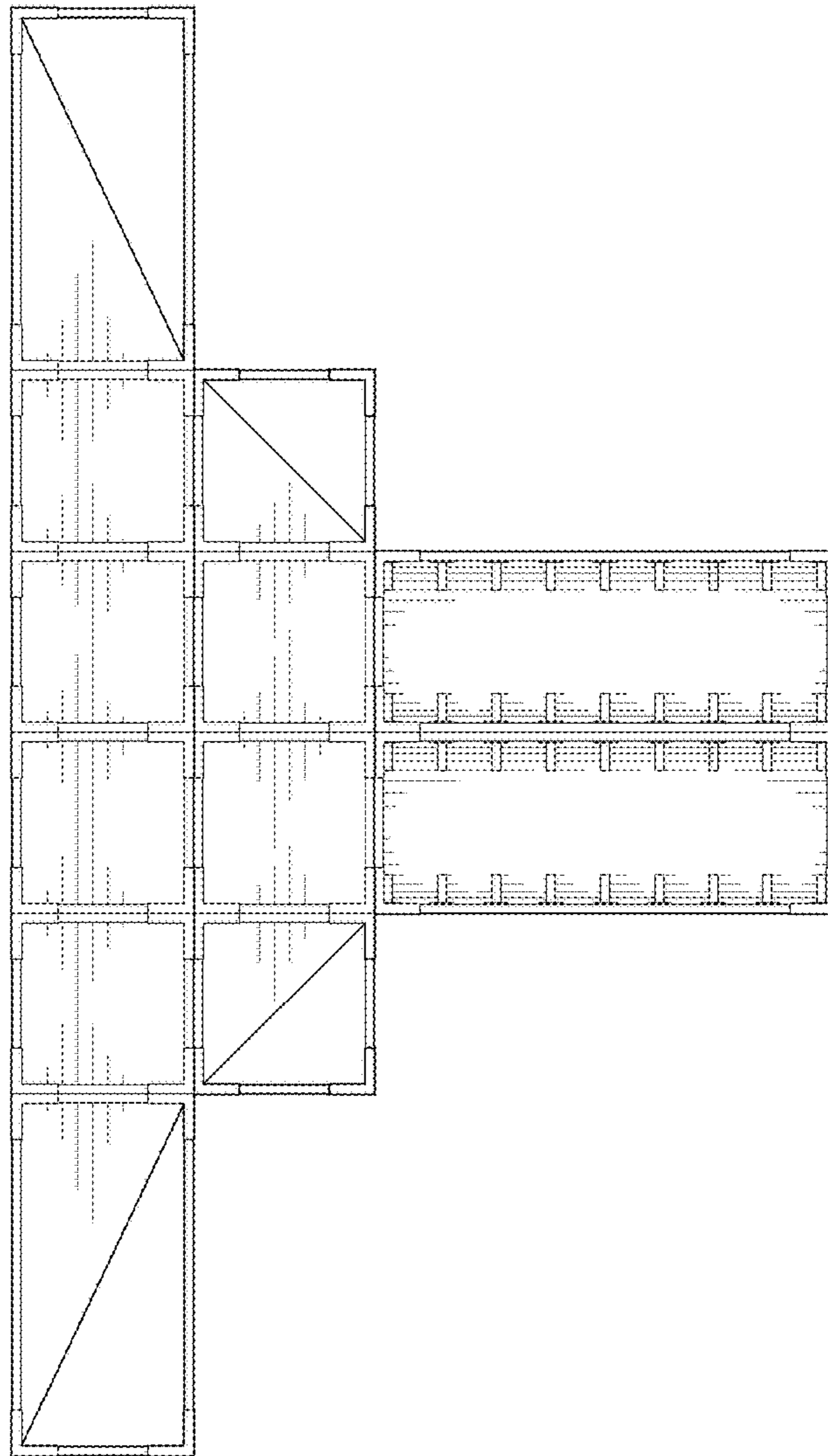

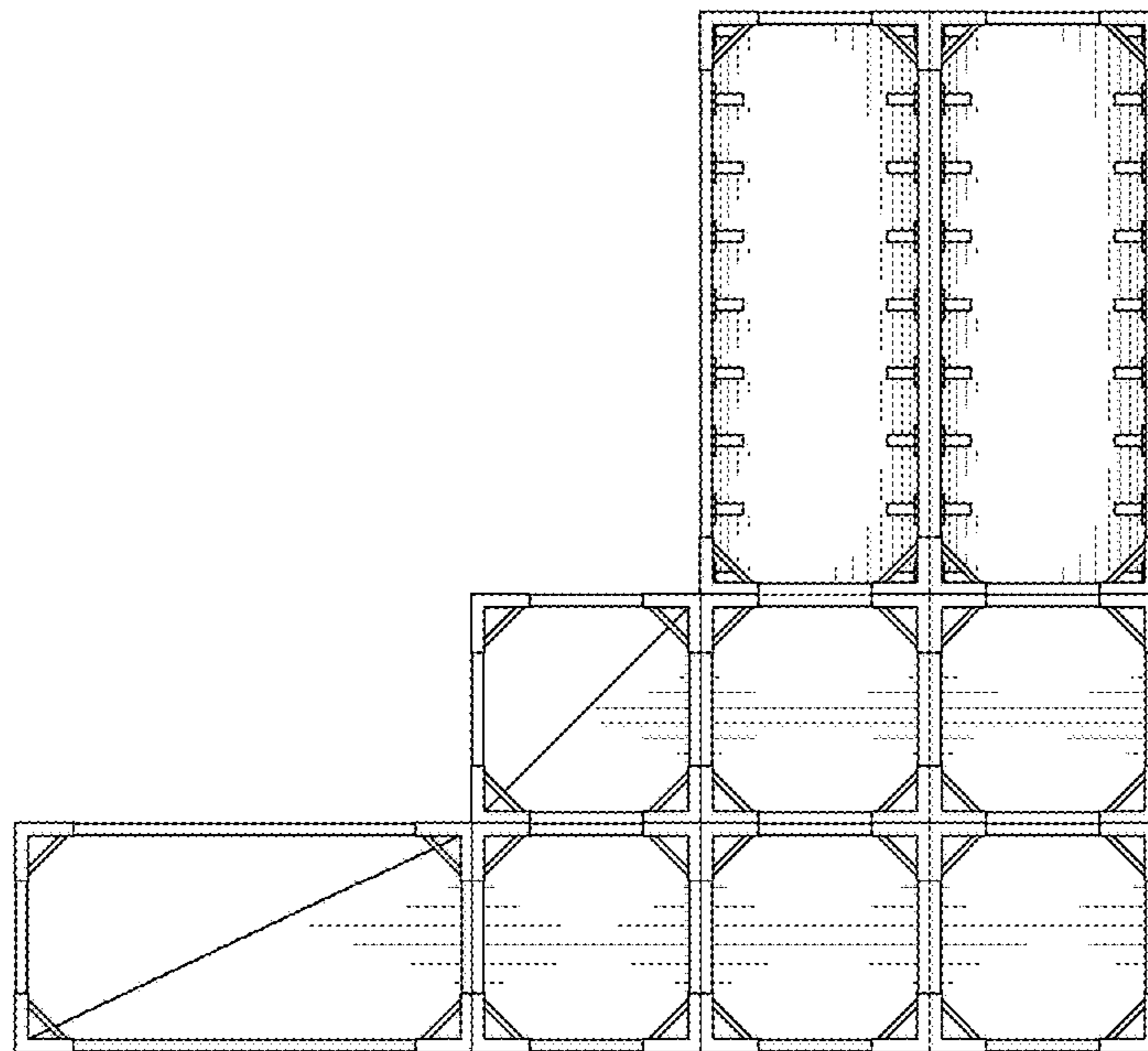

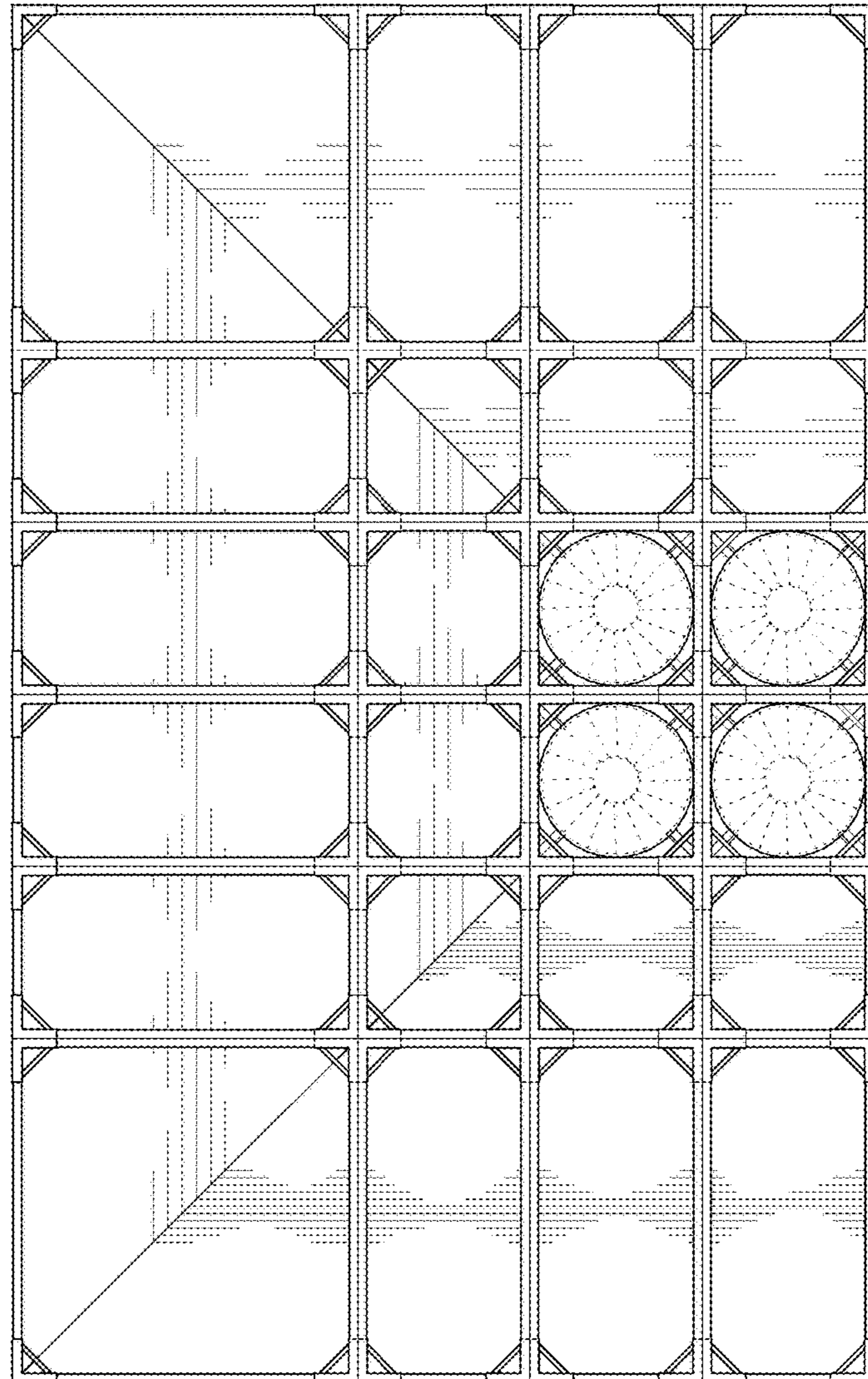

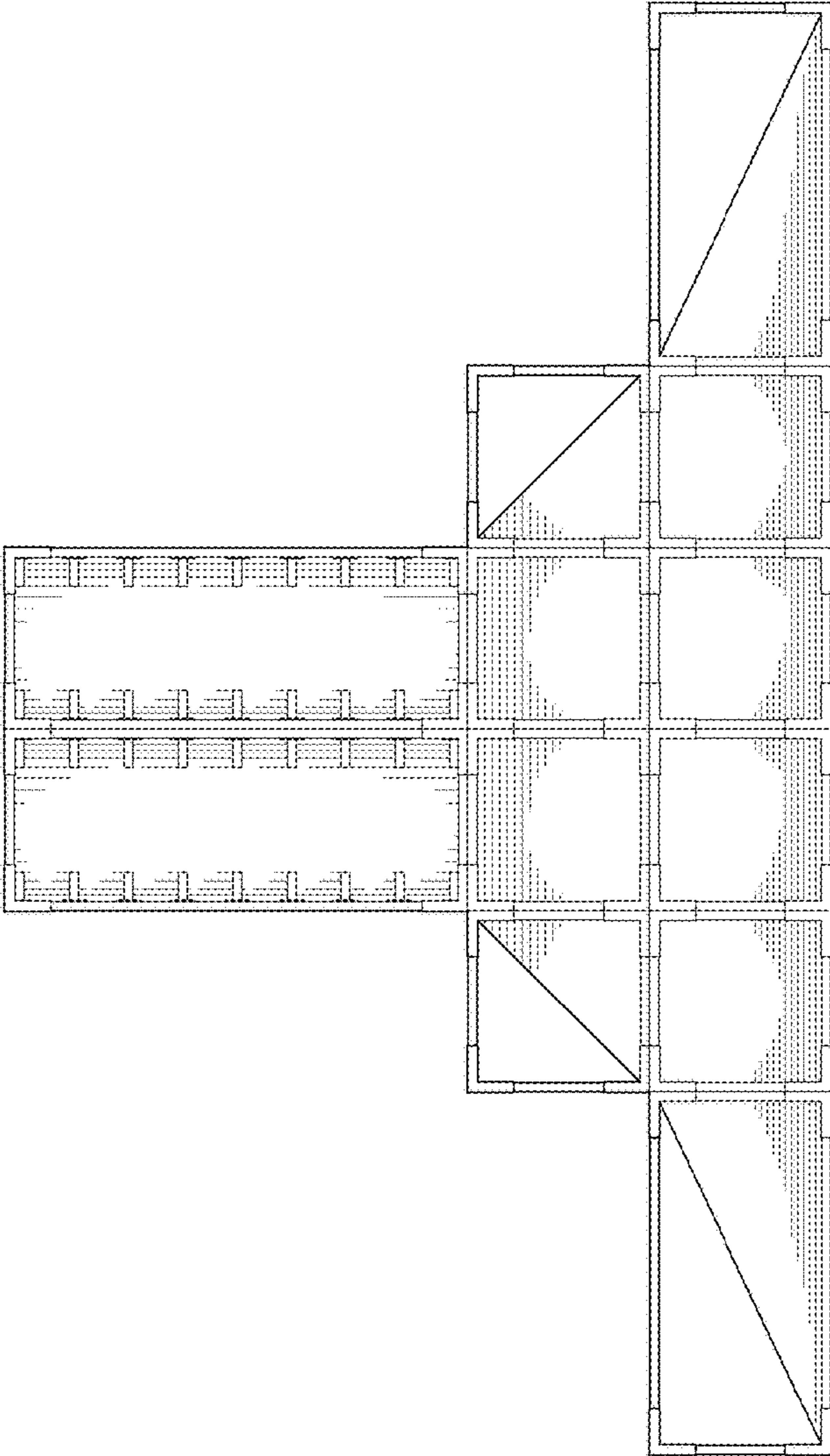
