**DESCRIPTION**

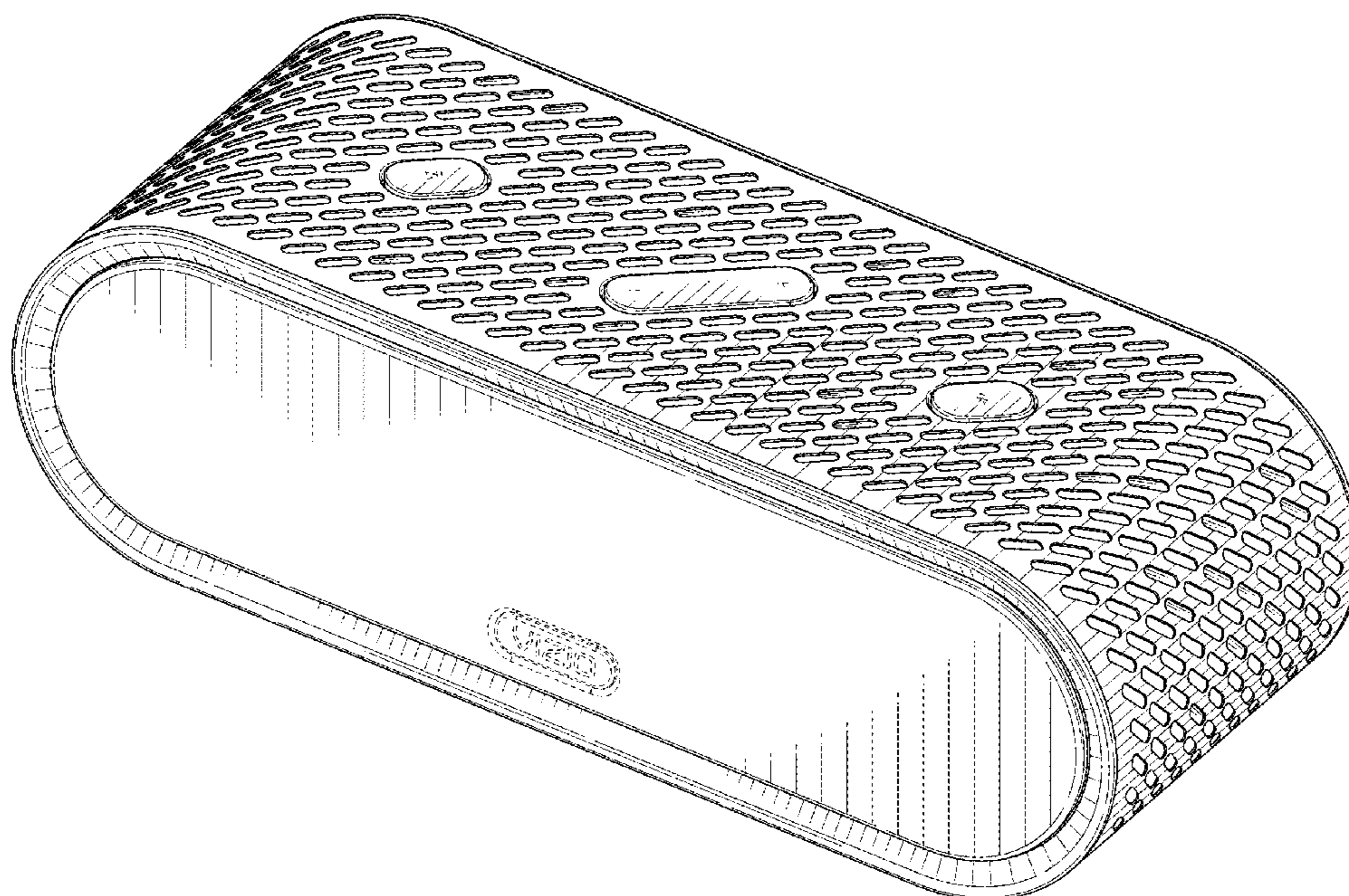
FIG. 1 is a perspective view of a speaker, showing our new design;

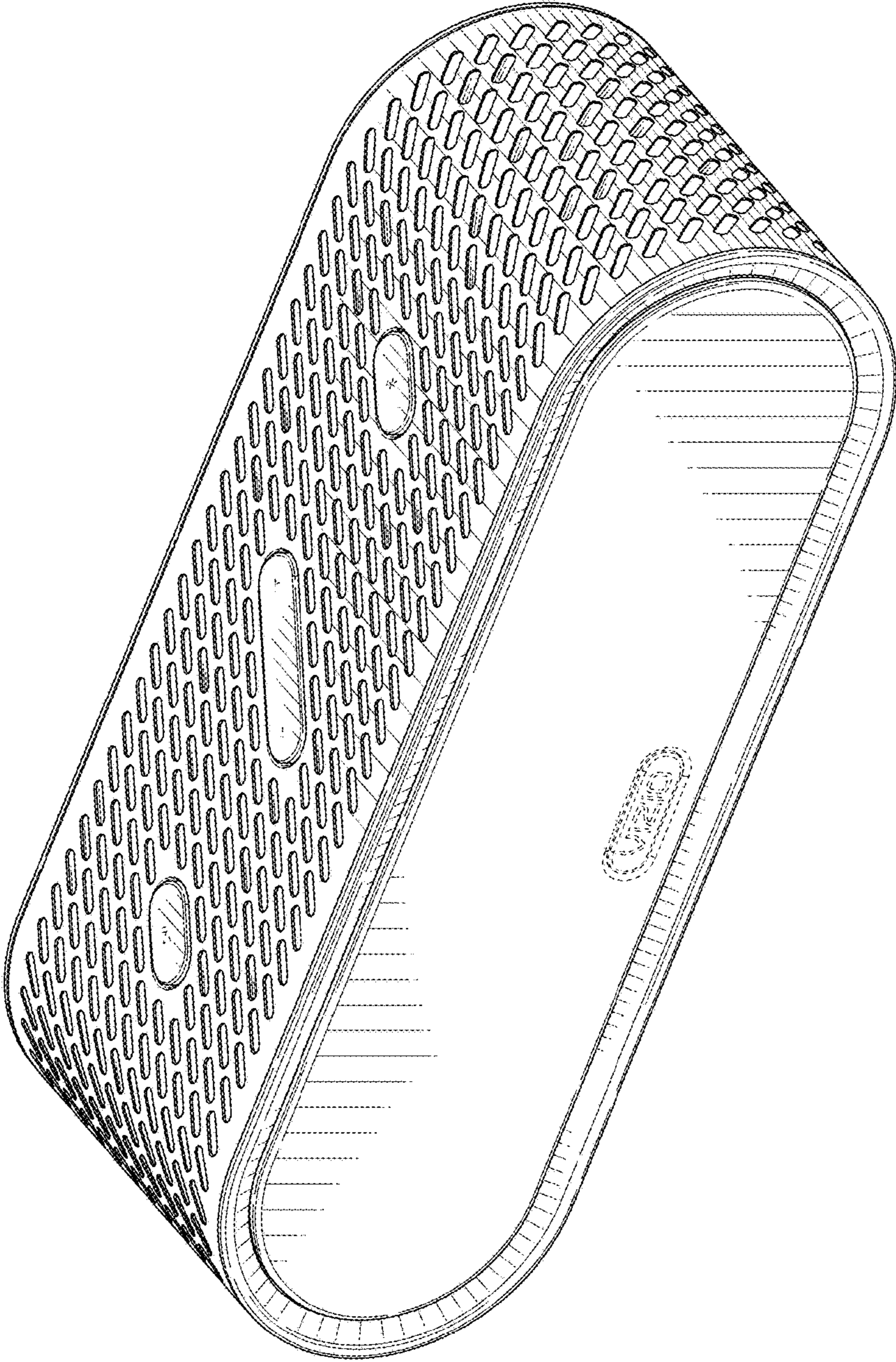

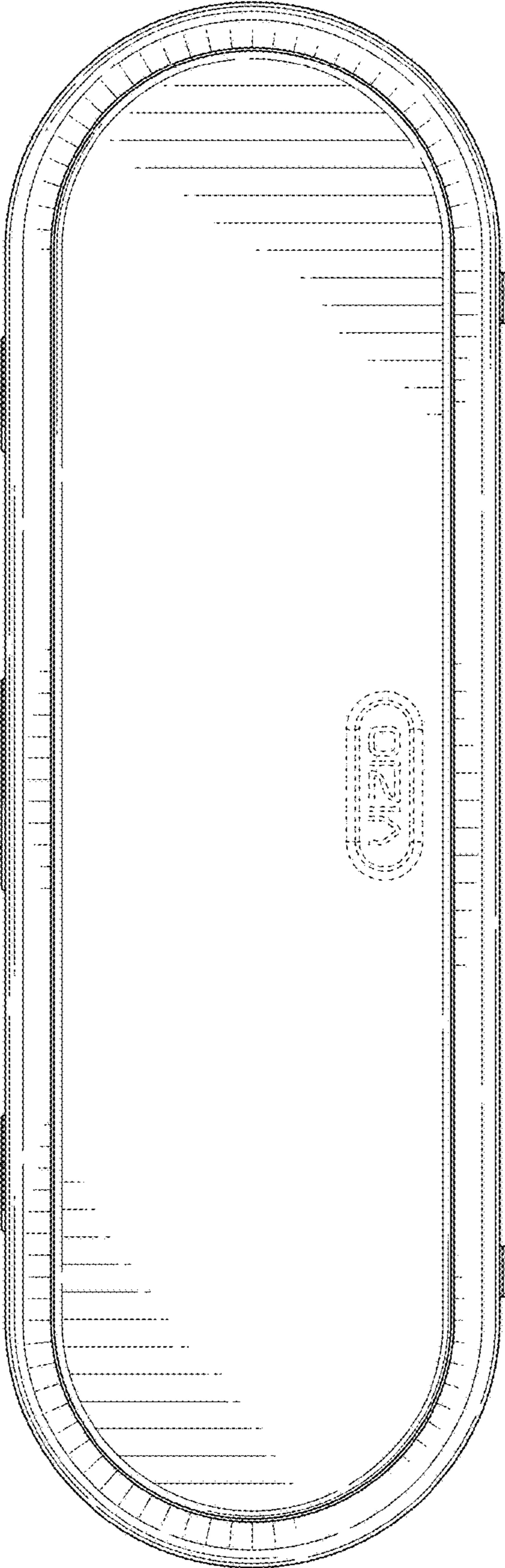

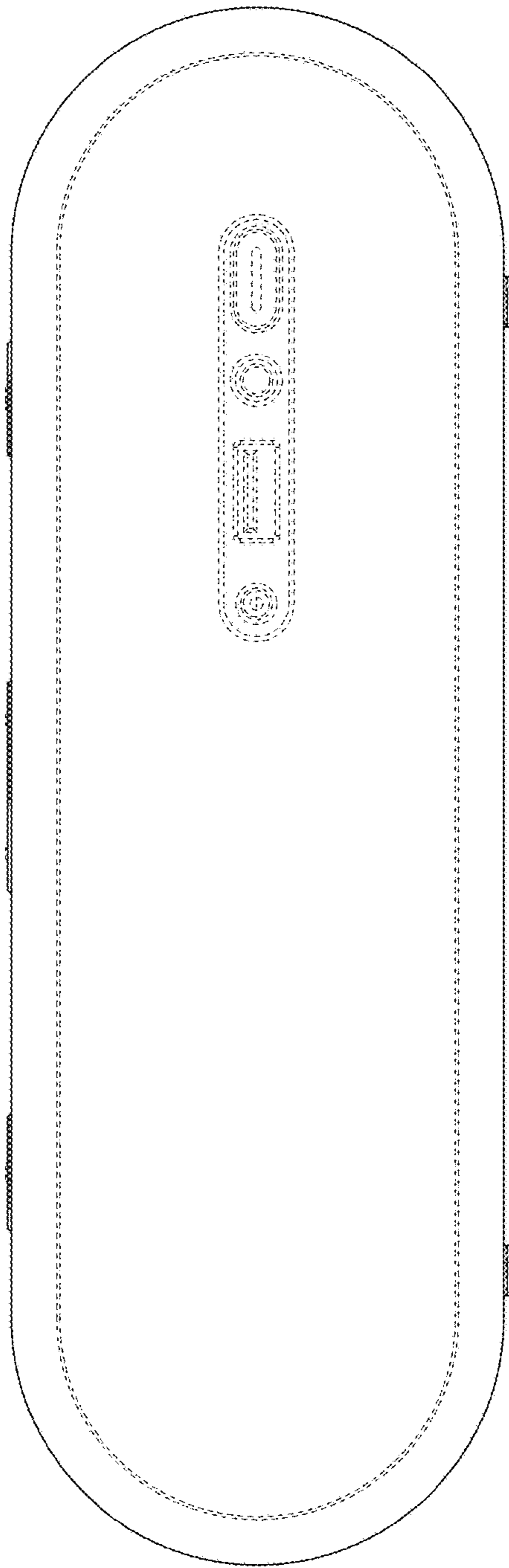

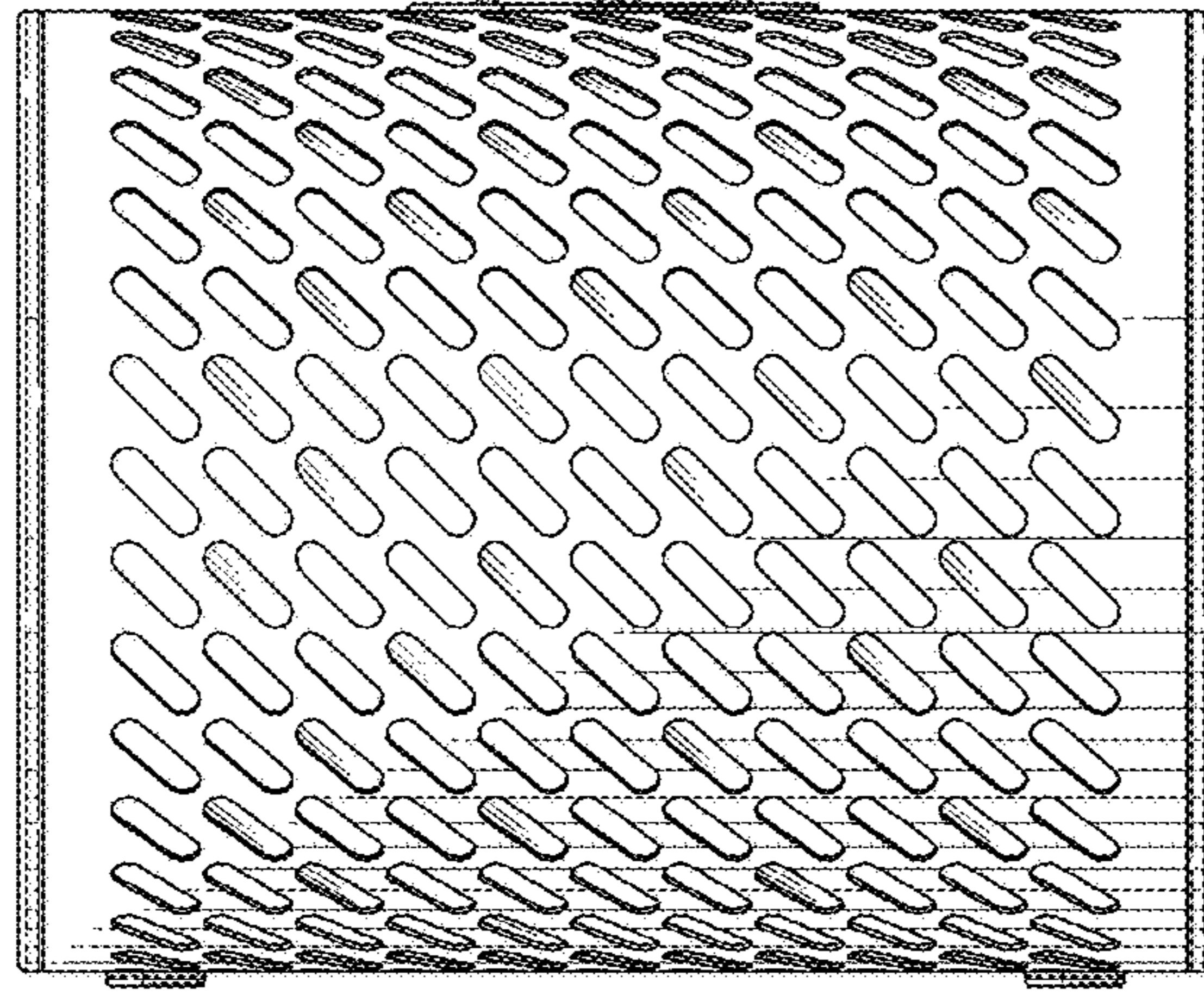

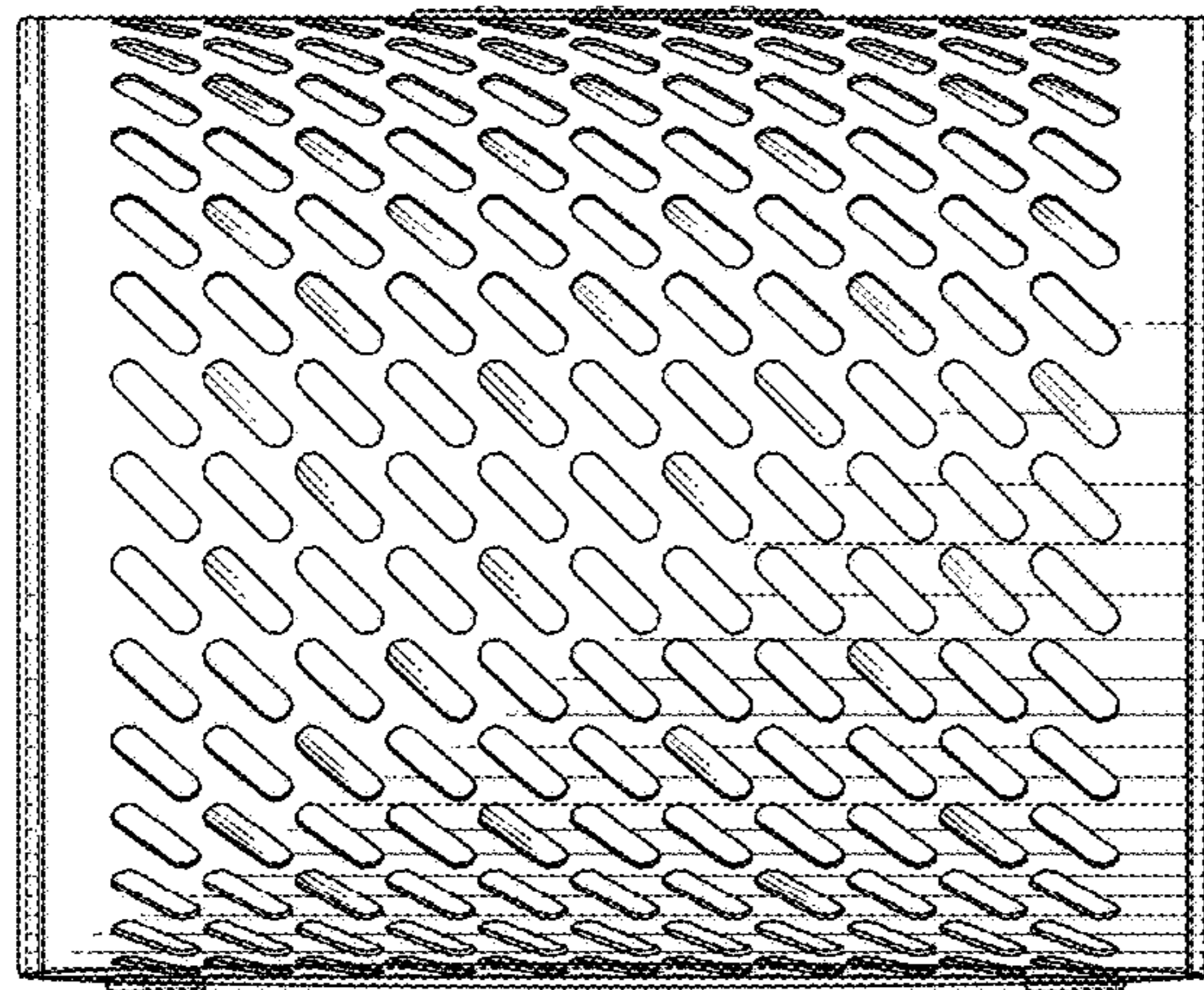

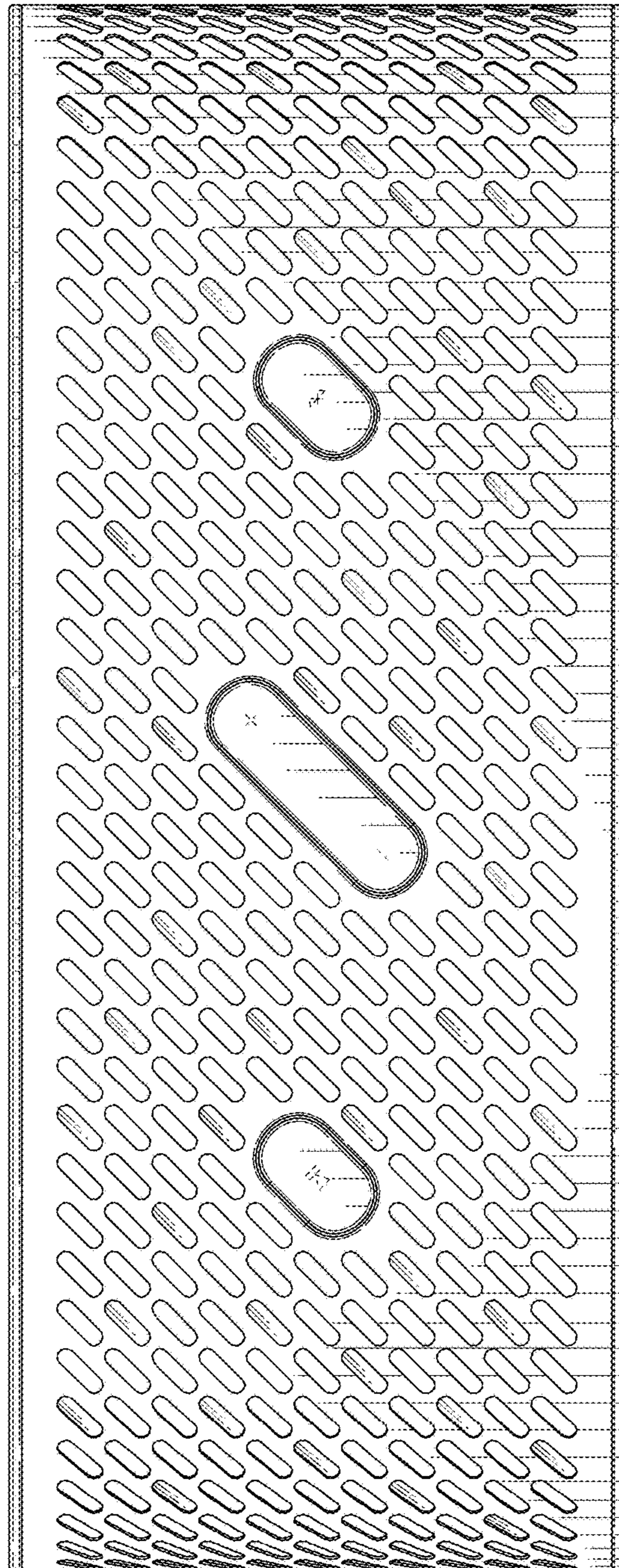

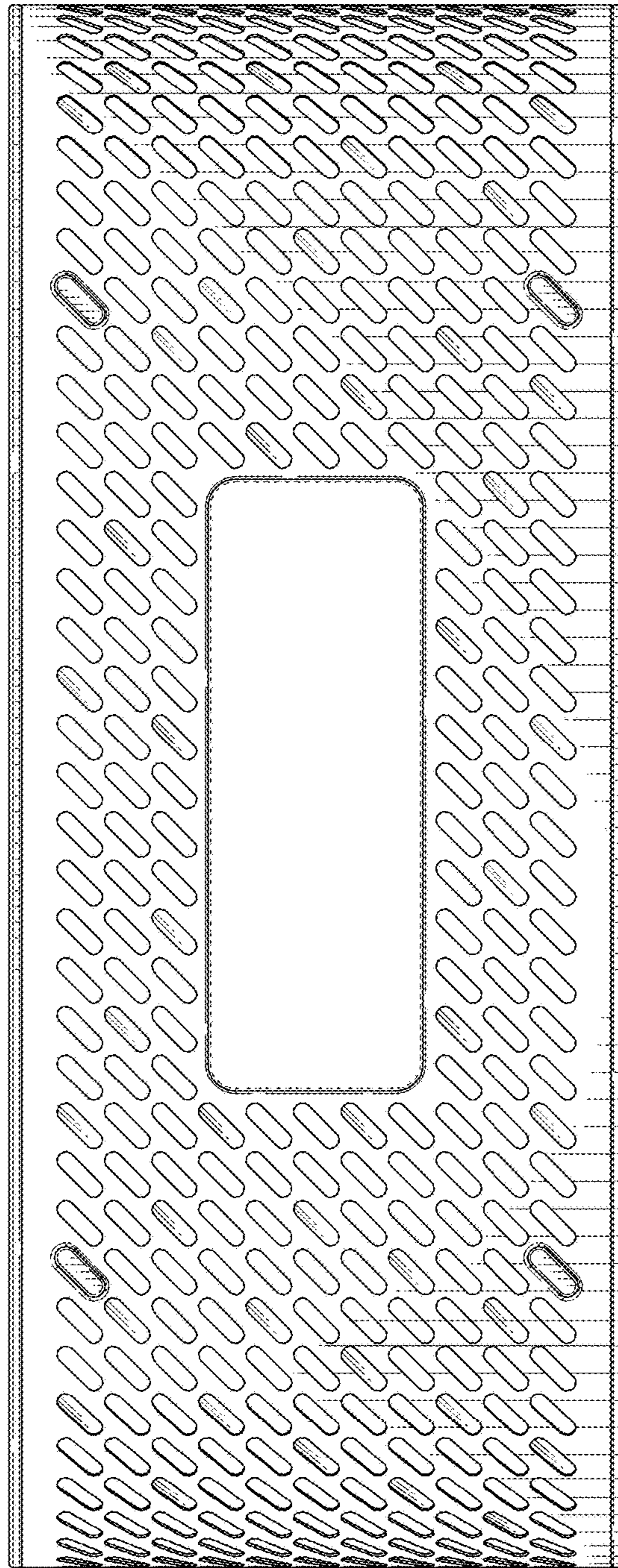
