DESCRIPTION

FIG. 1 is a front, top, right side perspective view of a speaker, showing my new design;
FIG. 2 is a rear, bottom, left side perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right side view thereof, left side view being a mirror image thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

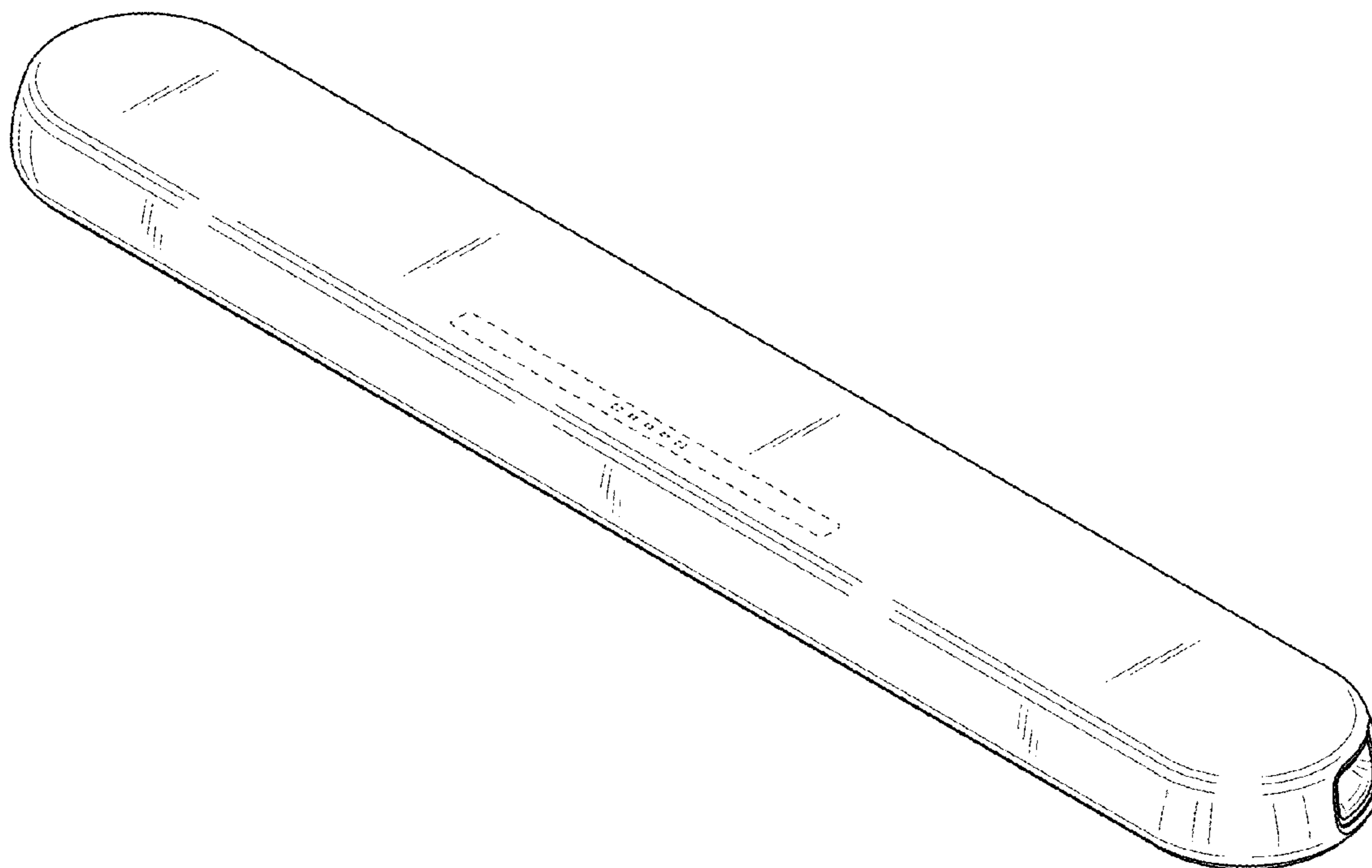
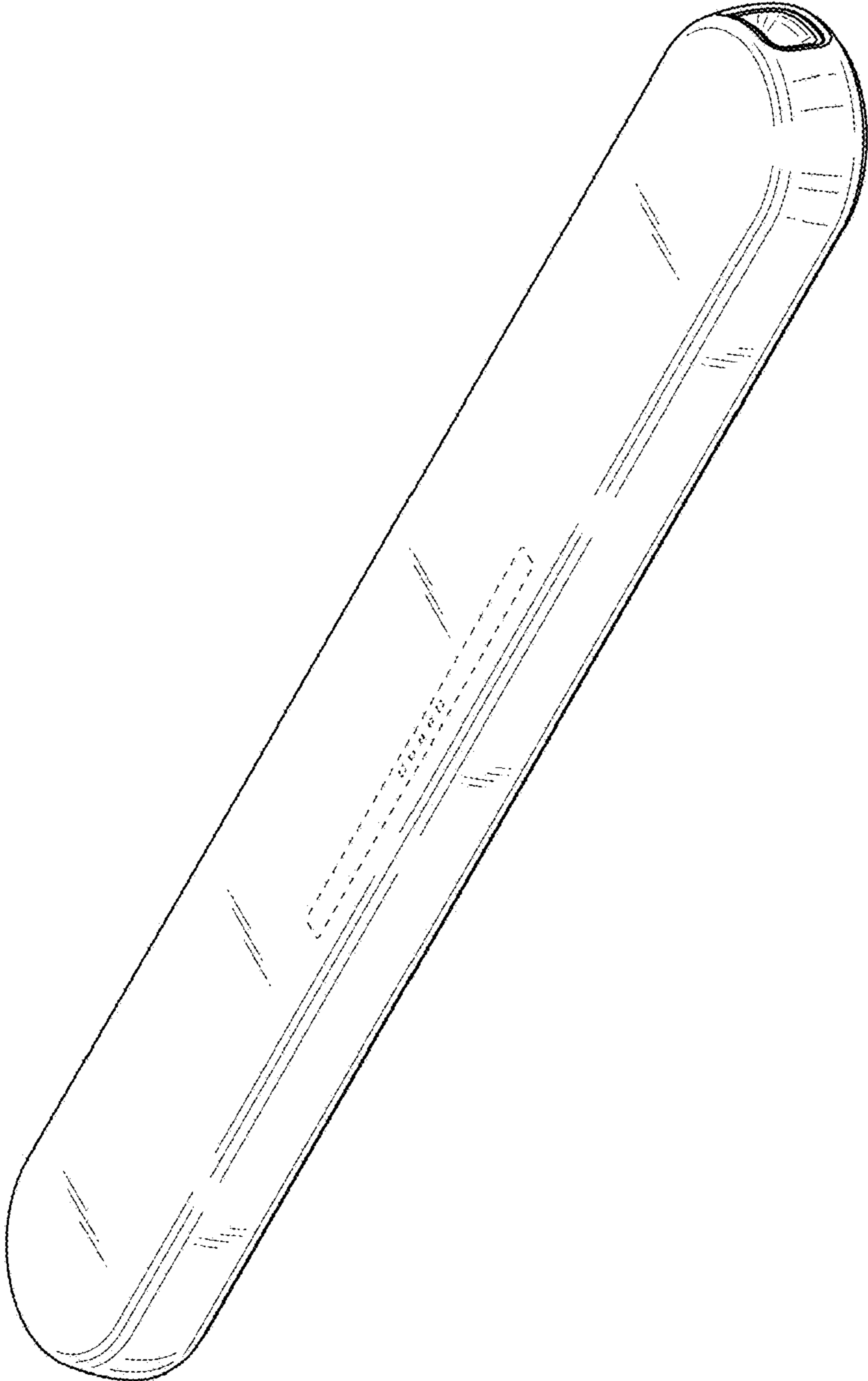

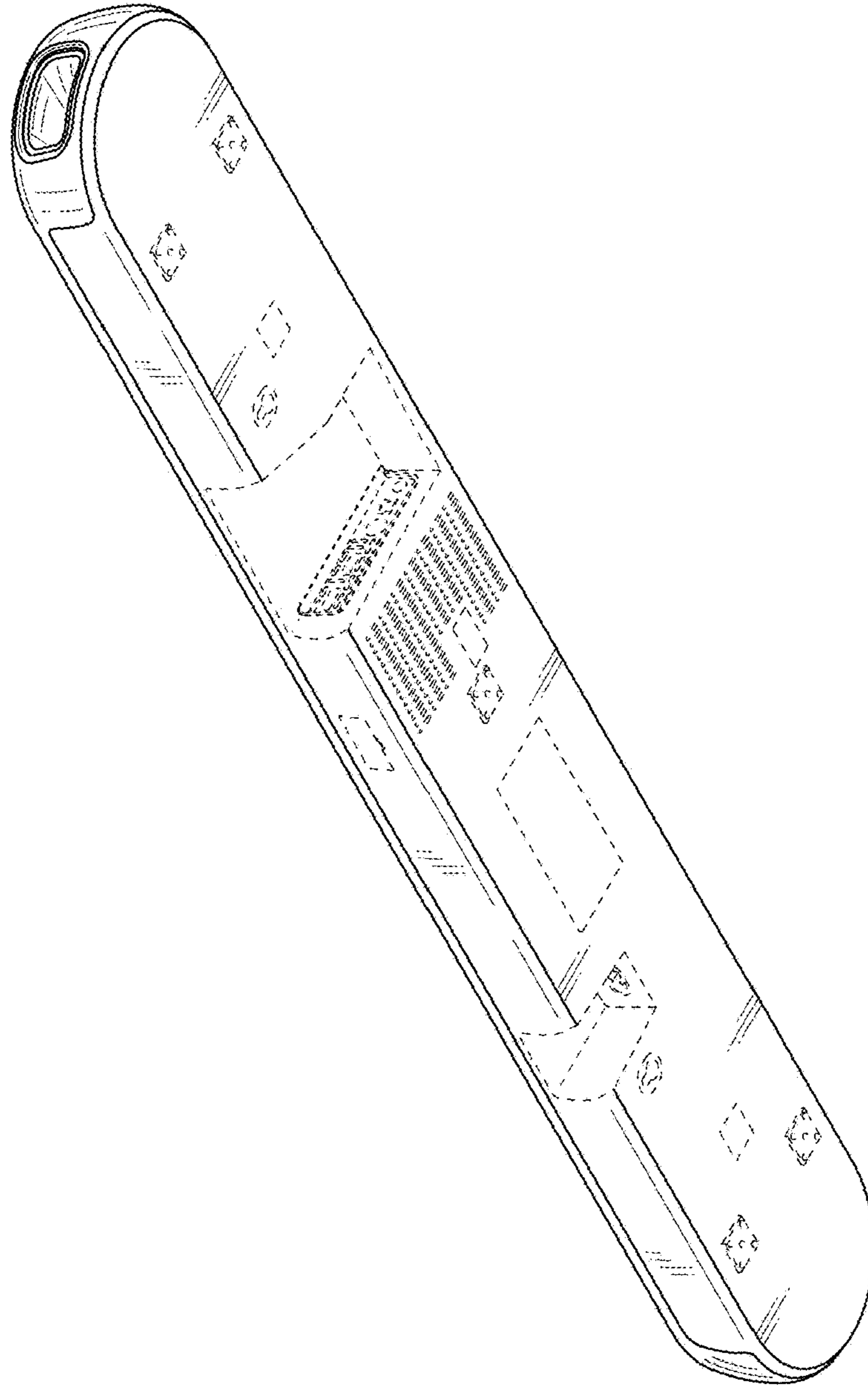

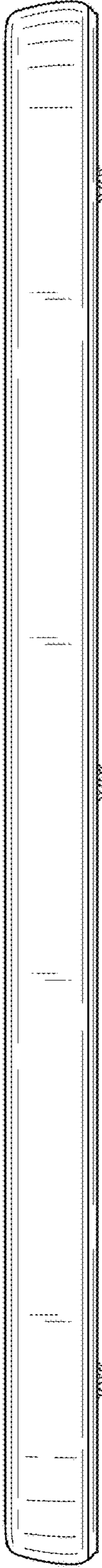

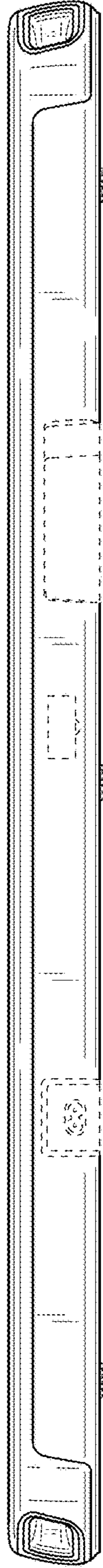

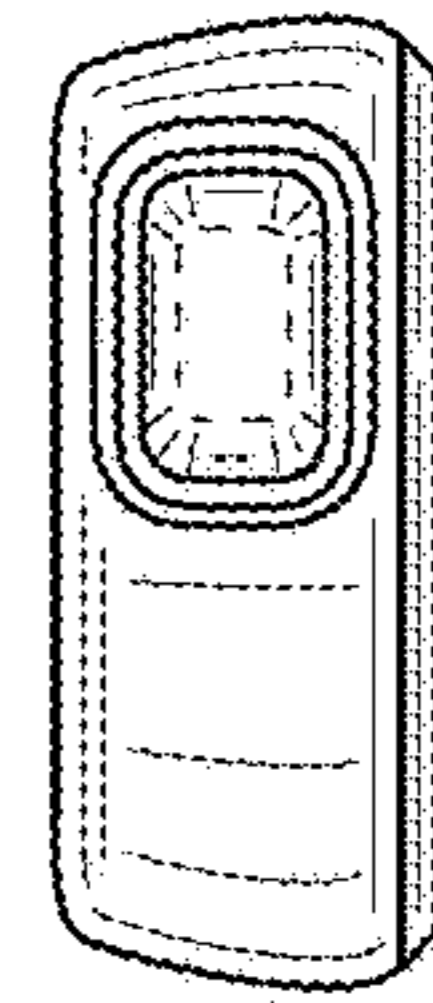

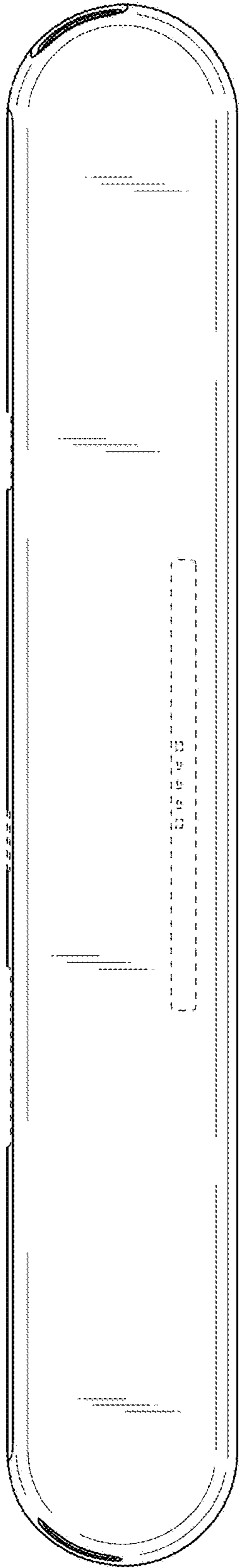
