**DESCRIPTION**

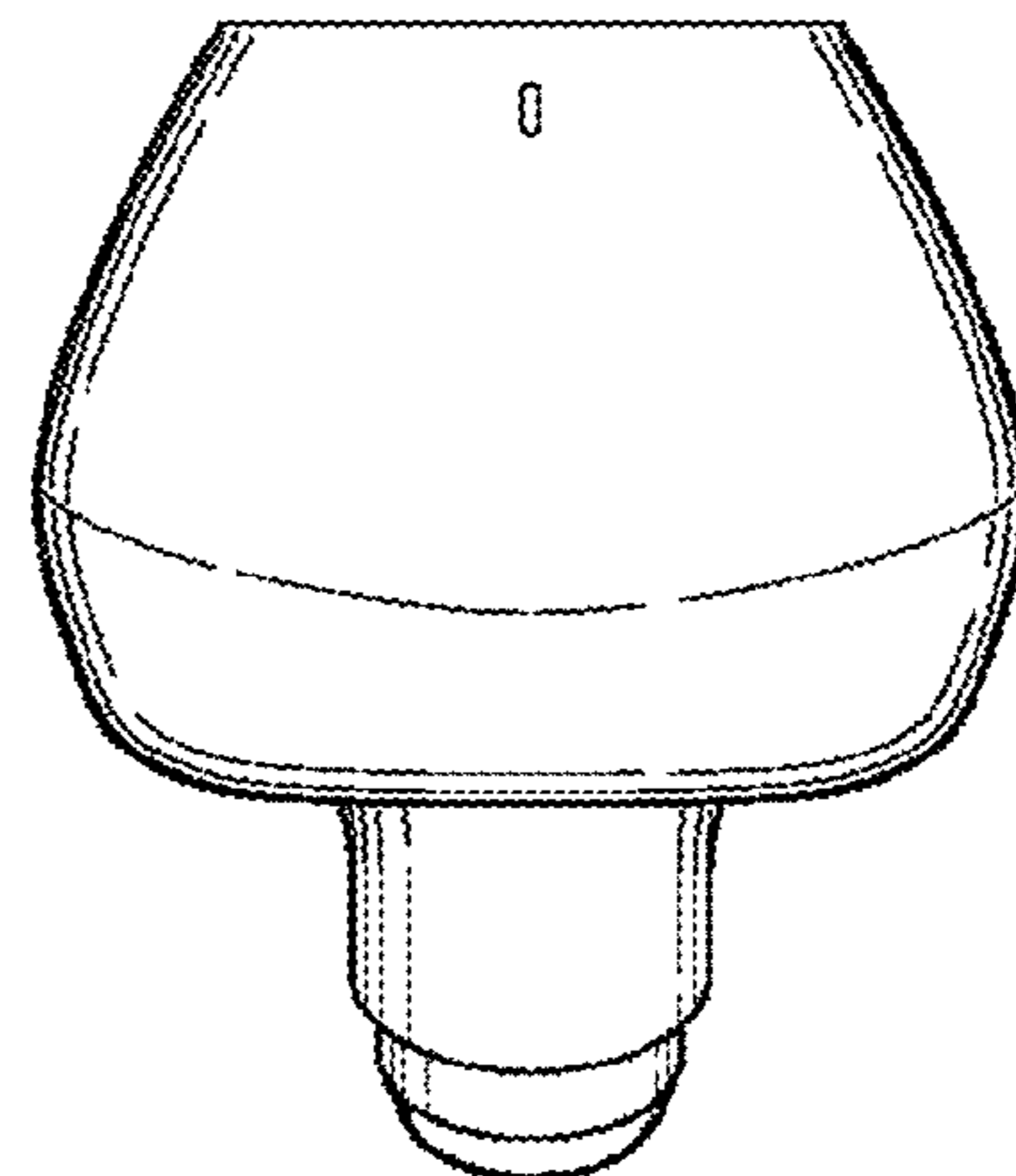
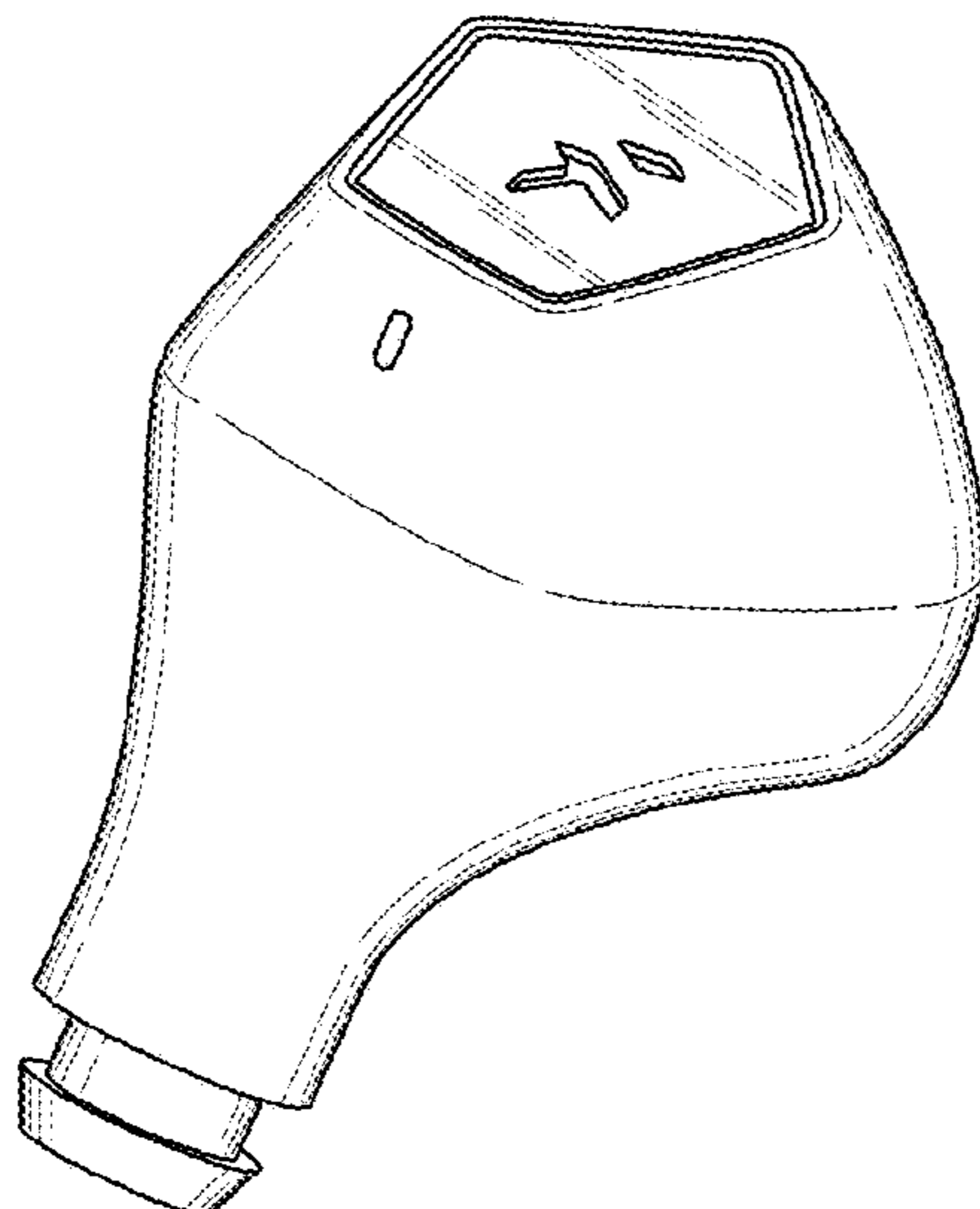

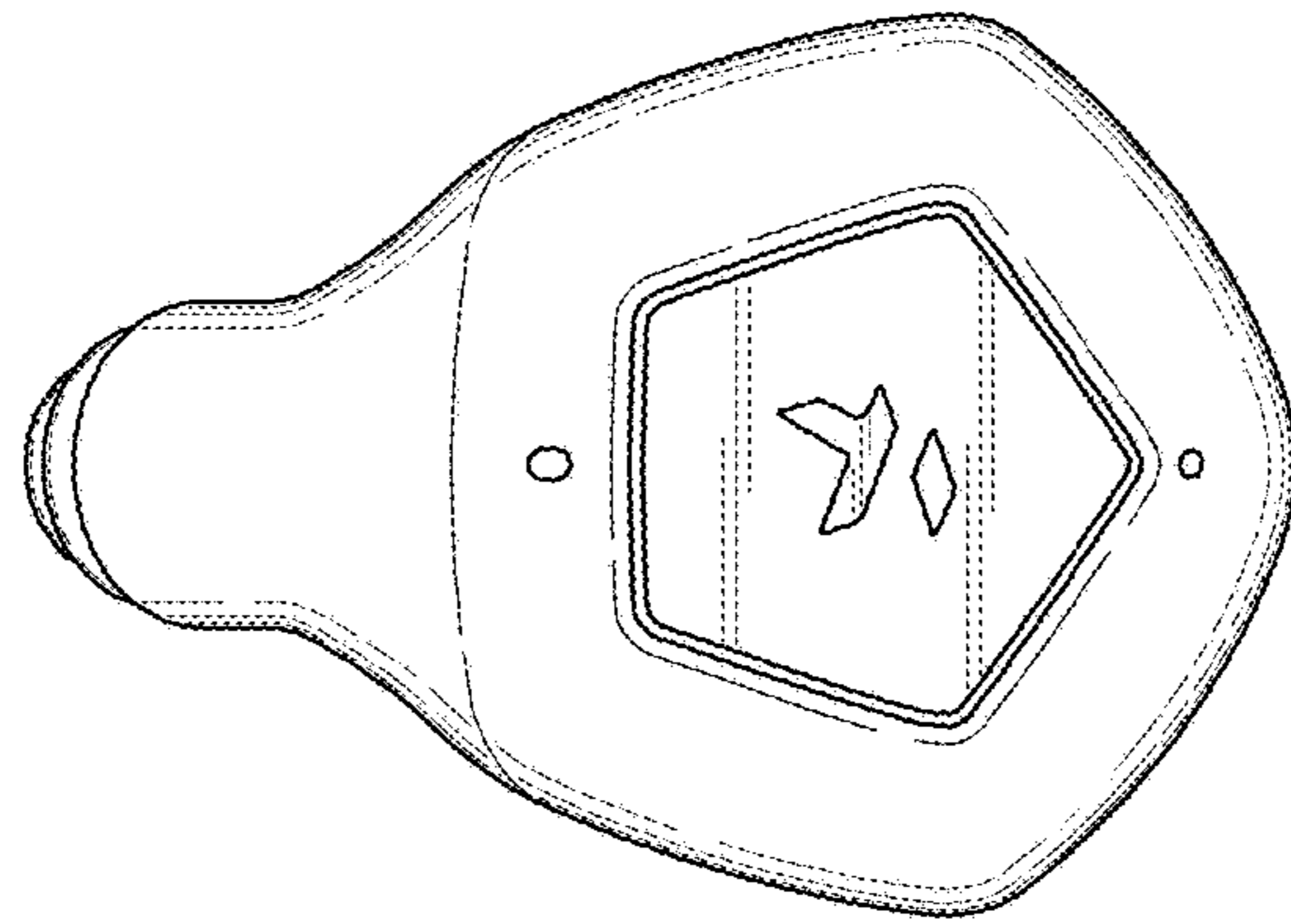

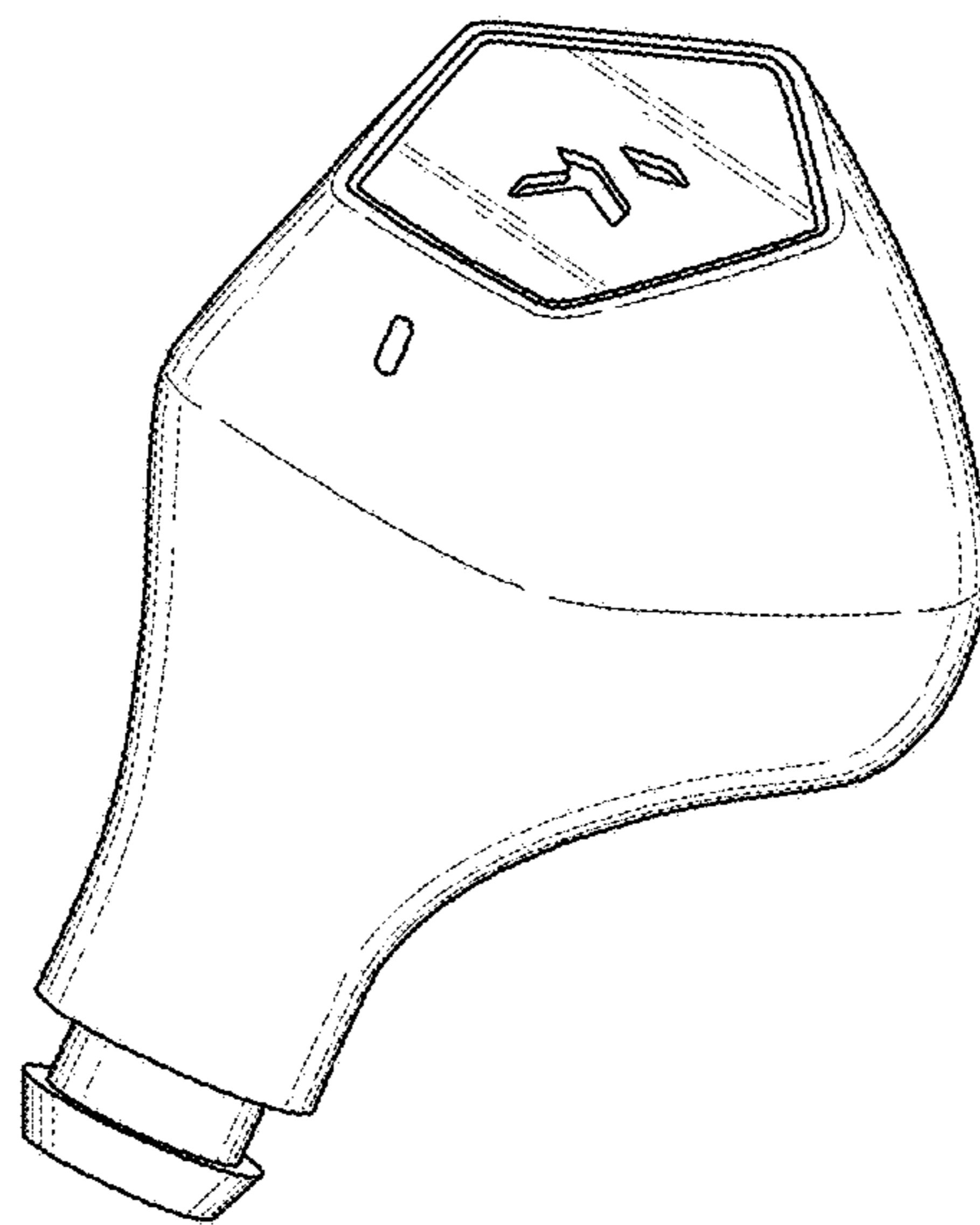

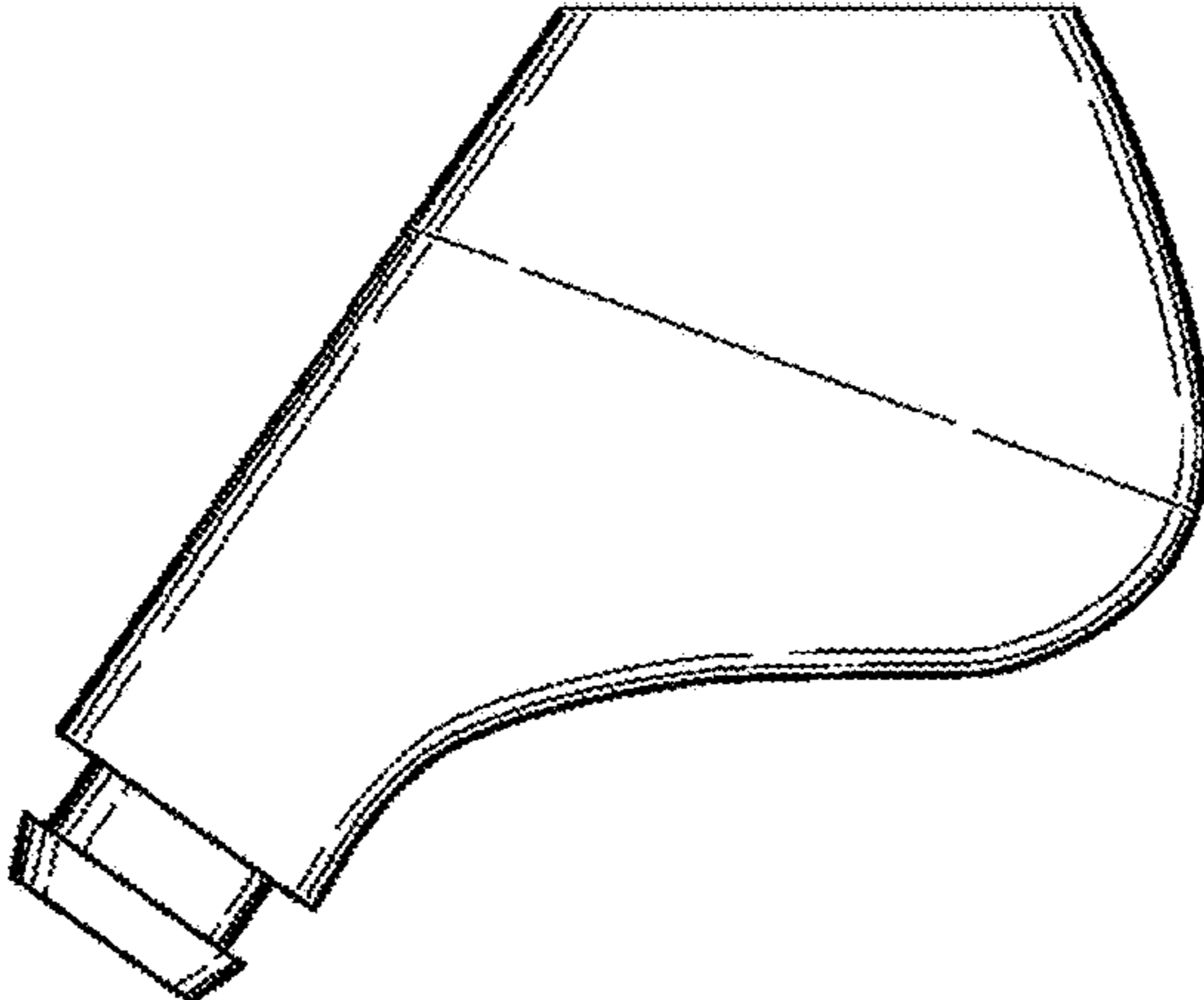

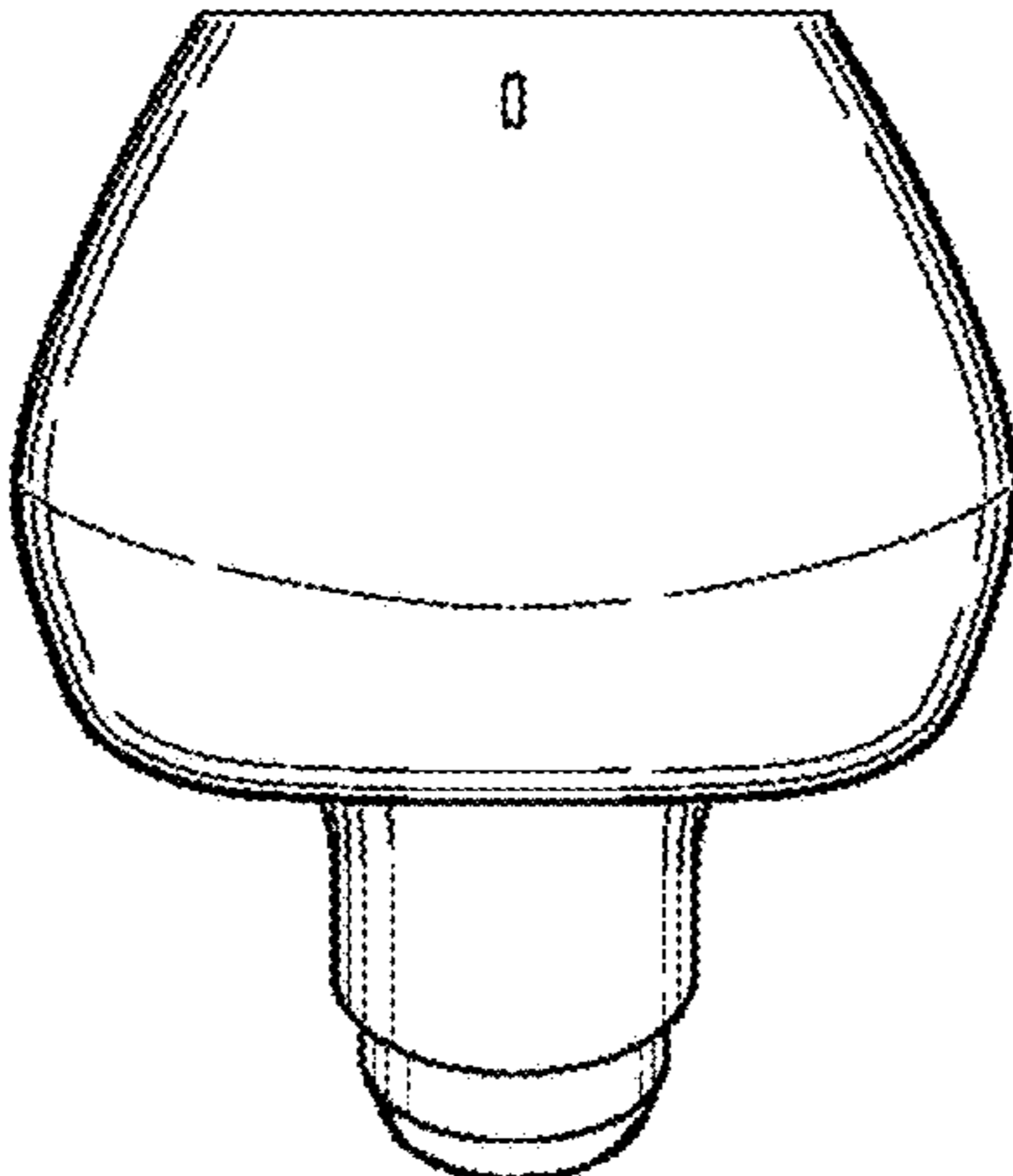
