FIG. 3 is a front view of a third embodiment of a display screen with graphical user interface for an account identifier showing our new design;

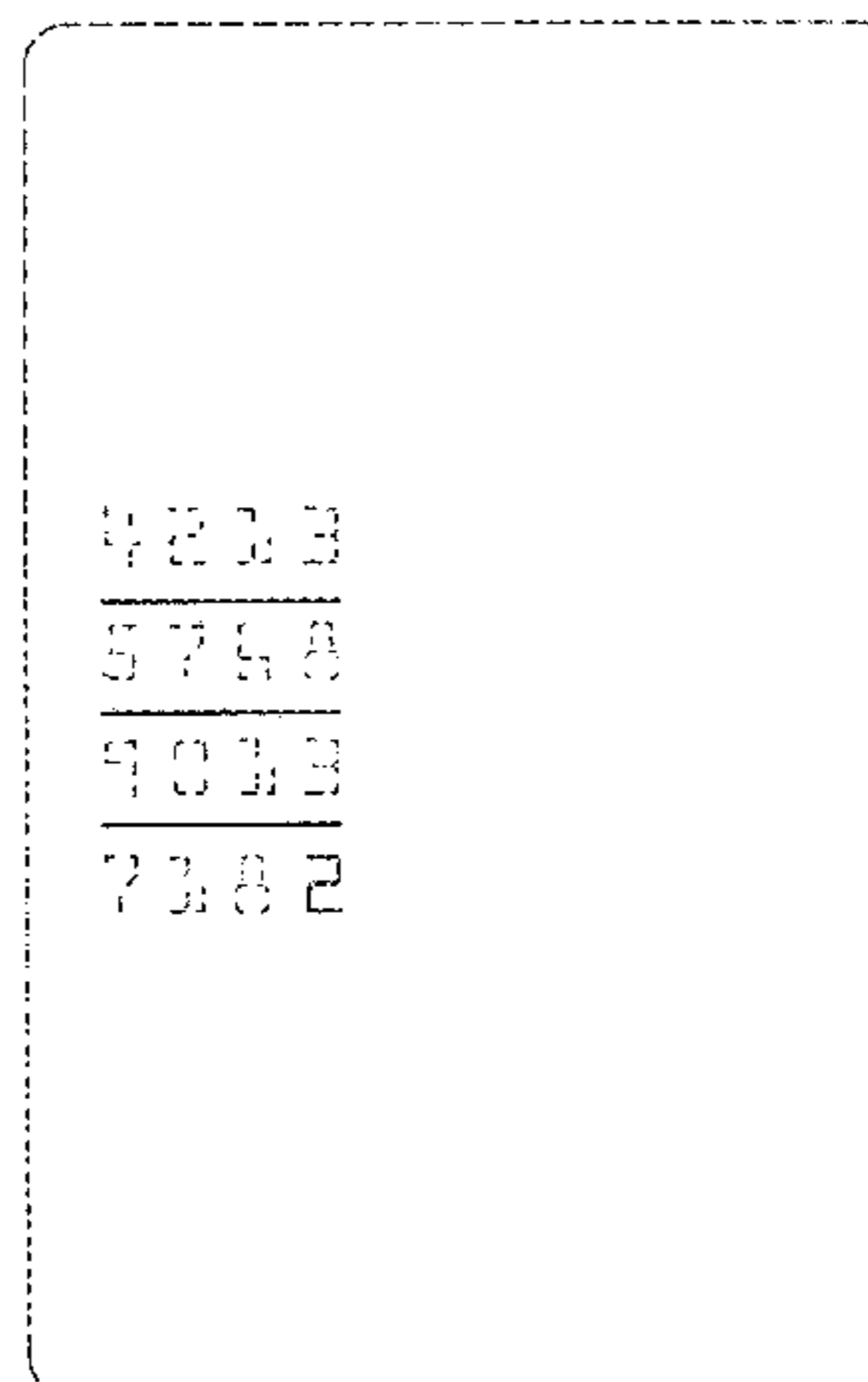
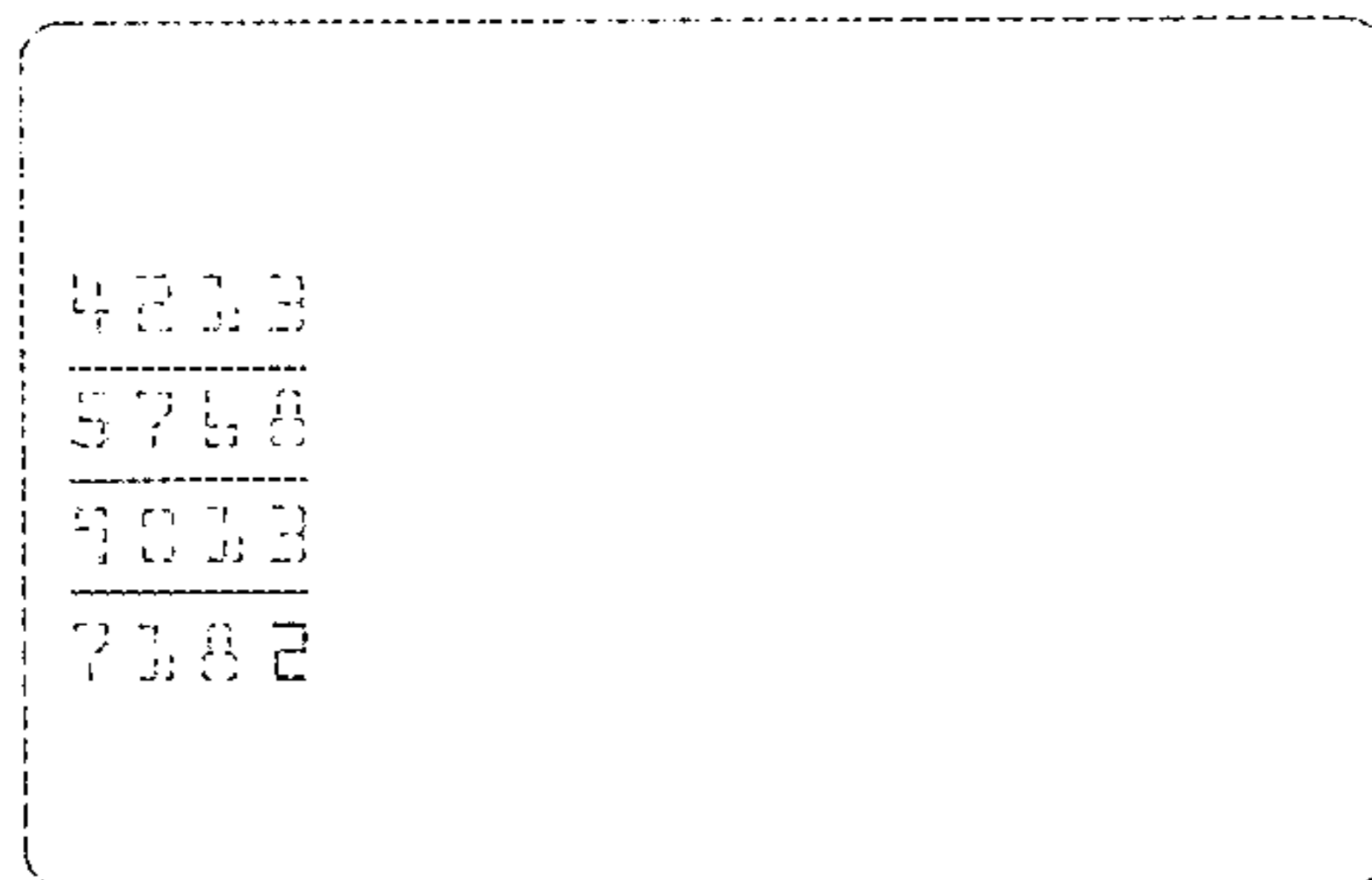
FIG. 4 is a front view of a fourth embodiment of a display screen with graphical user interface for an account identifier showing our new design;

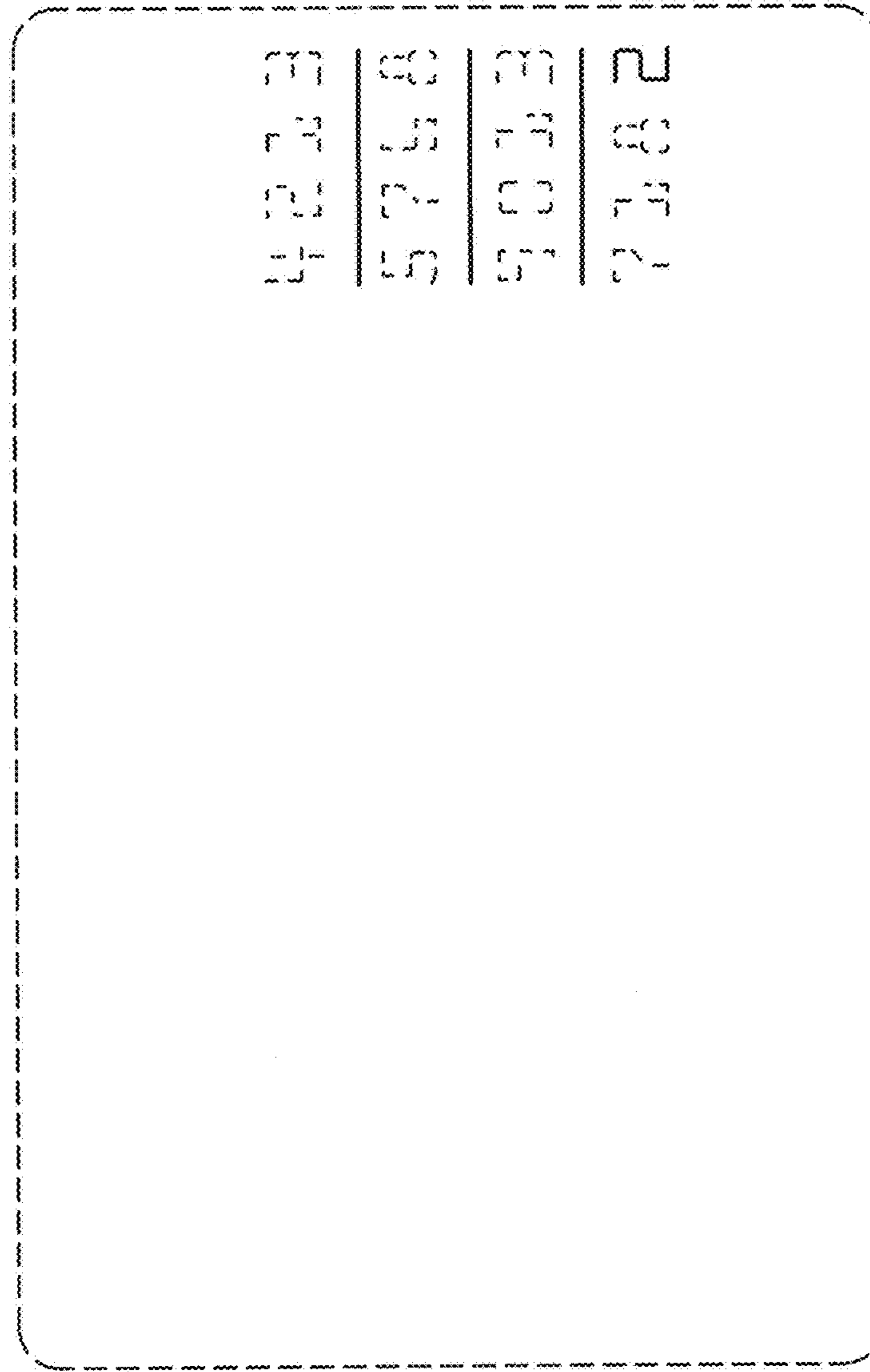

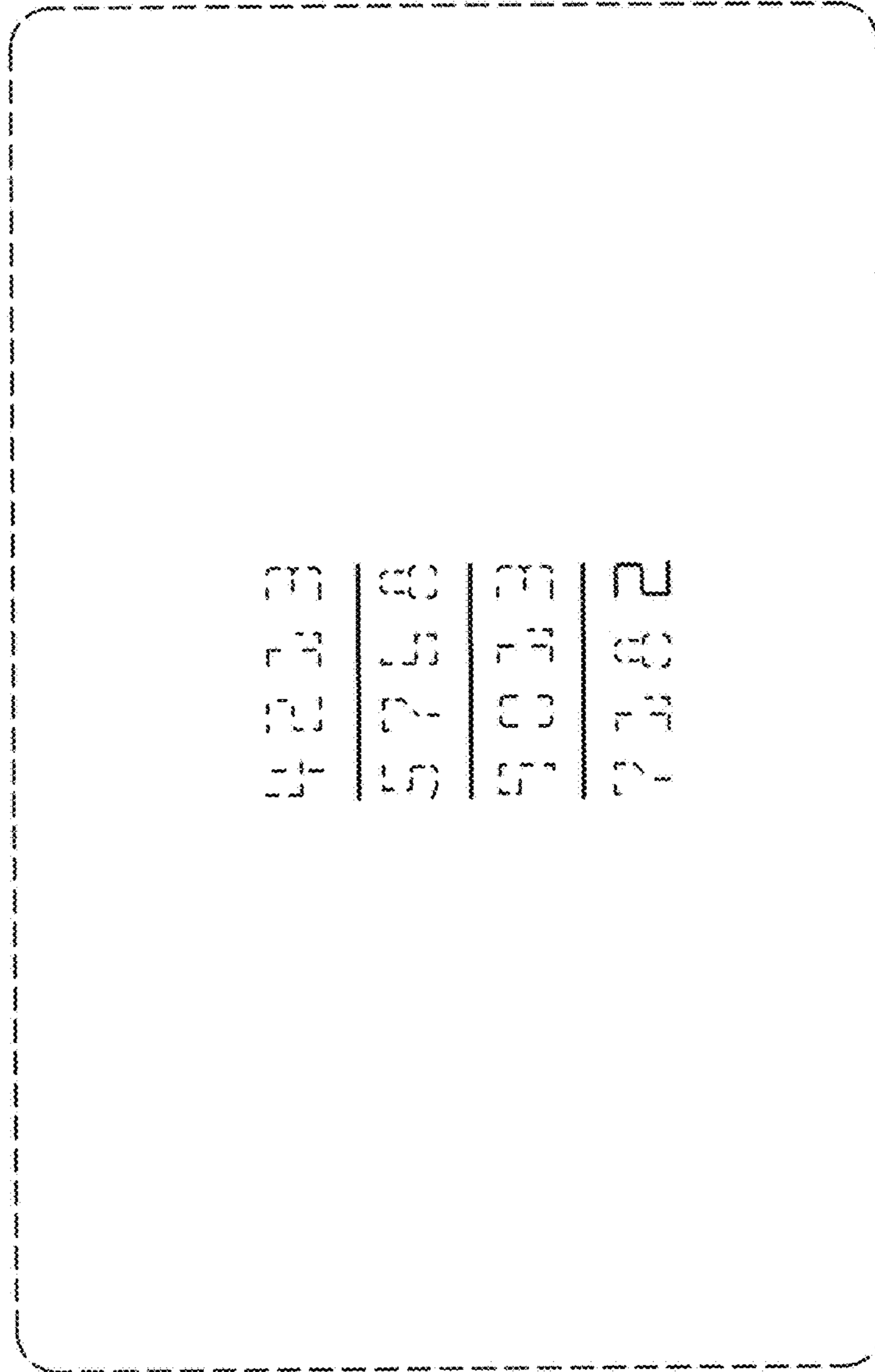

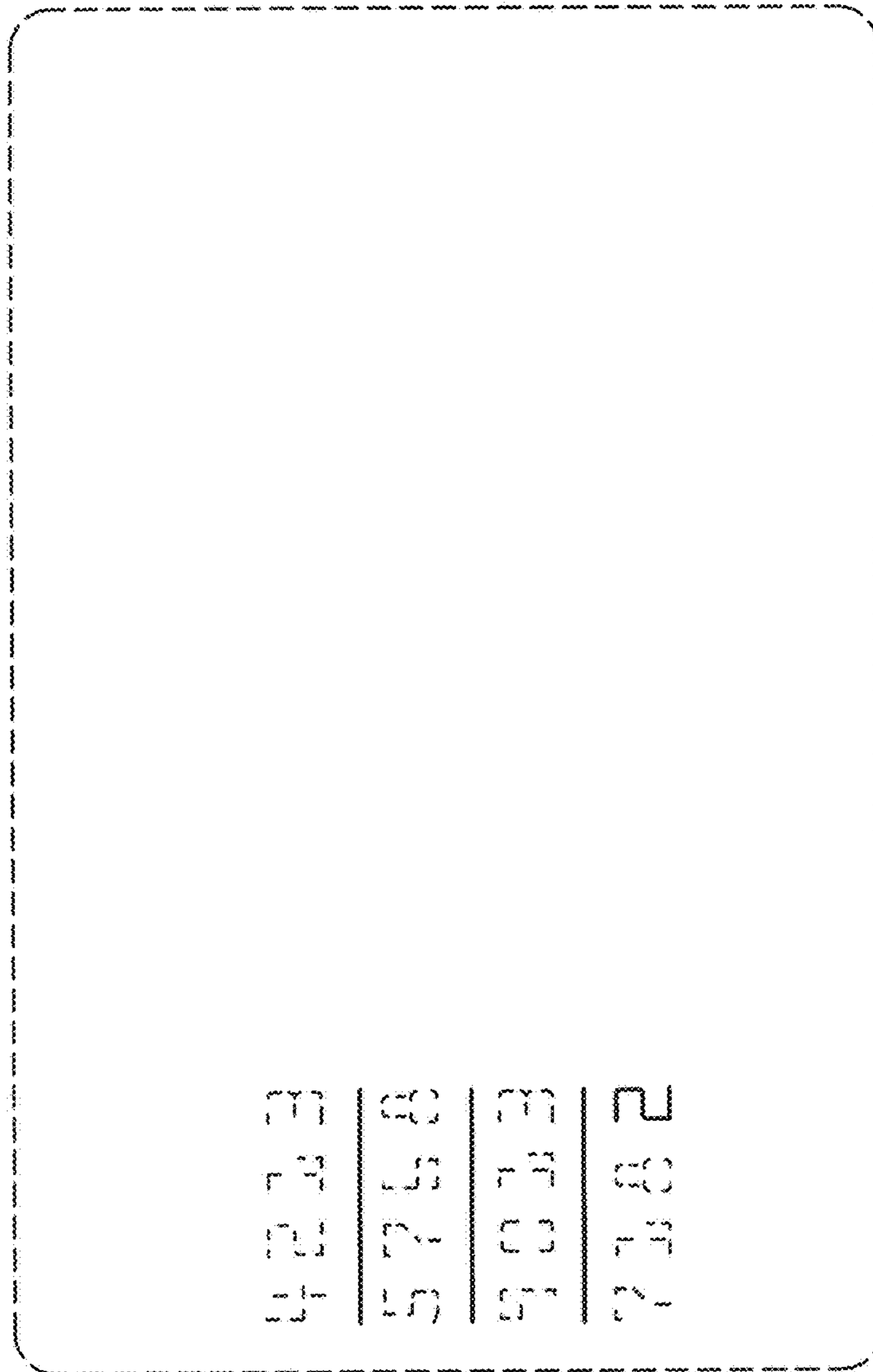

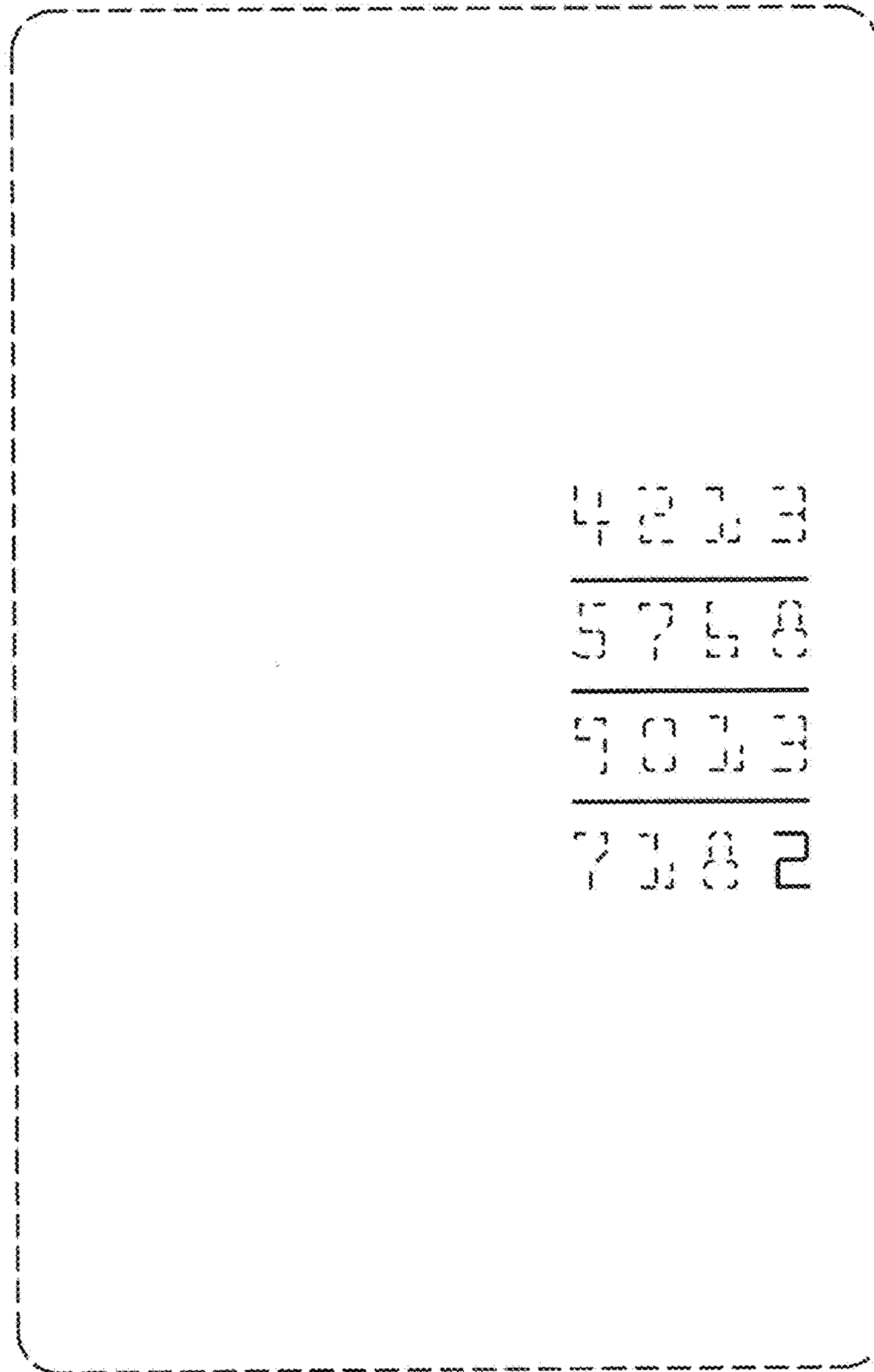

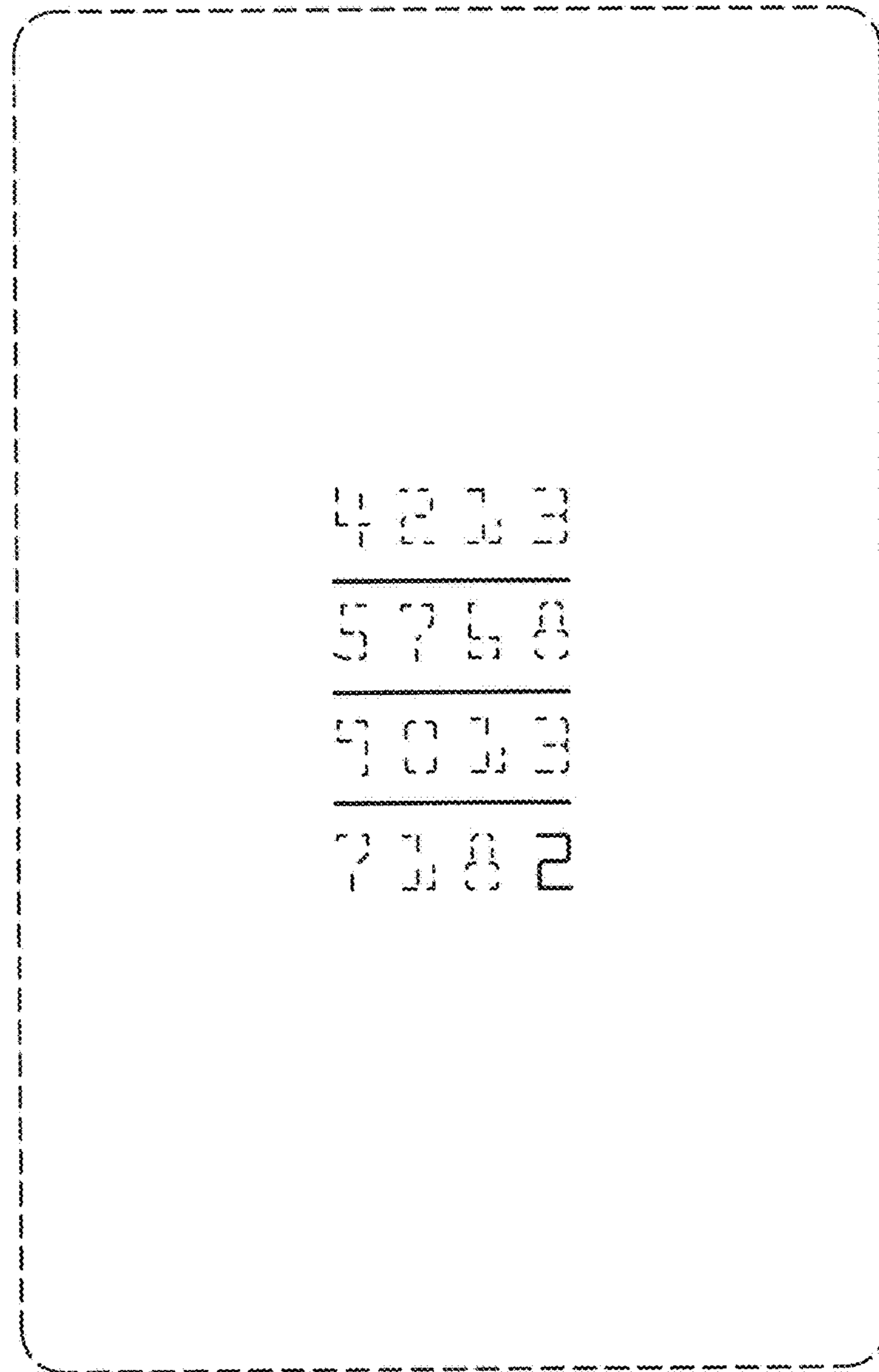

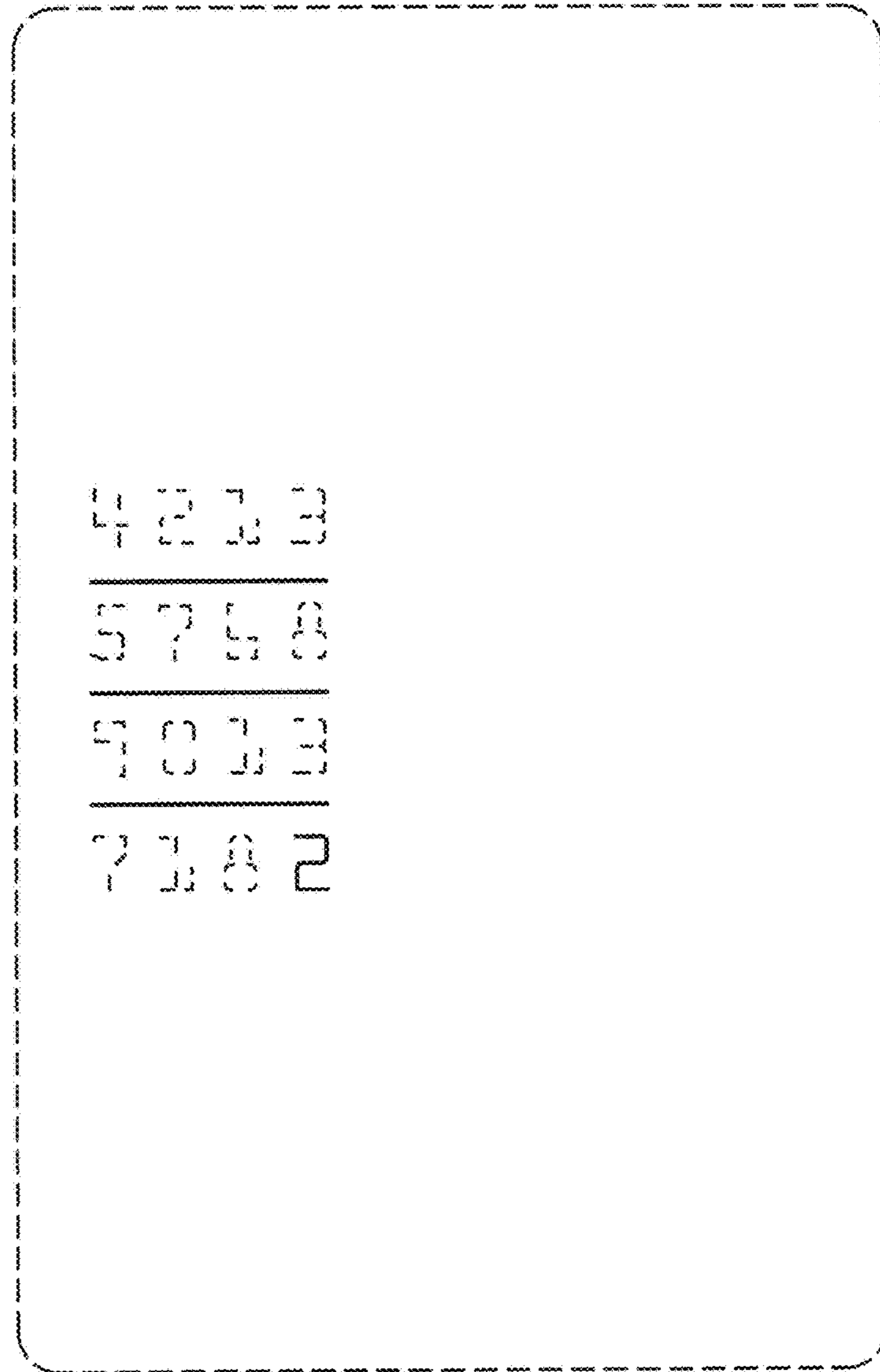
