The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

FIG. 4 is a fourth image thereof.

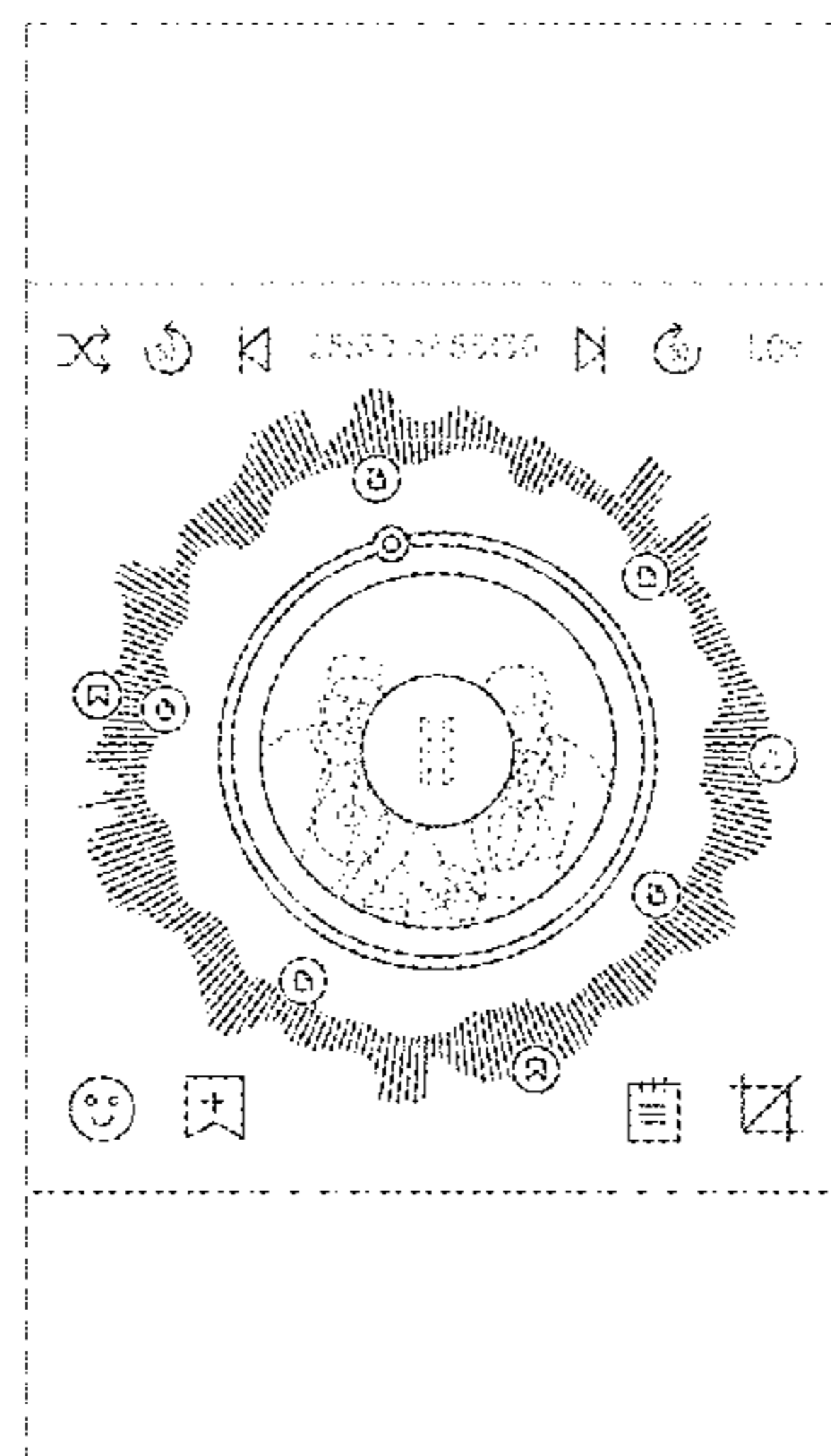
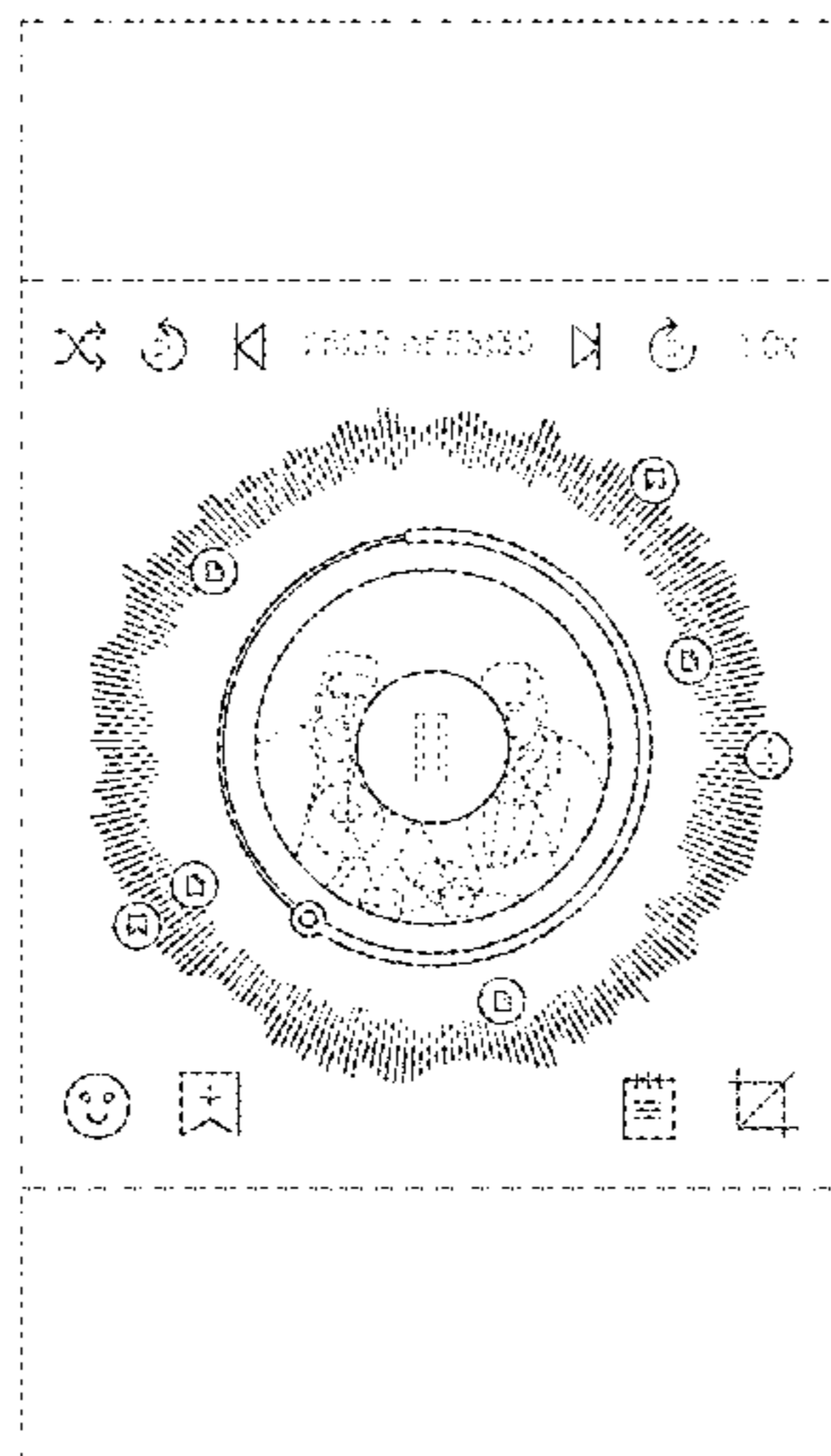

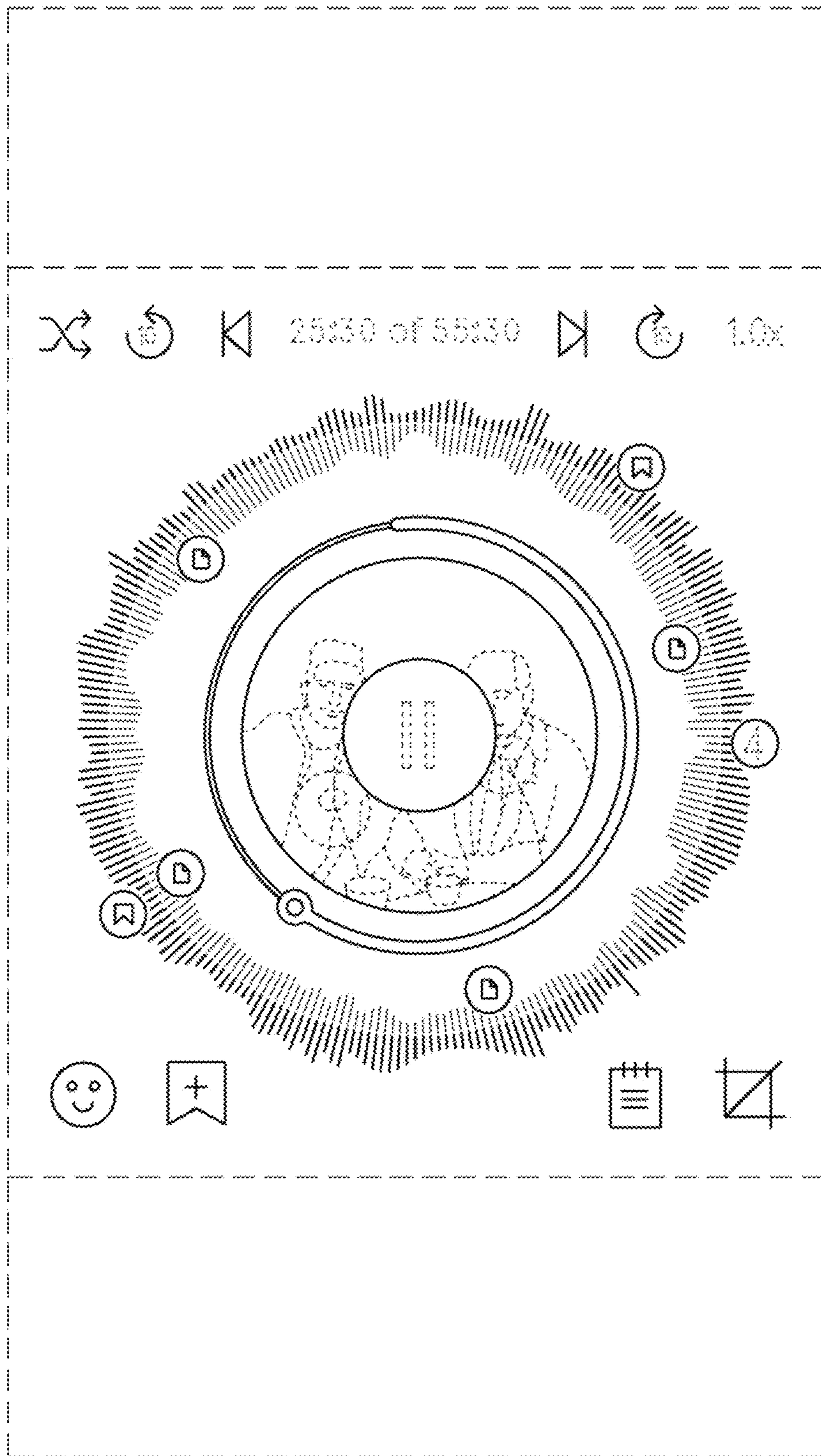

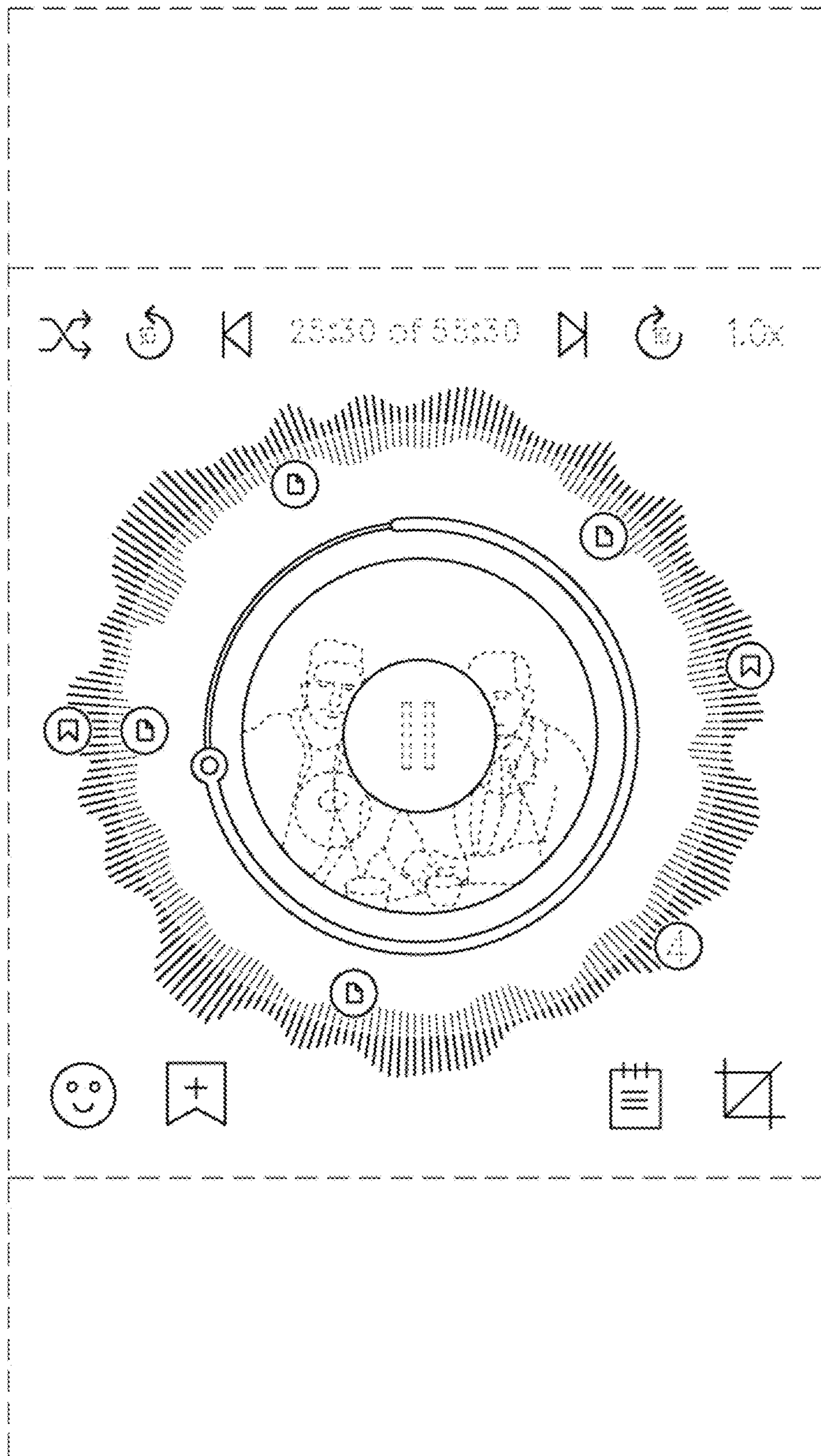

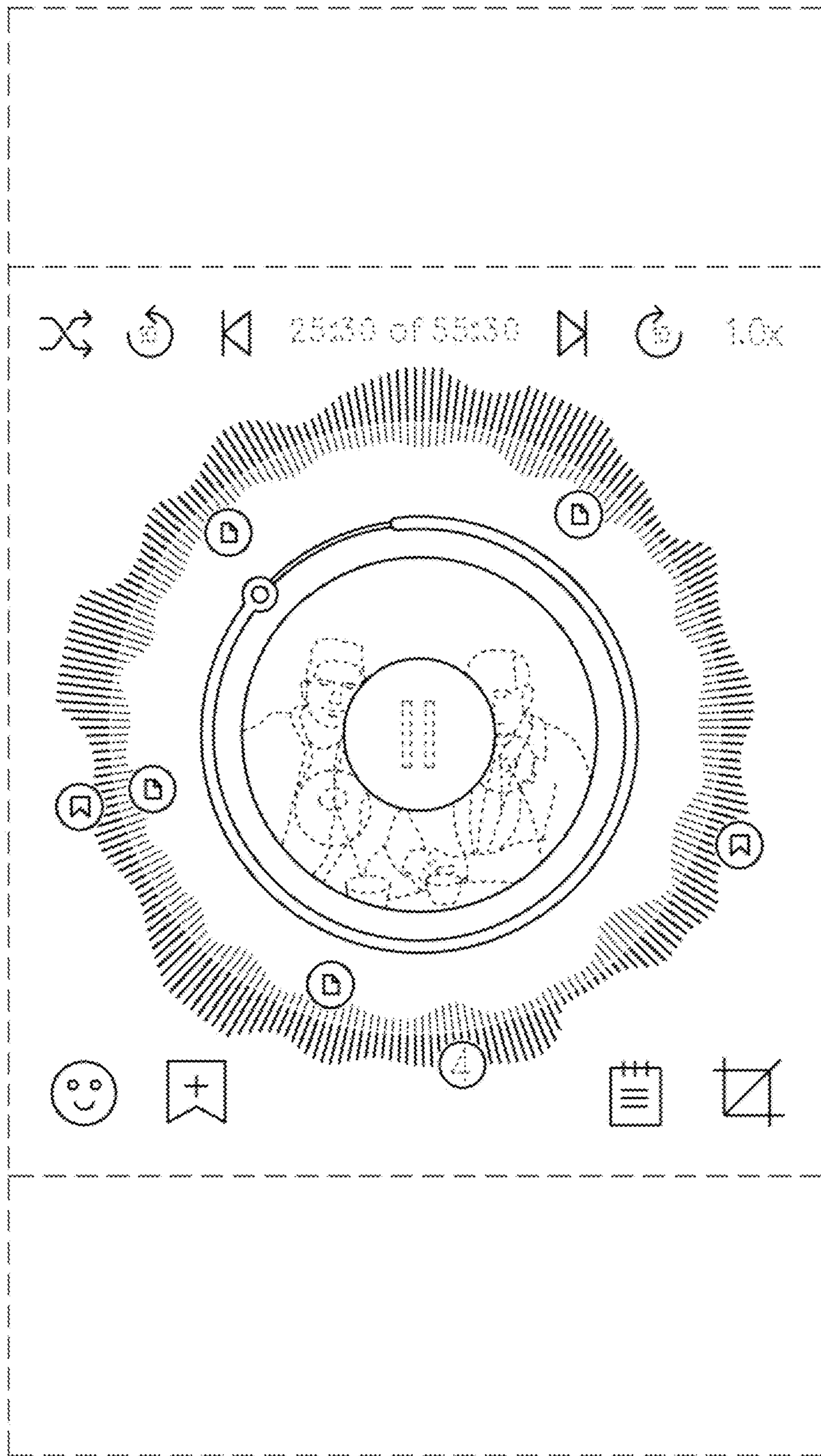

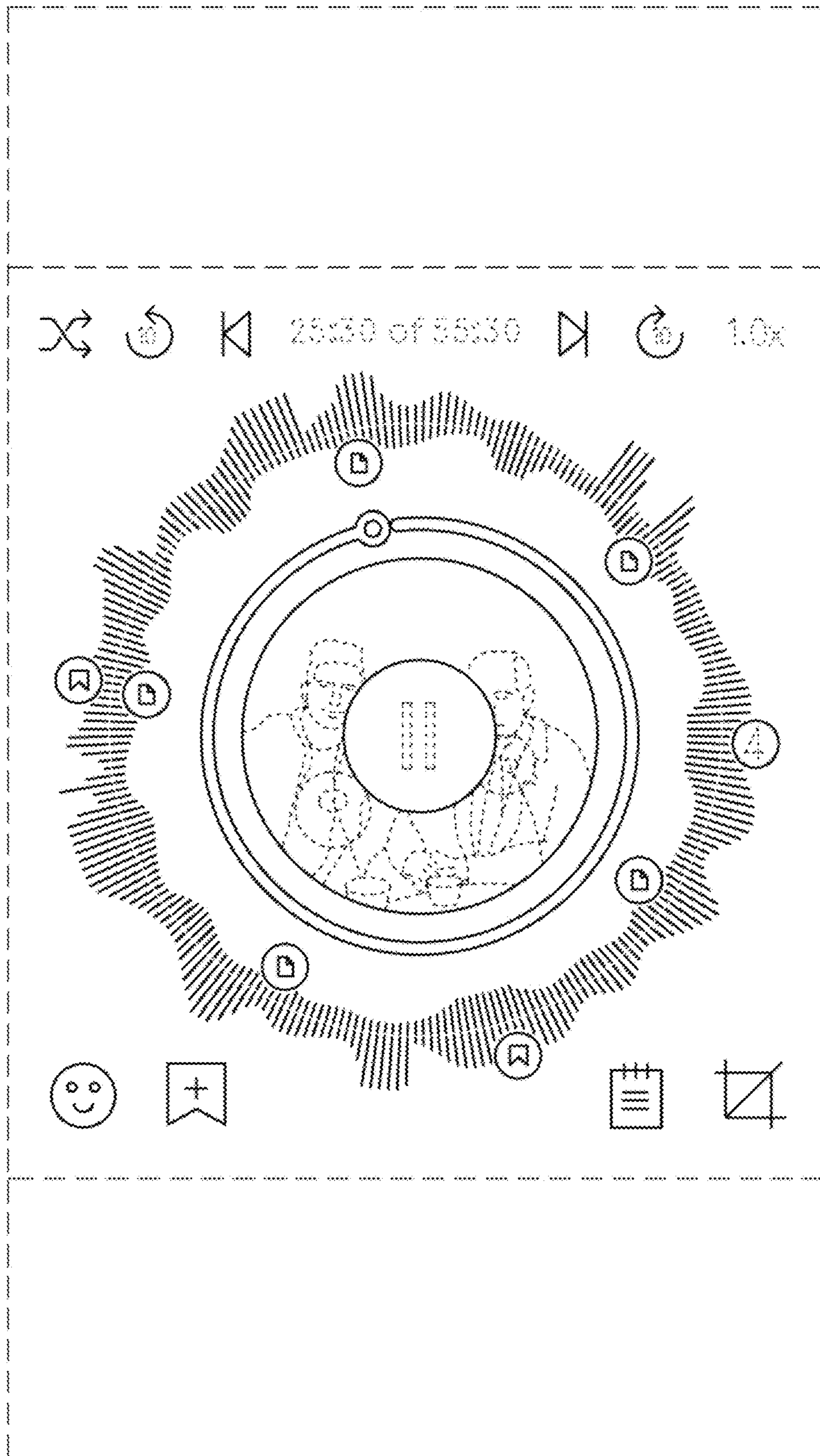
