DESCRIPTION

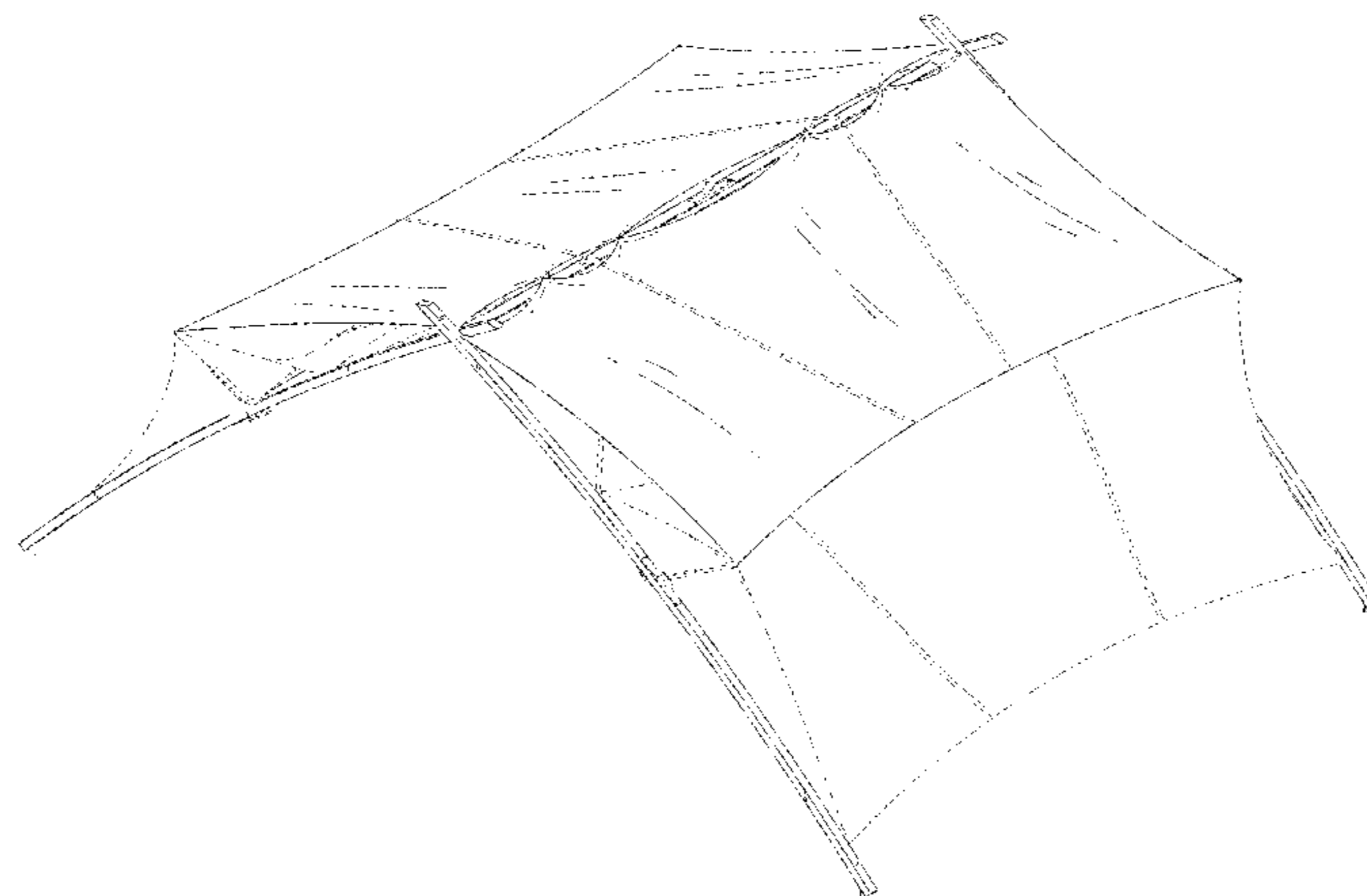

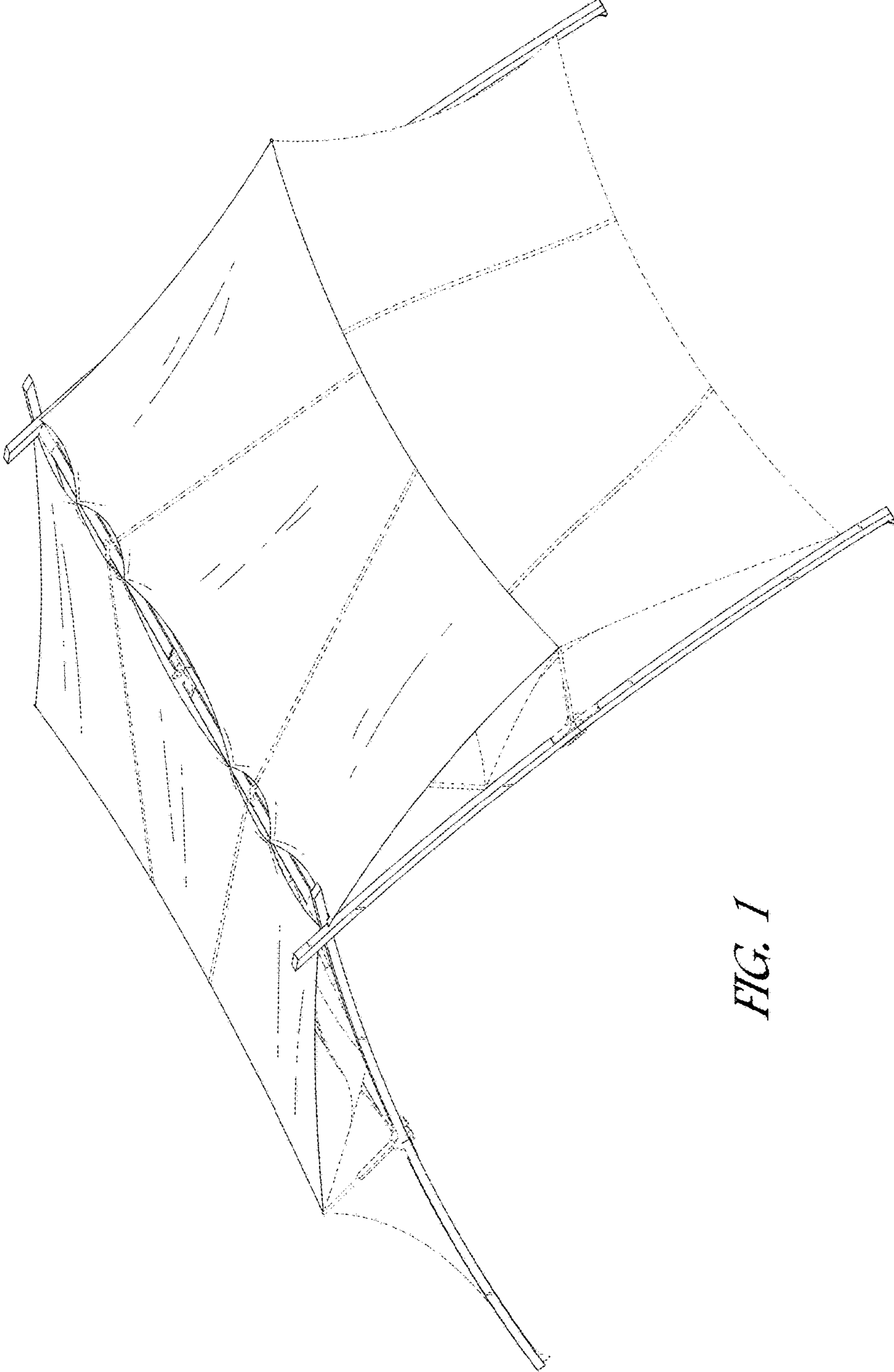

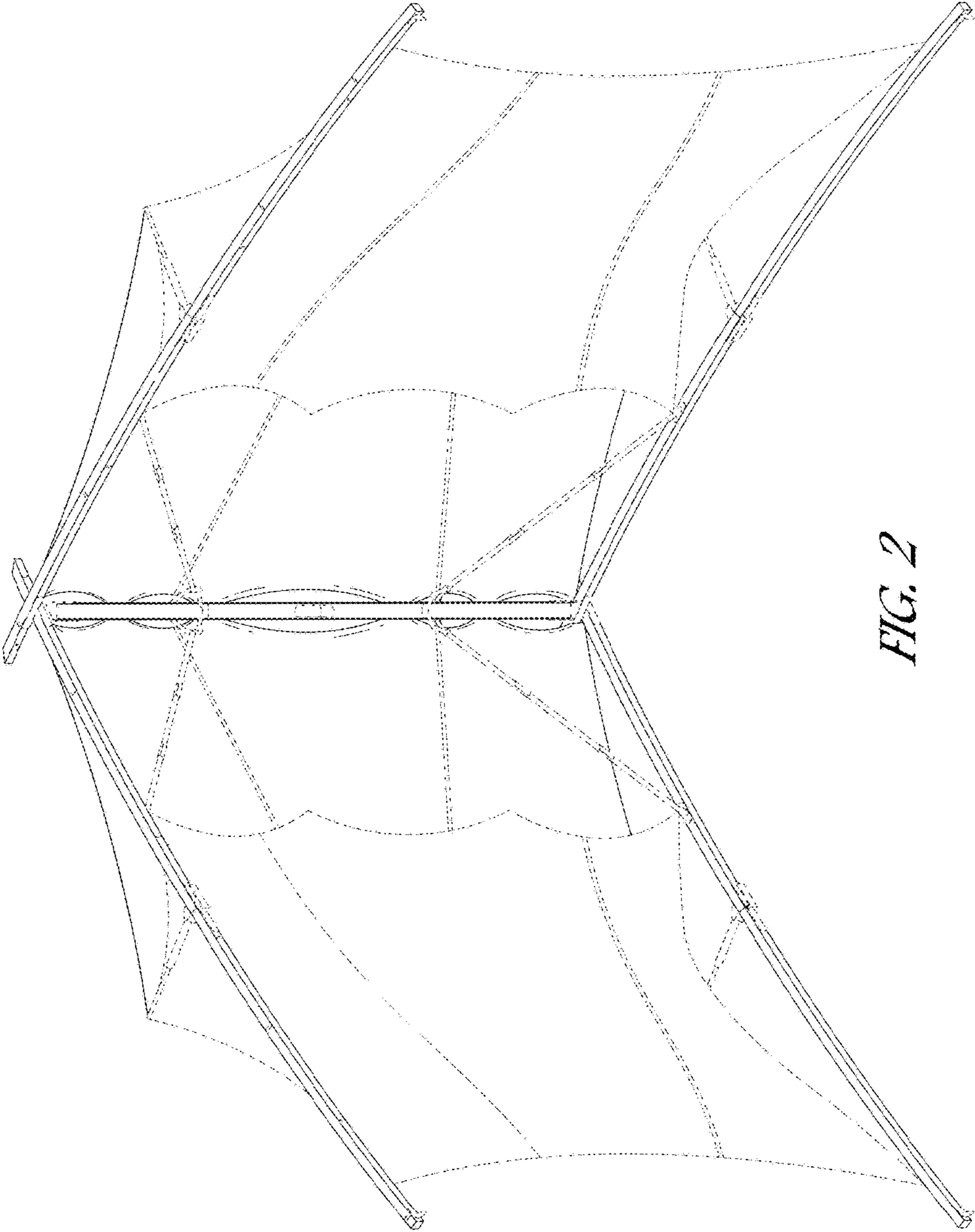

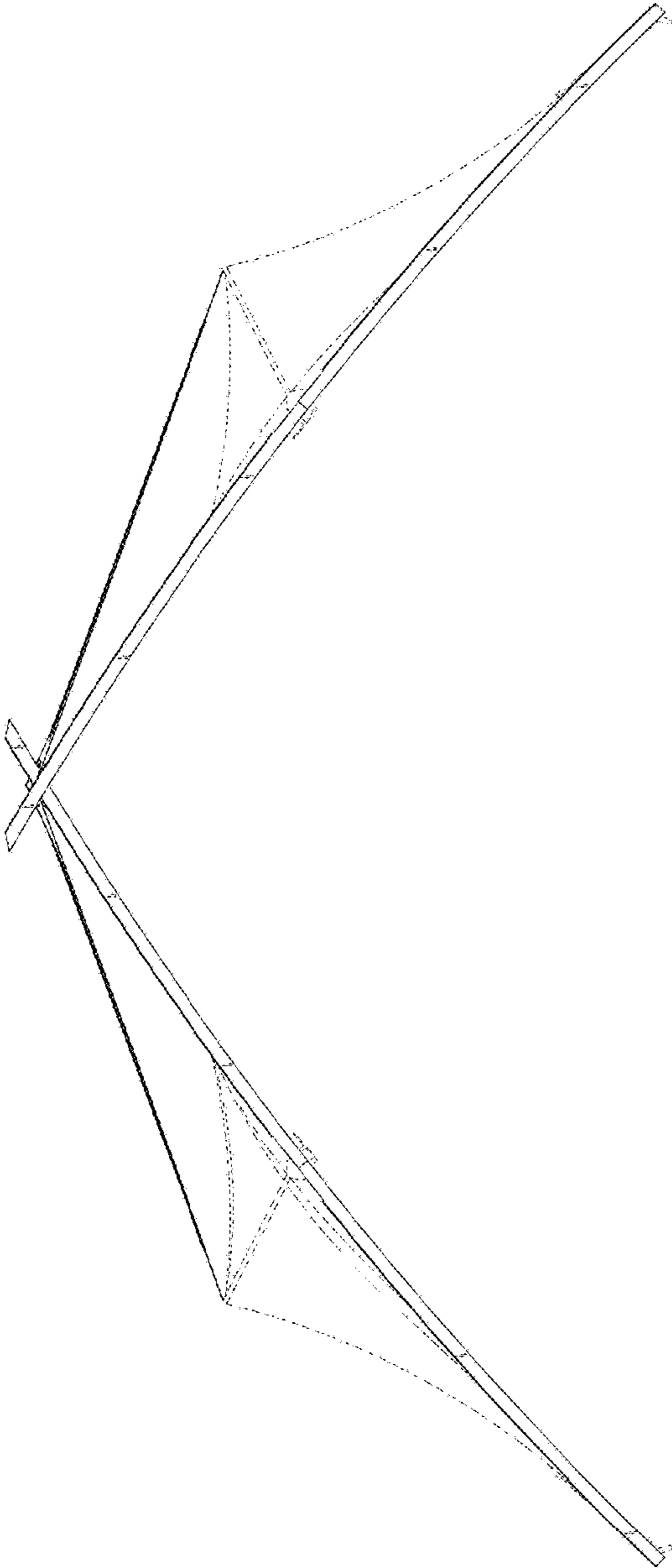

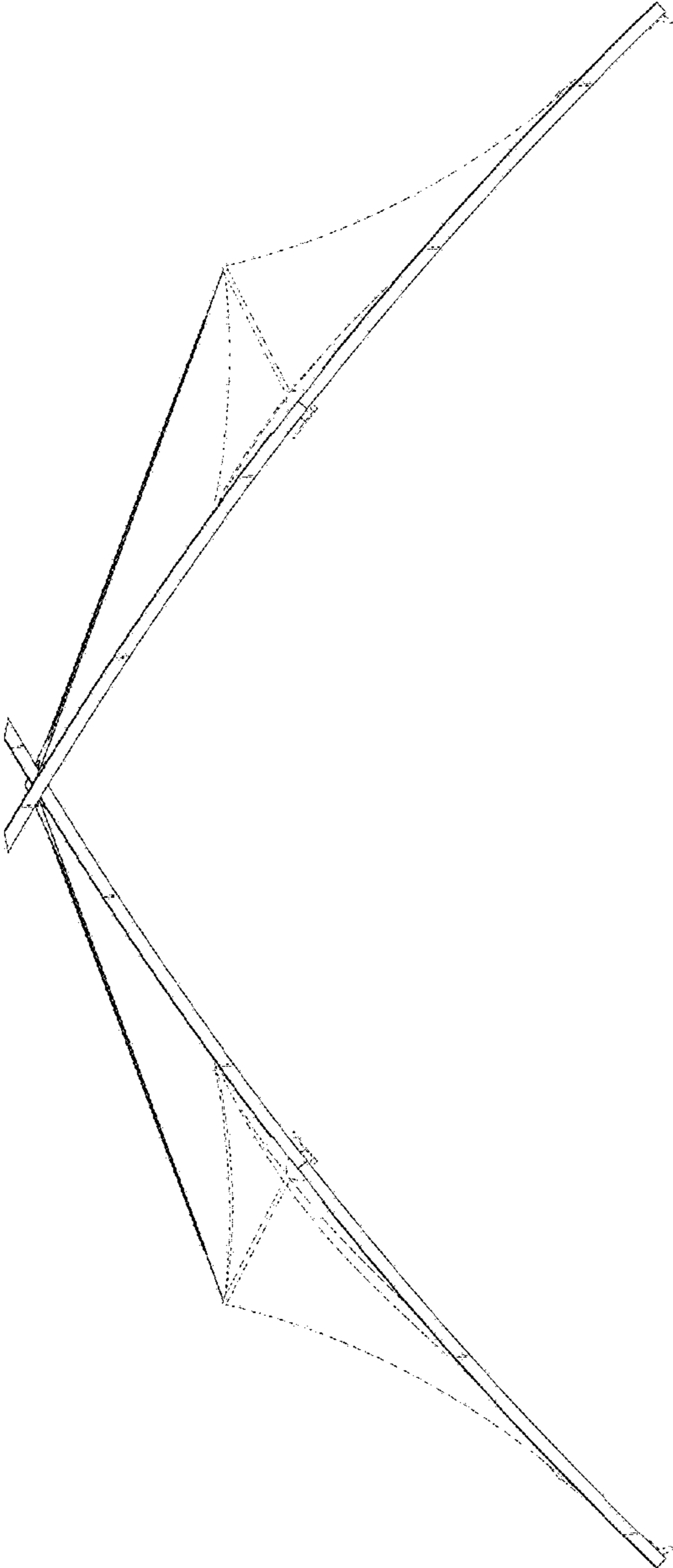

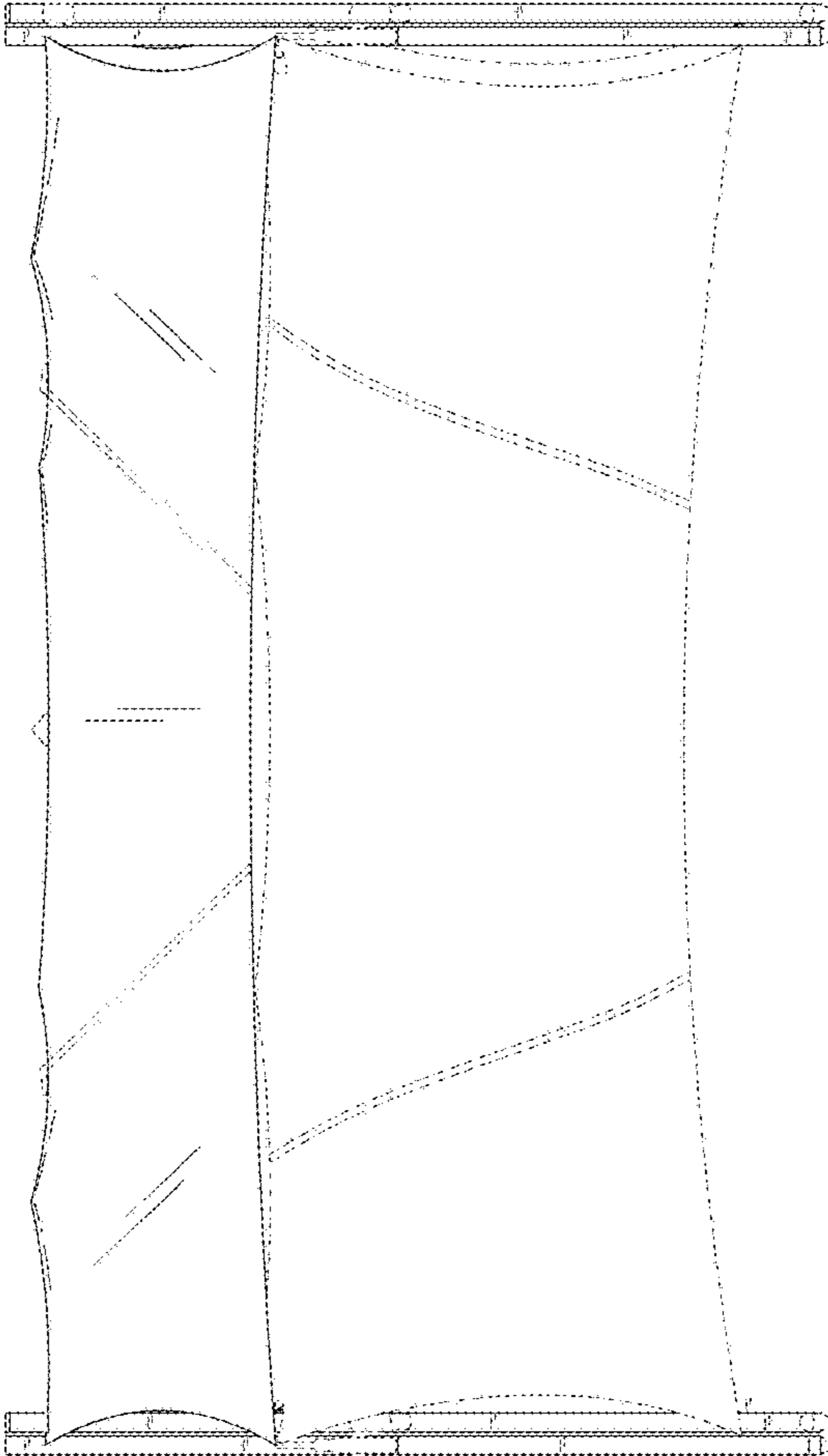

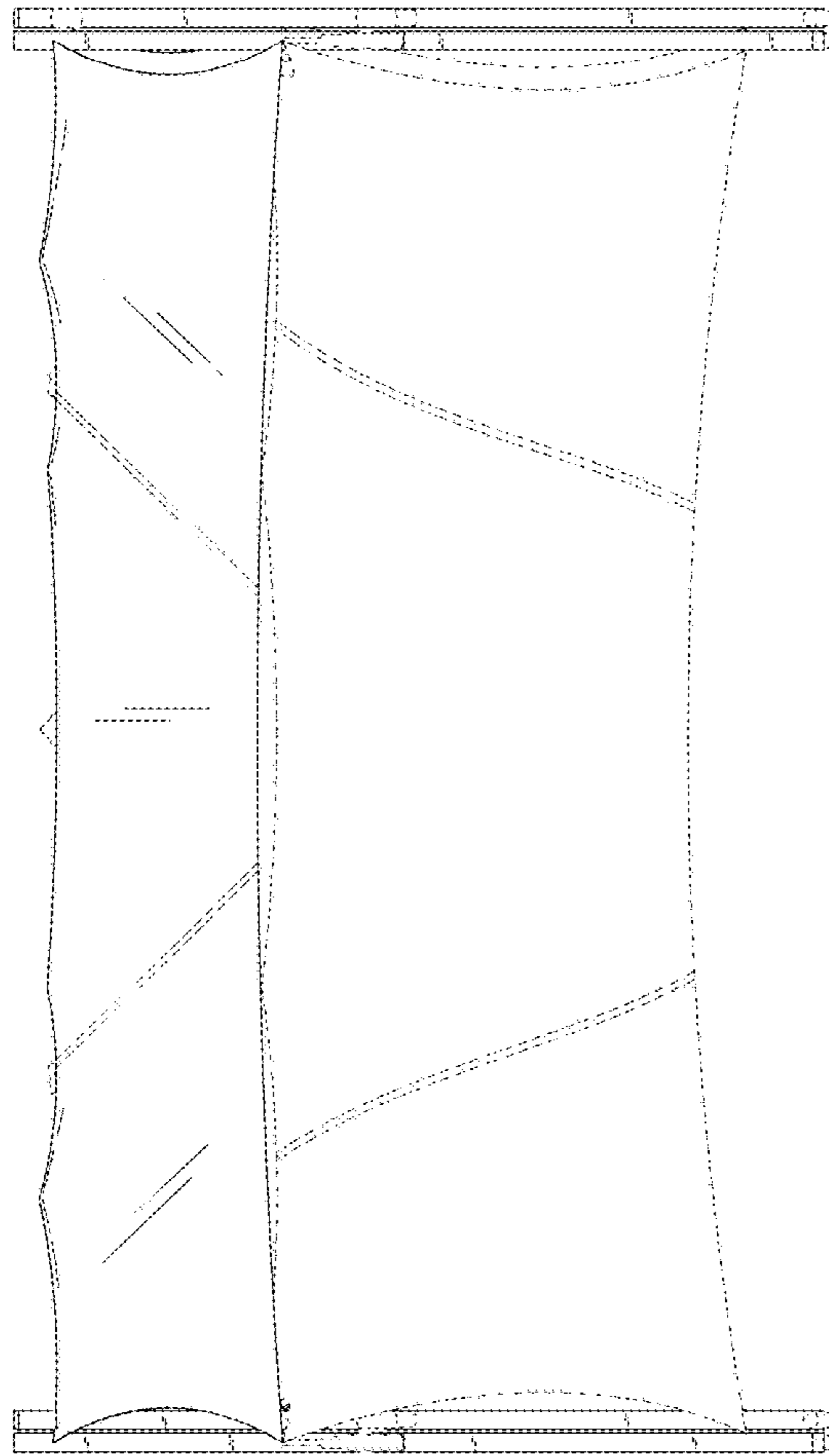

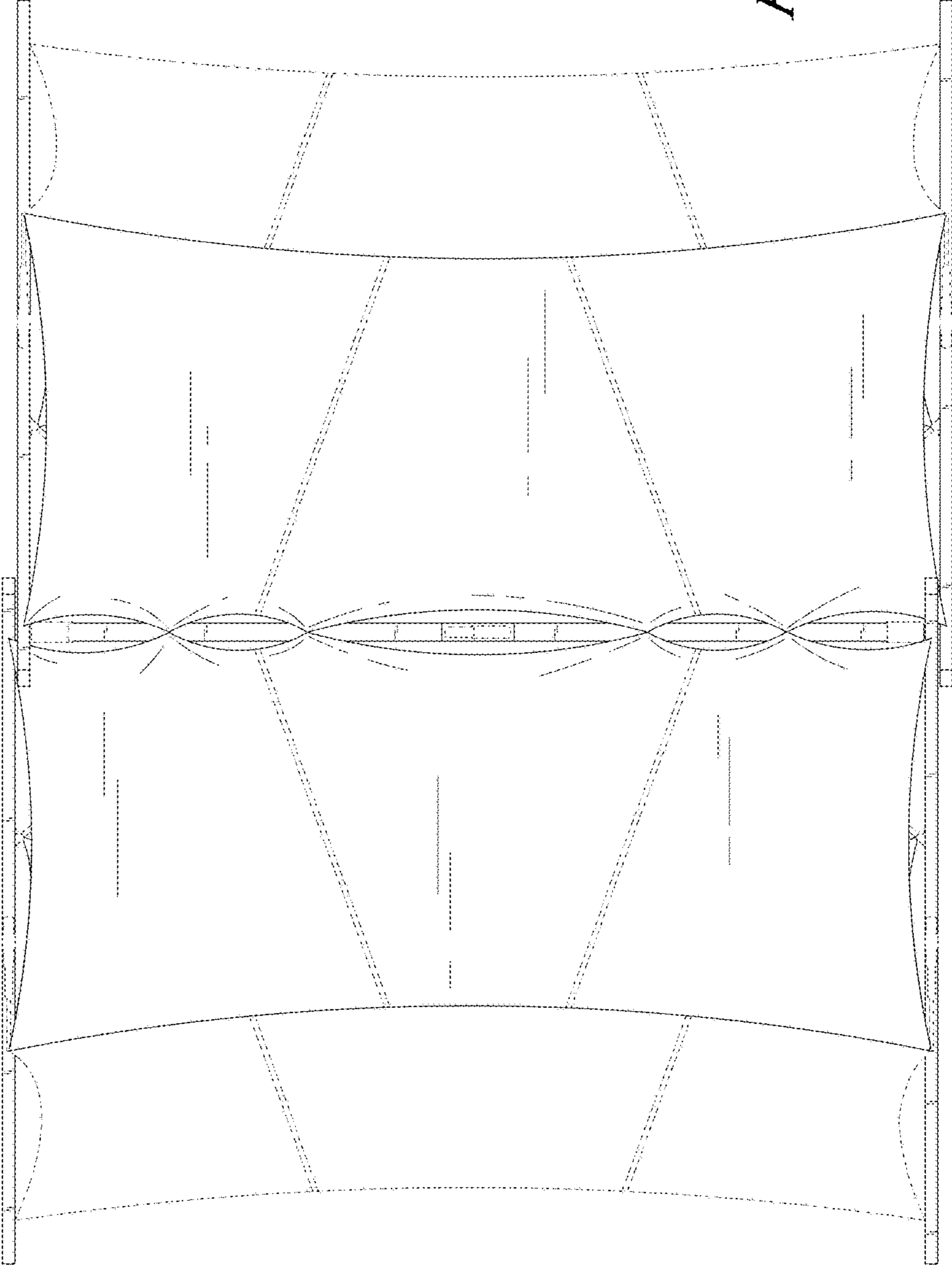
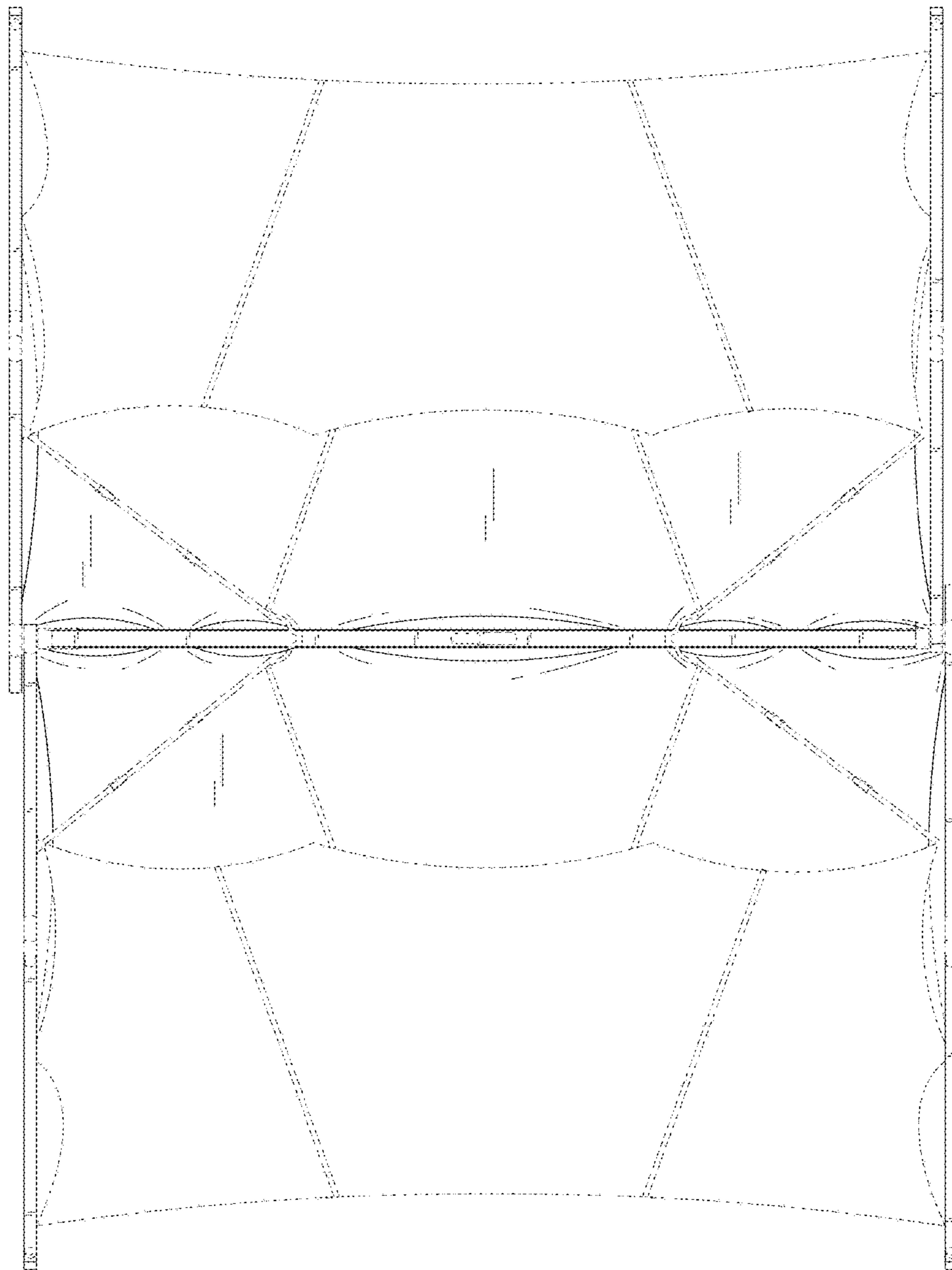
