**DESCRIPTION**

FIG. 17 is rear view of the collapsible target of FIG. 15;

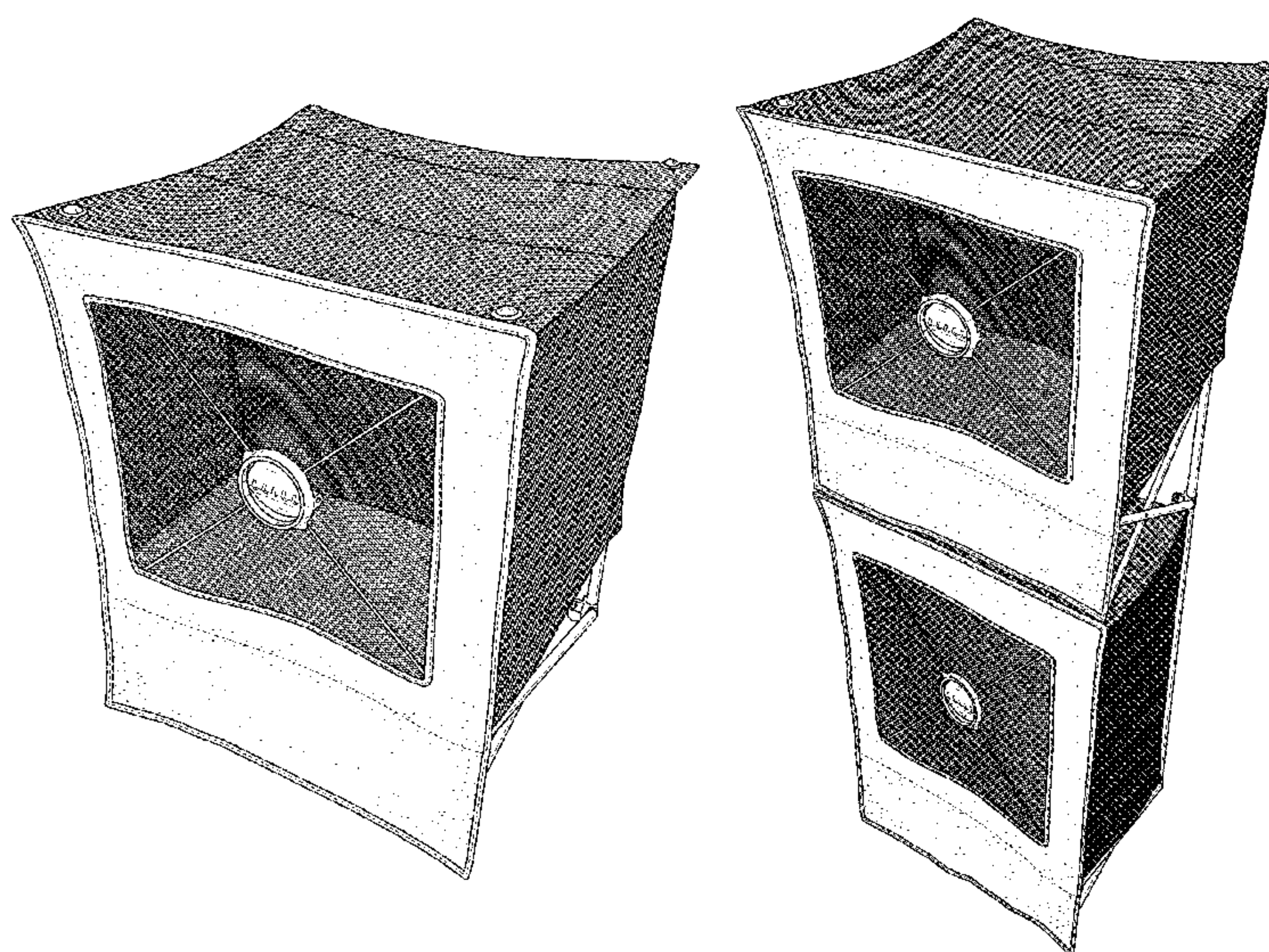
FIG. 18 is a left side view of the collapsible target of FIG. 15;

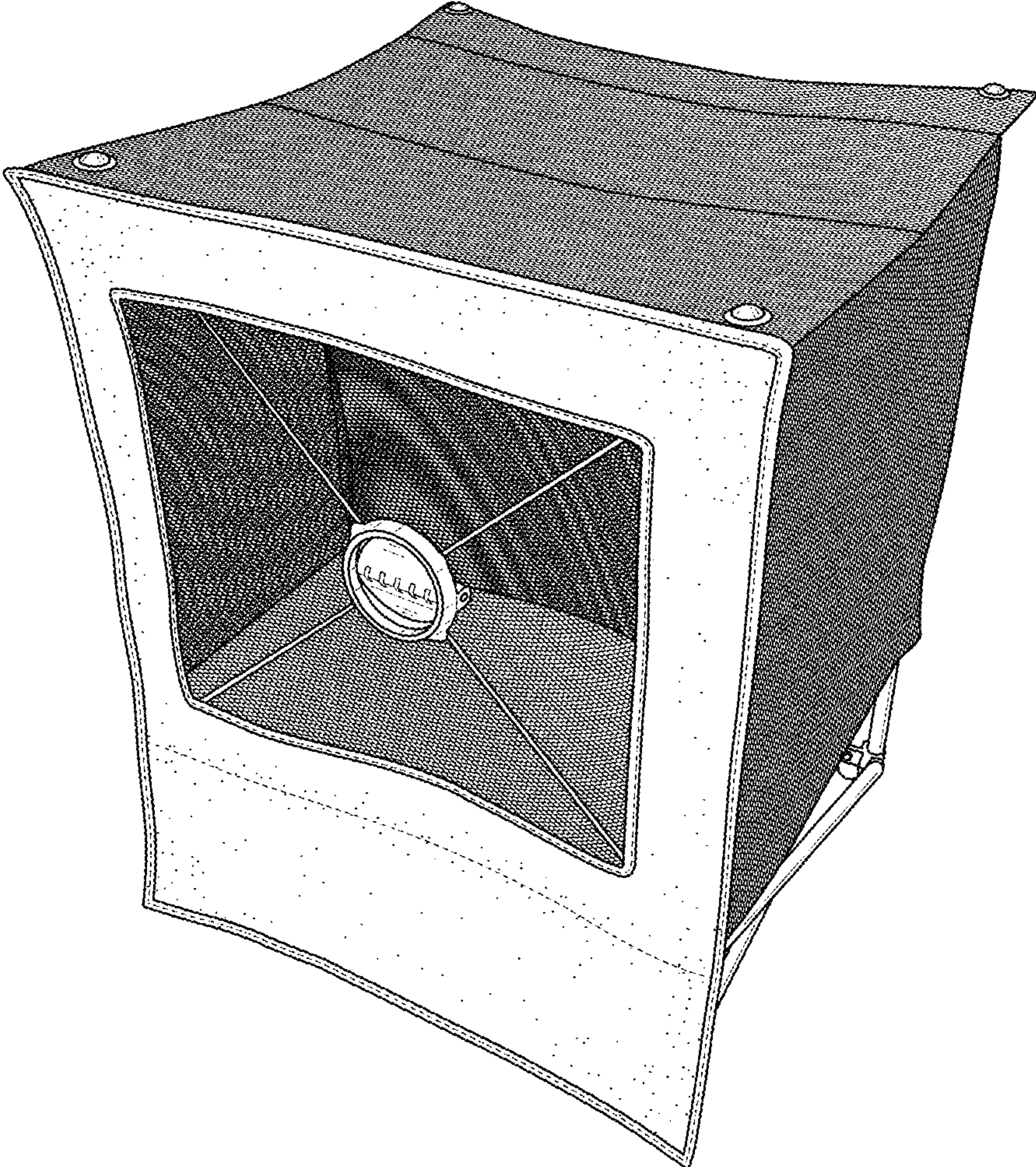

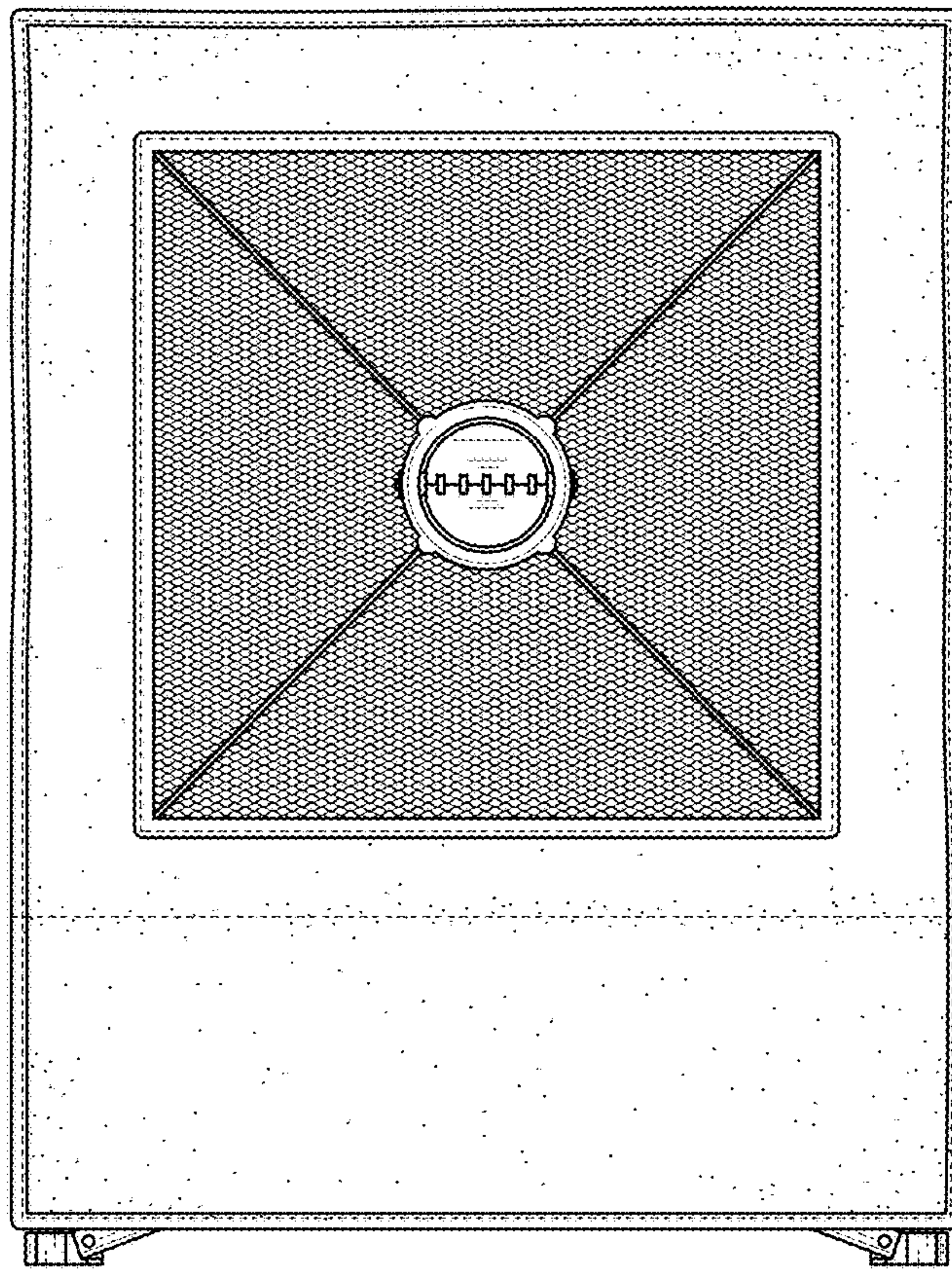

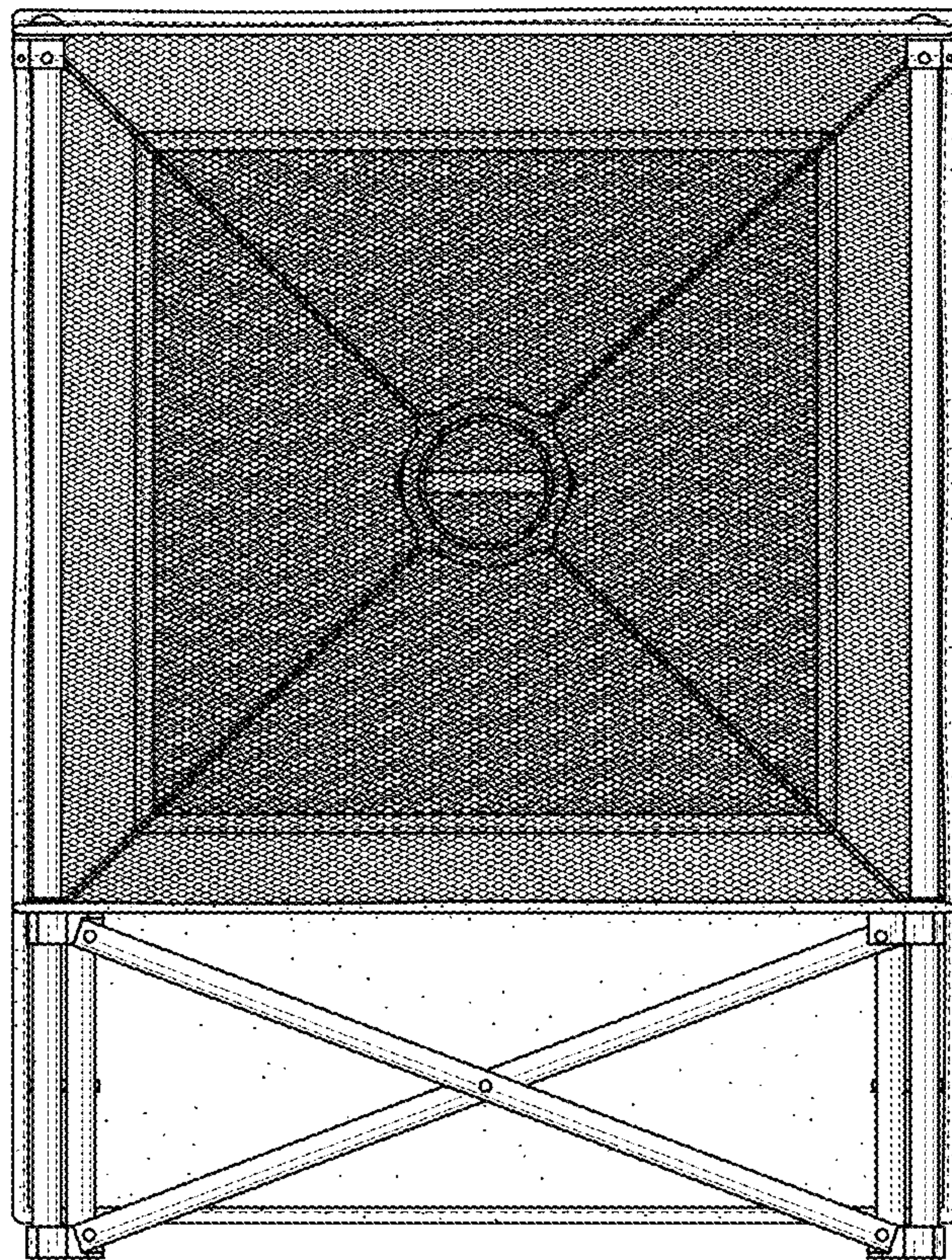

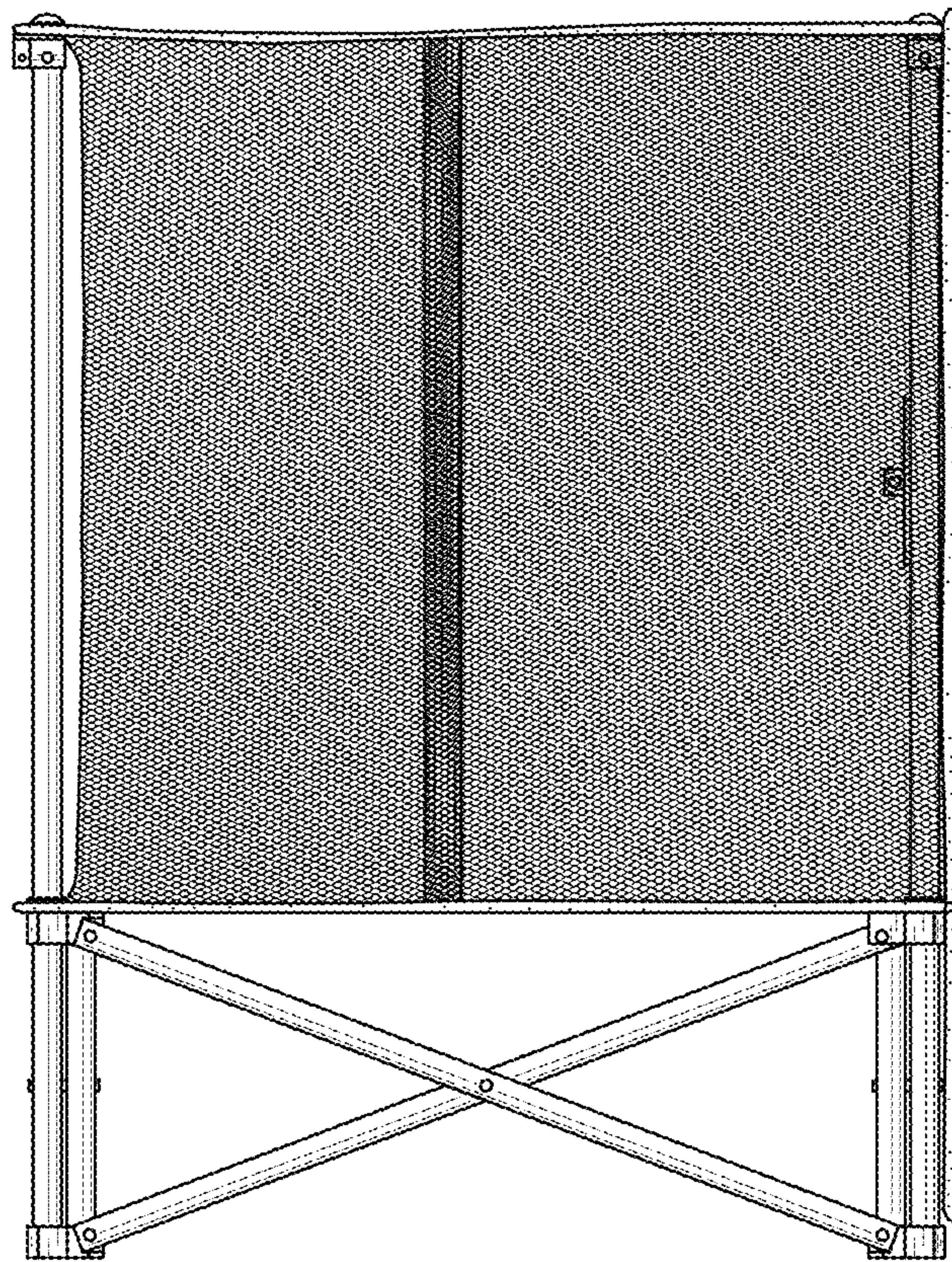

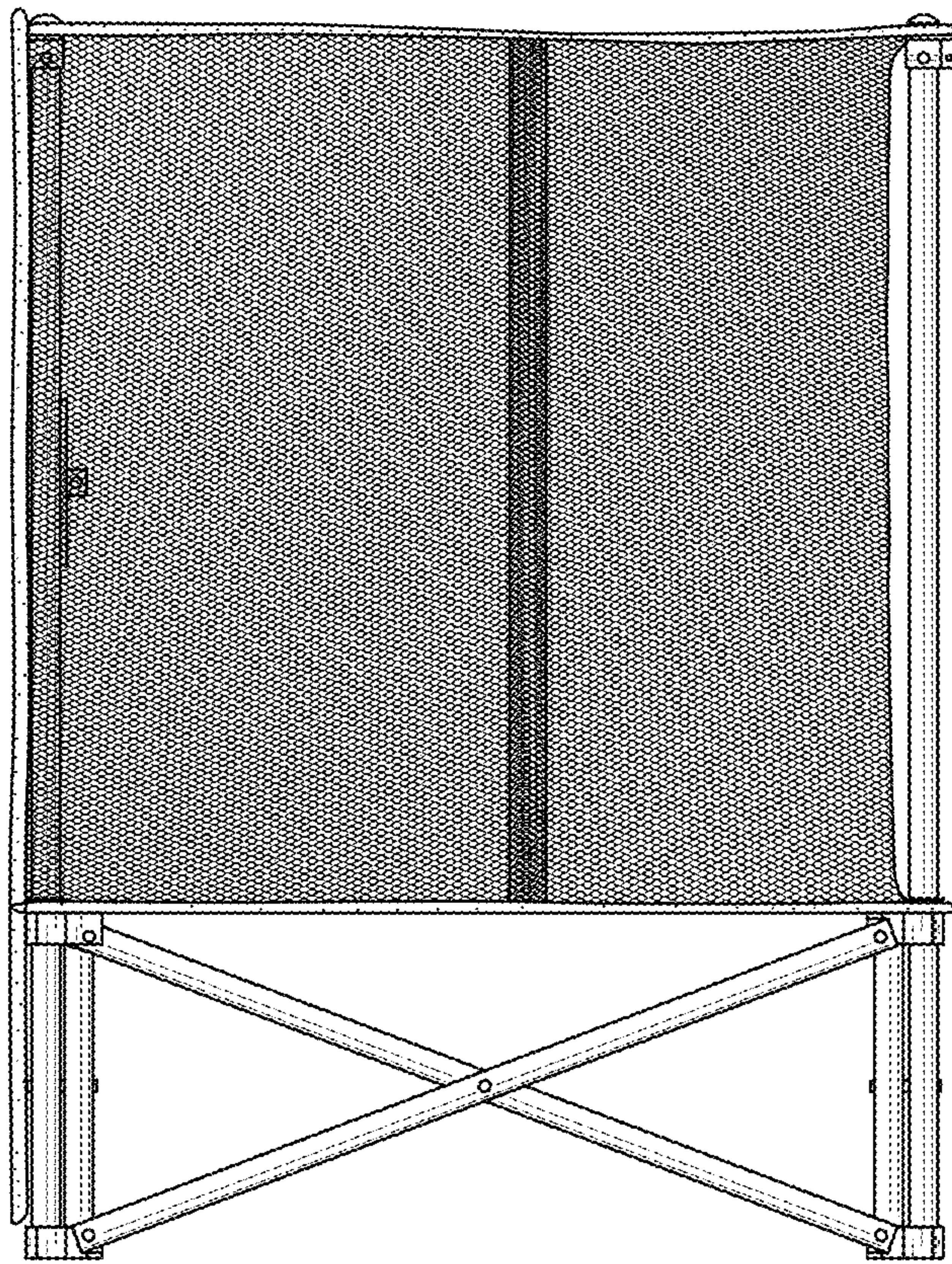

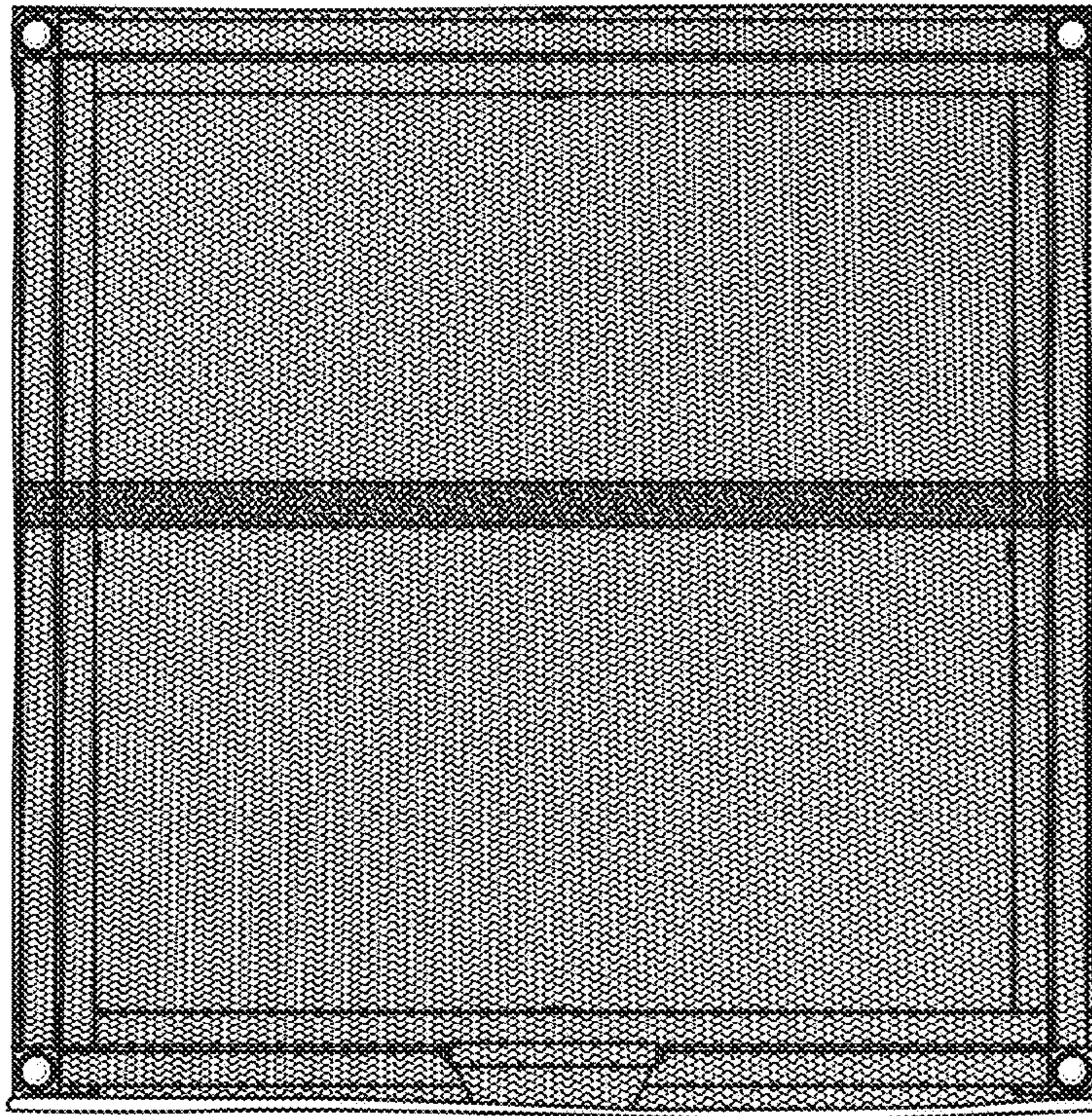

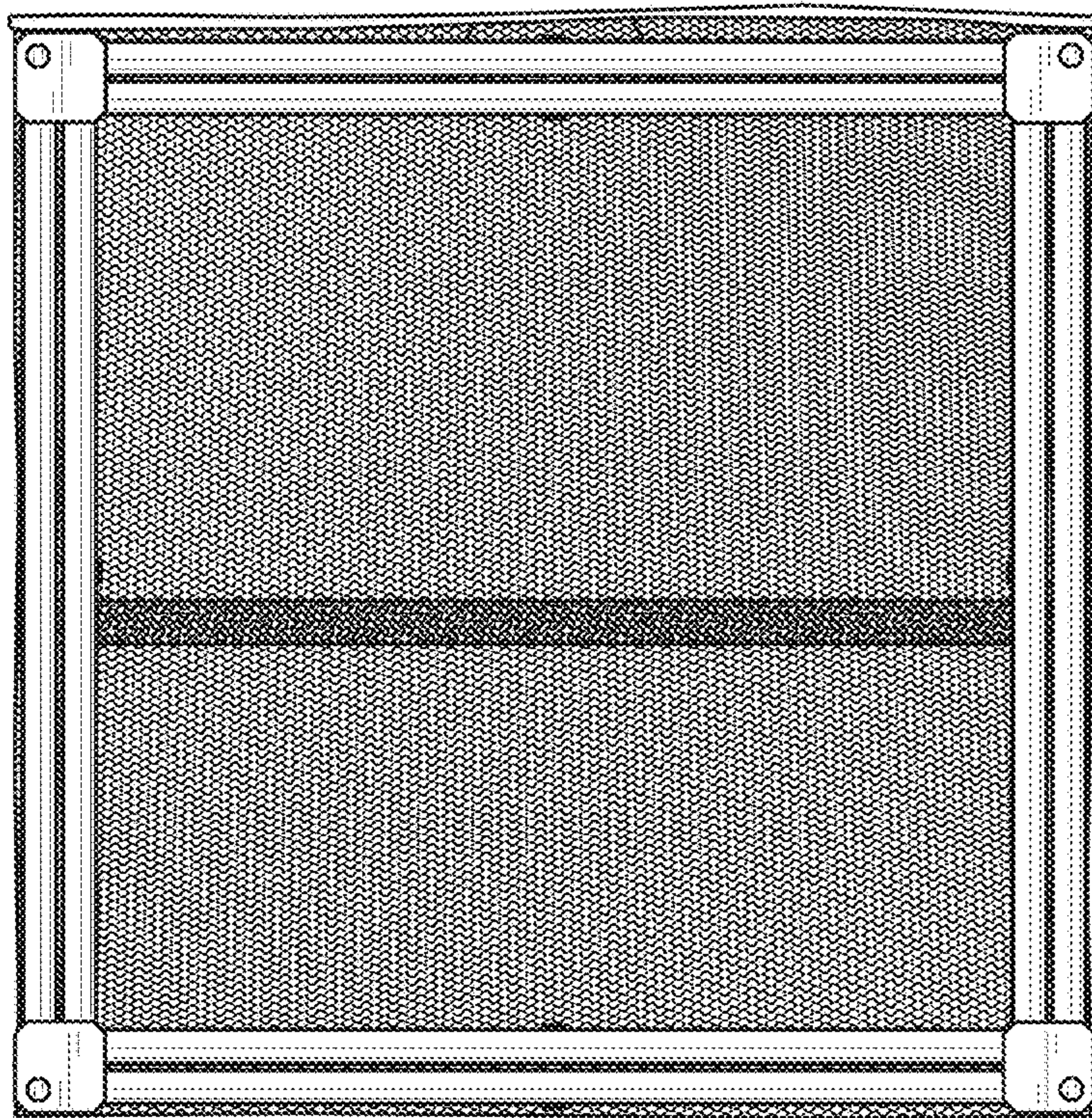

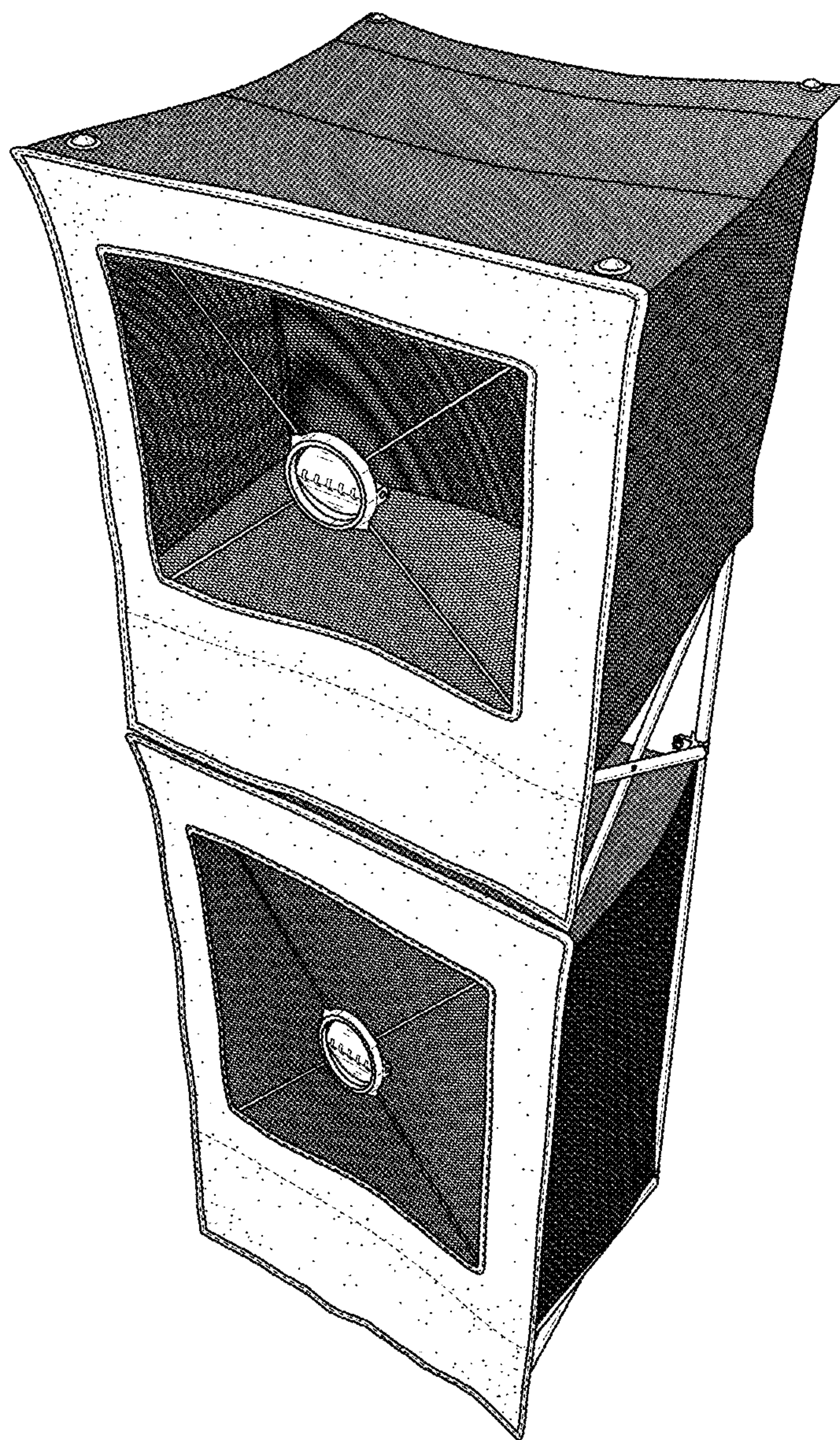

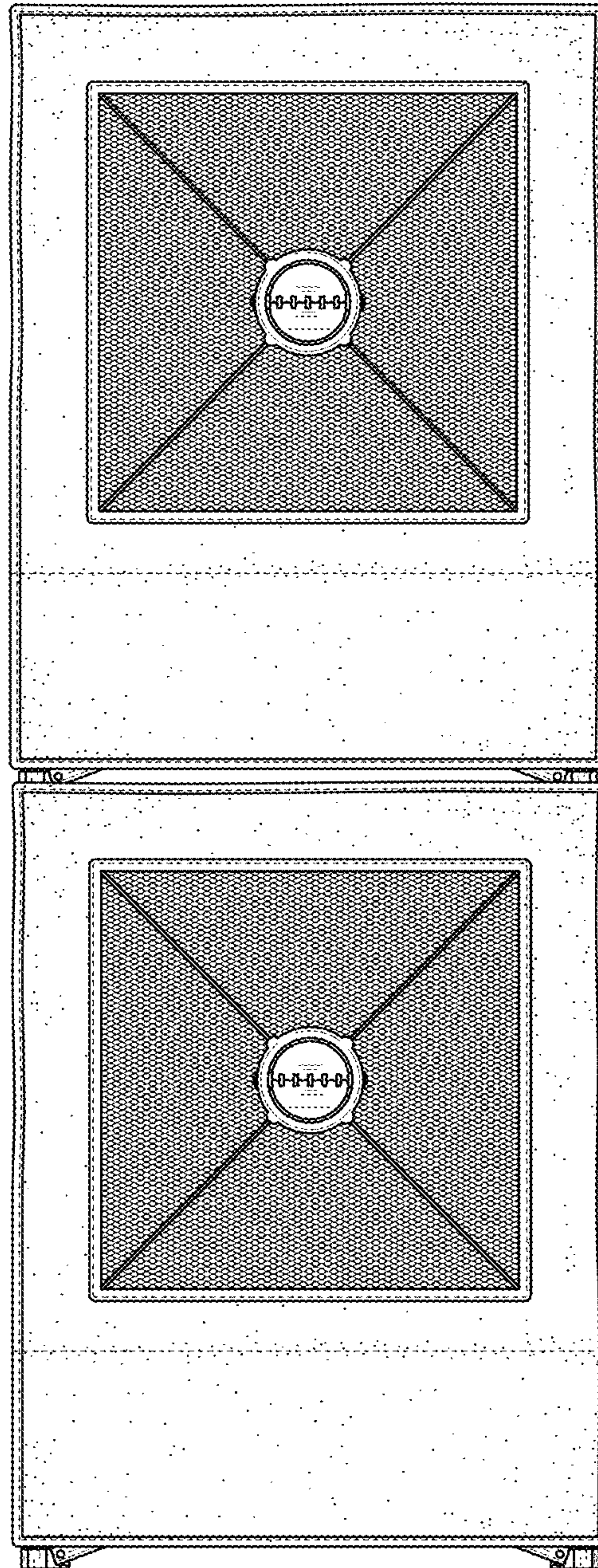

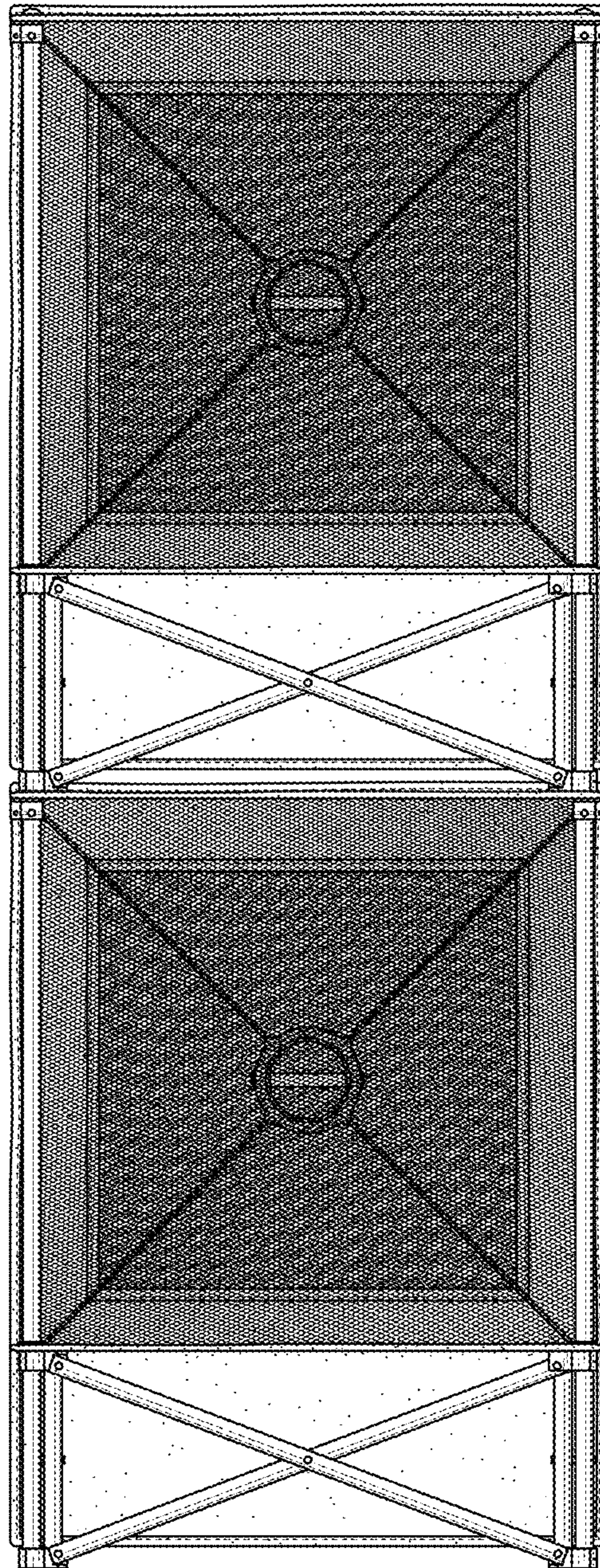

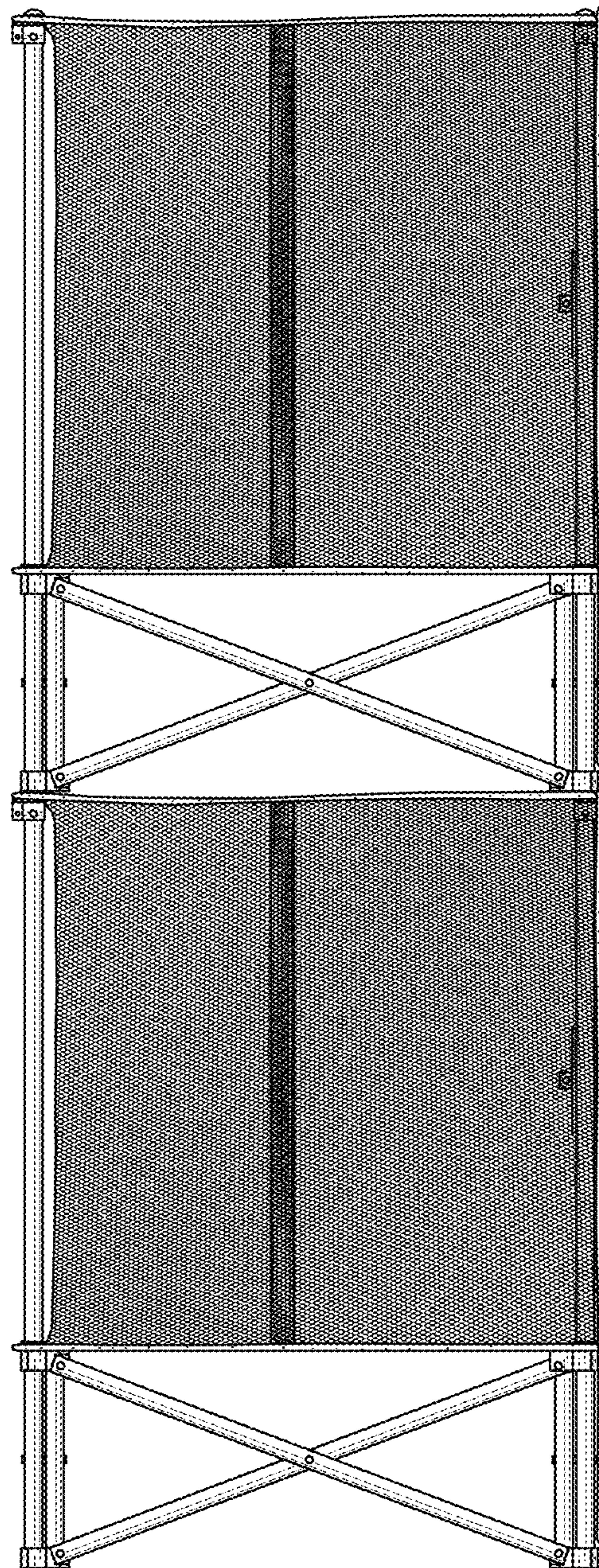

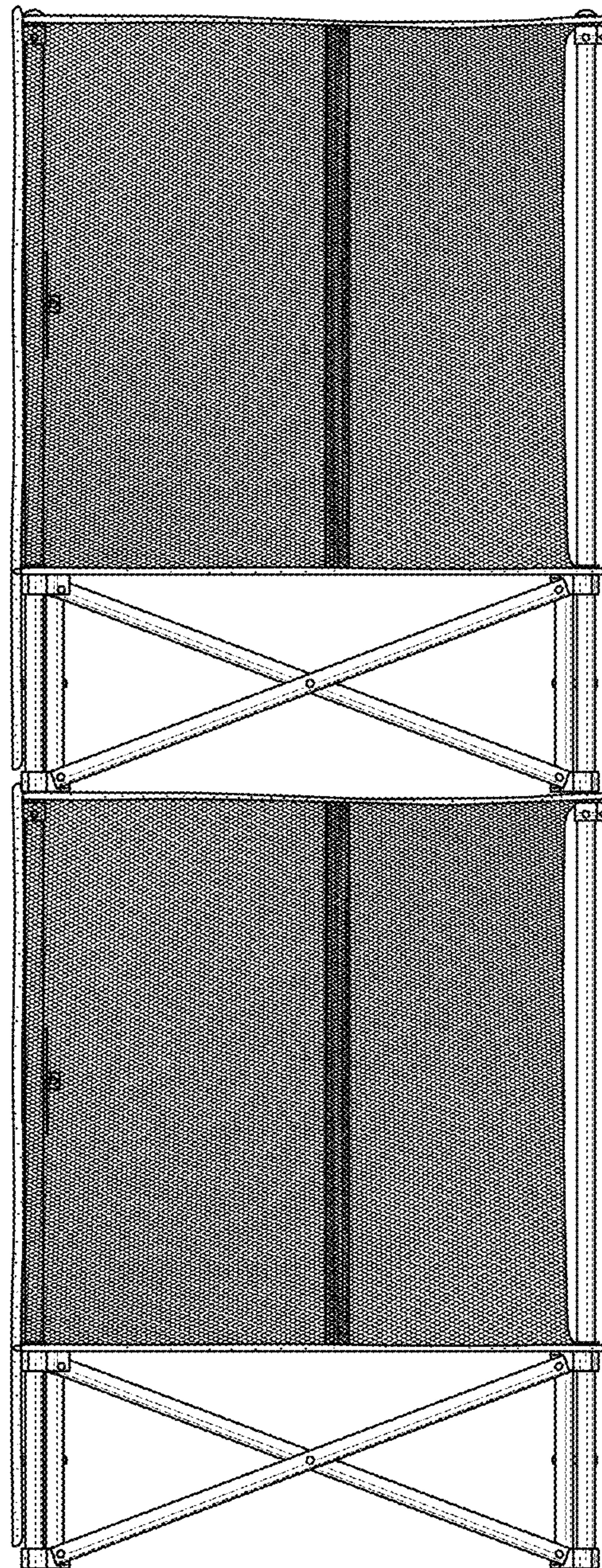

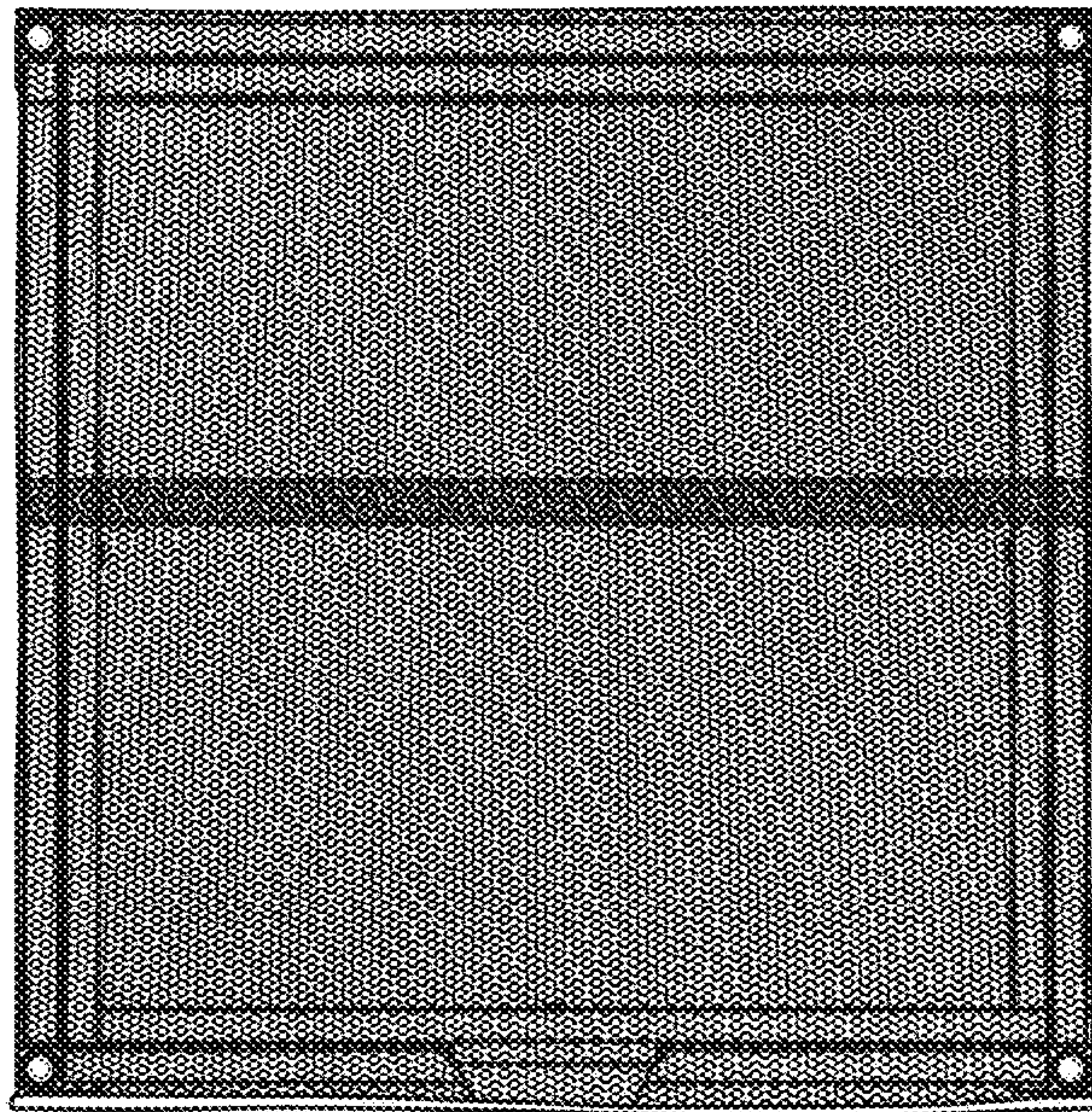

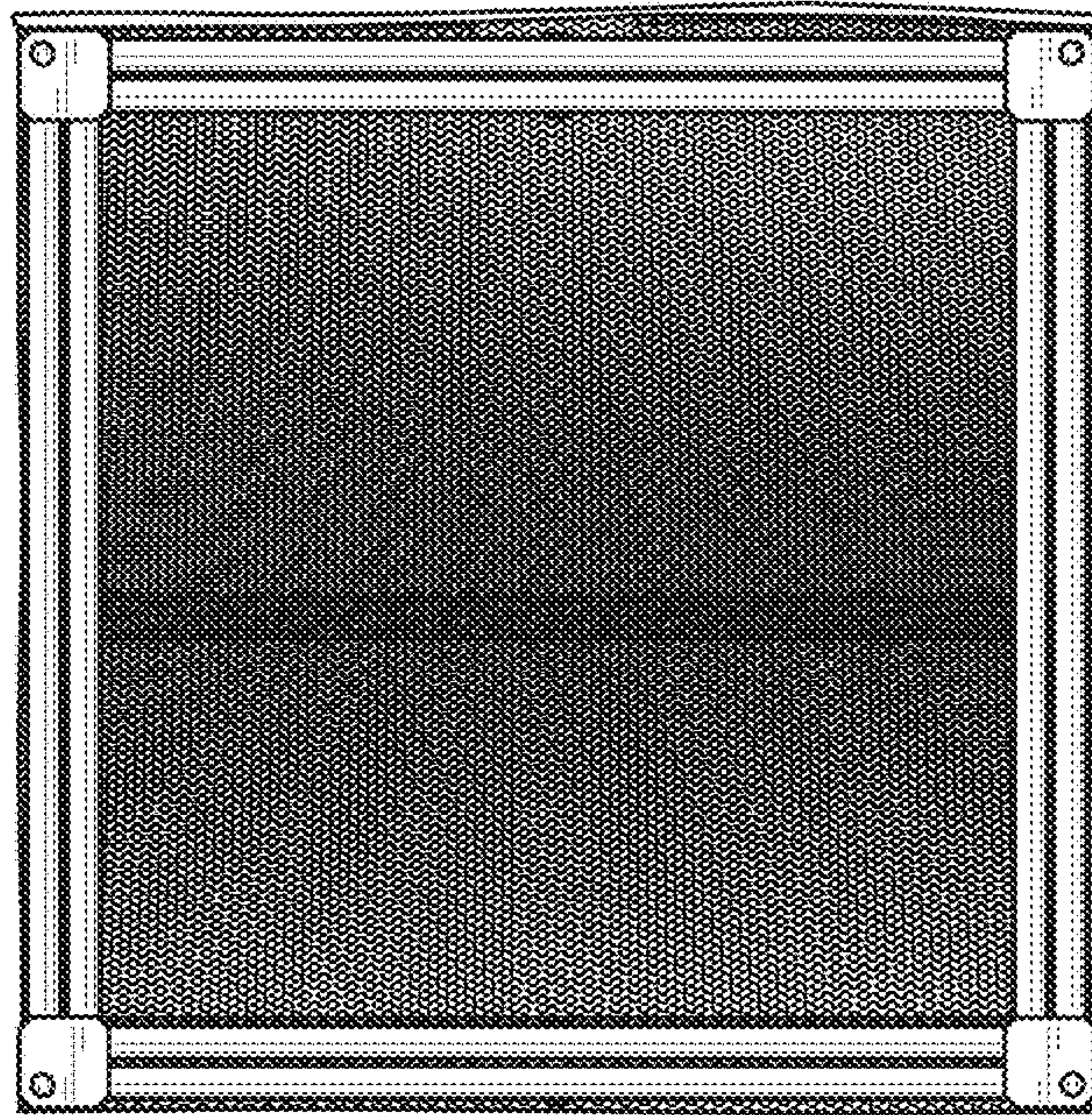

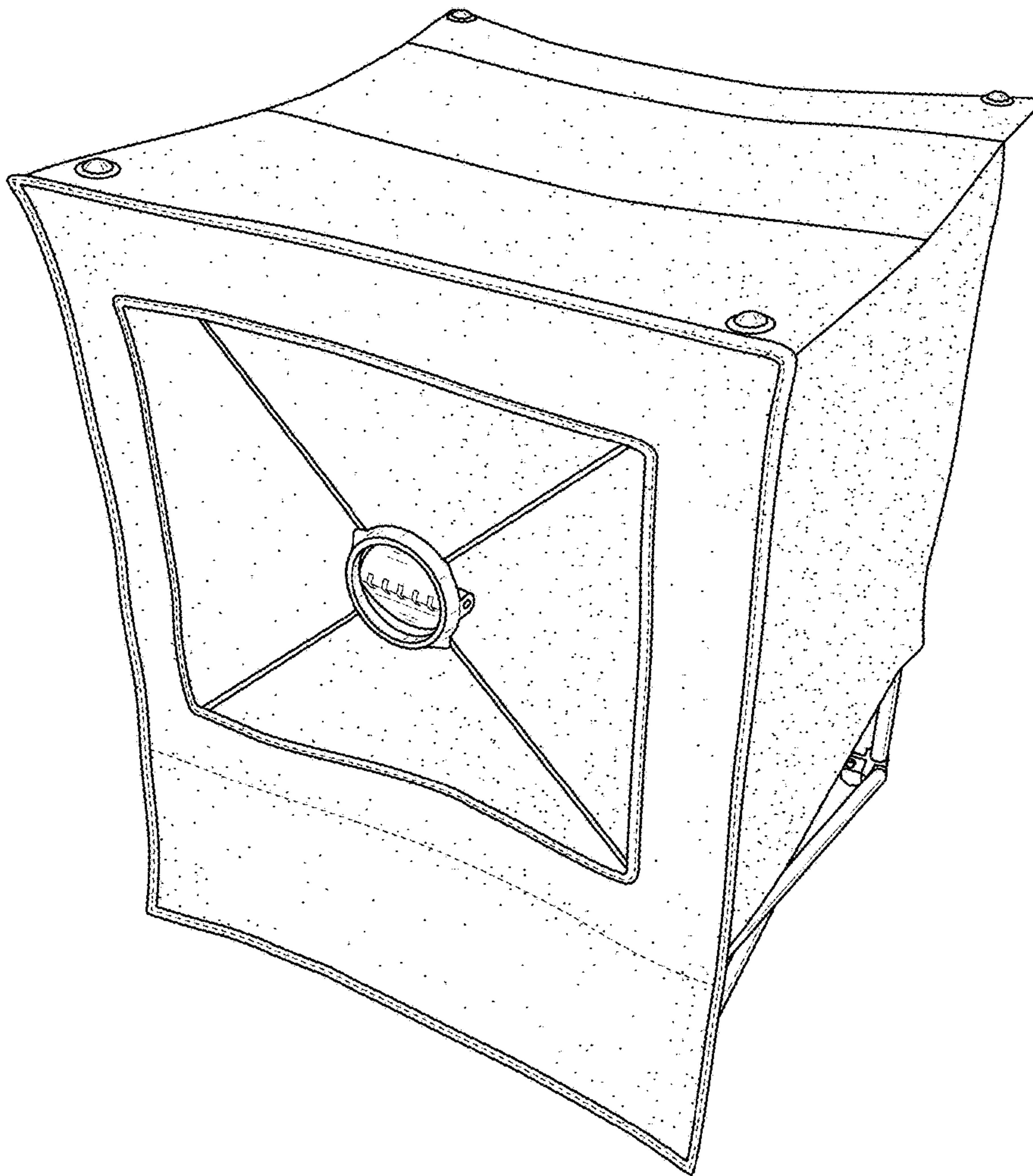

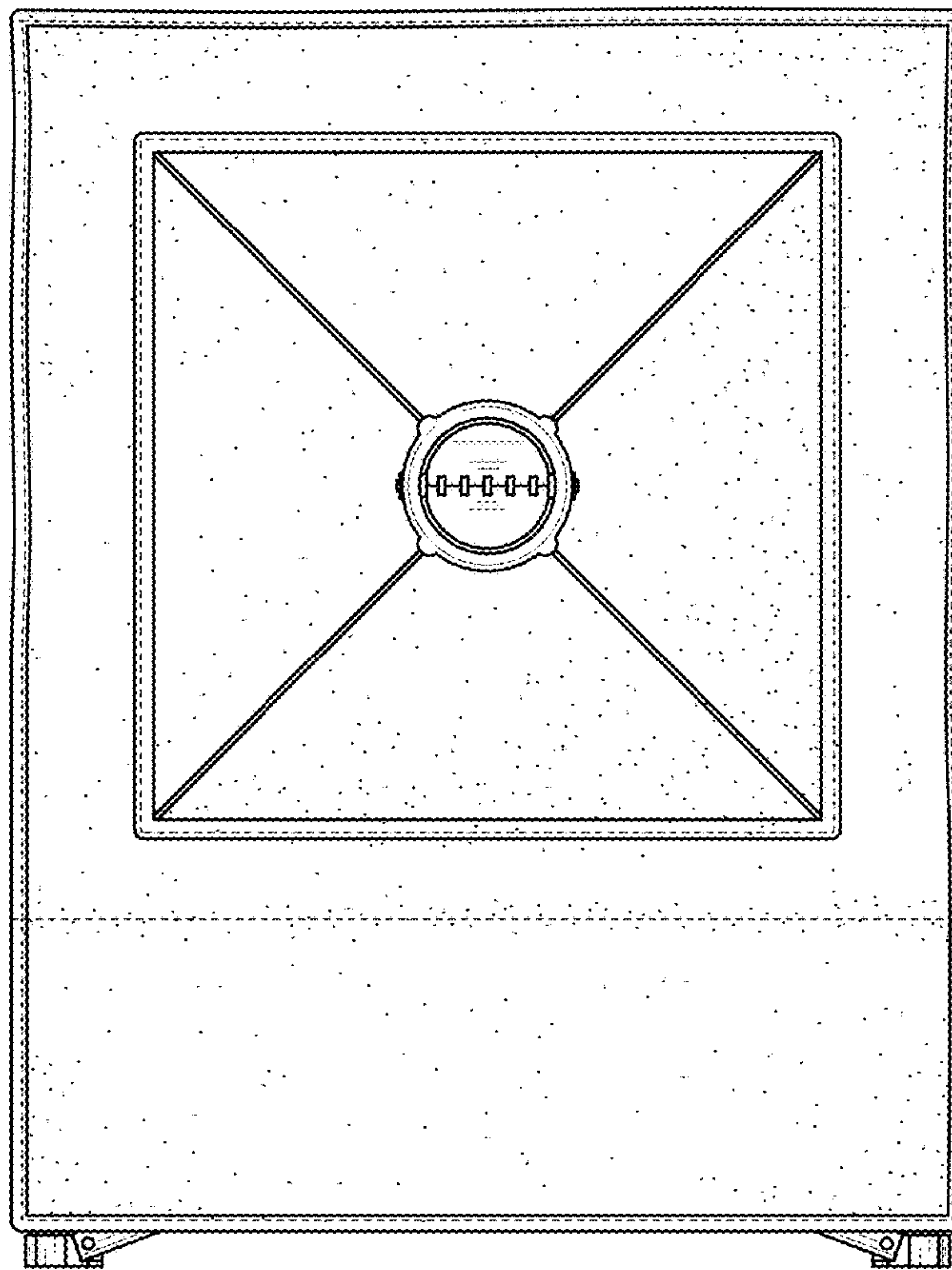

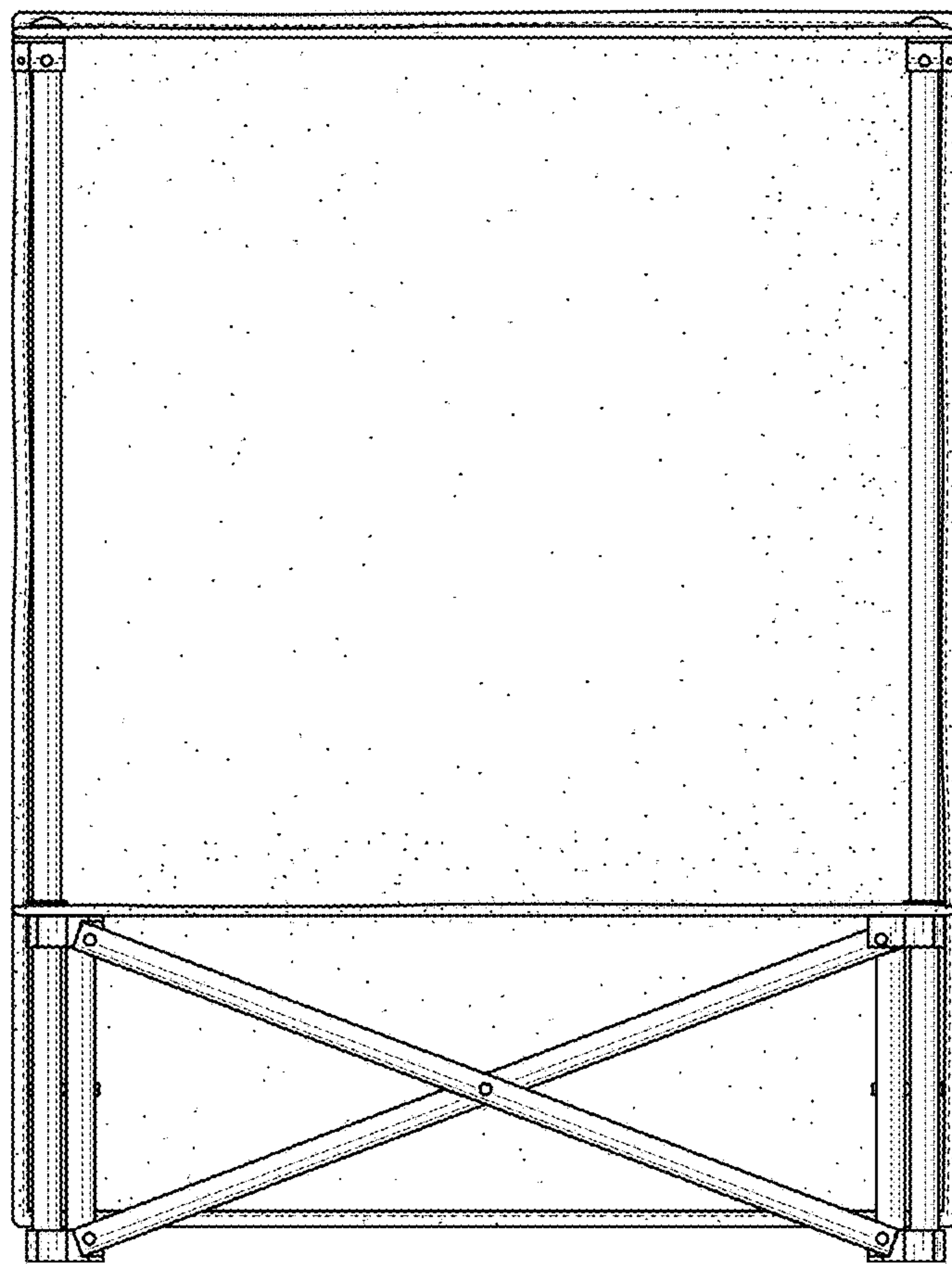

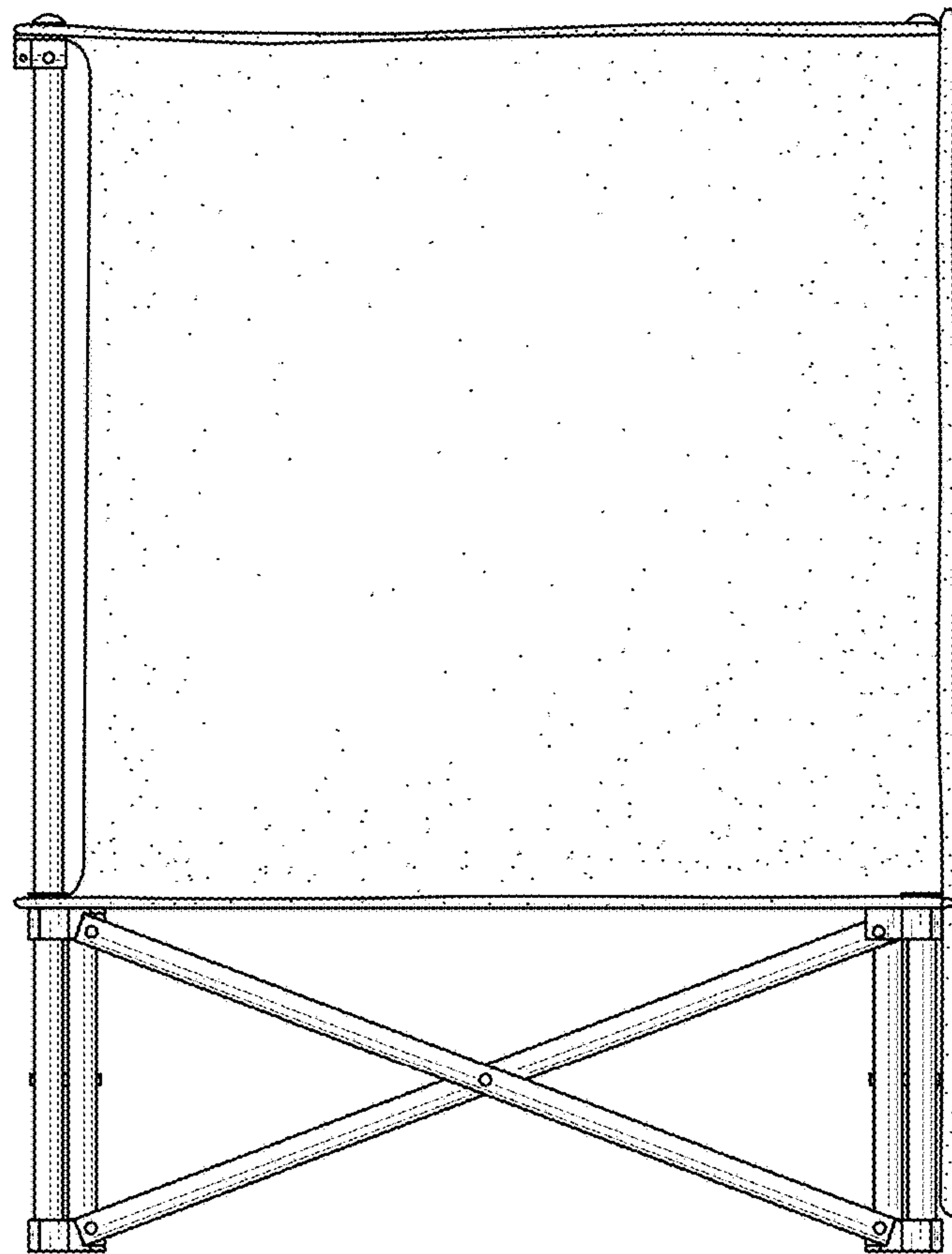

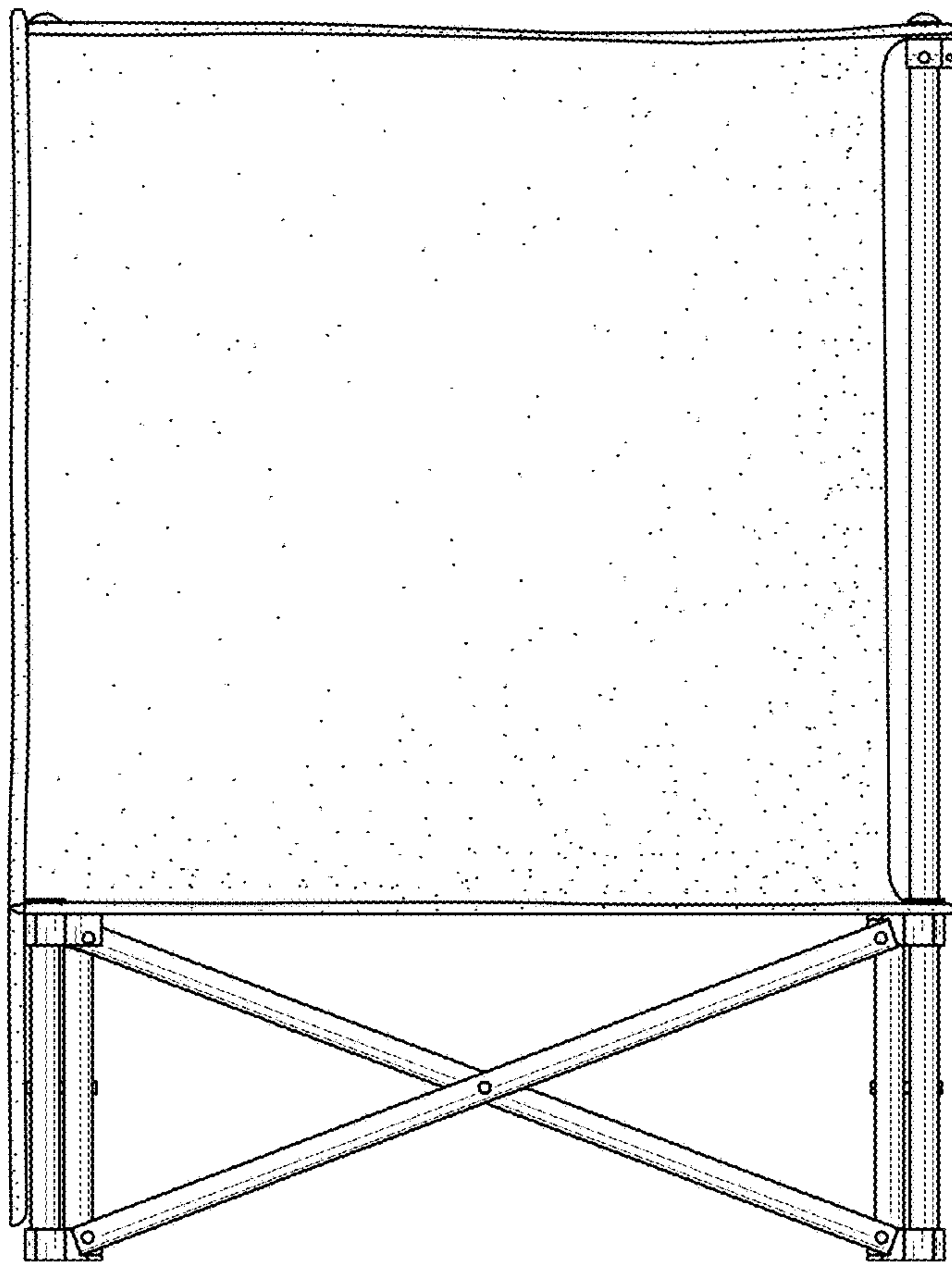

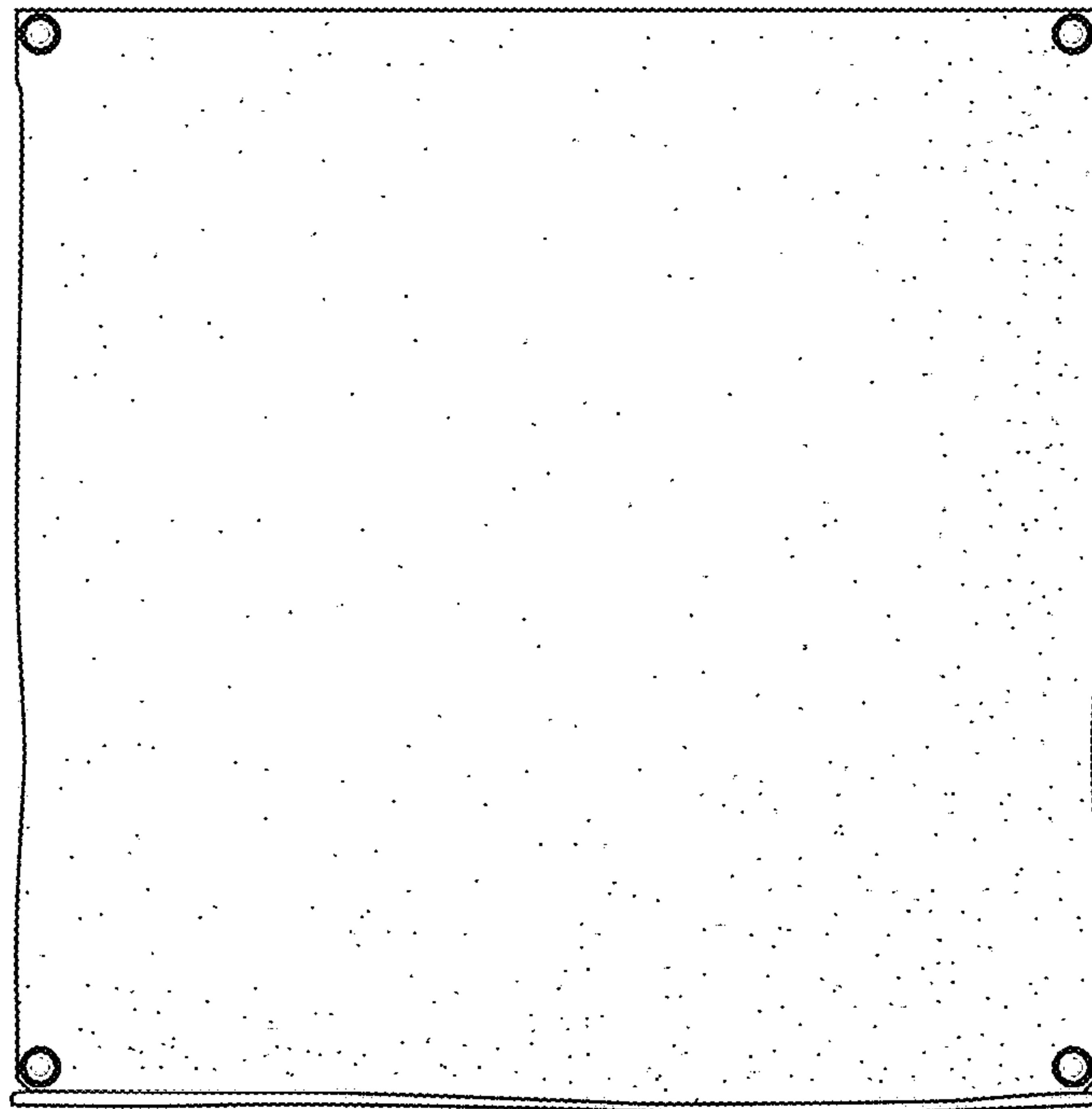

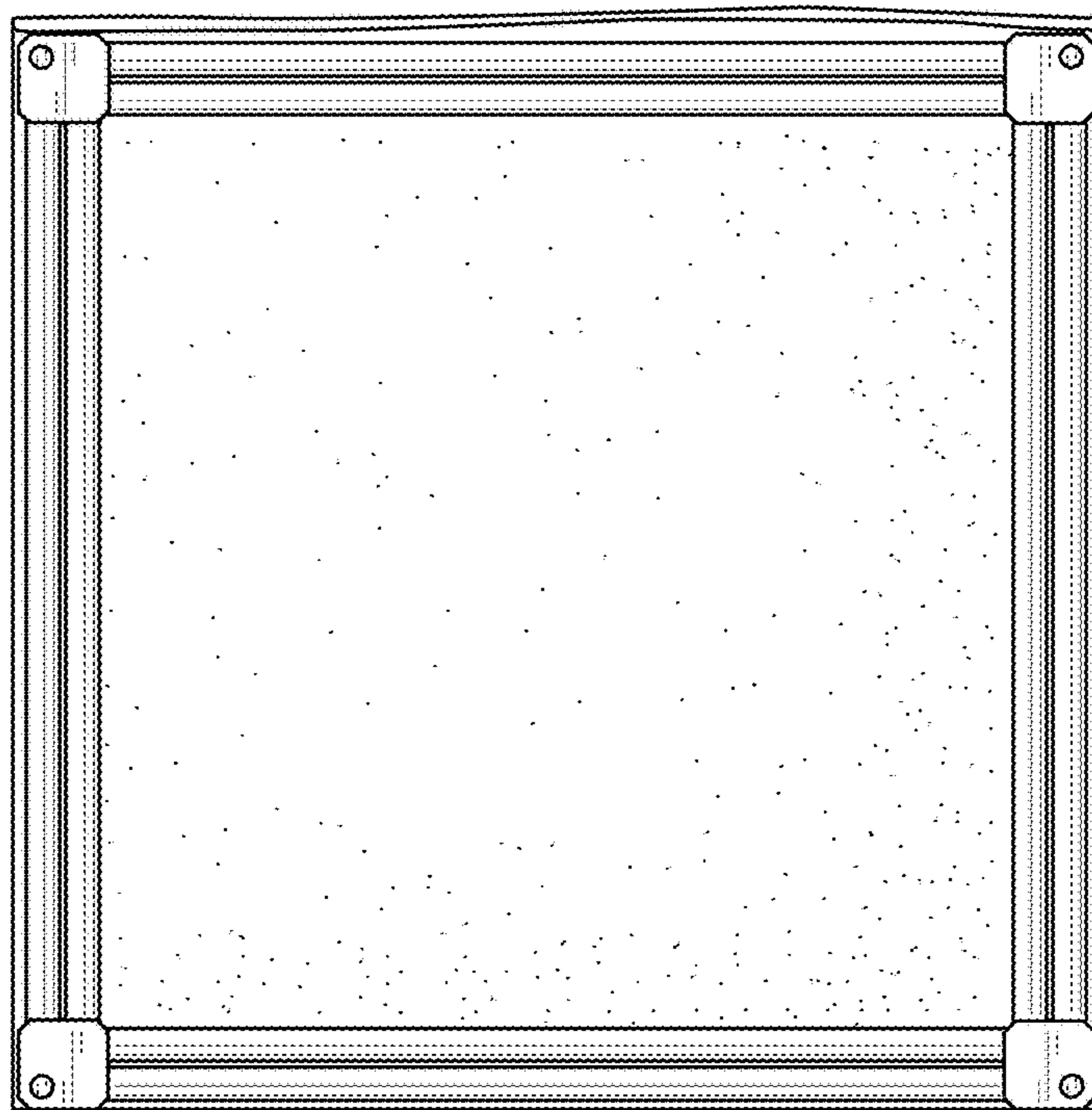
